The ornamental design for a face mask with access flap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a face mask with access flap showing my new design;

FIG. 2 is a bottom front perspective view thereof;

FIG. 3 is a top rear perspective view thereof;

FIG. 4 is a bottom rear perspective view thereof;

FIG. 5 is a front elevated view thereof;

FIG. 6 is a rear elevated view thereof;

FIG. 10 is a left elevated view thereof;

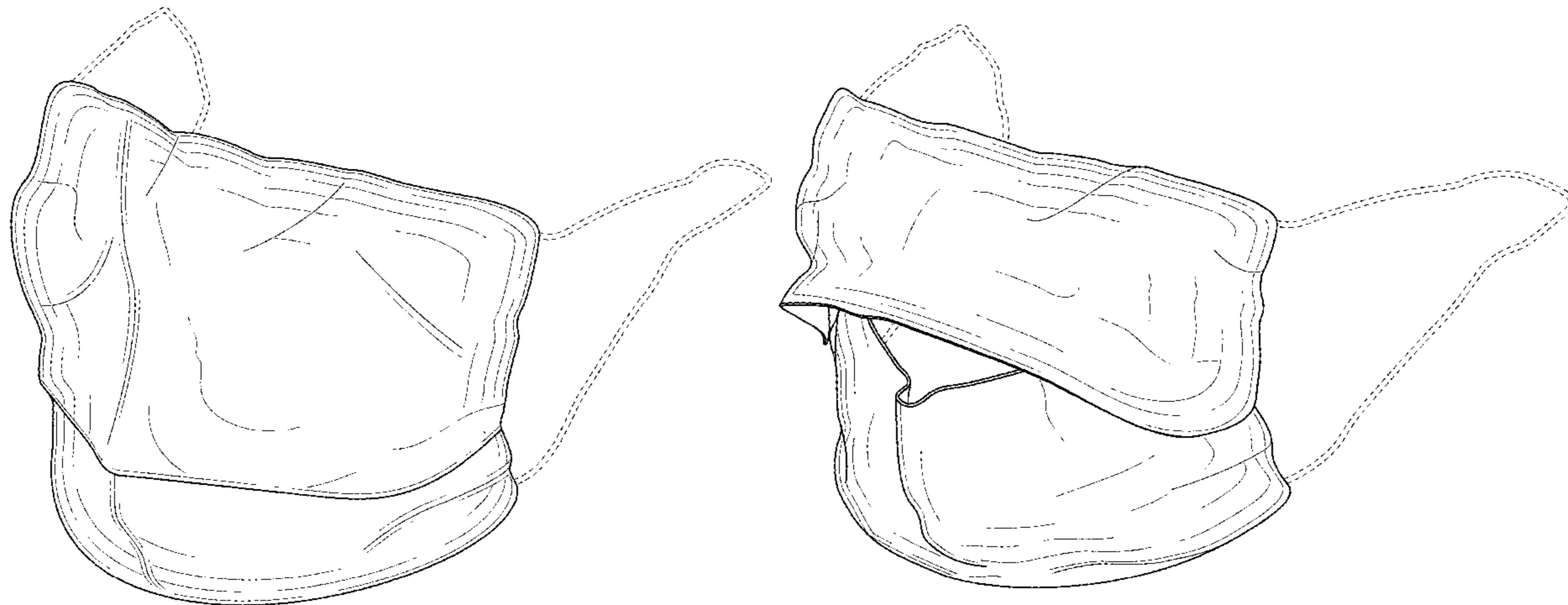
FIG. 11 is a top front perspective view thereof, showing the face mask with access flap in an open configuration;

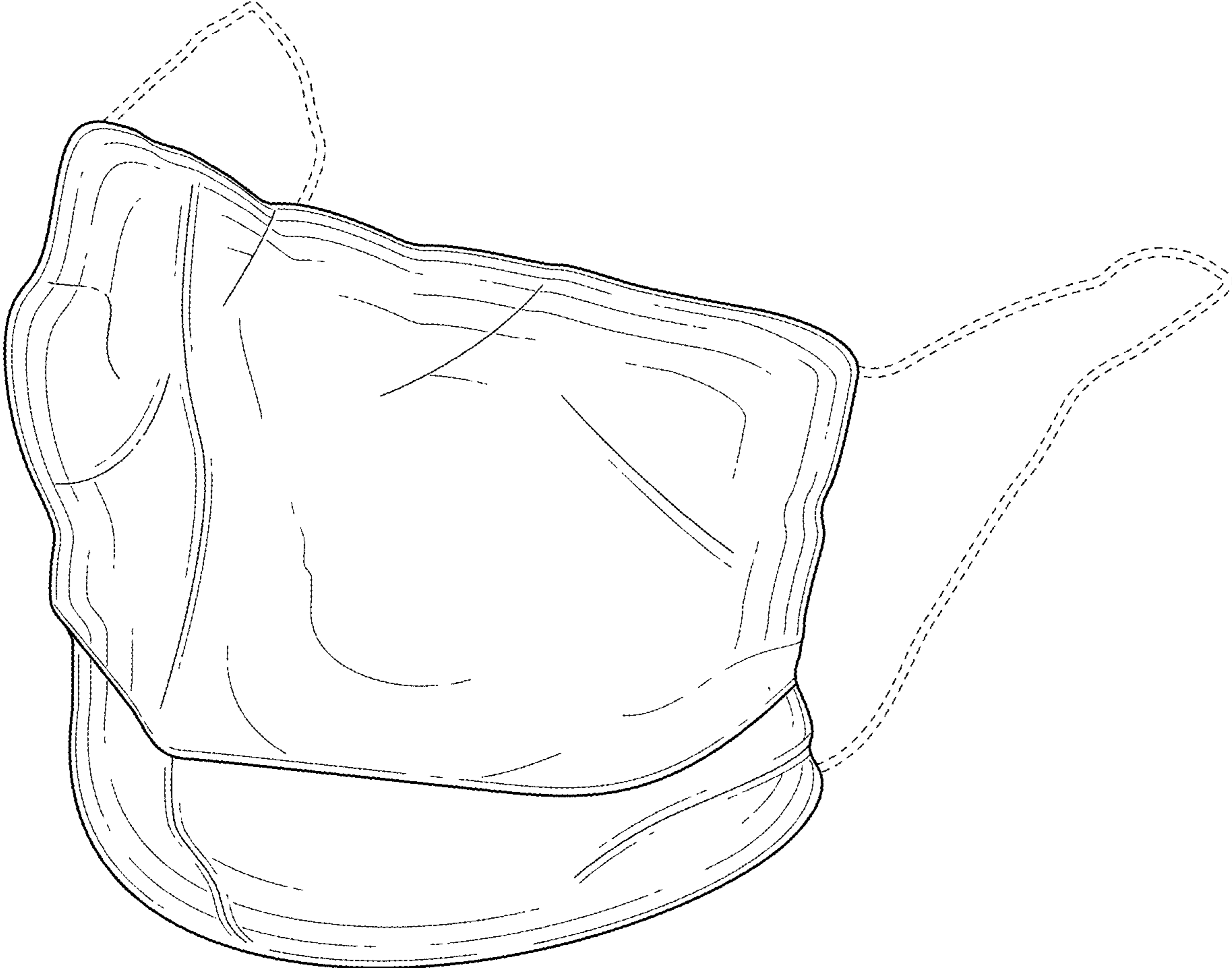

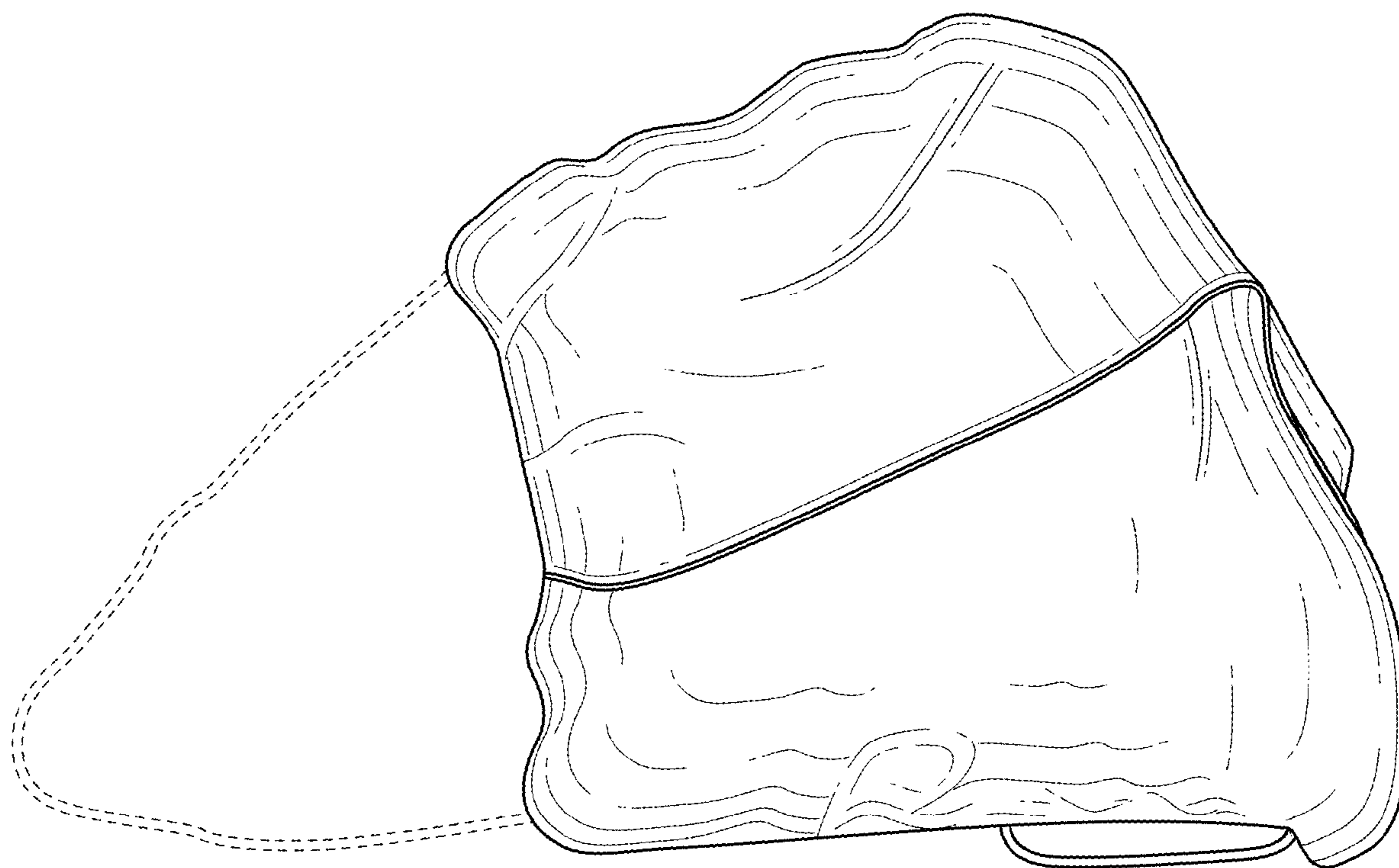

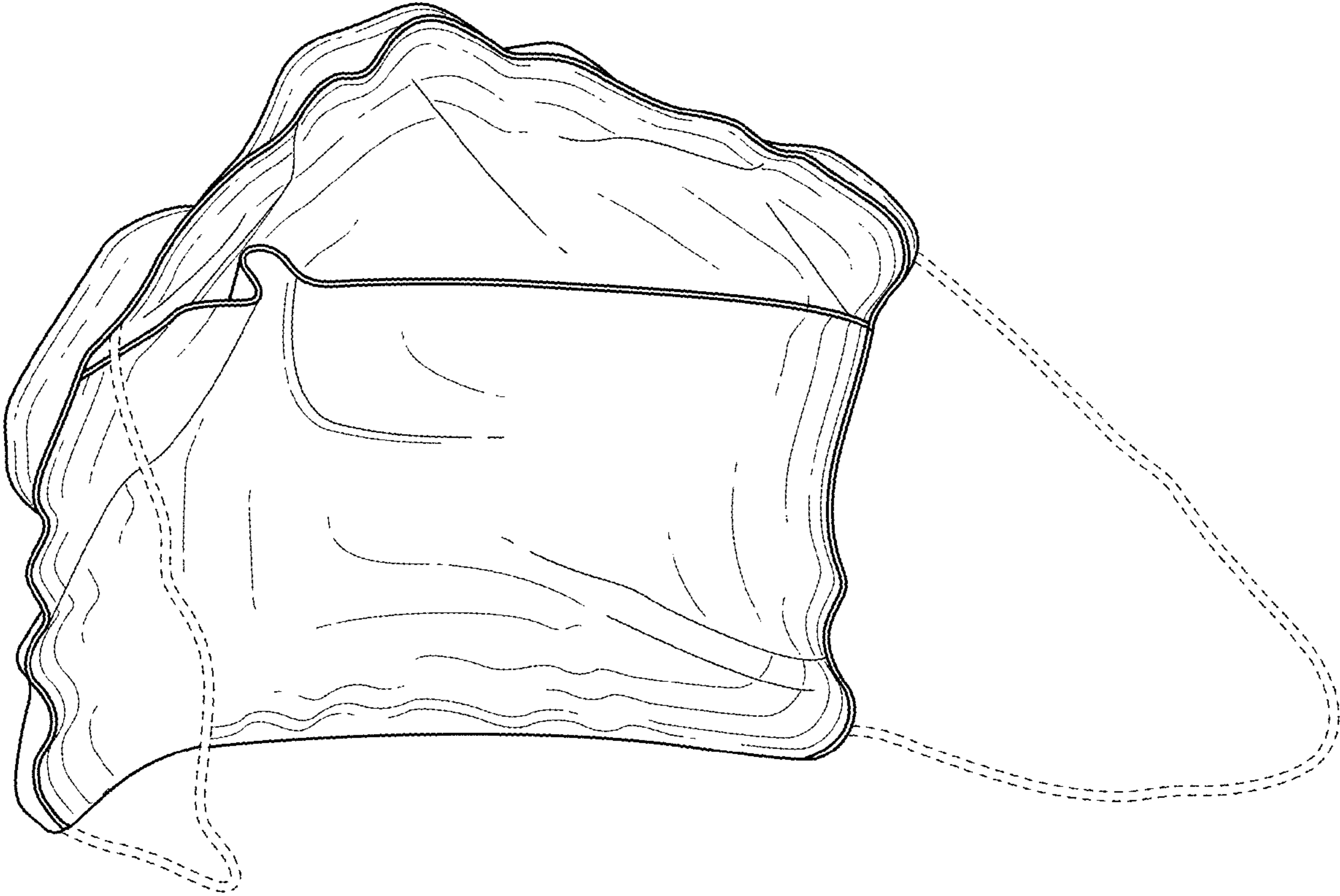

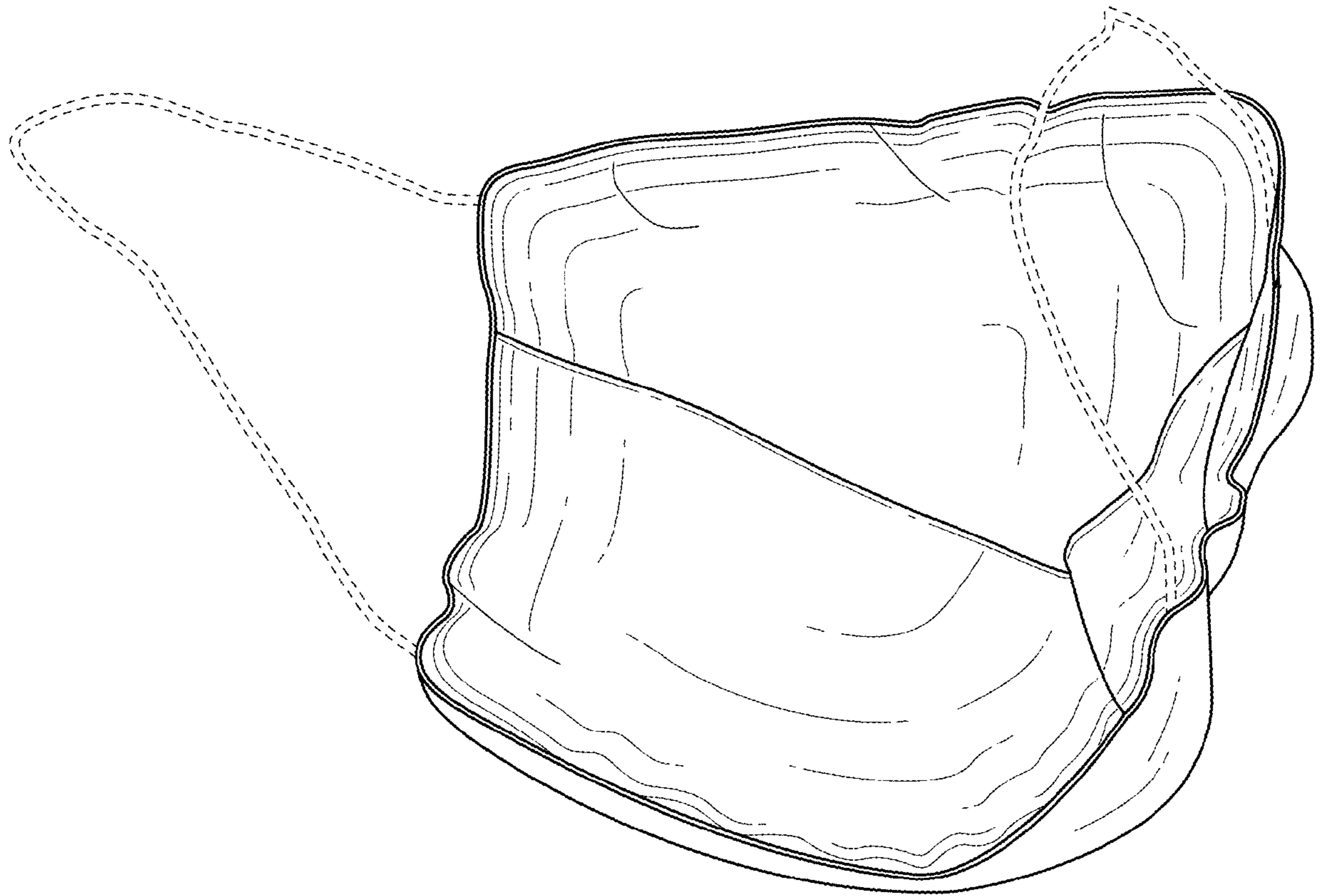

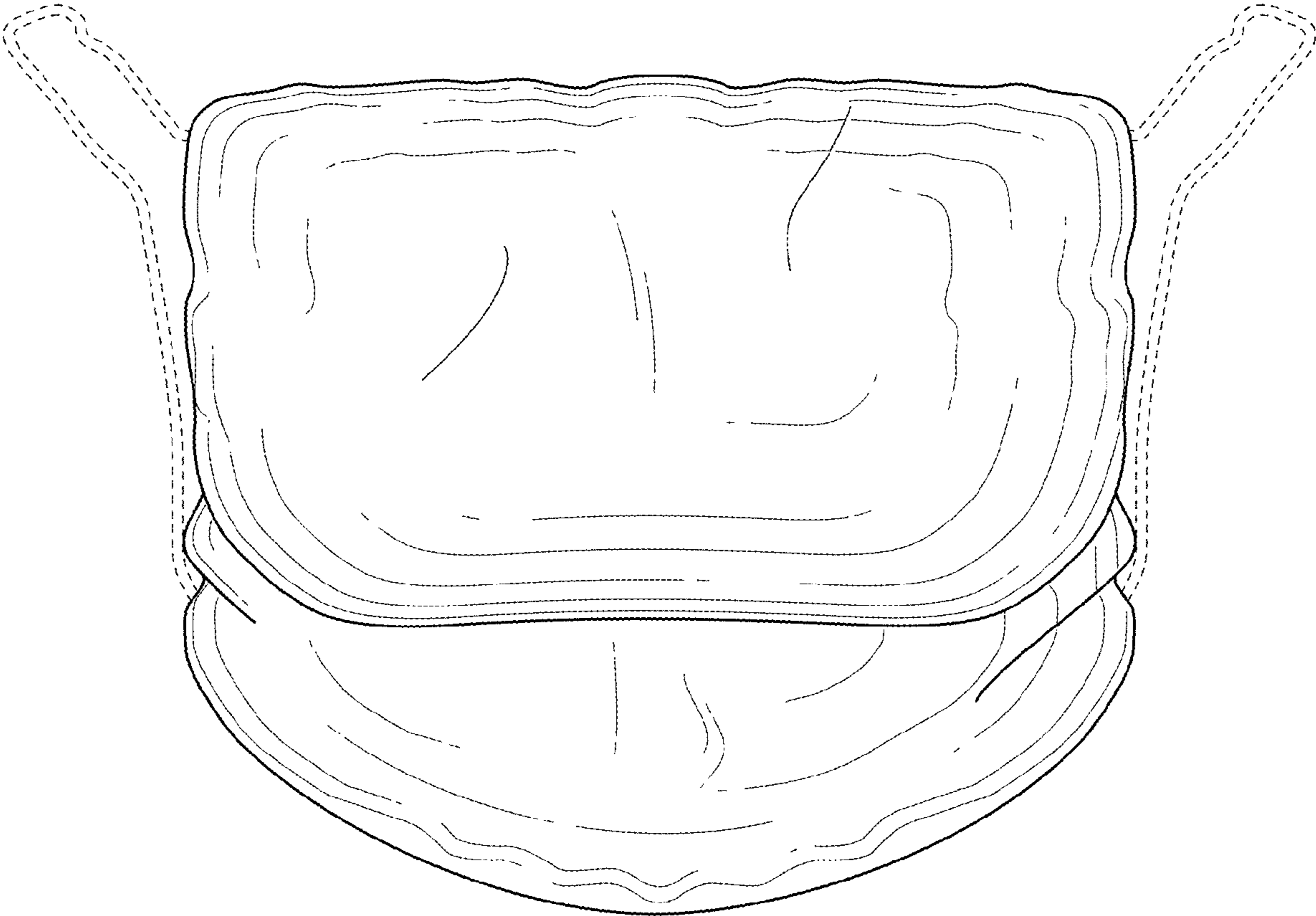

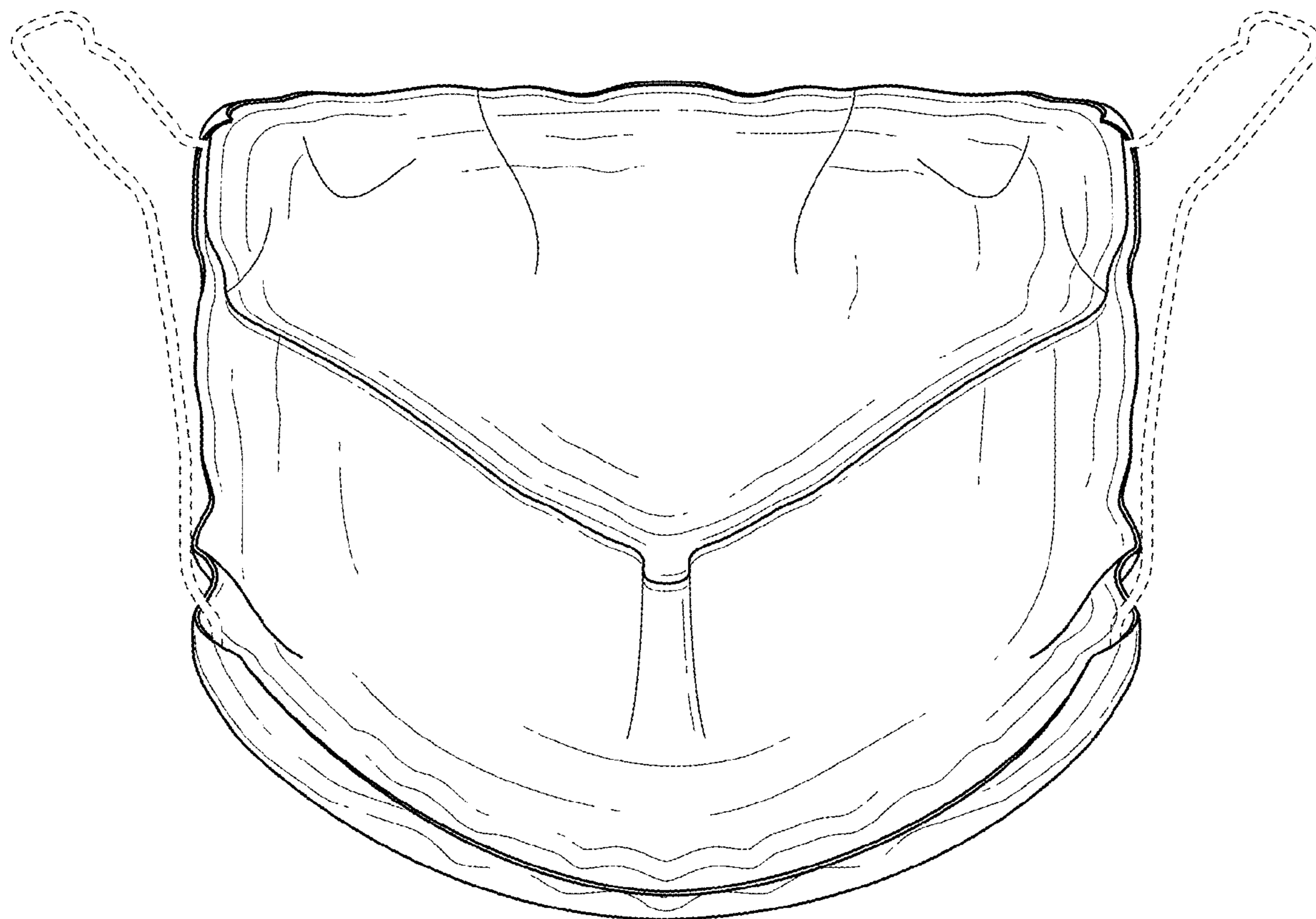

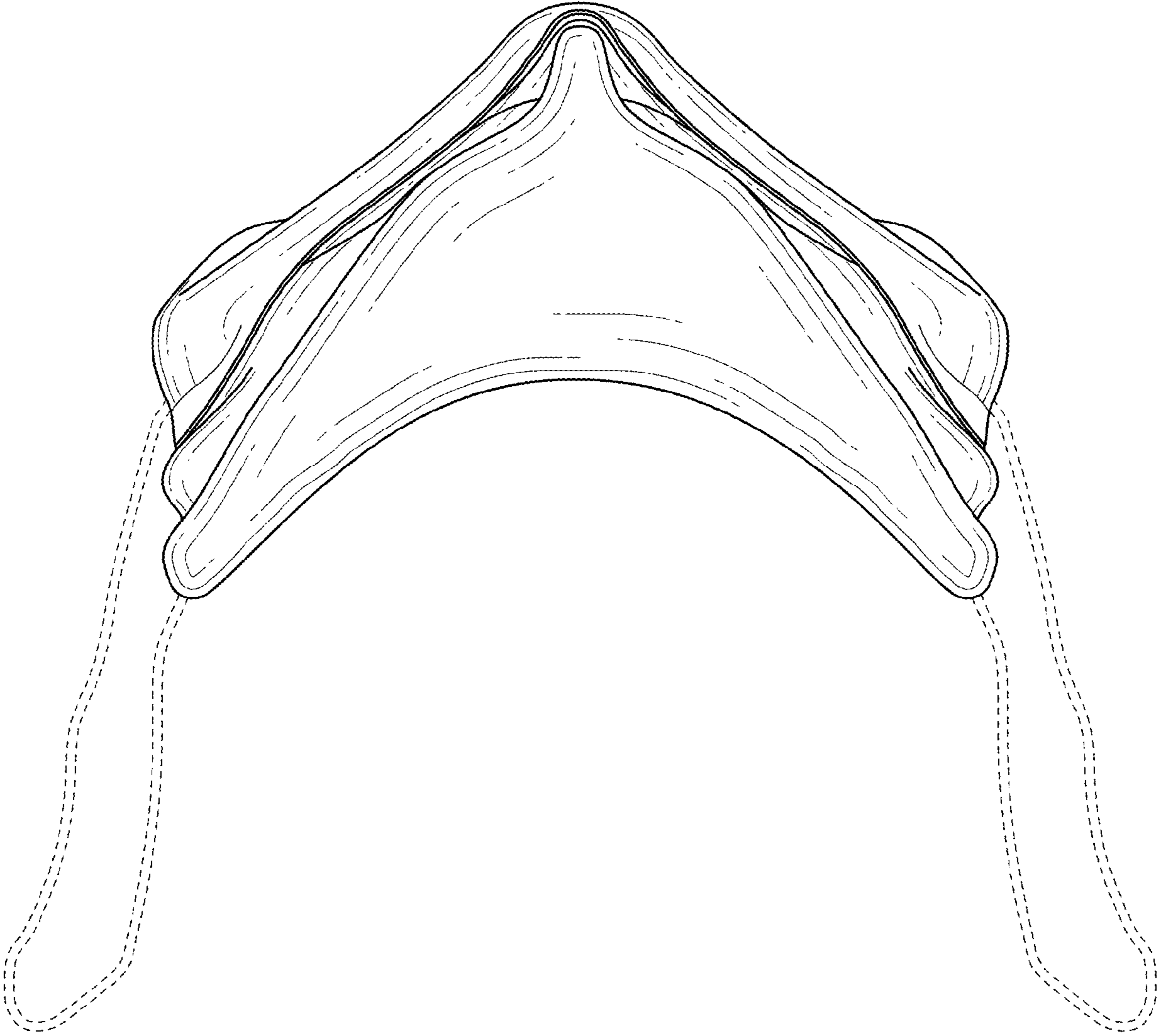

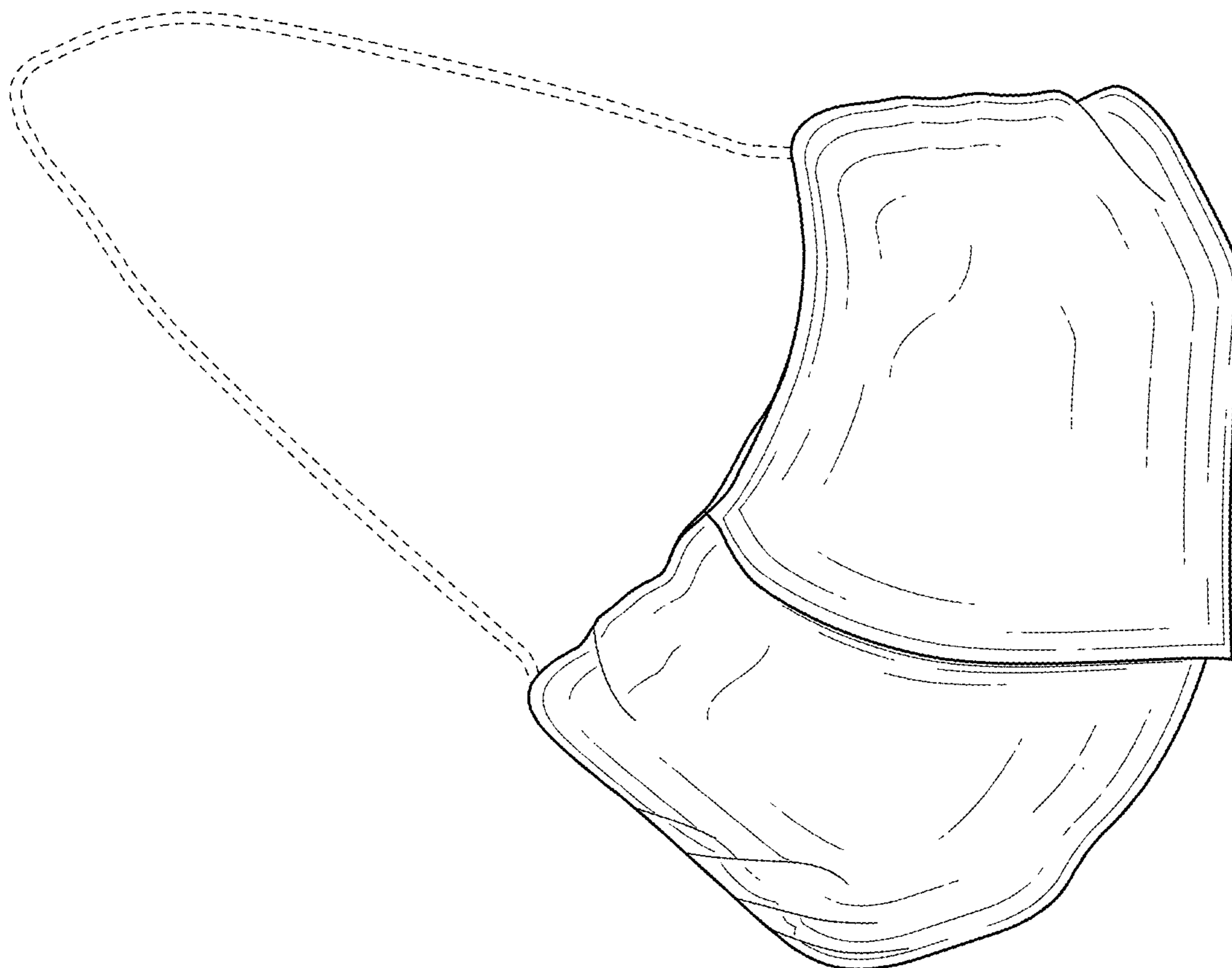

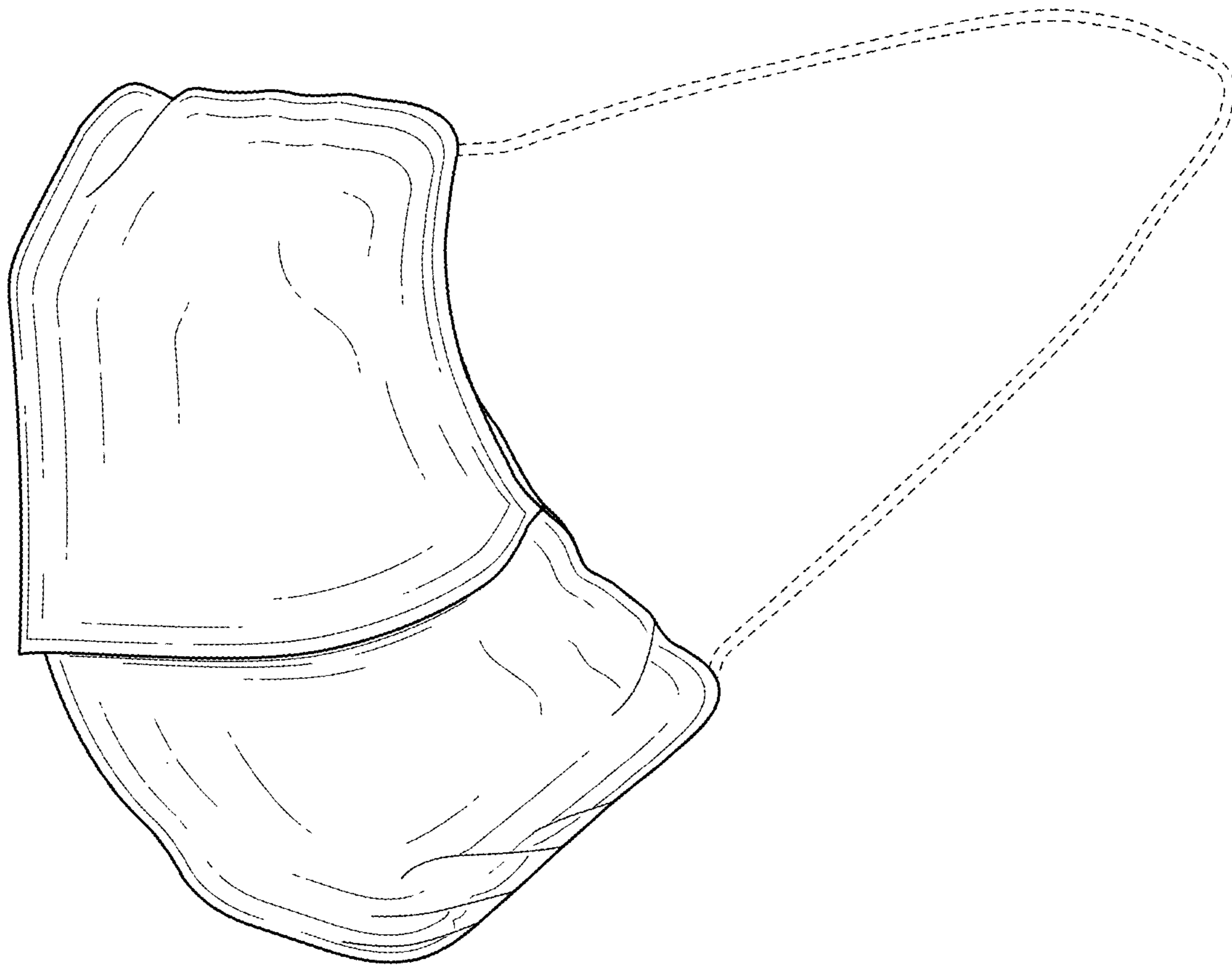

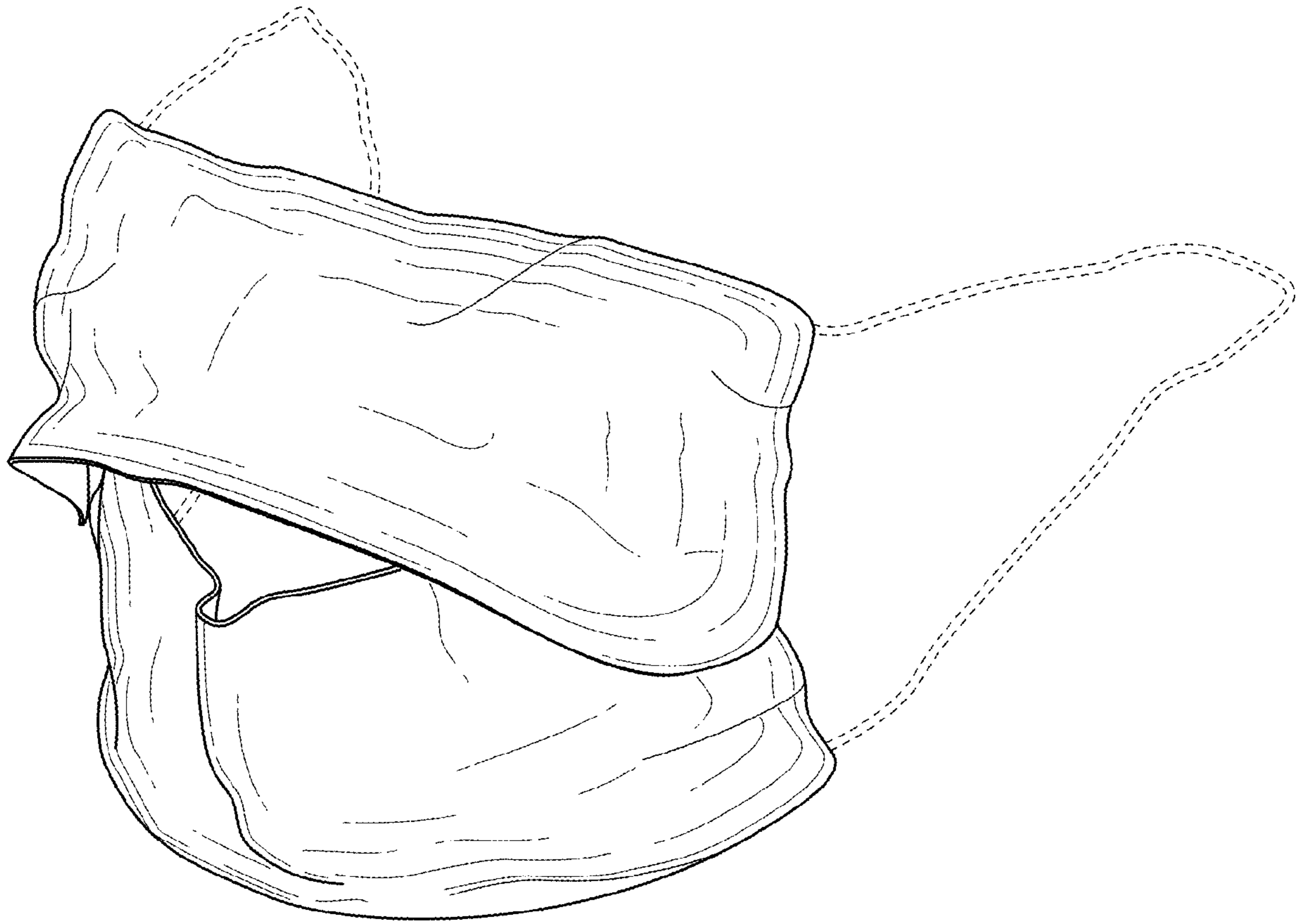

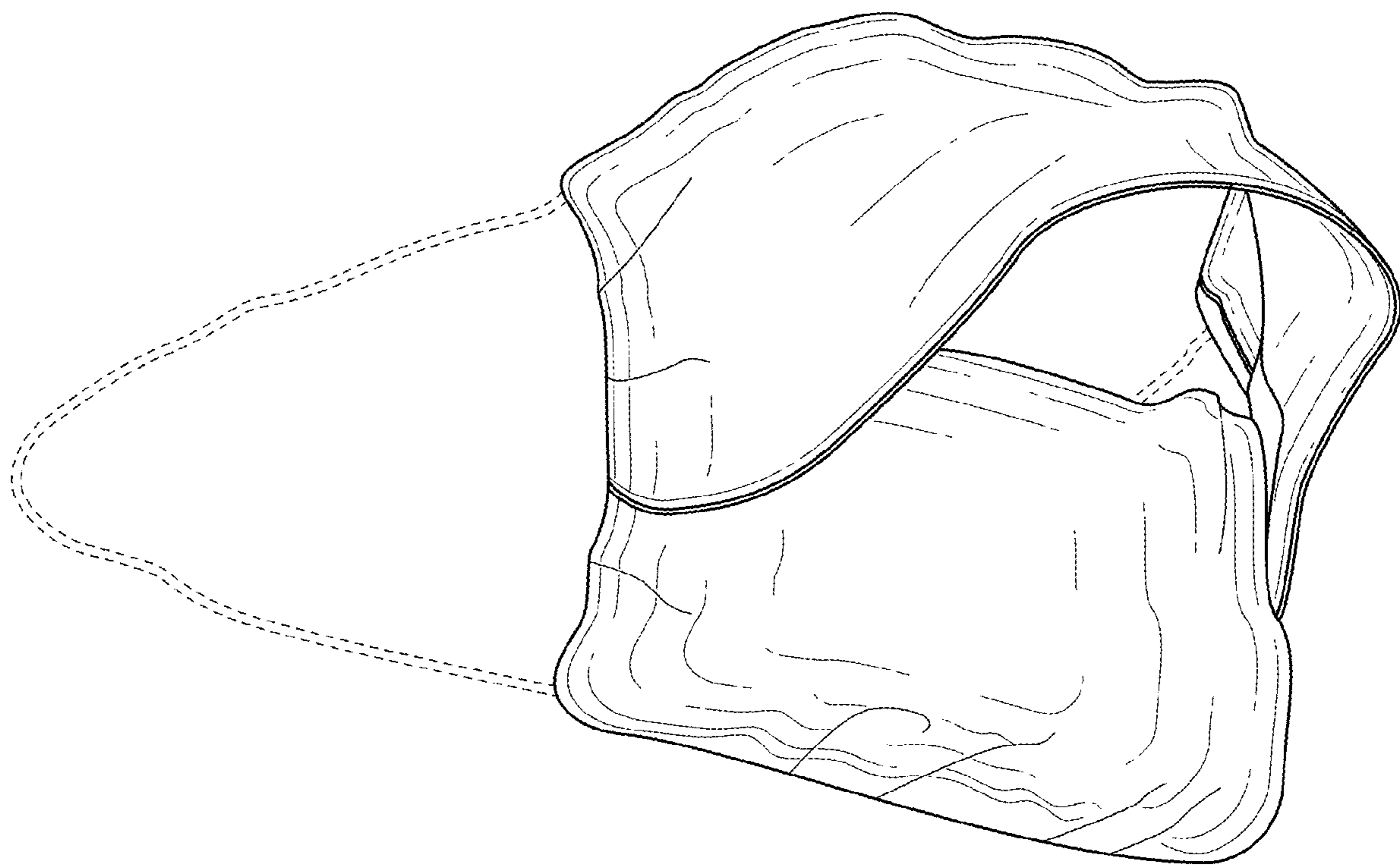

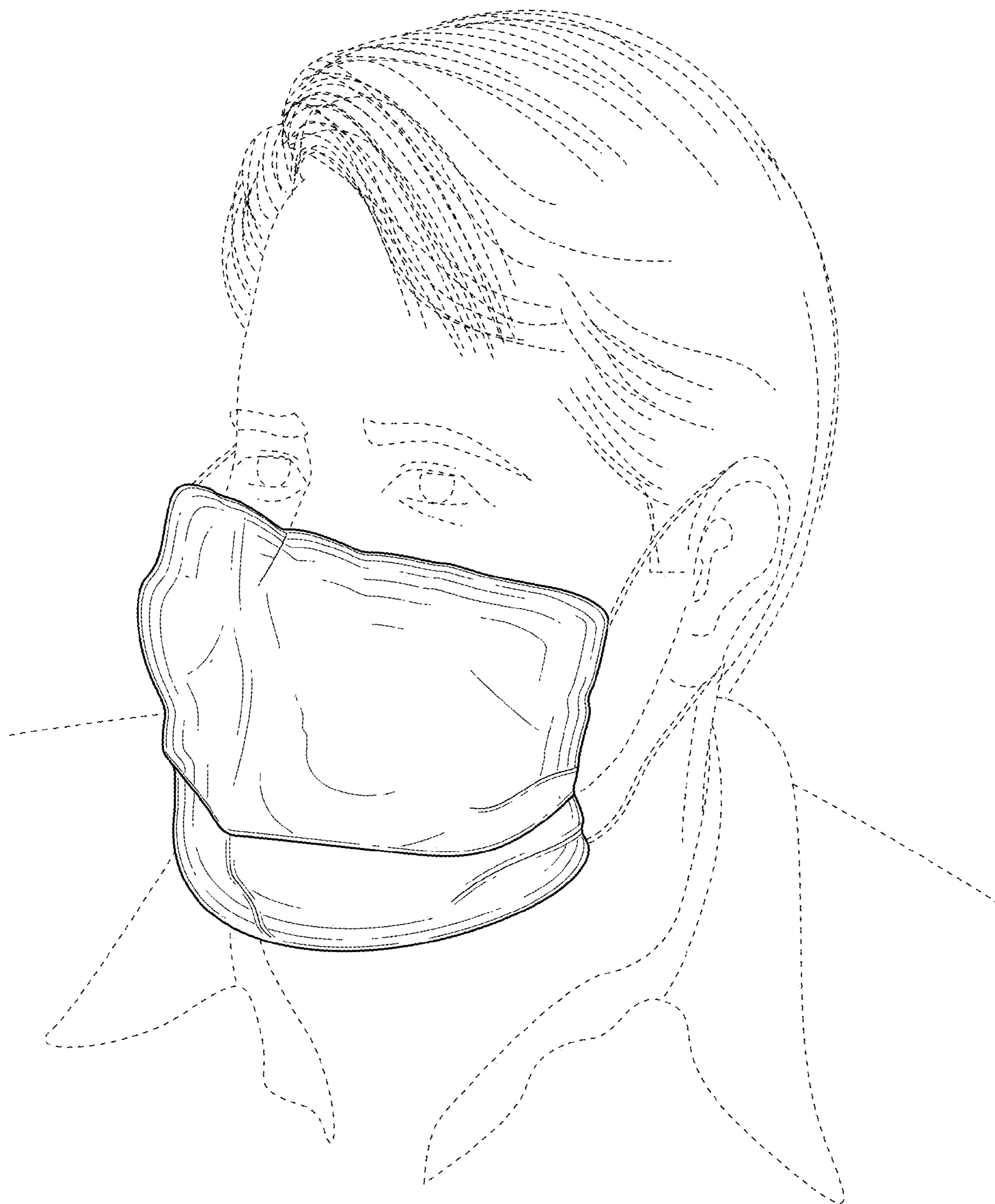
