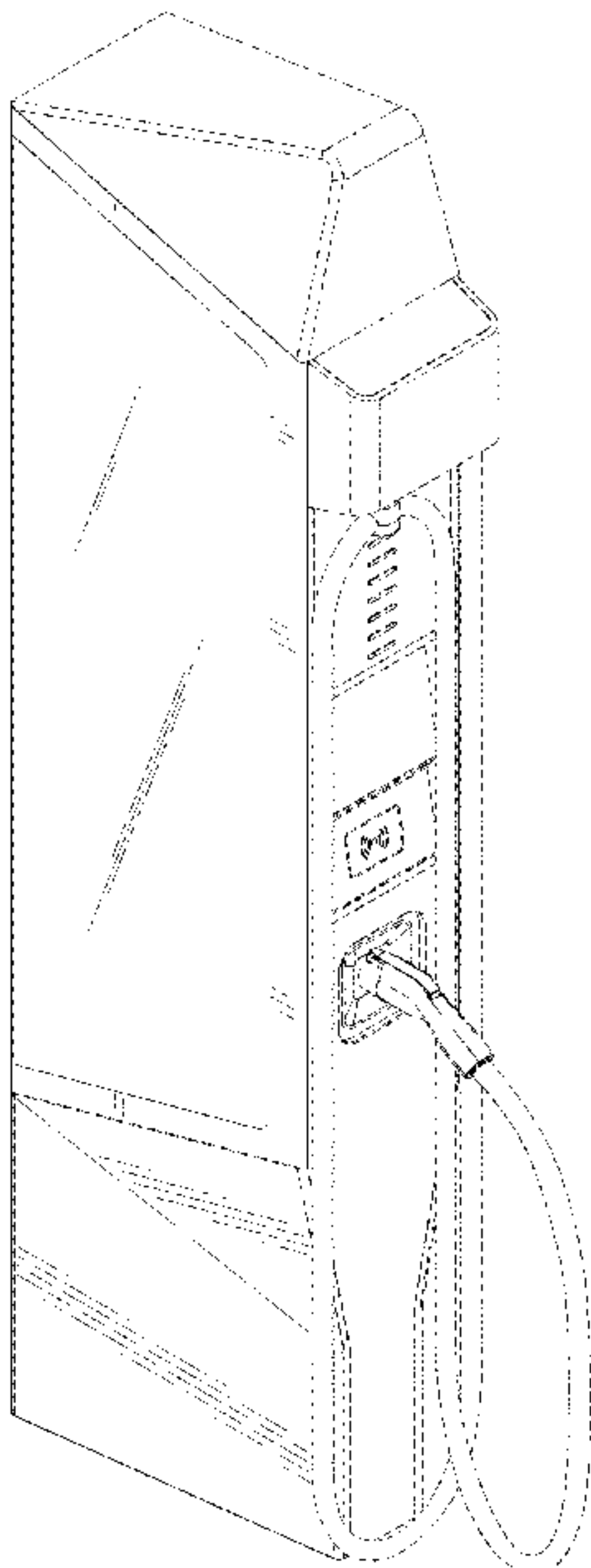
(57) CLAIM

DESCRIPTION

FIG. 1 is a front perspective view of a charging station showing our new design;

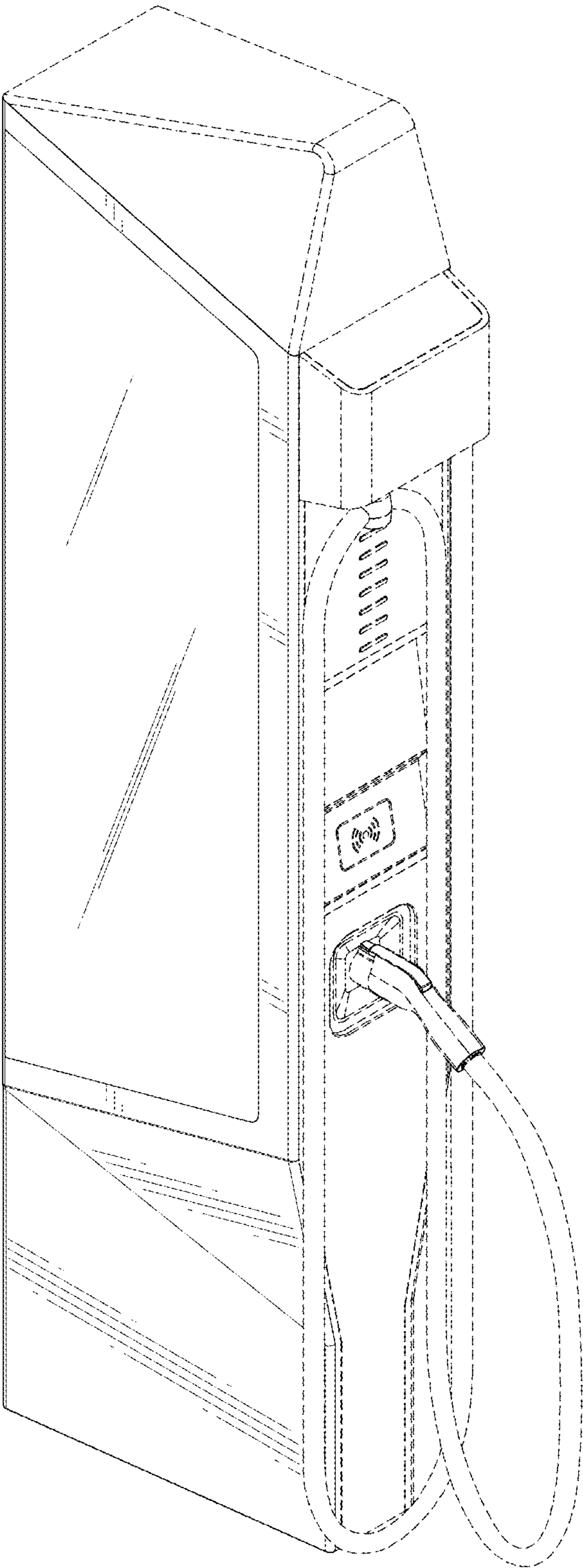

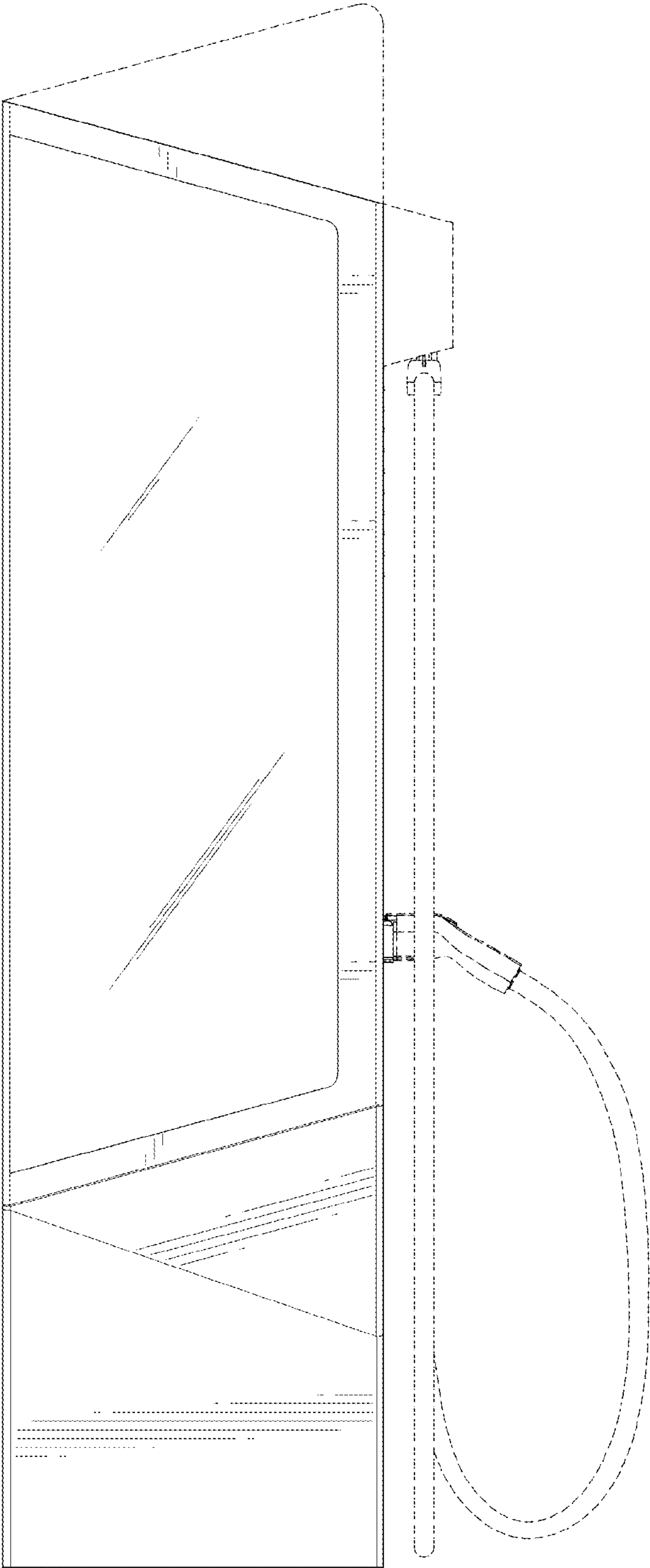

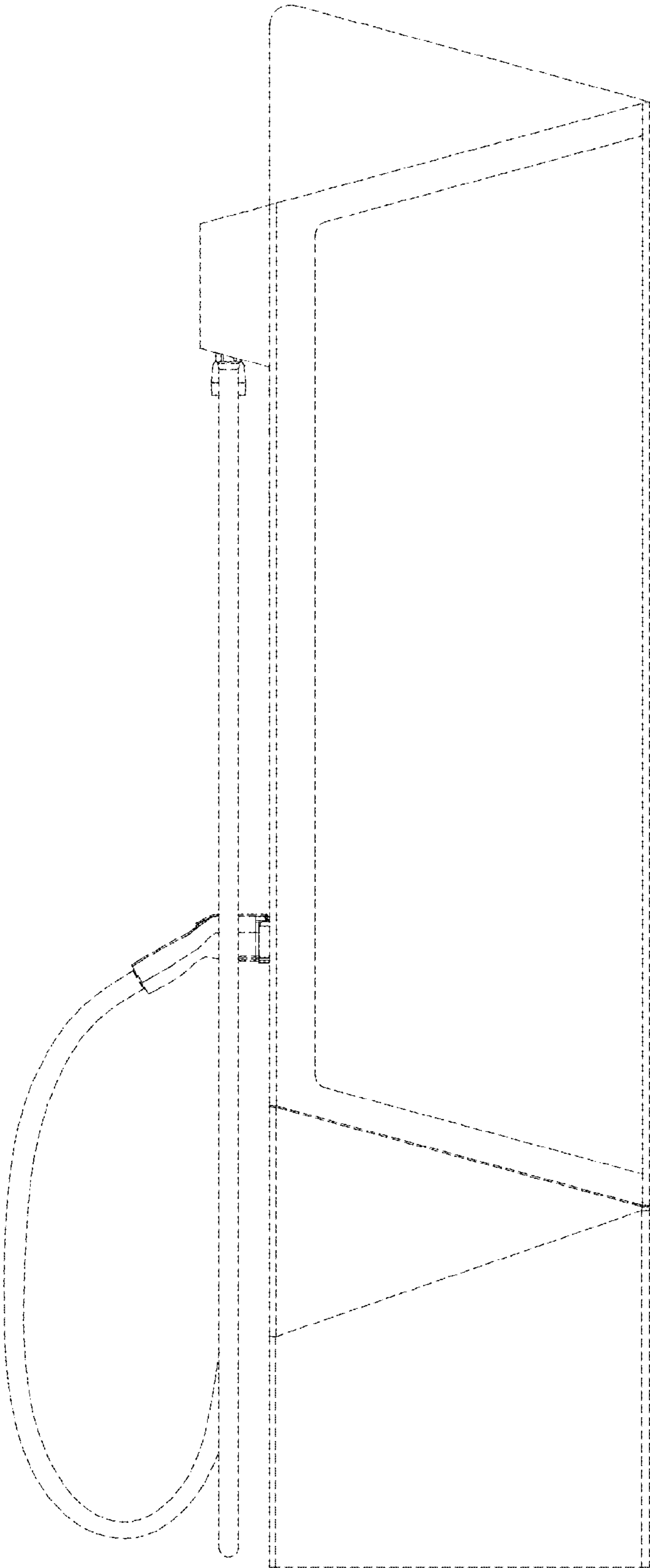

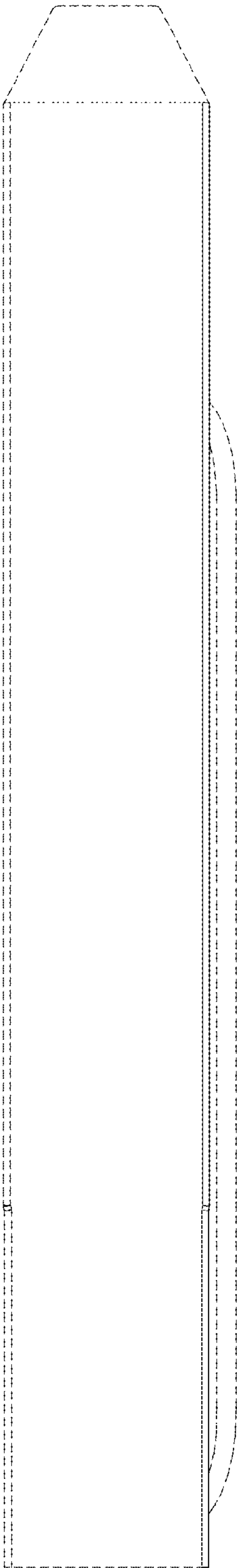

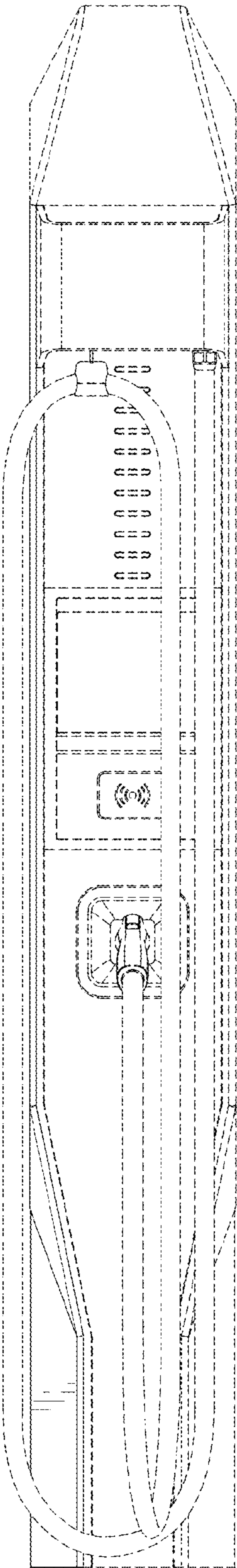

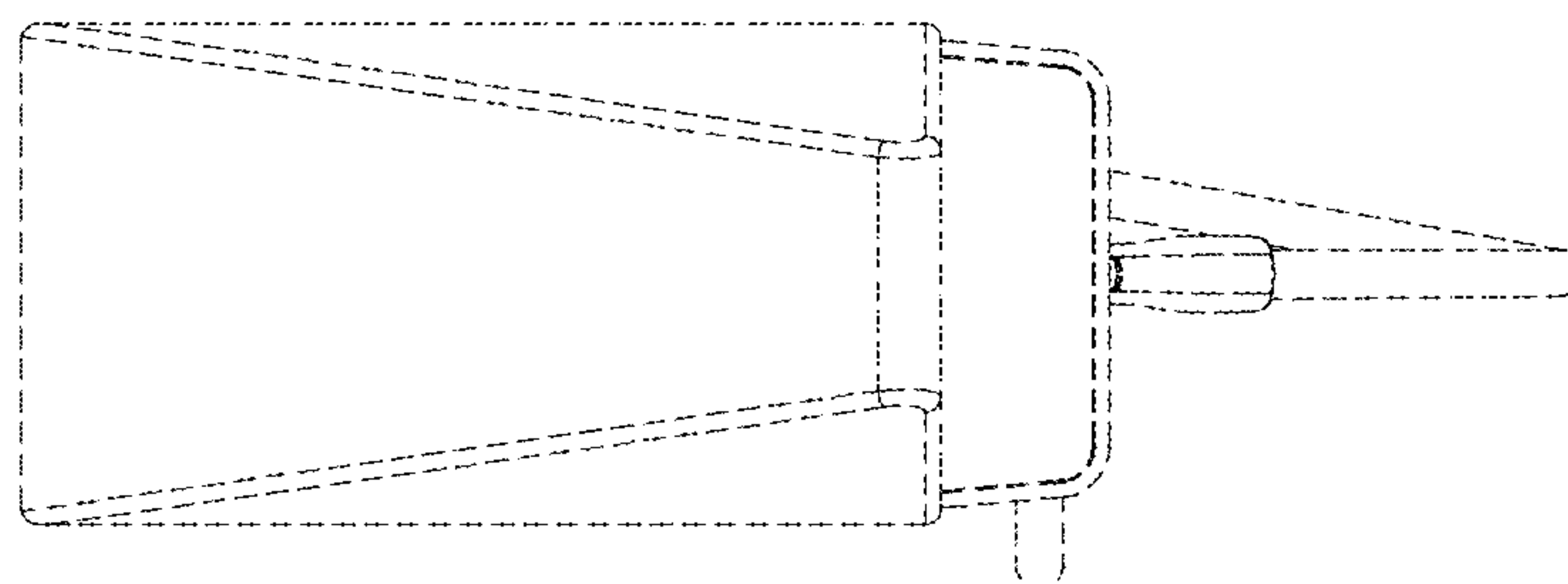

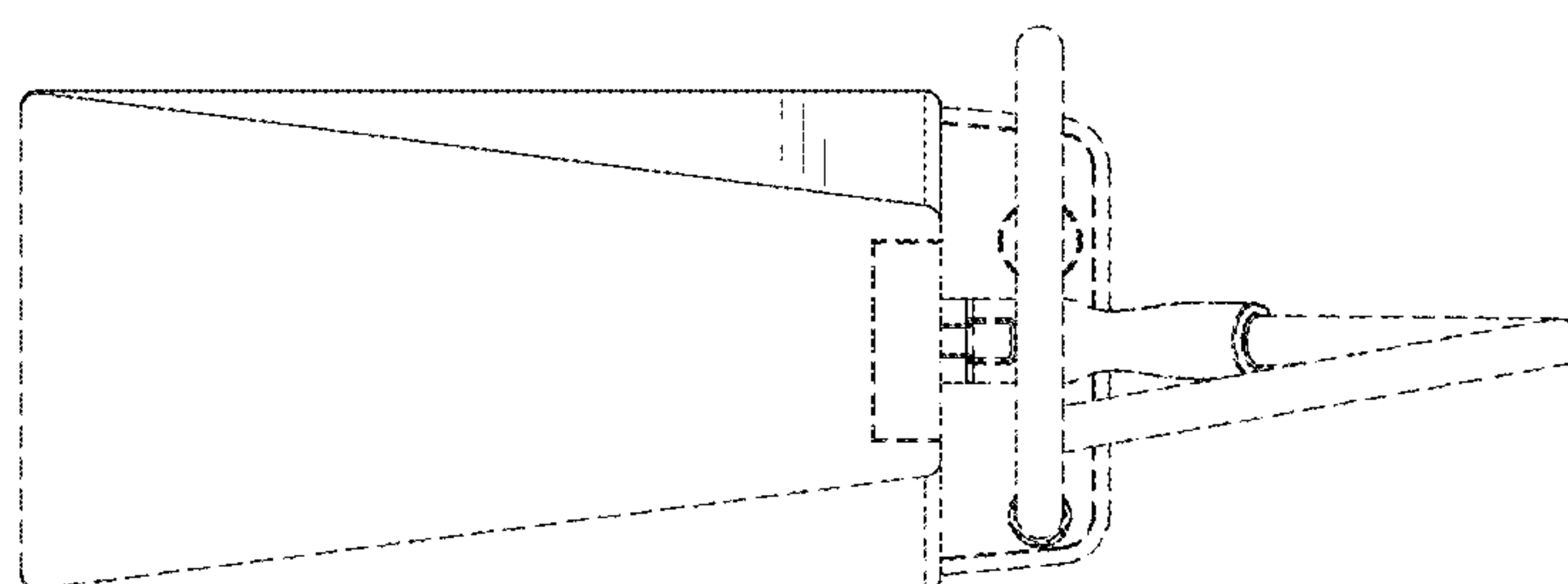
