DESCRIPTION

dental implant abutment;

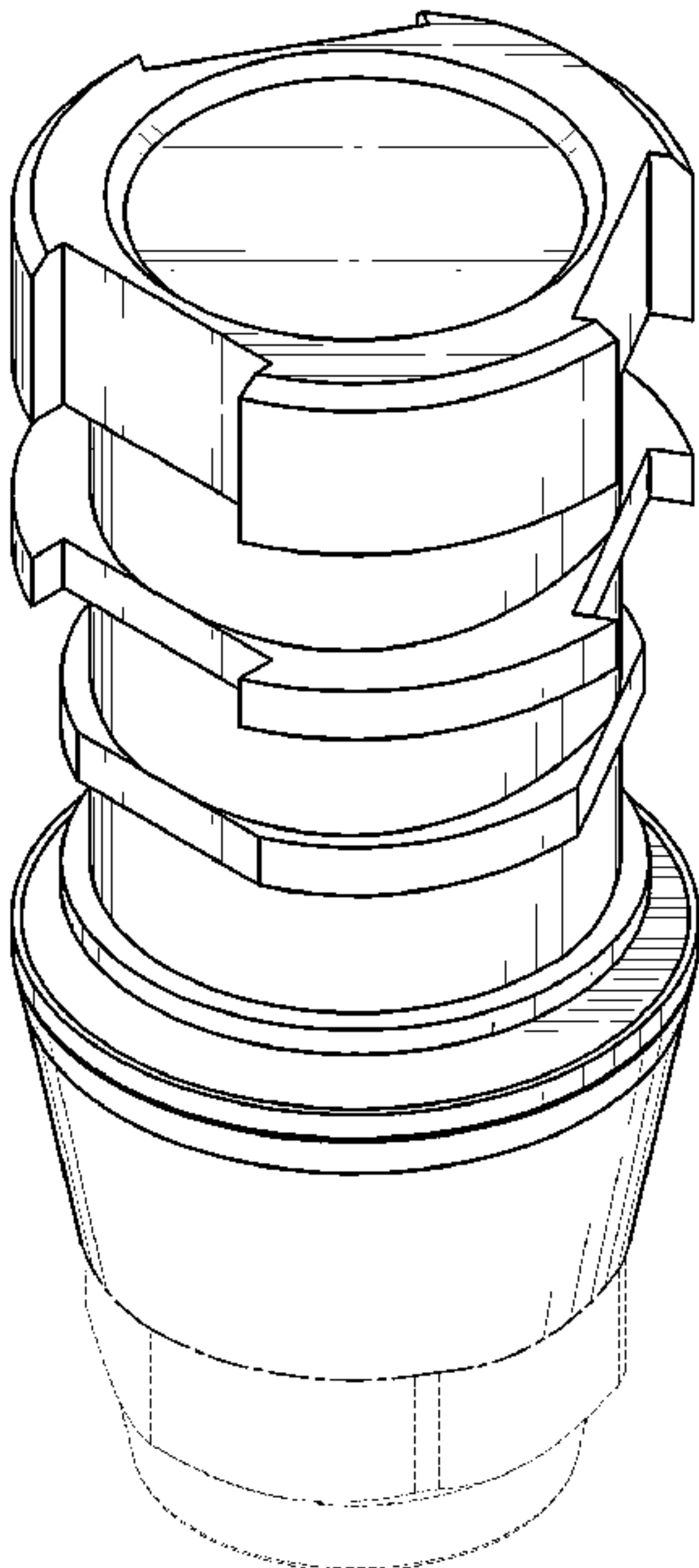

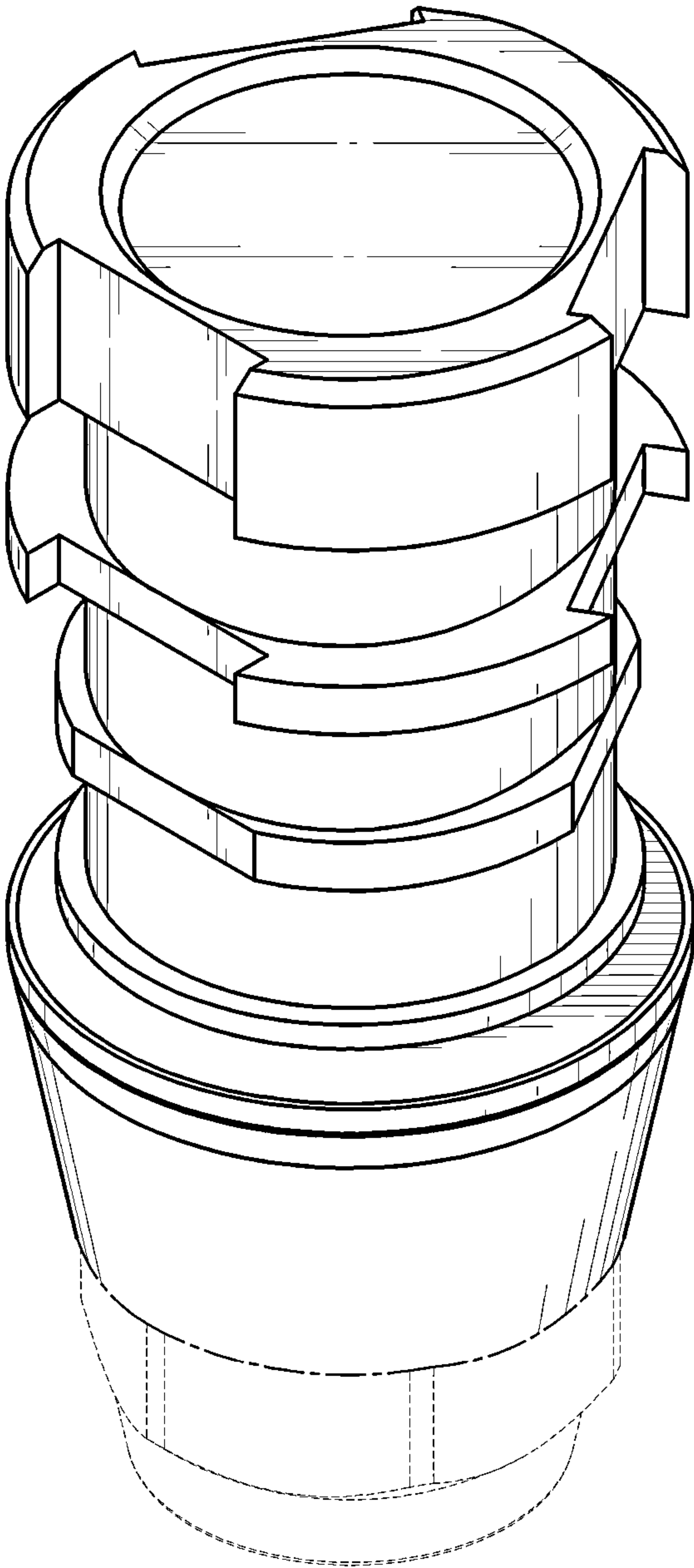

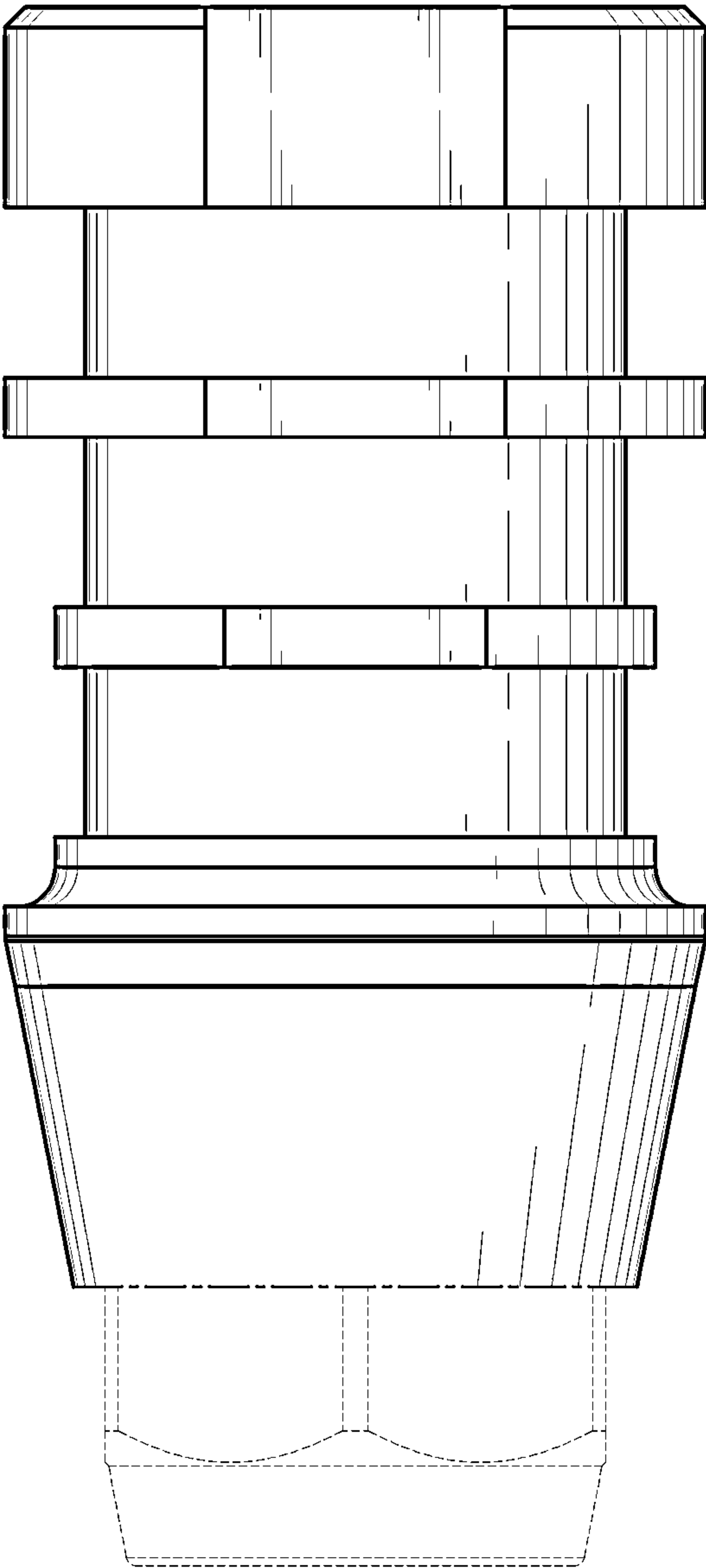

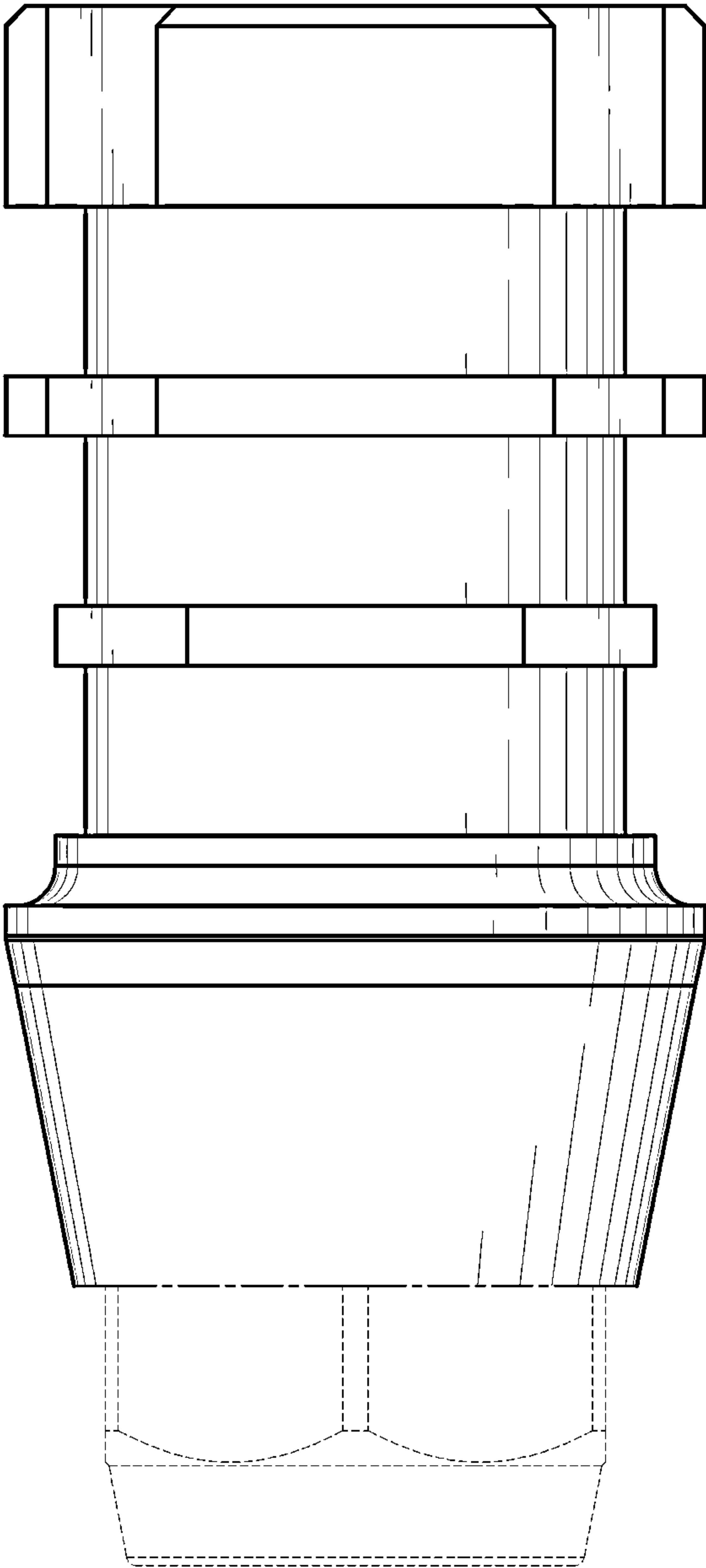

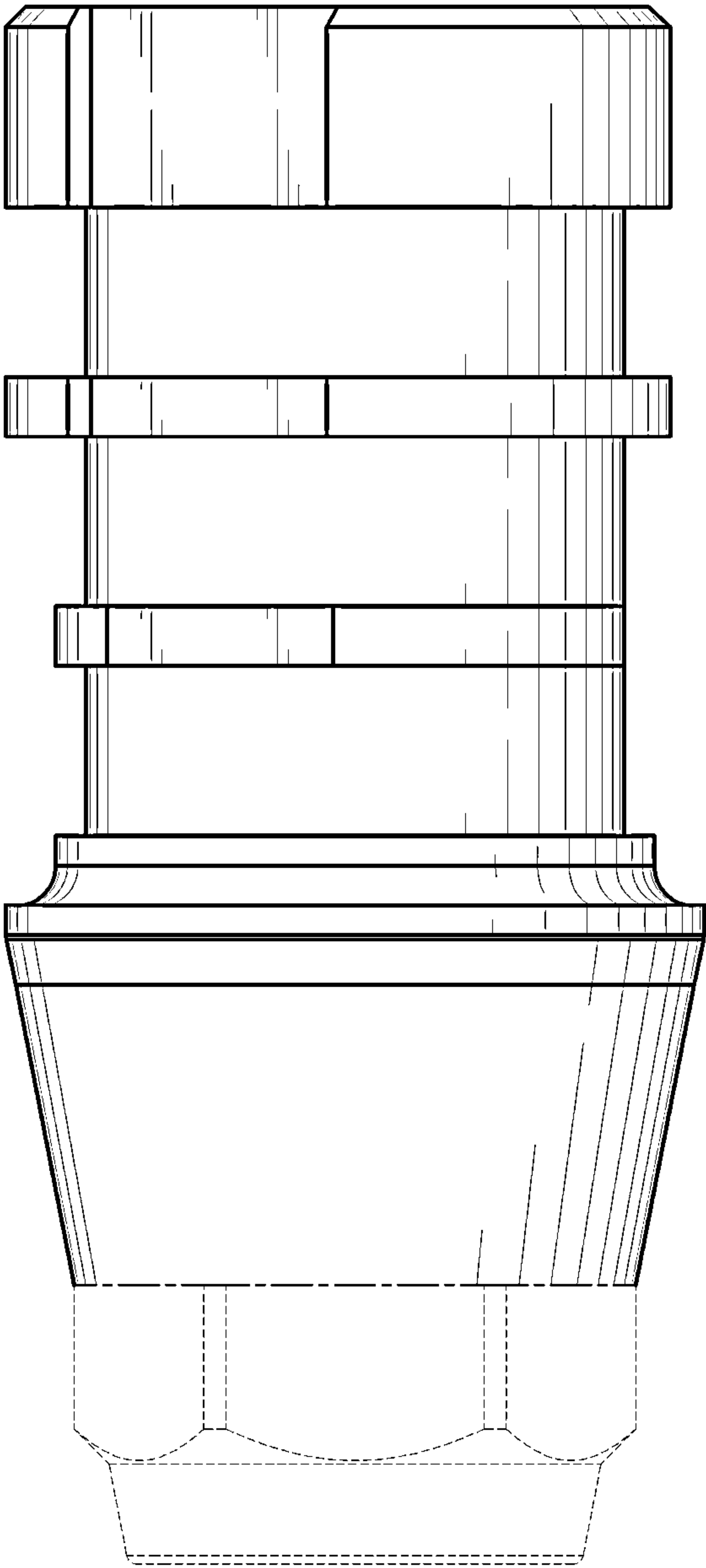

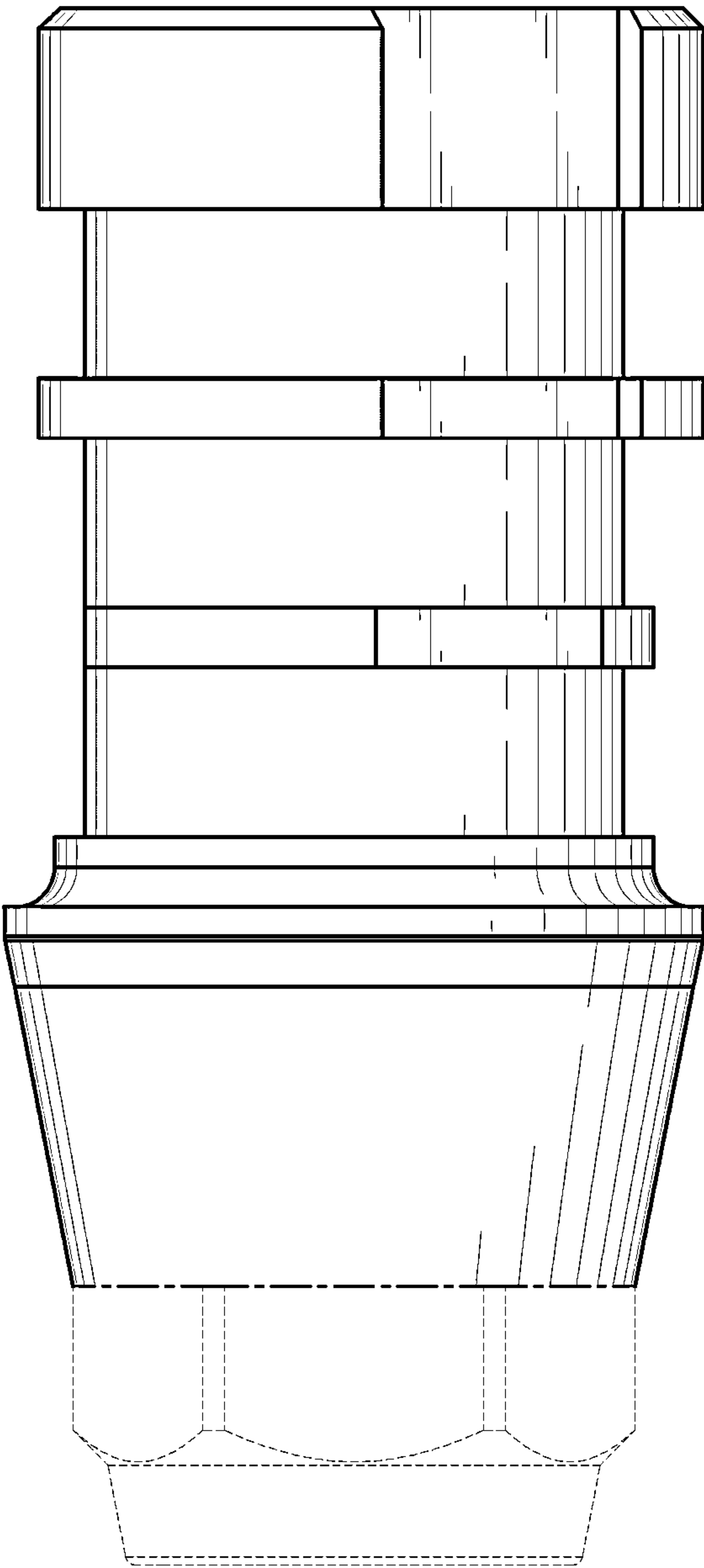

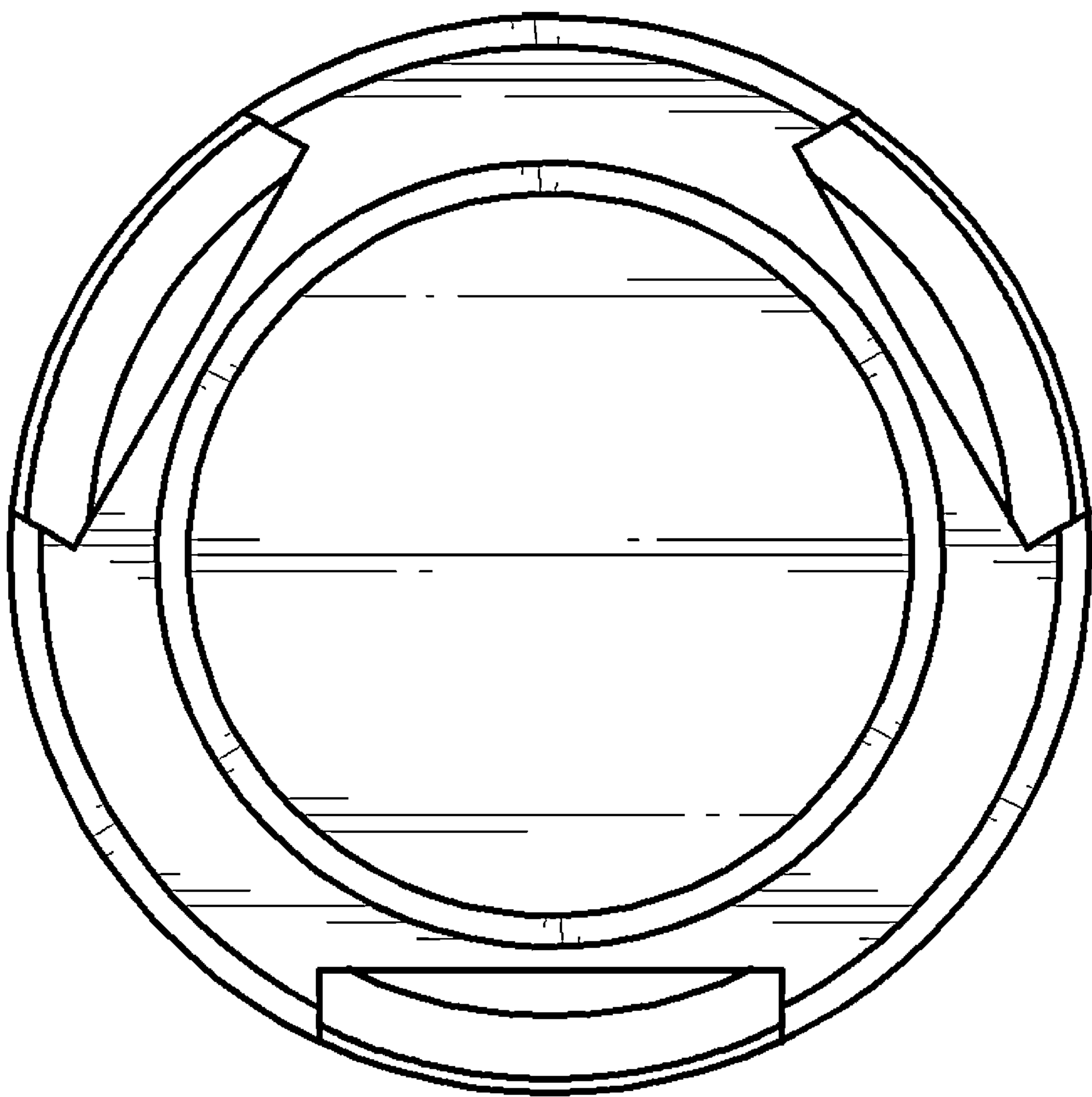

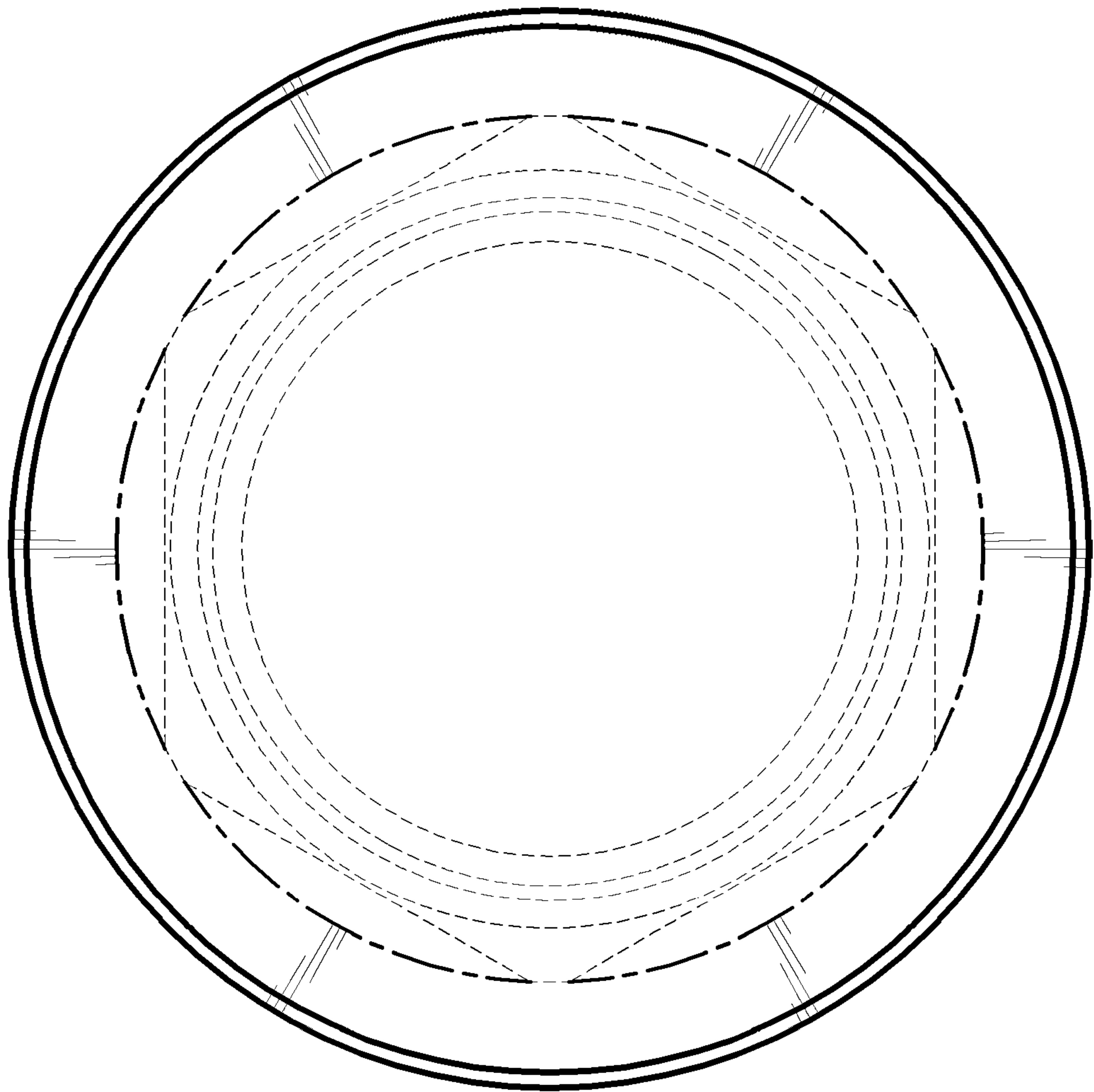
