FIG. 5 is a front elevation view thereof;

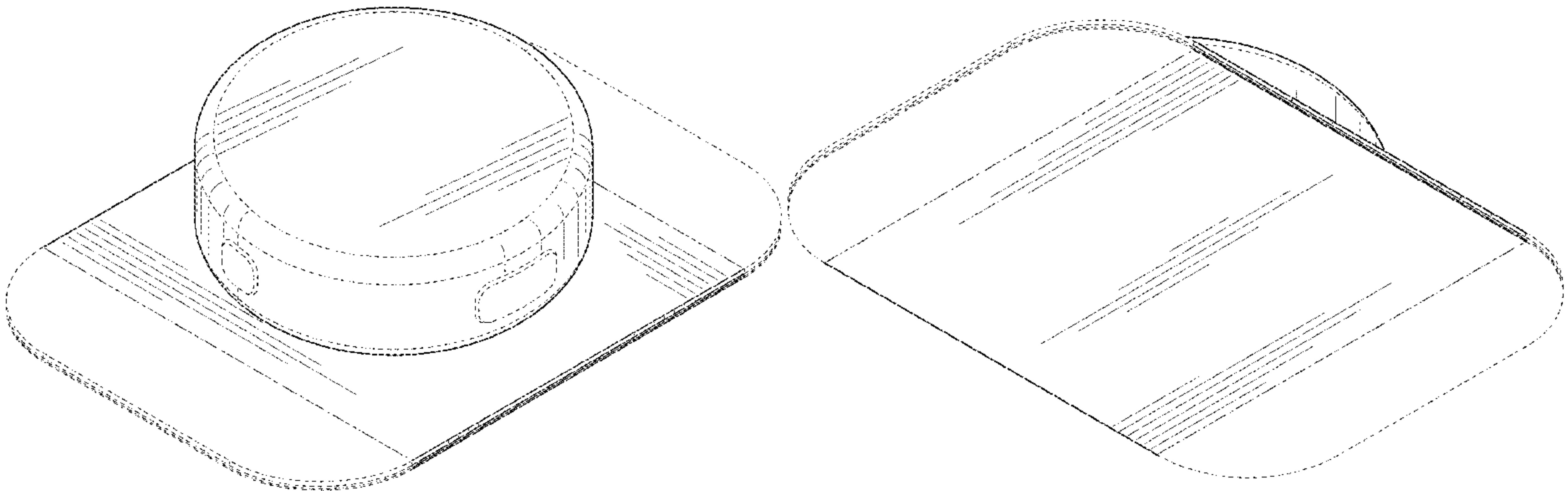
FIG. 6 is a top, plan view thereof;

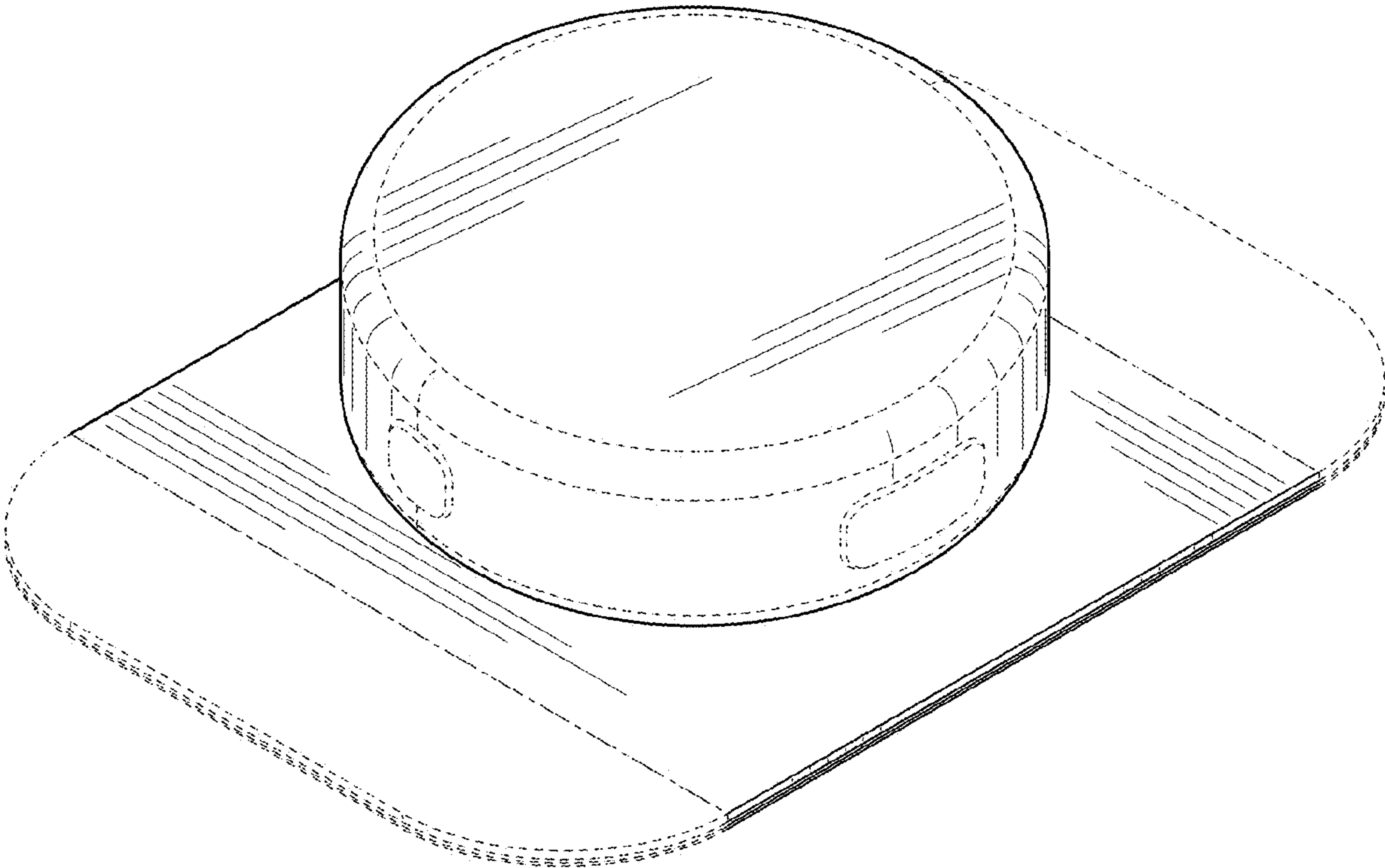

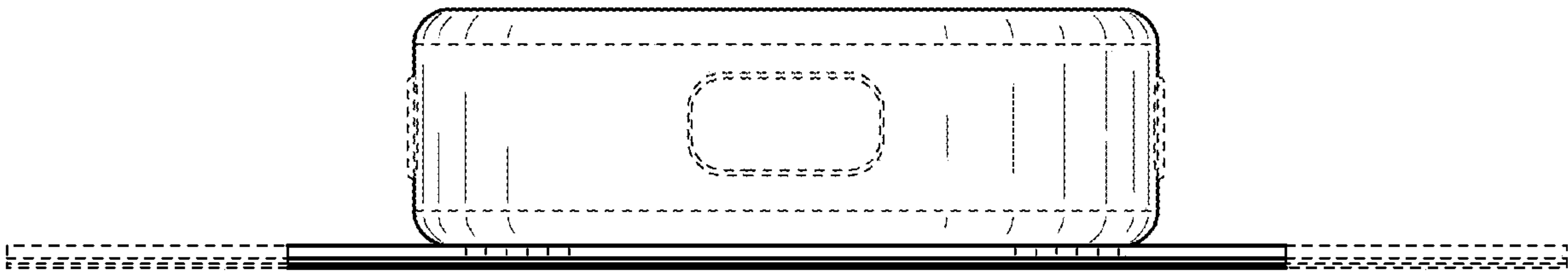

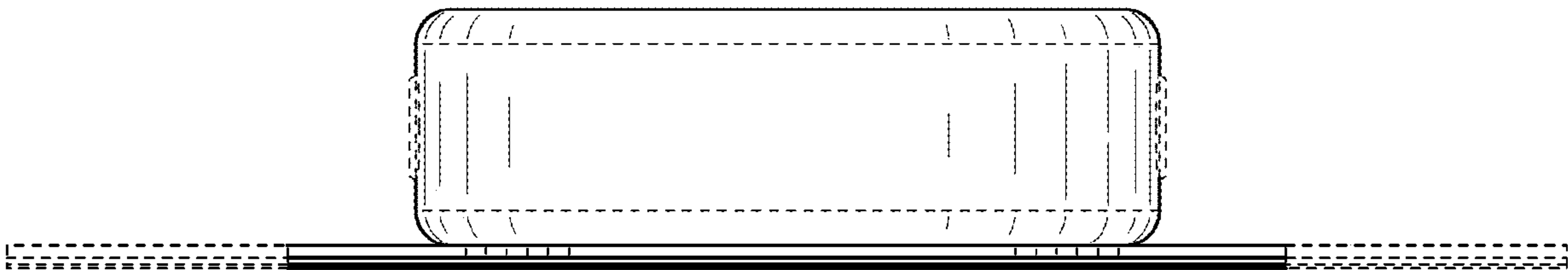

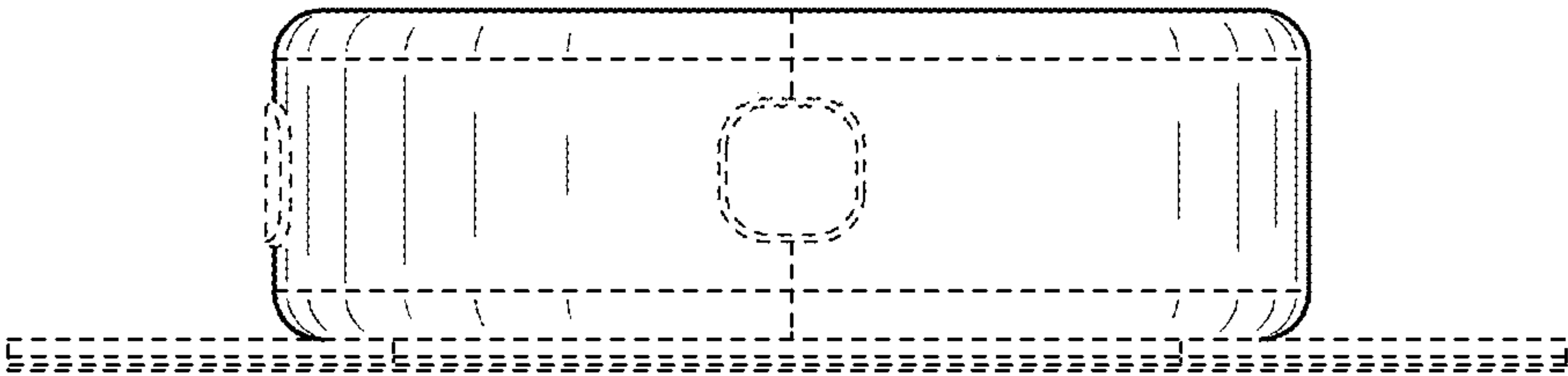

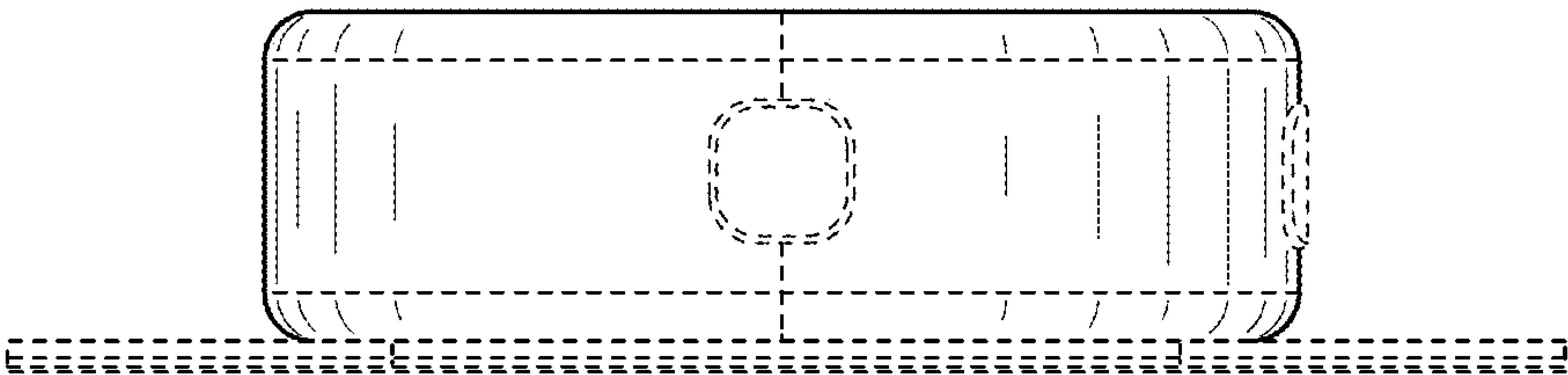

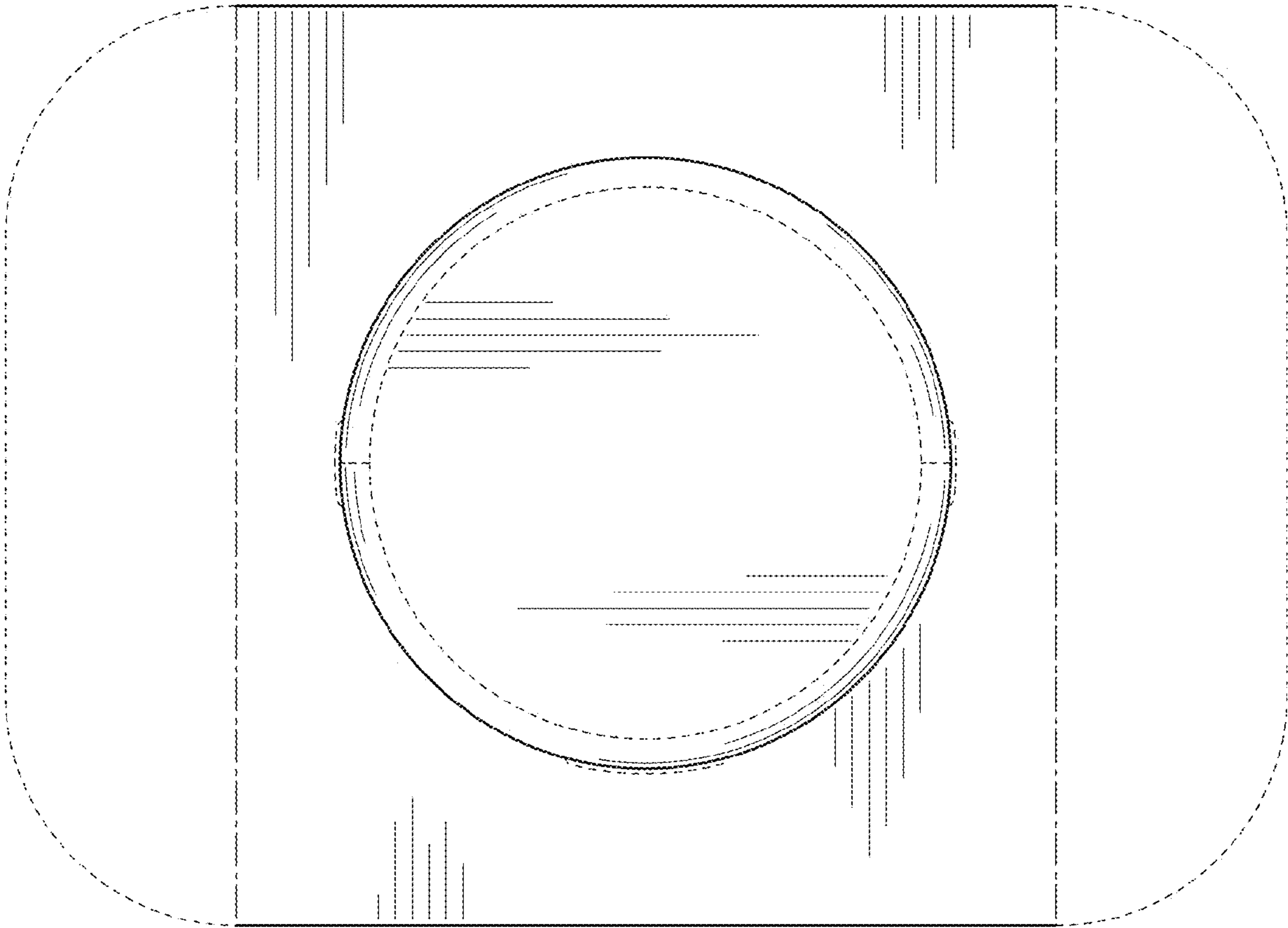

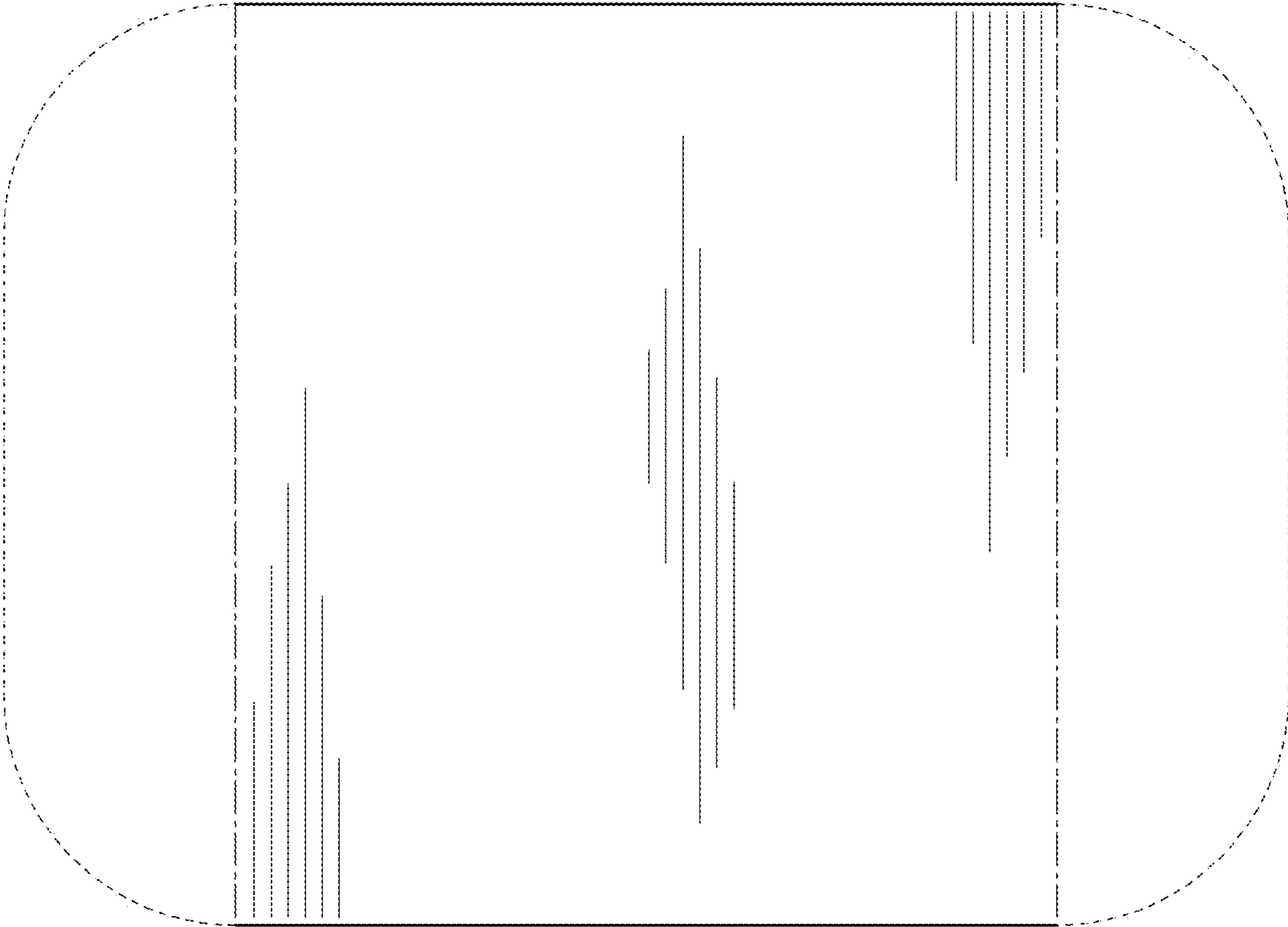

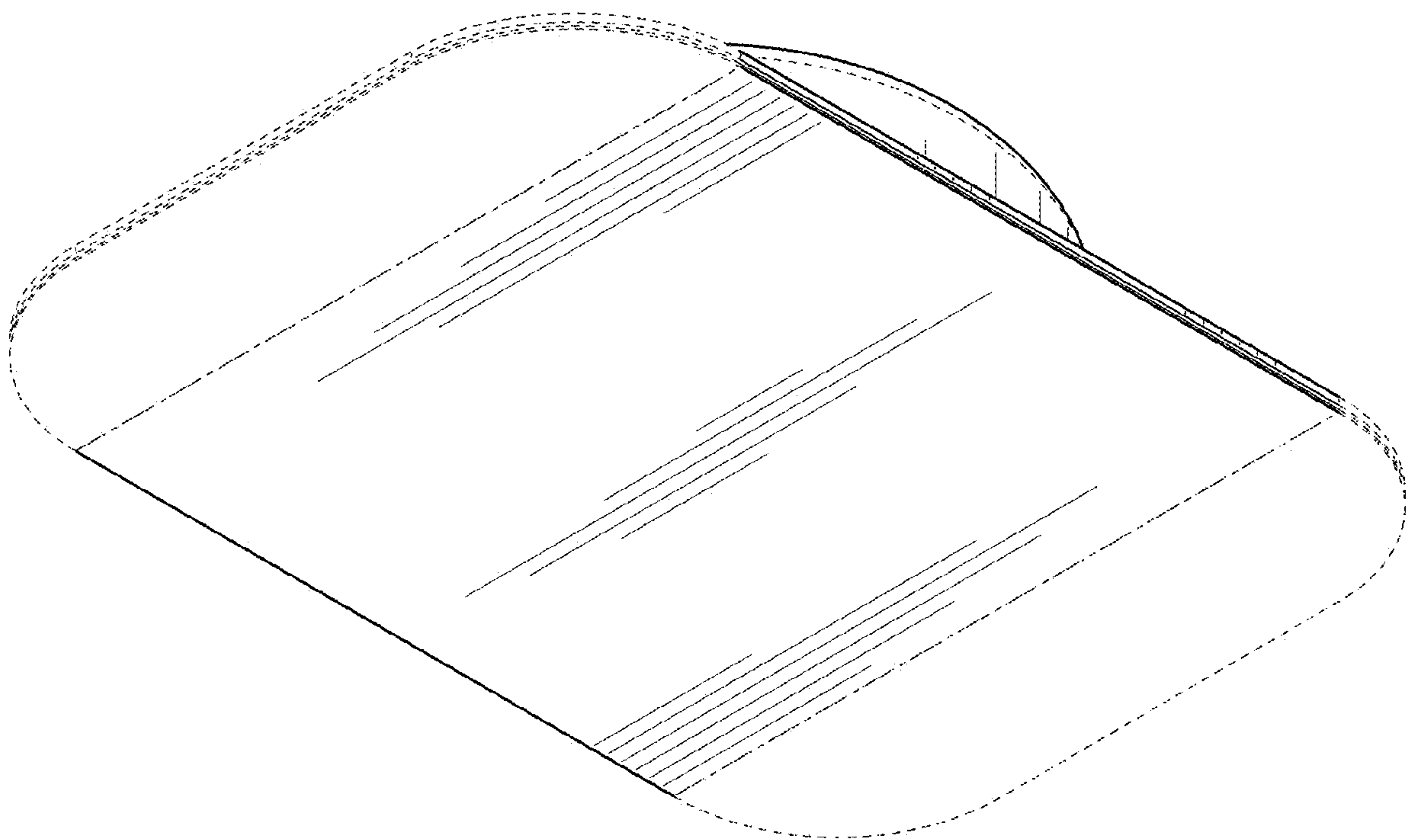
