FIG. 6 is a right side elevational view thereof;

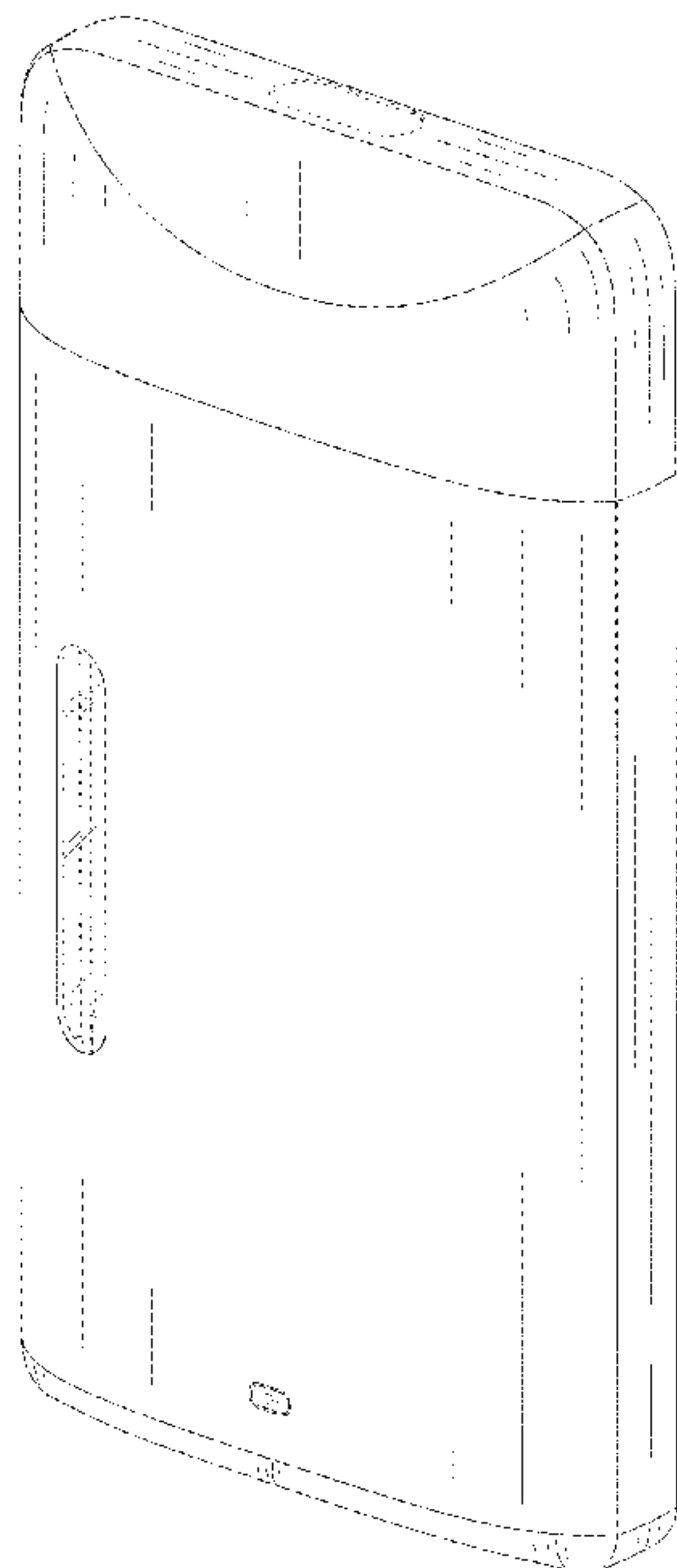
FIG. 7 is an enlarged top plan view thereof; and,

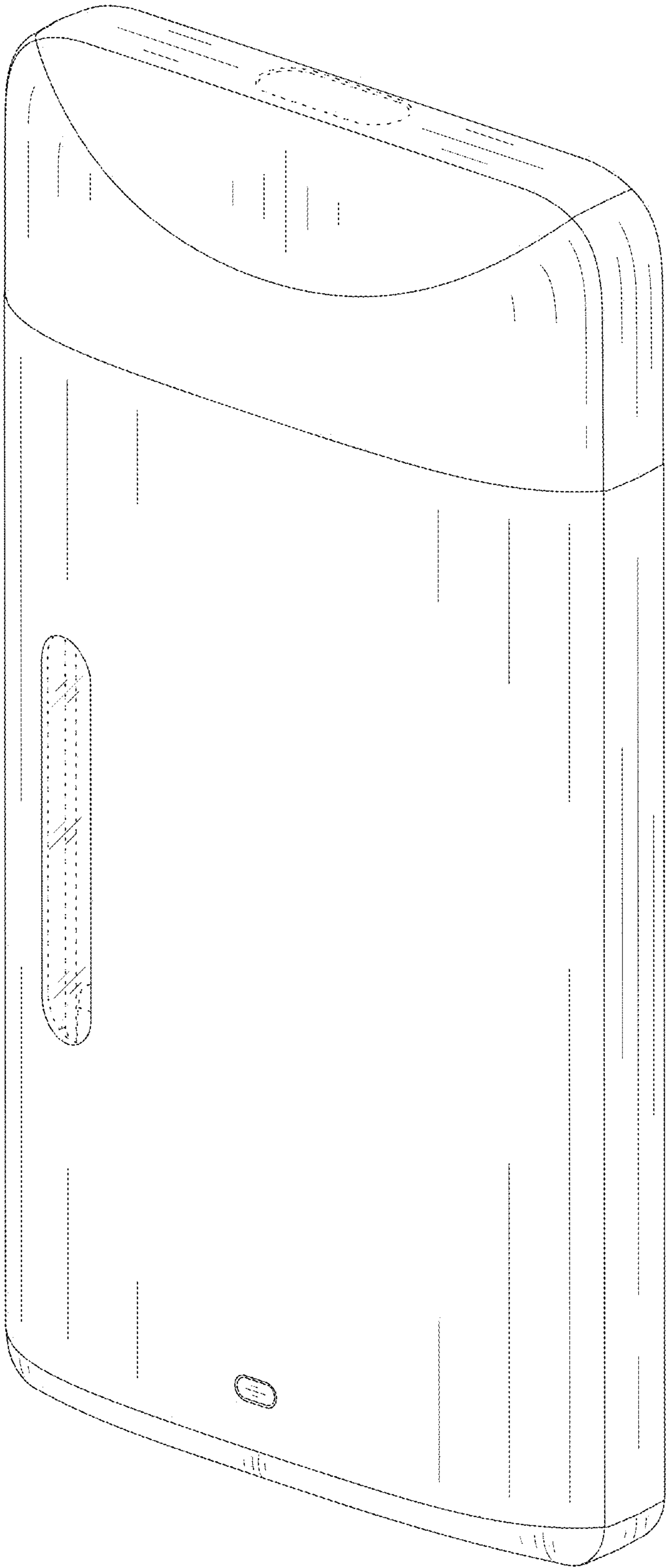

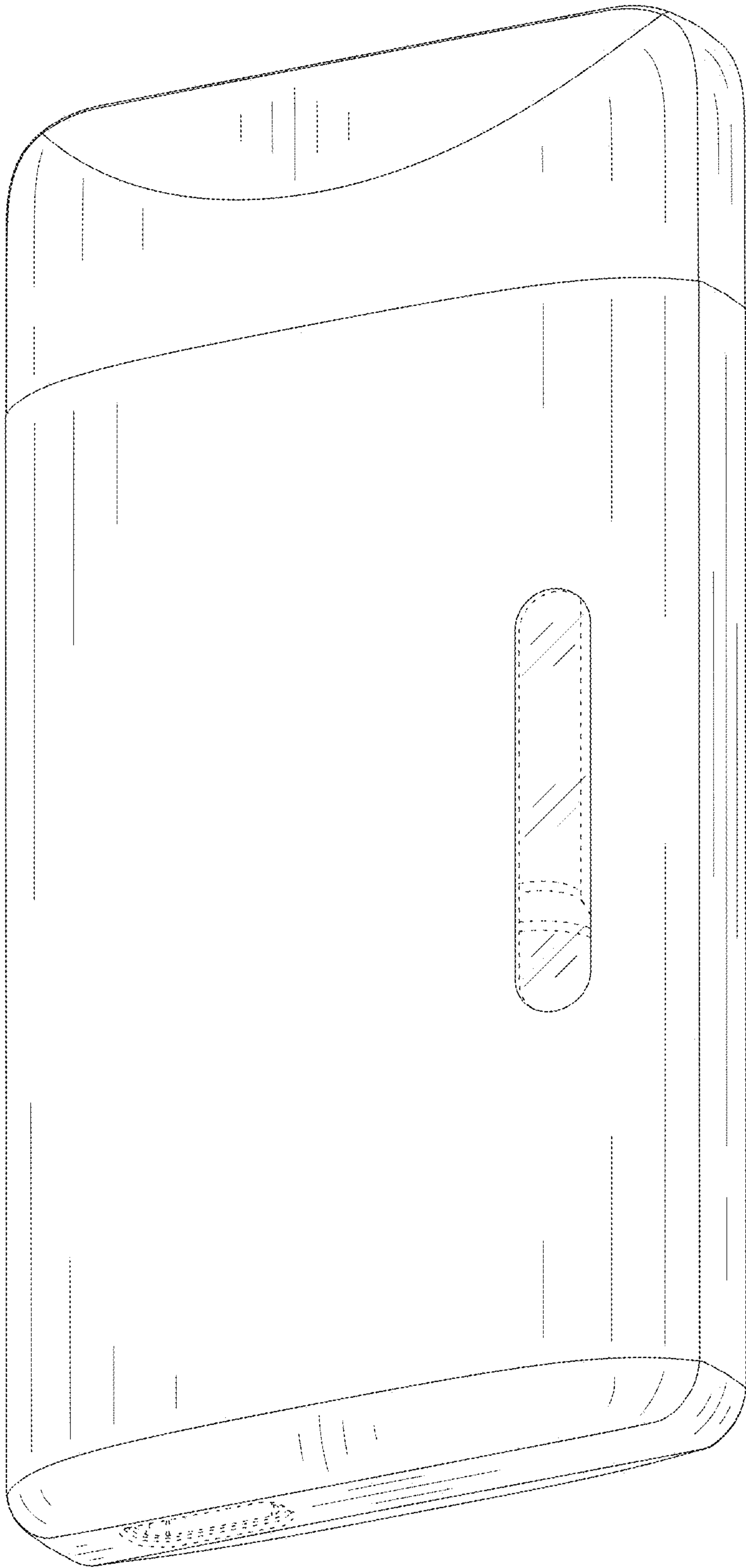

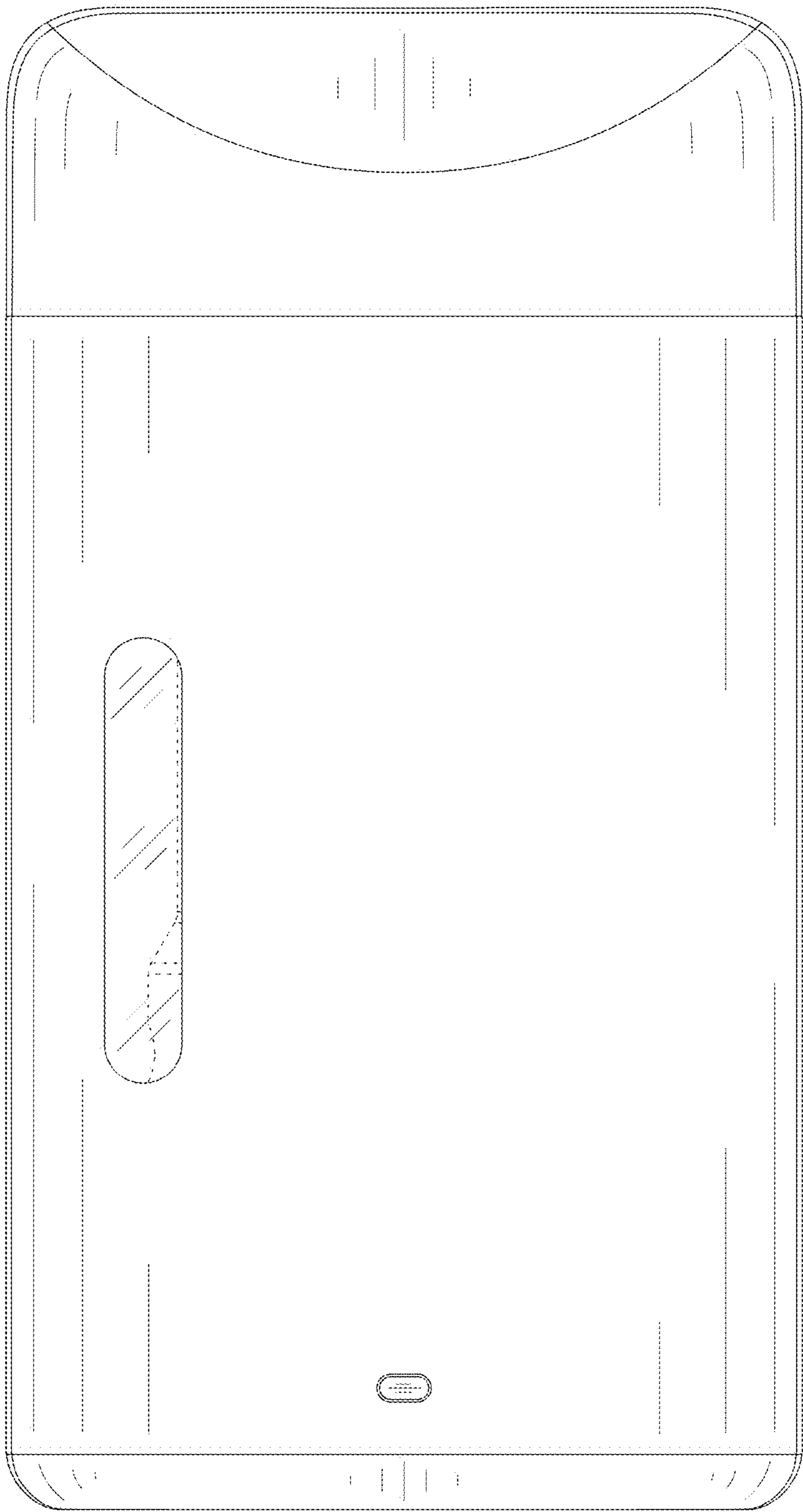

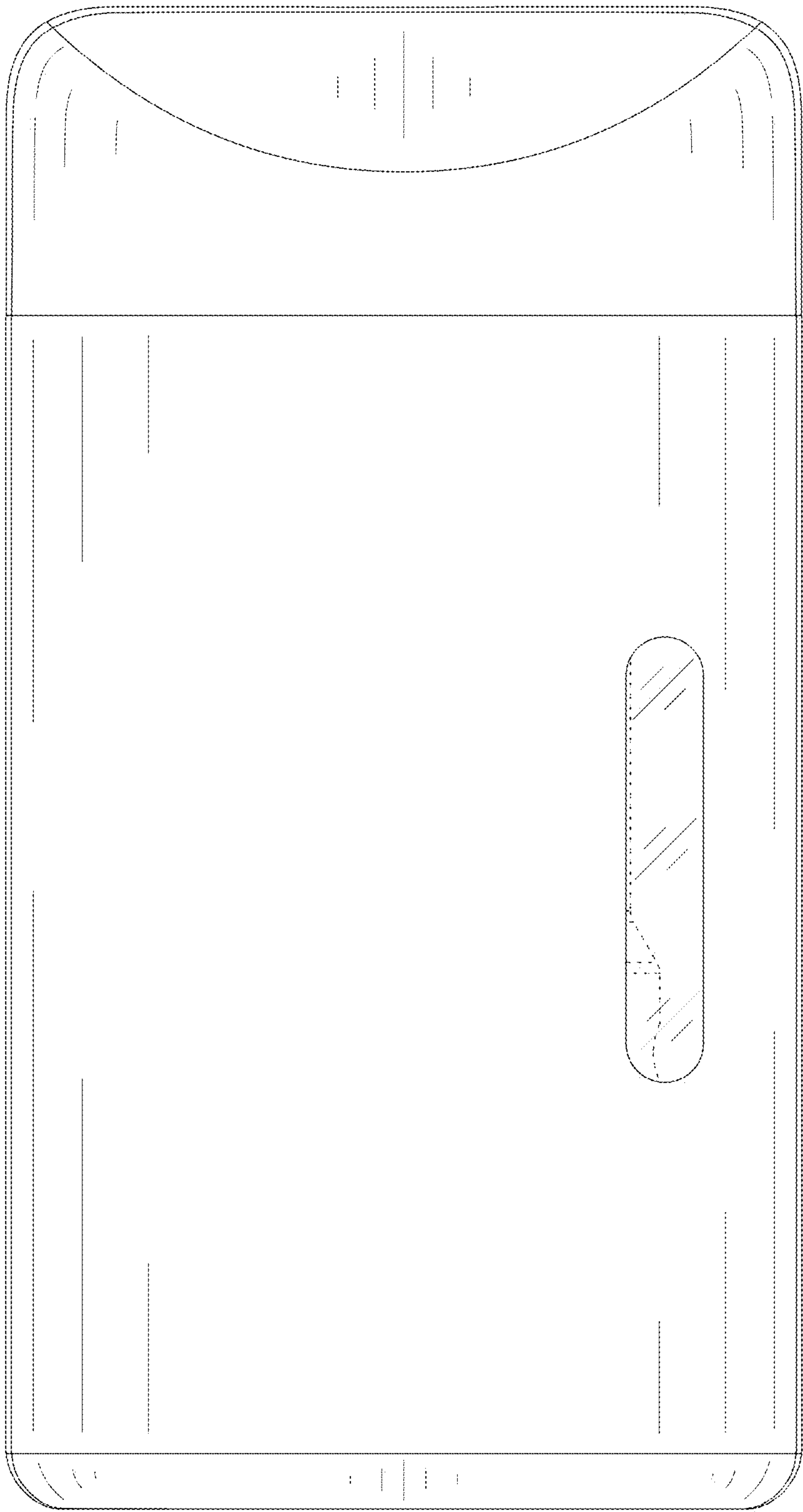

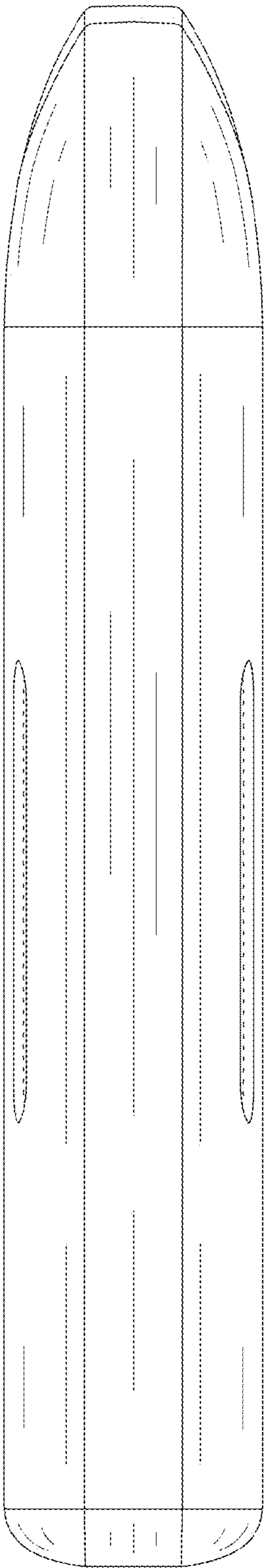

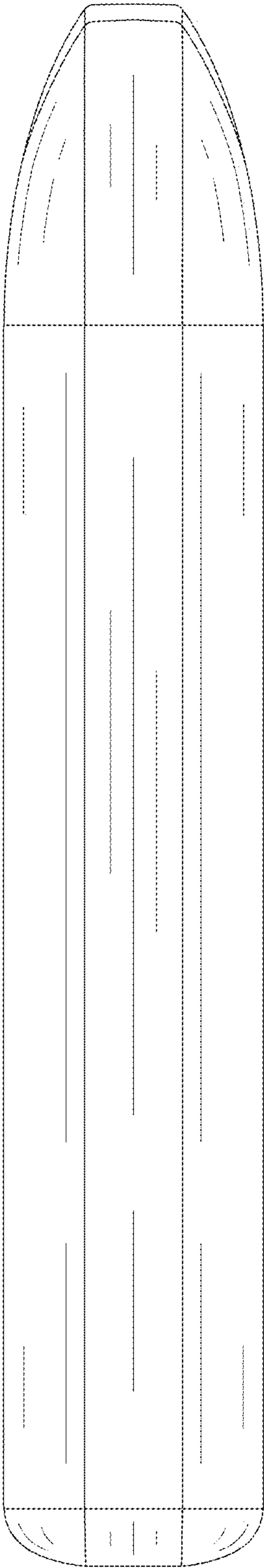

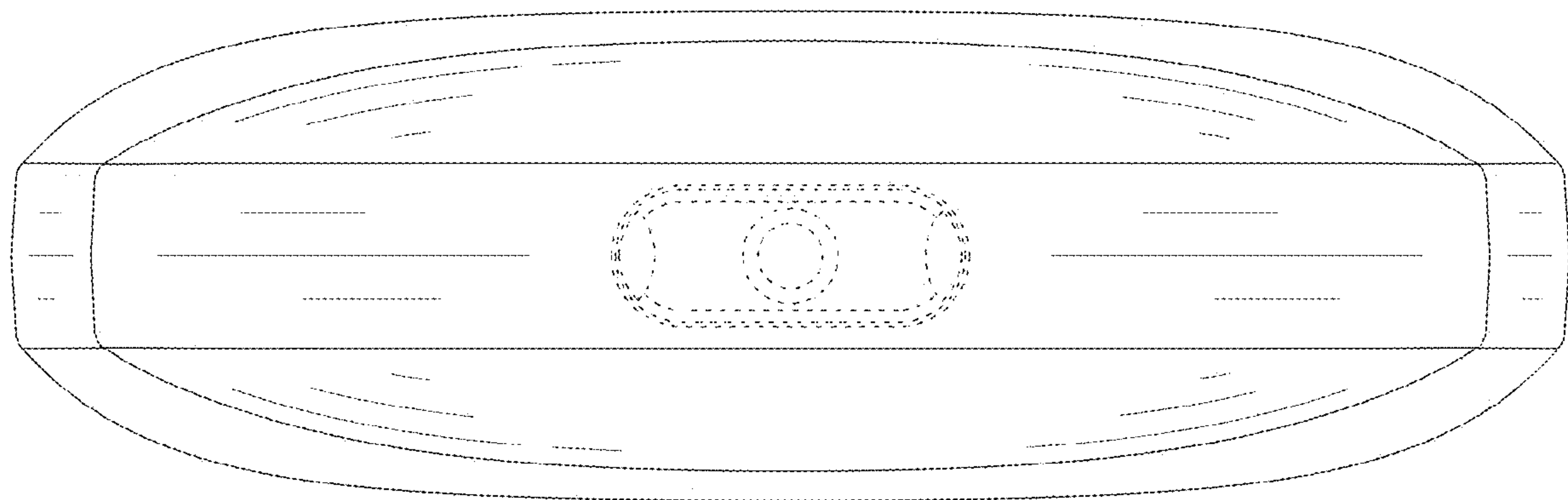

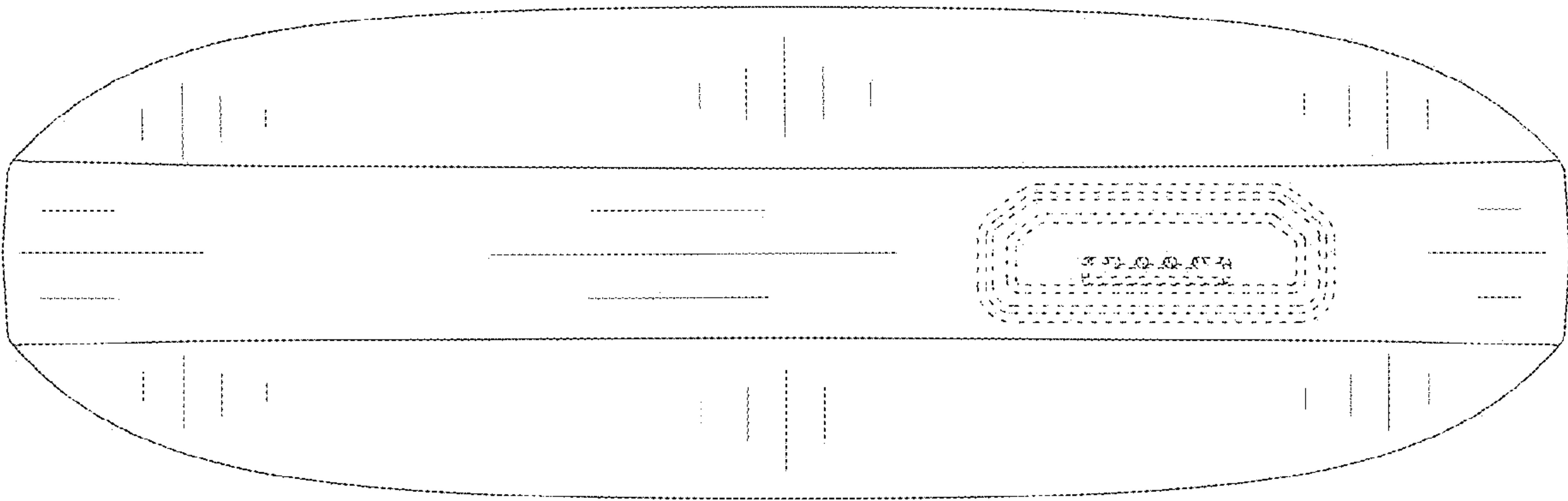
