The ornamental design for a wheel rim, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wheel rim showing our new design;
FIG. 2 is a front elevational view thereof;

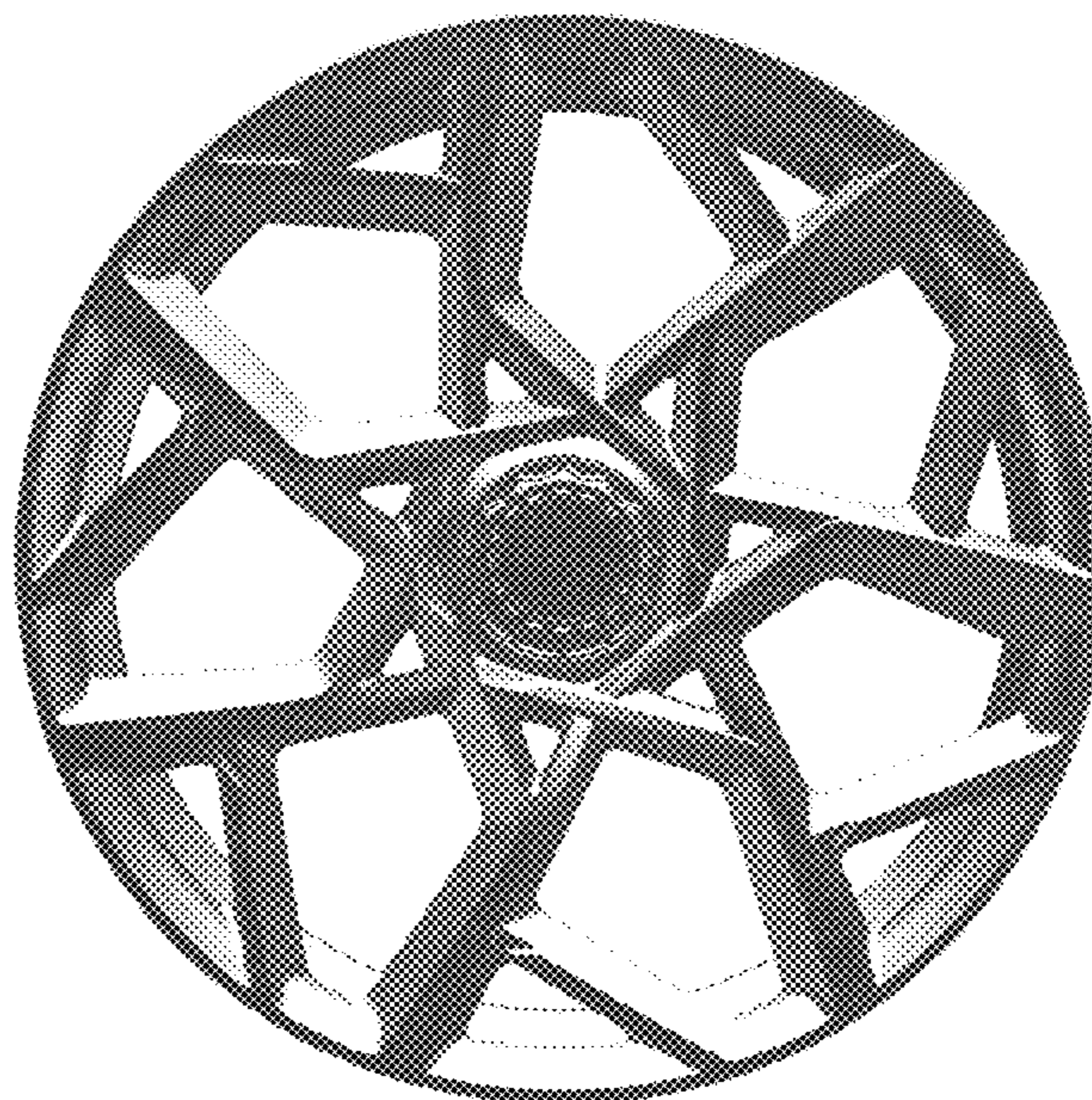
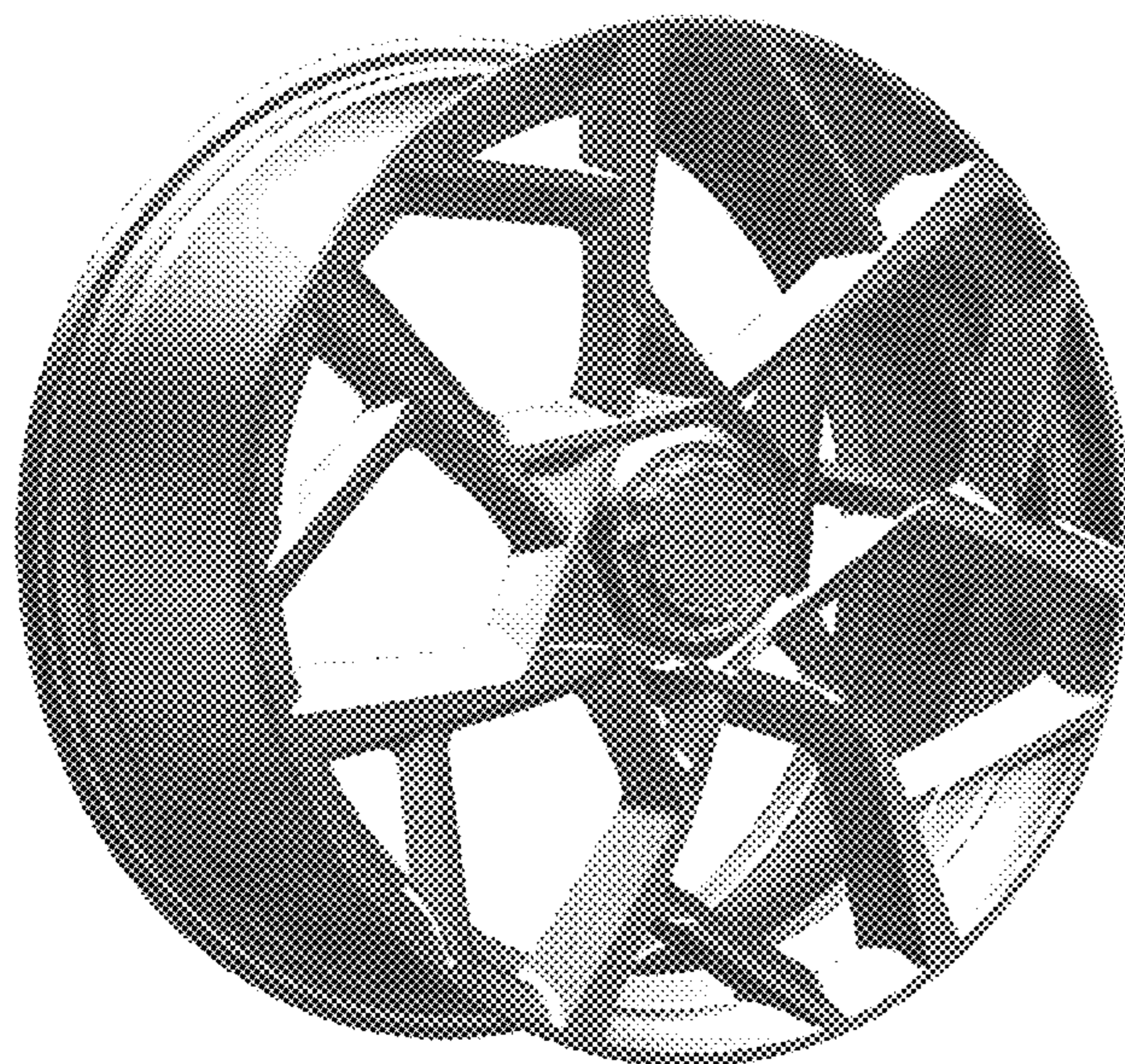

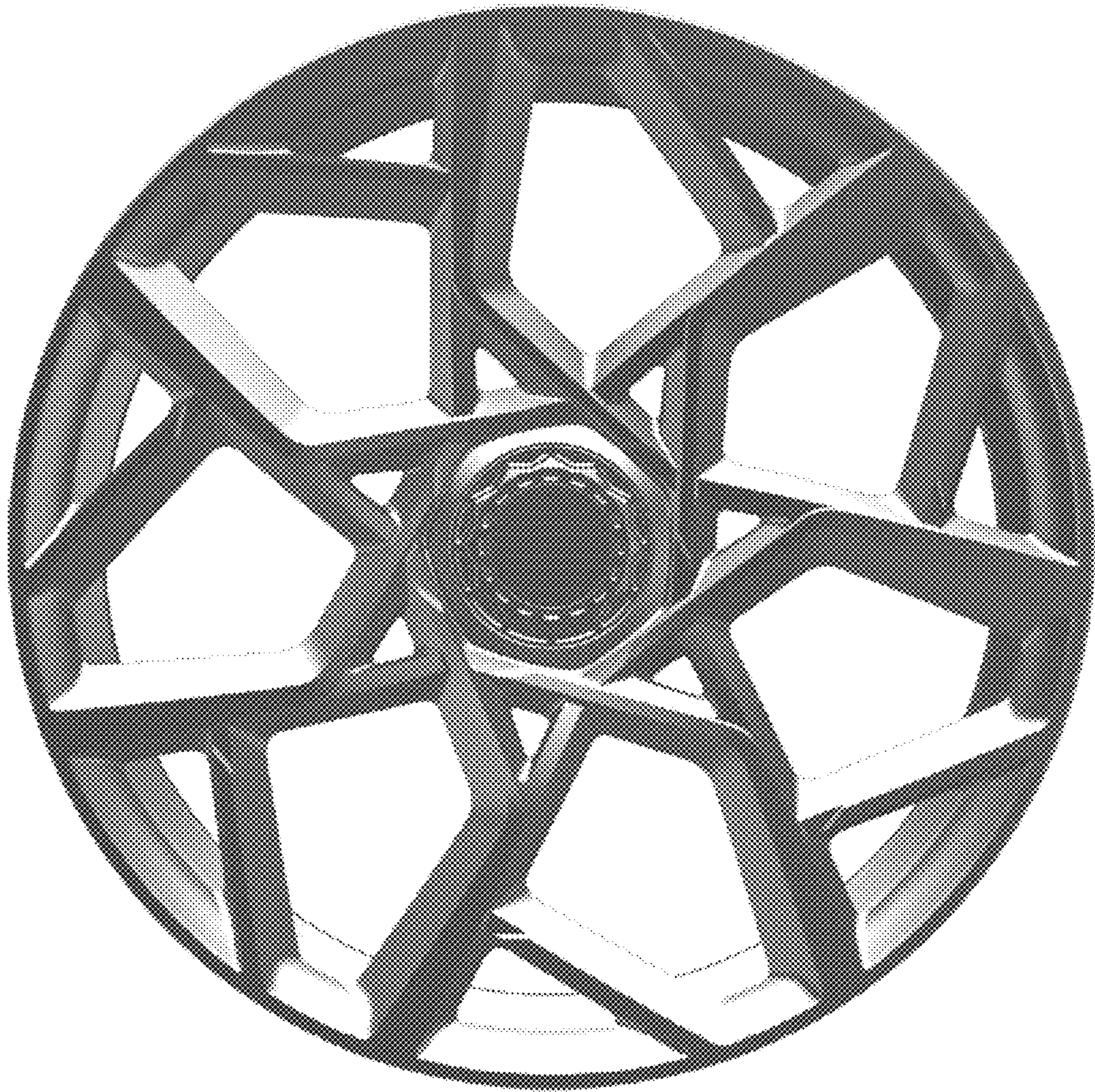

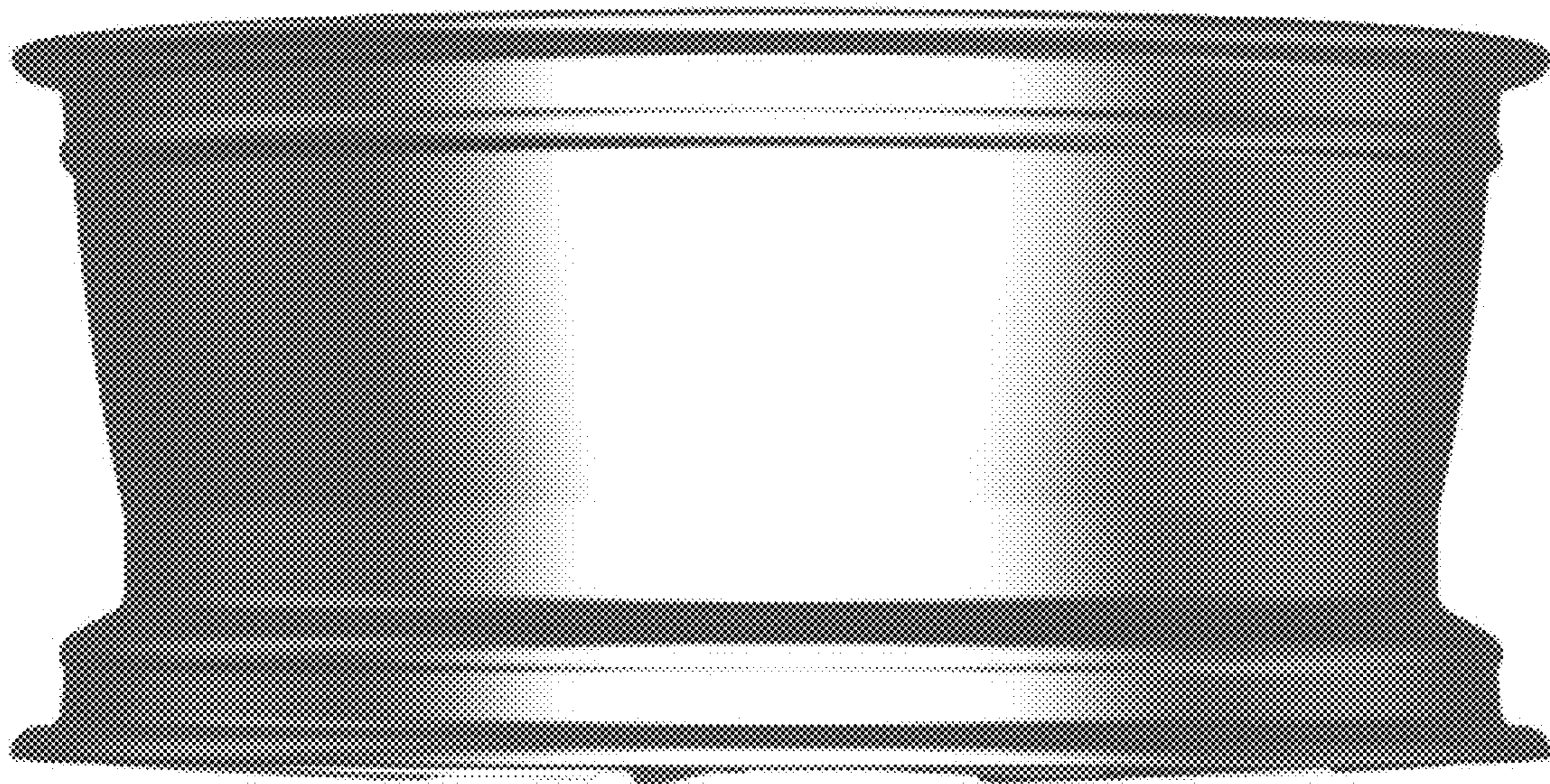

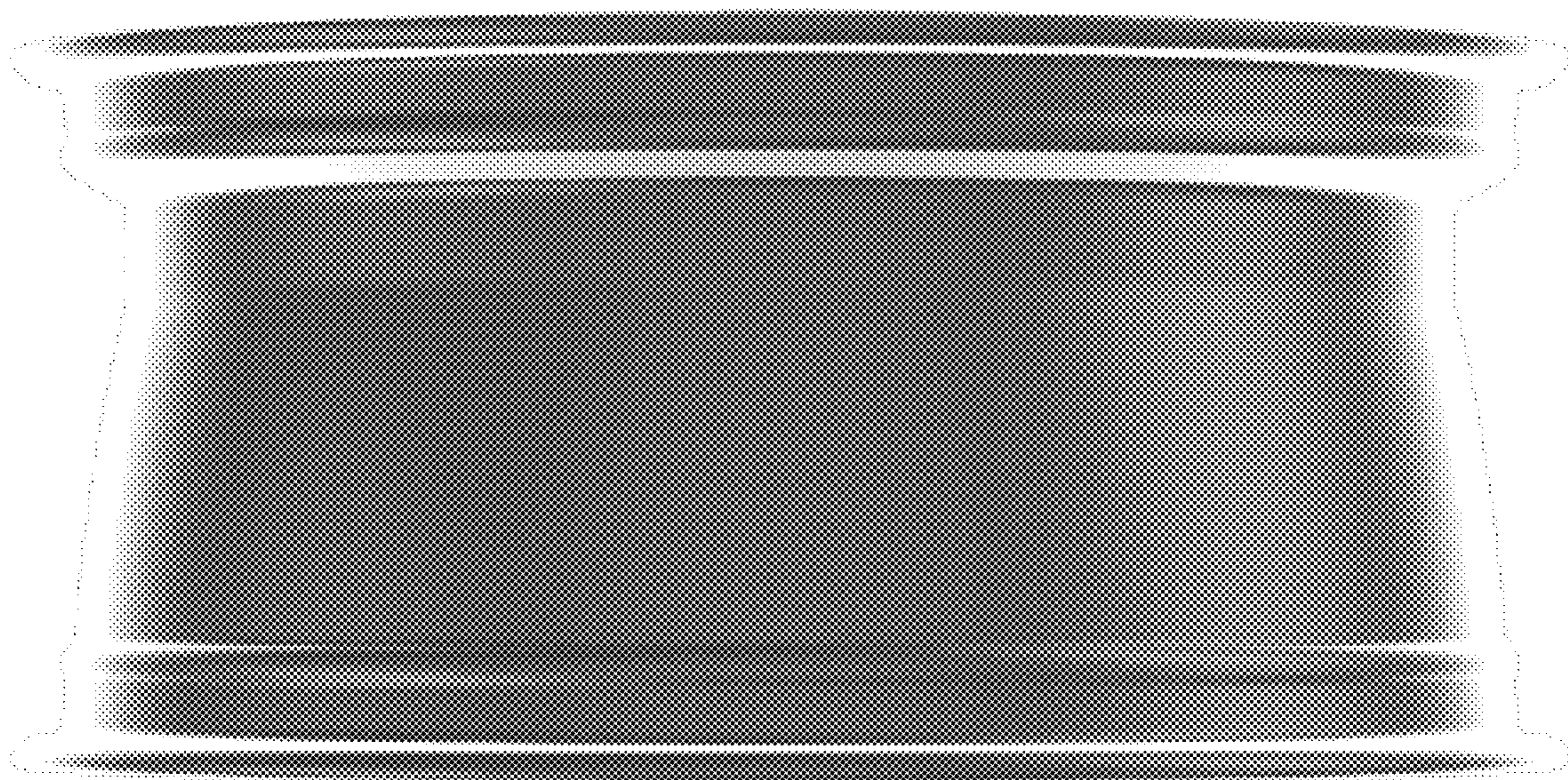

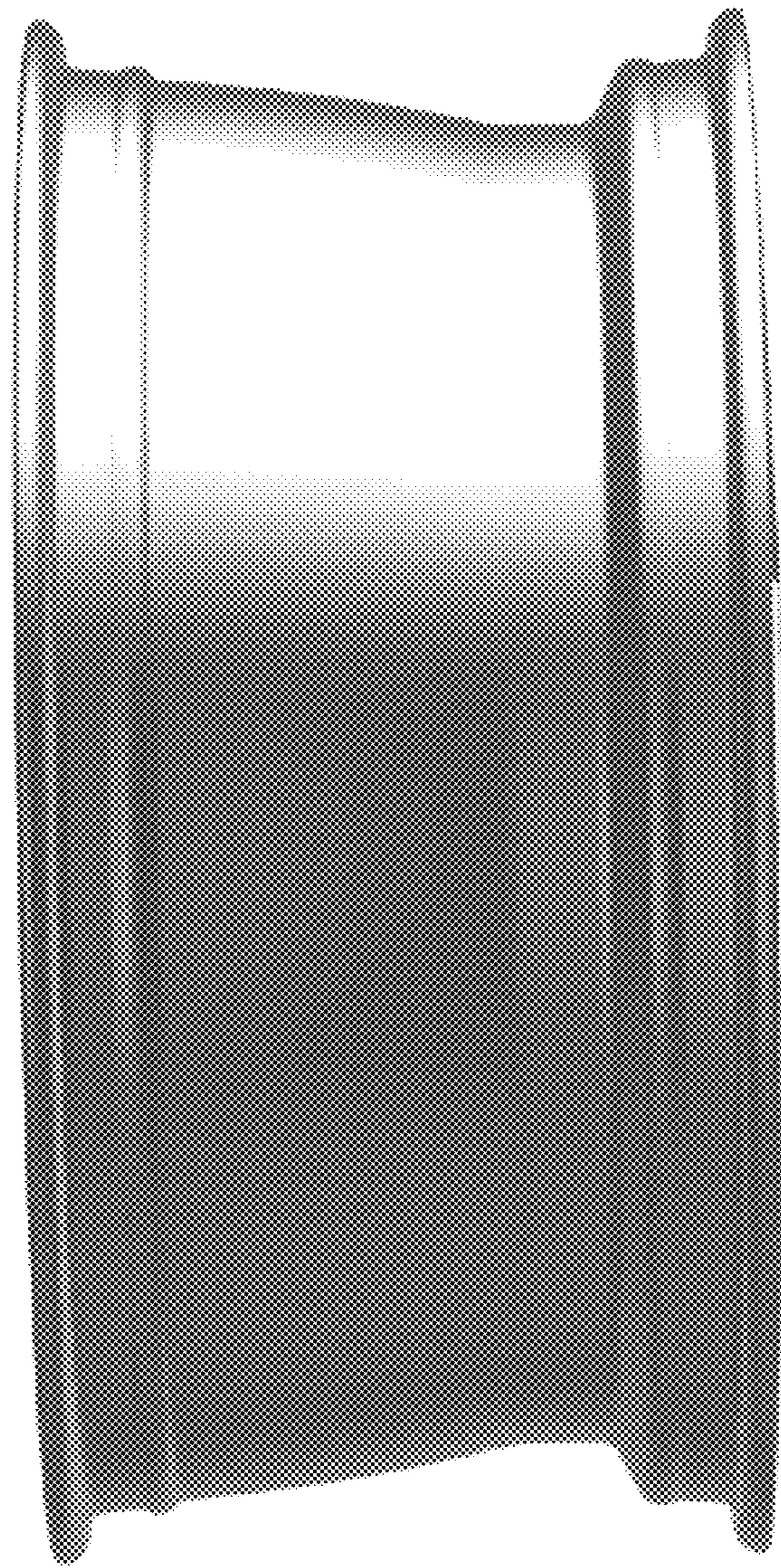
