(57) **CLAIM**

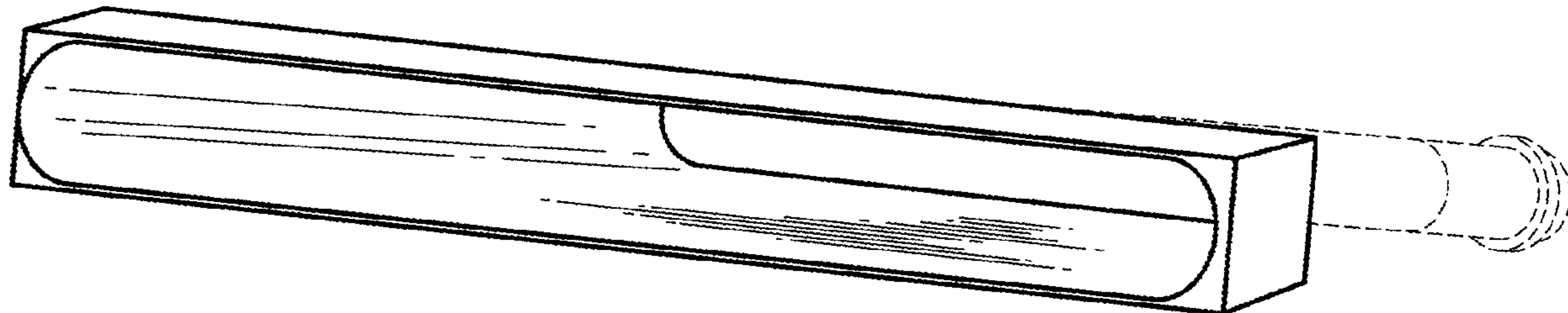
The ornamental design for a chamber inlet, as shown and described.

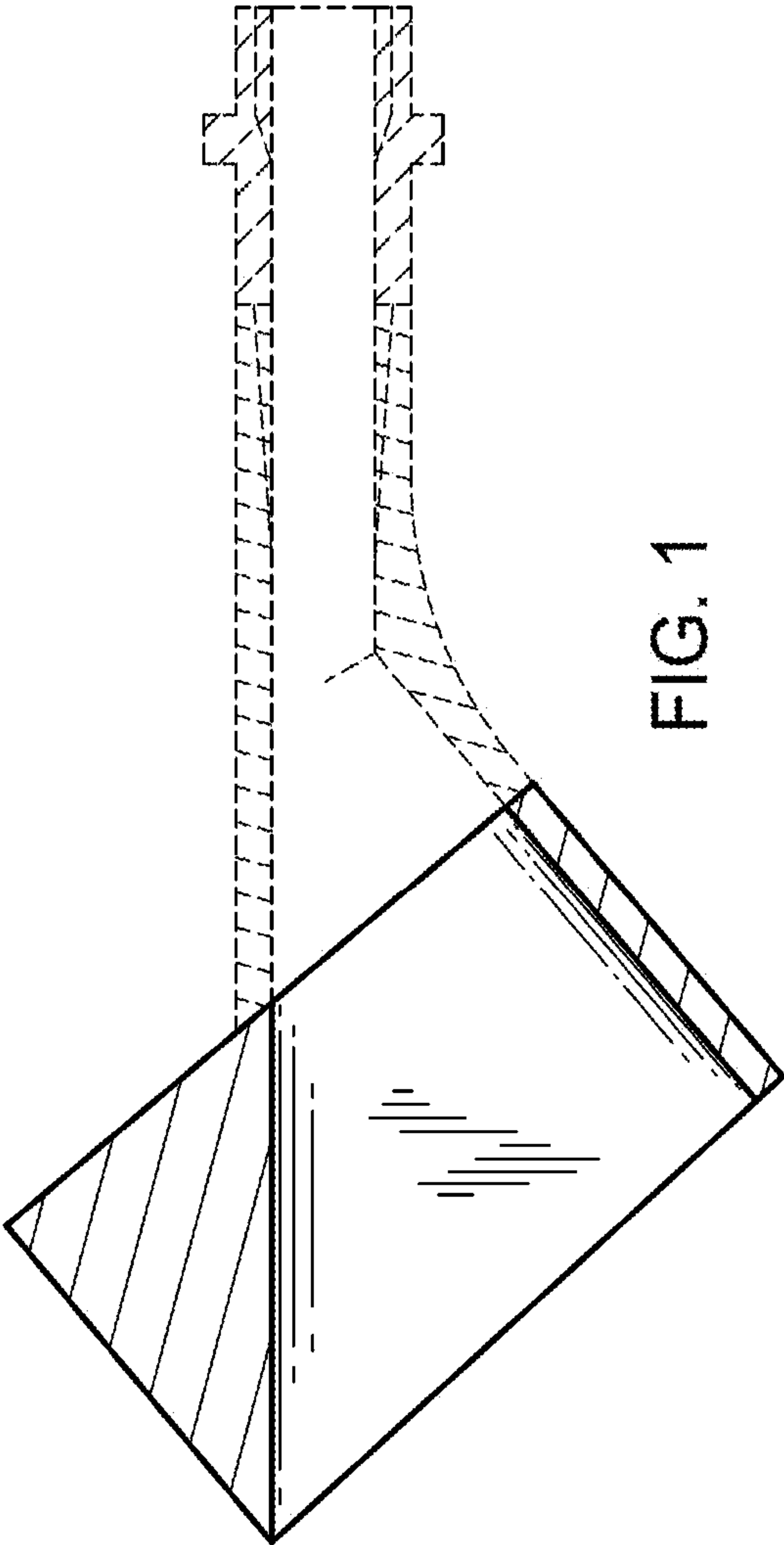

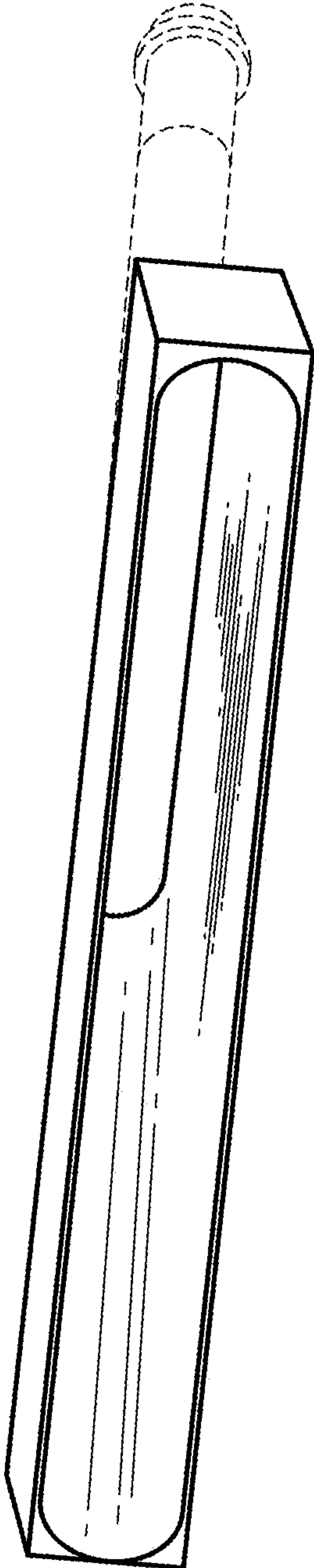
