We claim the ornamental design for a ride on toy, as shown and described.

DESCRIPTION

FIG. 6 is a rear elevation view of the ride on toy shown in FIG. 1.

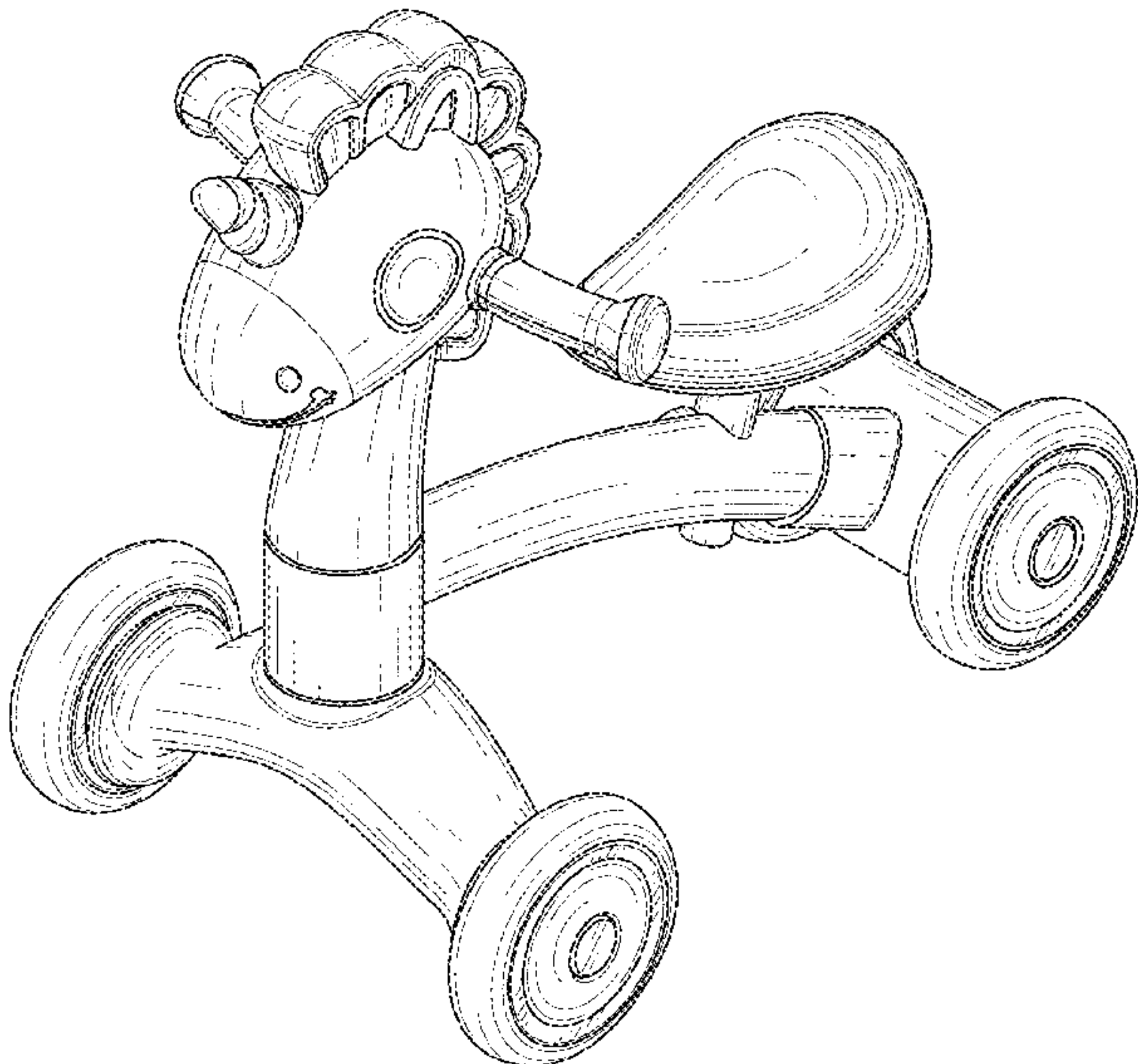
FIG. 7 is a right side elevation view of the ride on toy shown in FIG. 1.

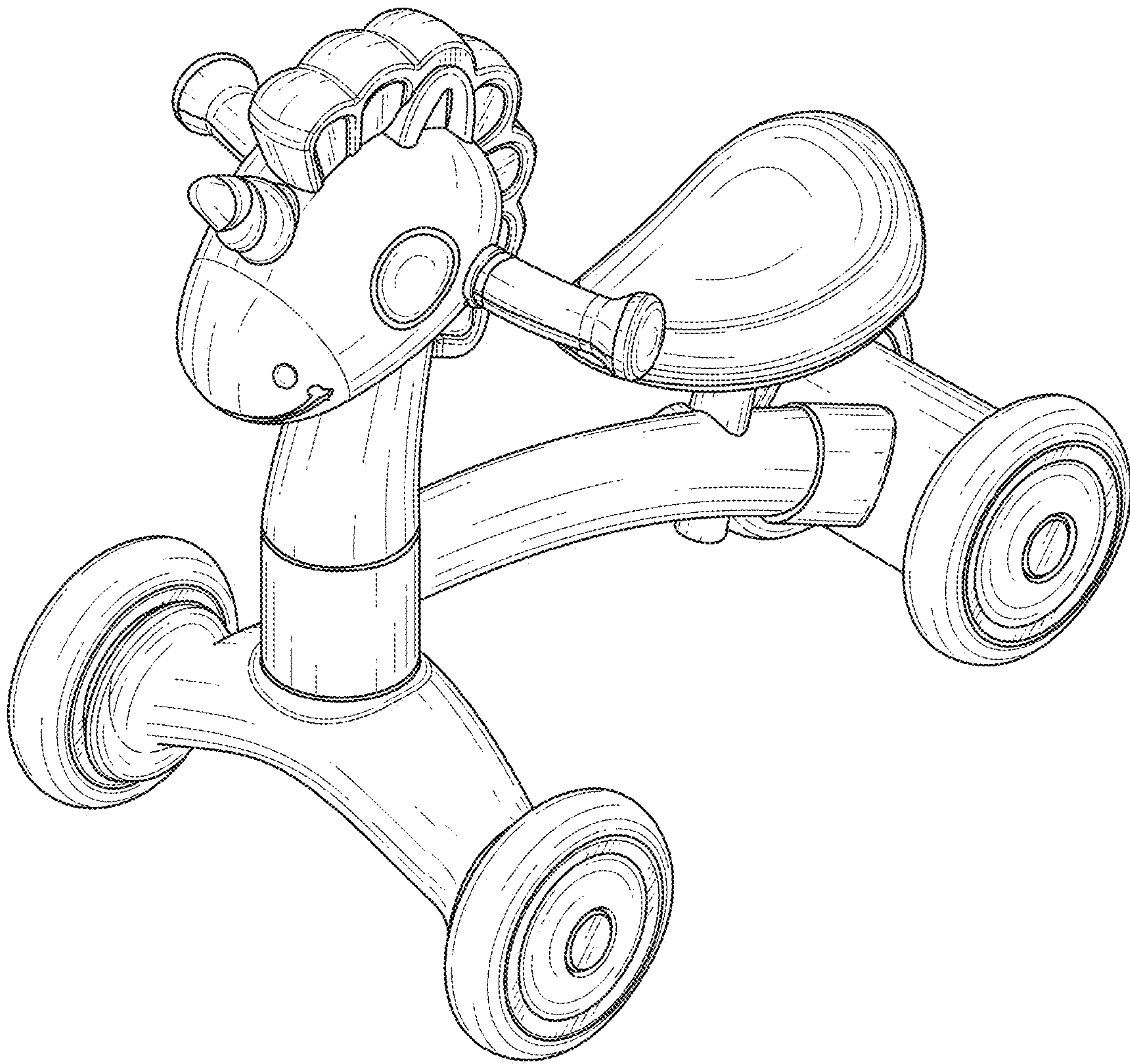

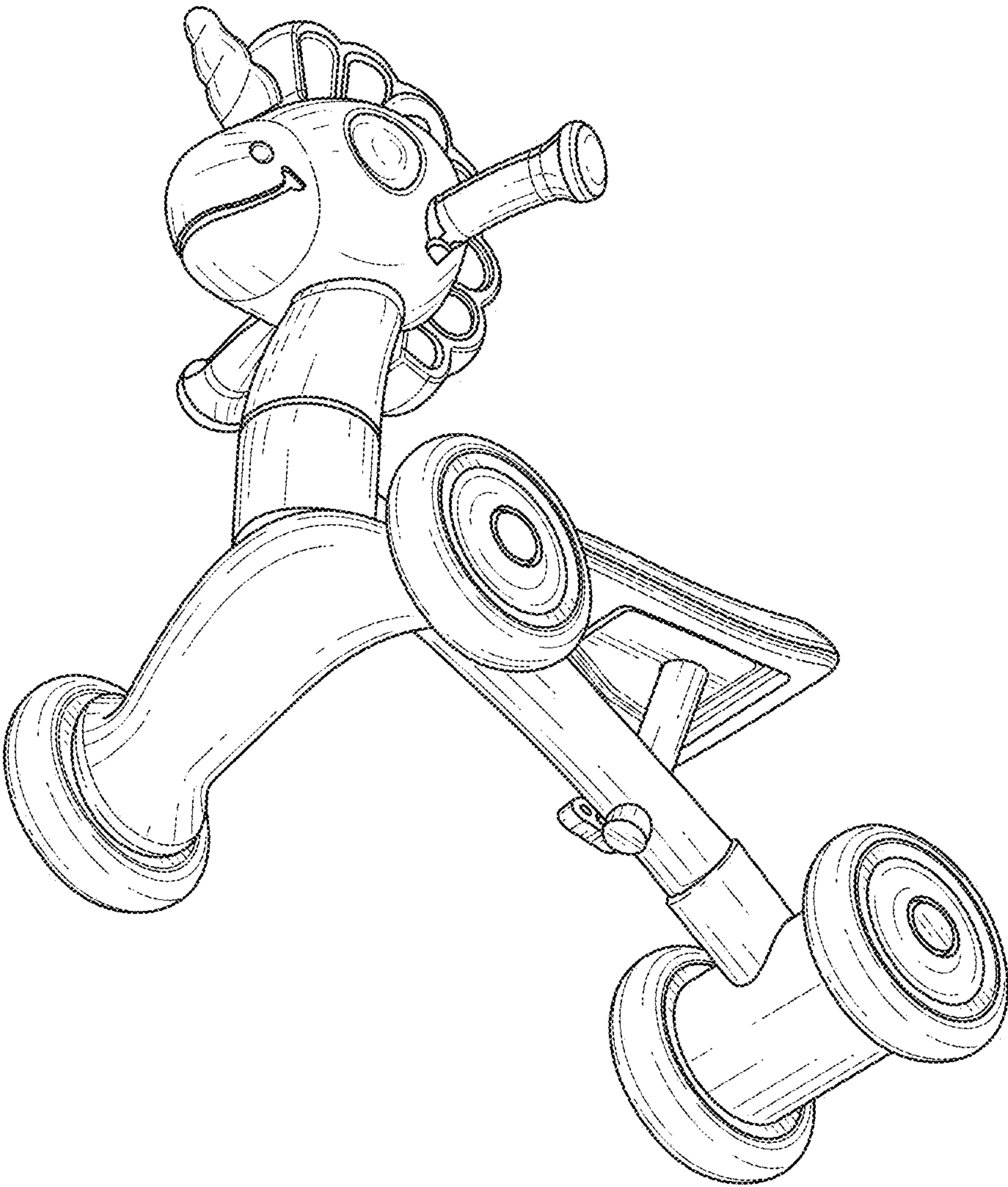

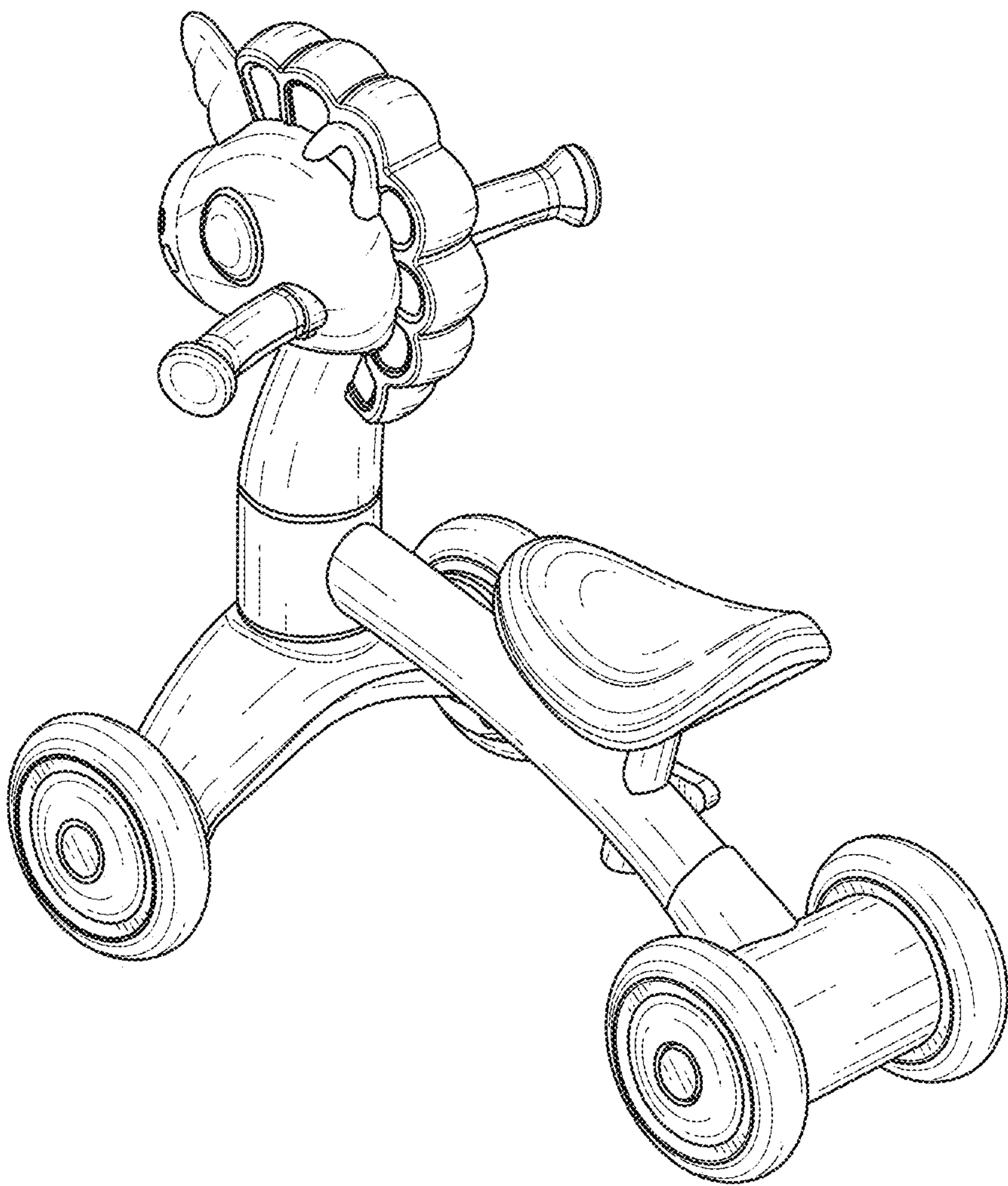

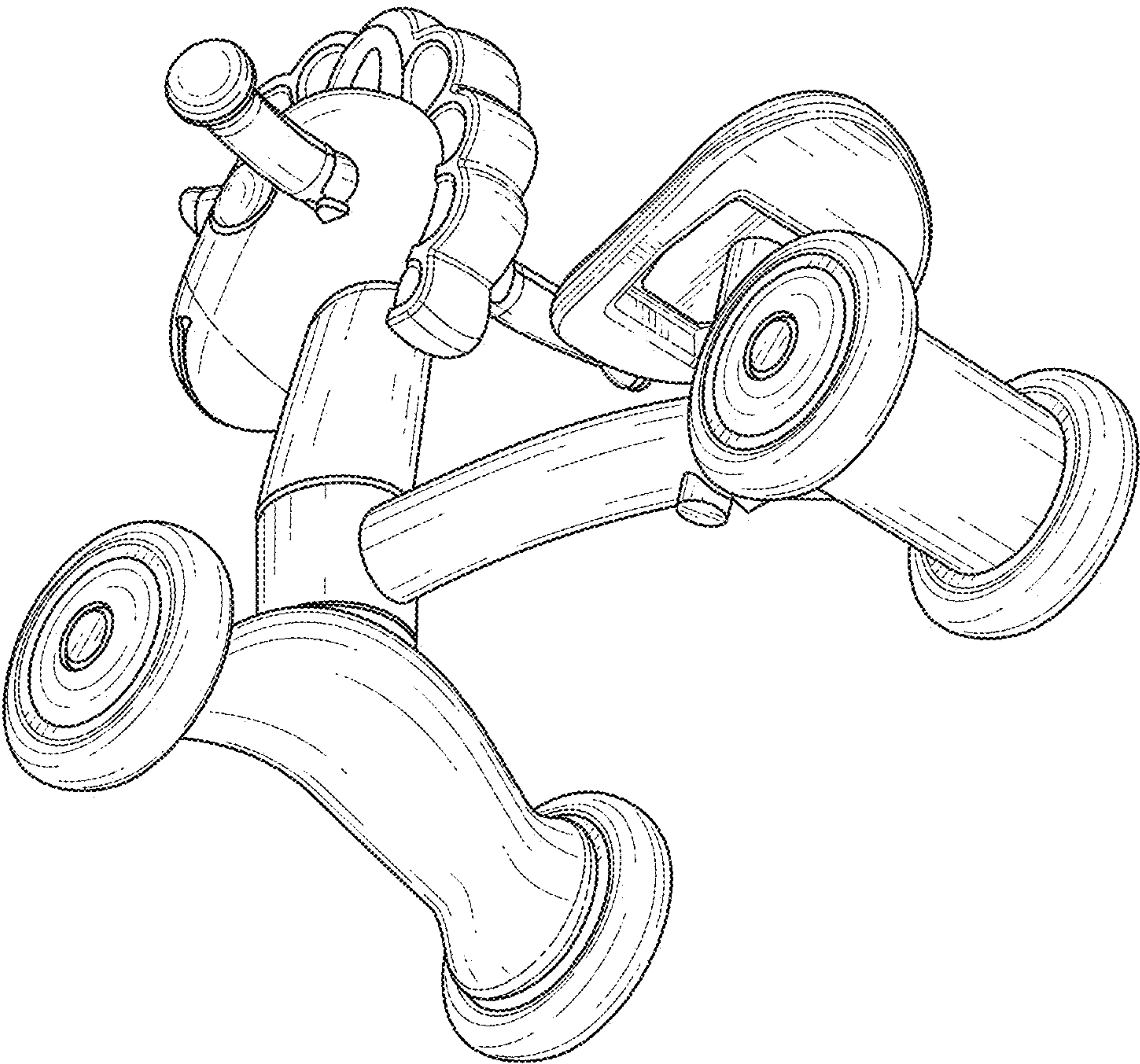

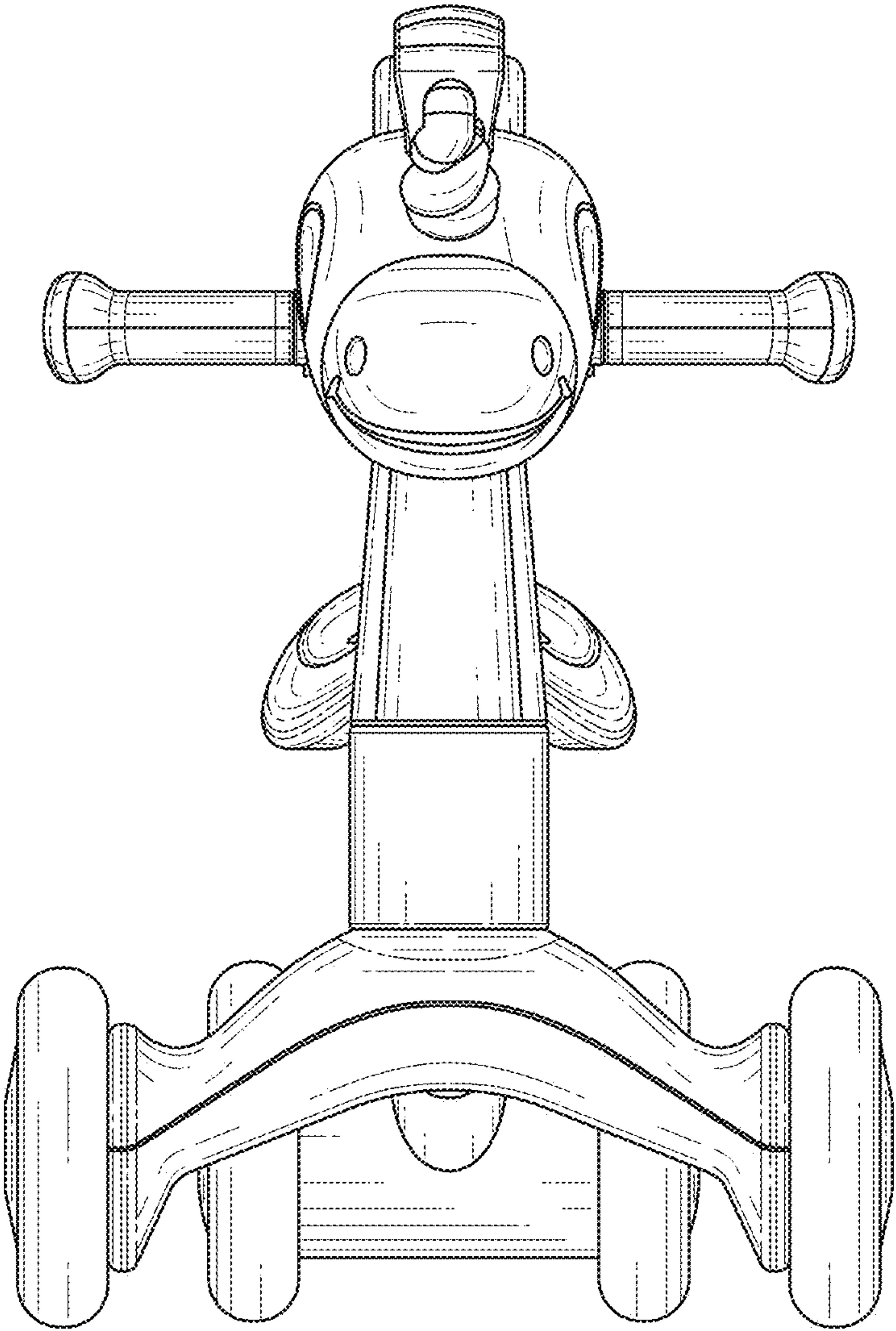

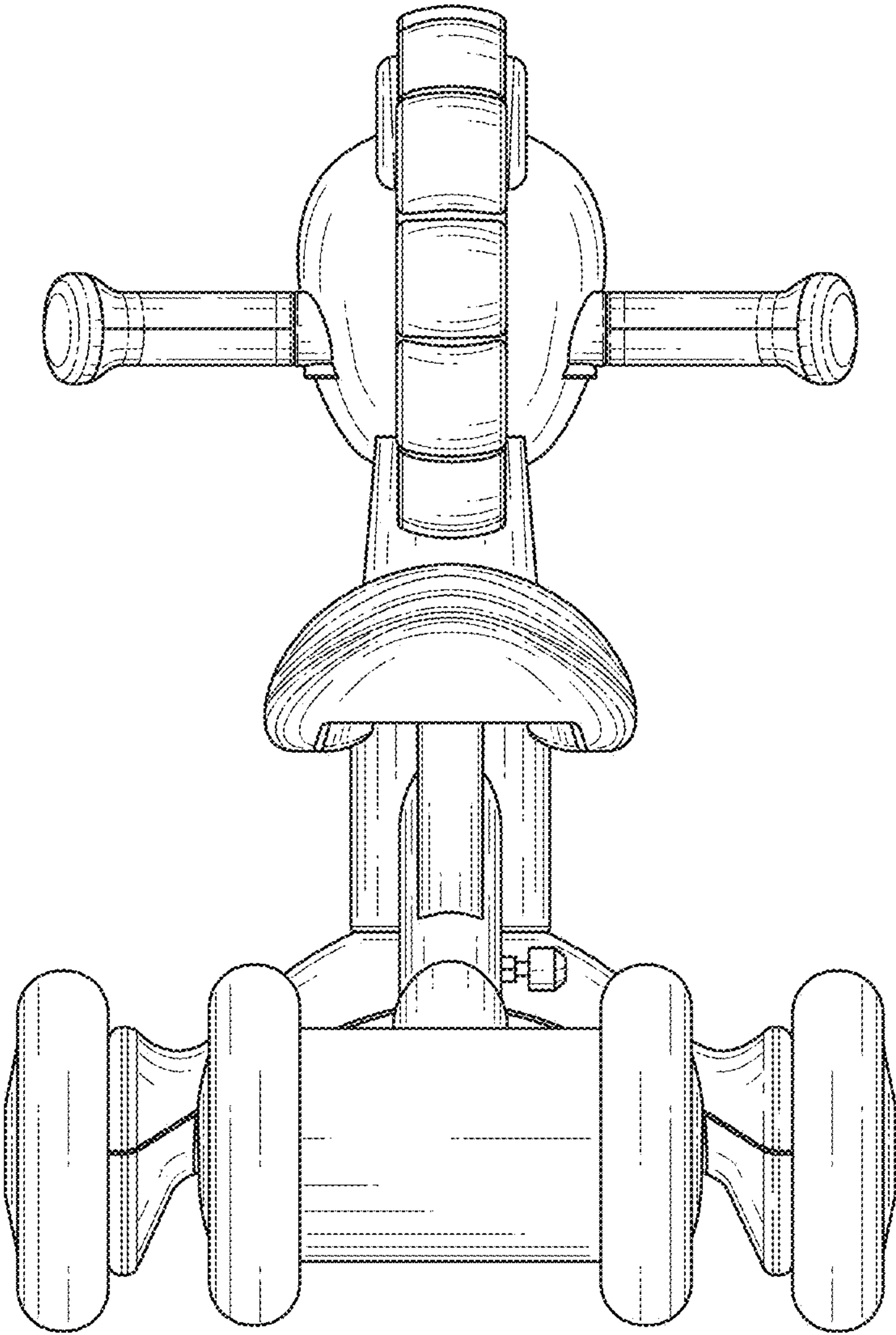

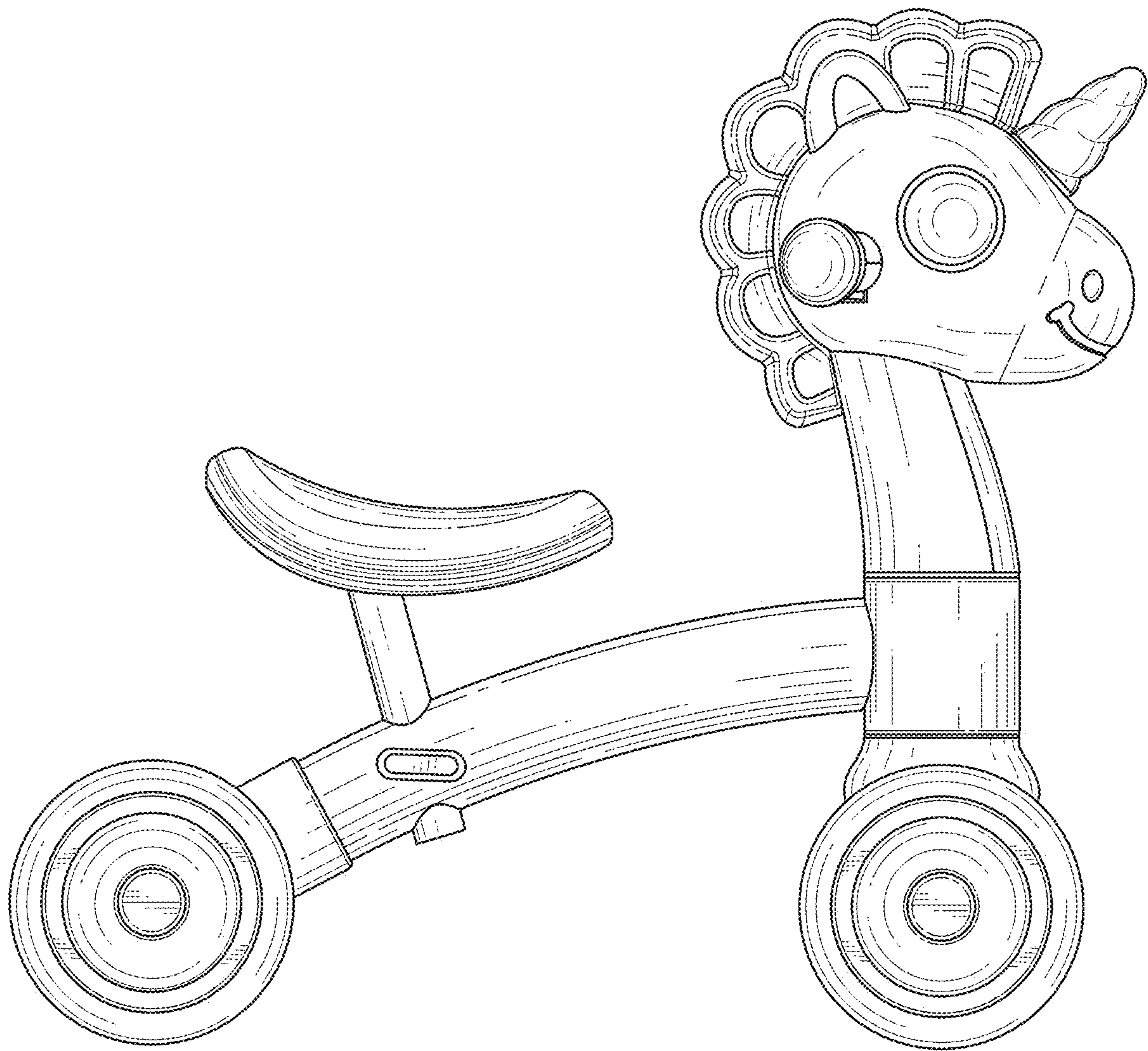

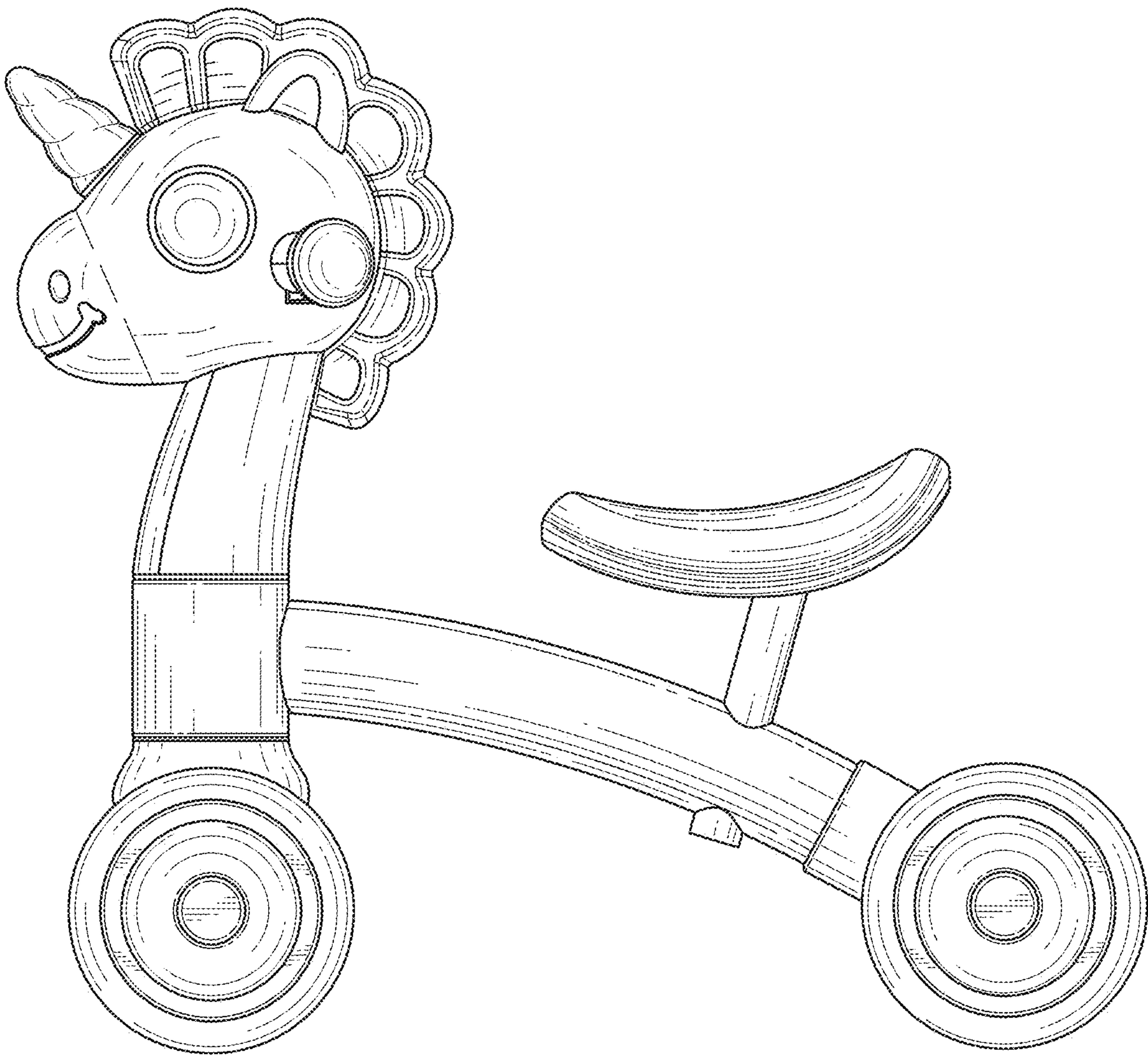

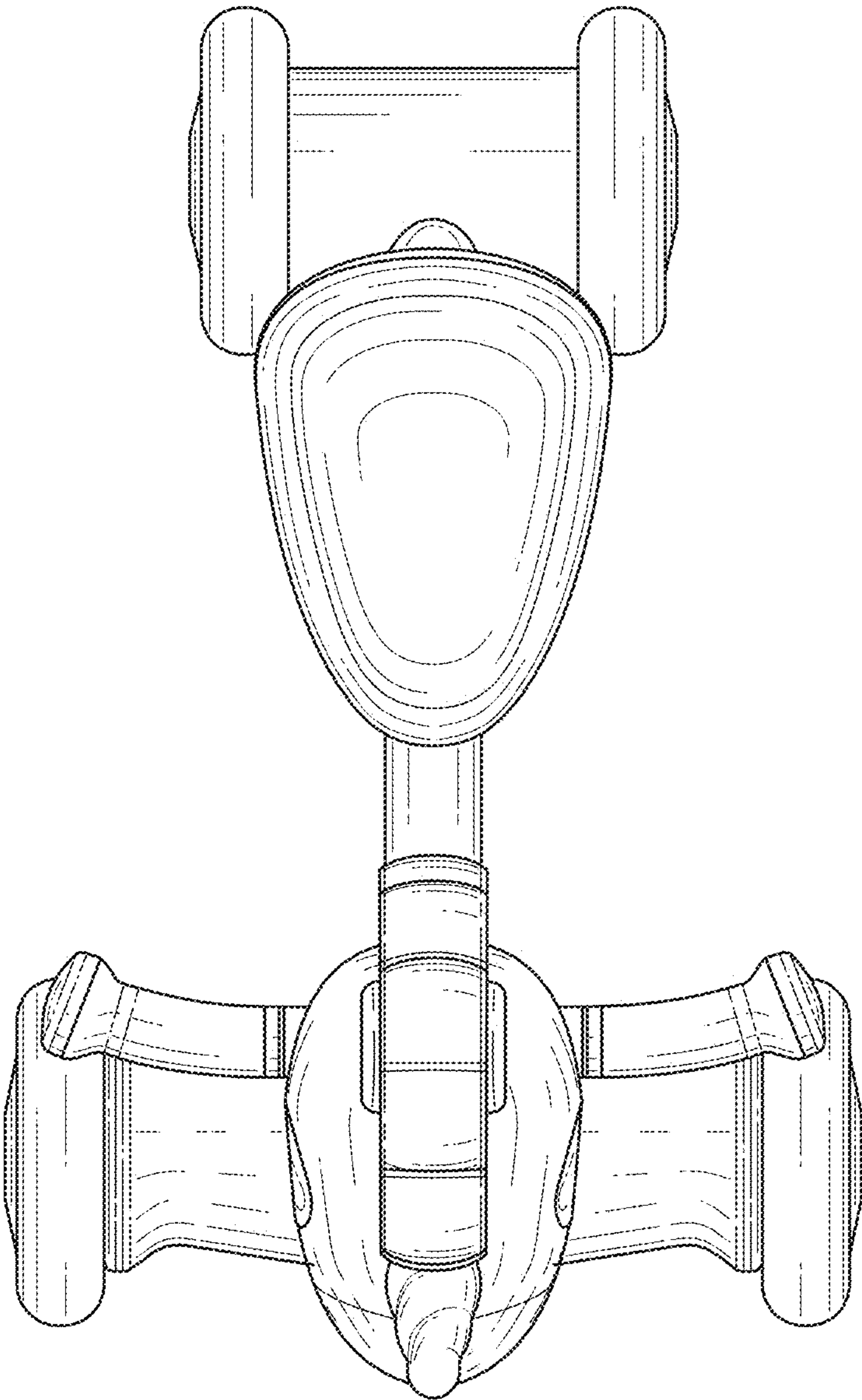

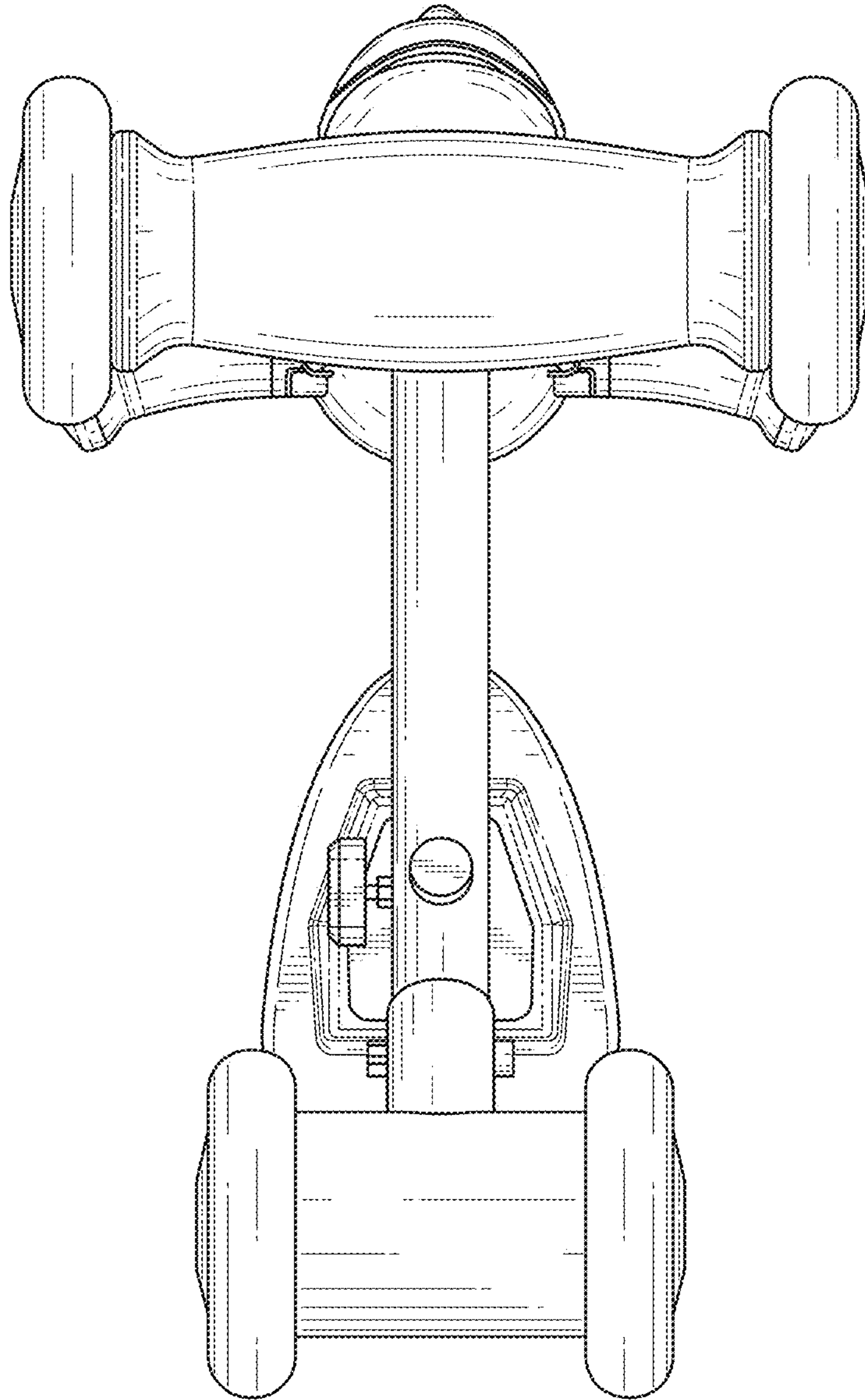
