**DESCRIPTION**

FIG. 1 is a front and left perspective view of a motor, showing our new design.  
FIG. 2 is a rear and right perspective view thereof.  
FIG. 3 is a front elevation view thereof.  
FIG. 4 is a rear elevation view thereof.  
FIG. 5 is a left side elevation view thereof.  
FIG. 6 is a right side elevation view thereof.  
FIG. 7 is a top plan view thereof.  
FIG. 8 is a bottom plan view thereof; and,  
FIG. 9 is an enlarged cross-sectional view taken along the line 9-9 in FIG. 5.

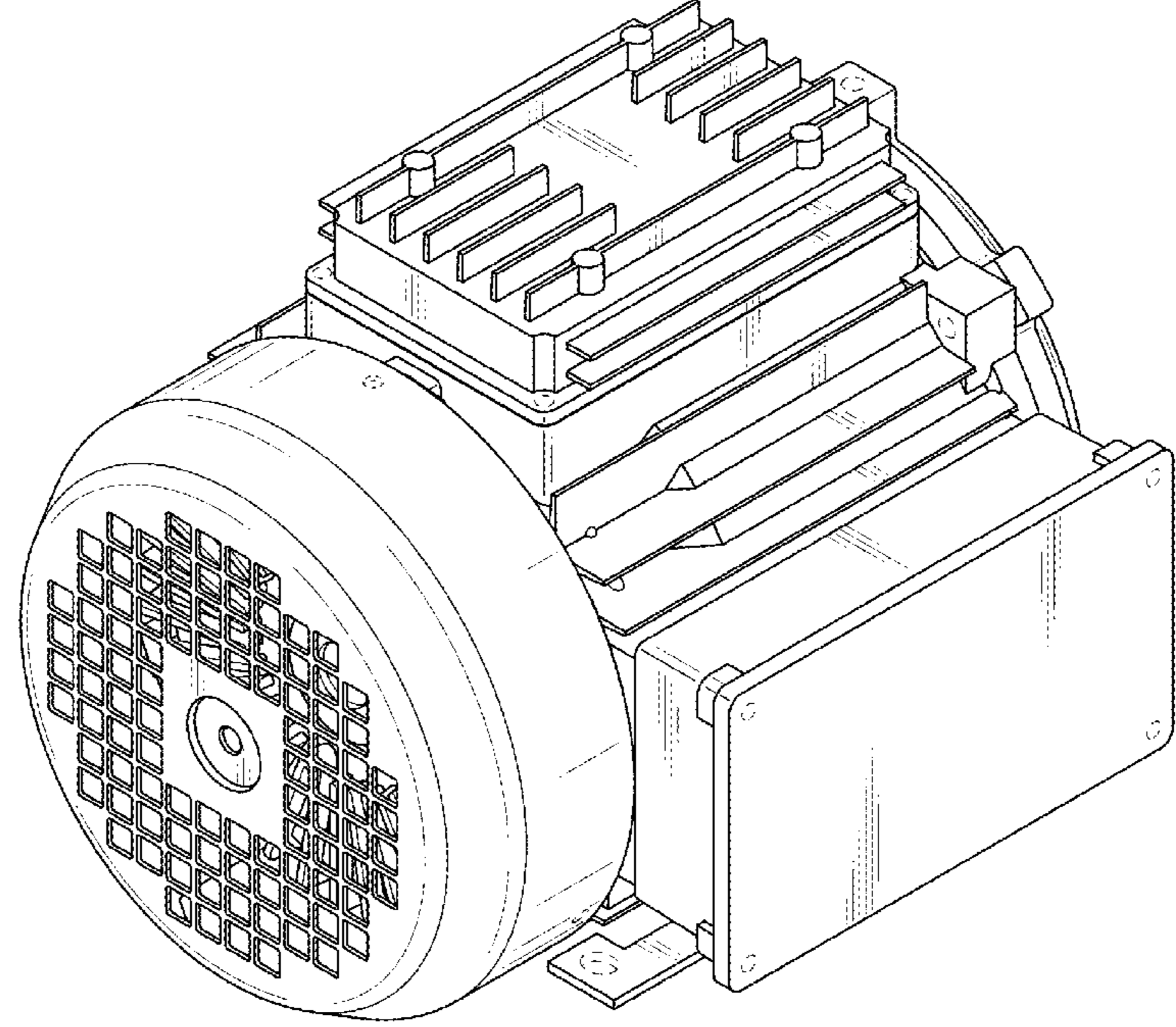

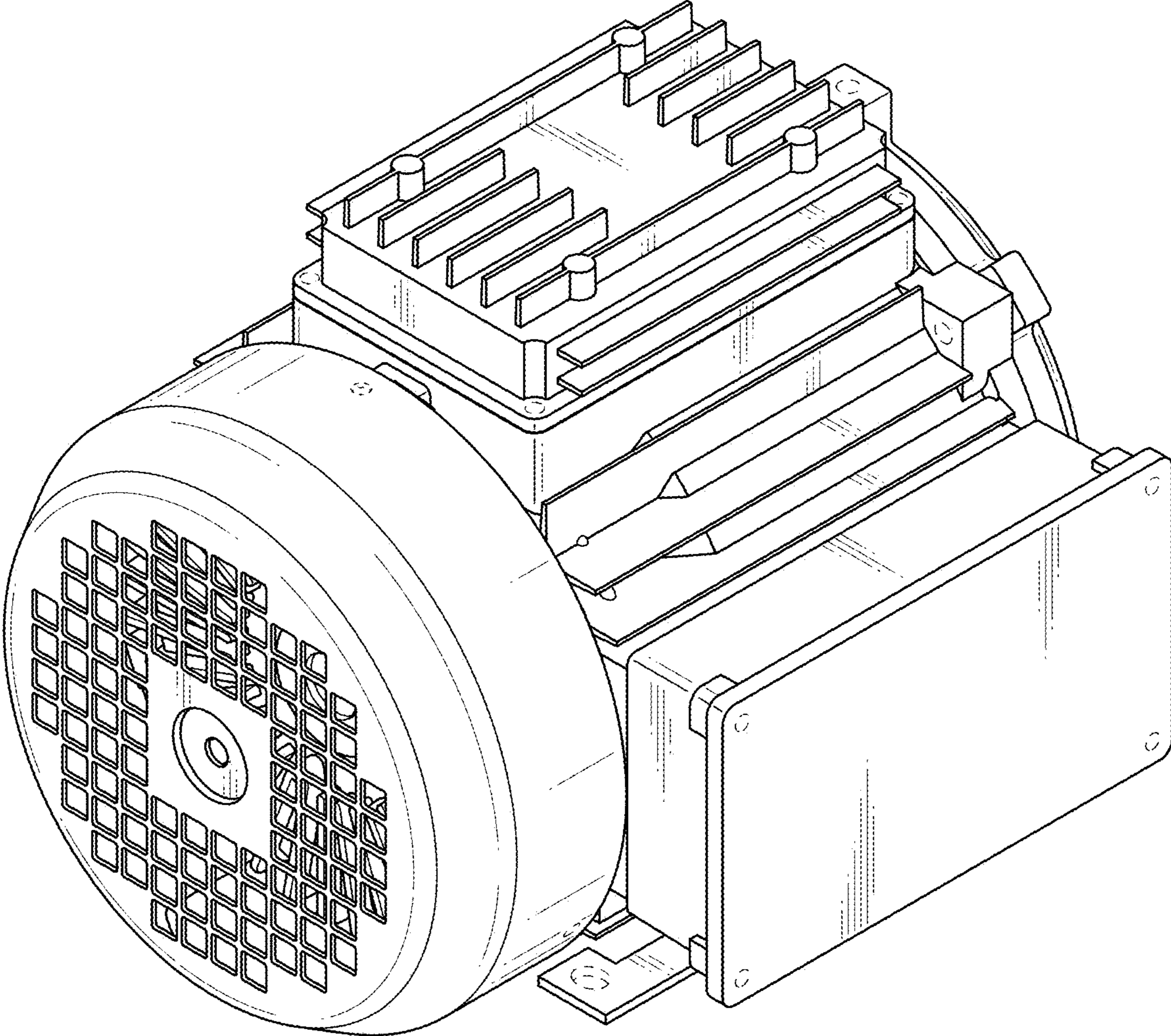

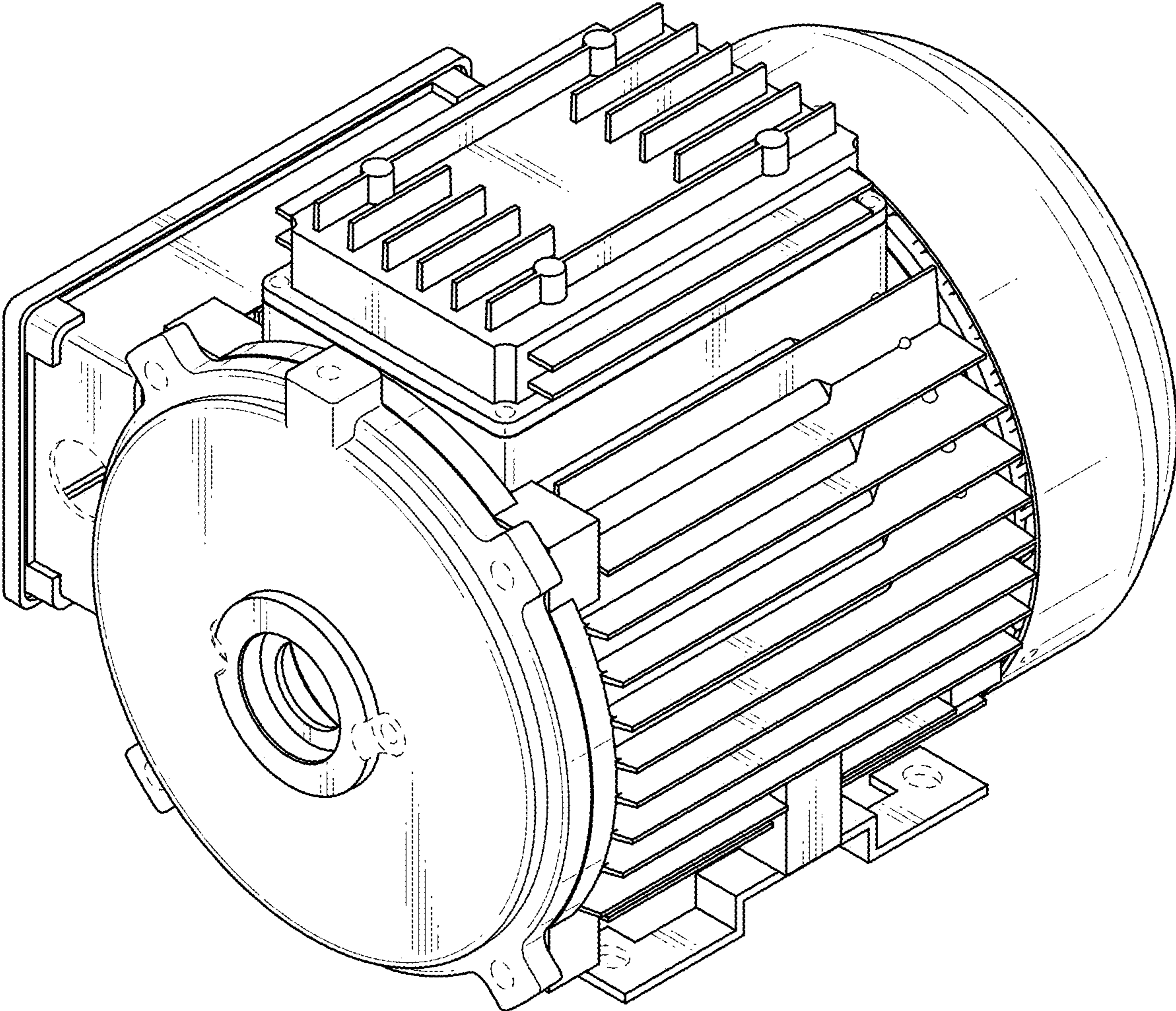

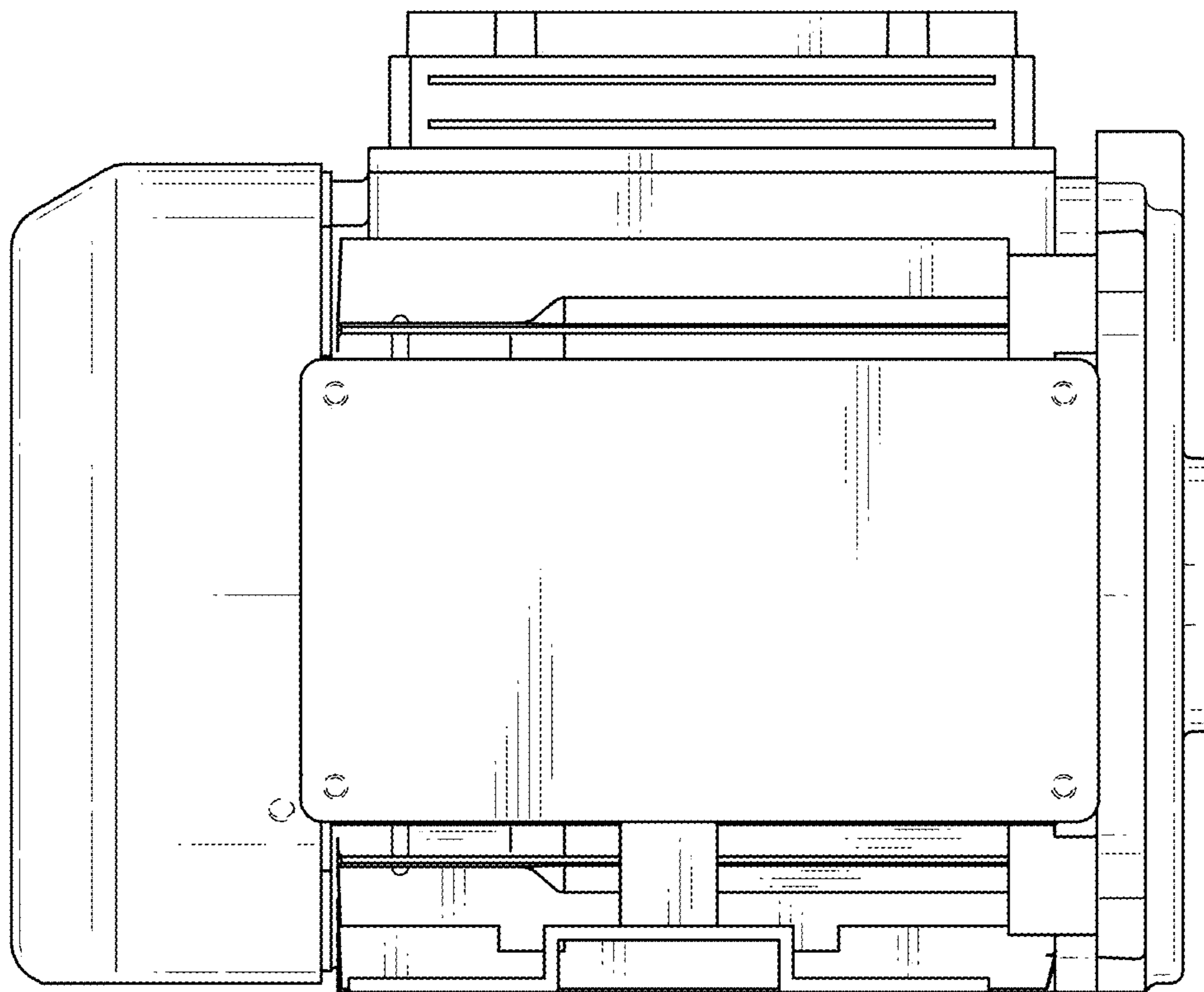

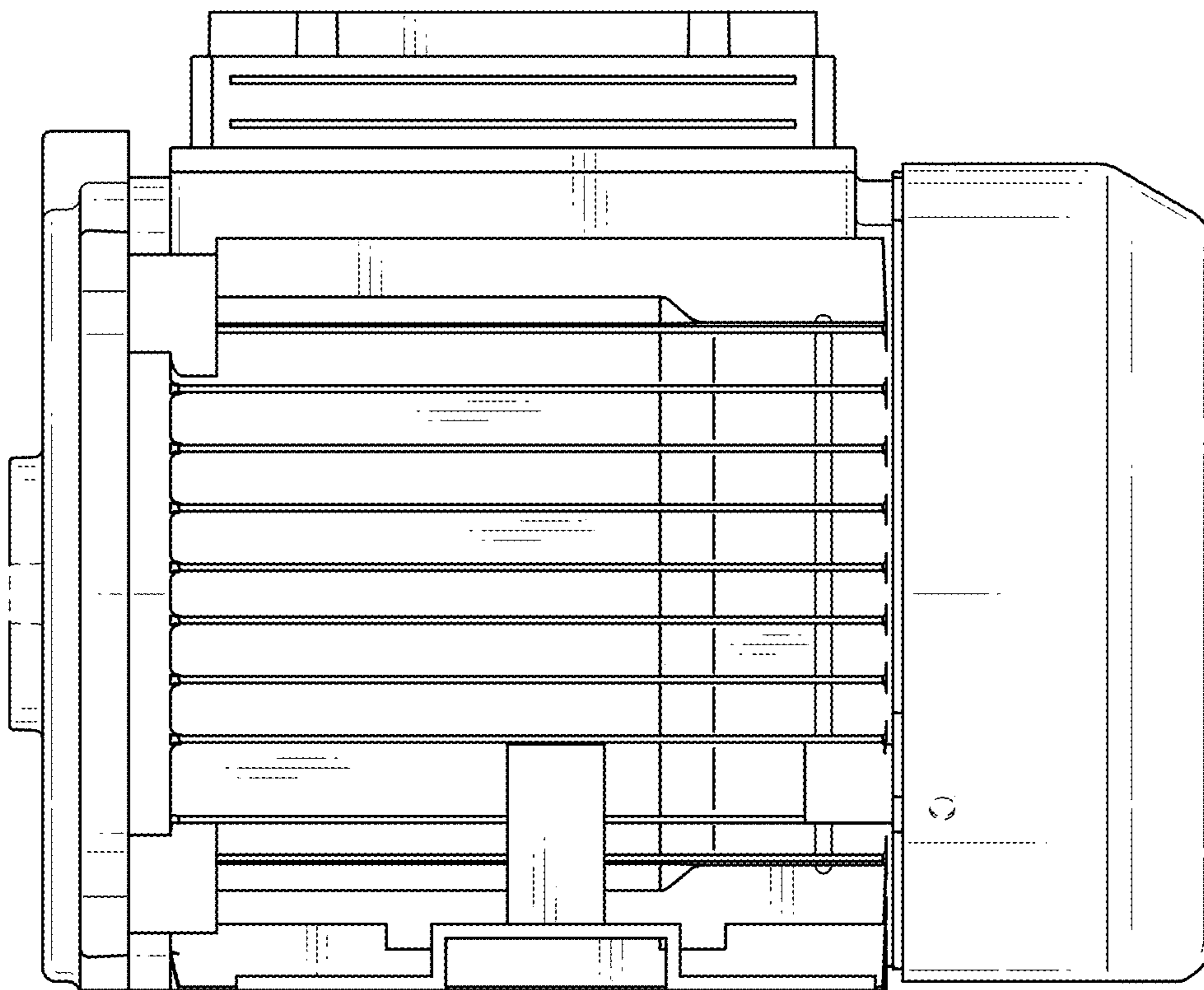

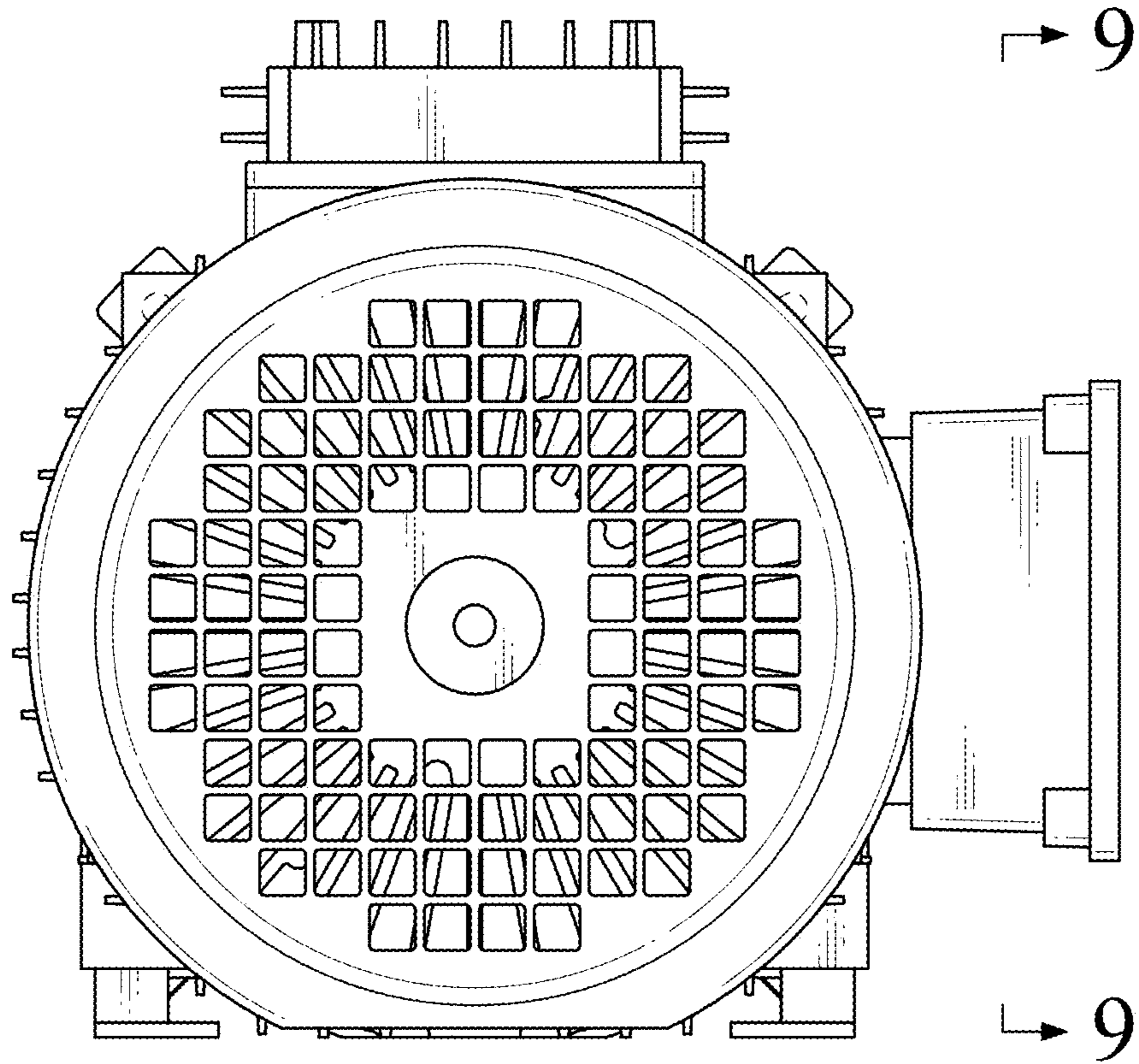

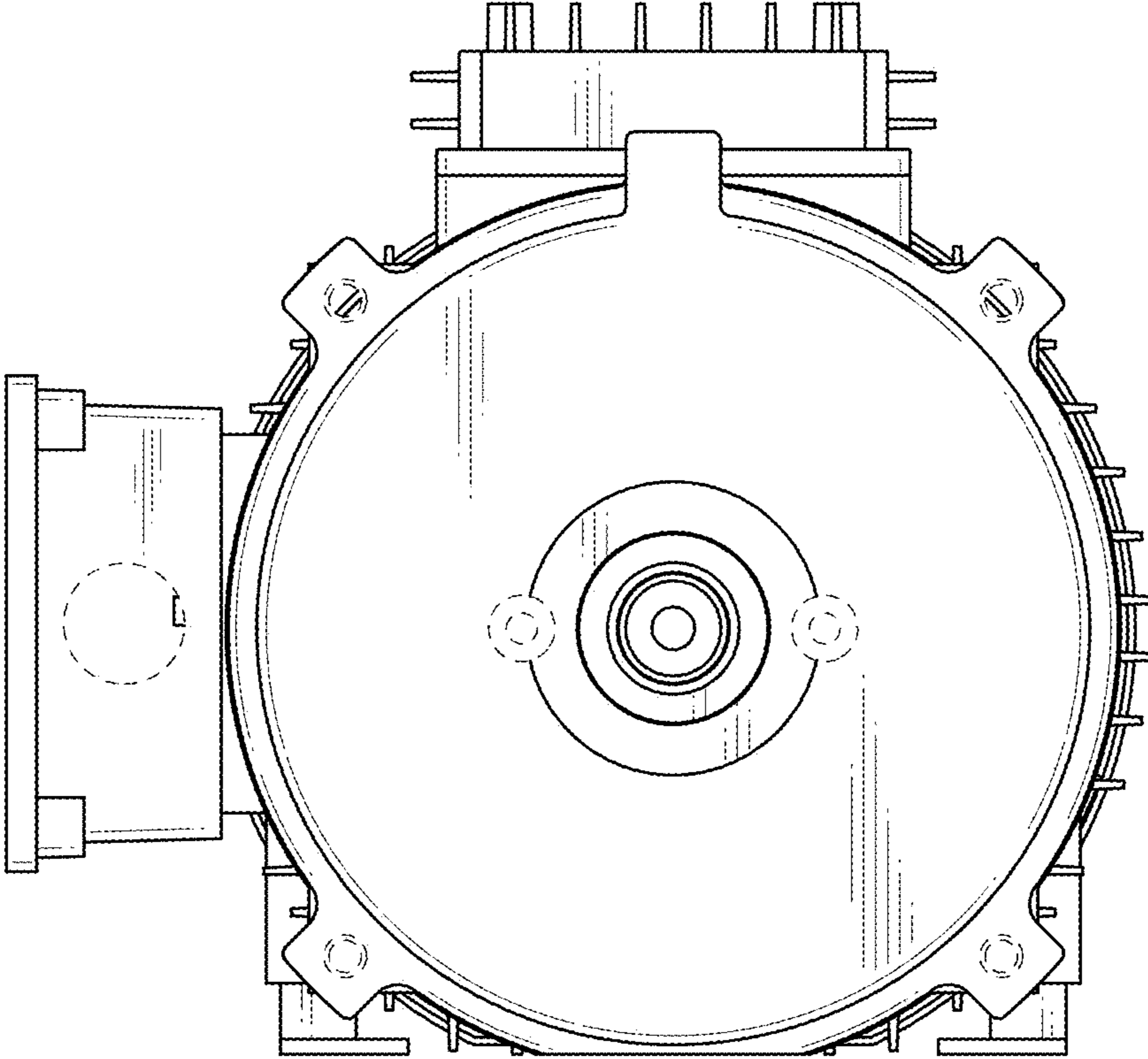

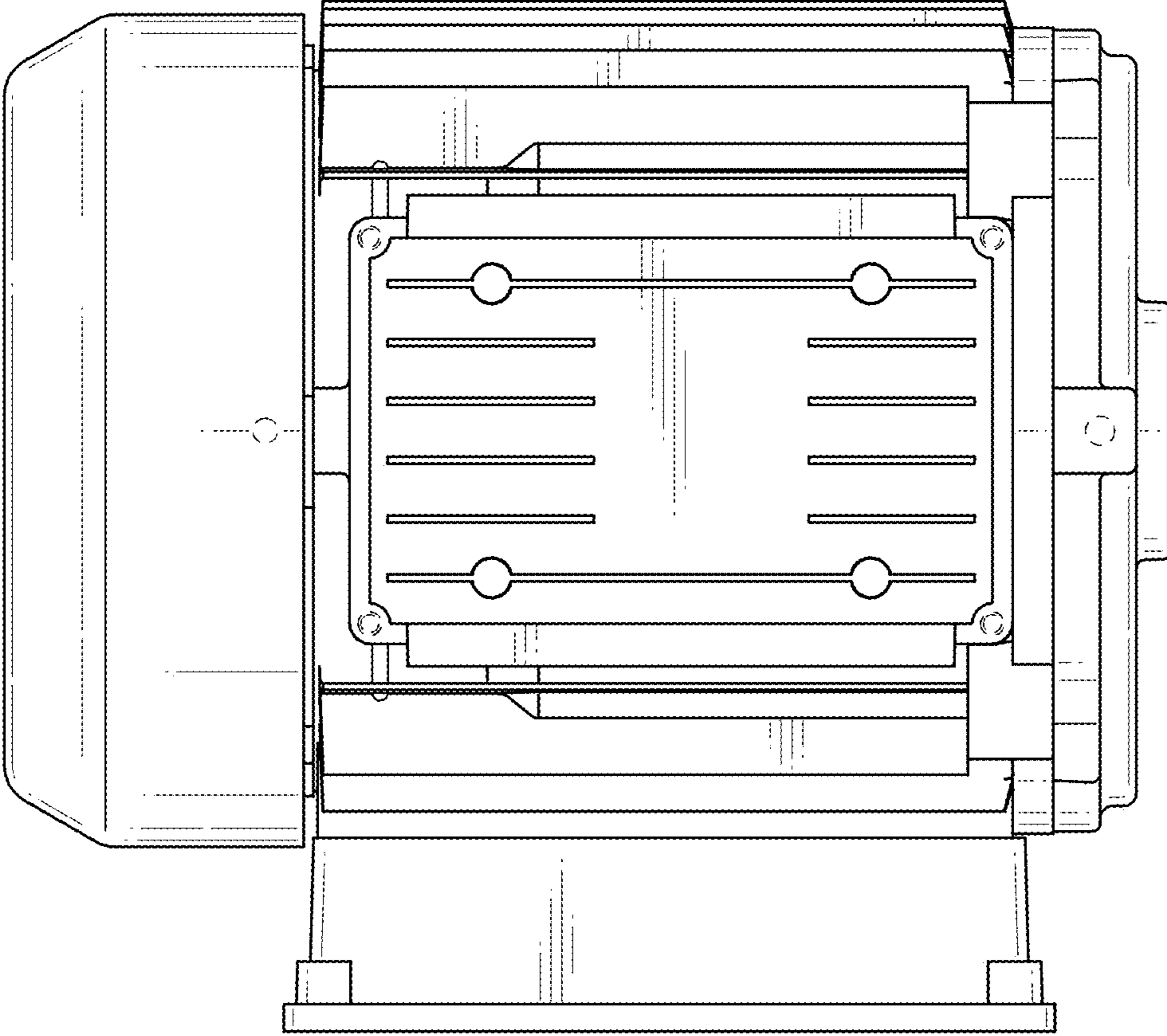

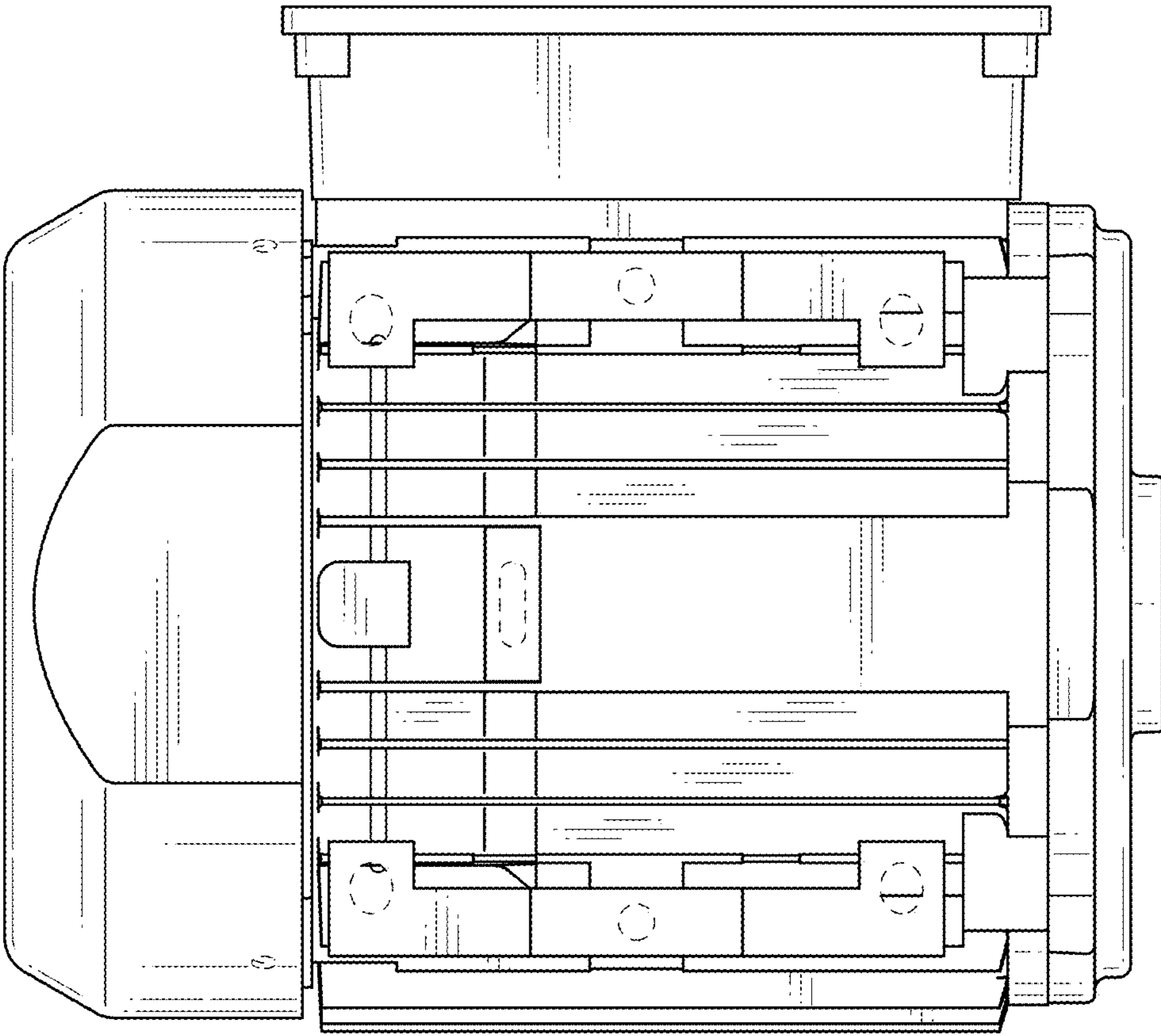
