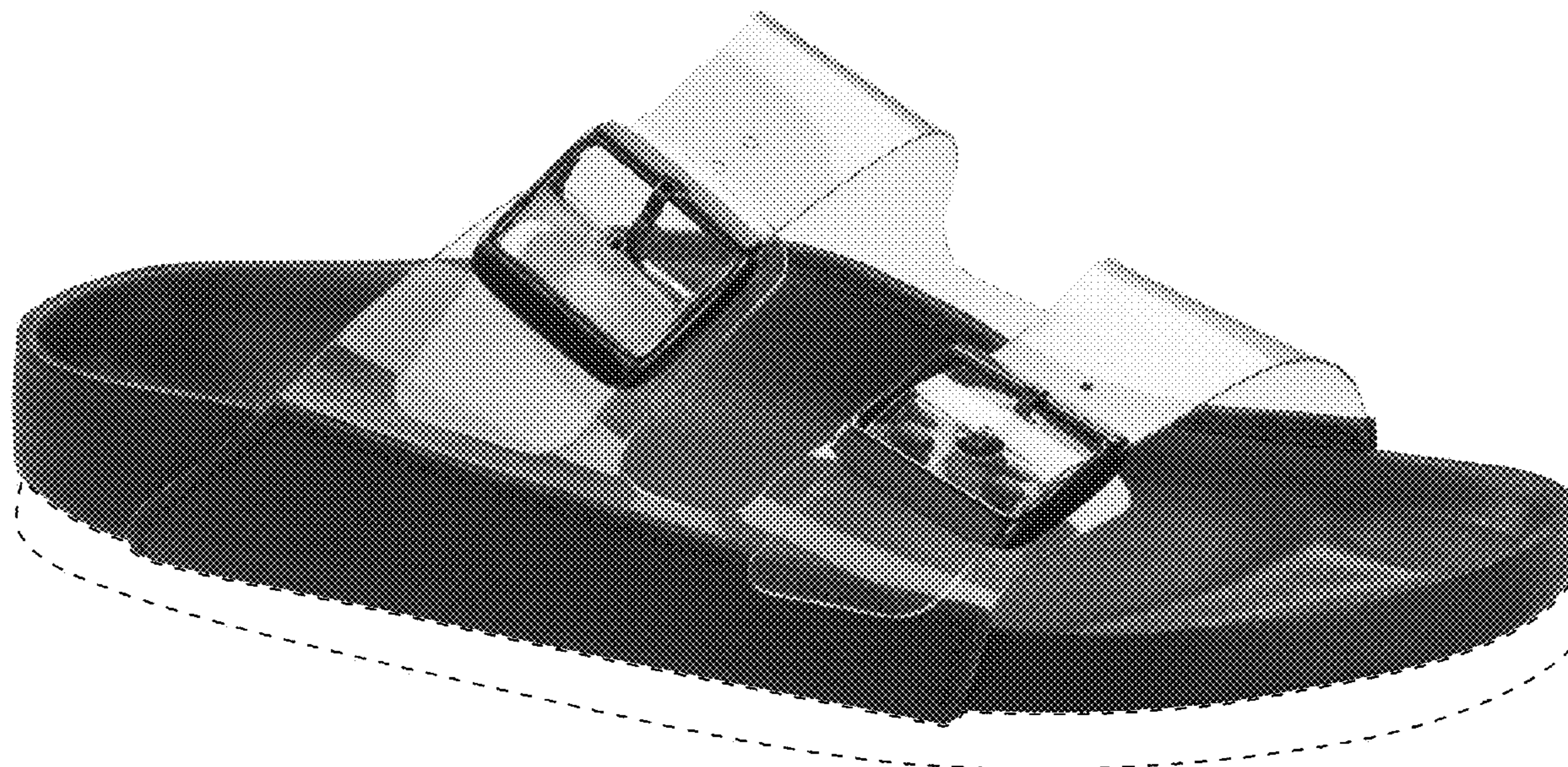
The ornamental design for a sandal, as shown and described.

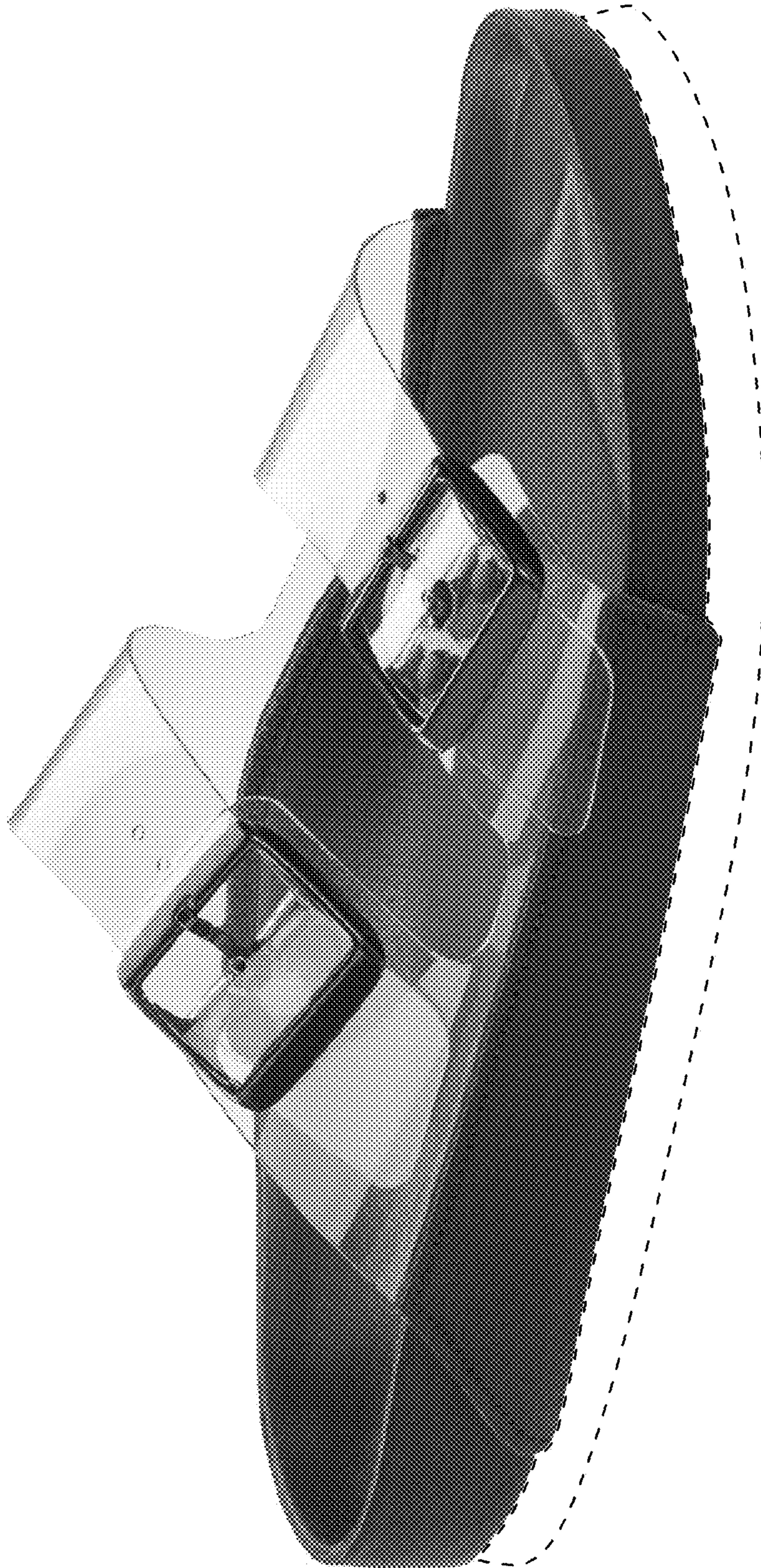

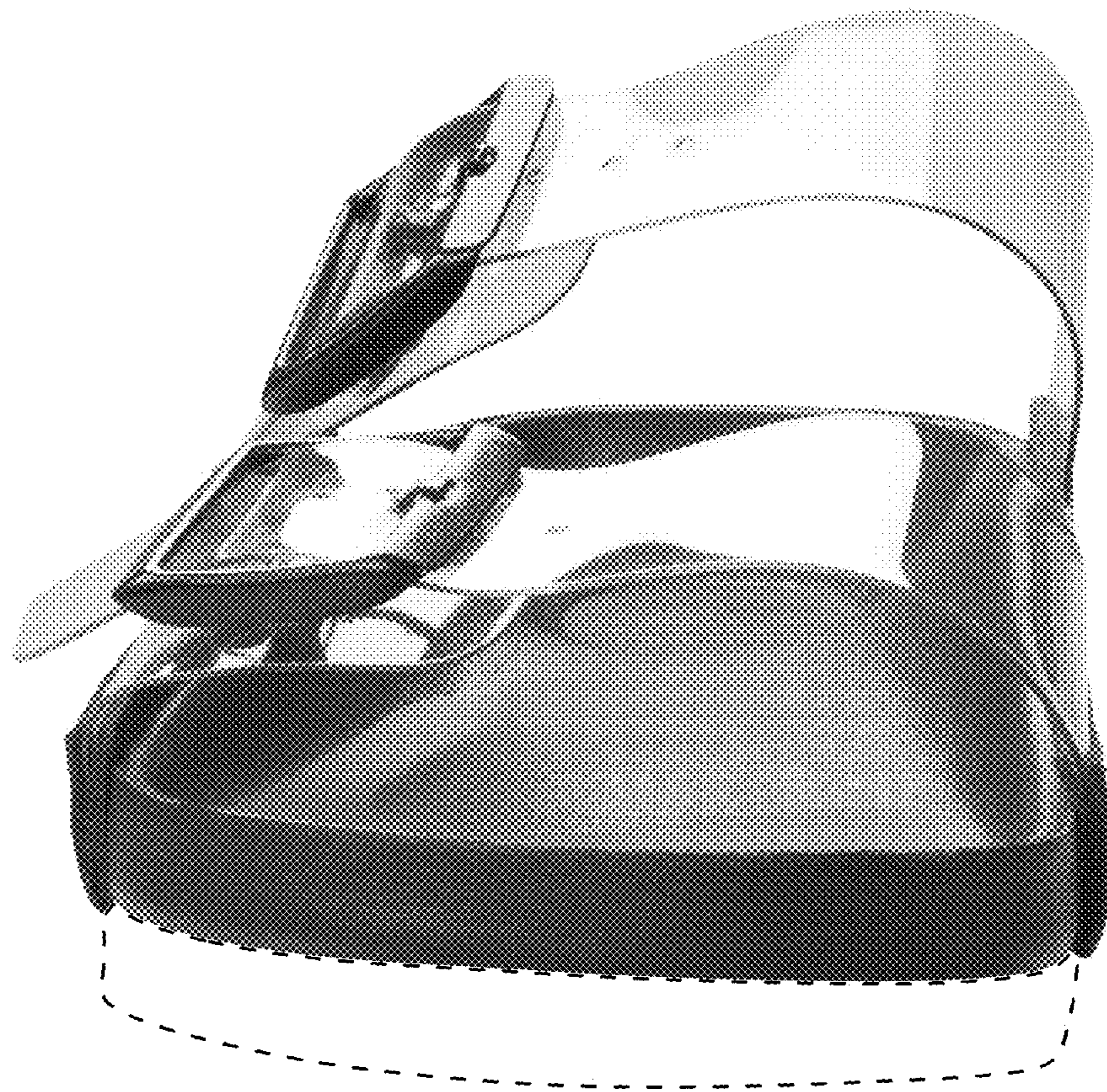

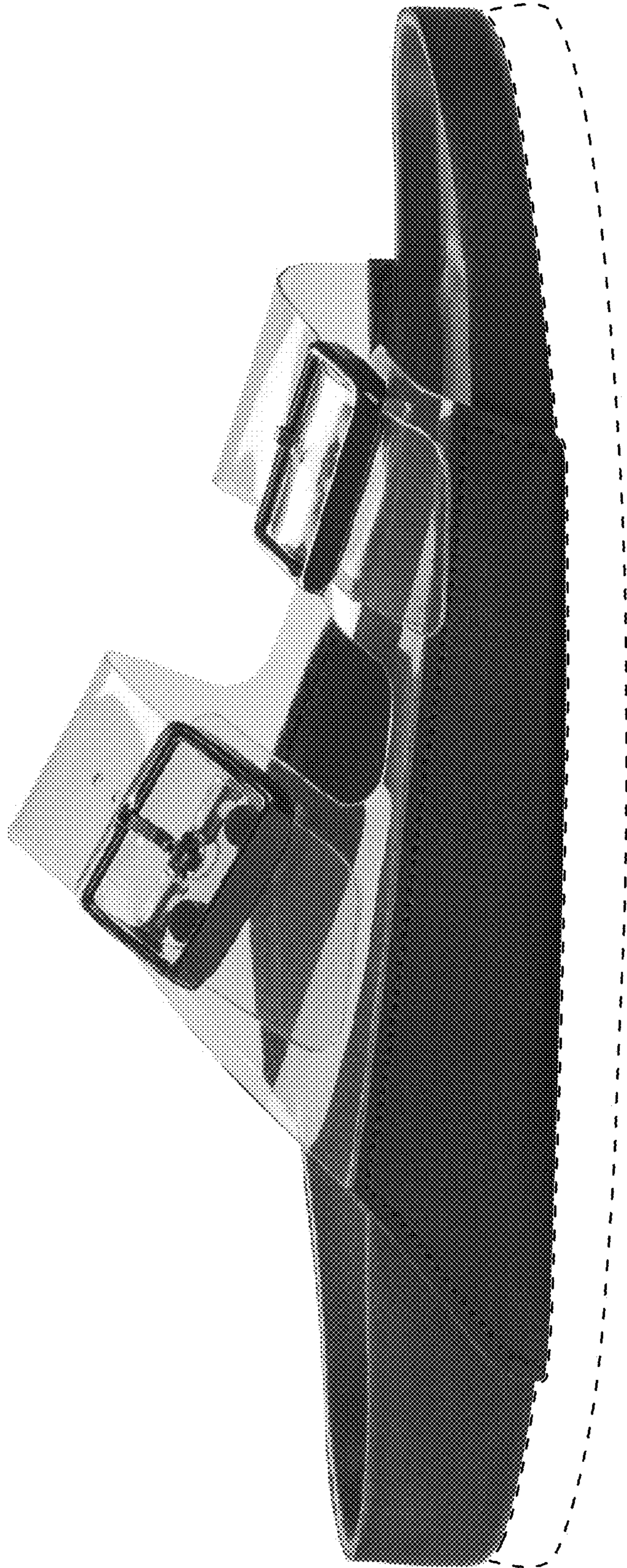

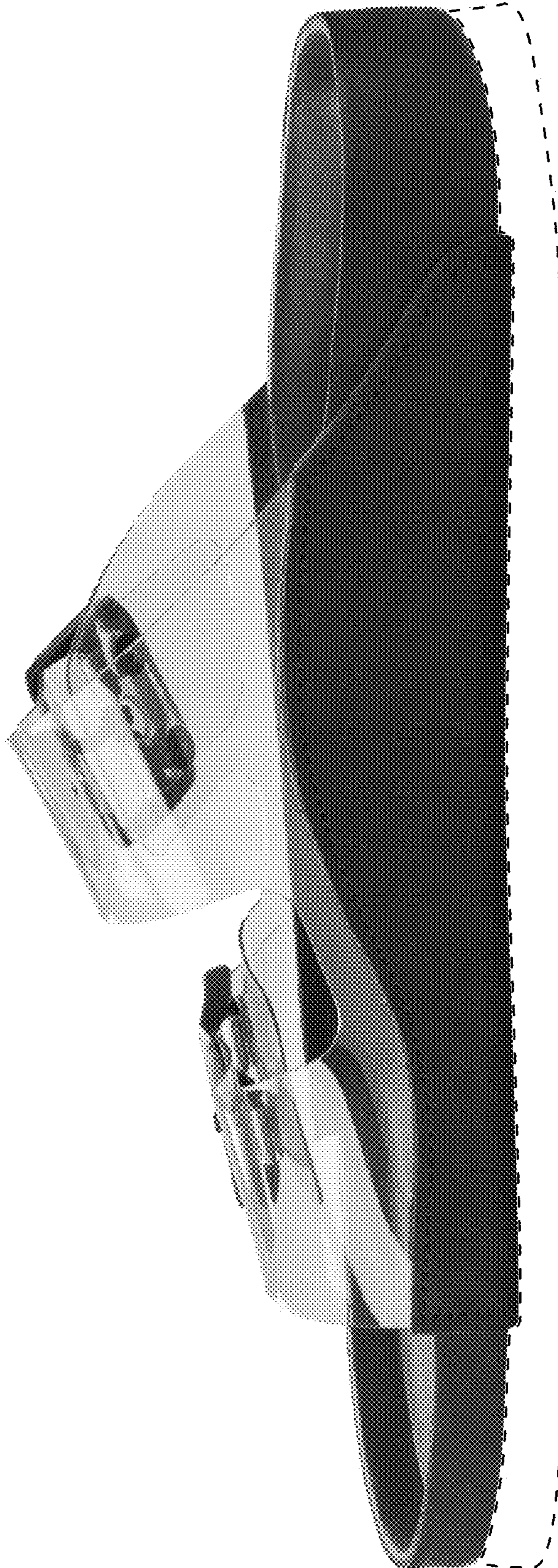

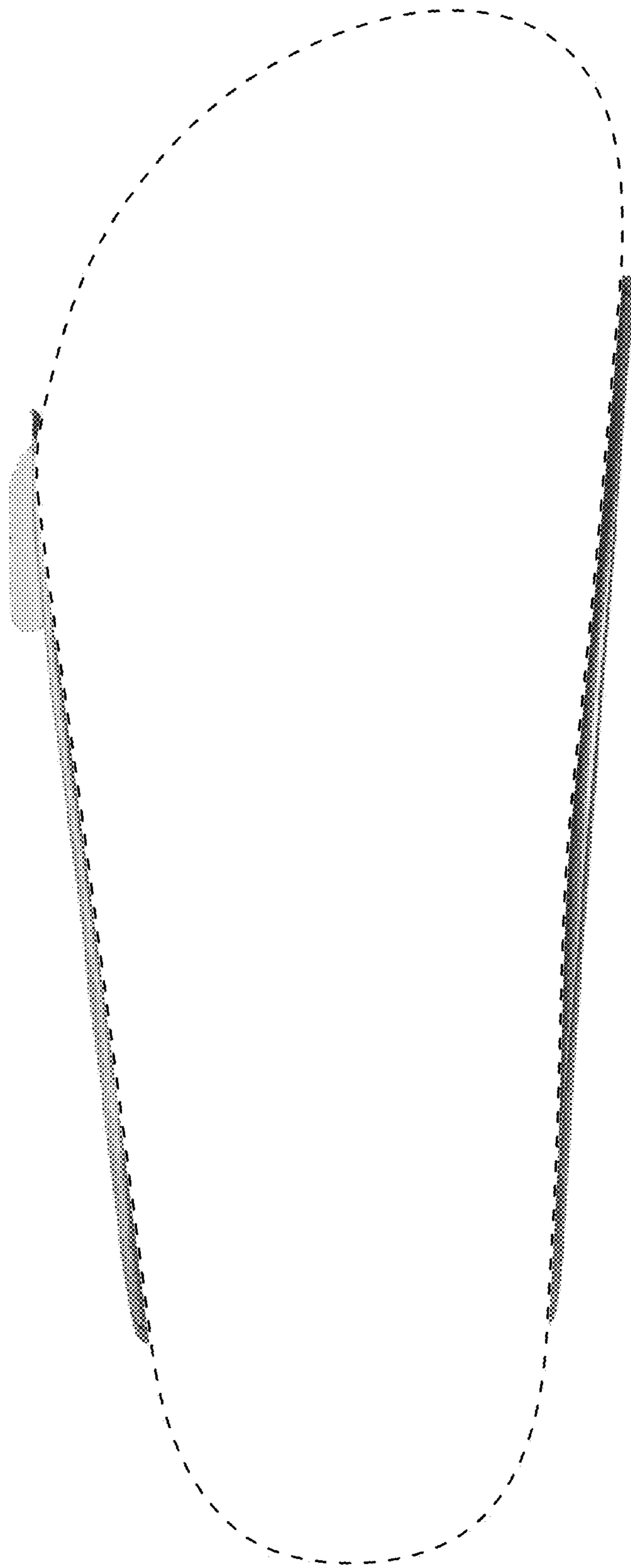
