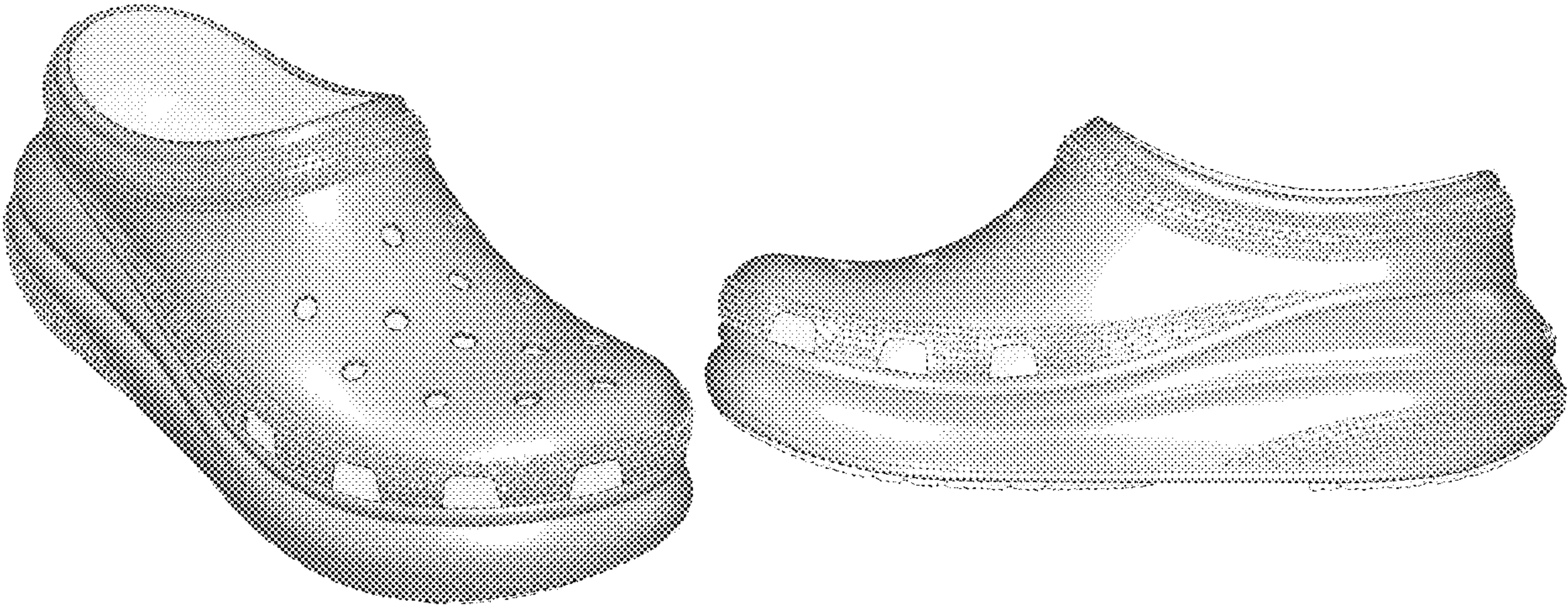
(57) CLAIM

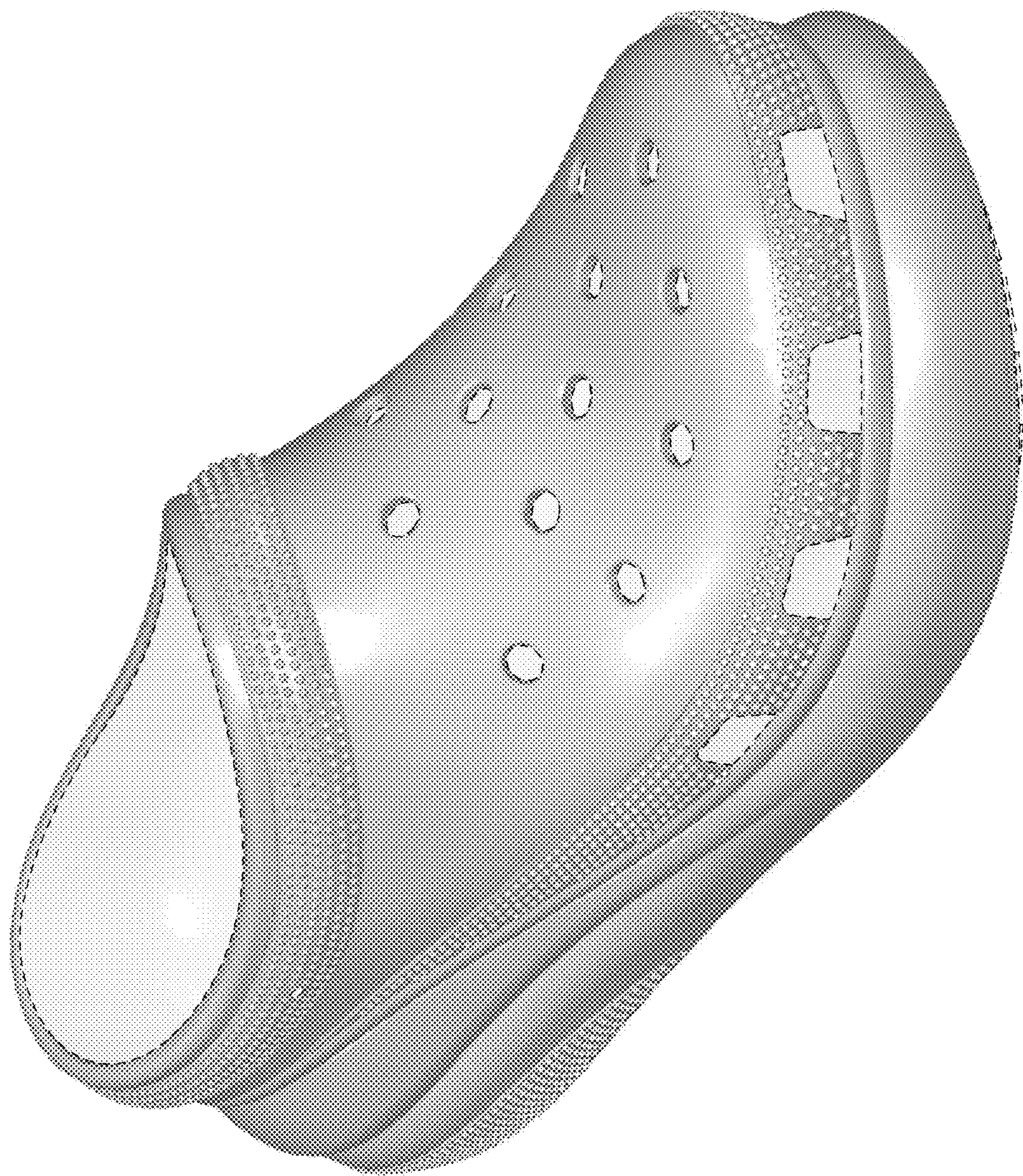

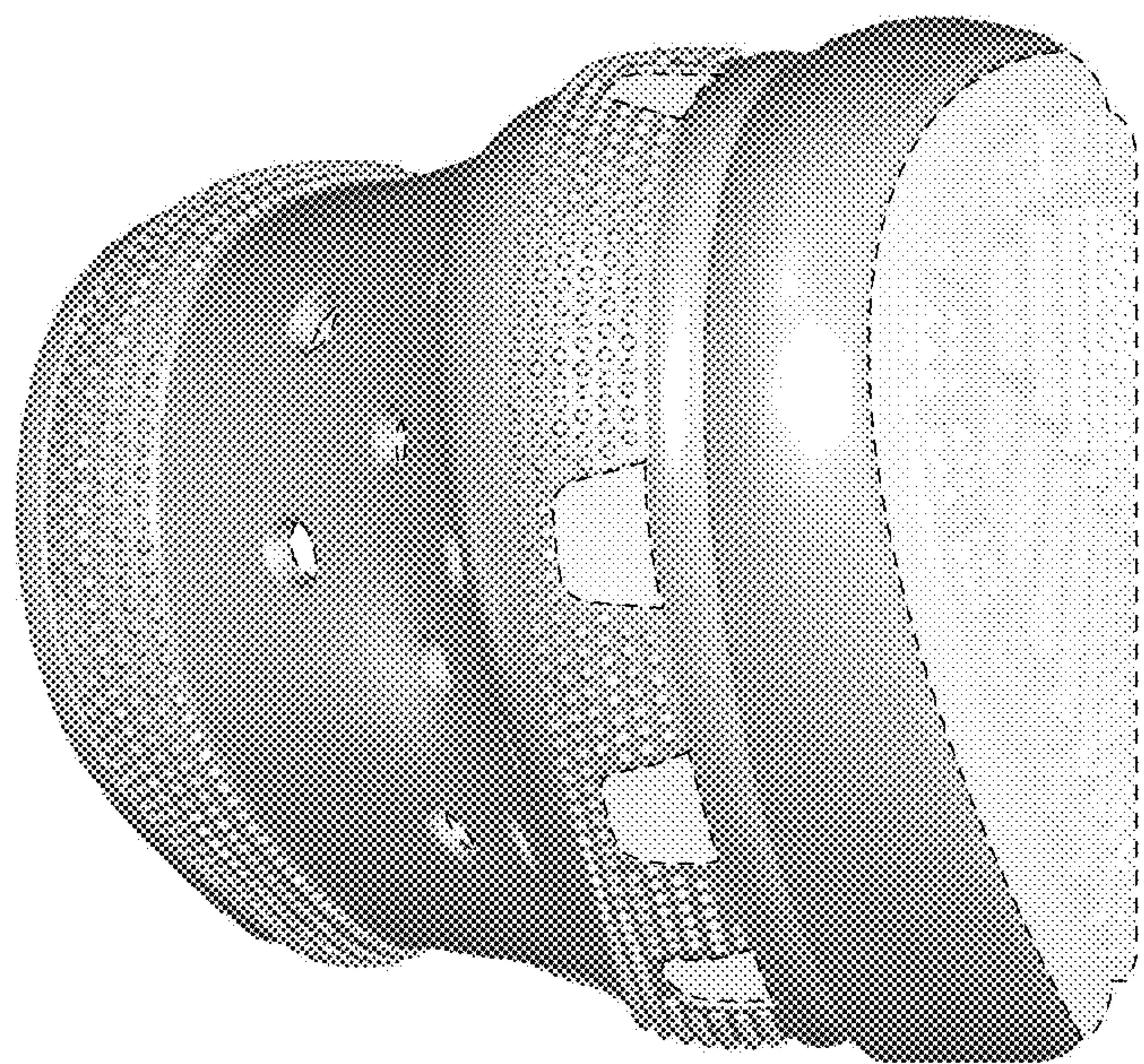

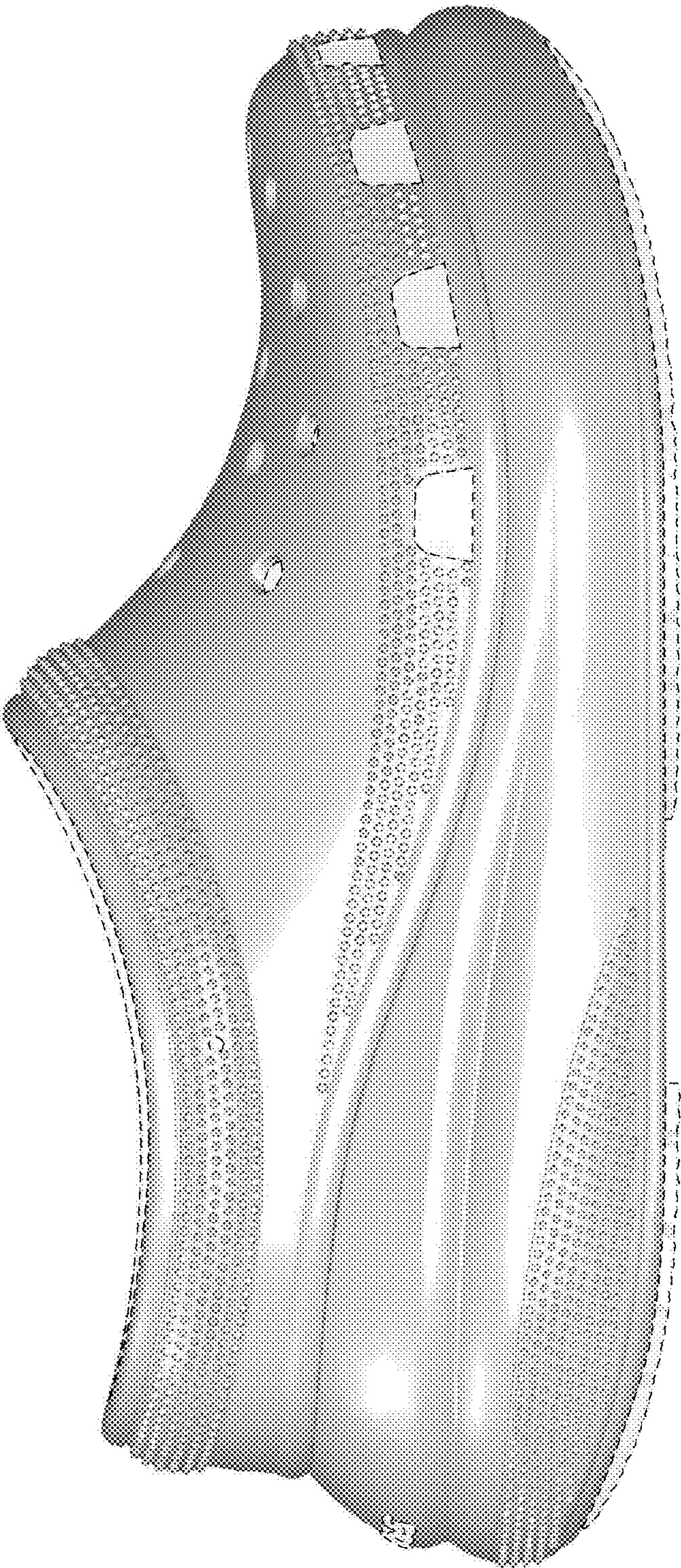

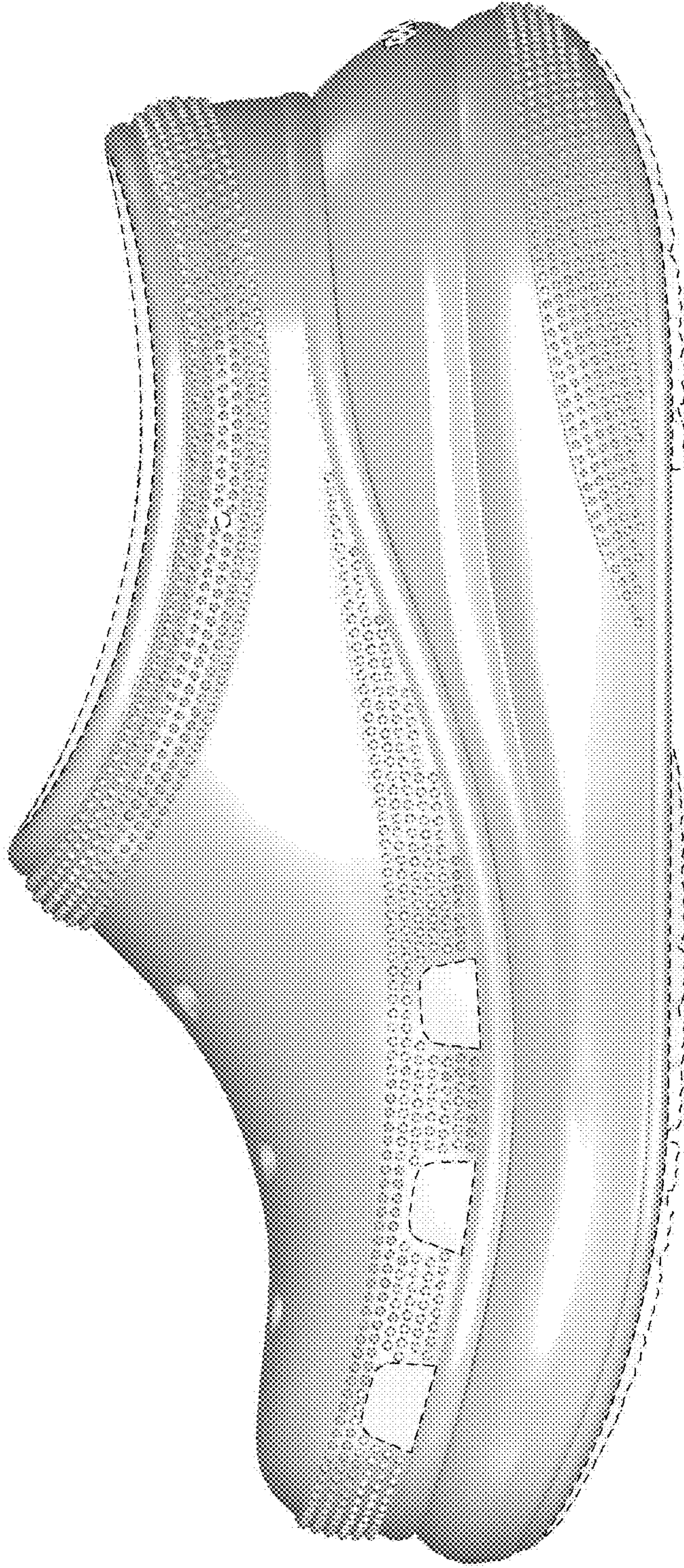

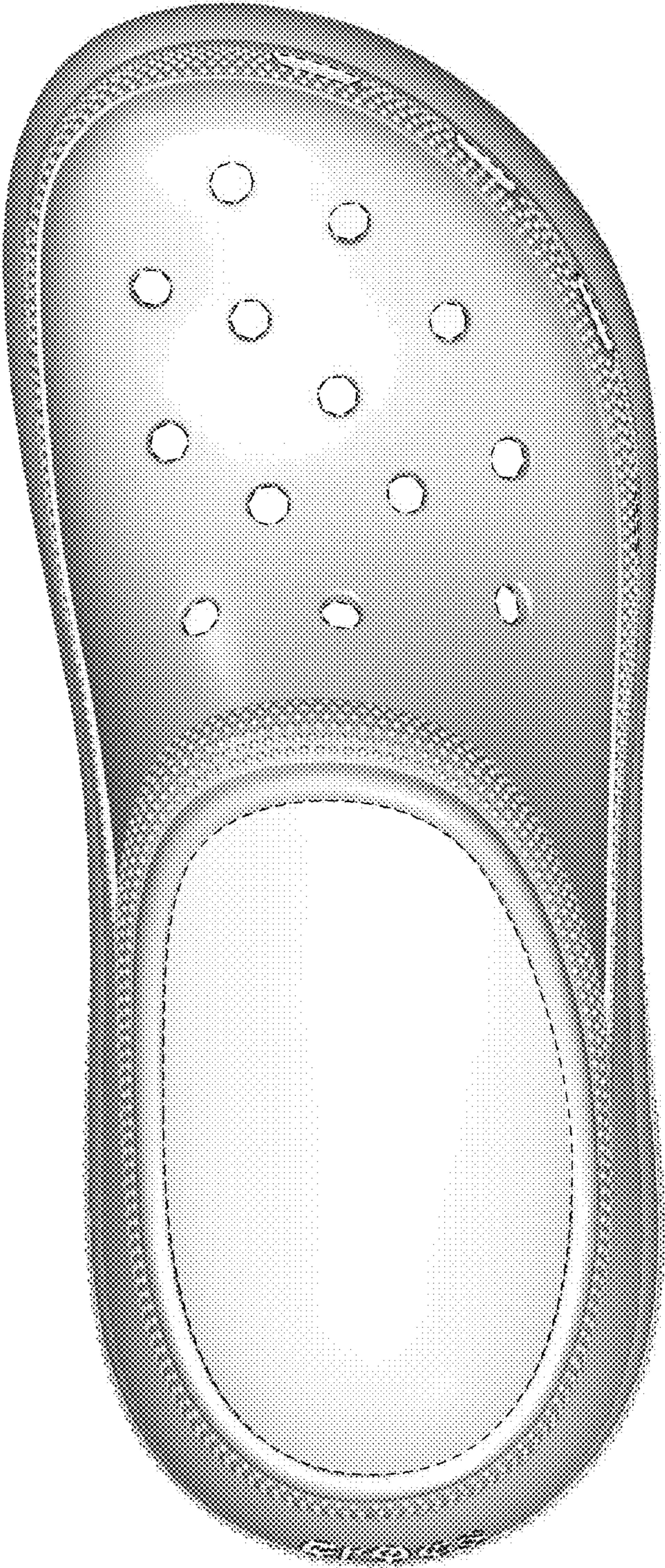
