The ornamental design for a makeup box, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, left side perspective view showing my new design for a makeup box;

FIG. 2 is a top, back, right side perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a back view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof;

FIG. 8 is a bottom view thereof;

FIG. 9 is a bottom, front, left side perspective view thereof, showing the makeup box in an opened configuration;

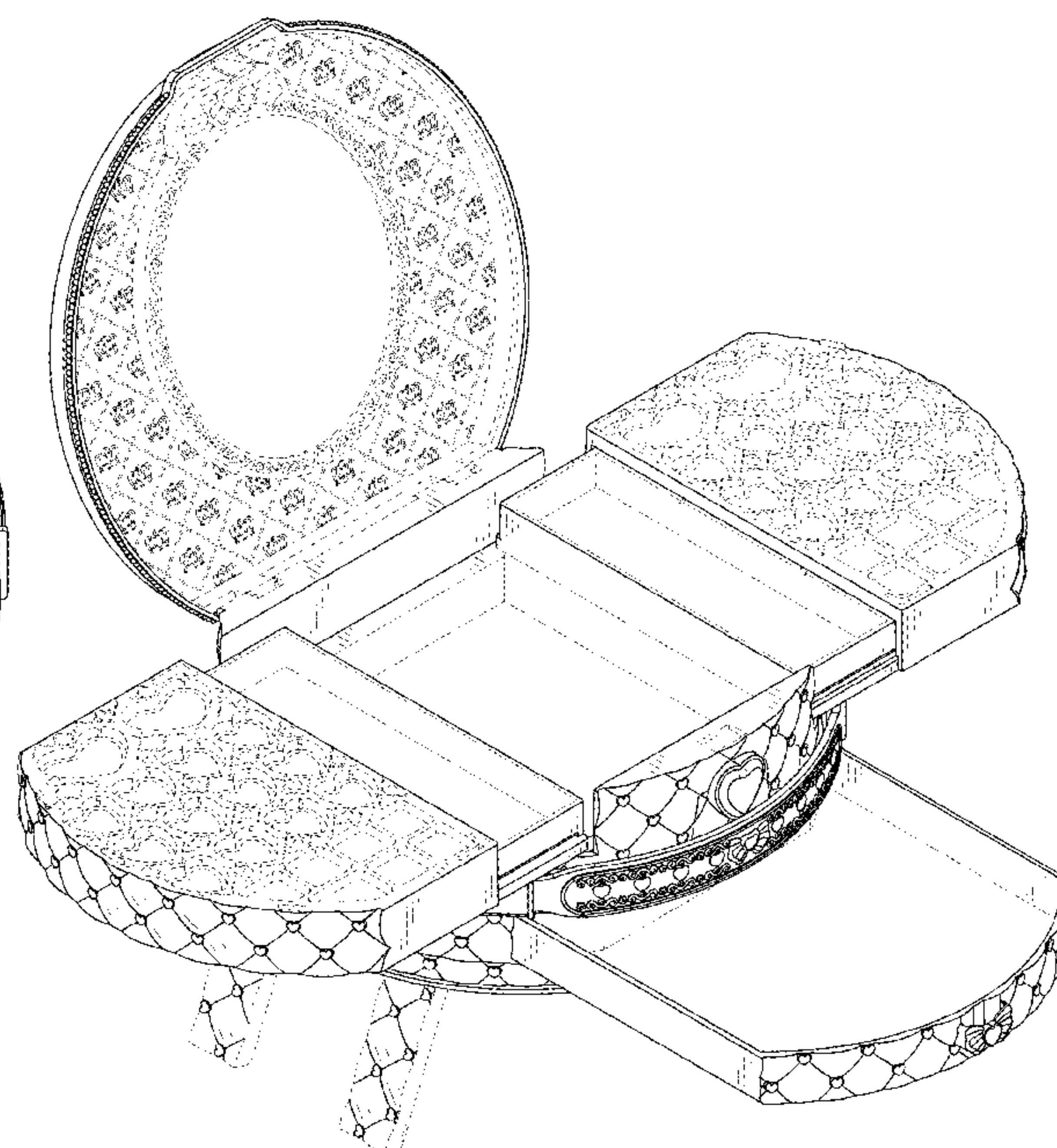
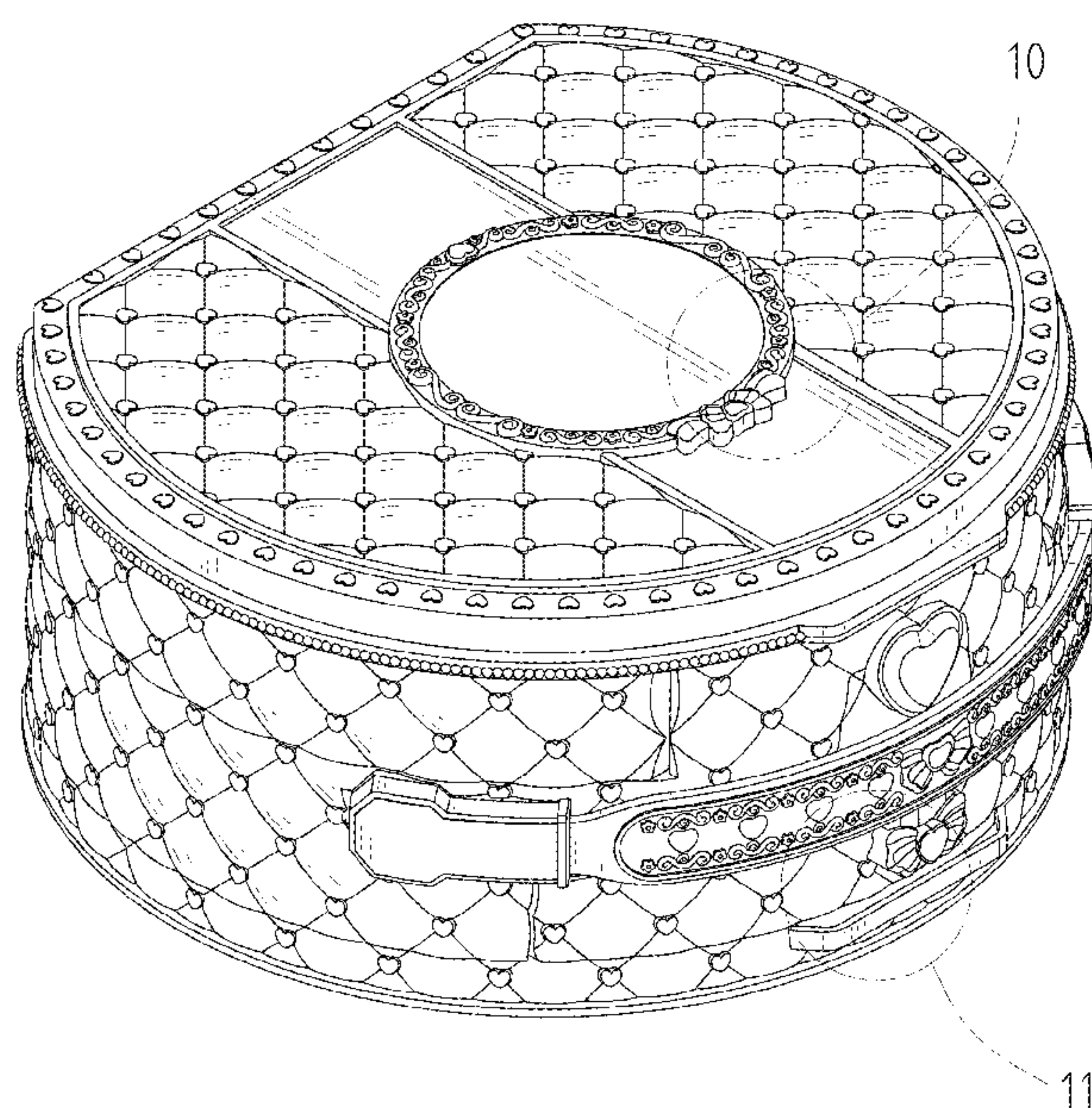
FIG. 10 is an enlarged view of the portion of the makeup box encircled in FIG. 1;

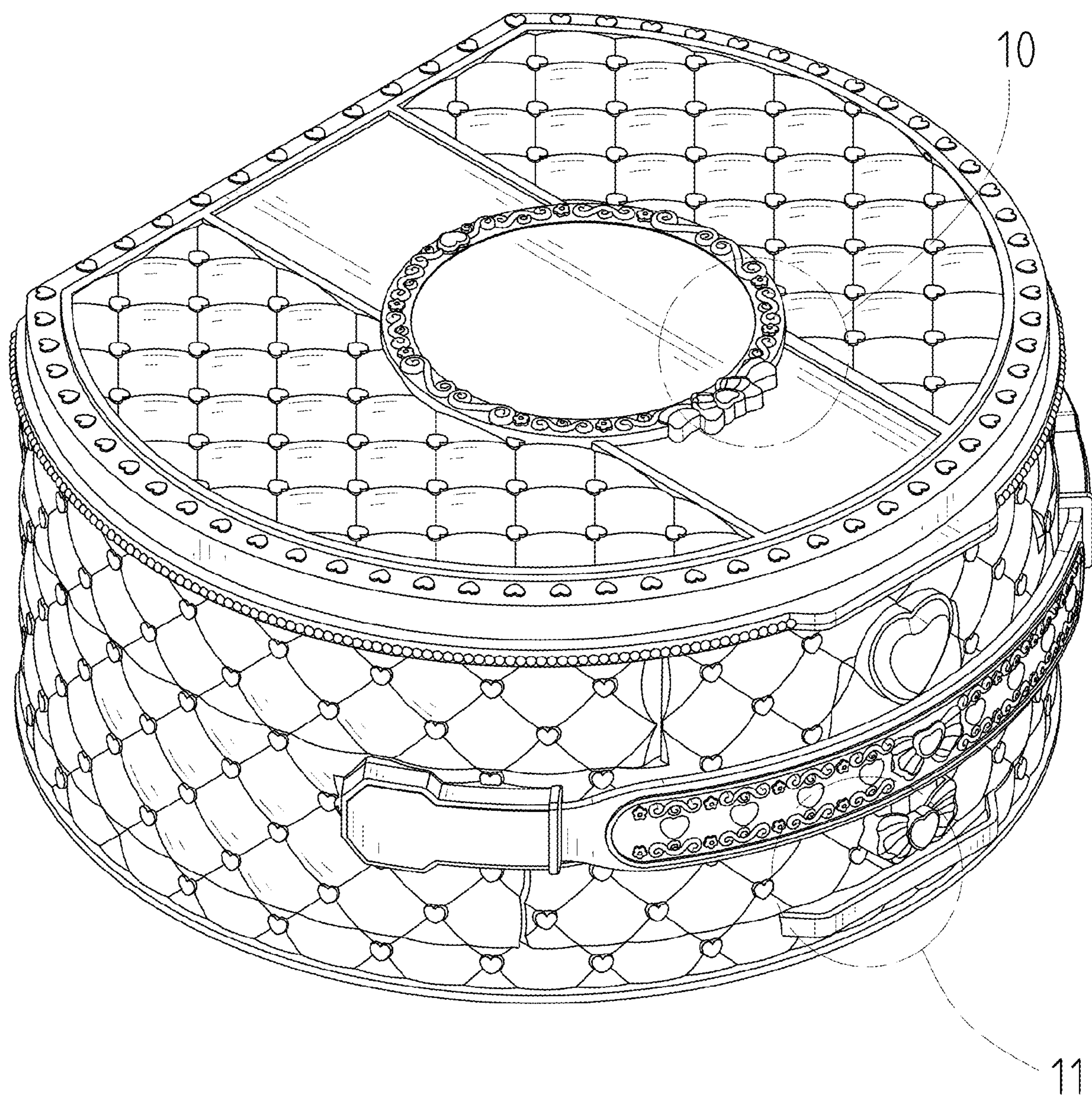

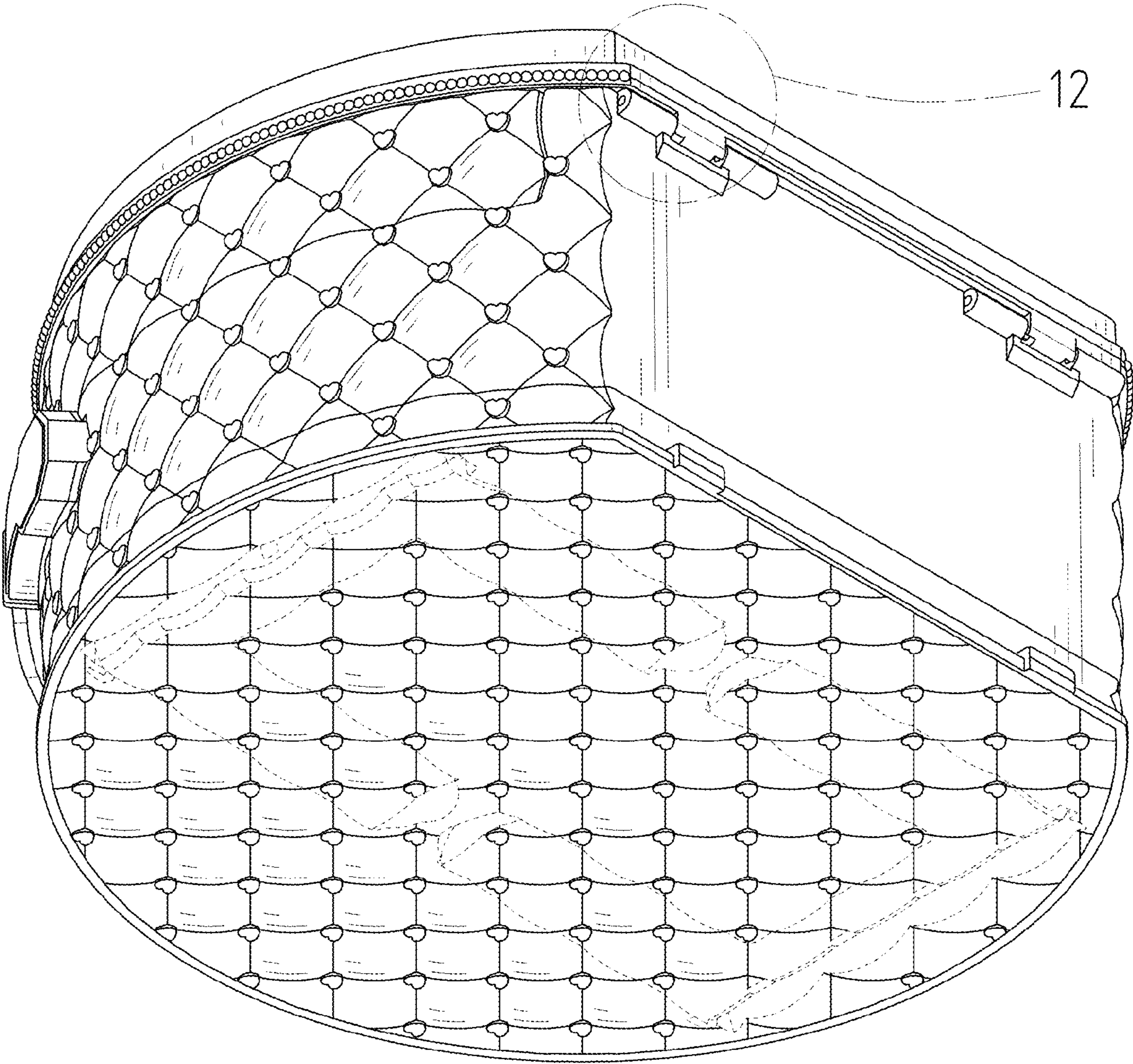

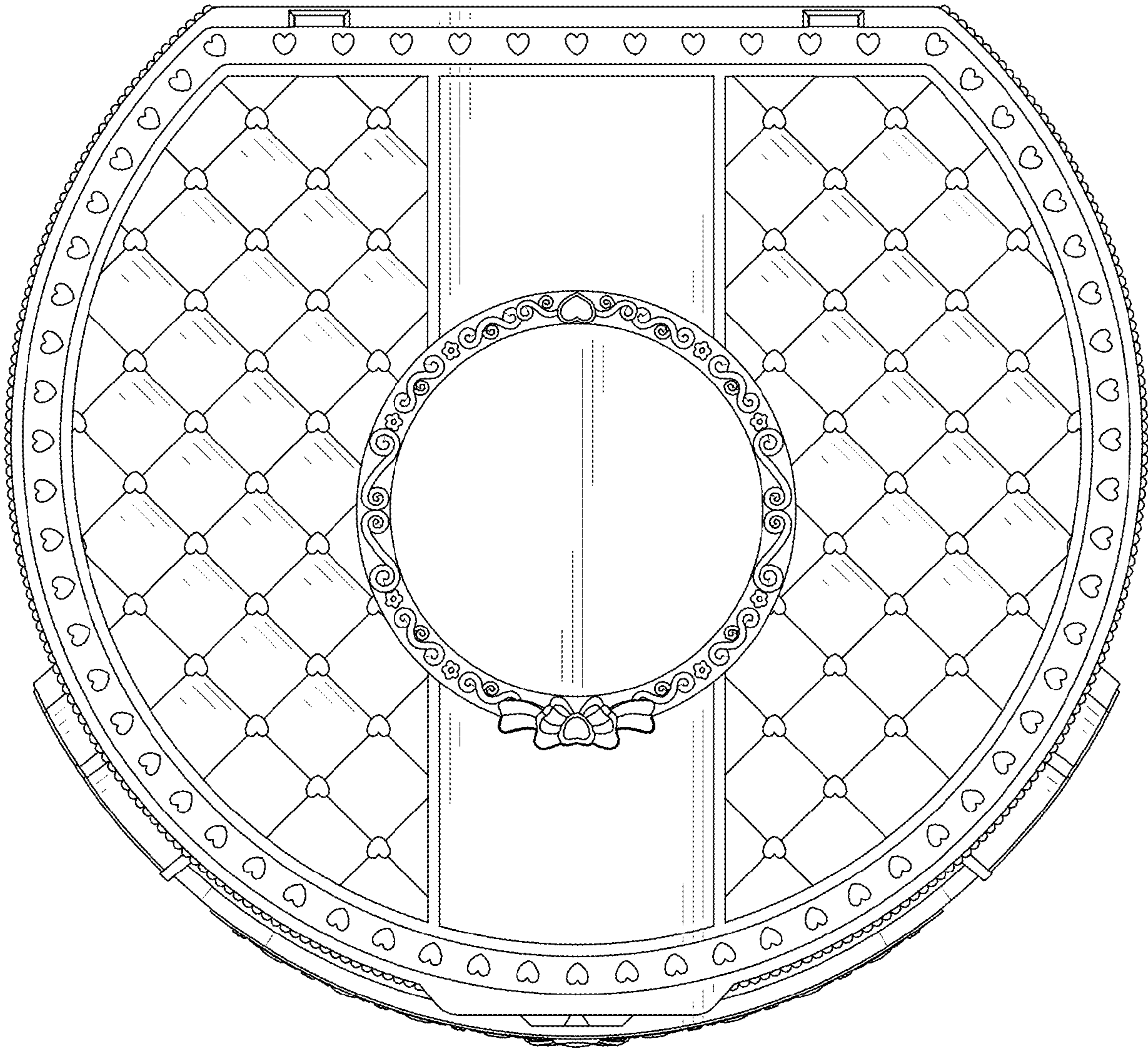

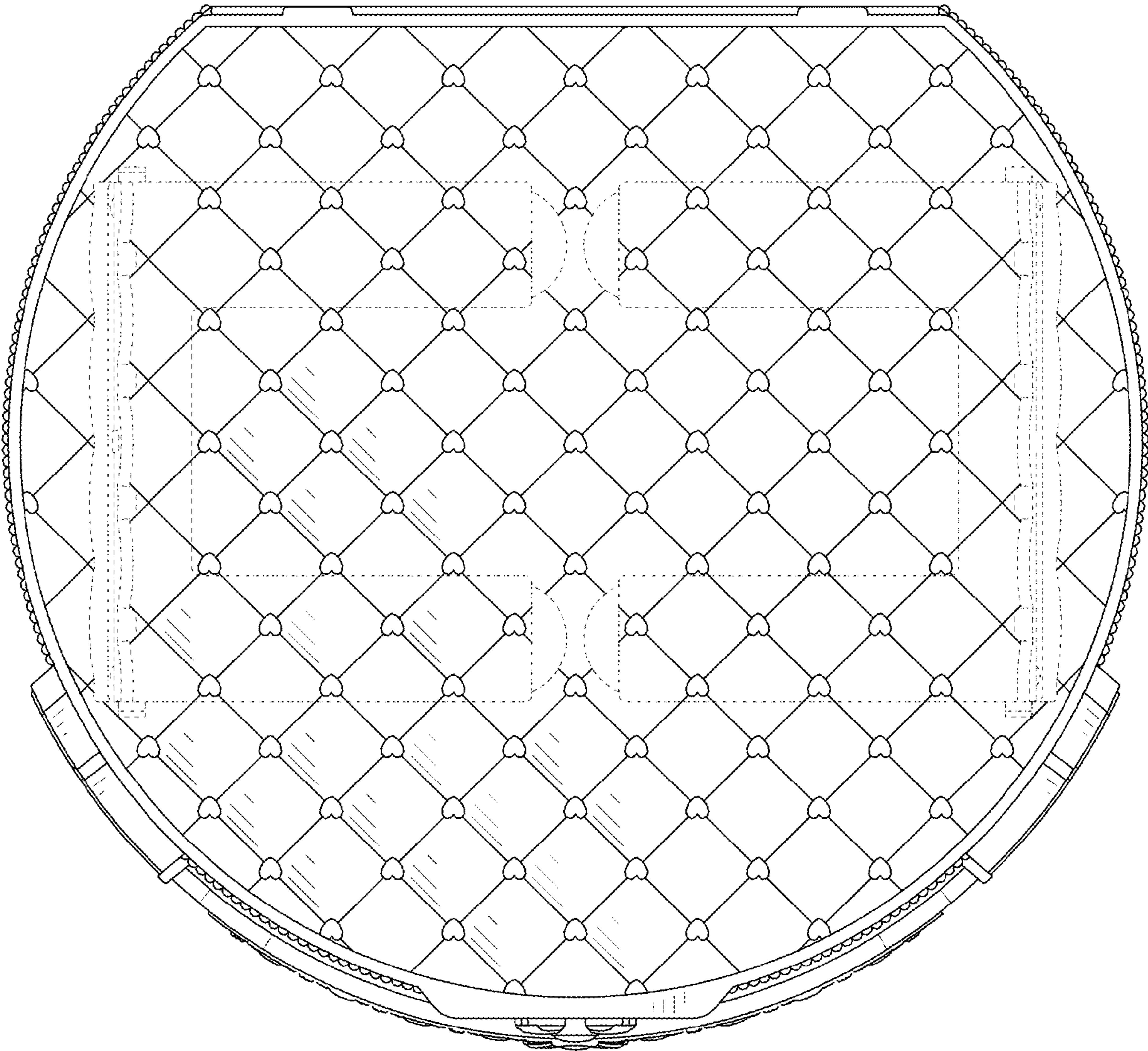

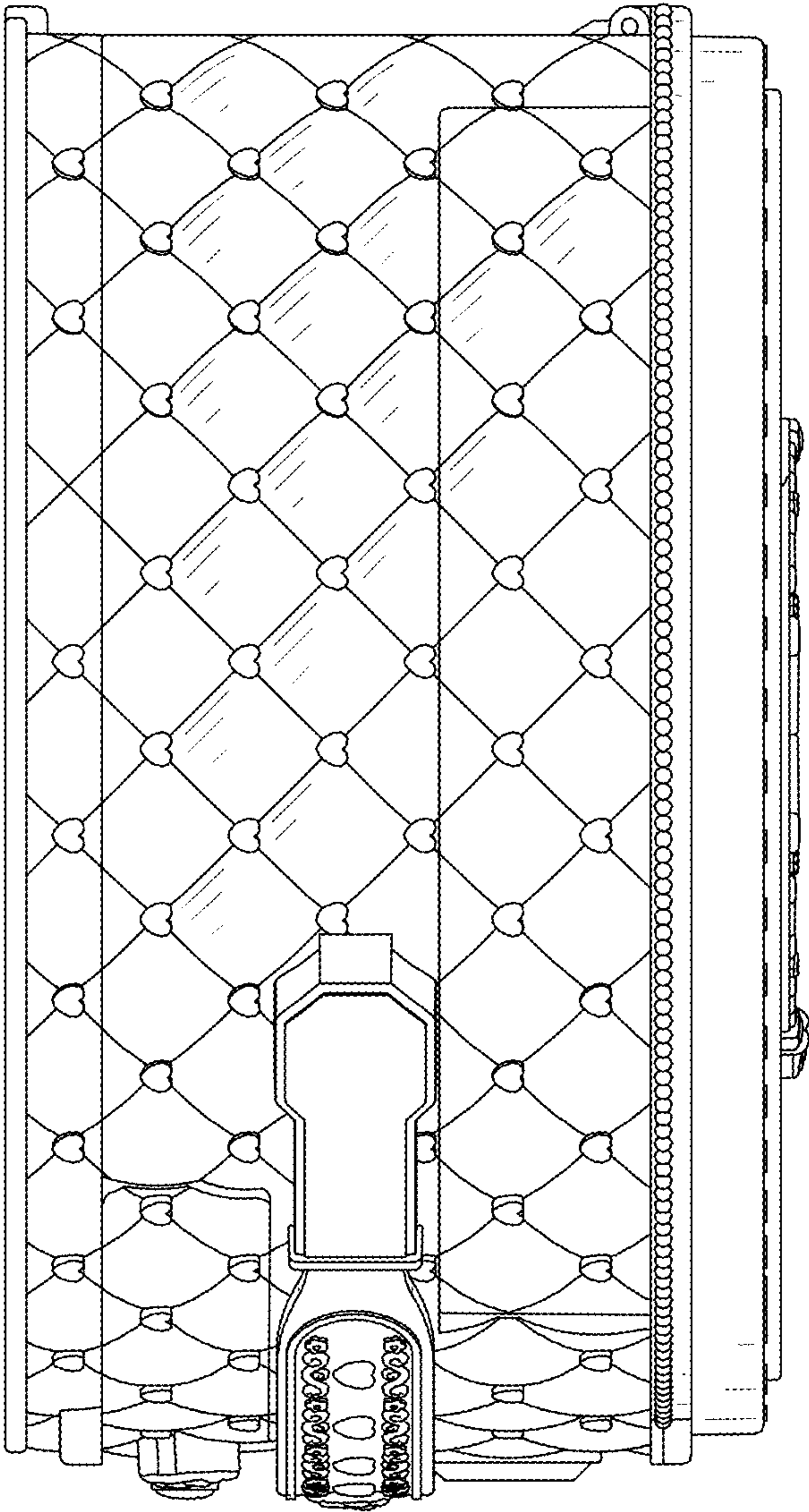

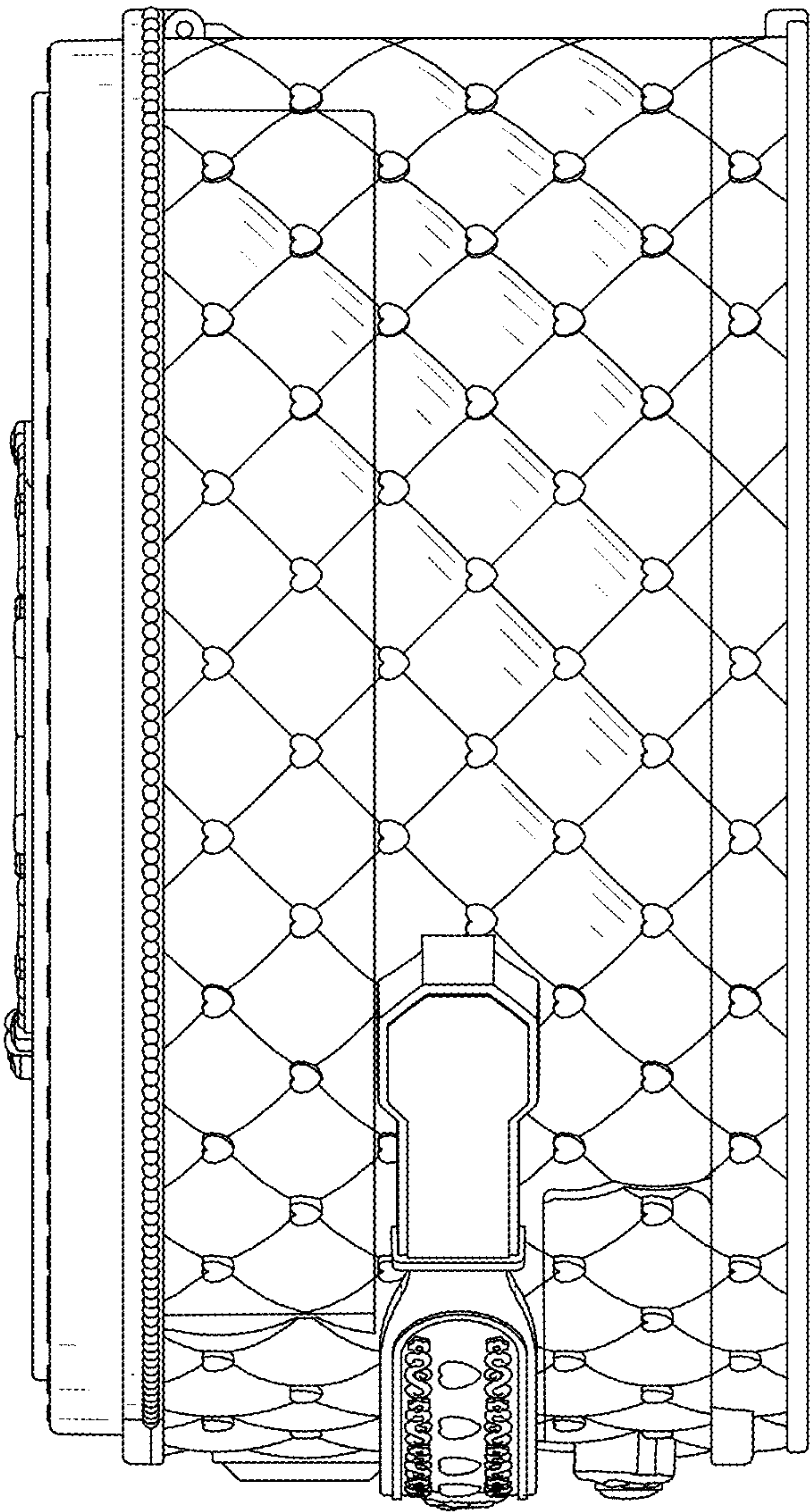

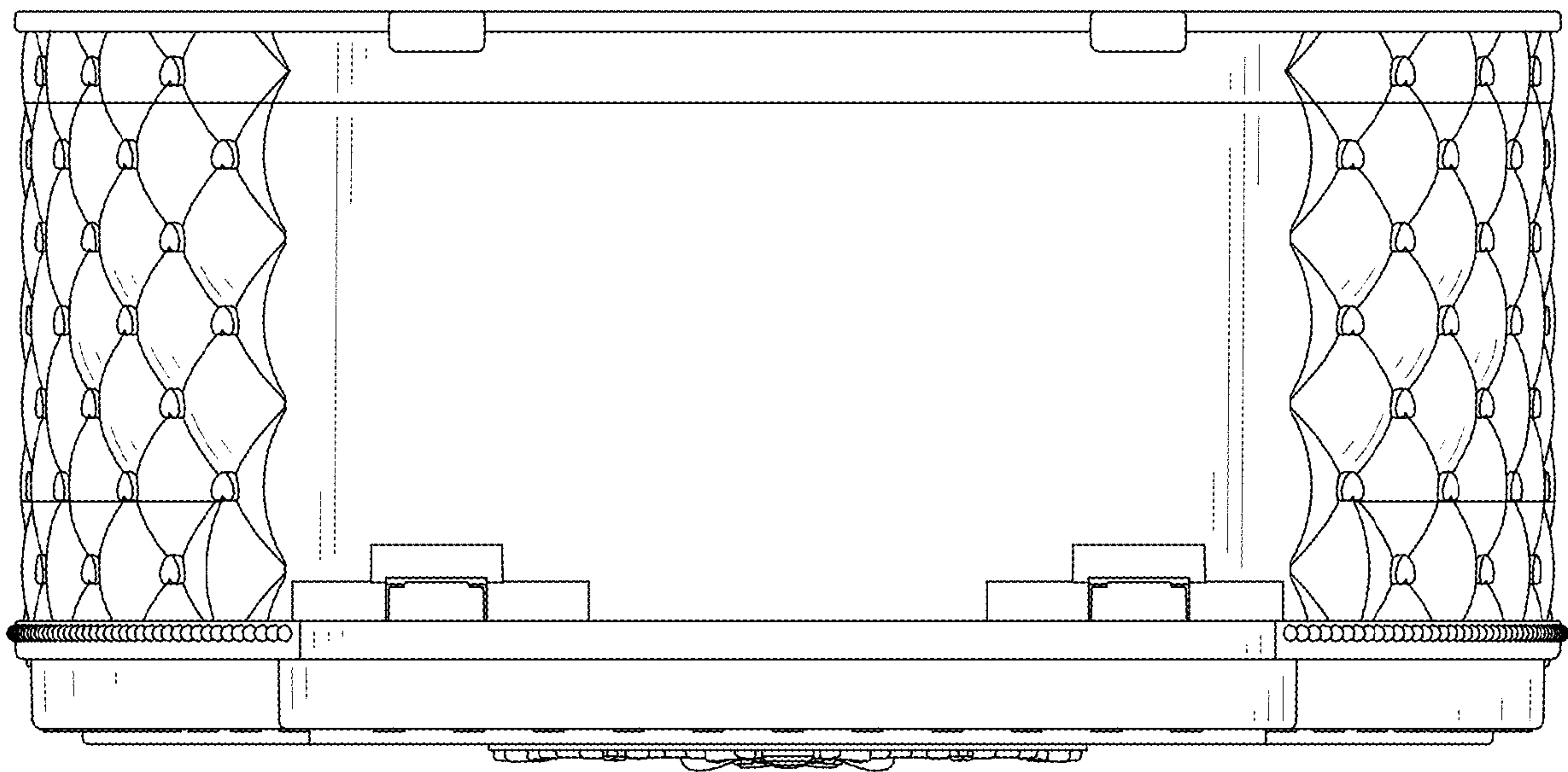

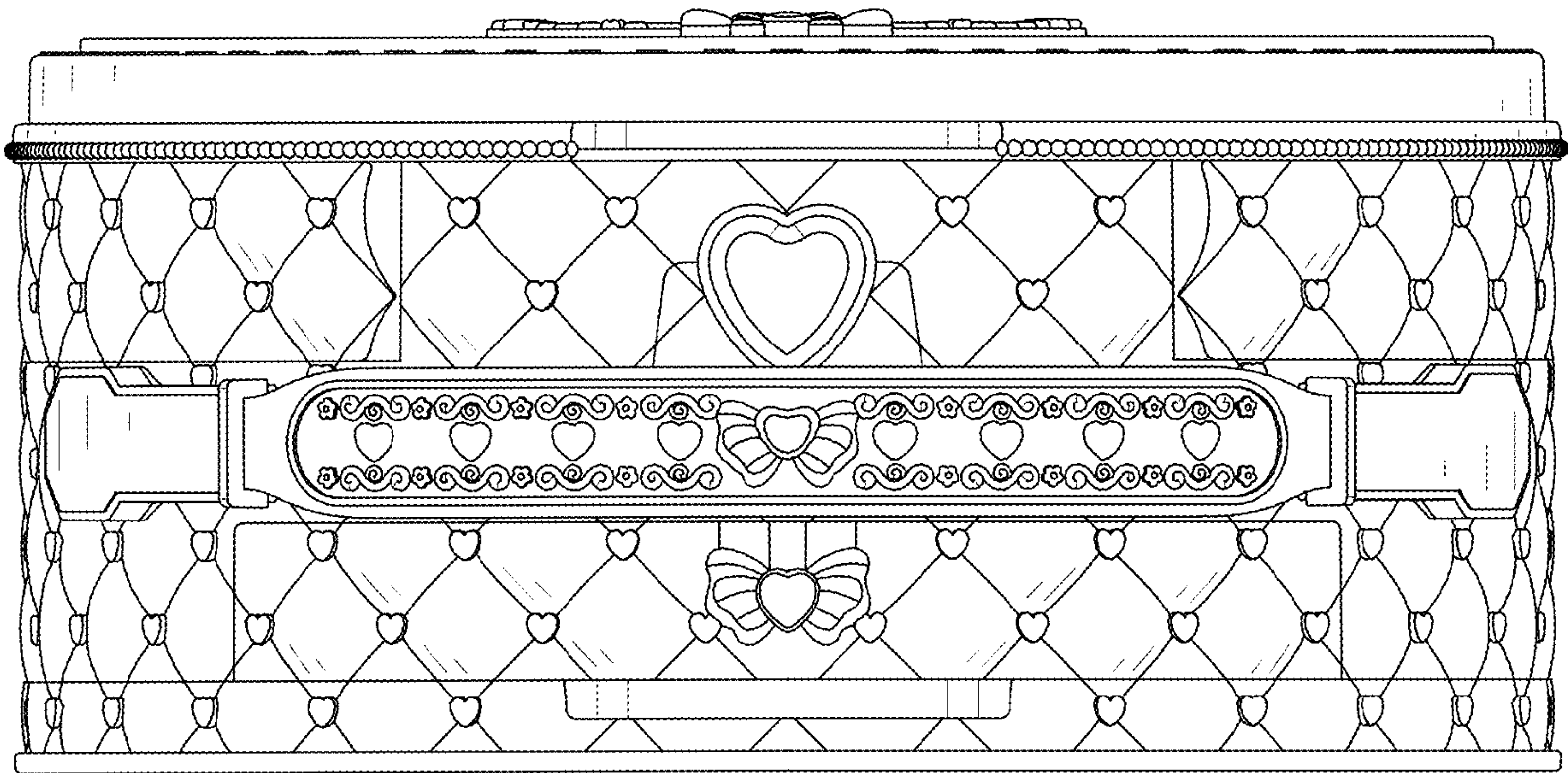

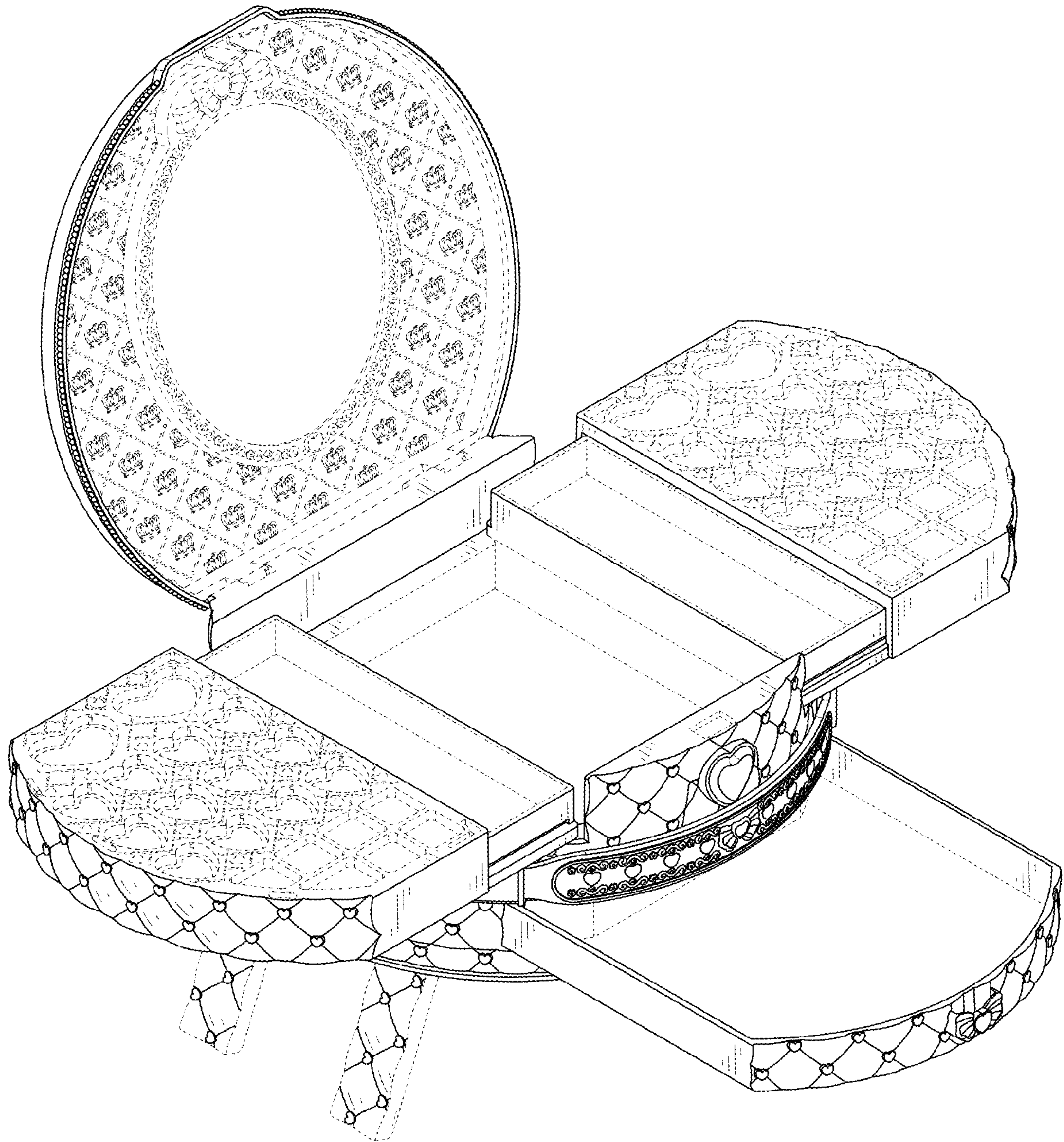

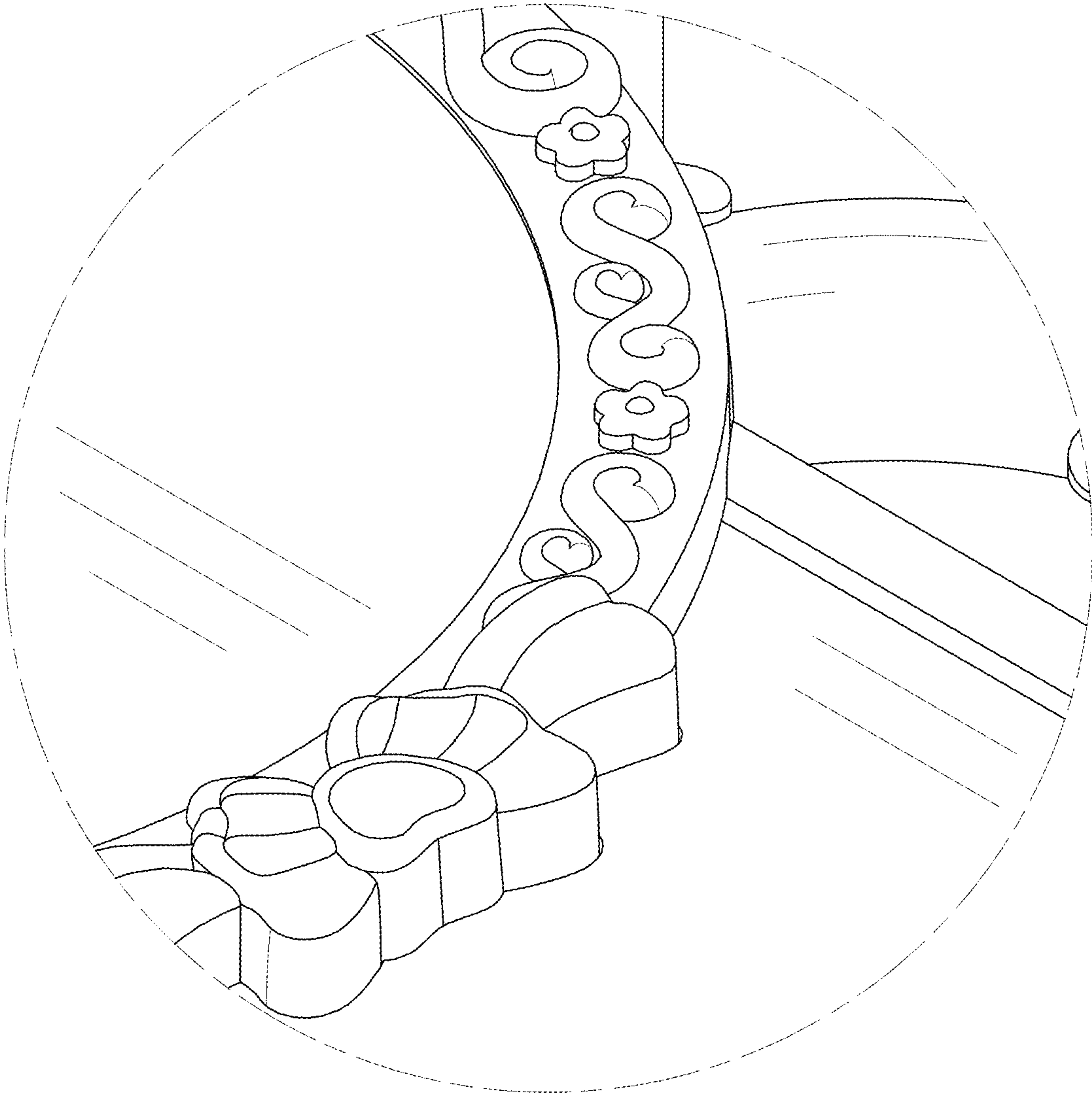

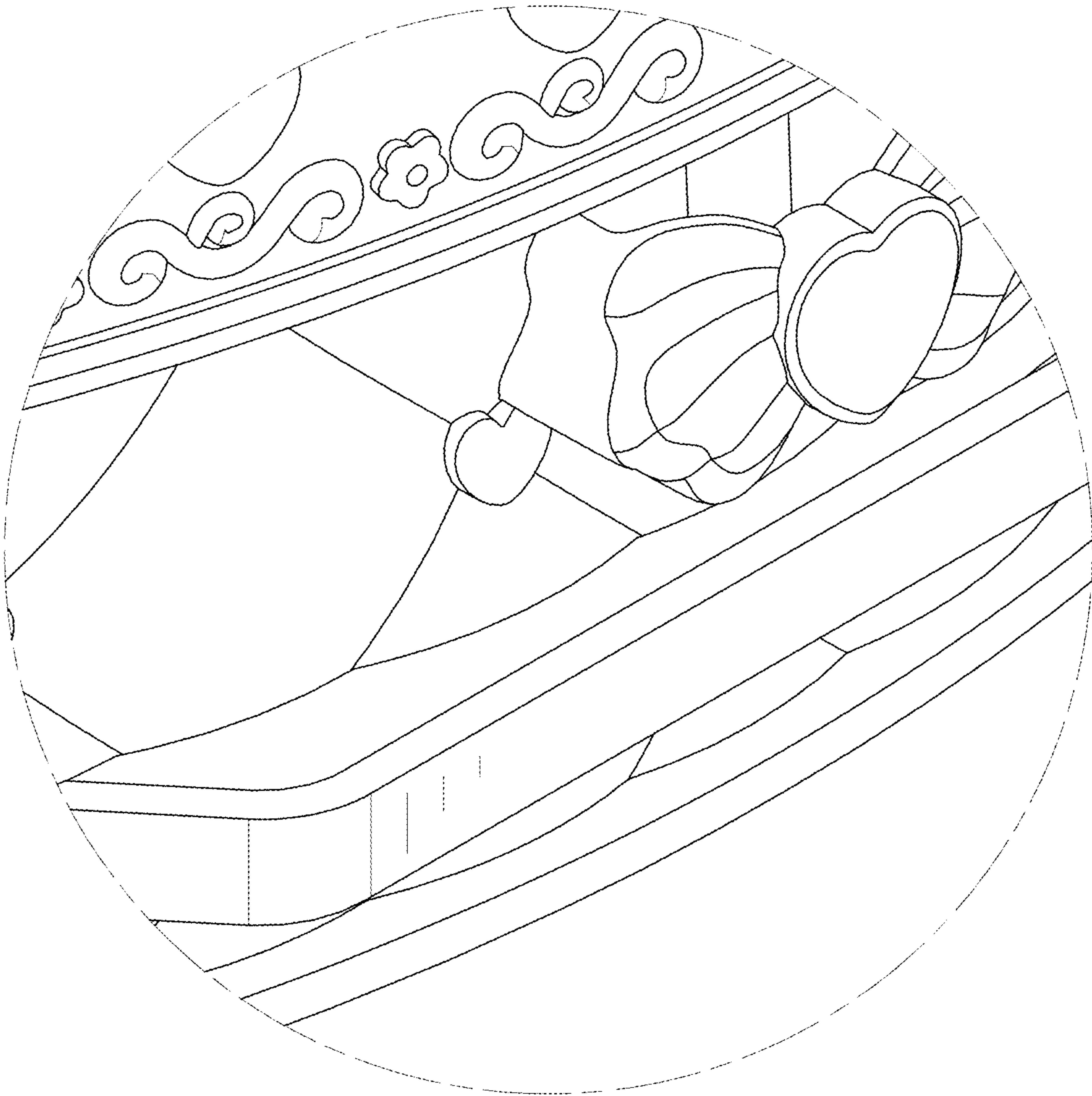

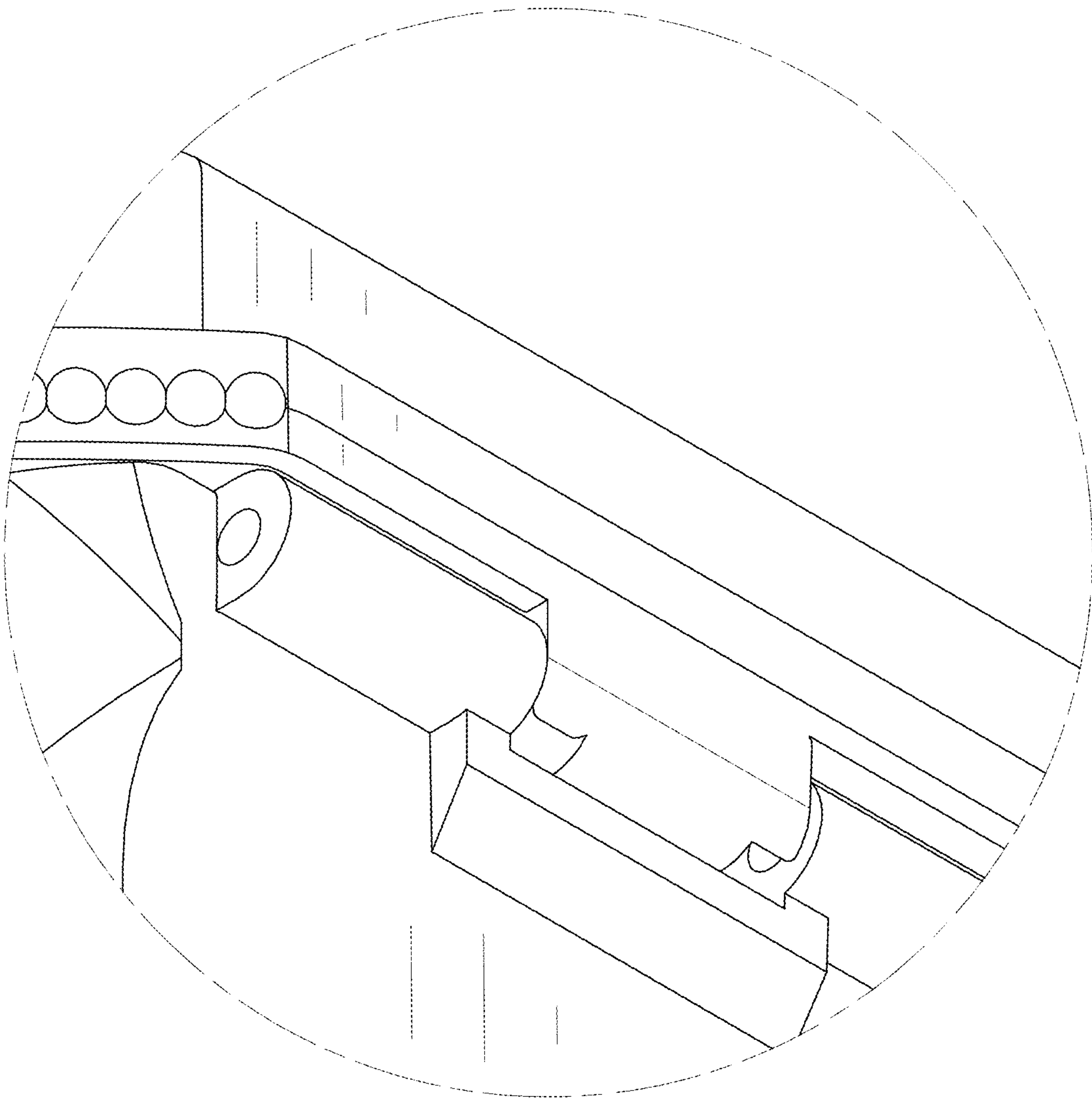
