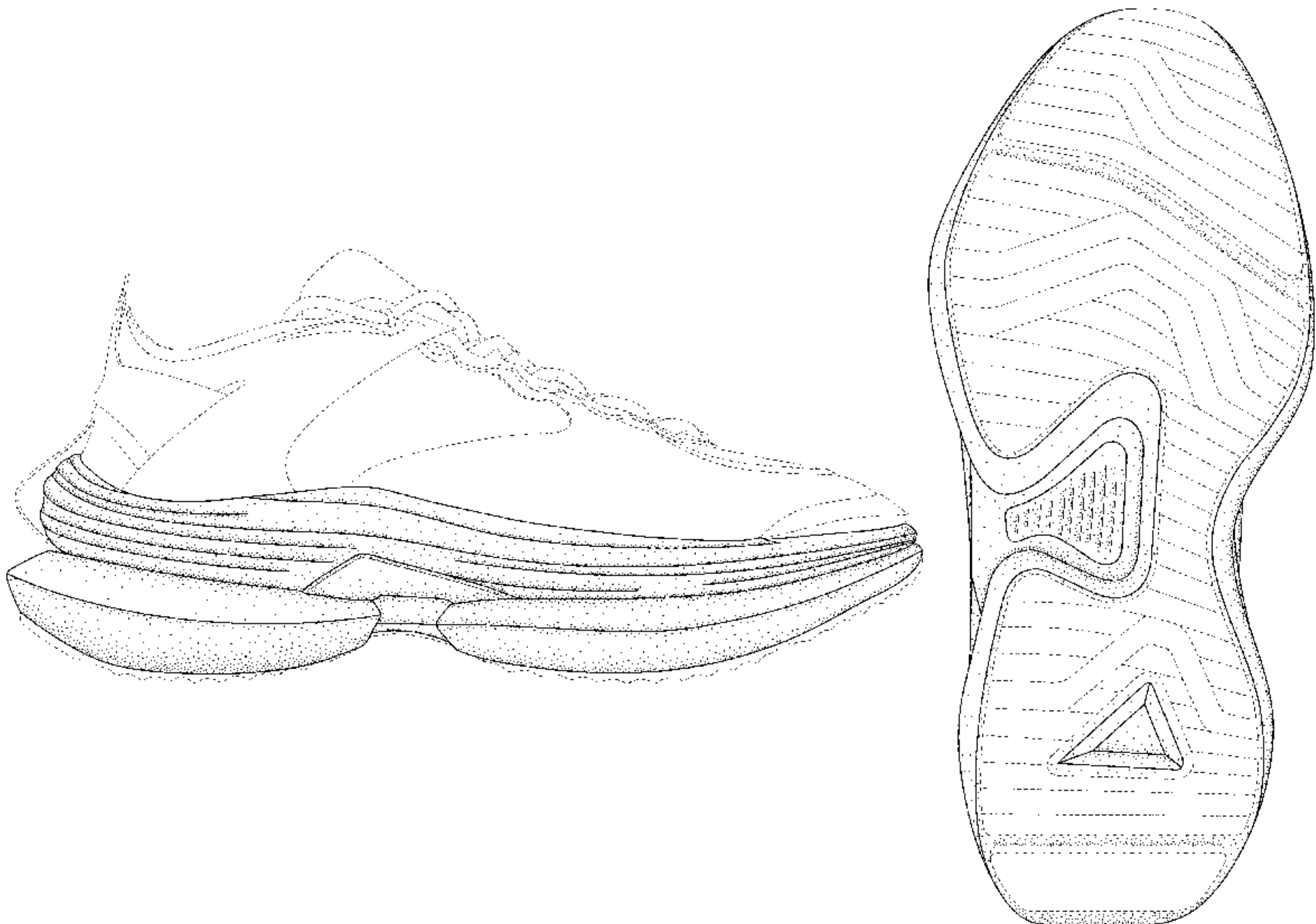
(57) CLAIM

DESCRIPTION

FIG. 1 is a top, right, and front perspective view of an ornamental design for a shoe;
FIG. 2 is a front elevational view of the shoe of FIG. 1;

FIG. 4 is a right side elevational view of the shoe of FIG. 1;

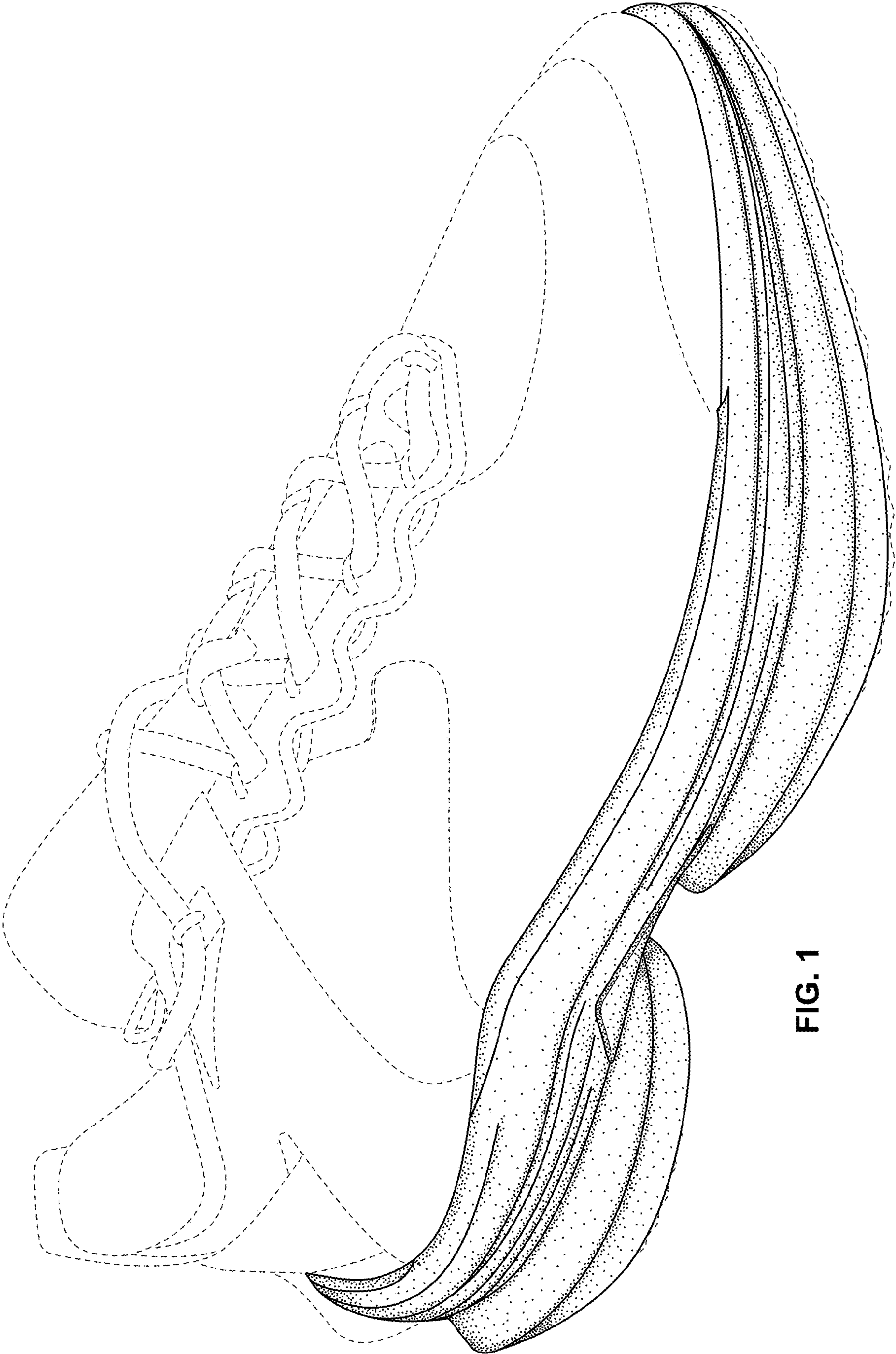

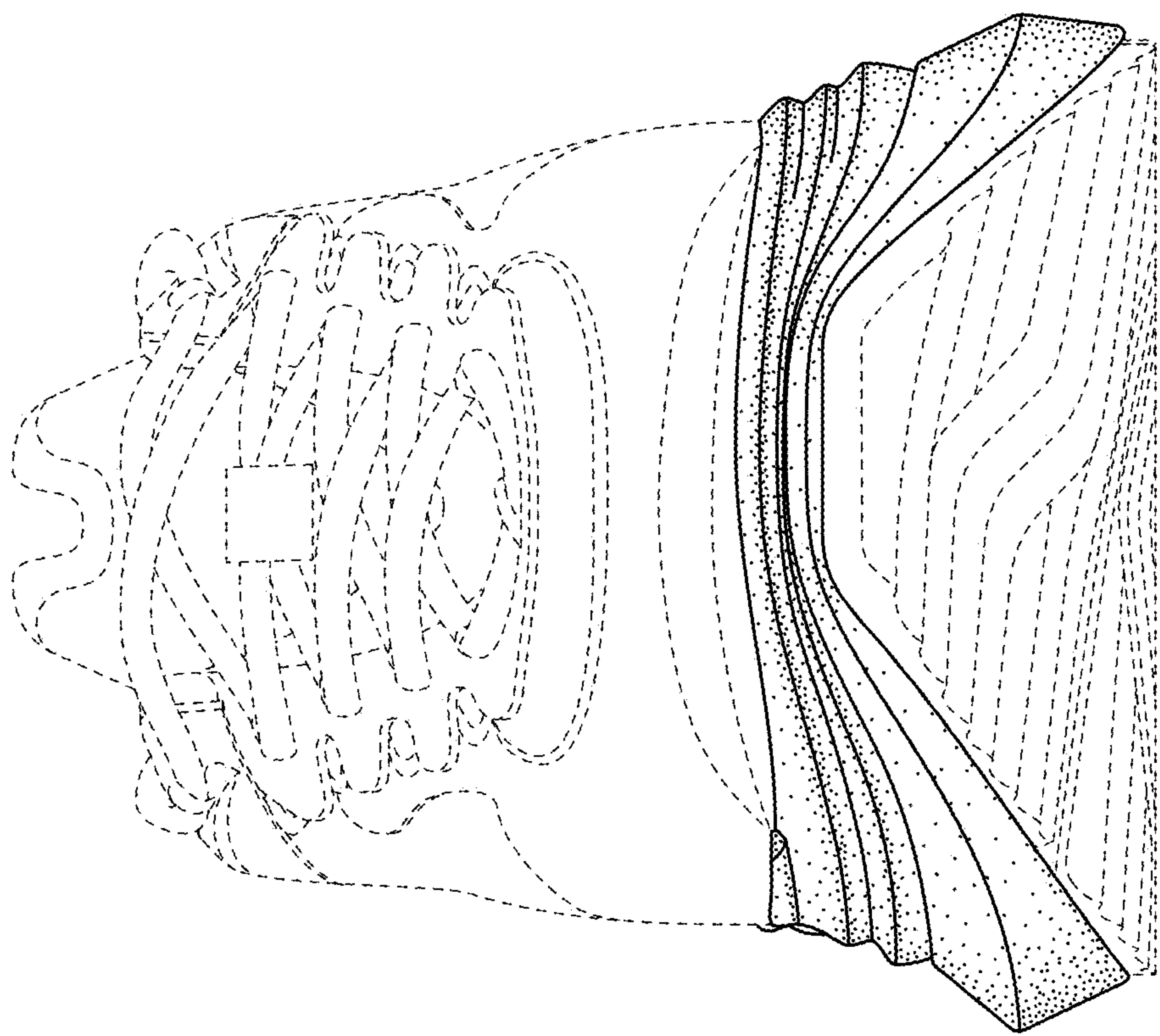

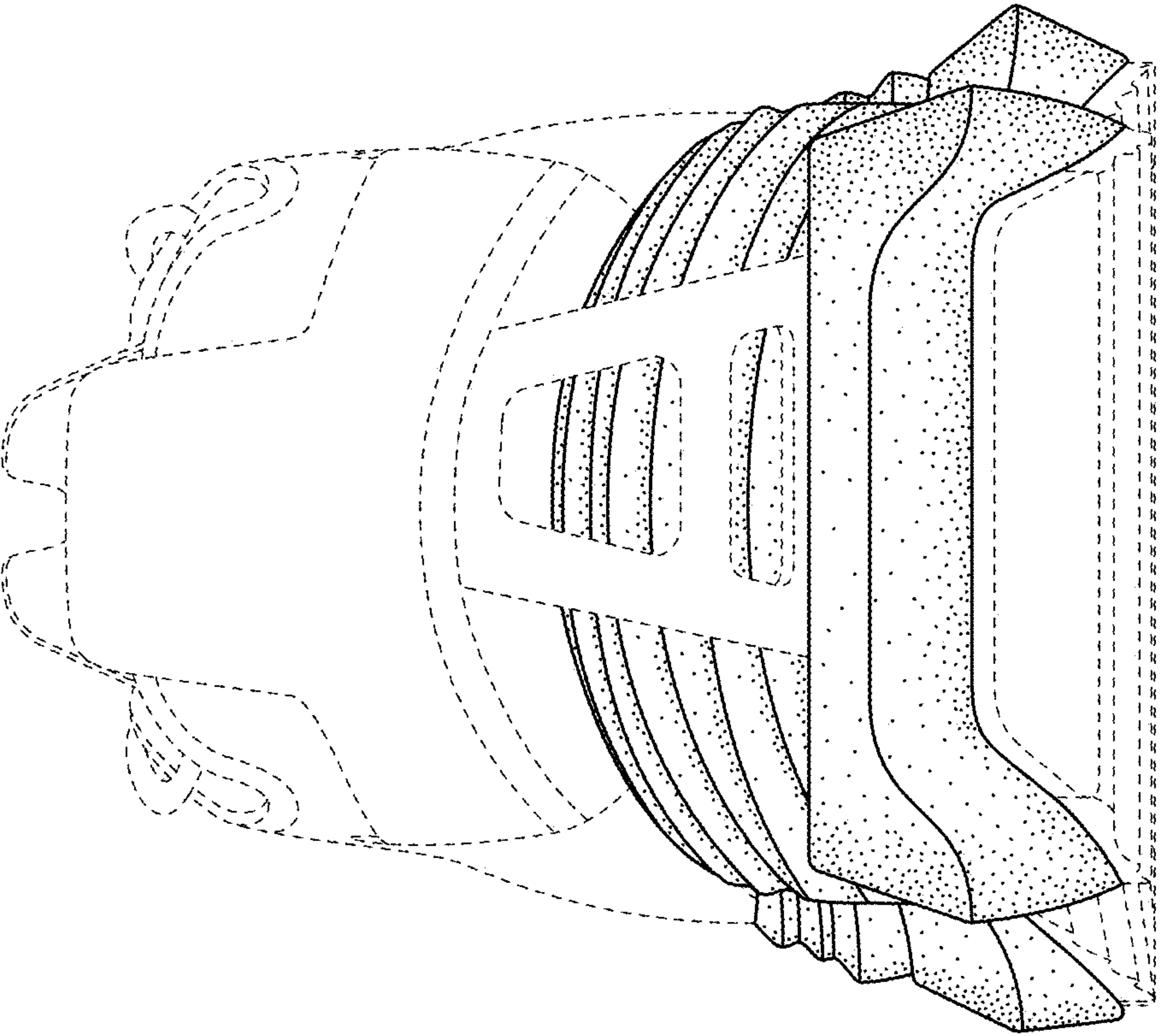

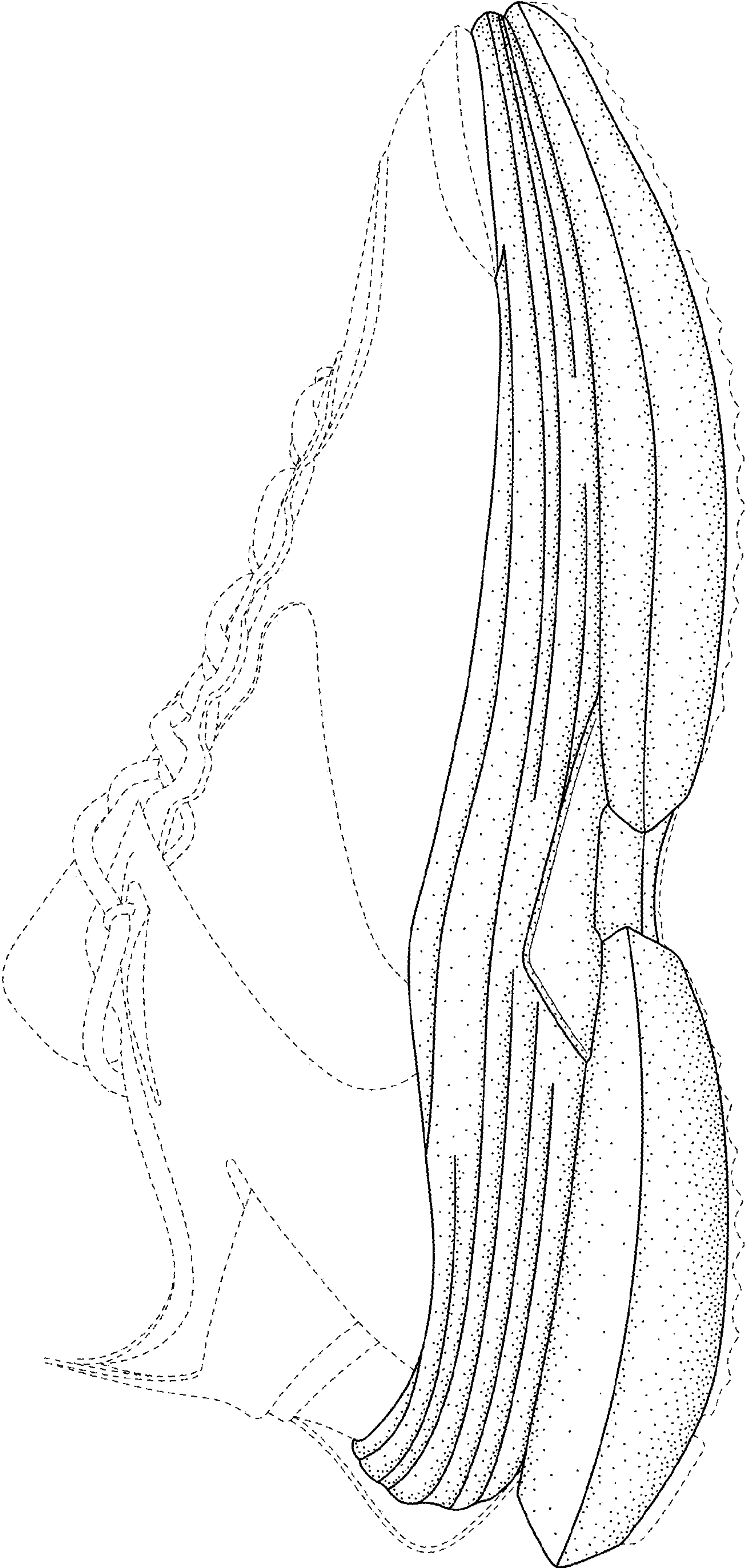

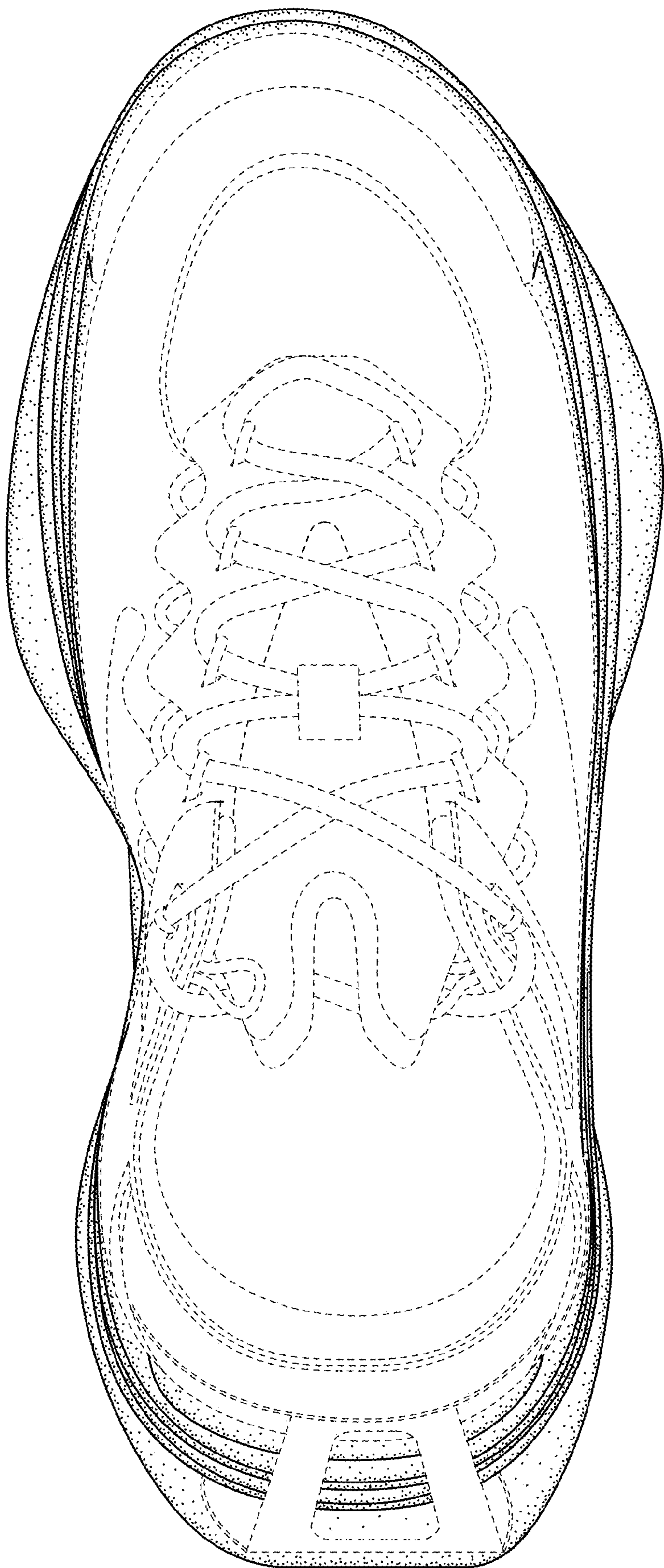

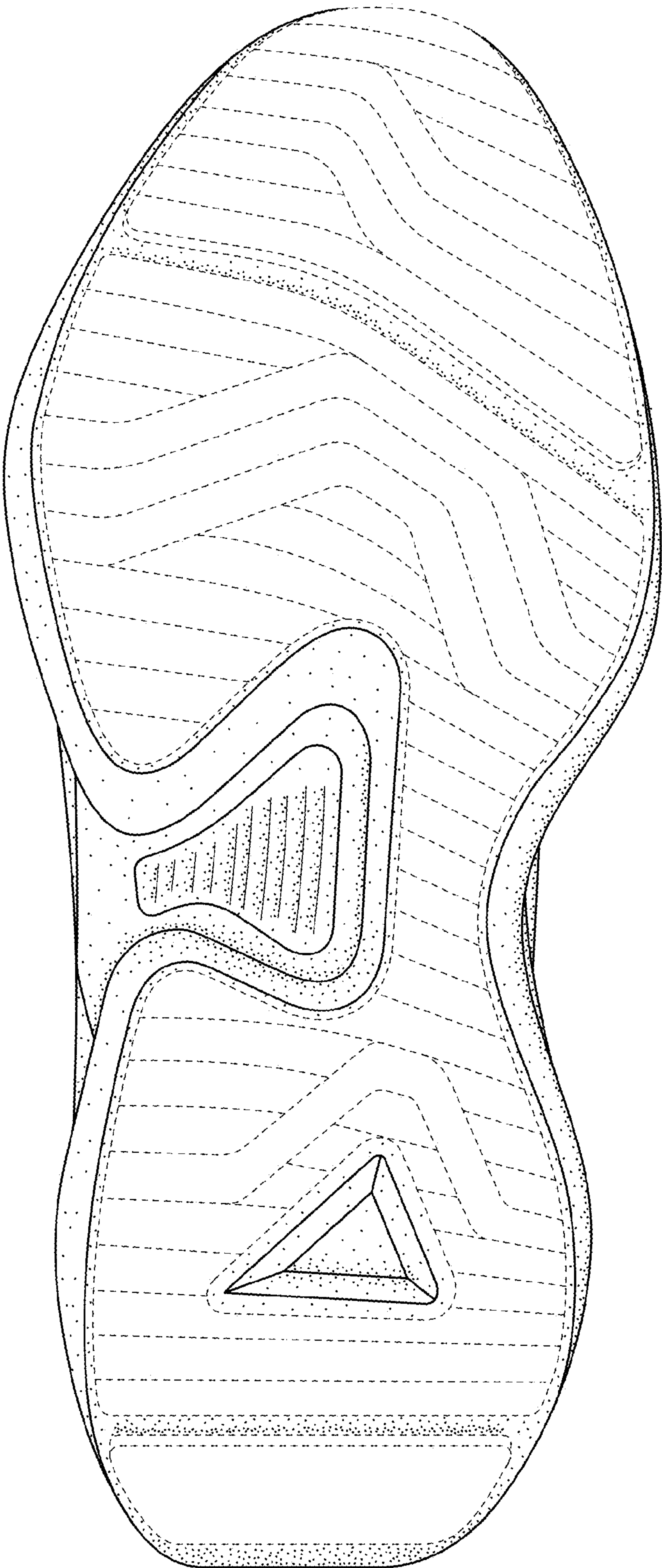

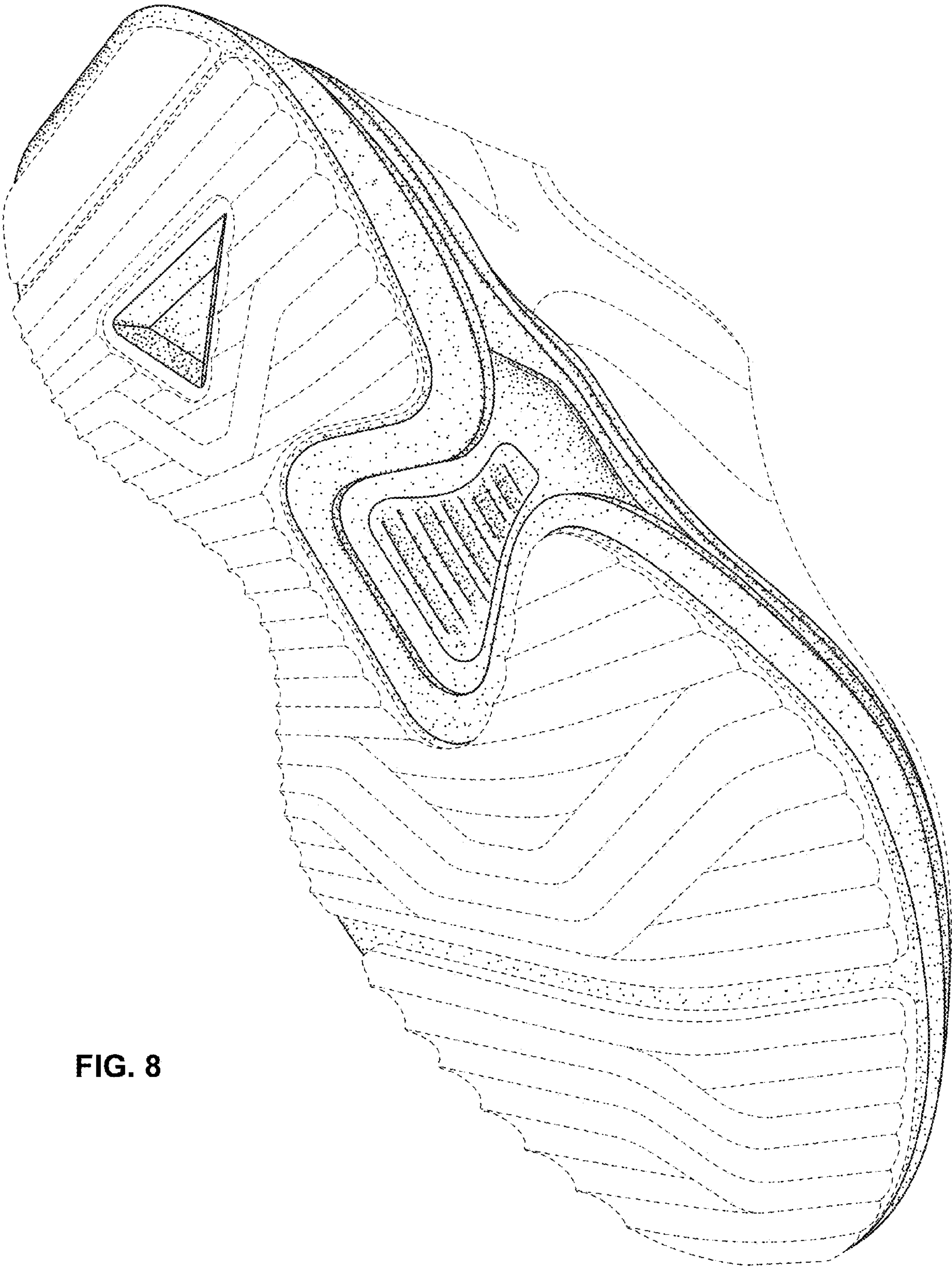
