The broken lines shown in the drawings depict portions of the food waste disposer trim shell housing that form no part of the claimed design.

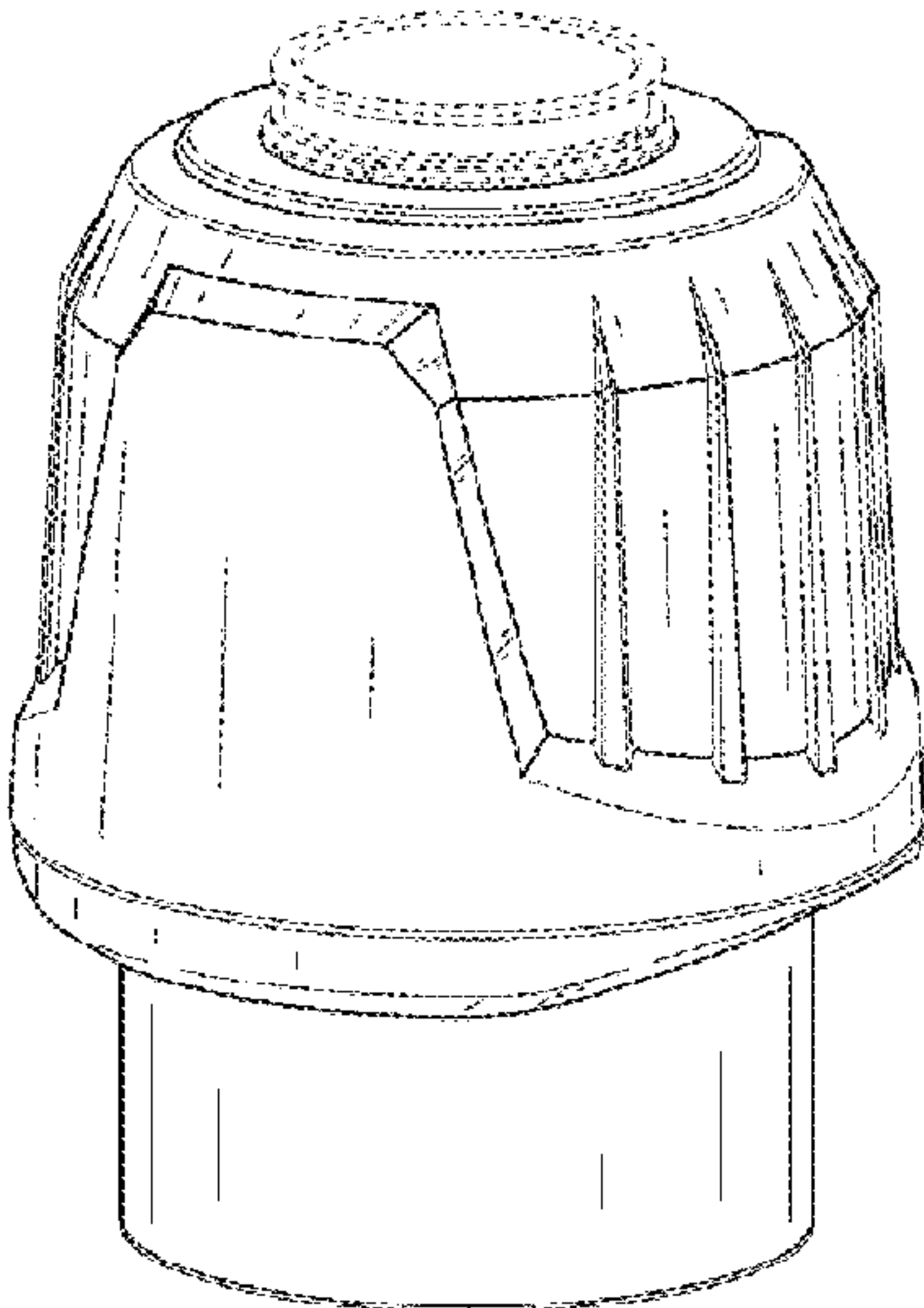

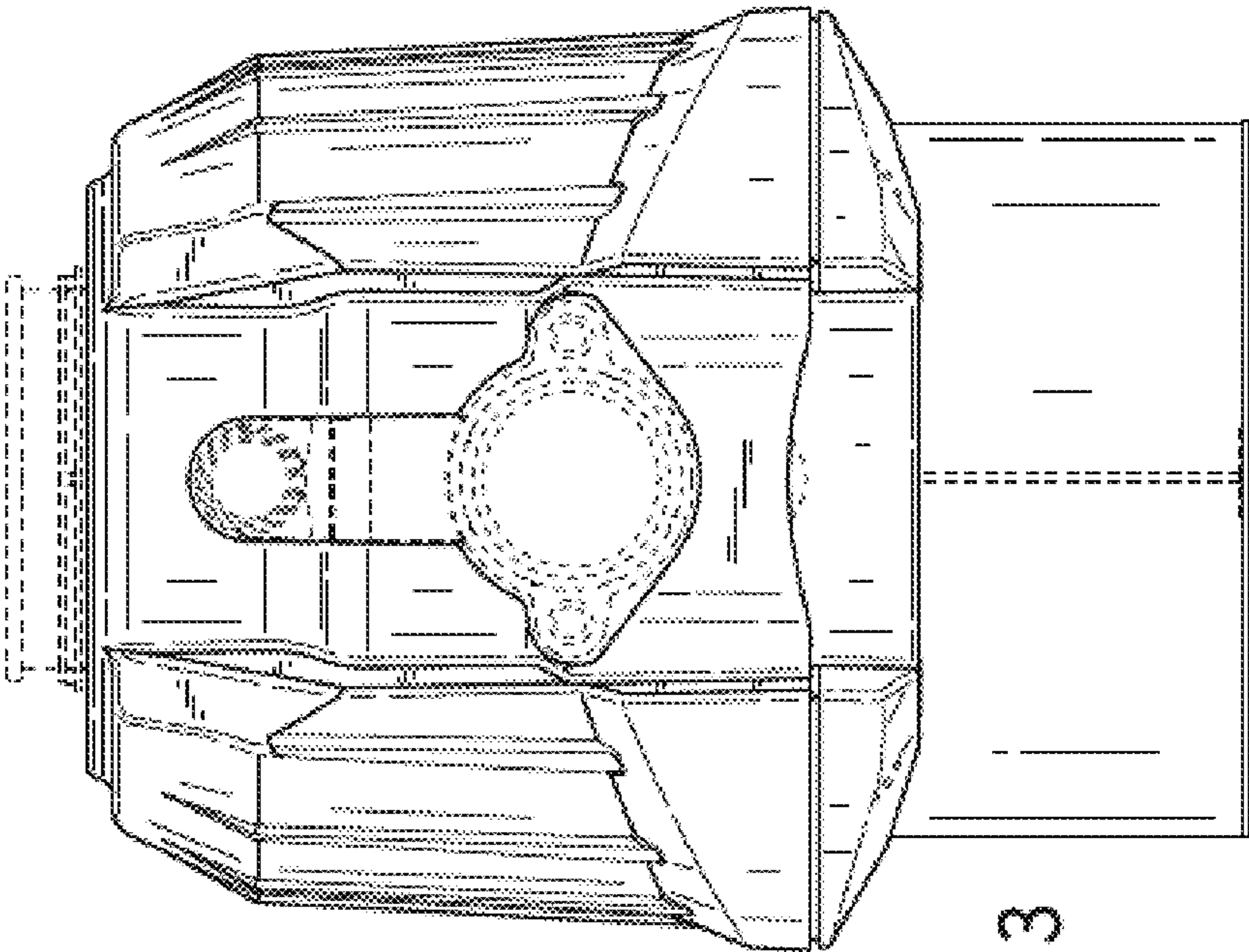

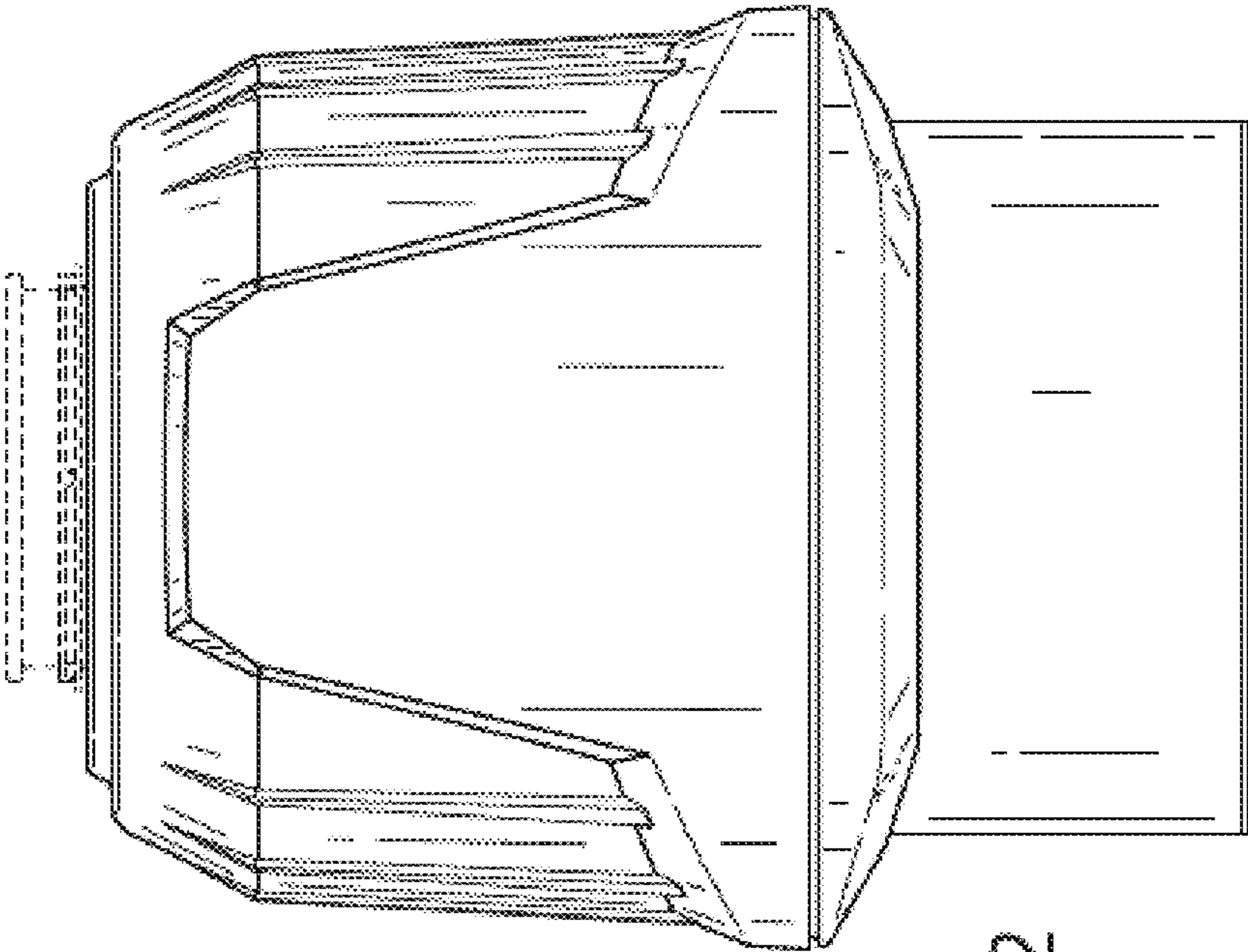

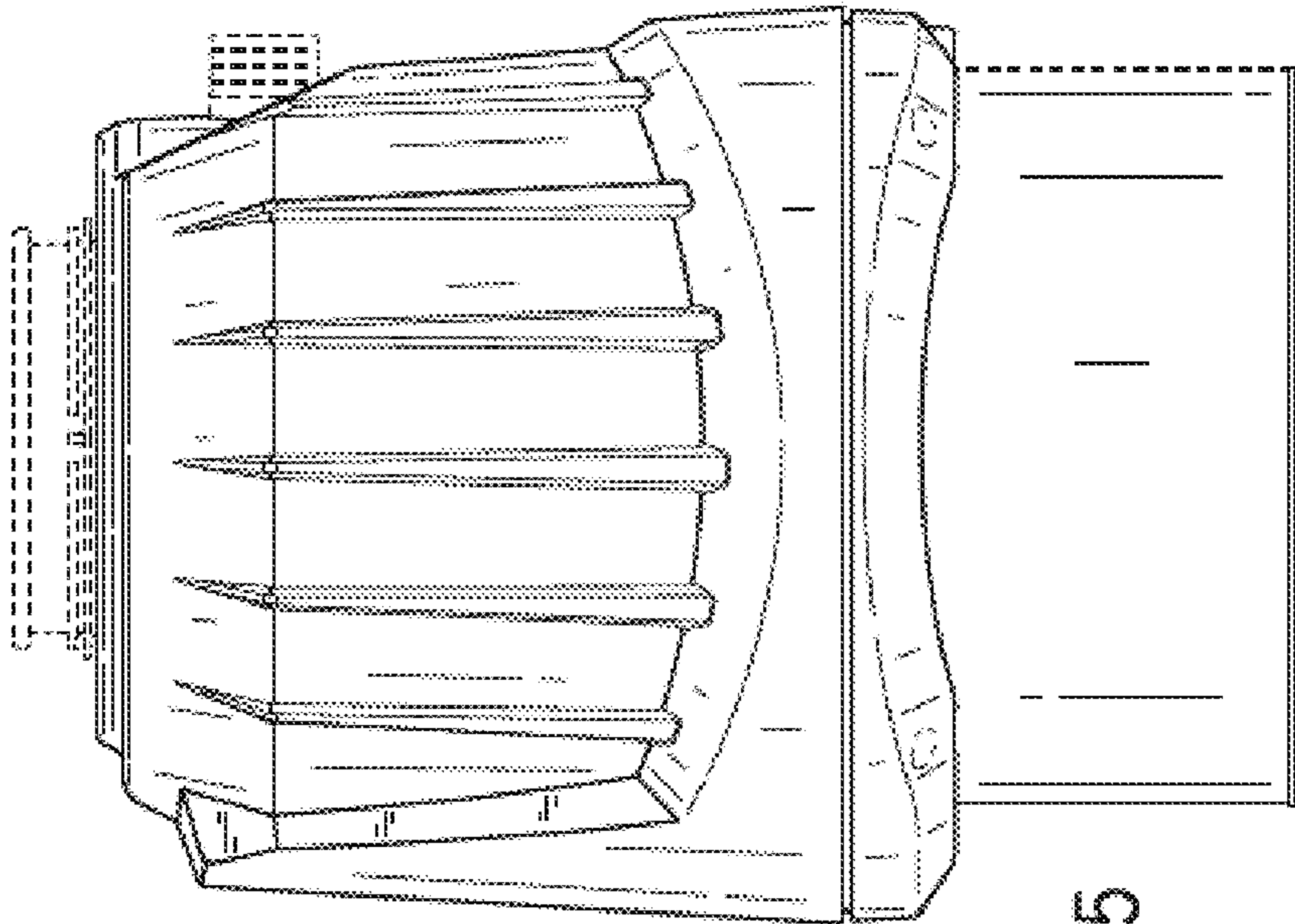

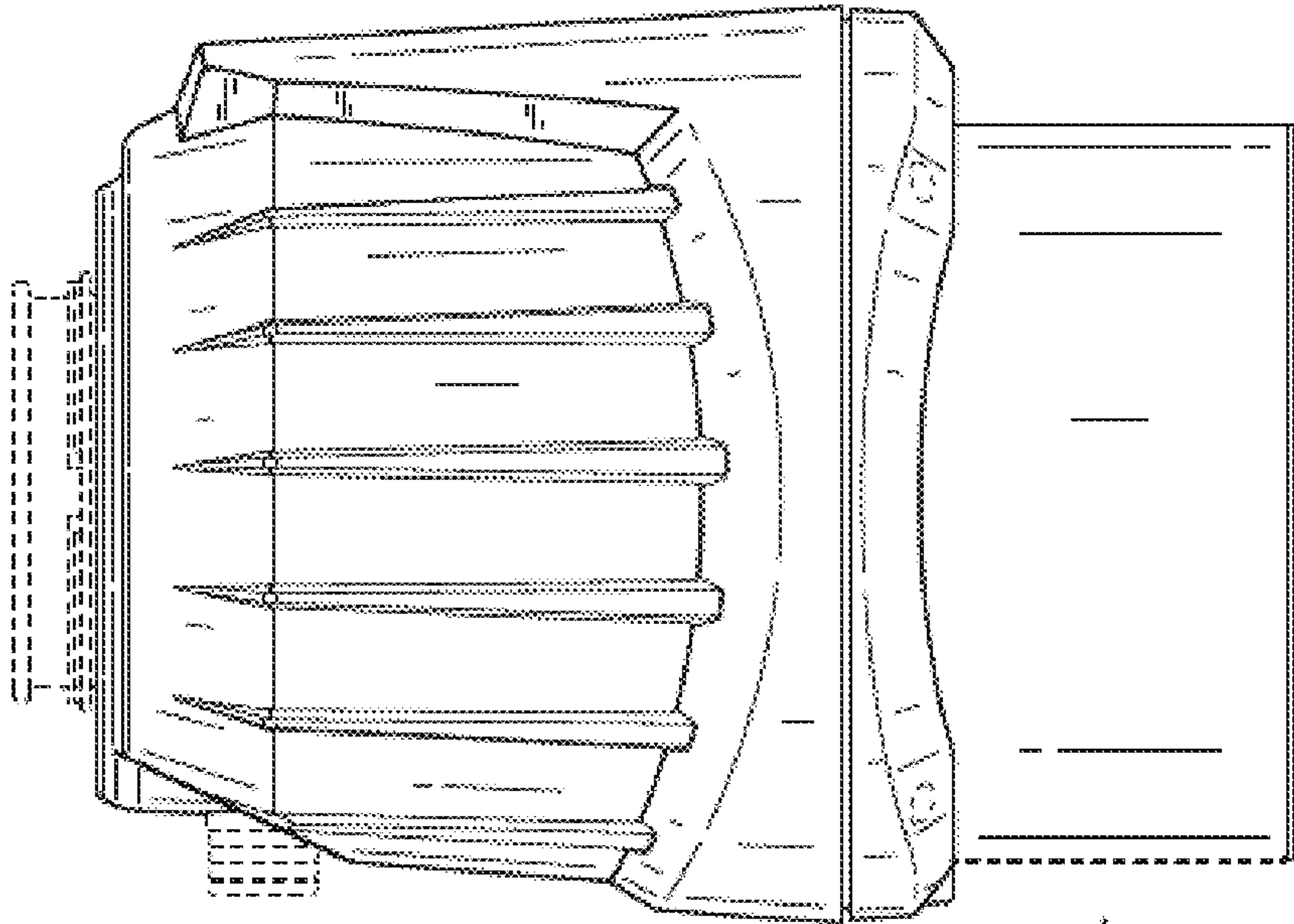

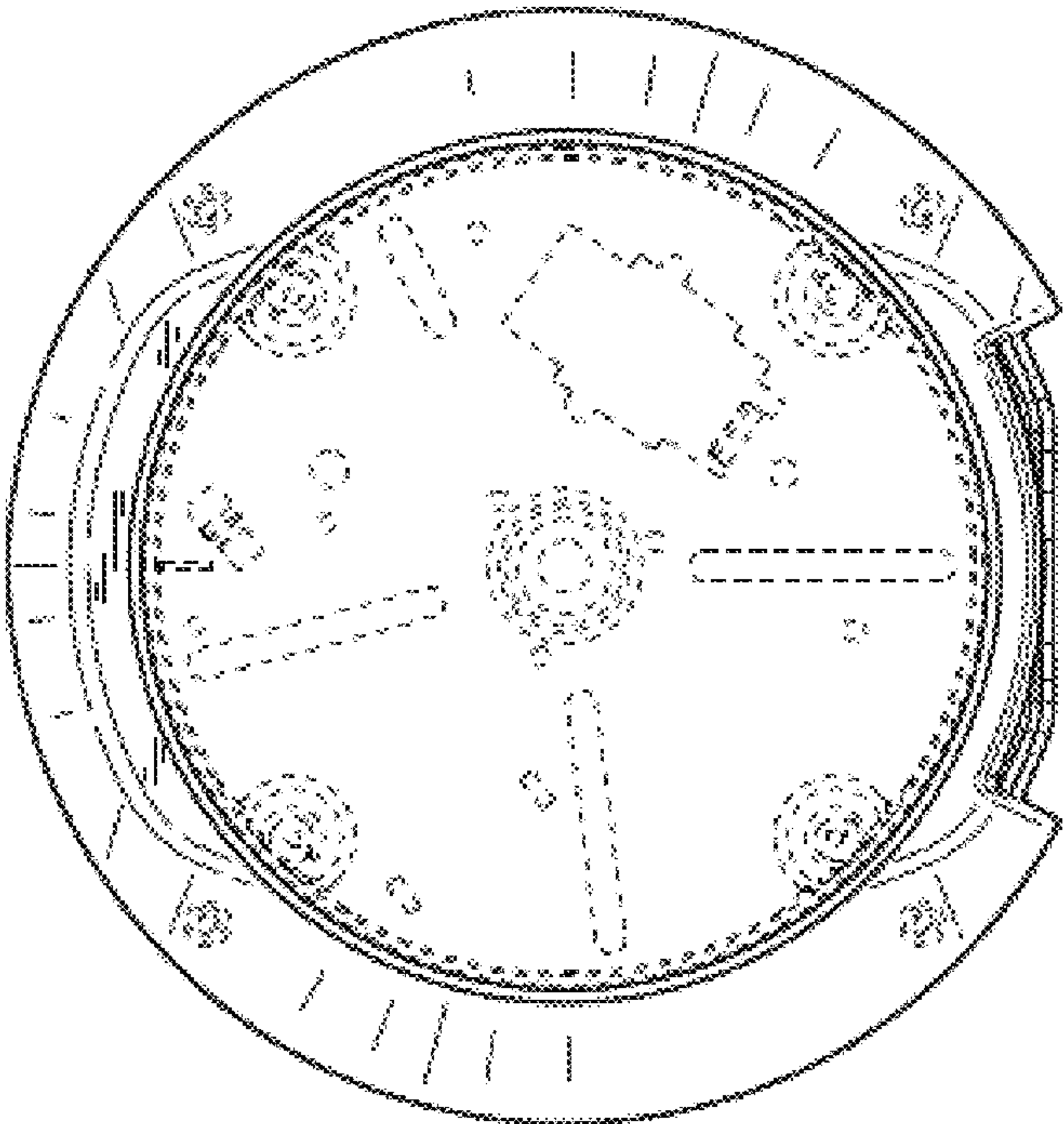

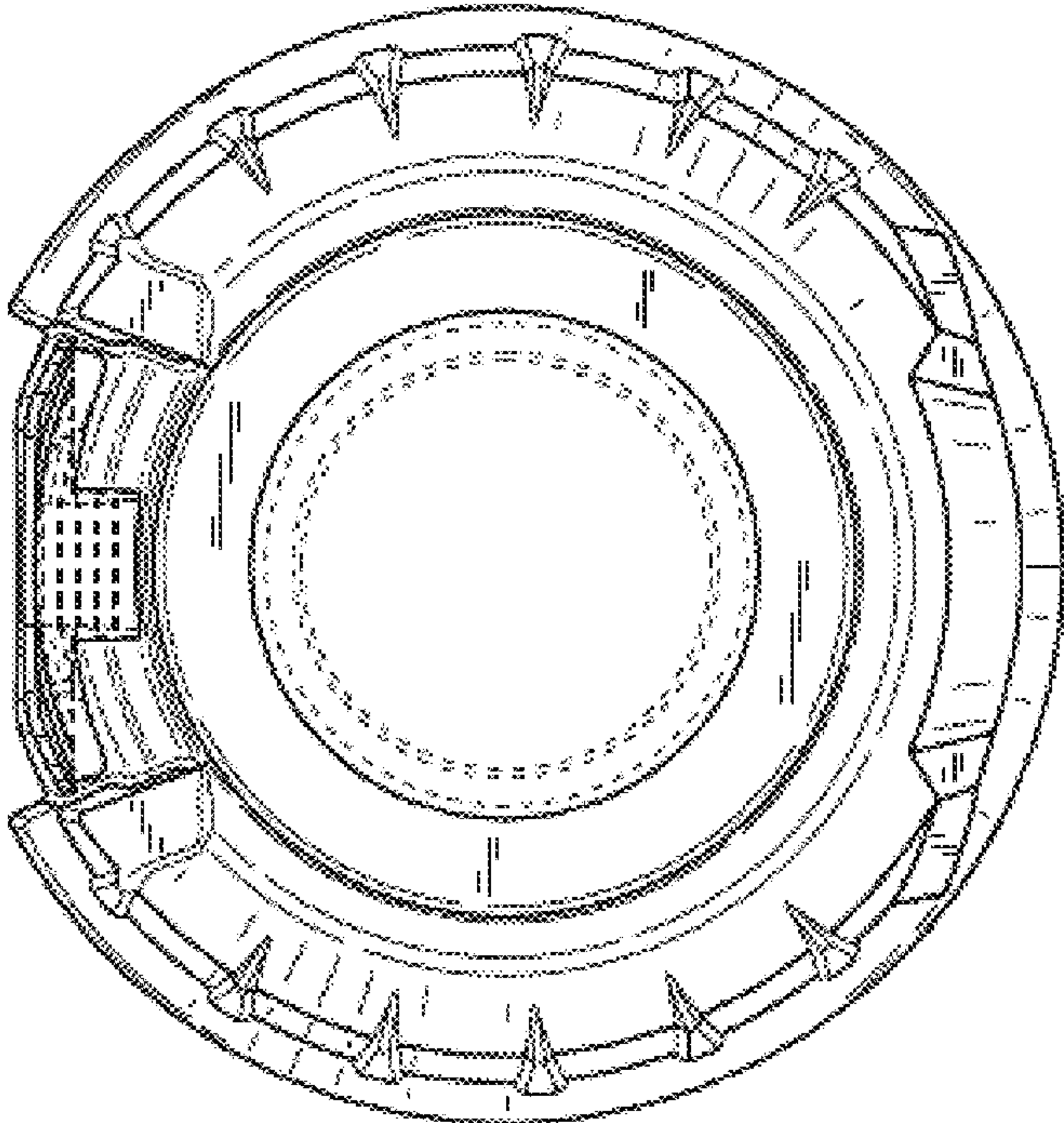
