and described.

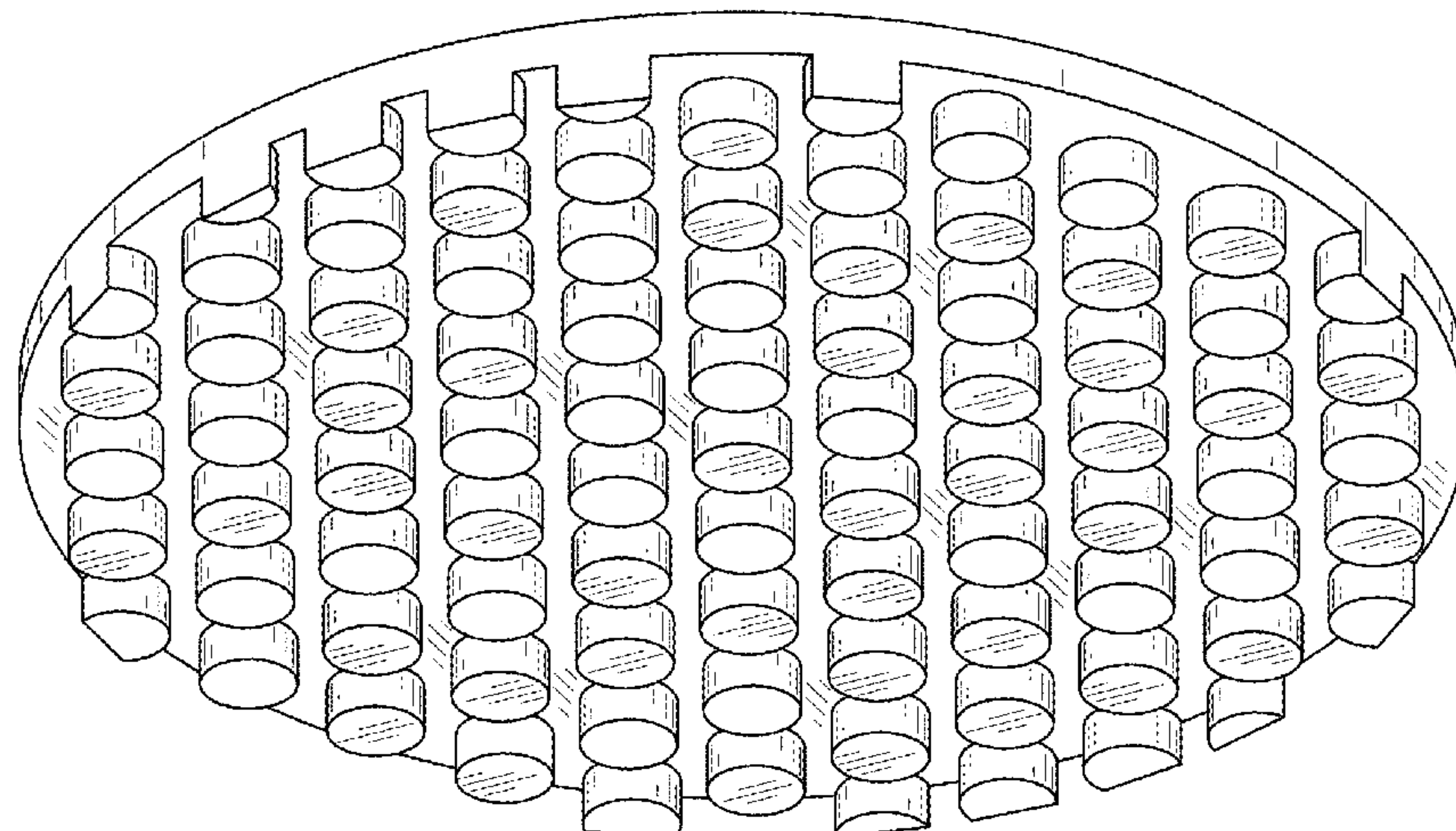
DESCRIPTION

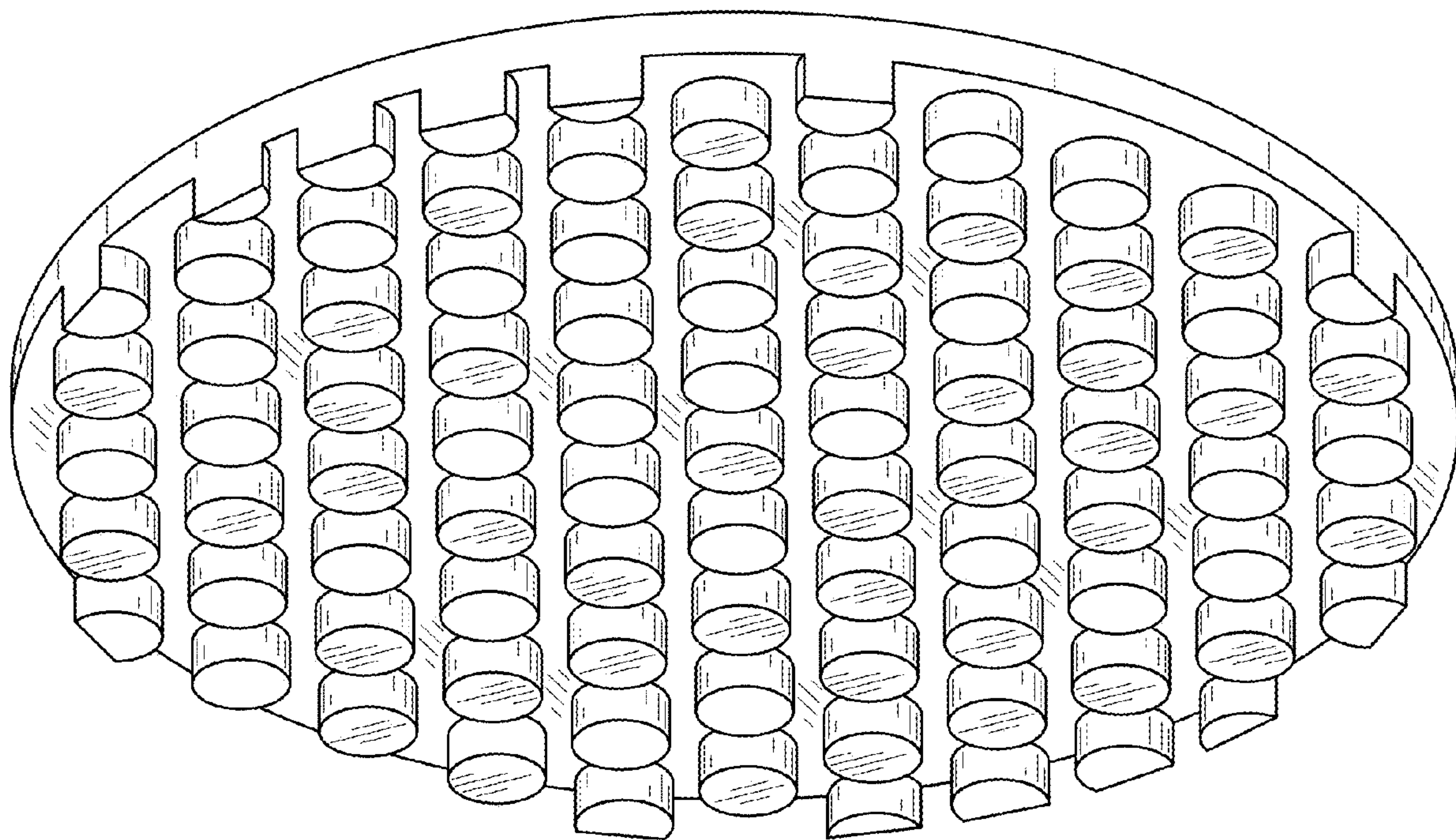

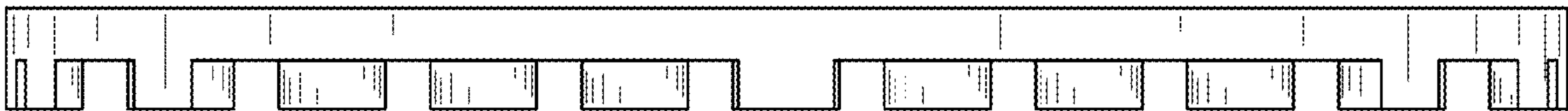

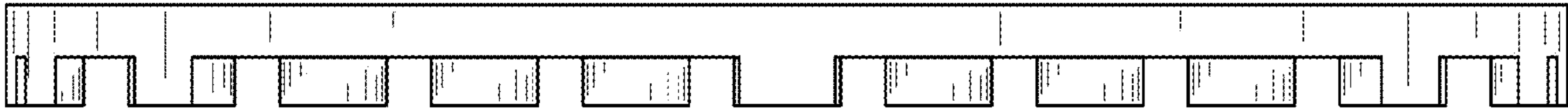

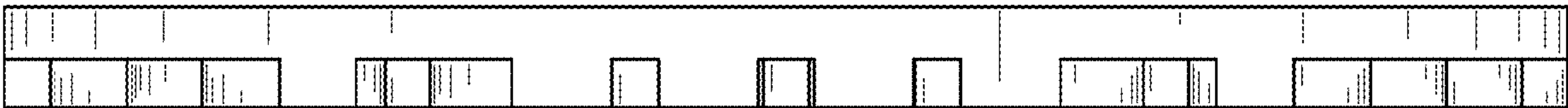

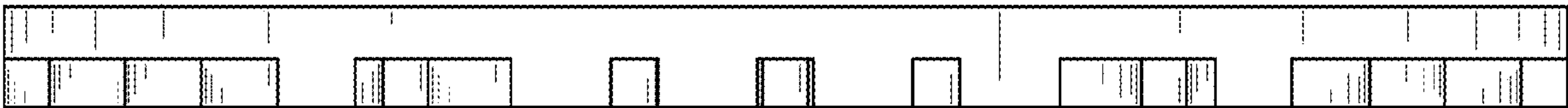

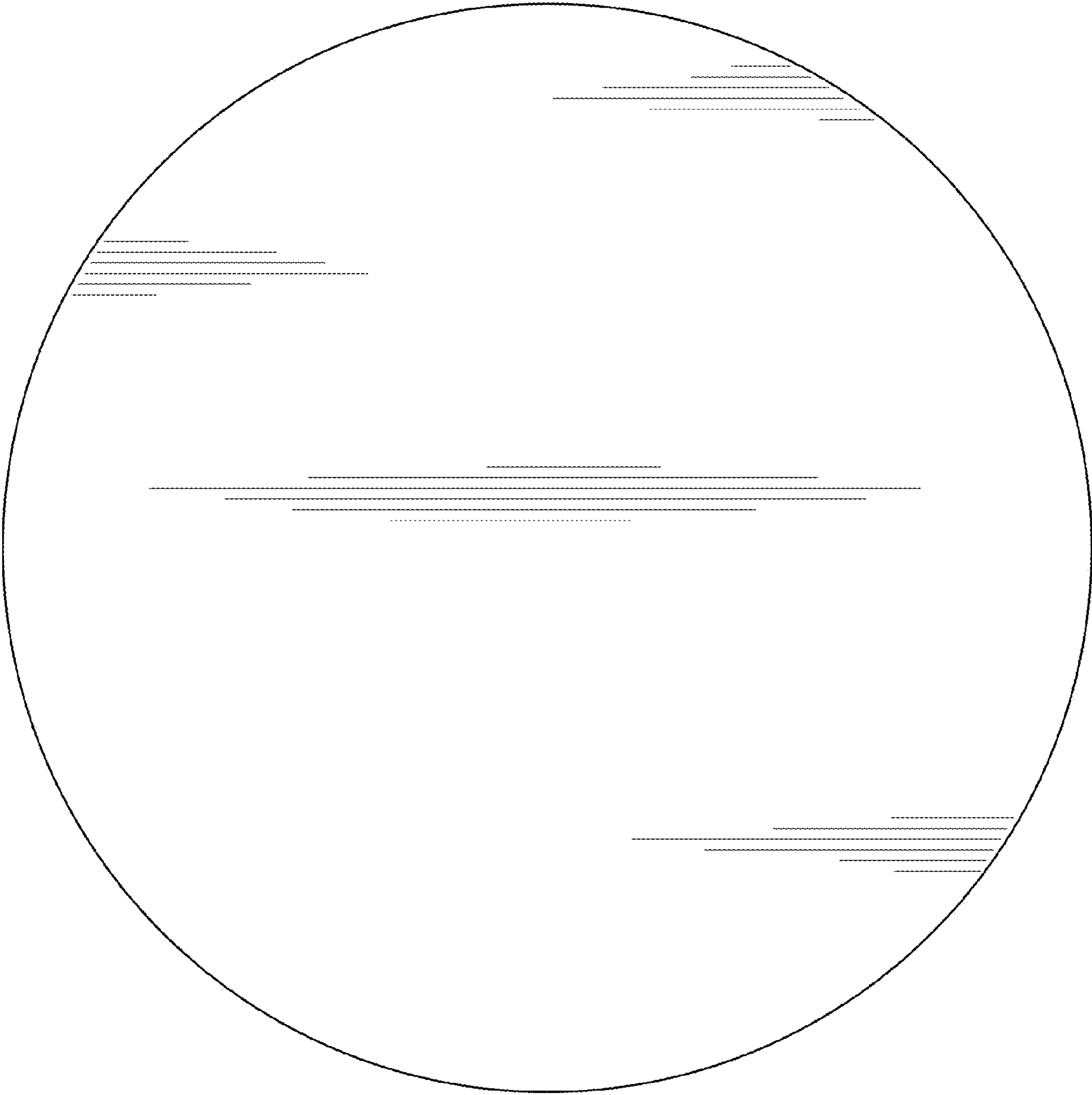

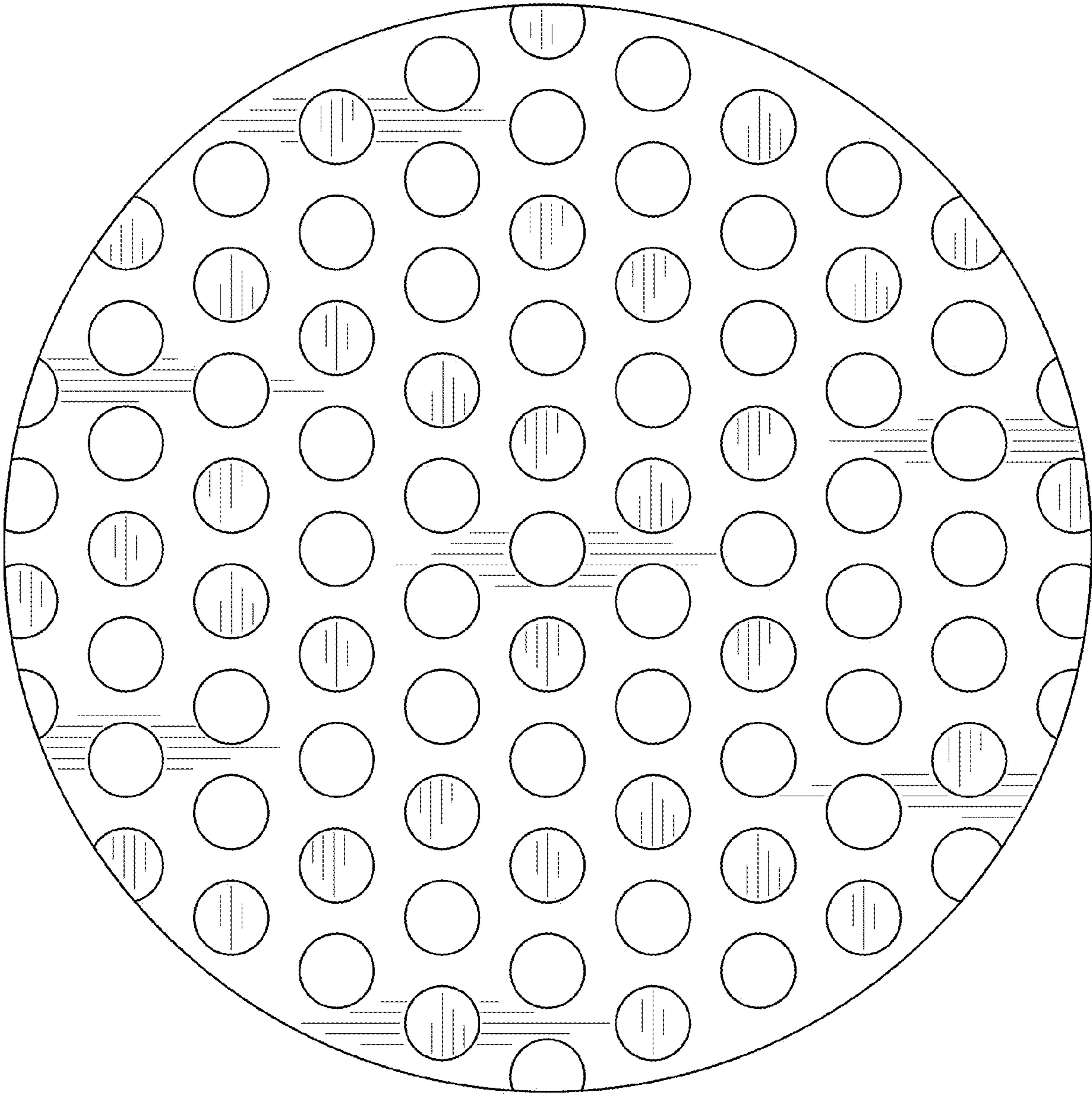

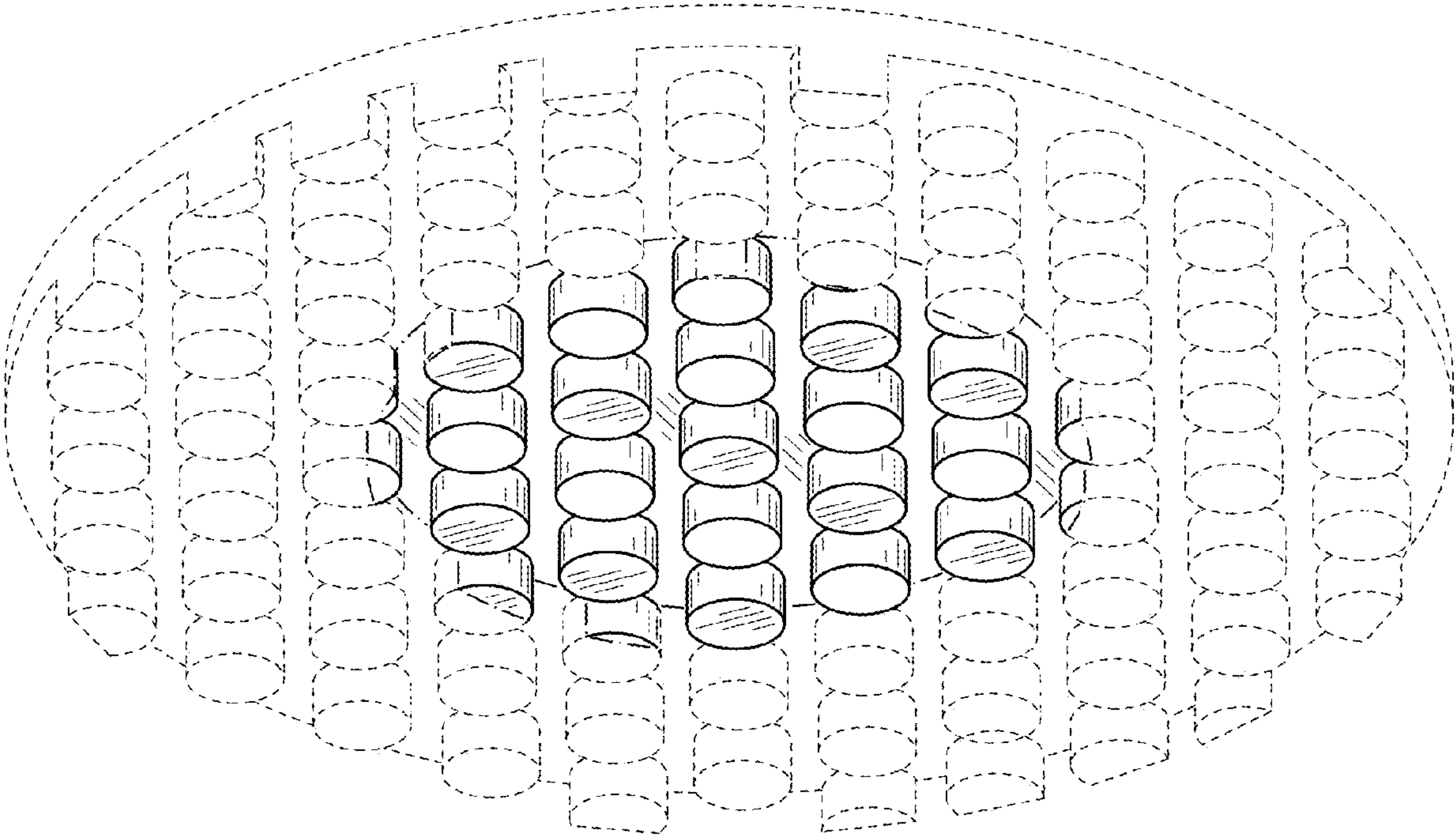

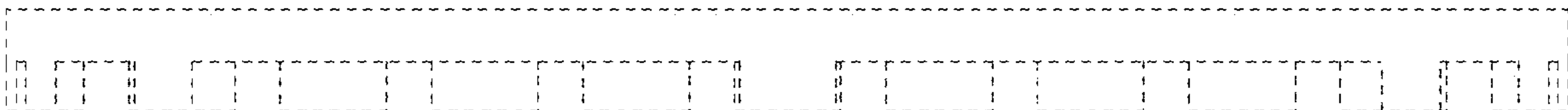

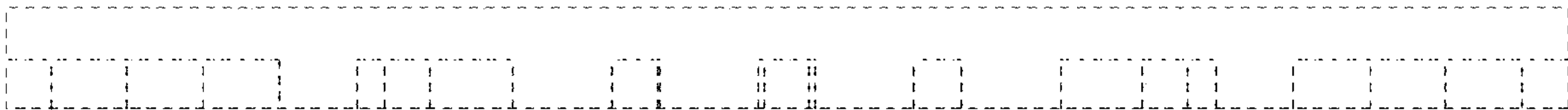

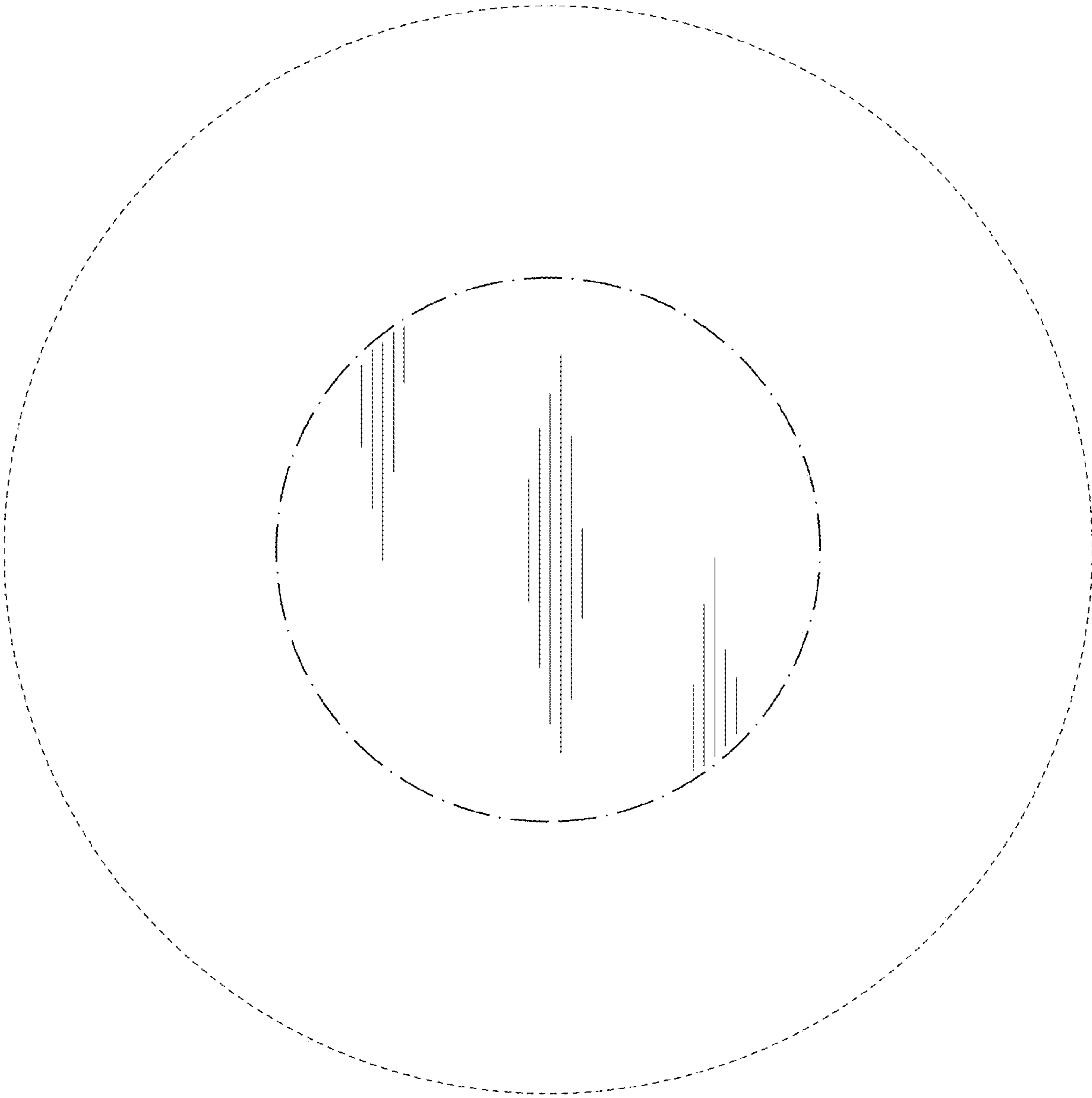

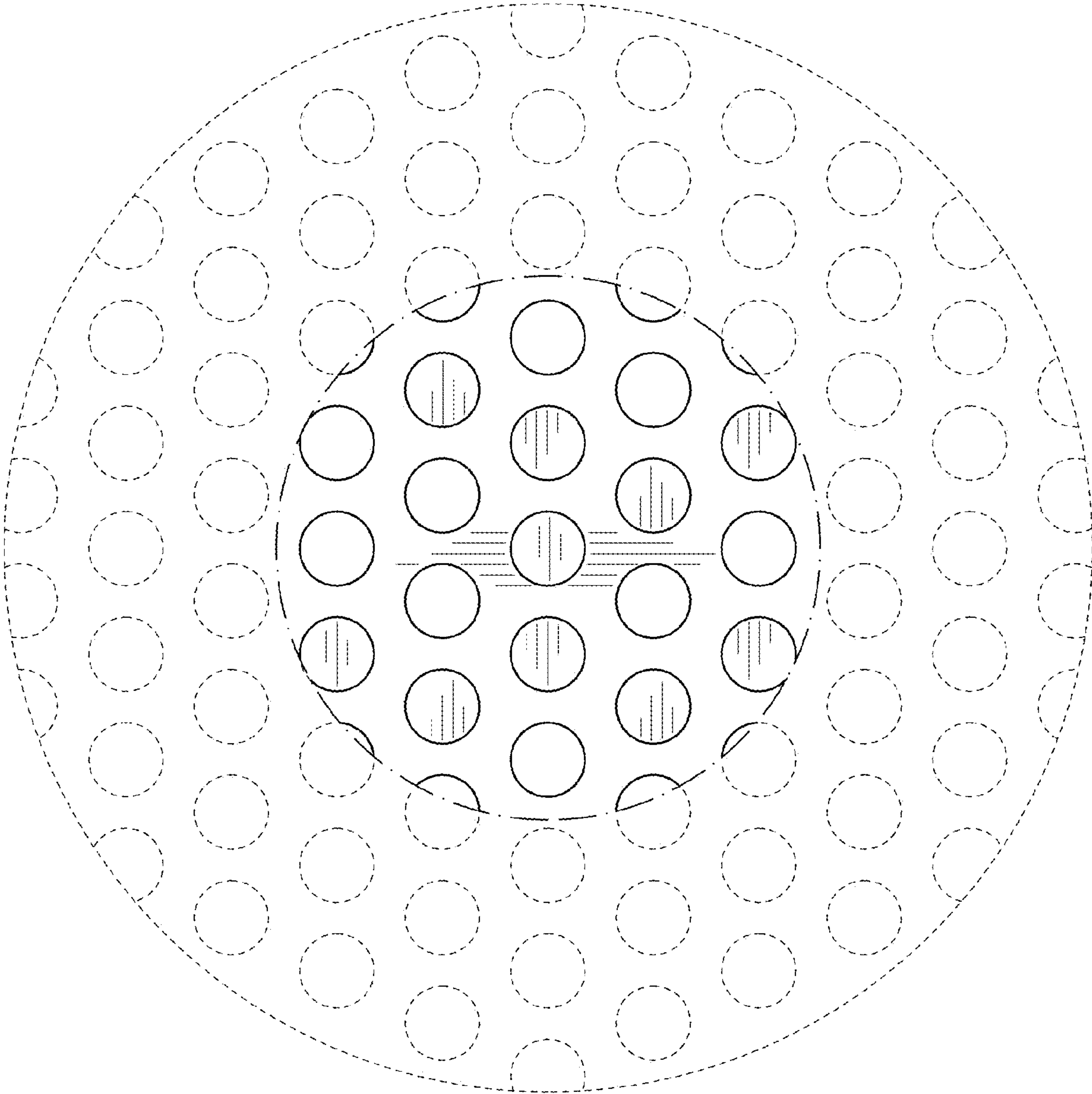
