FIG. 3 is a front side view of the crop top of FIG. 1;

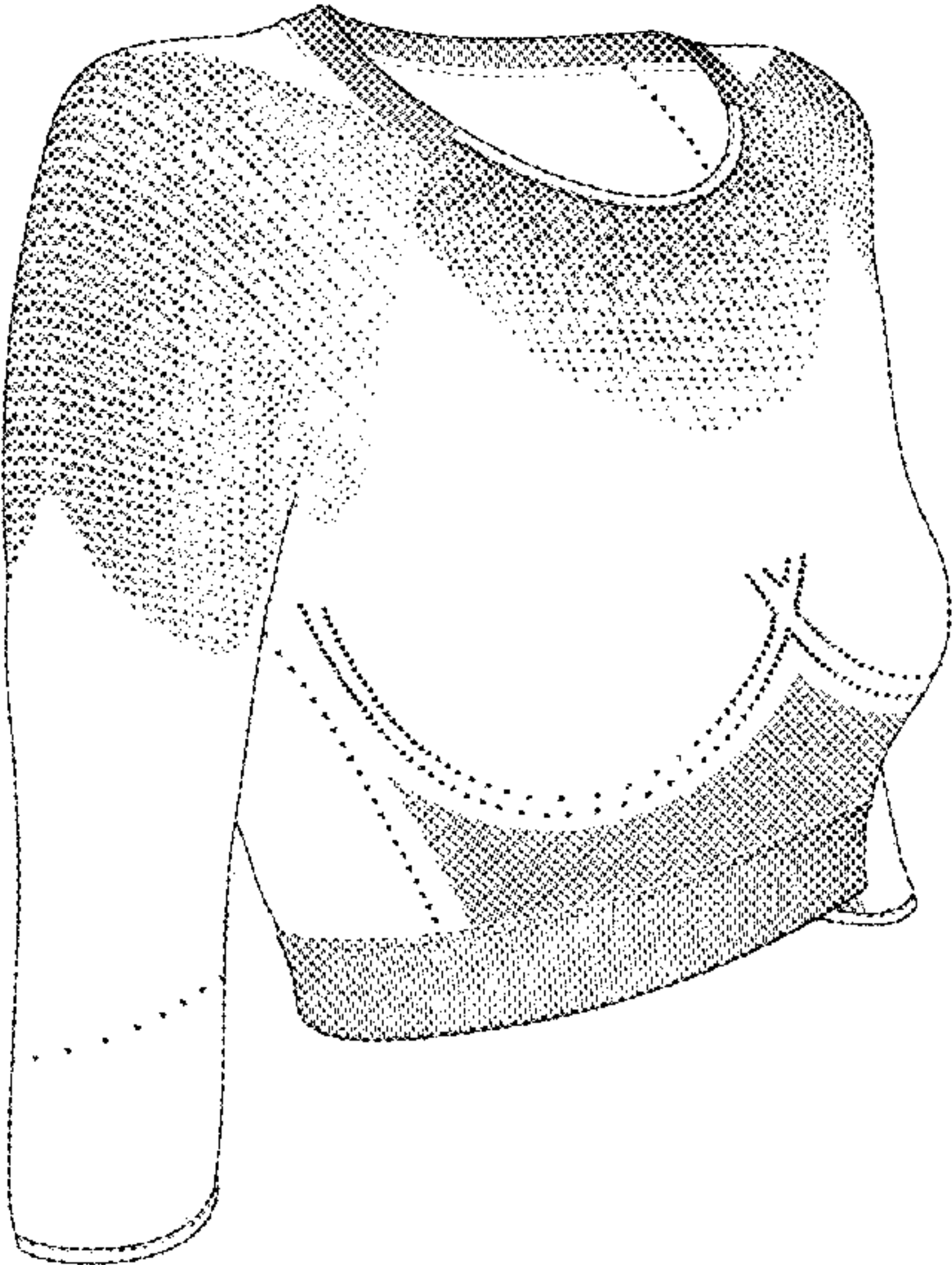
FIG. 4 is a rear side view of the crop top of FIG. 1;

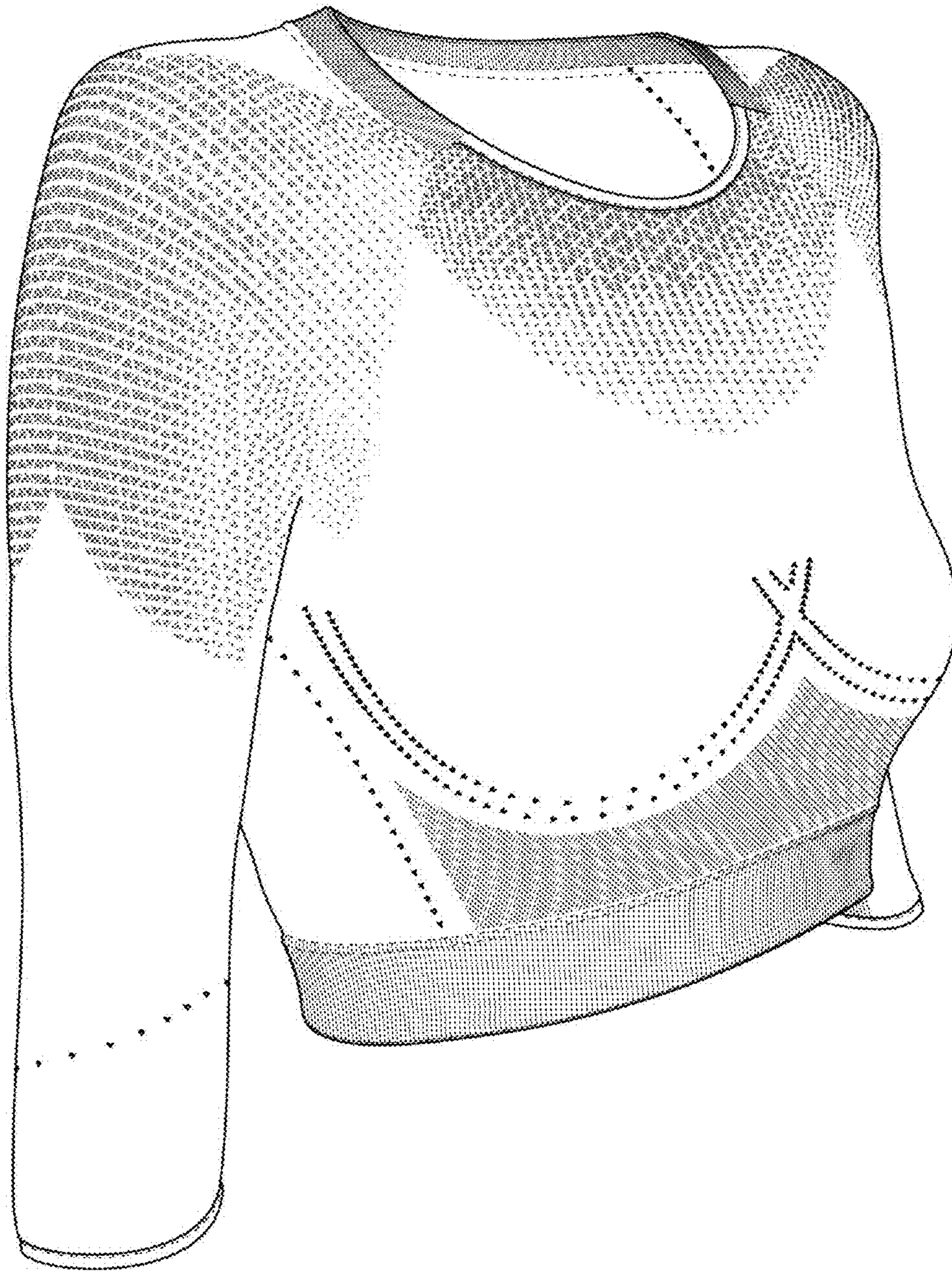

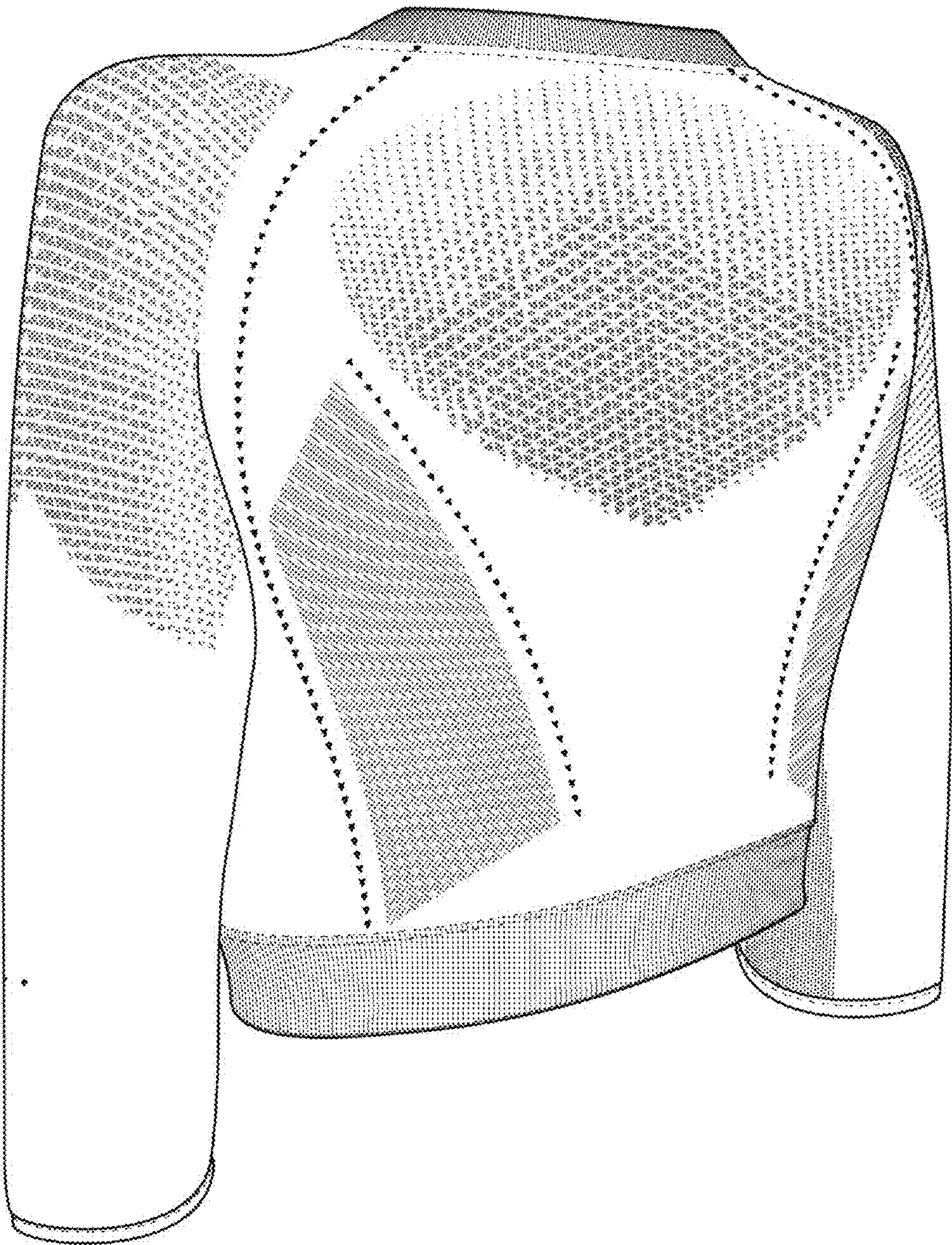

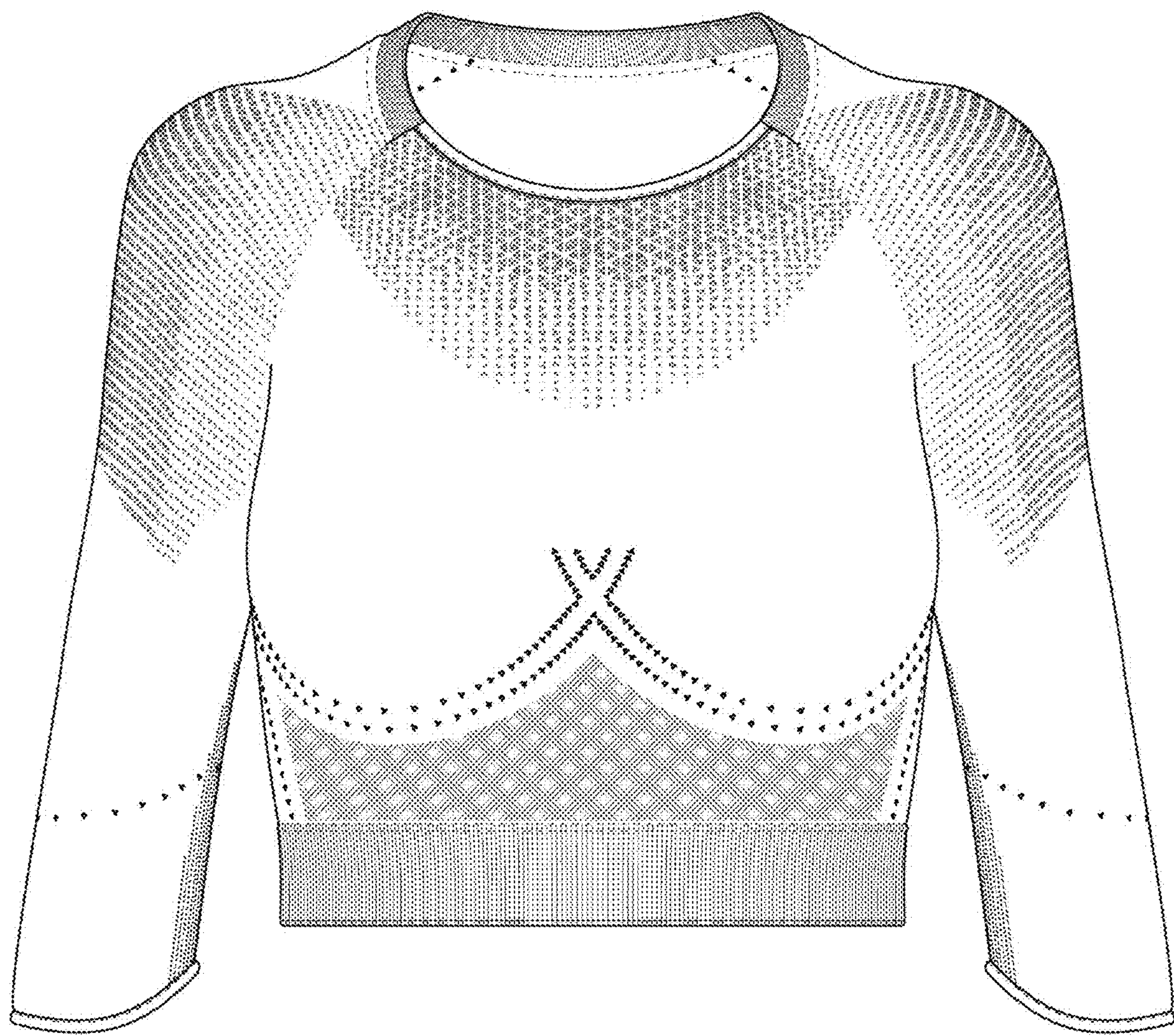

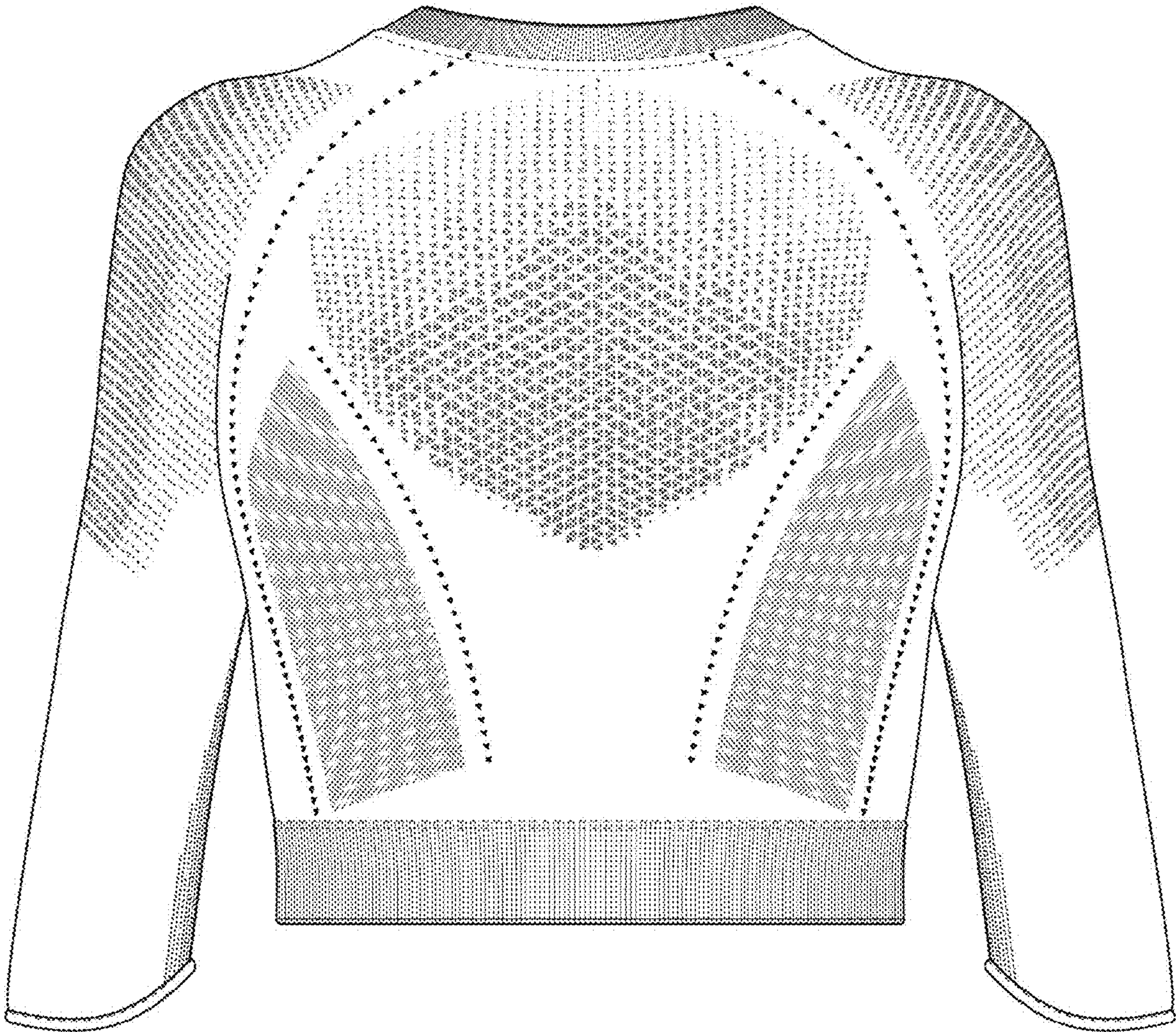

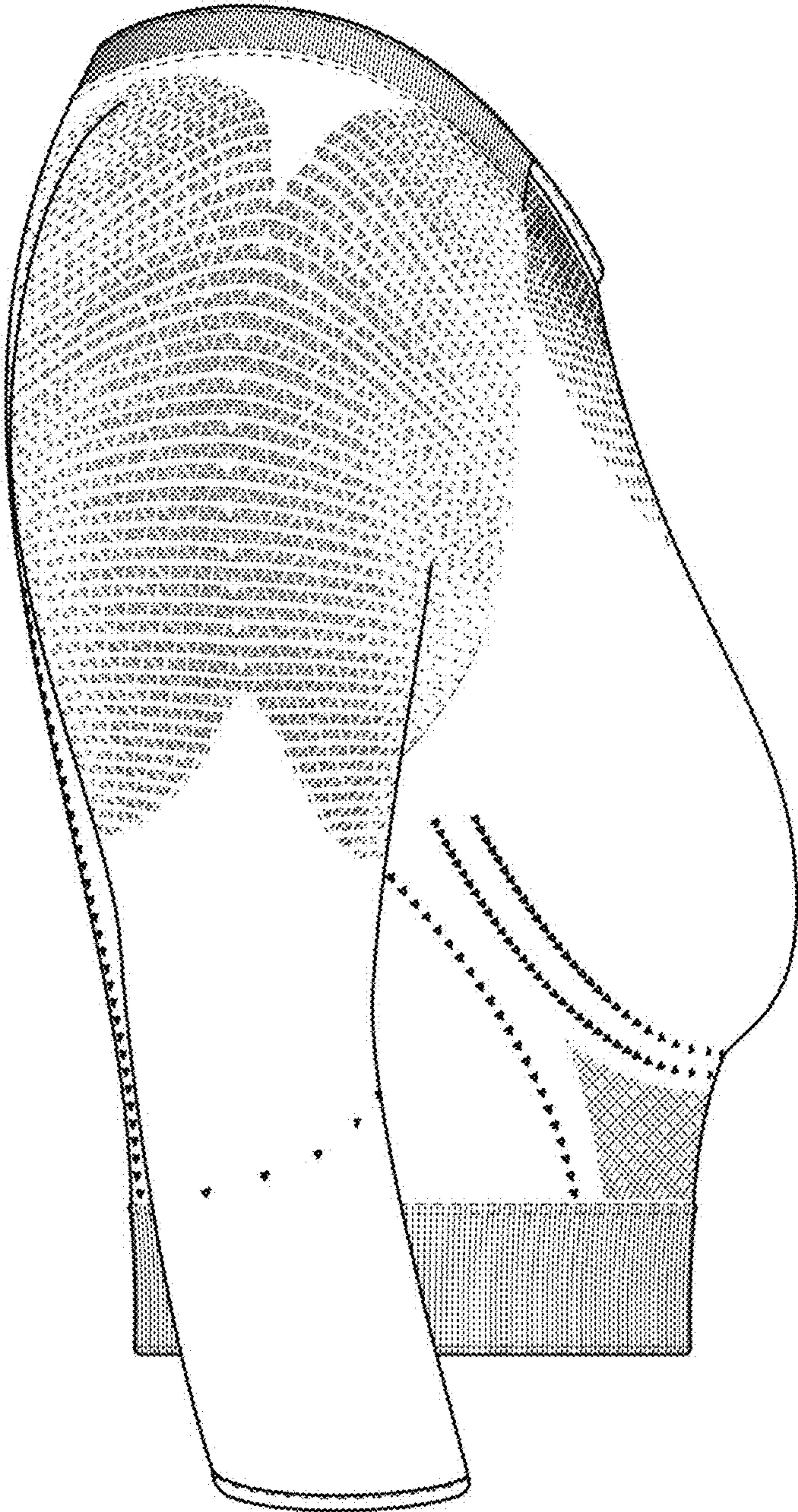

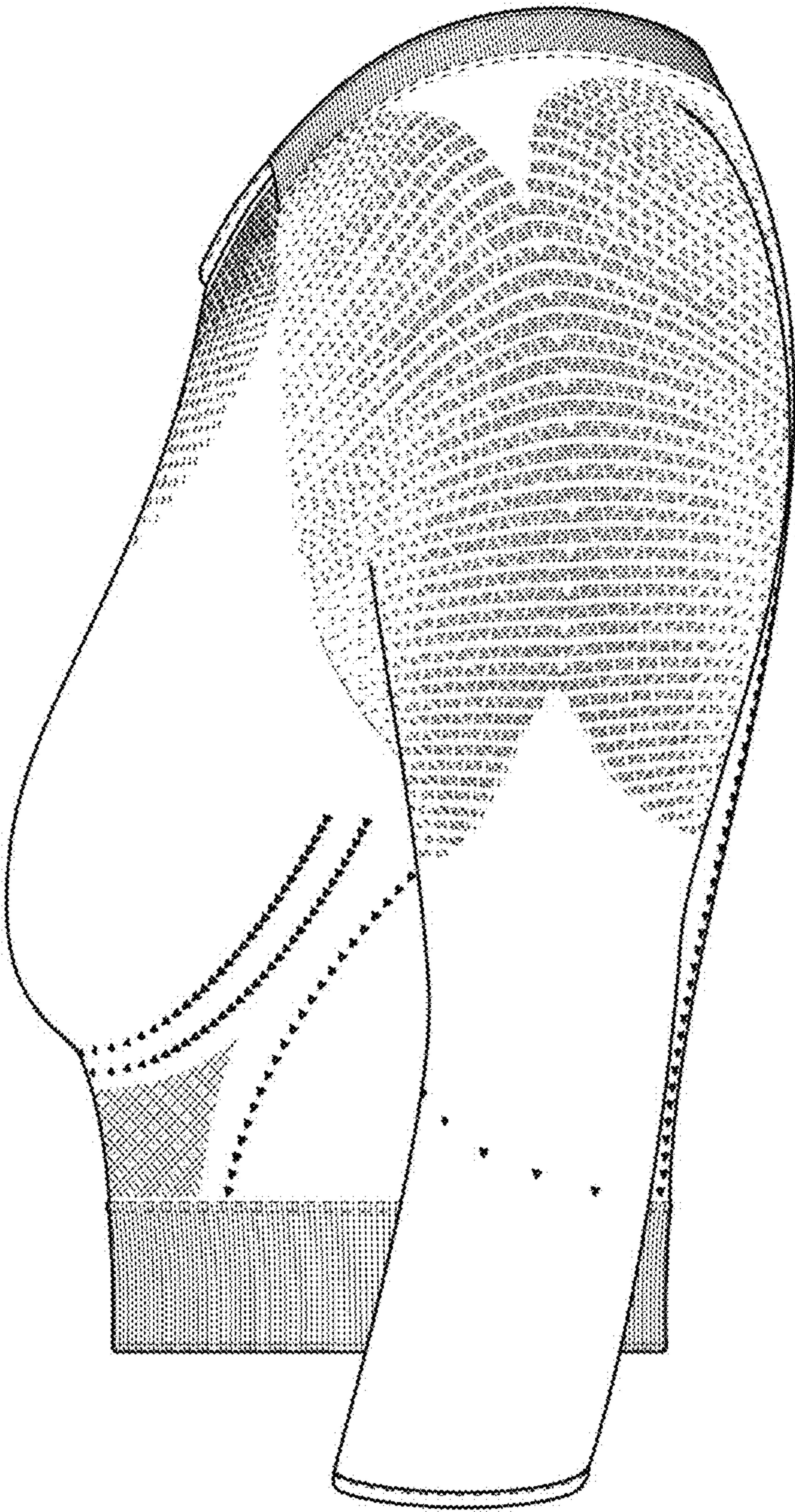
