The ornamental design for a bathroom rug, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bathroom rug showing my new design;
FIG. 2 is a rear view of the bathroom rug;
FIG. 3 is a right side view of the bathroom rug;
FIG. 4 is a left side view of the bathroom rug;
FIG. 5 is a top view of the bathroom rug;
FIG. 6 is a bottom view of the bathroom rug;
FIG. 7 is a top front side perspective view of the bathroom rug; and,
FIG. 8 is a top front side perspective view of the bathroom rug in use.

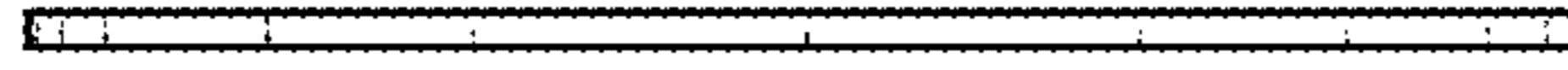

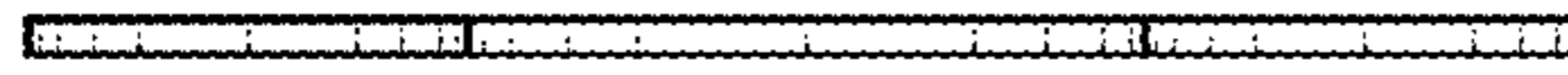

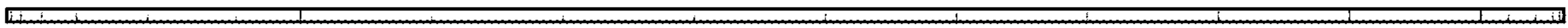

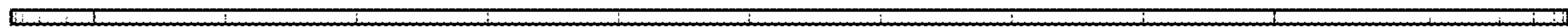

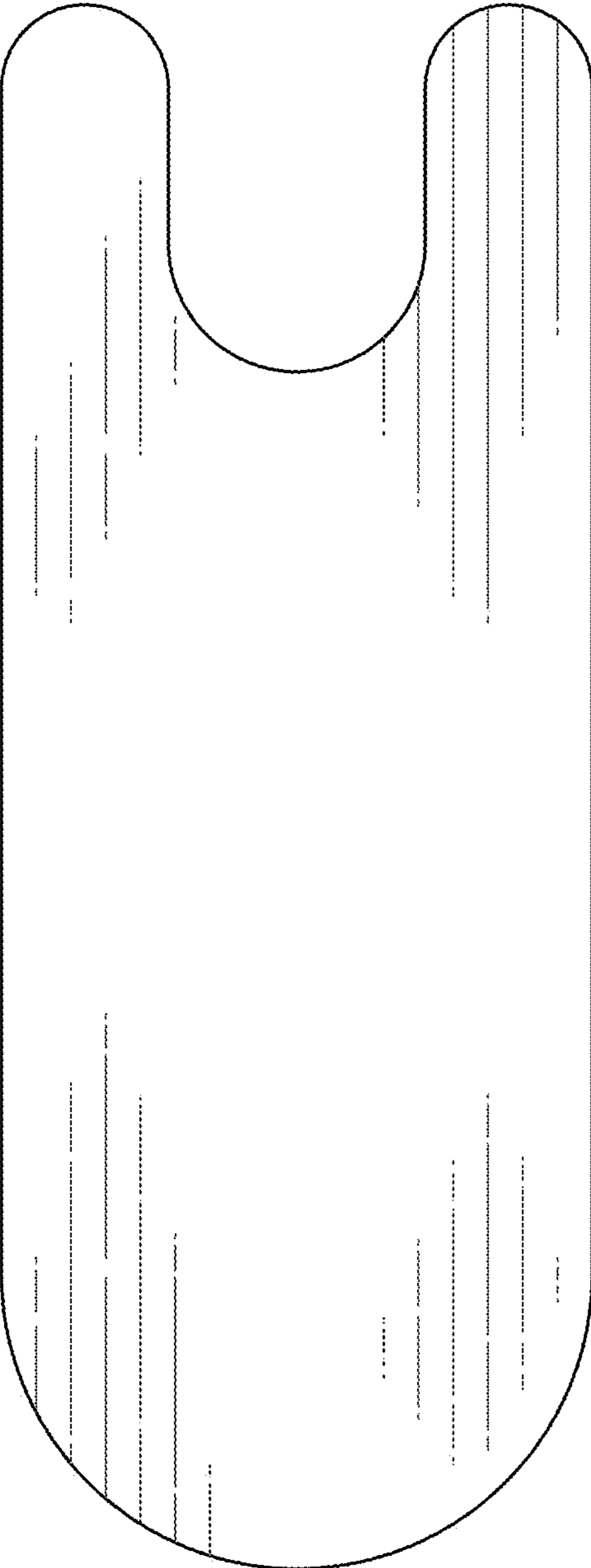

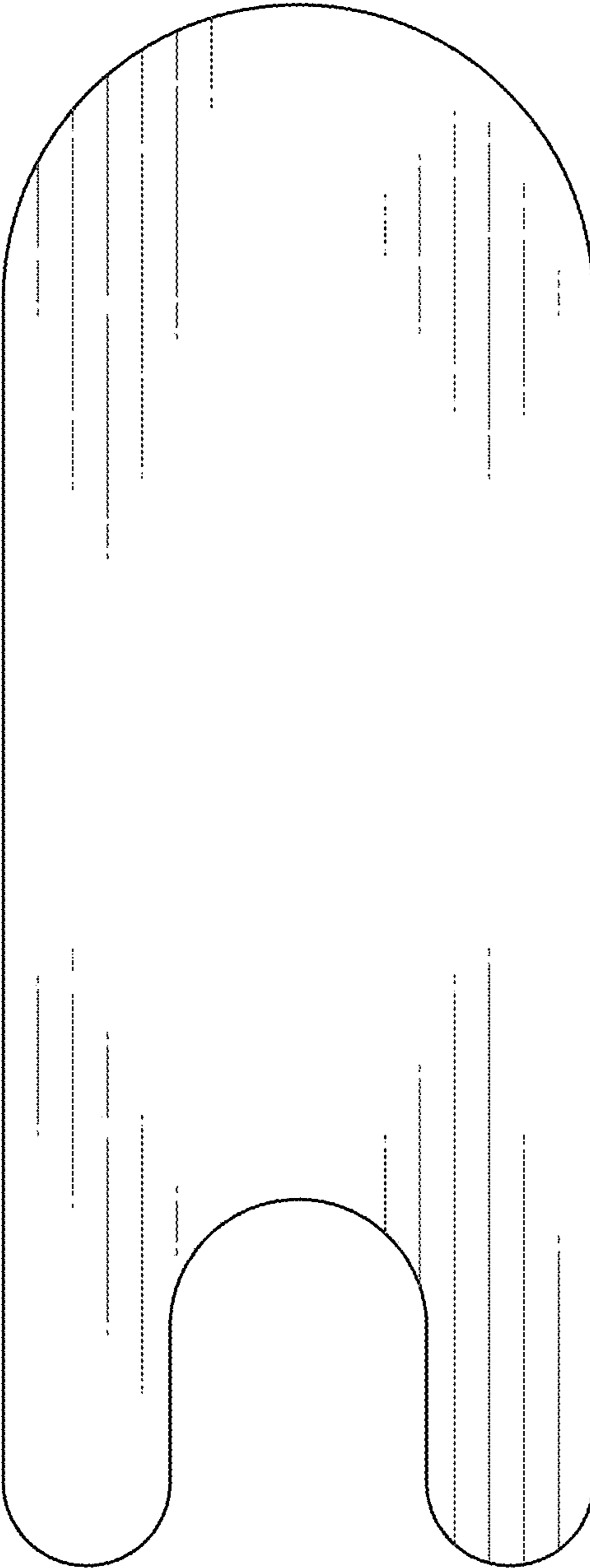

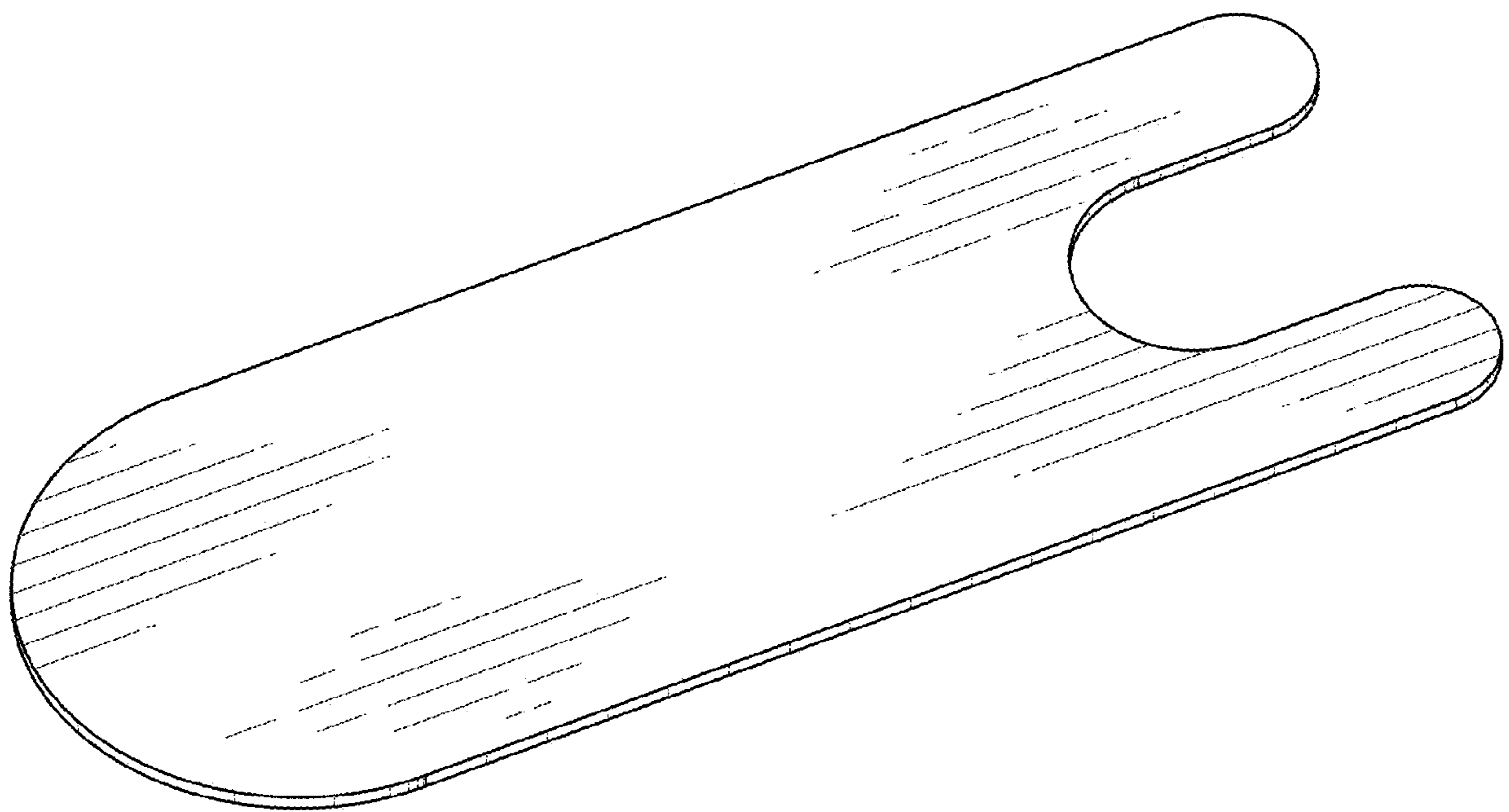

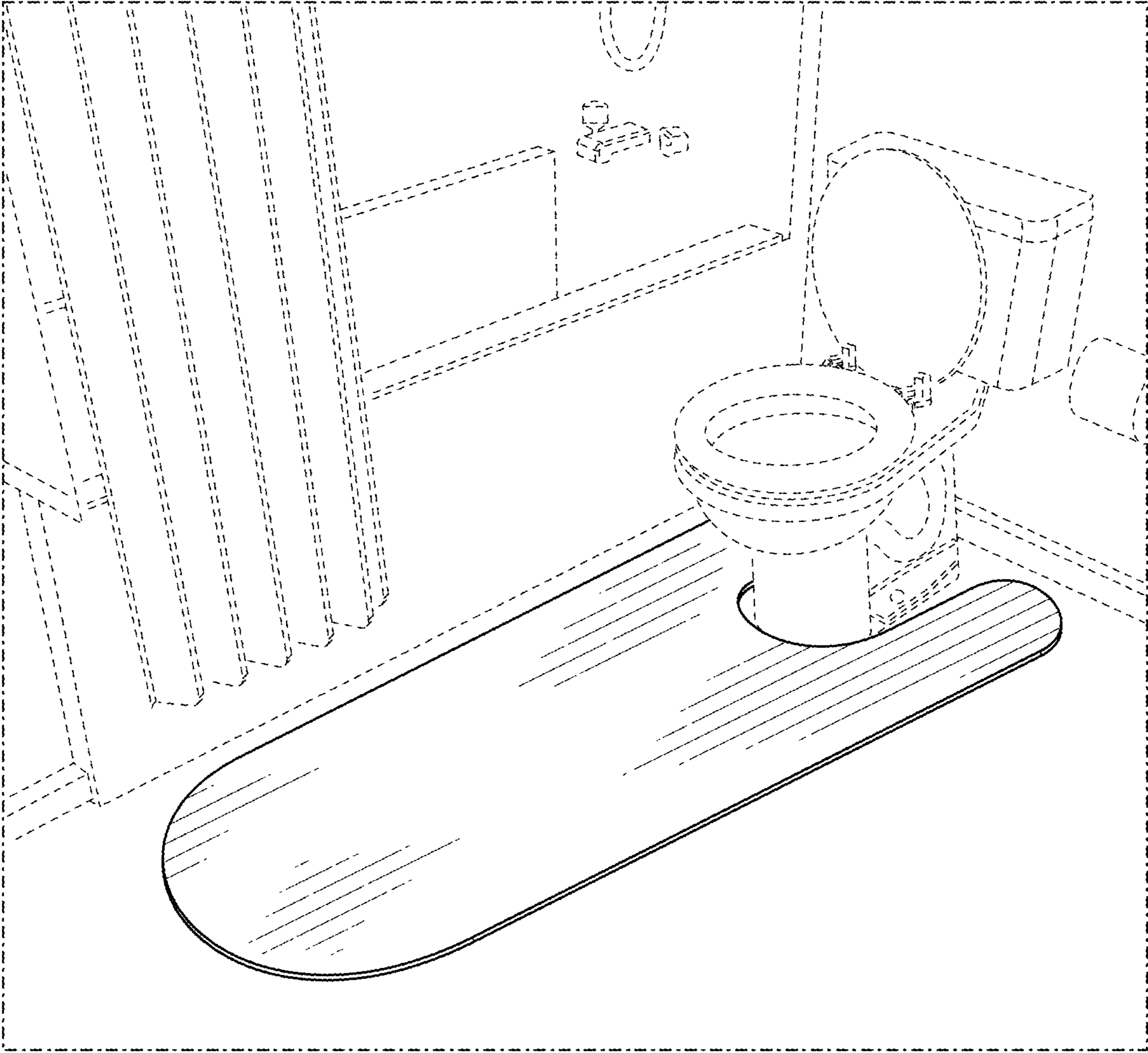
