**DESCRIPTION**

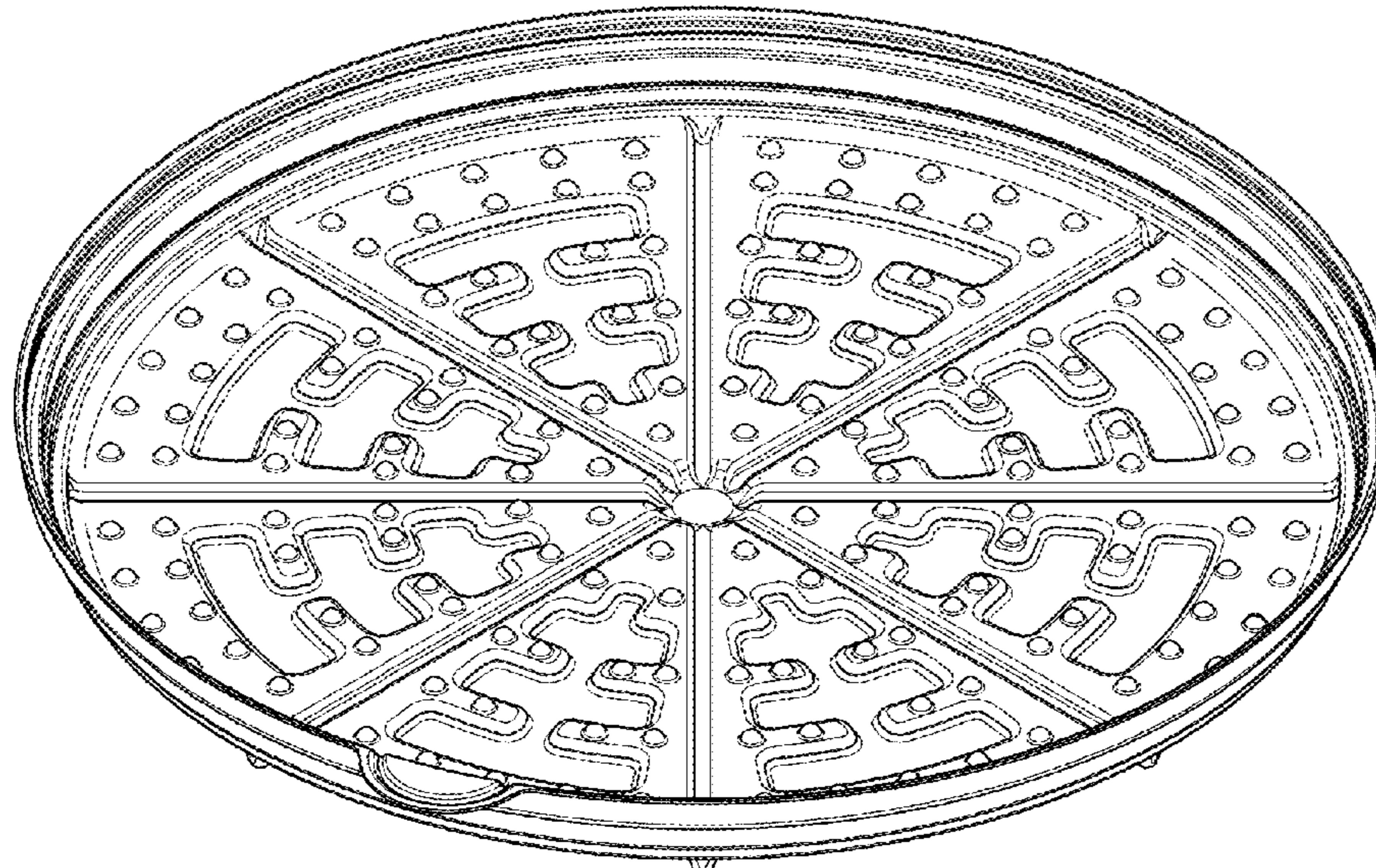

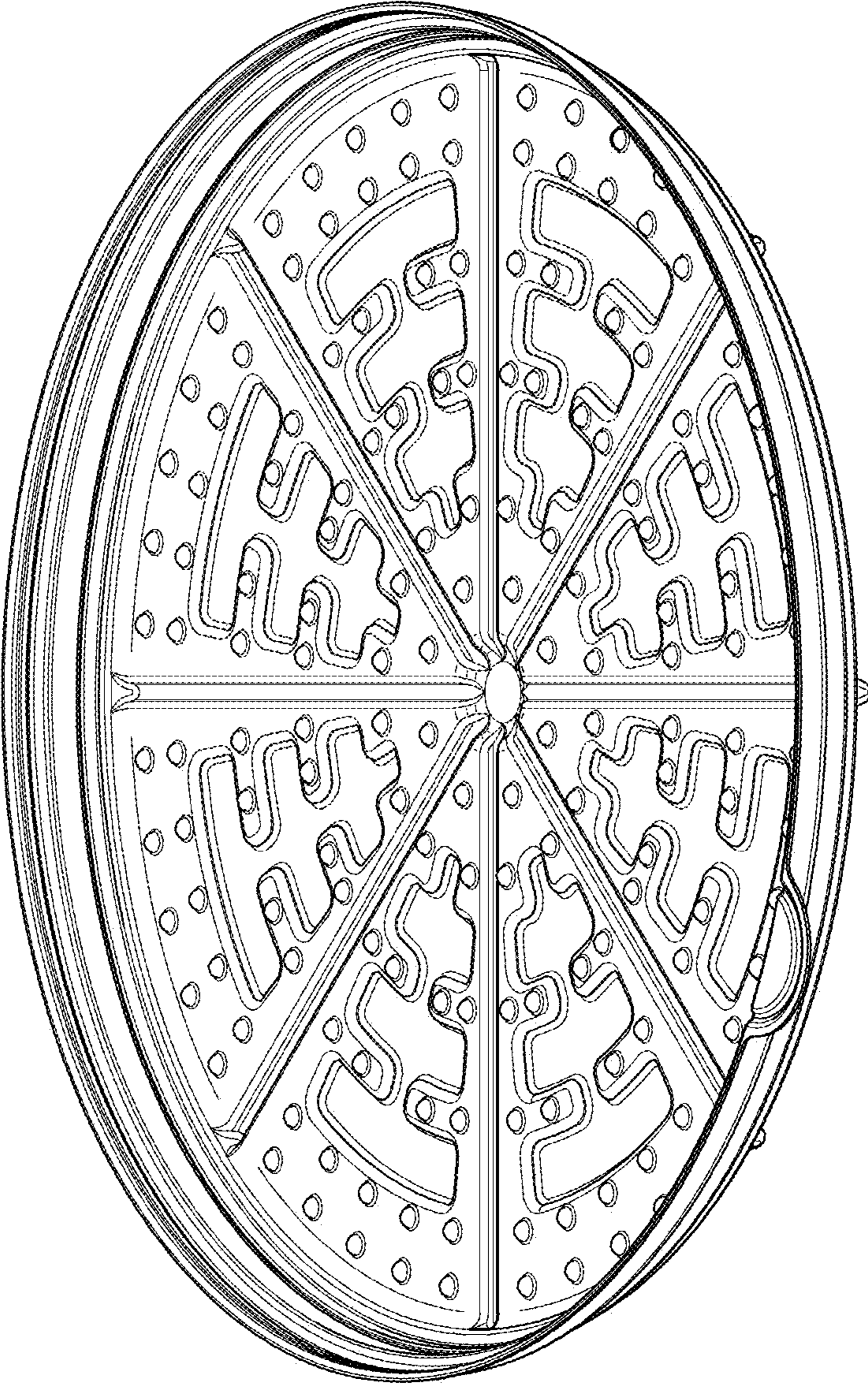

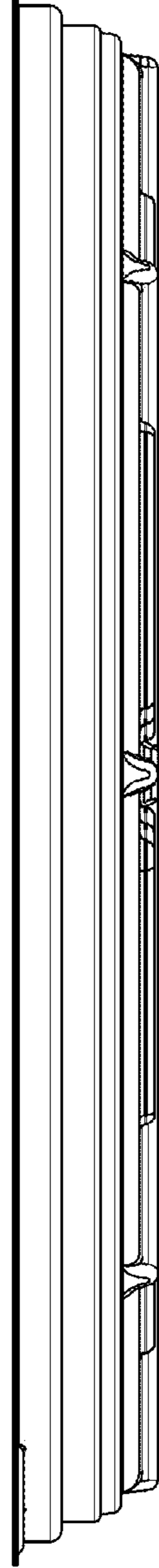

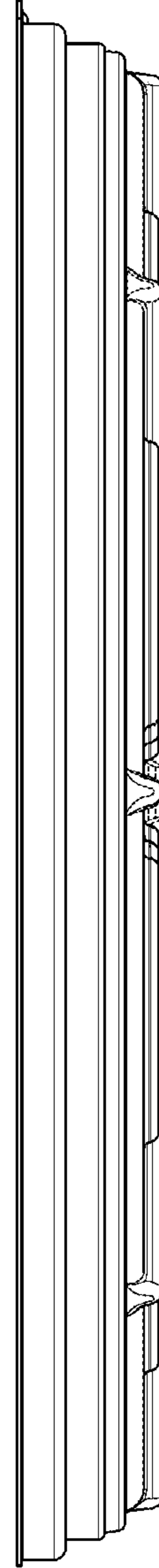
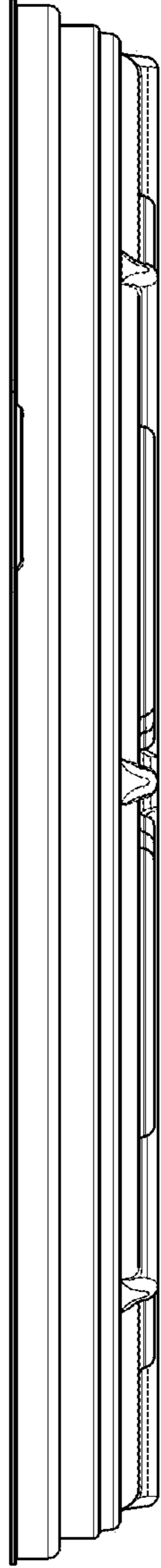
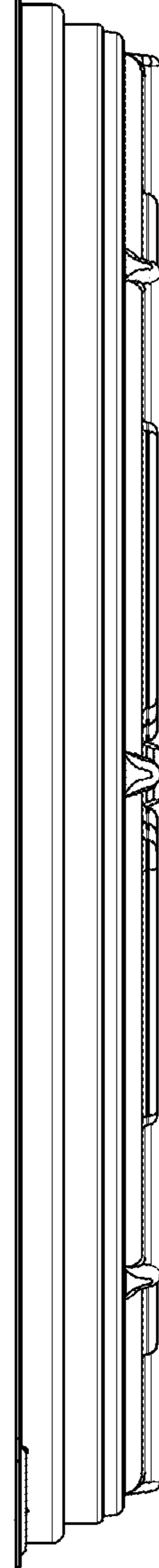

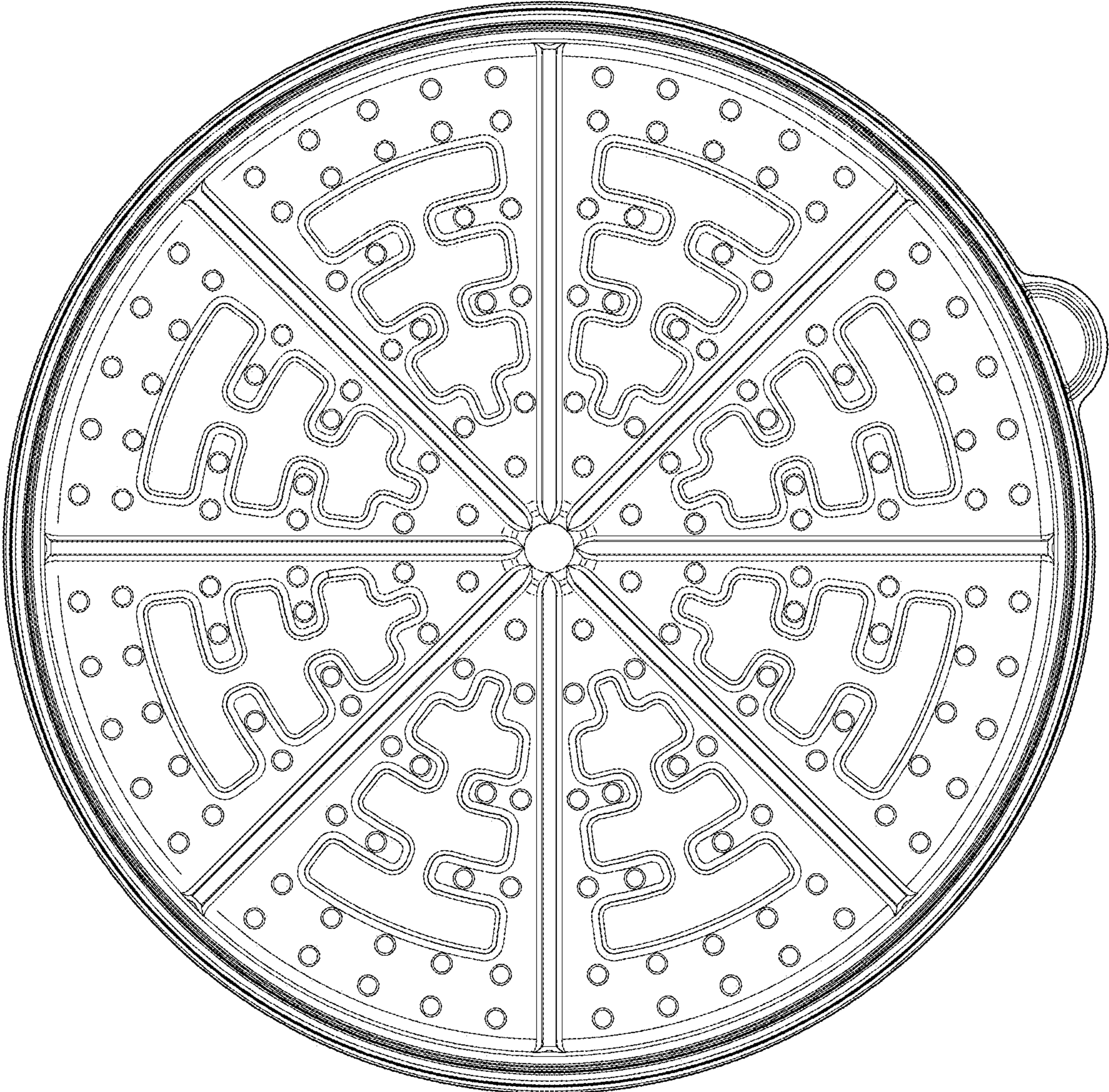

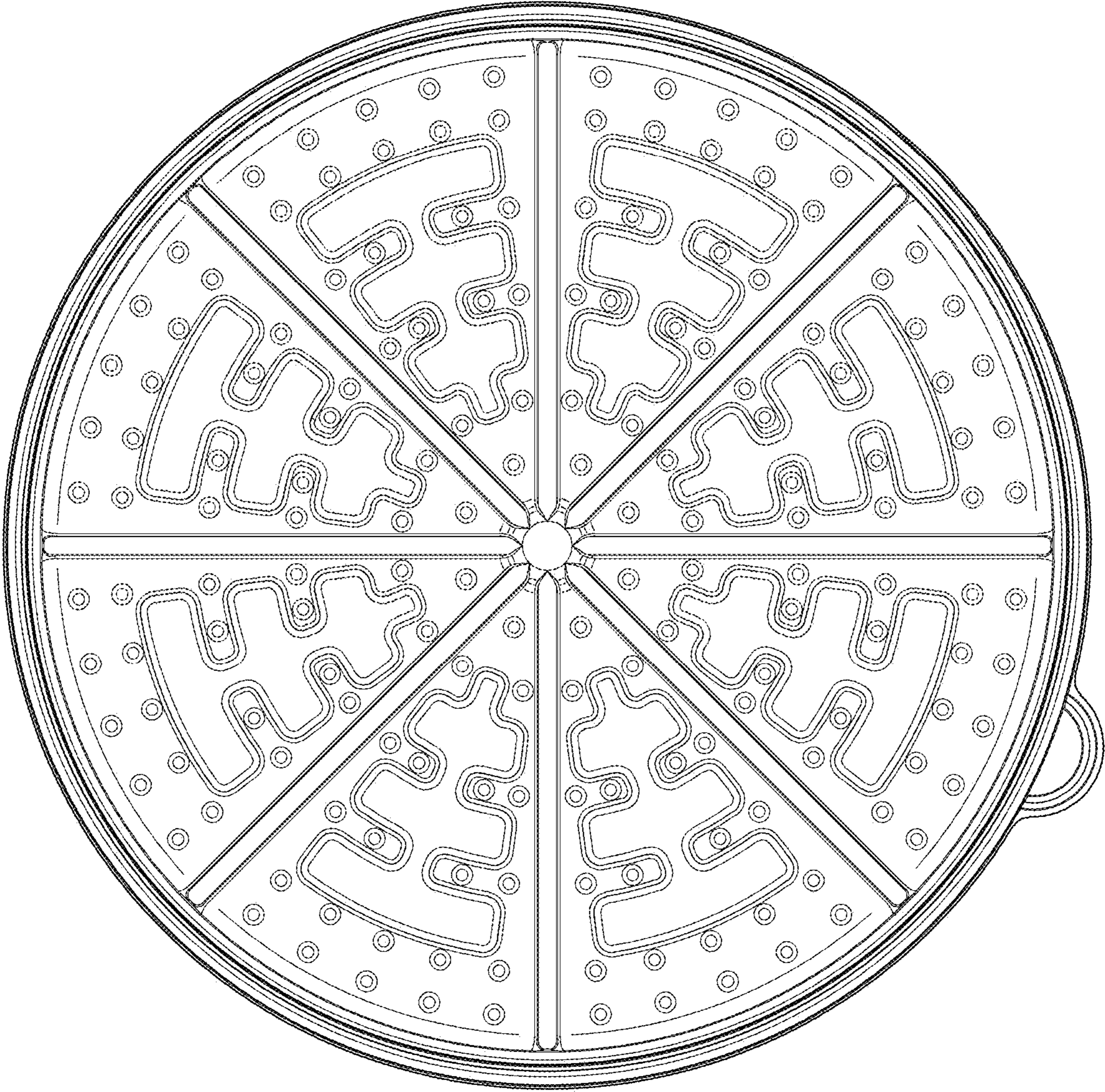
