(57) **CLAIM**

The ornamental design for an open heart jewelry box, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an open heart jewelry box, showing my new design, the bottom plan view being identical thereto;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

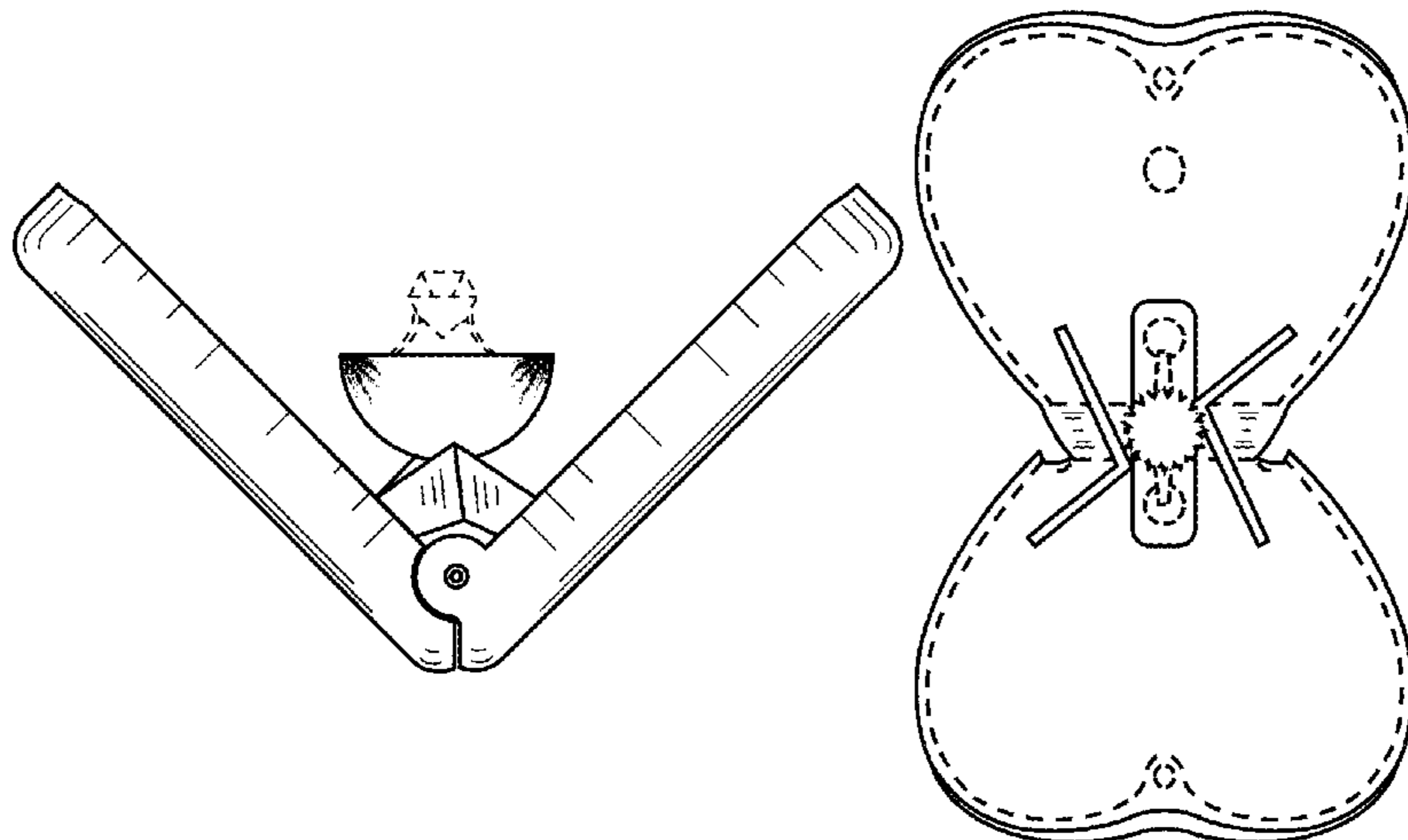
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 5 is a side elevational view of the open heart jewelry box in an open position; and,

FIG. 6 is a top plan view of the open heart jewelry box in an open position.

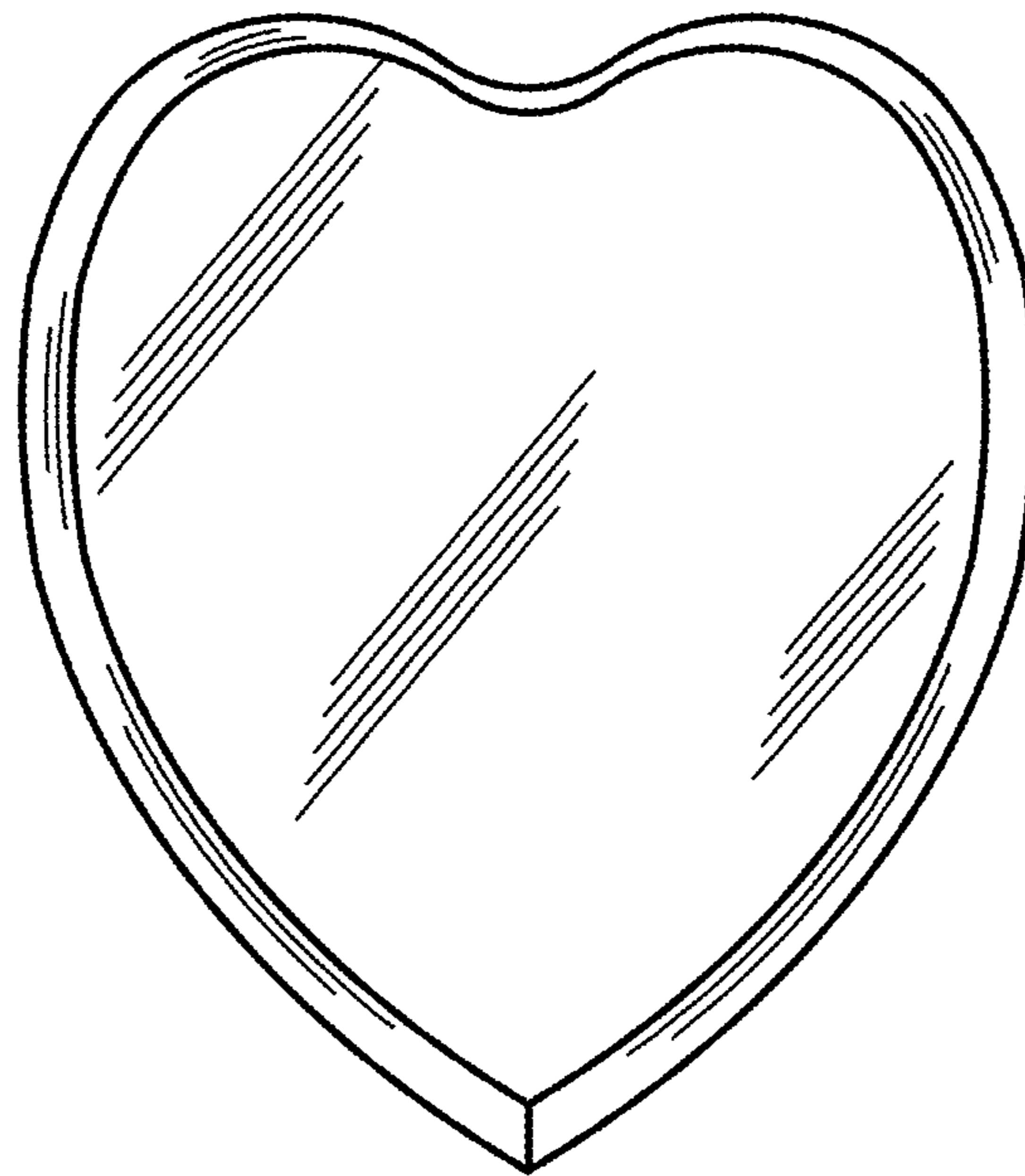

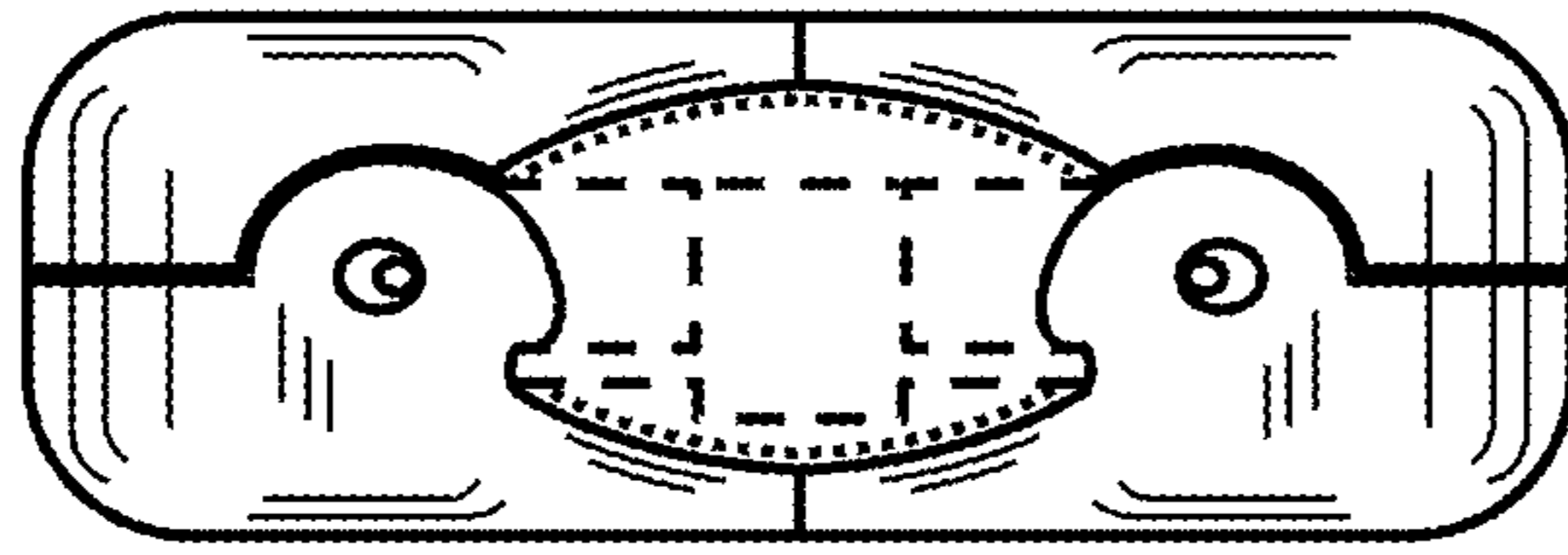

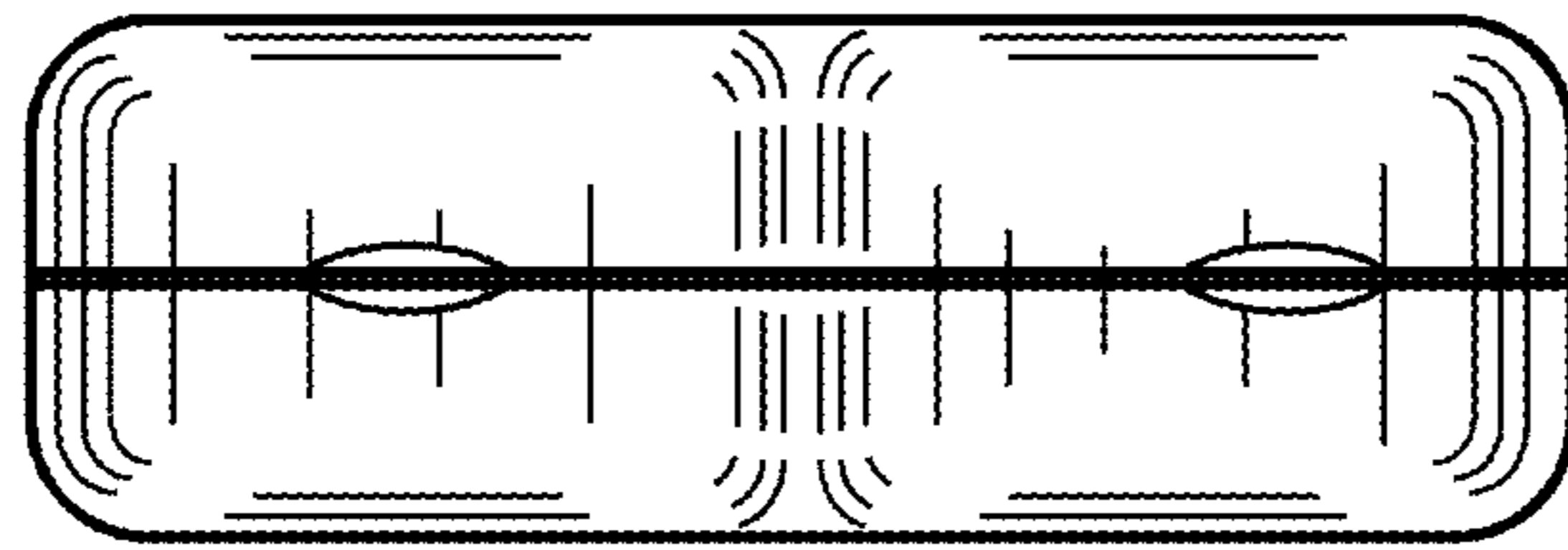

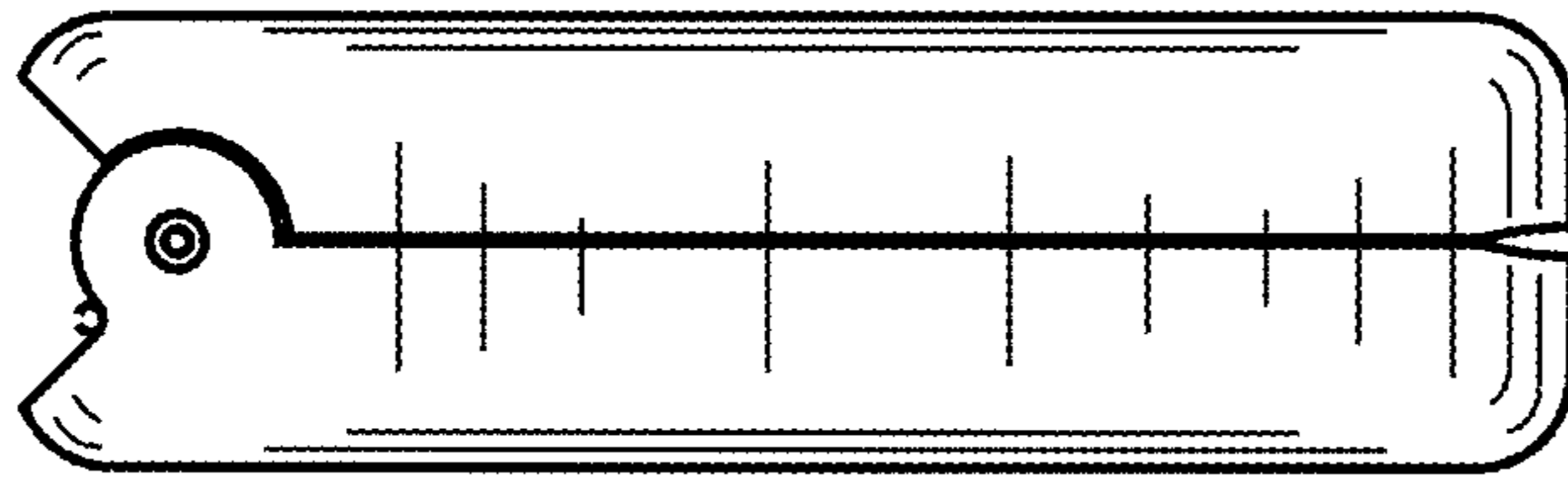

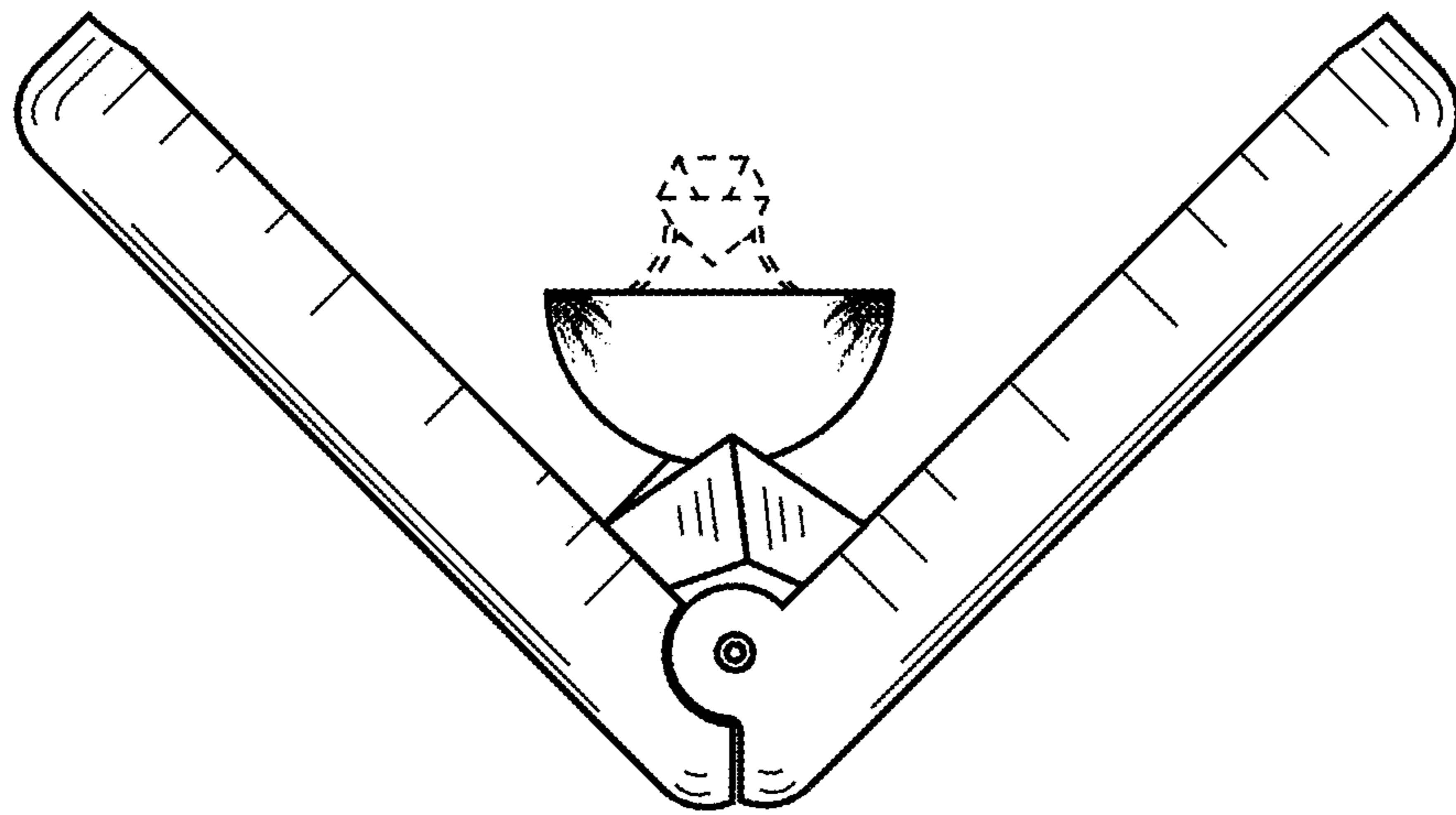

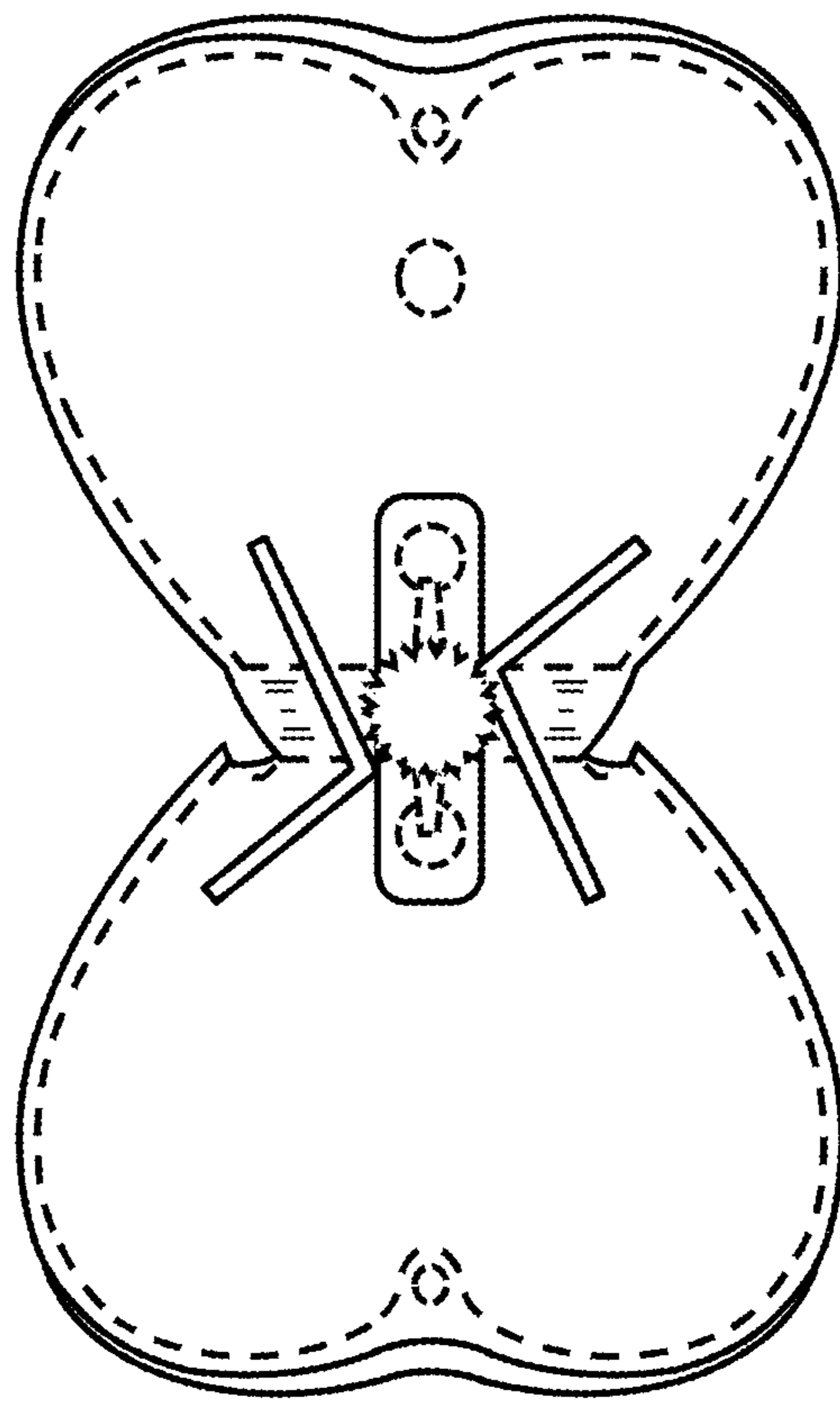
