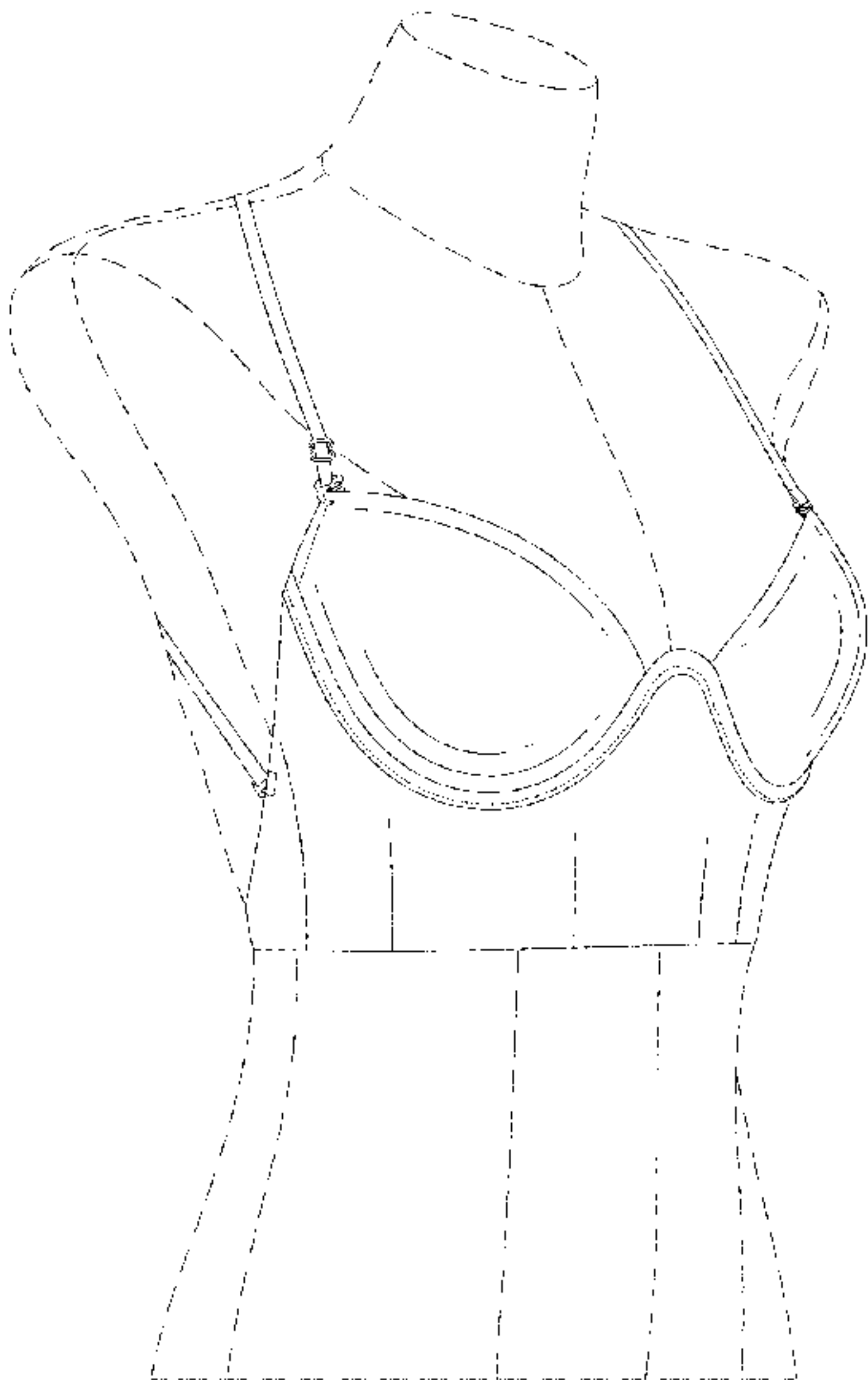
(57) **CLAIM**

The ornamental design for an underwear, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an underwear showing my new design in a first configuration of use;
FIG. 2 is a rear view thereof;
FIG. 3 is a perspective view of the underwear of FIG. 1 shown in a second configuration of use on a mannequin bust;
FIG. 4 is a perspective view of the underwear of FIG. 1 shown in a third configuration of use on a mannequin bust;
FIG. 5 is a left side view of the underwear in FIG. 3;
FIG. 6 is a right side view of the underwear in FIG. 3;
FIG. 7 is a front view of the underwear in FIG. 3;
FIG. 8 is a front view of the underwear in FIG. 4;
FIG. 9 is a rear view of the underwear in FIG. 4;
FIG. 10 is a rear view of the underwear in FIG. 3; and,
FIG. 11 is a rear view of the underwear of FIG. 1 shown in a fourth configuration of use on a mannequin bust.
The short dashed broken lines in the drawings depict portions of the underwear that form no part of the claimed design. The long dashed broken lines showing a mannequin bust illustrate environmental subject matter and form no part of the claimed design.

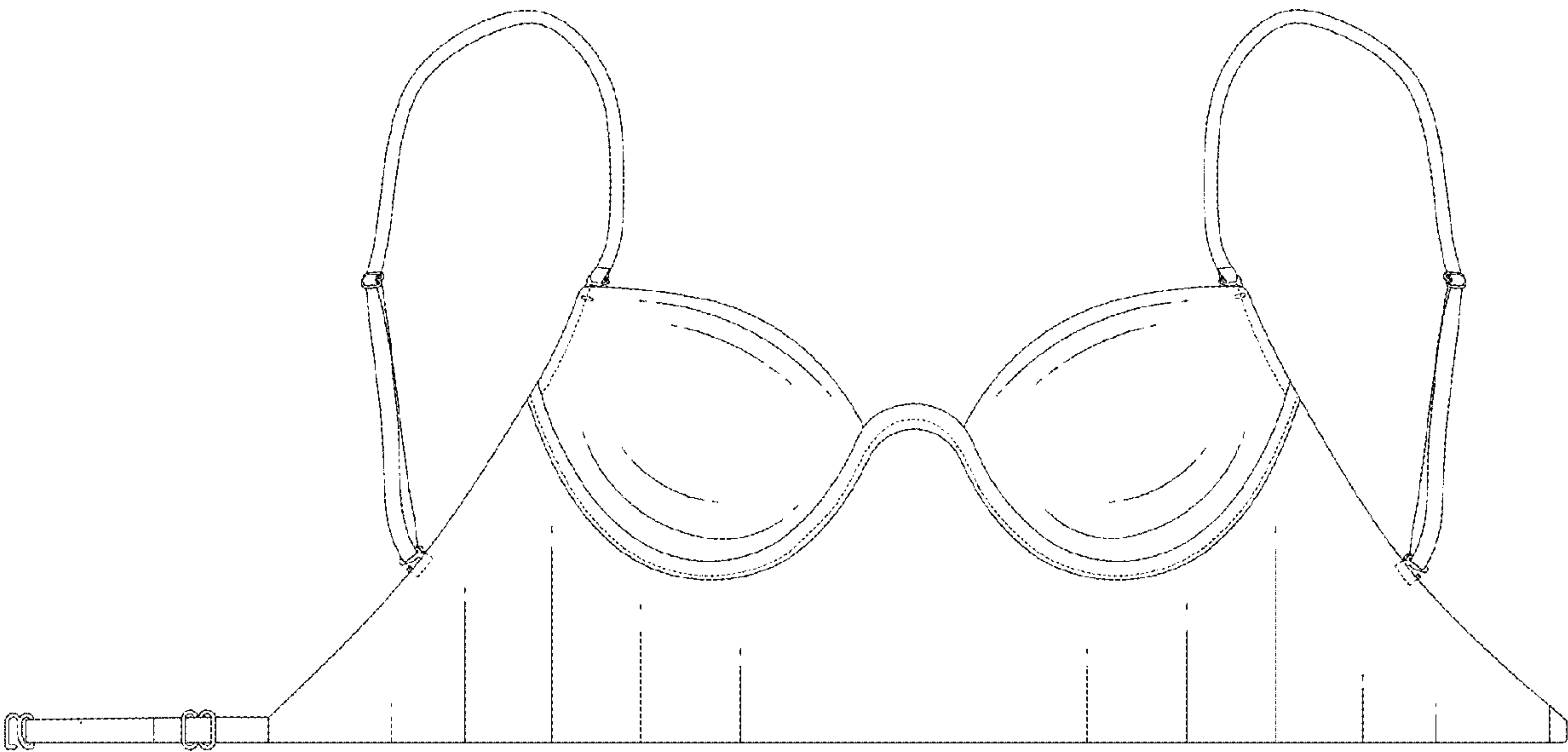

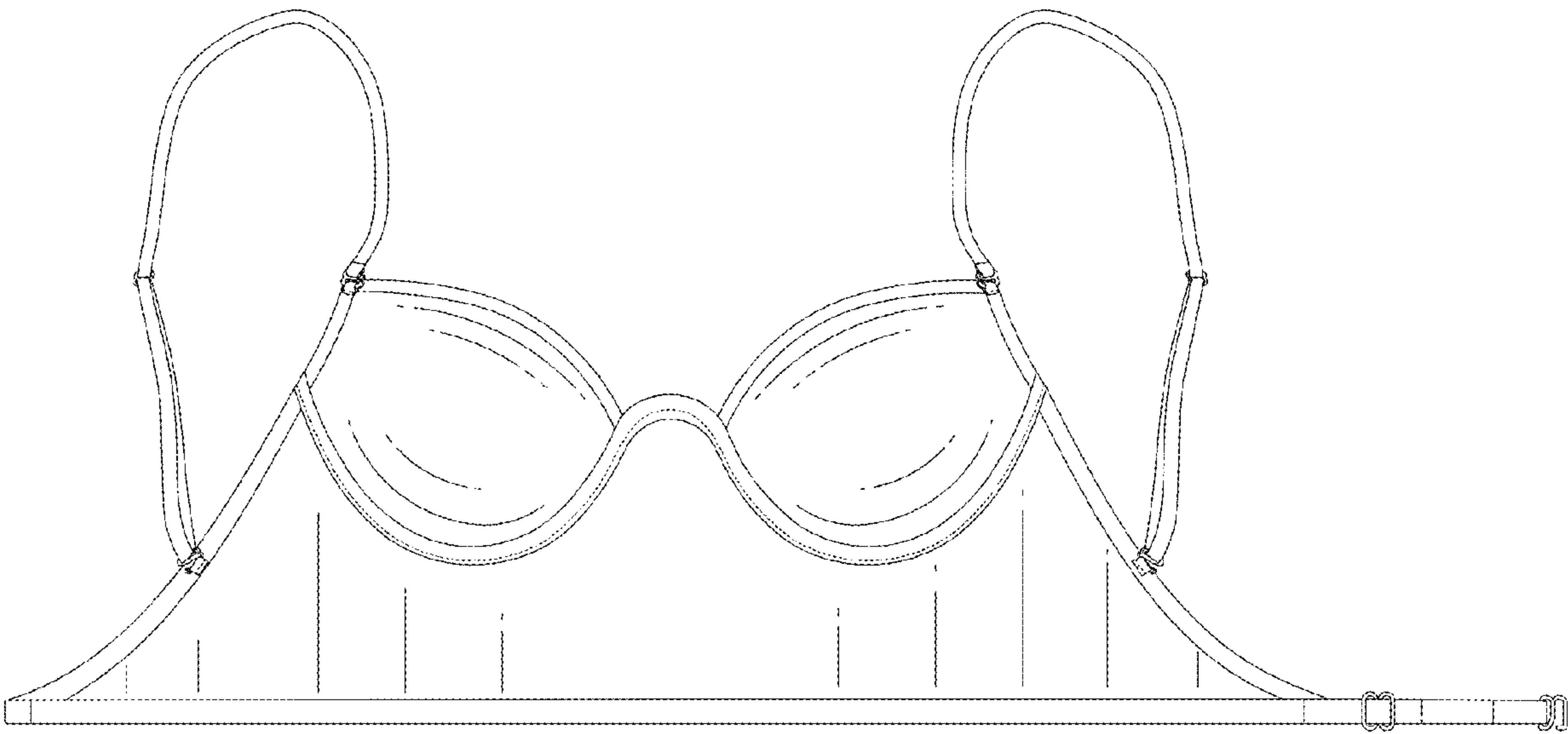

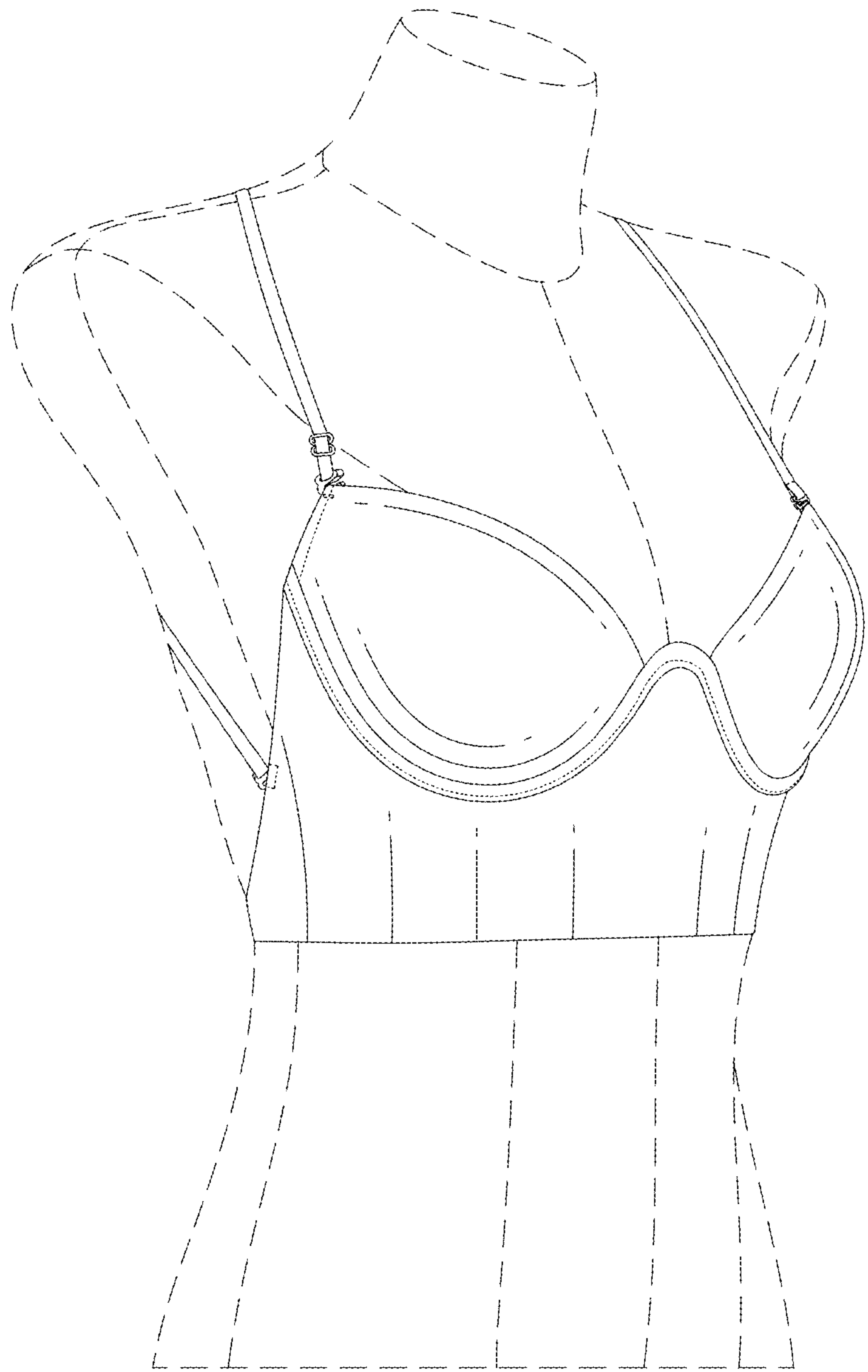

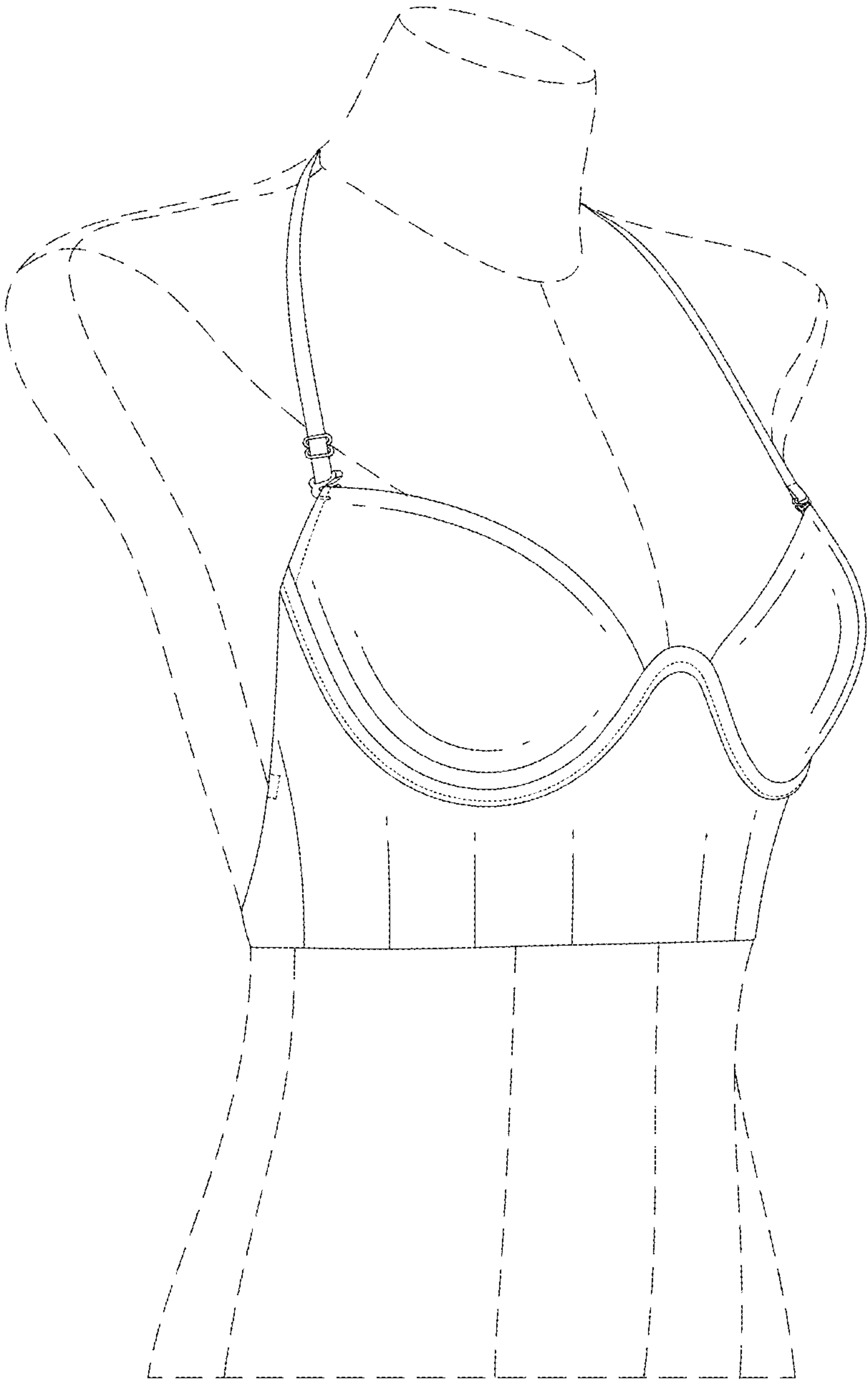

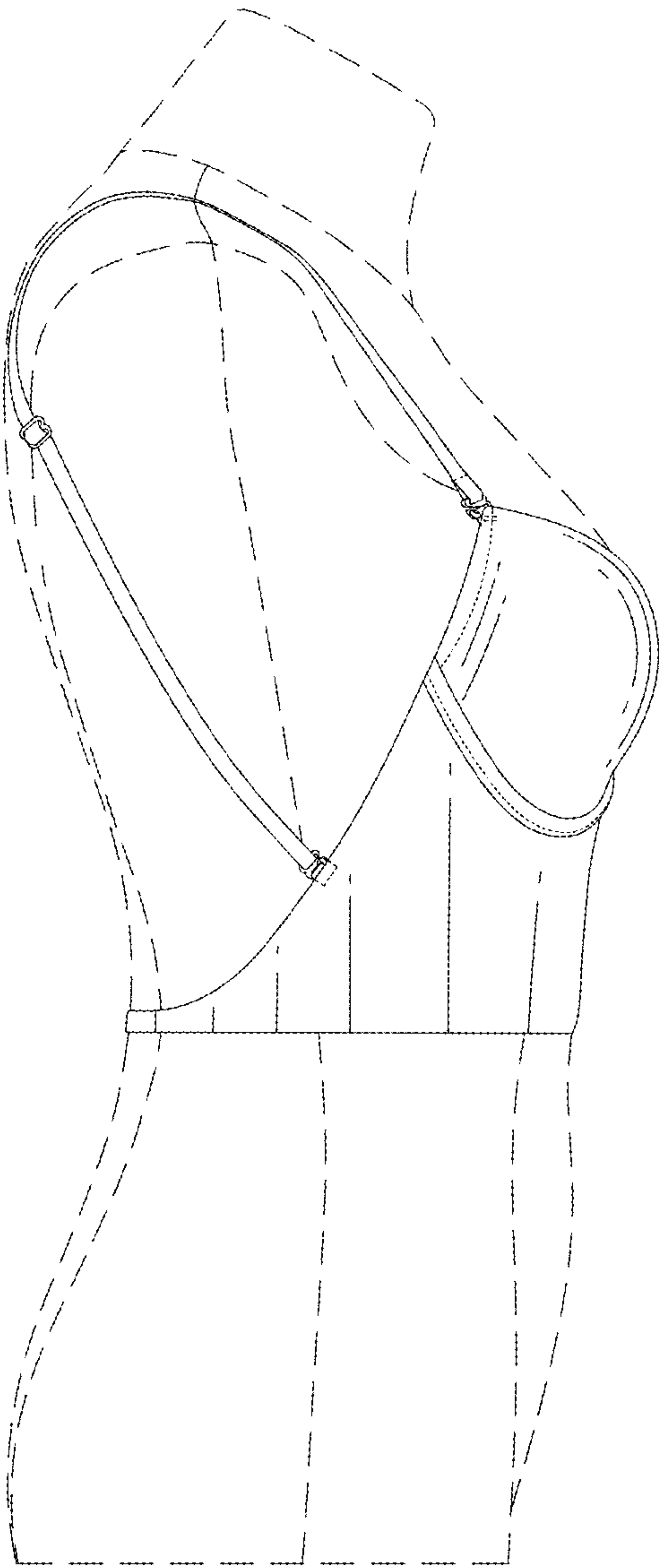

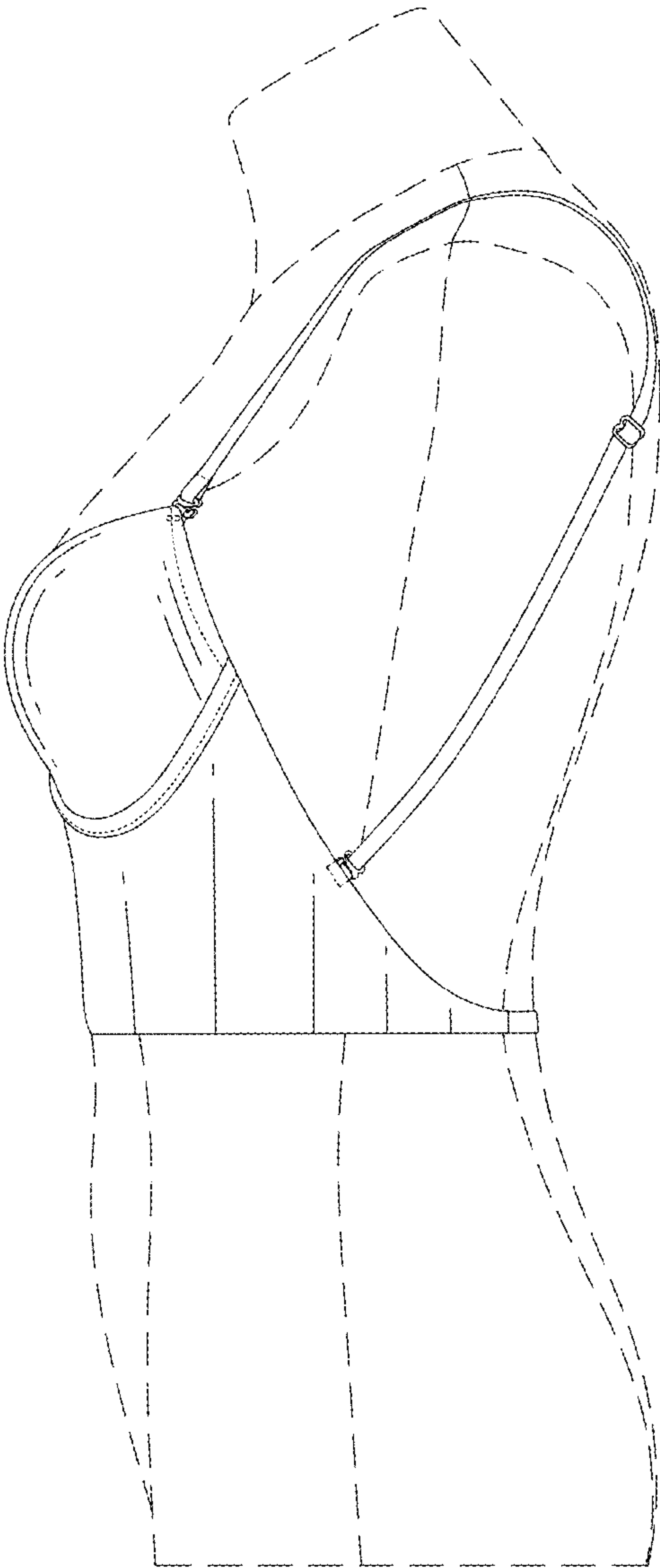

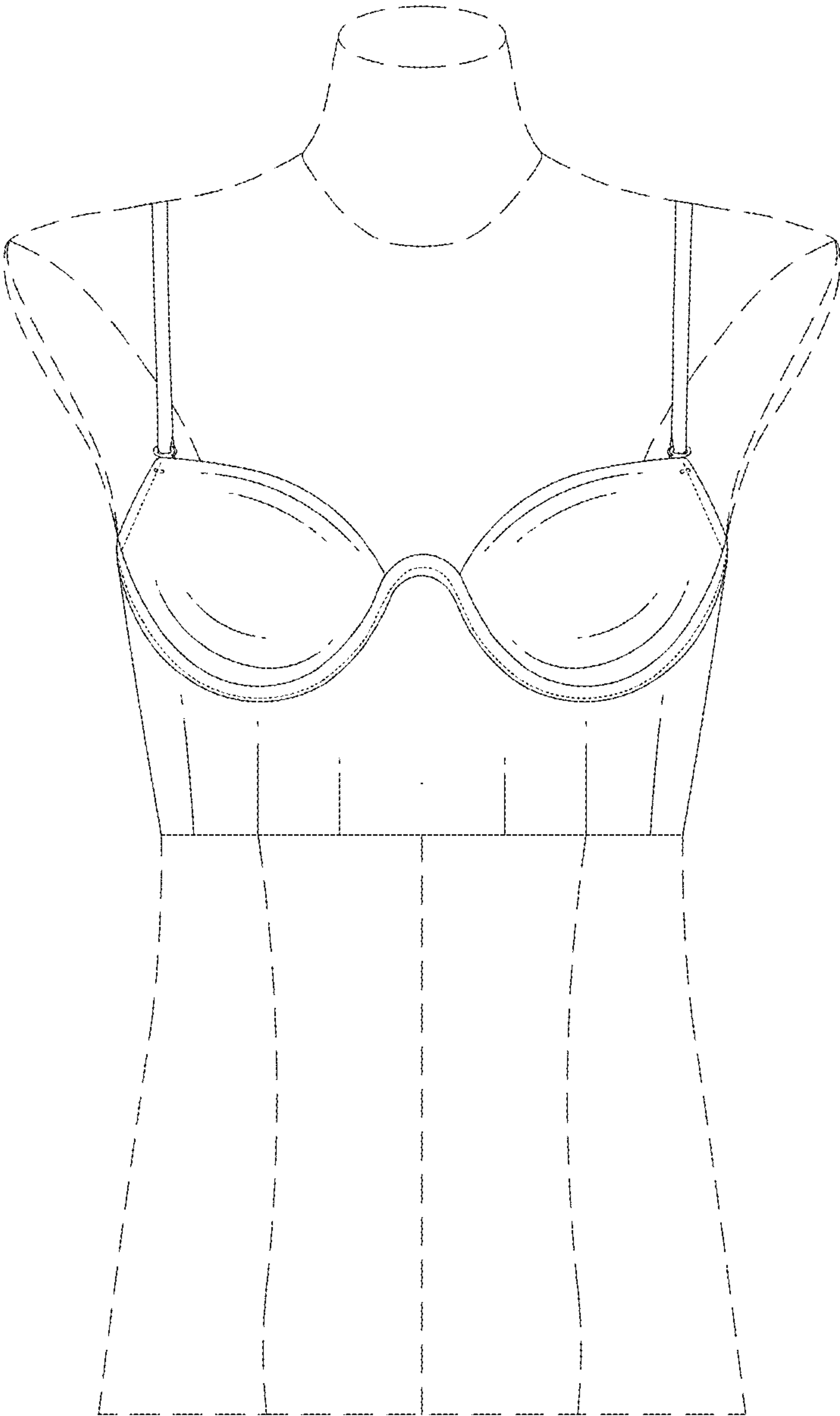

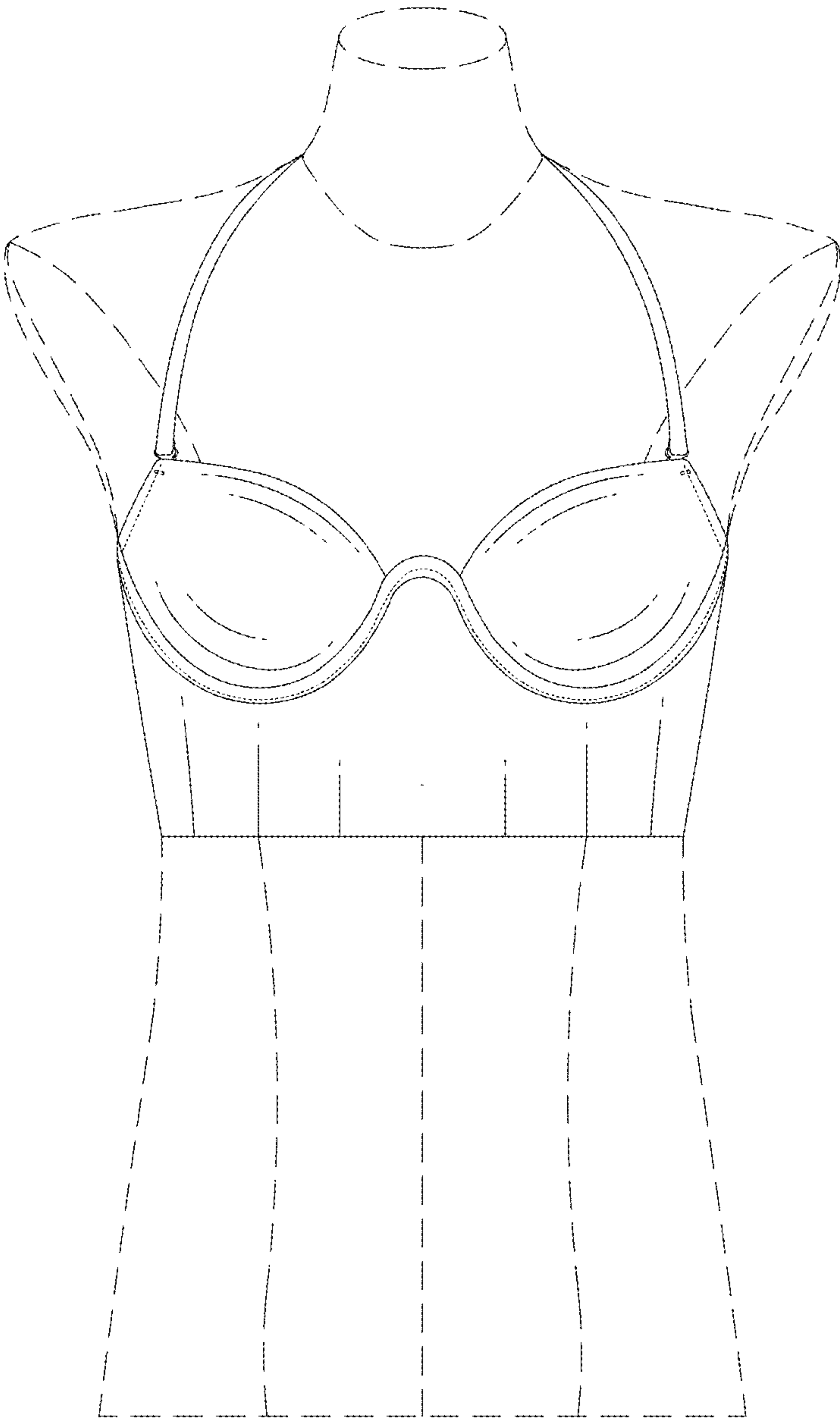

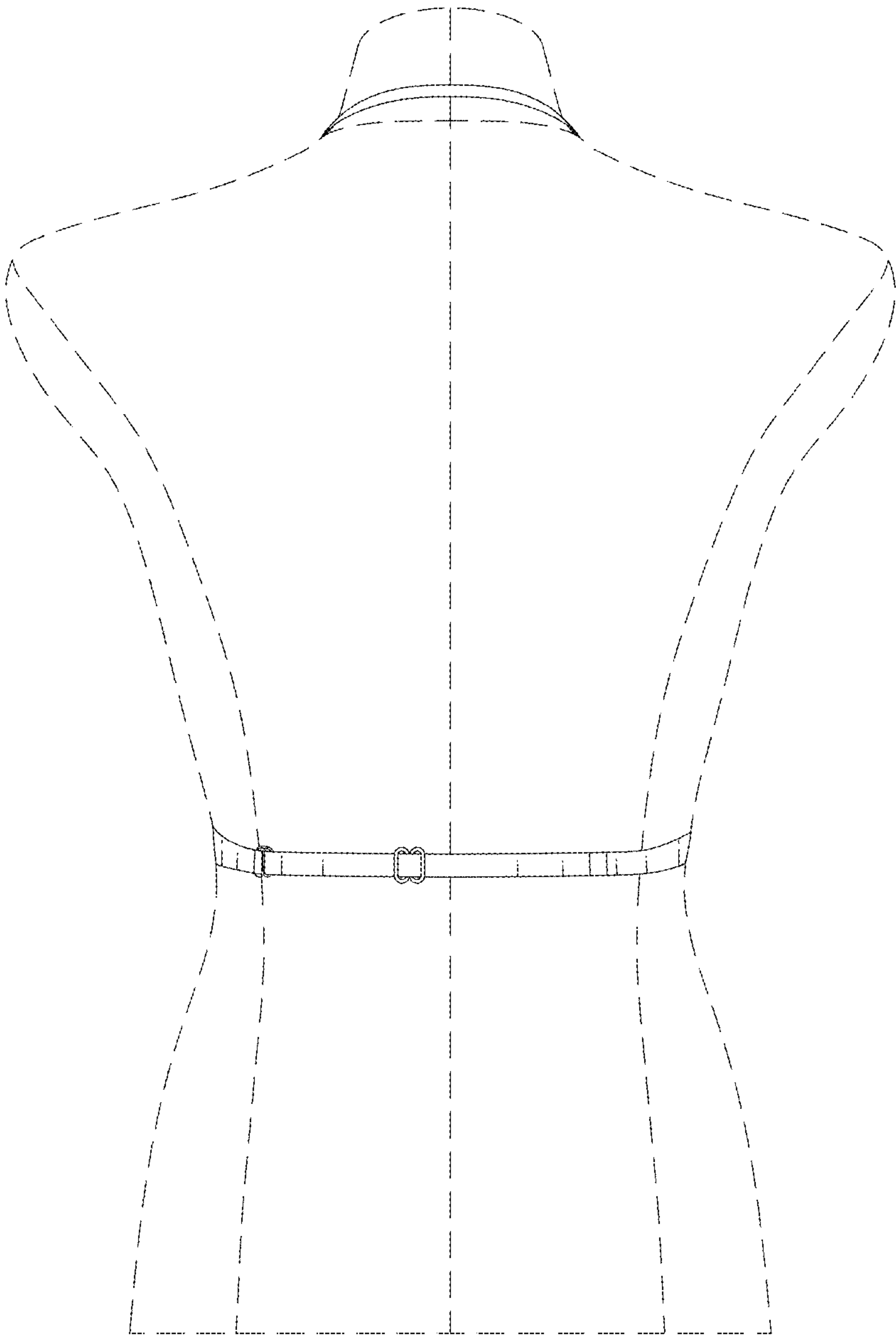

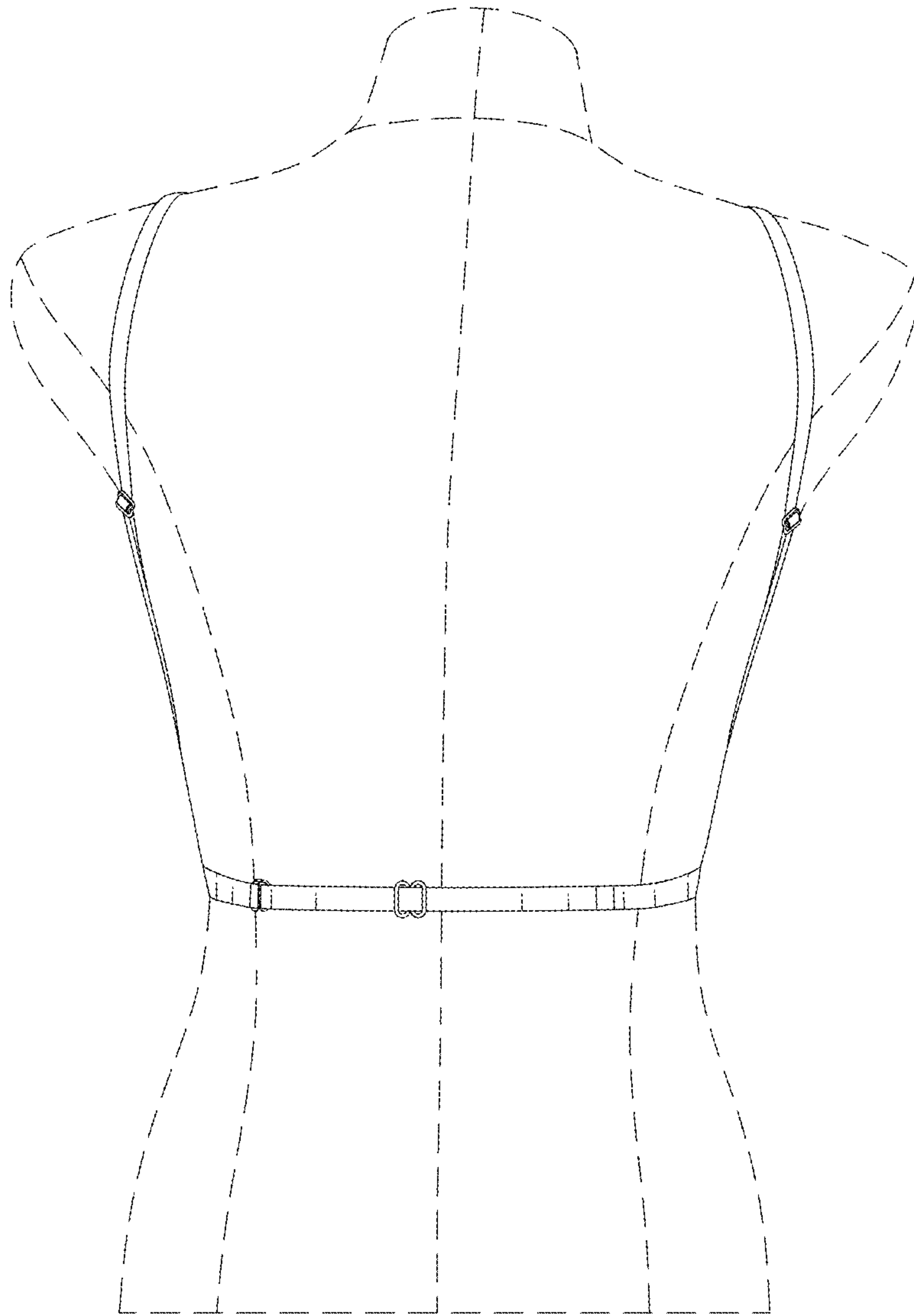

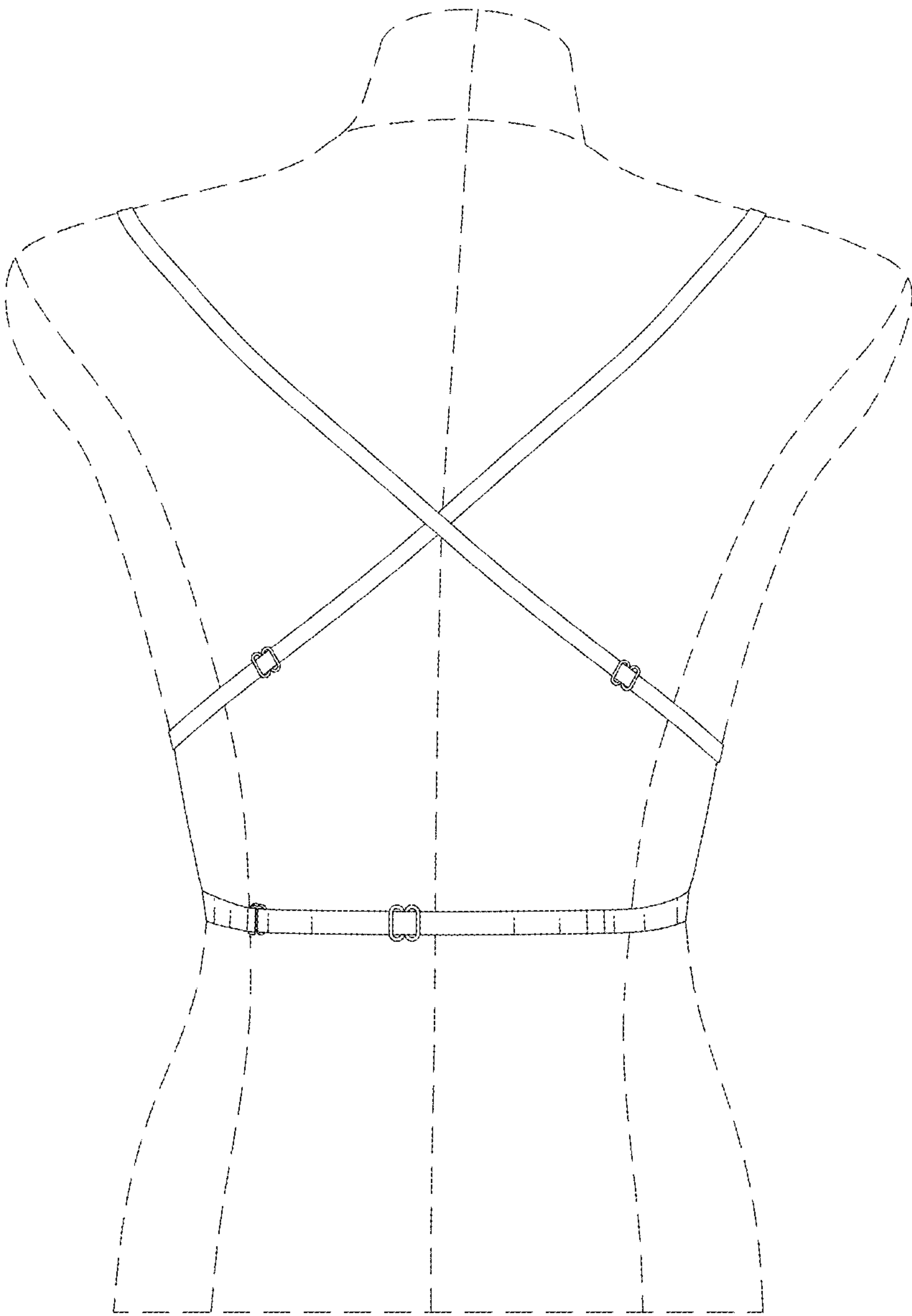
