DESCRIPTION

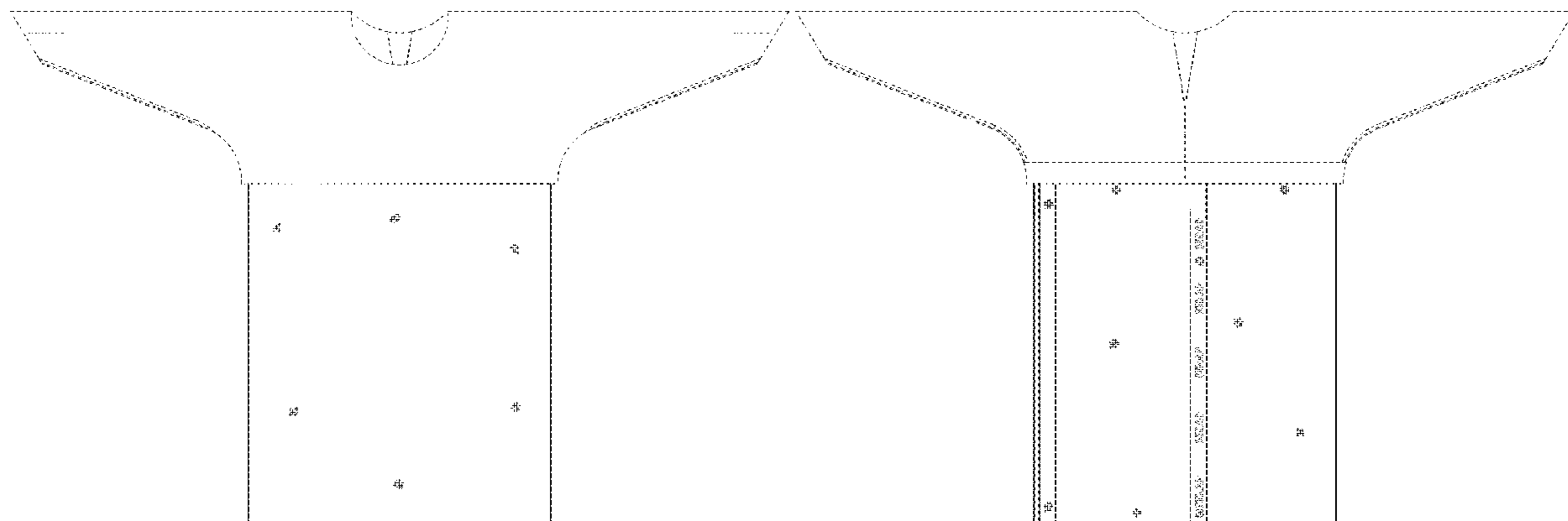
FIG. 1 is a front elevation view showing the medical gown of Applicants' invention.

FIG. 2 is a rear elevation view of the medical gown of FIG. 1; and,

FIG. 3 is a rear elevation view of the medical gown of FIG. 1 with left and right flaps in a lifted state as well as left and right ties in a lifted state.

The "dash-dash" broken lines show portions of a medical gown which form no part of the claimed design.

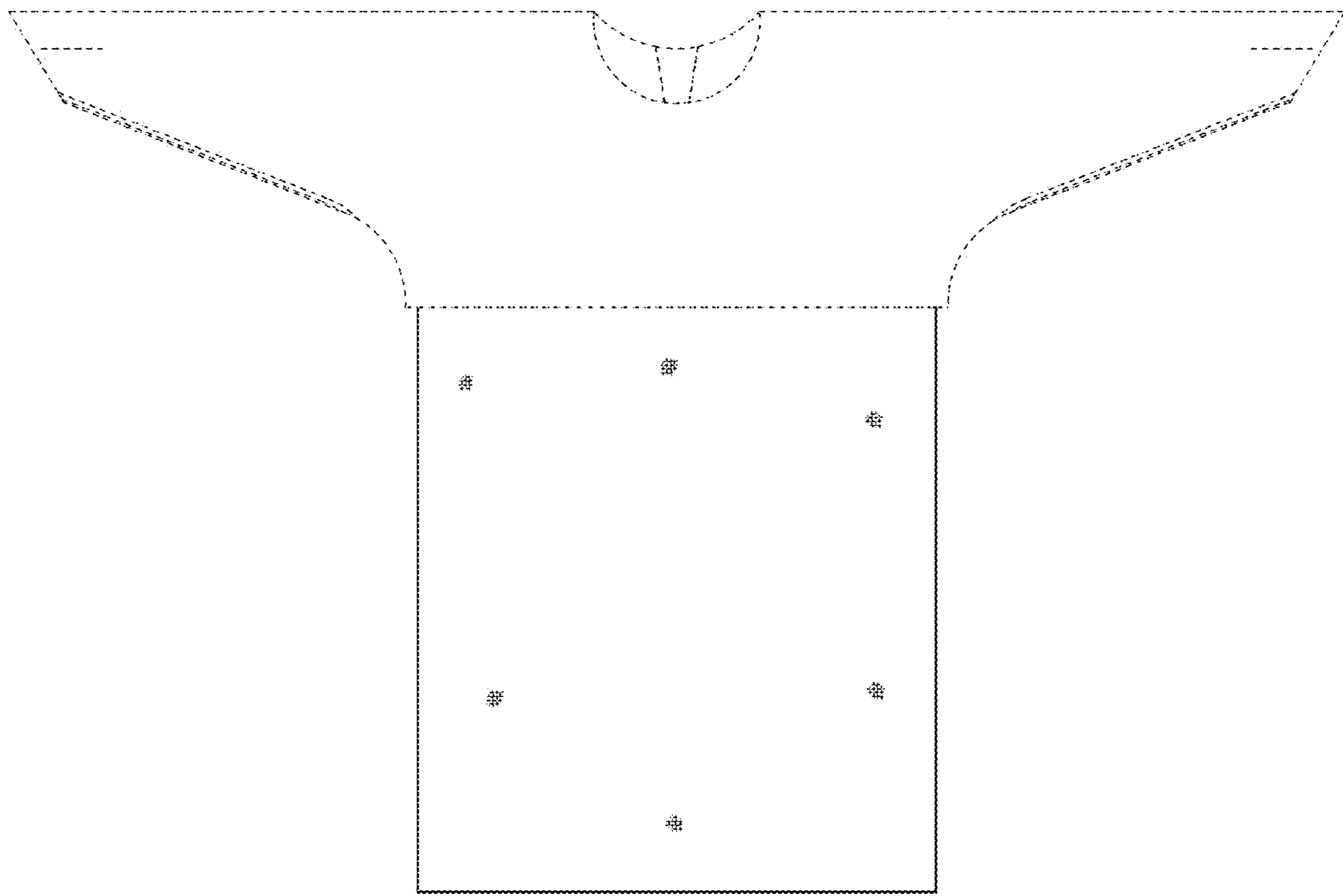

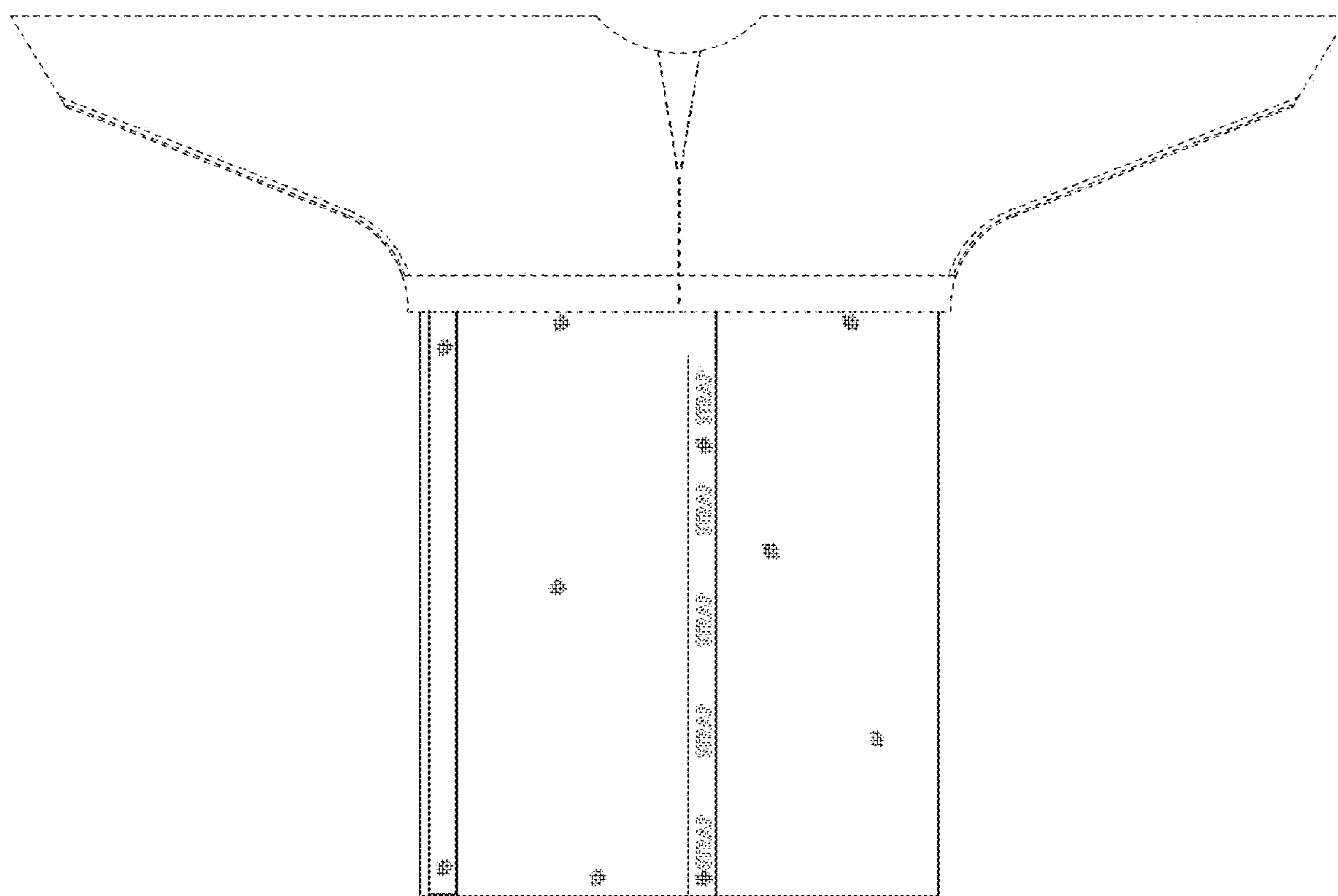

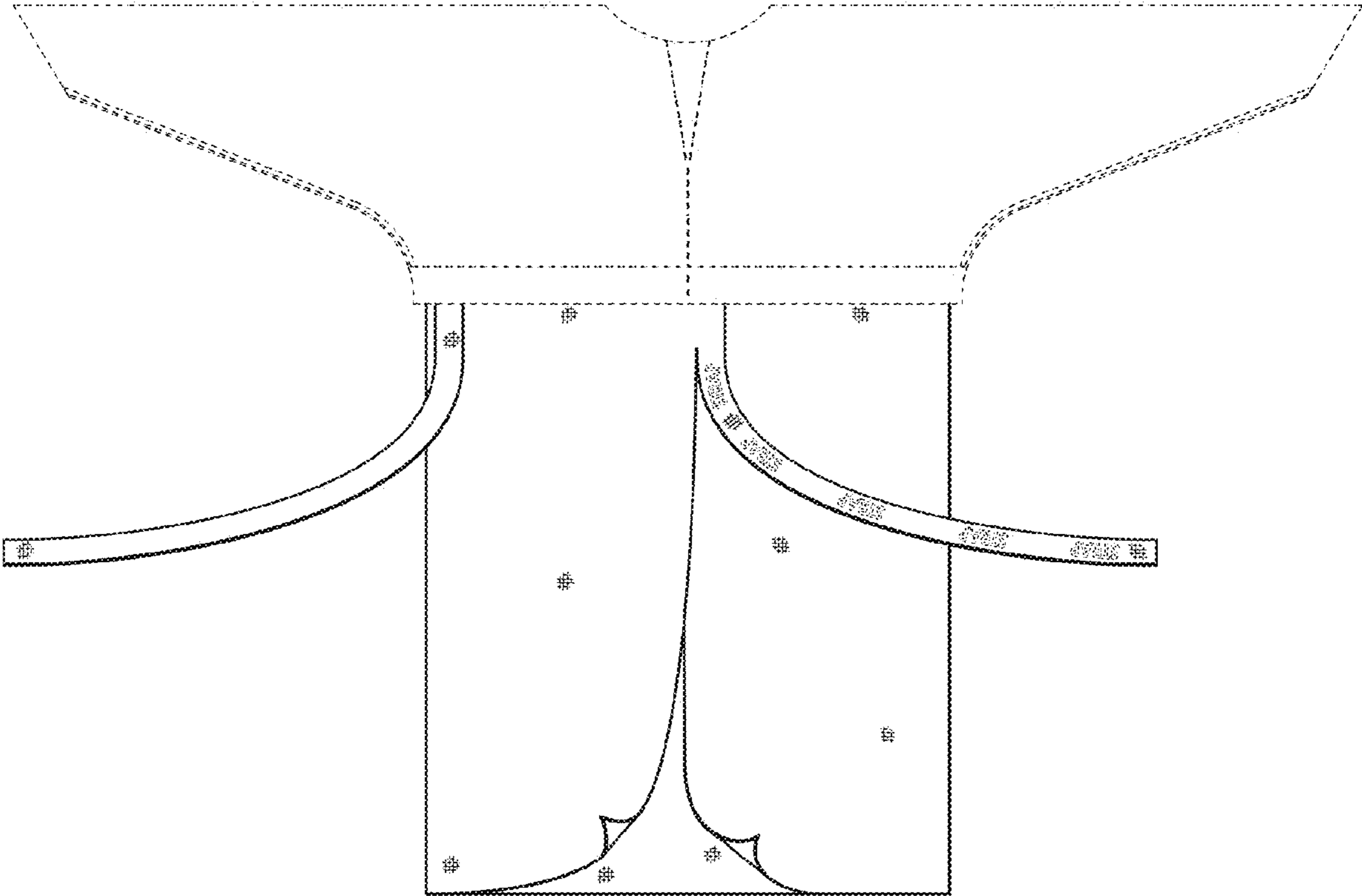
