(57) CLAIM

The ornamental design for a baby one piece, as shown and described.

DESCRIPTION

FIG. 1 is a diagram illustrating a perspective front view of a baby one piece.

FIG. 2 is a diagram illustrating a perspective back view of the baby one piece of FIG. 1, further illustrating the baby one piece.

FIG. 3 is a diagram illustrating a front elevation view of the baby one piece of FIG. 1, further illustrating the baby one piece.

FIG. 4 is a diagram illustrating a rear elevation view of the baby one piece of FIG. 1, further illustrating the baby one piece.

FIG. 5 is a diagram illustrating a left-side elevation view of the baby one piece of FIG. 1, further illustrating the baby one piece.

FIG. 6 is a diagram illustrating a right-side elevation view of the baby one piece of FIG. 1, further illustrating the baby one piece.

FIG. 7 is a diagram illustrating a plan view of the baby one piece of FIG. 1 in an unsnapped configuration and further illustrating the baby one piece.

FIG. 8 is a diagram illustrating bottom plan view of the baby one piece of FIG. 1 in an unsnapped configuration and further illustrating the baby one piece.

FIG. 9 is a close-up view thereof, as referenced in FIG. 2.


FIG. 10 is a diagram illustrating a perspective view of the baby one piece of FIG. 1 as a baby may wear the one piece; and,


















