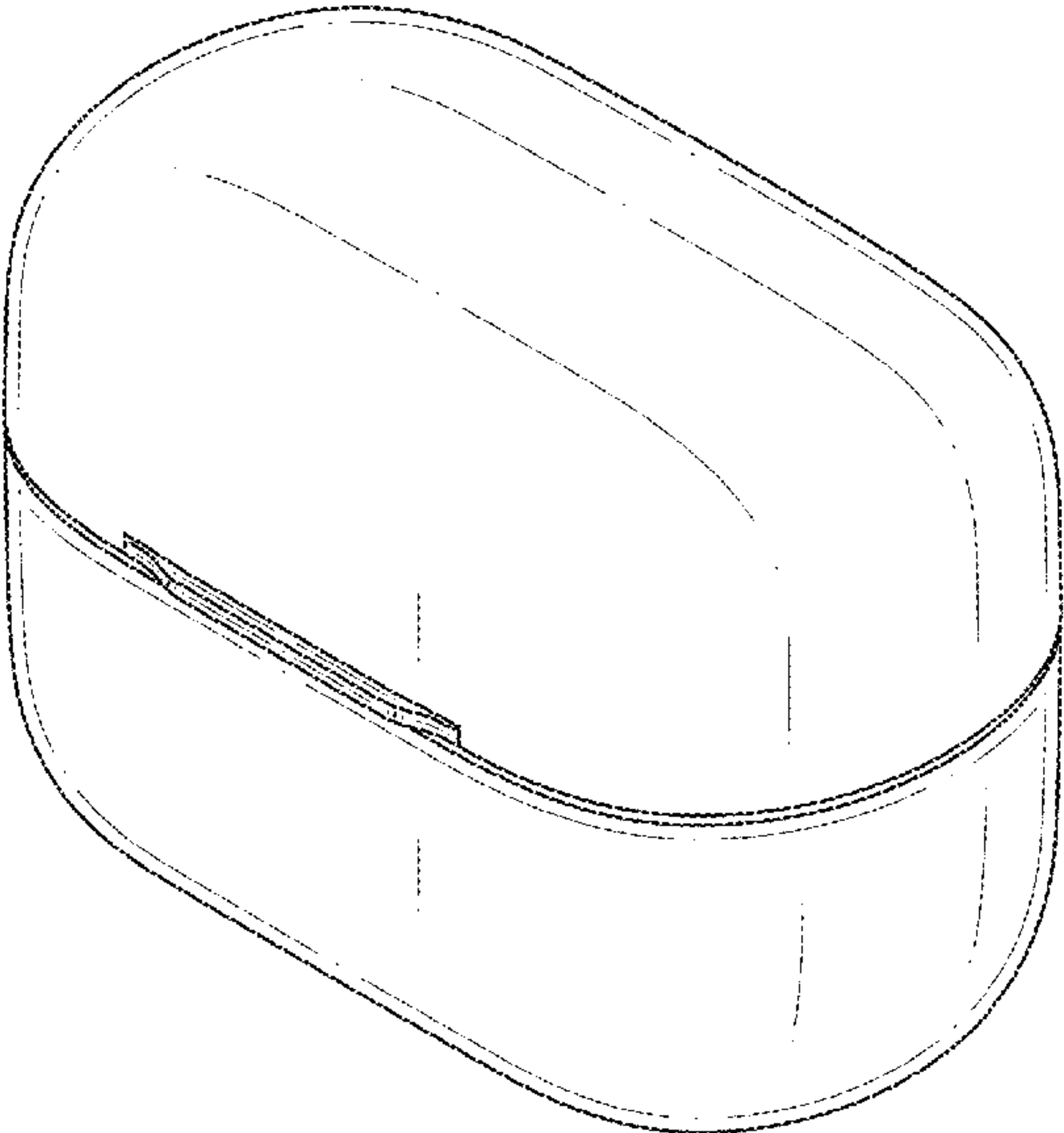
(57) CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a charging case in a closed state as seen from the front, top, and right side;
FIG. 2 is a top view thereof;

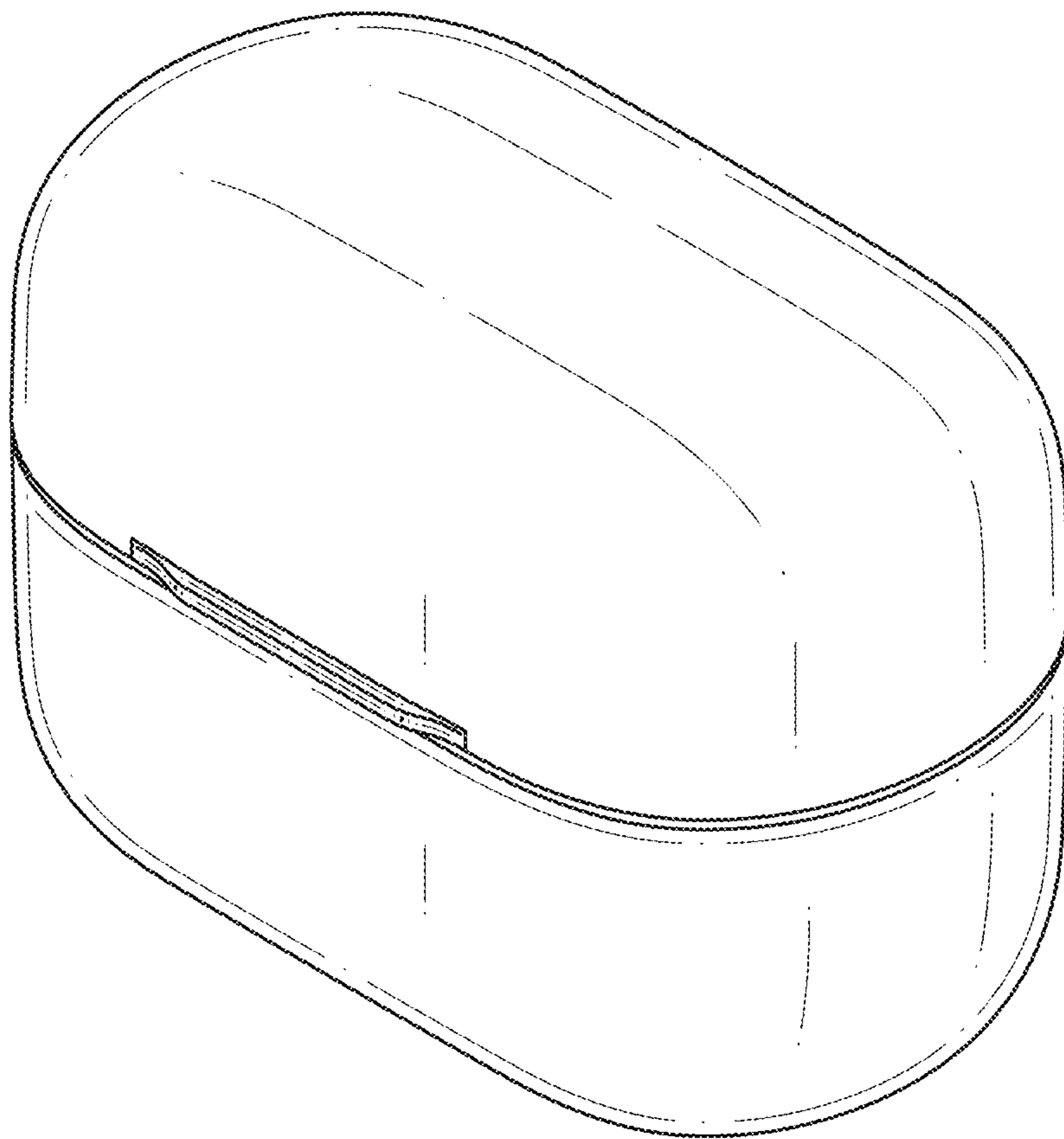

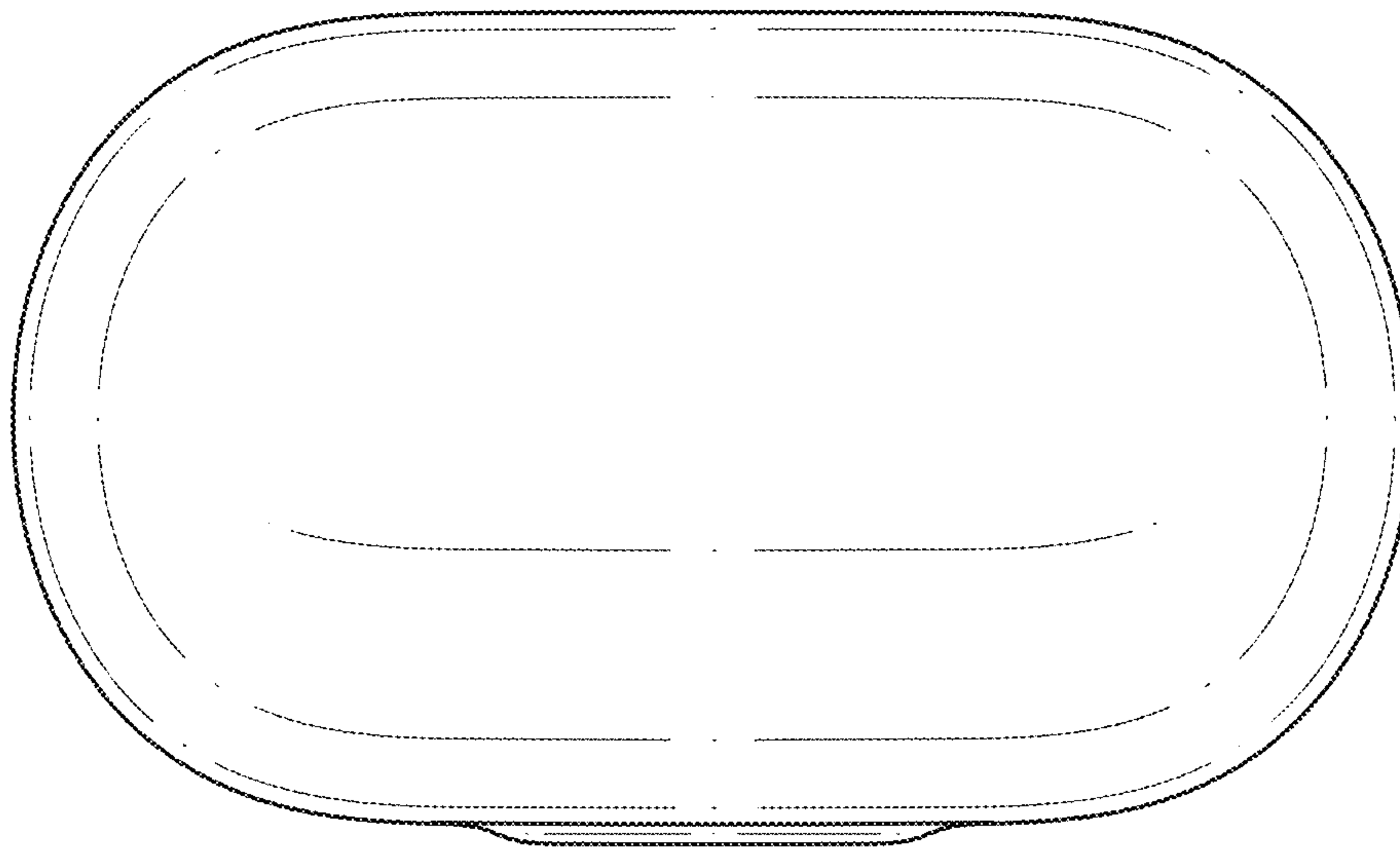

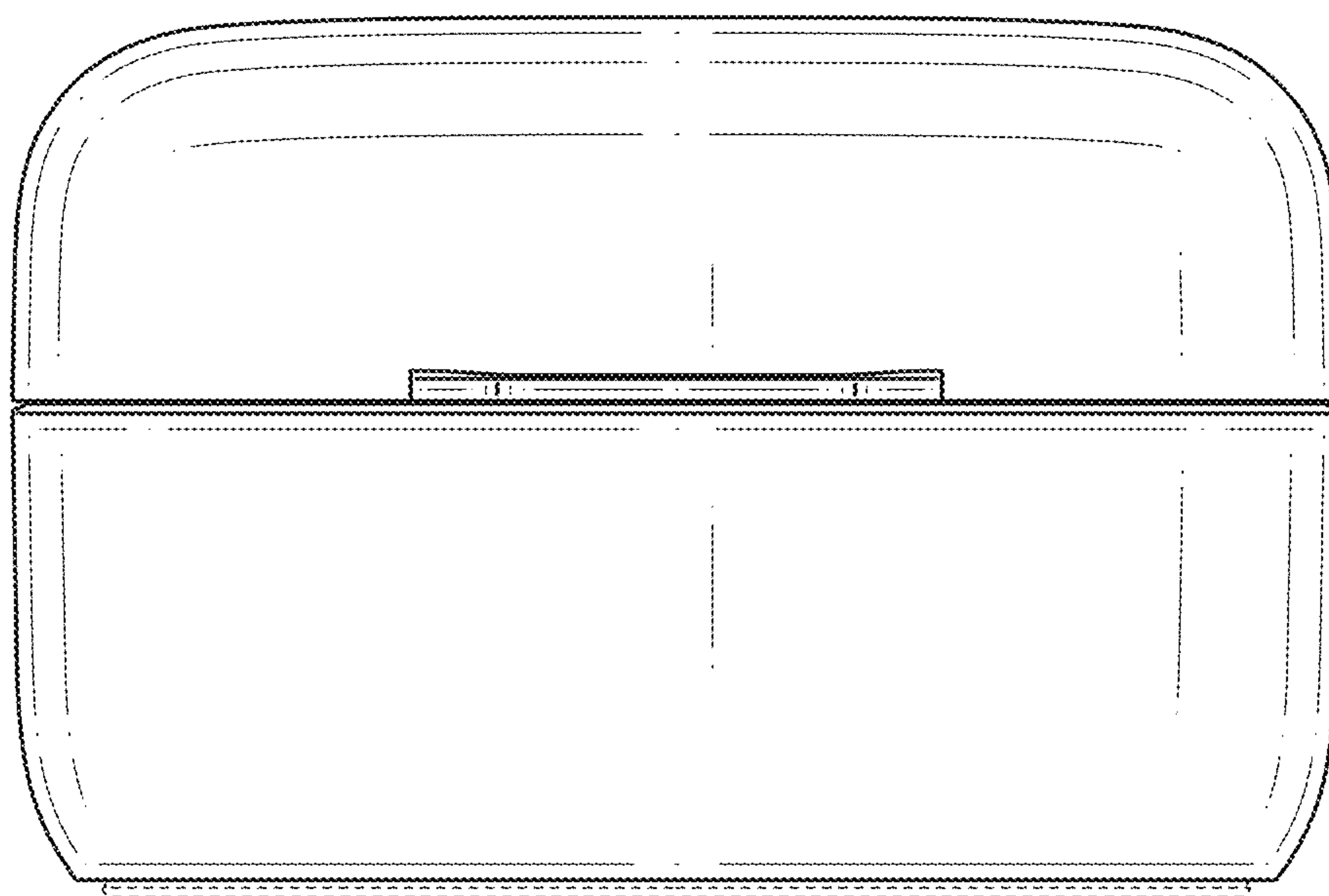

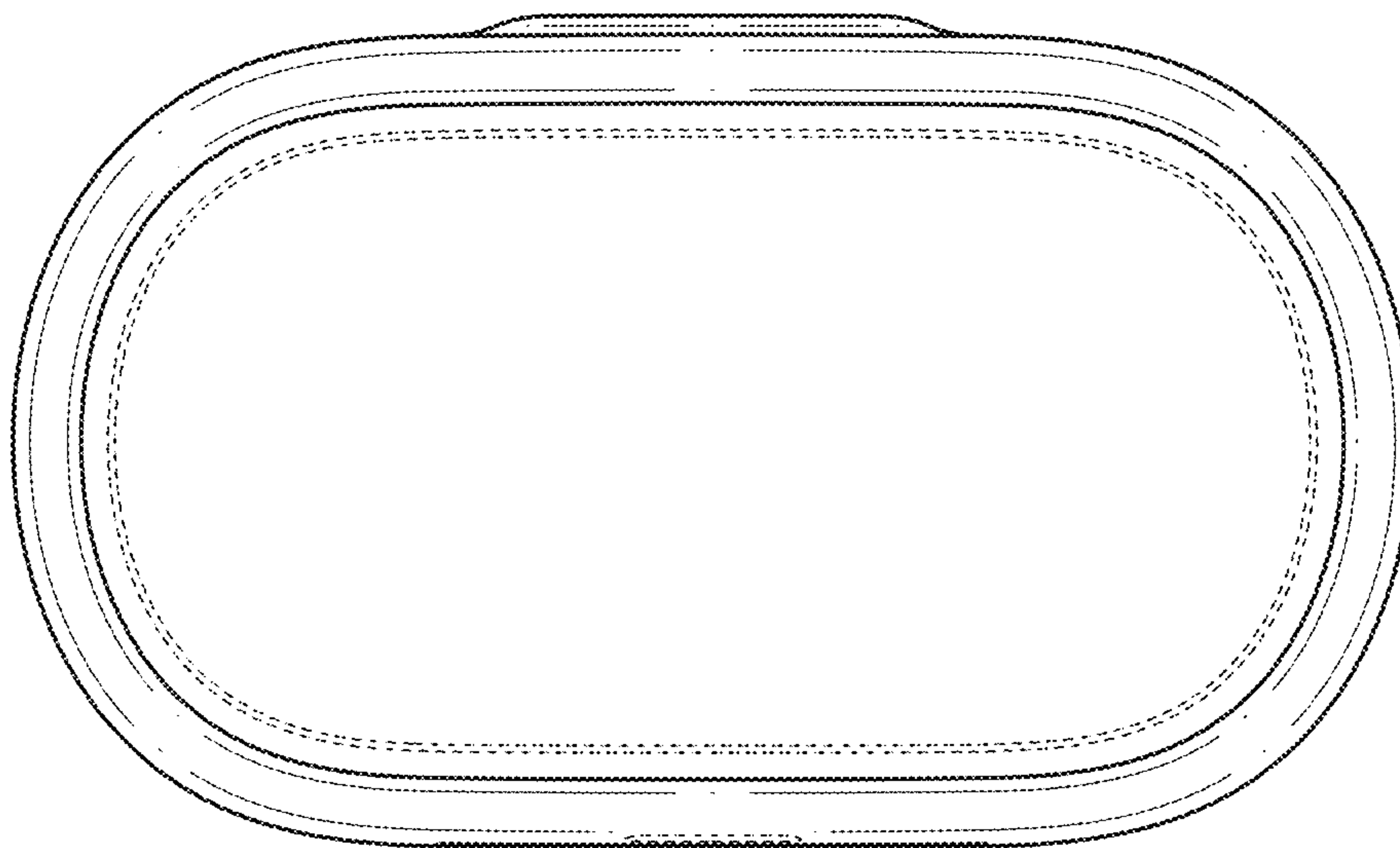

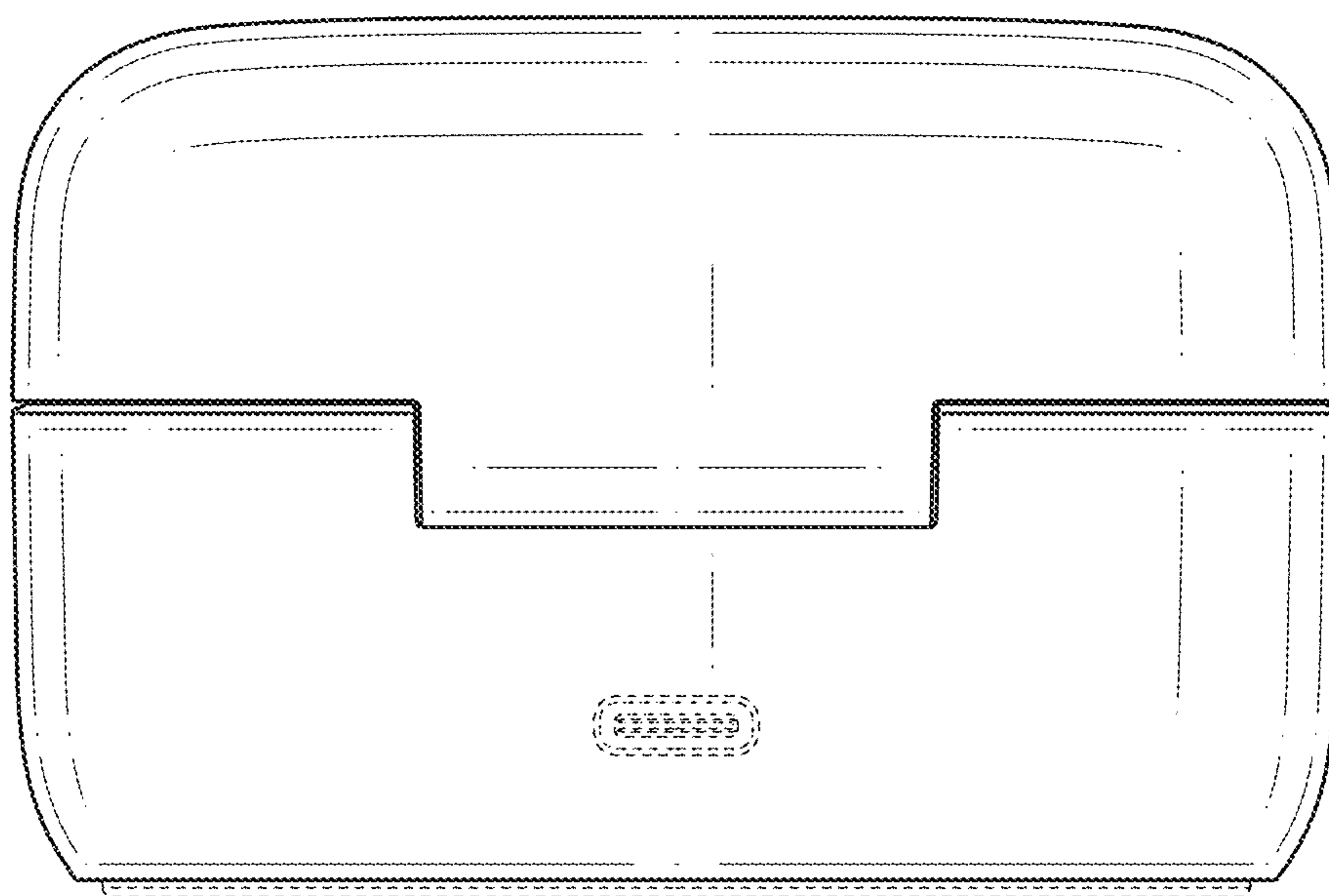

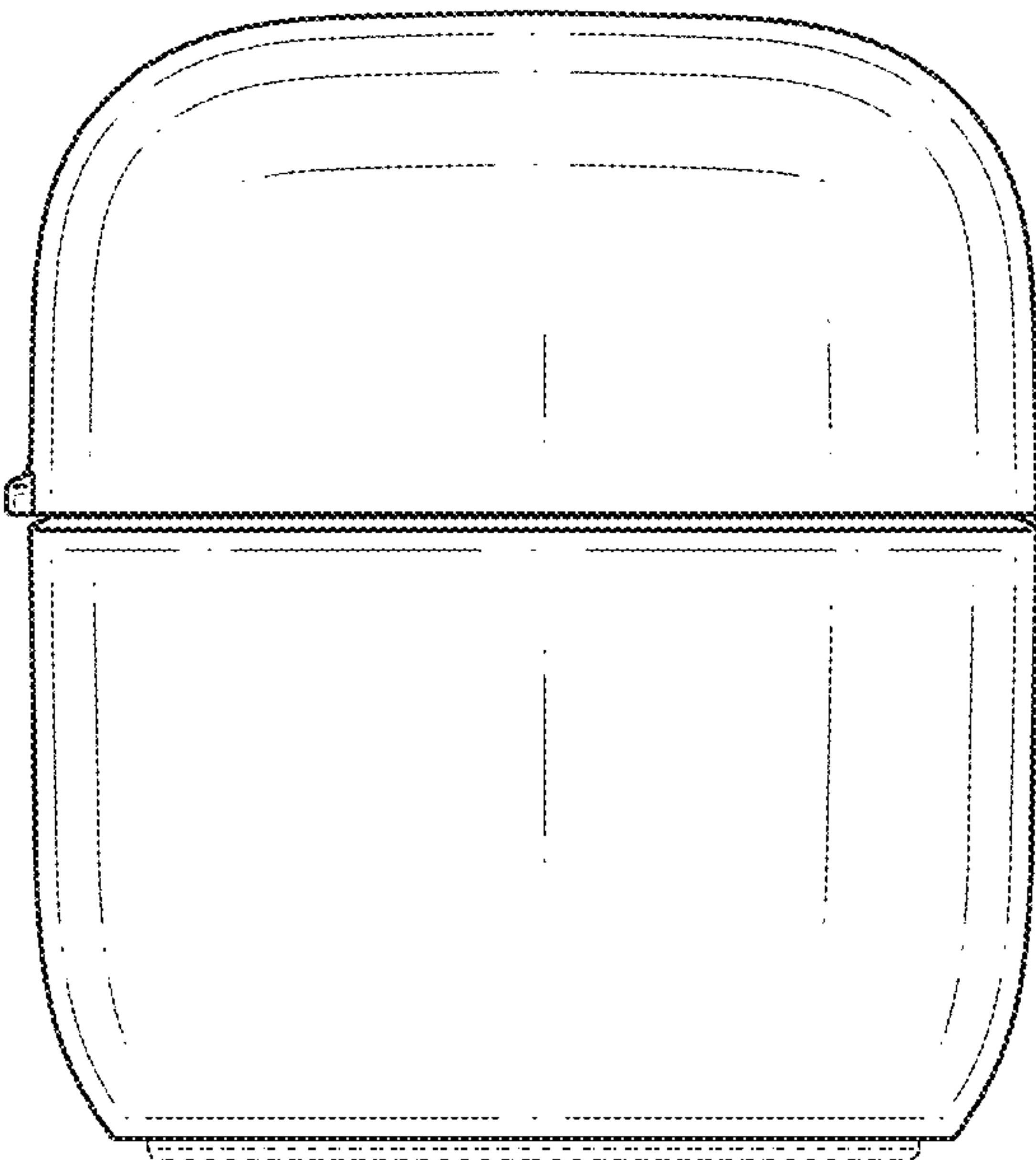

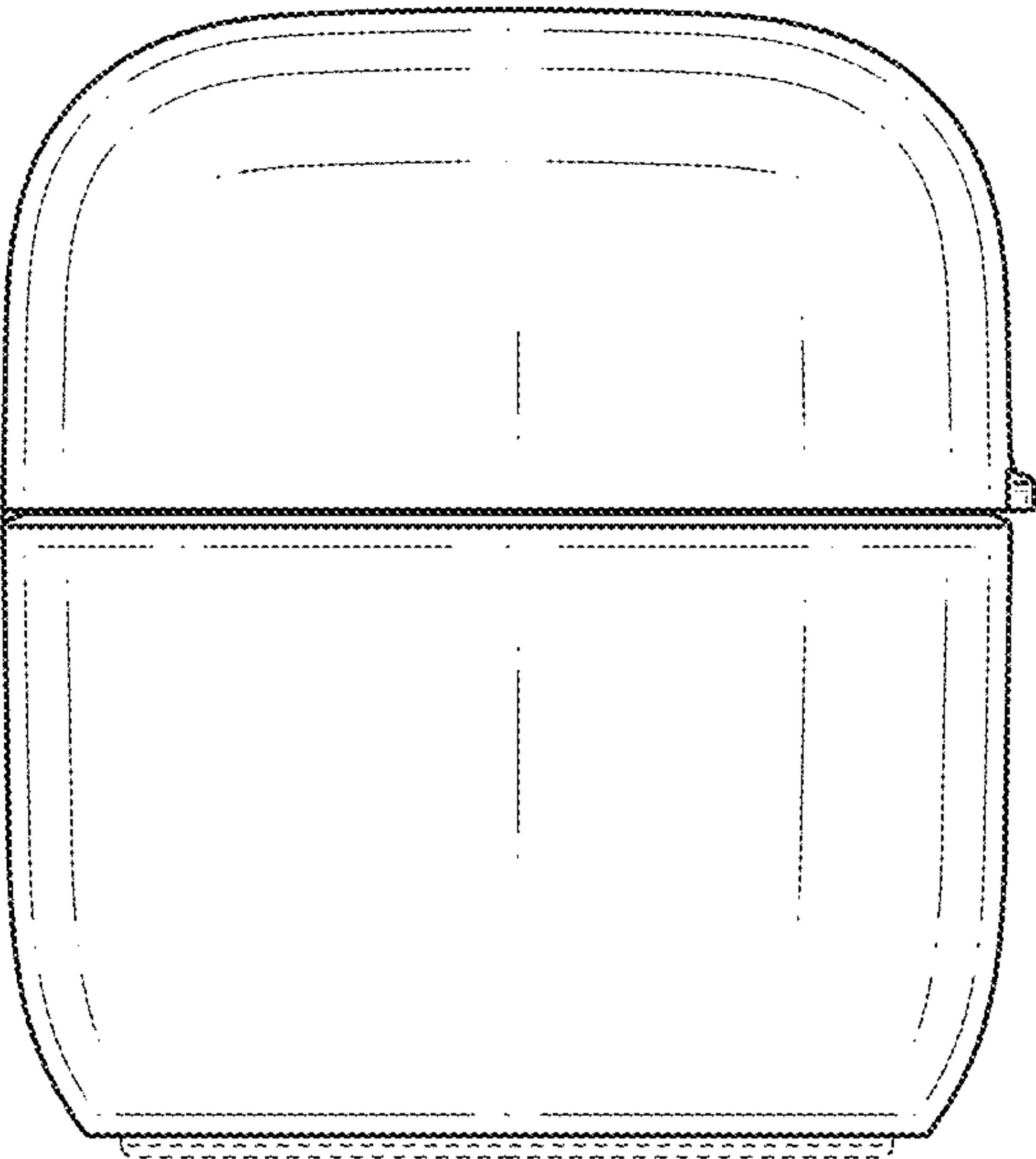

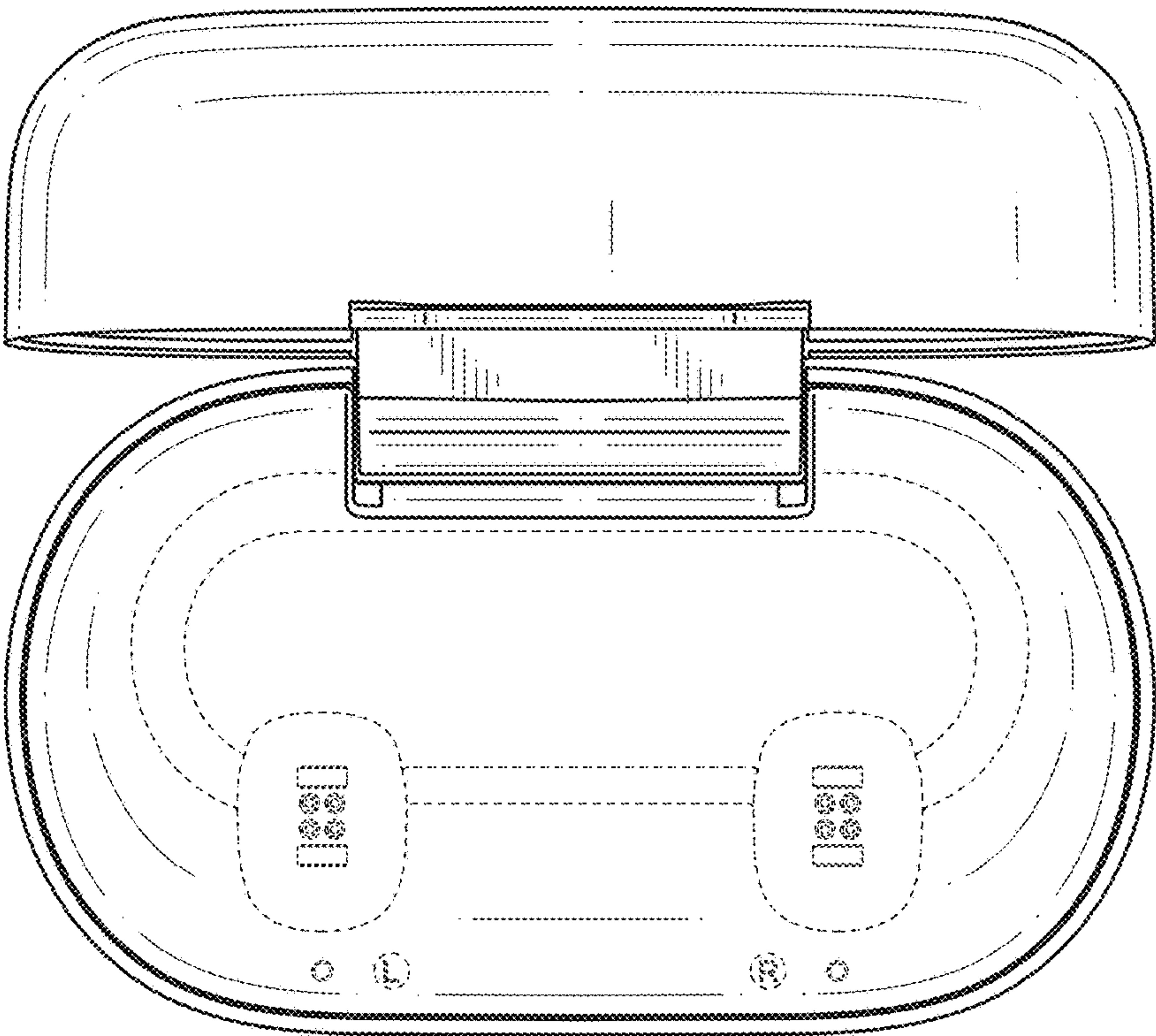

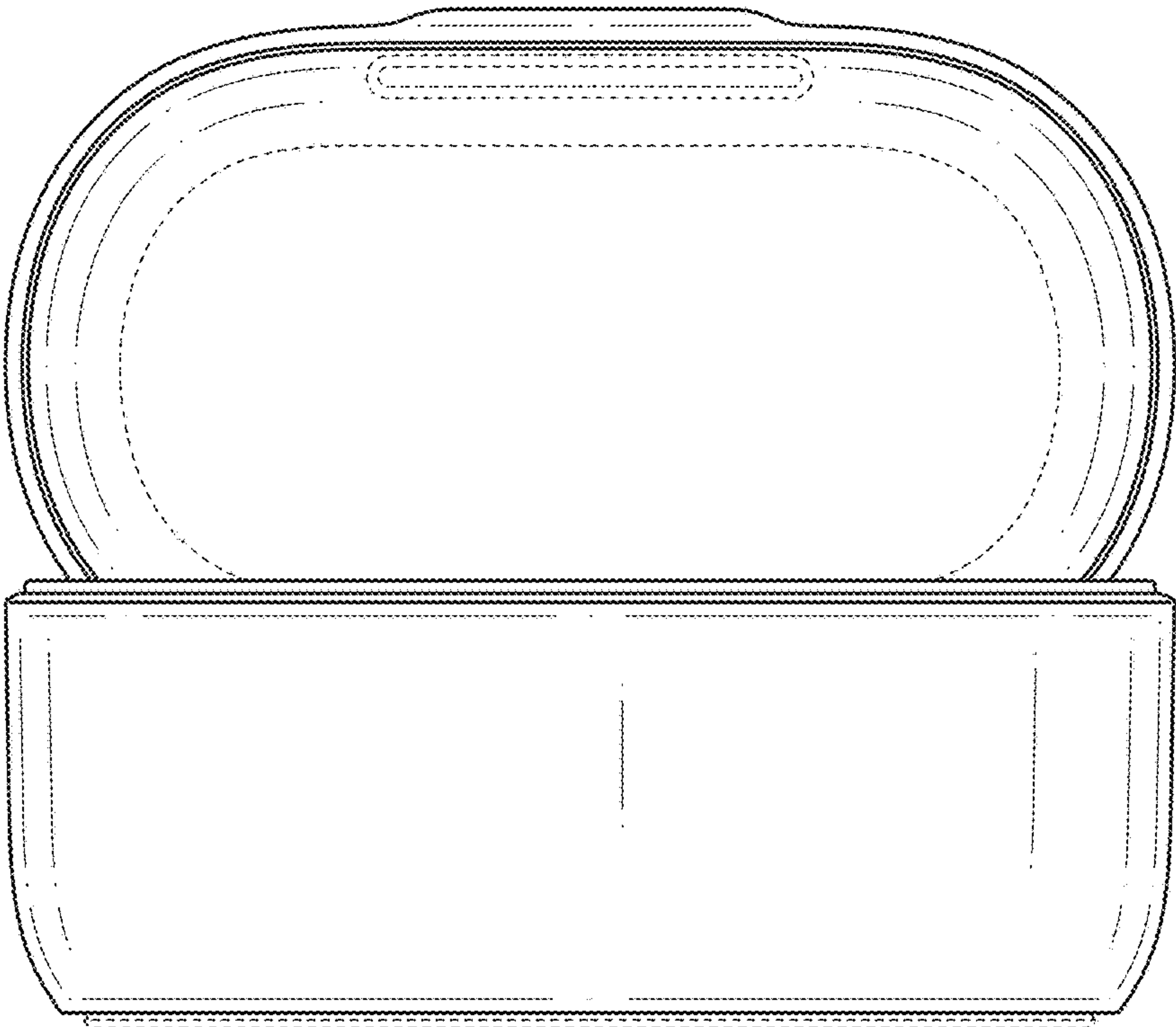

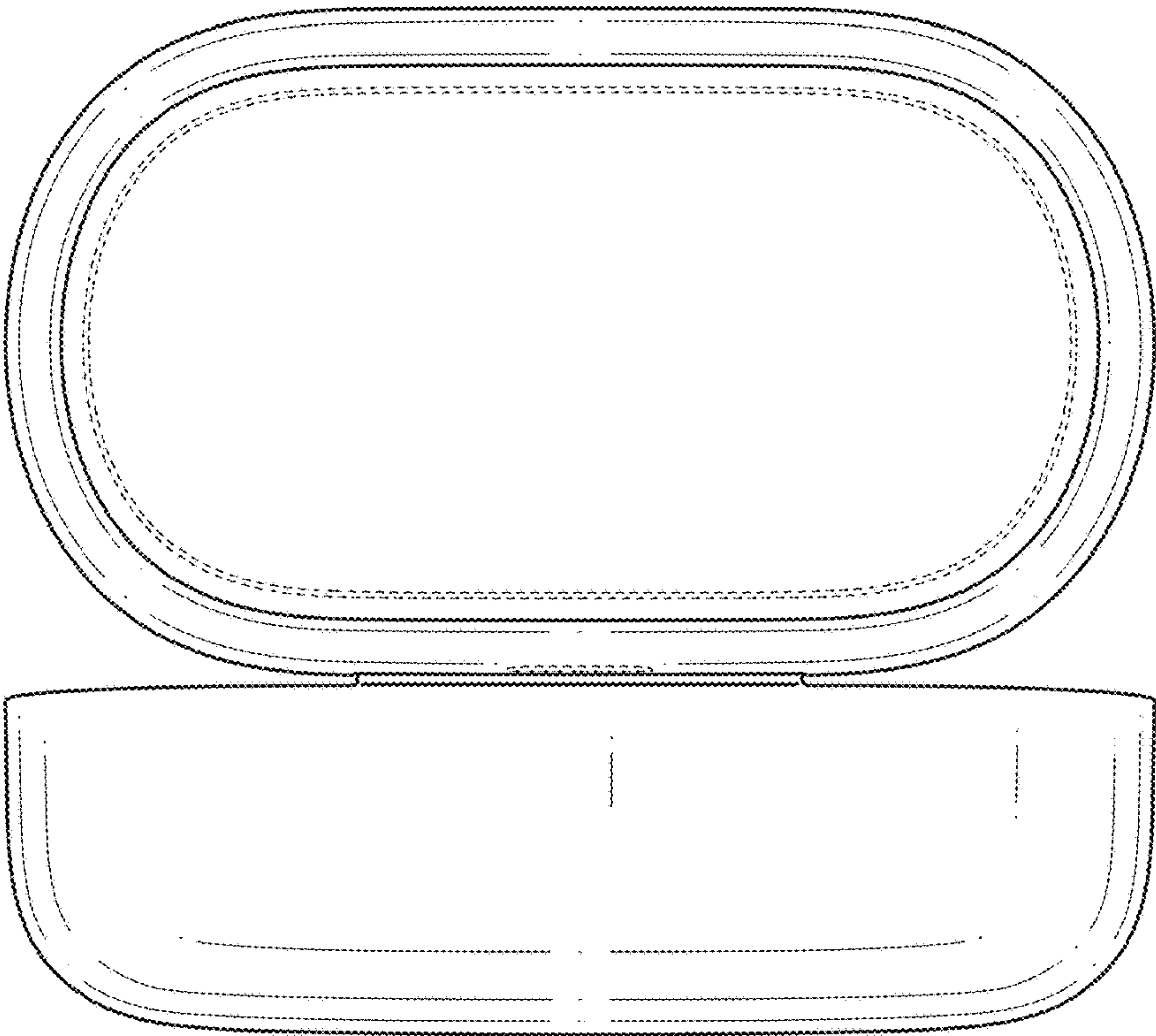

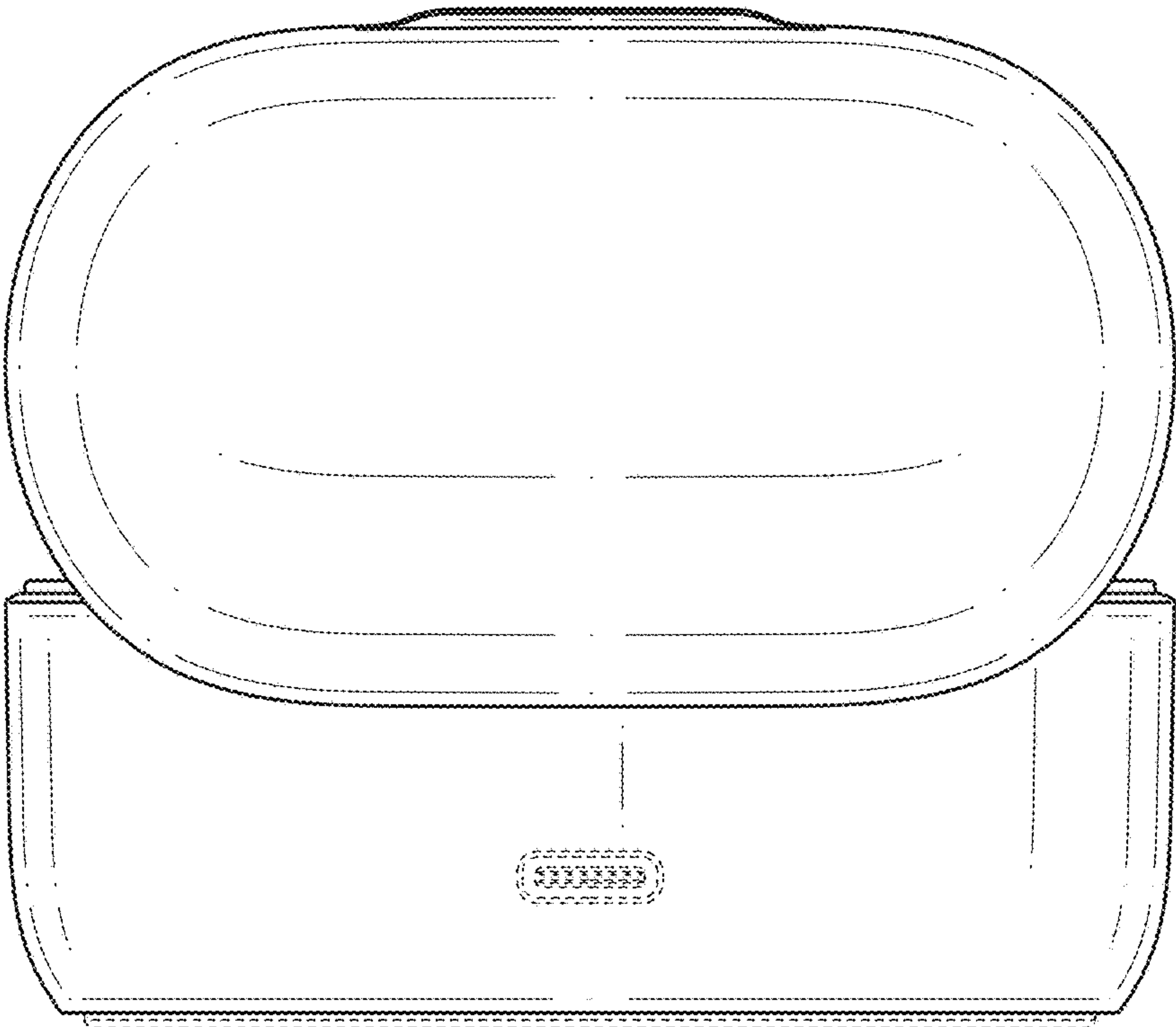

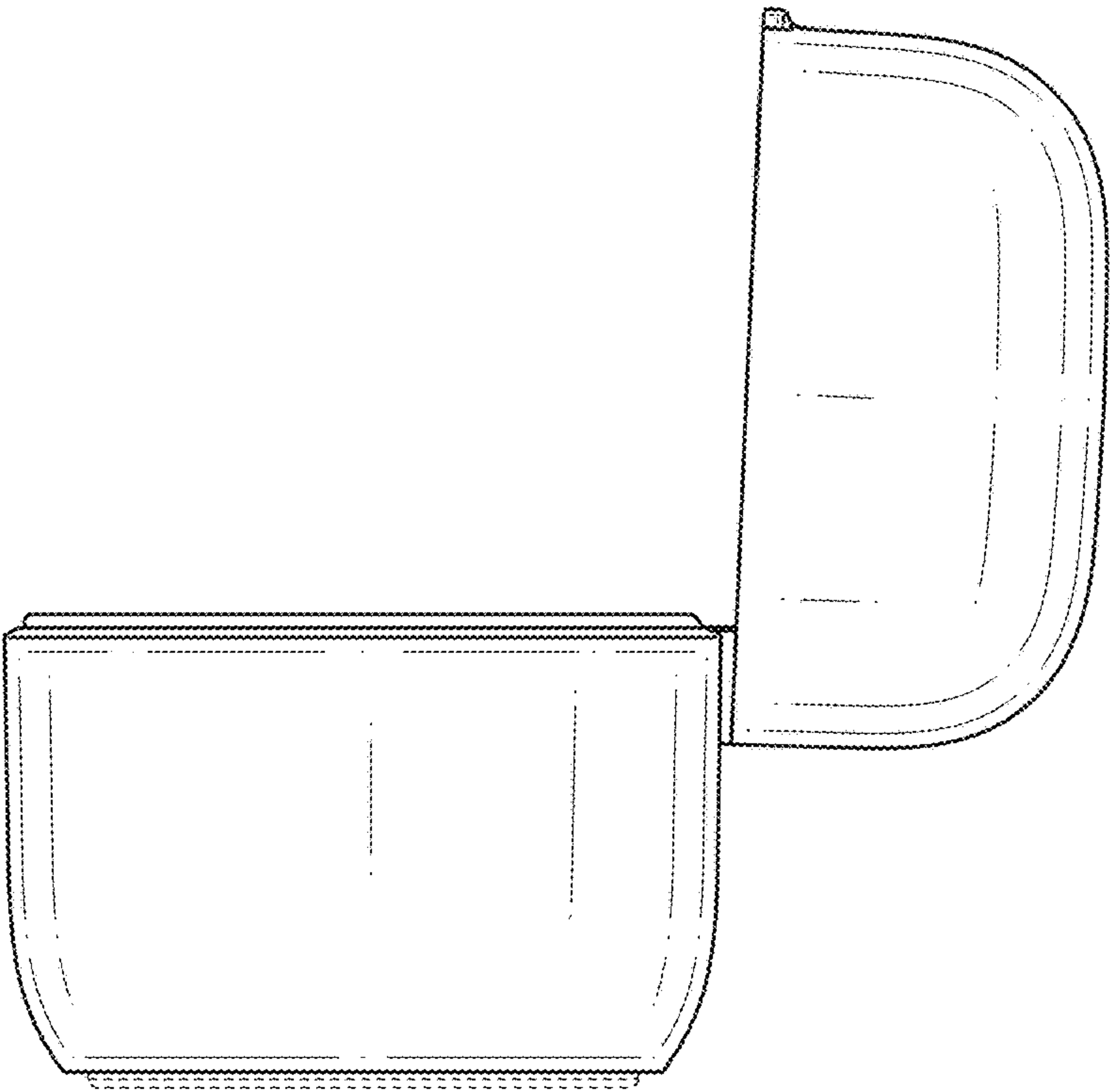

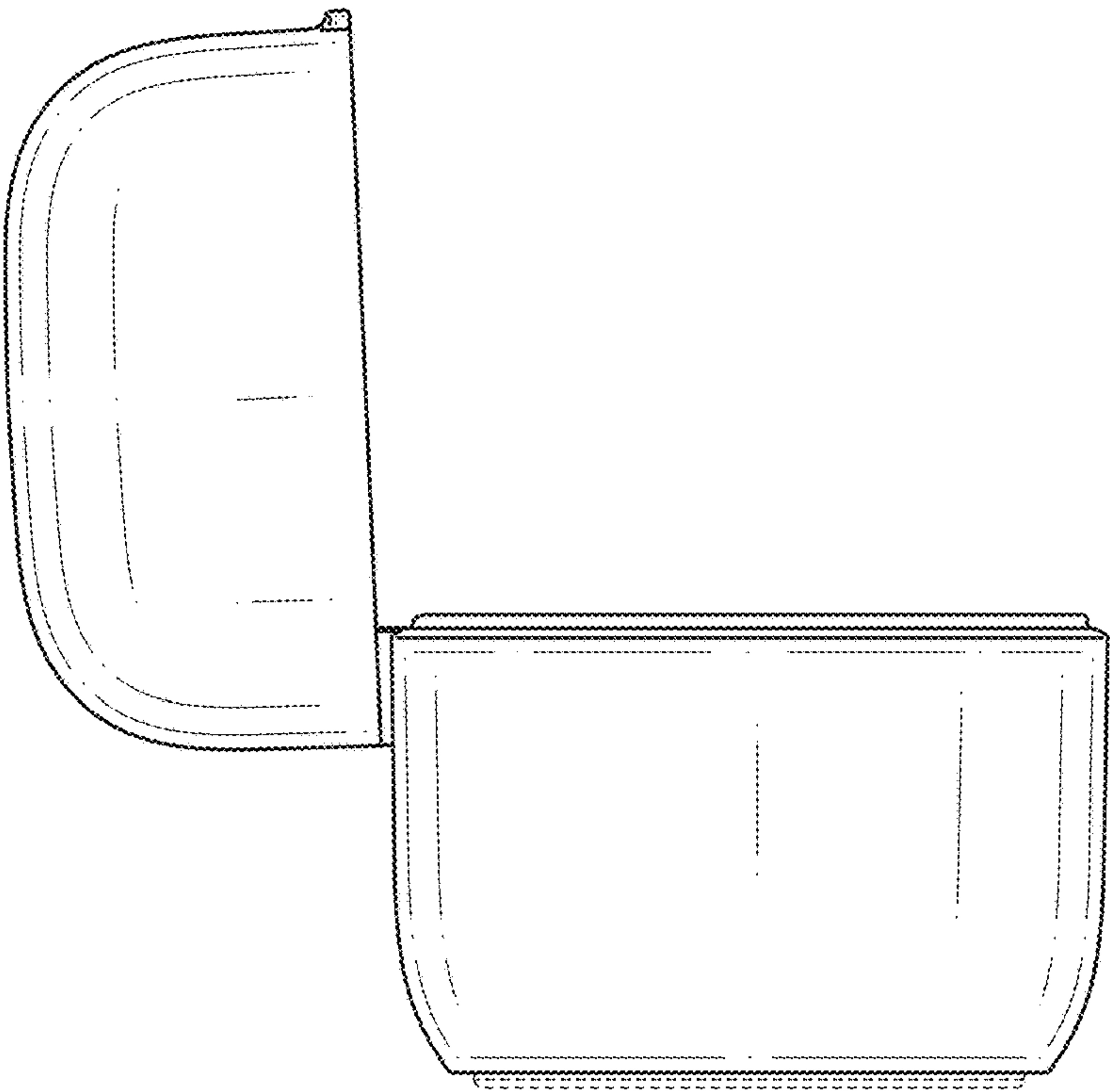
