The ornamental design for a calendar, as shown and described.

DESCRIPTION

FIG. 5 is a front elevational view of the fourth calendar month page.

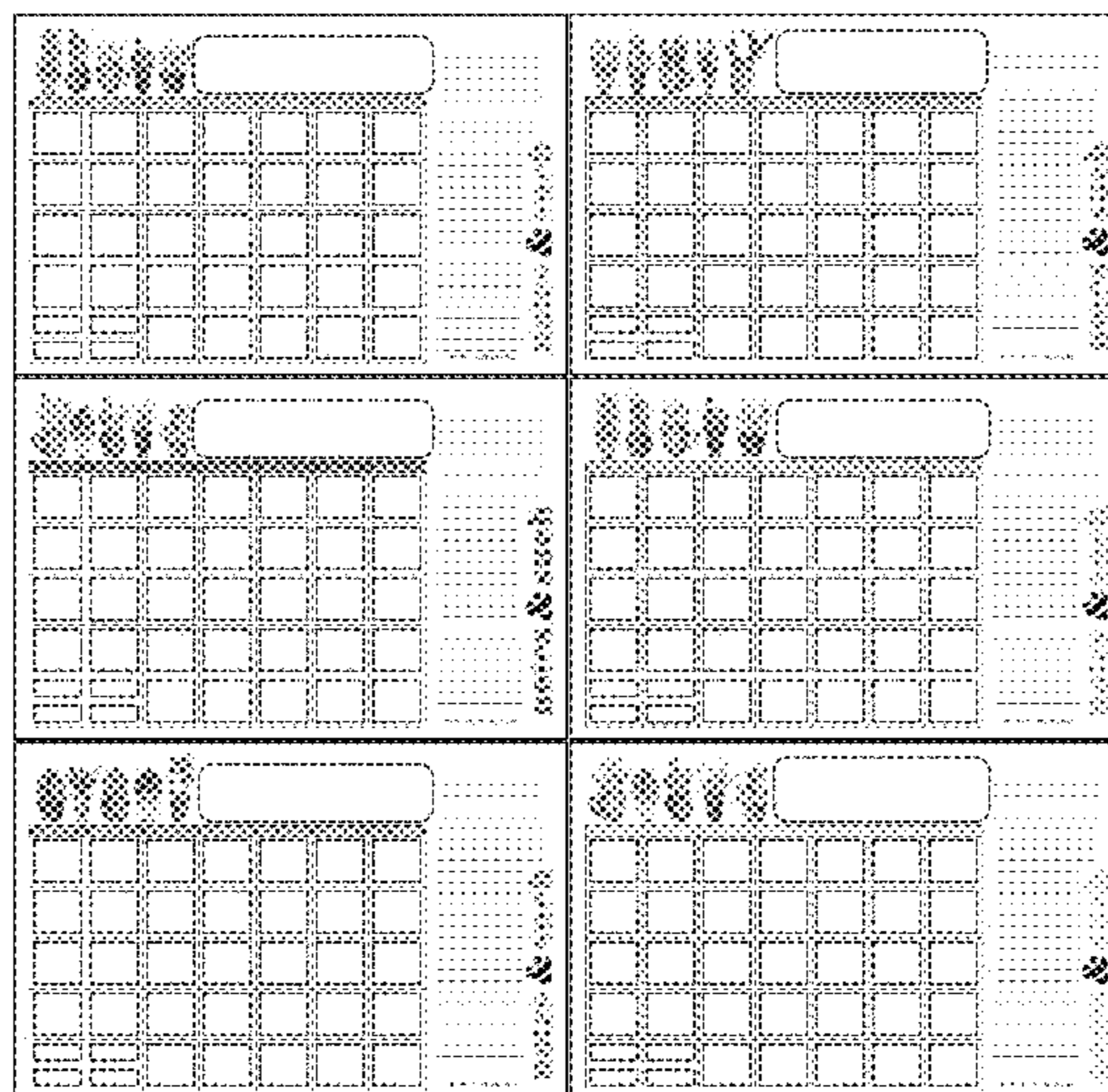
FIG. 6 is a front elevational view of the fifth calendar month page; and,

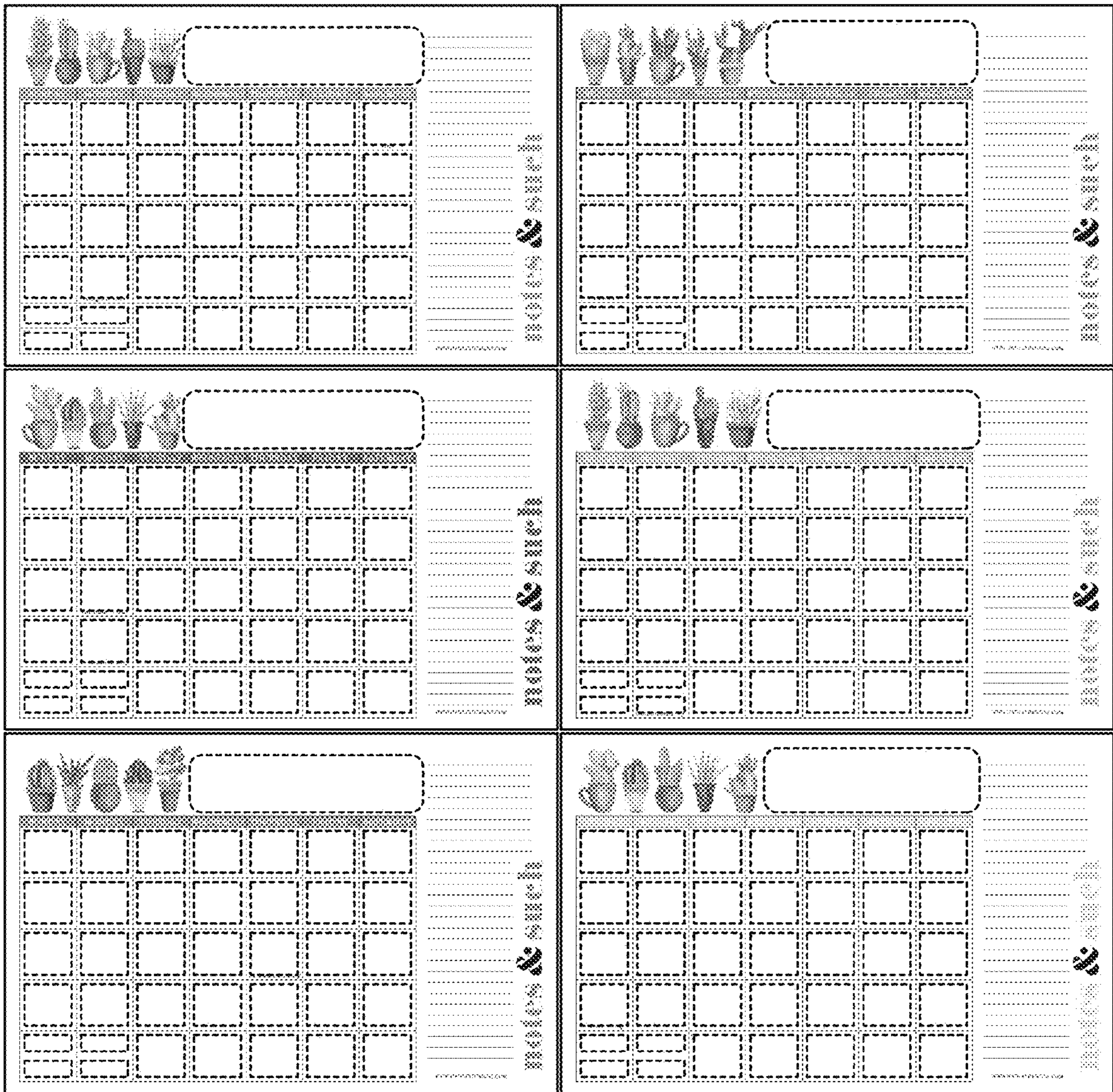

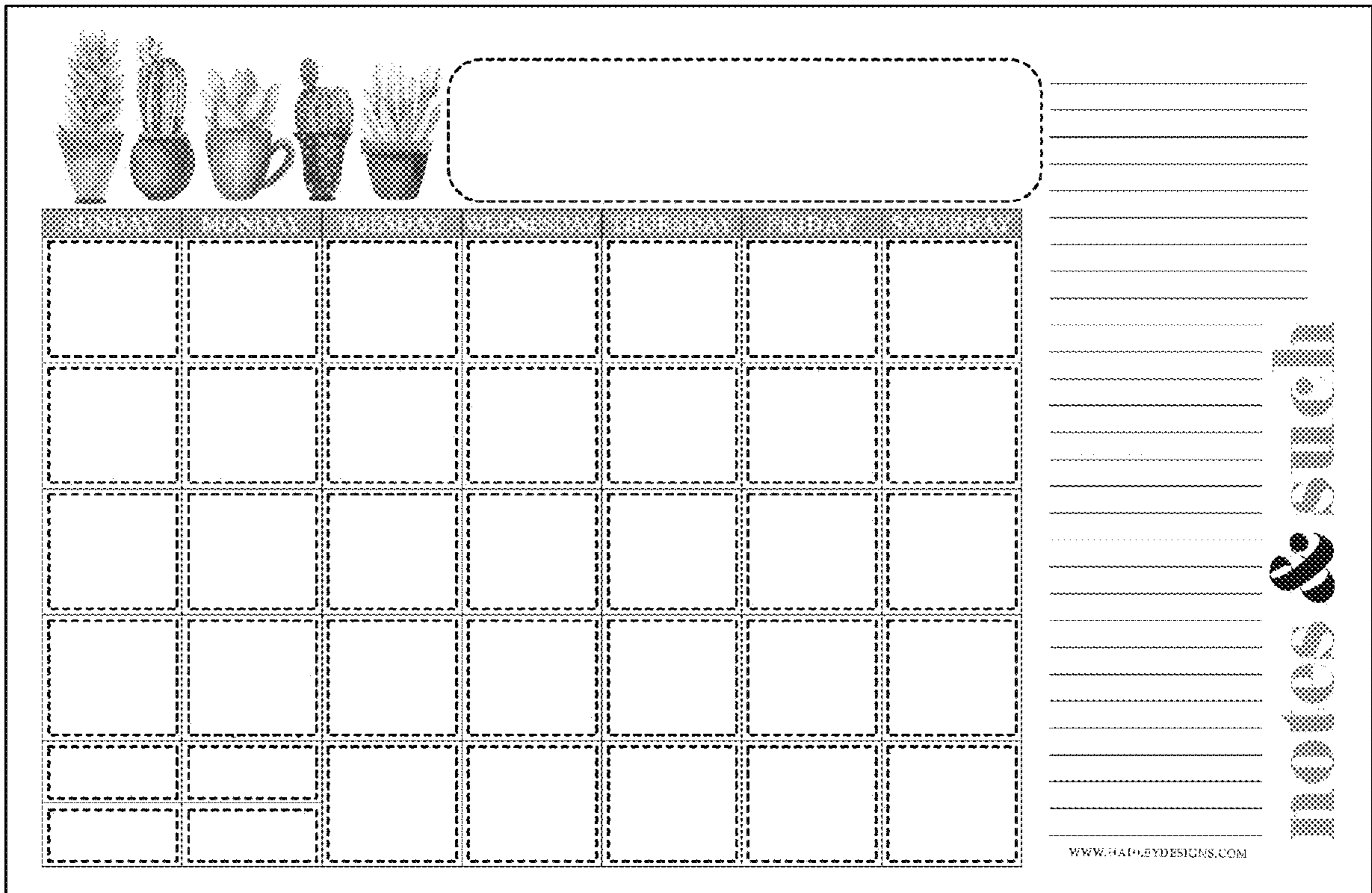

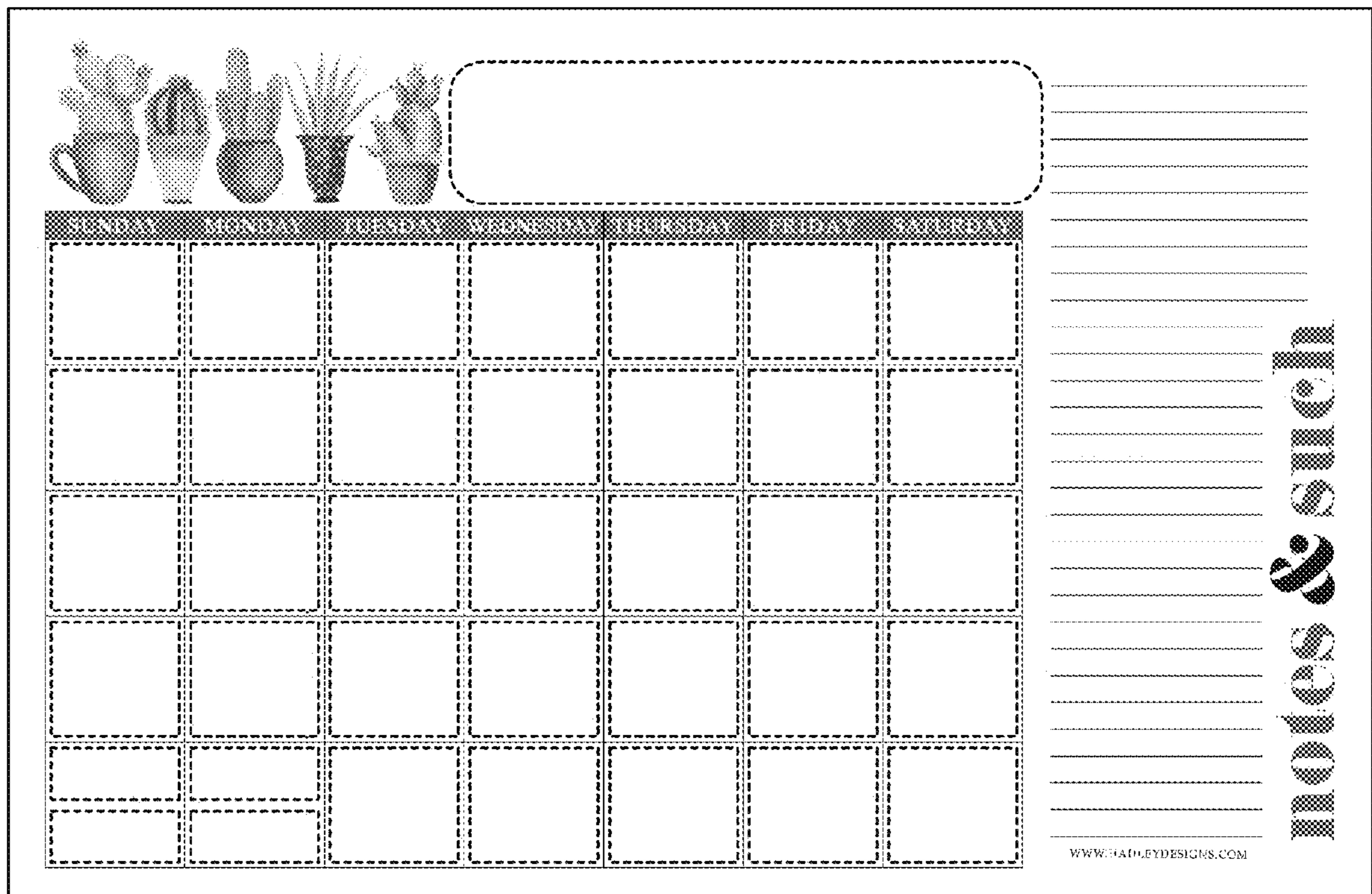

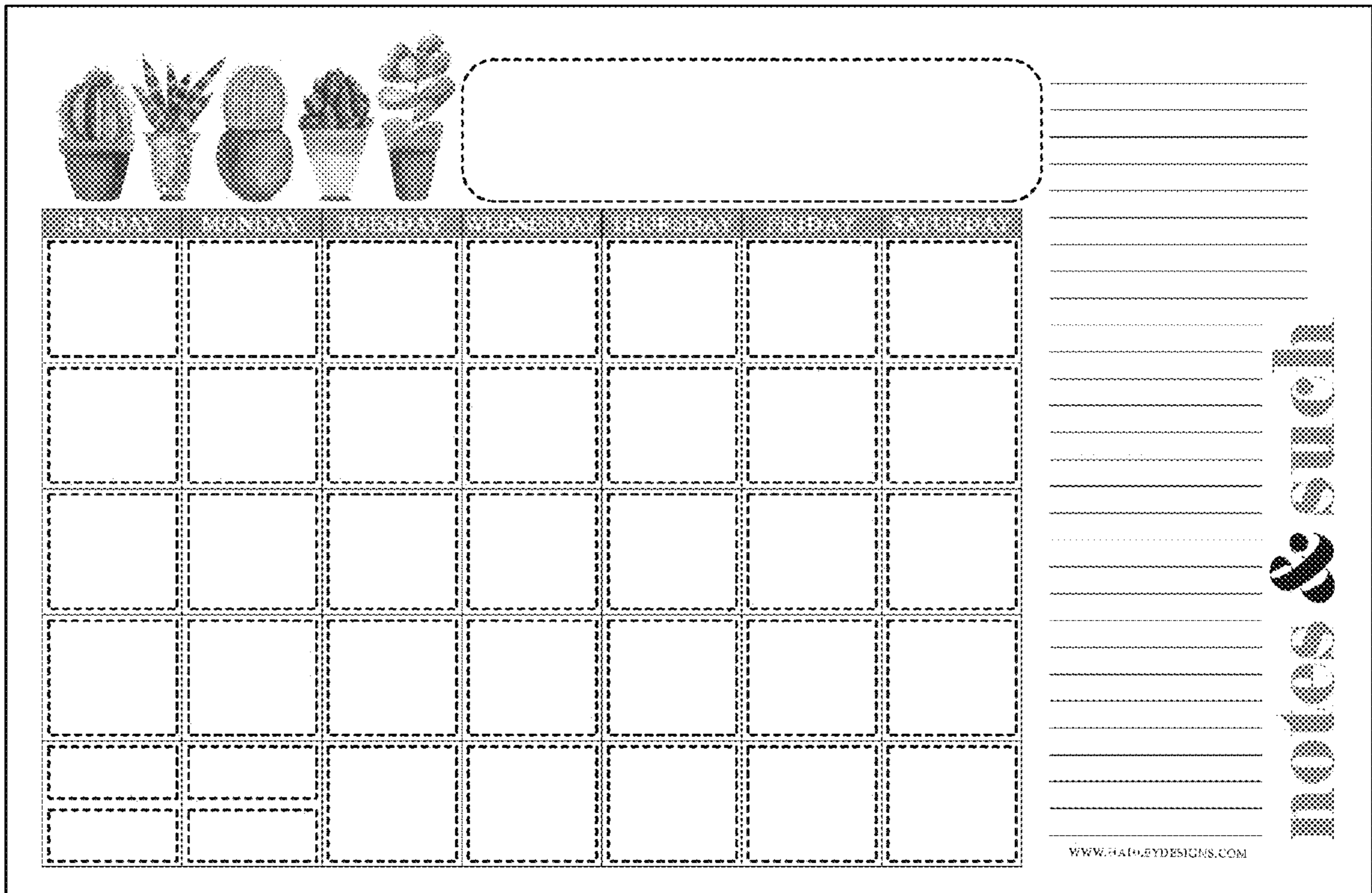

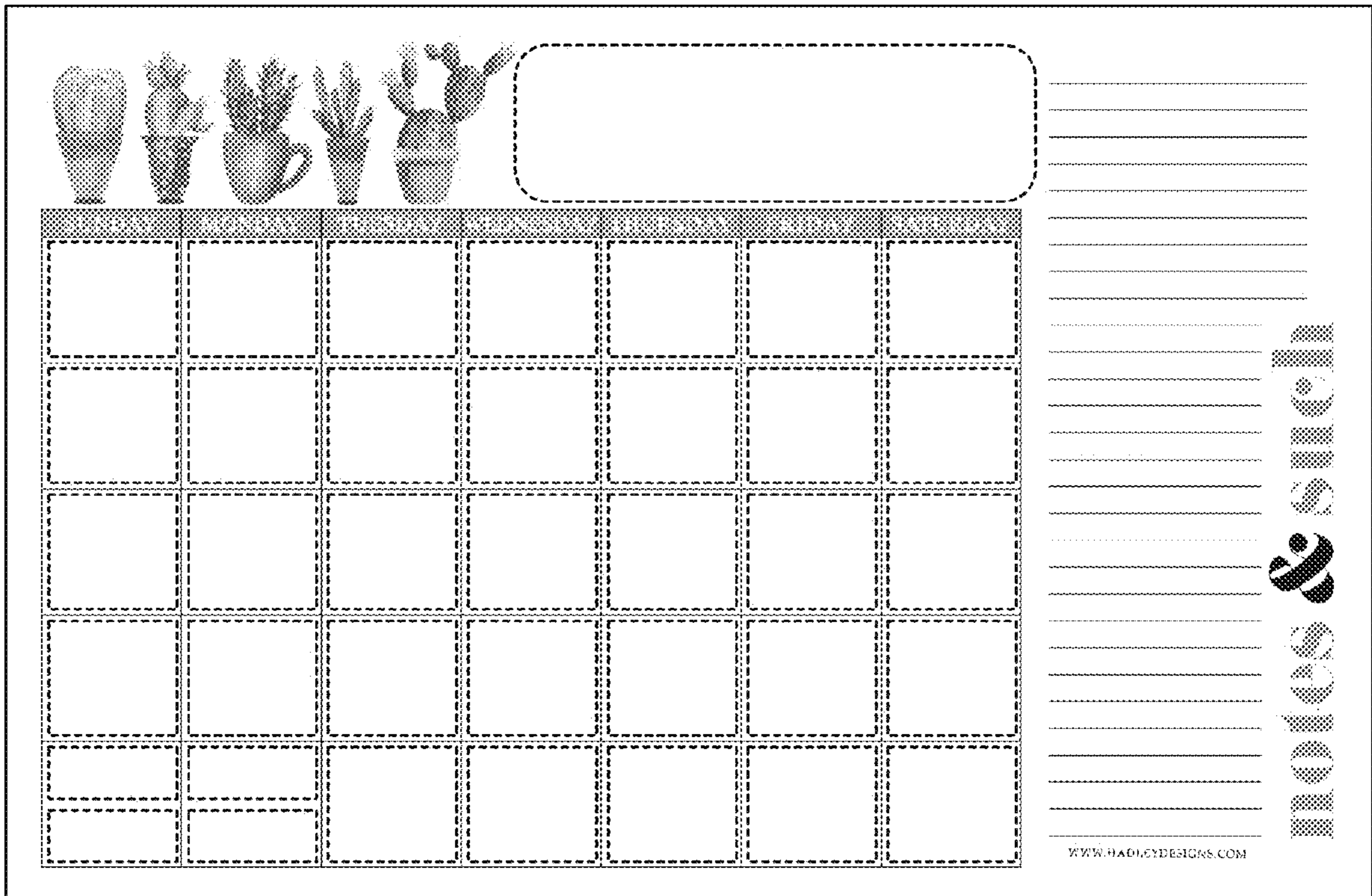

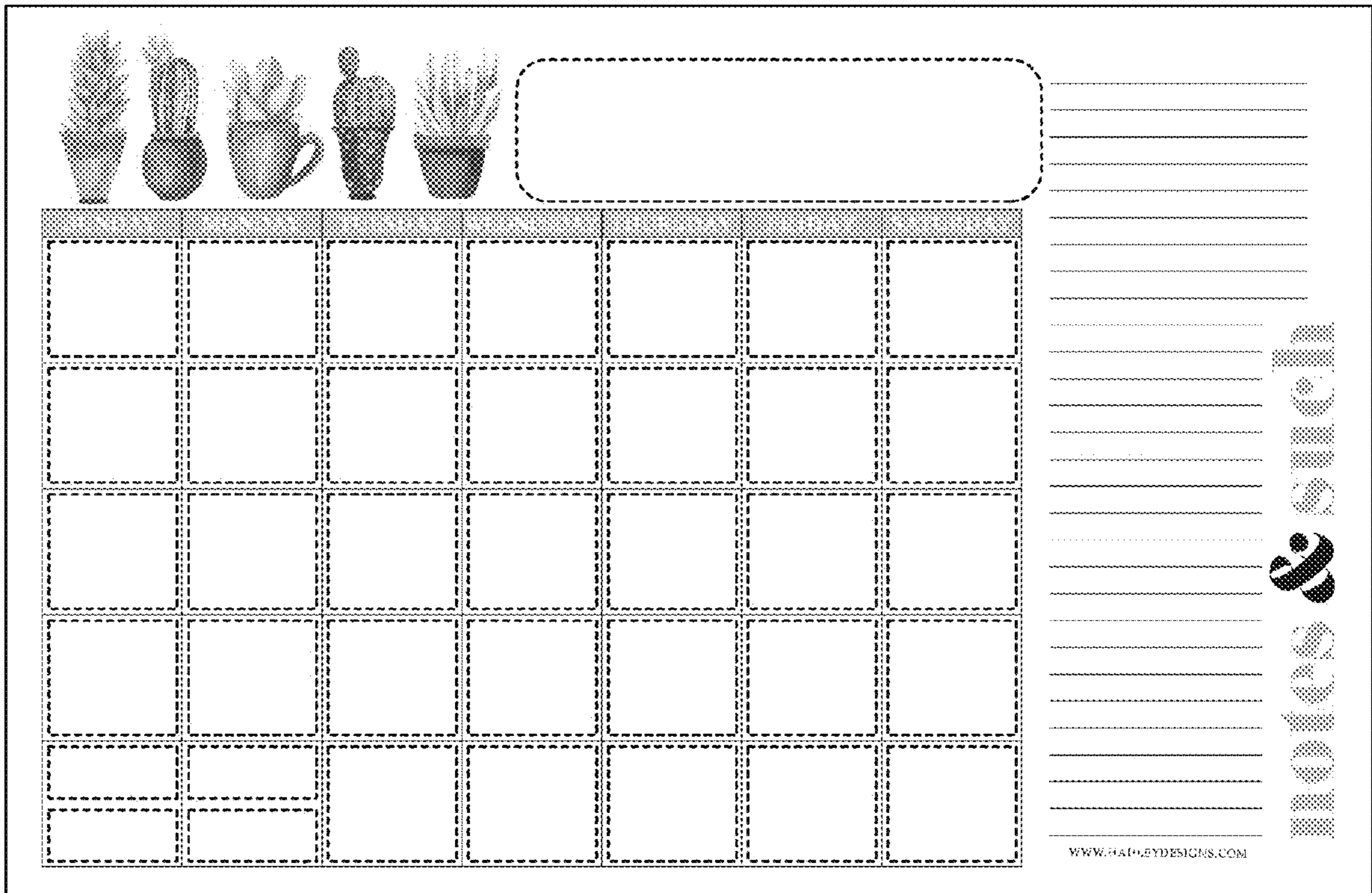

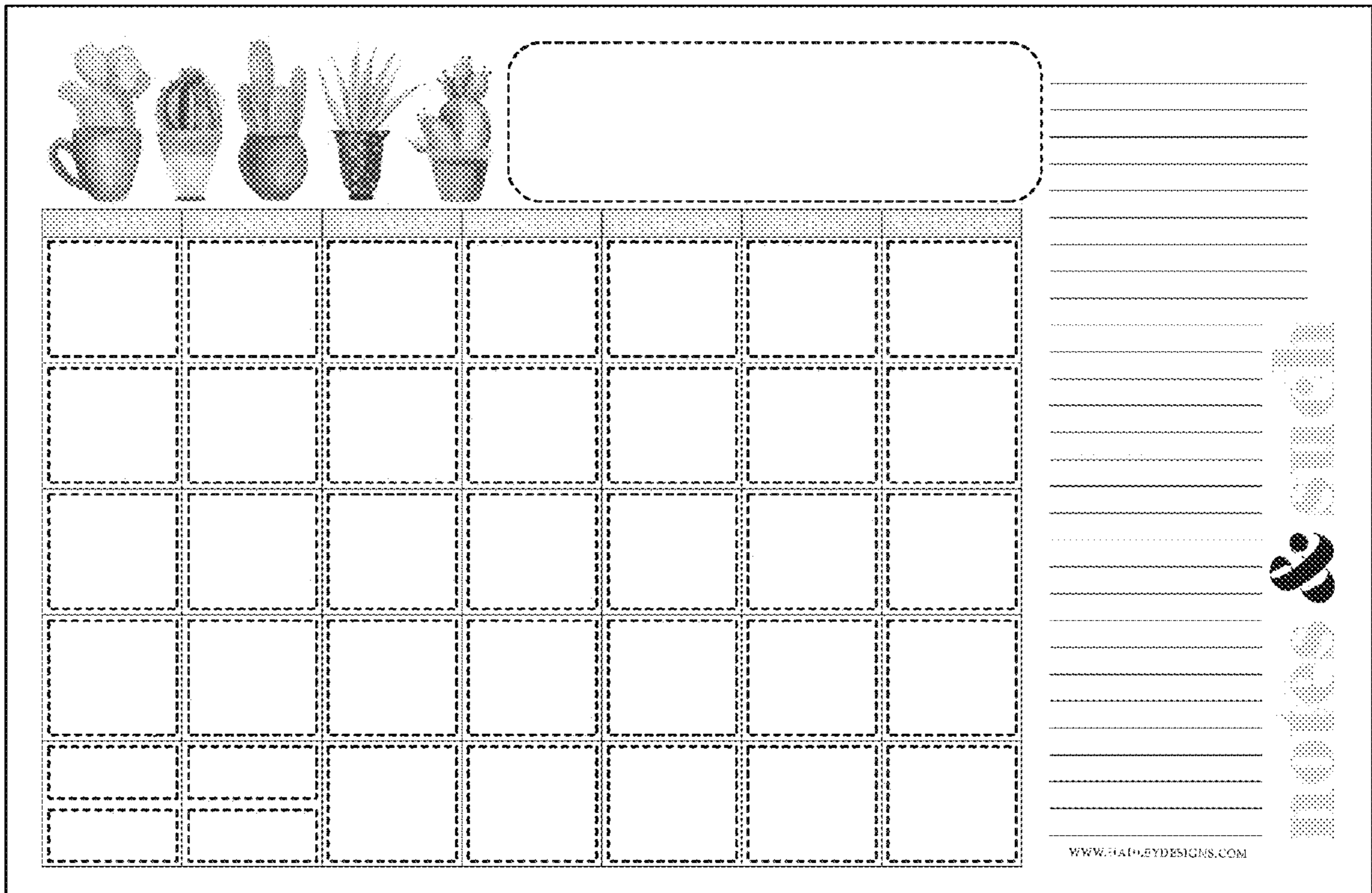
