**DESCRIPTION**

FIG. 7 is a front elevational view of the sixth sticker of the milestone sticker set, isolated for clarity of disclosure.

FIG. 8 is a front elevational view of the seventh sticker of the milestone sticker set, isolated for clarity of disclosure.

FIG. 9 is a front elevational view of the eighth sticker of the milestone sticker set, isolated for clarity of disclosure.

FIG. 10 is a front elevational view of the ninth sticker of the milestone sticker set, isolated for clarity of disclosure.

FIG. 11 is a front elevational view of the tenth sticker of the milestone sticker set, isolated for clarity of disclosure.

FIG. 12 is a front elevational view of the eleventh sticker of the milestone sticker set, isolated for clarity of disclosure; and,

FIG. 13 is a front elevational view of the twelfth sticker of the milestone sticker set, isolated for clarity of disclosure.

The design of each milestone sticker of the milestone sticker set is printed on flat material with no substantial thickness.
