FIG. 6

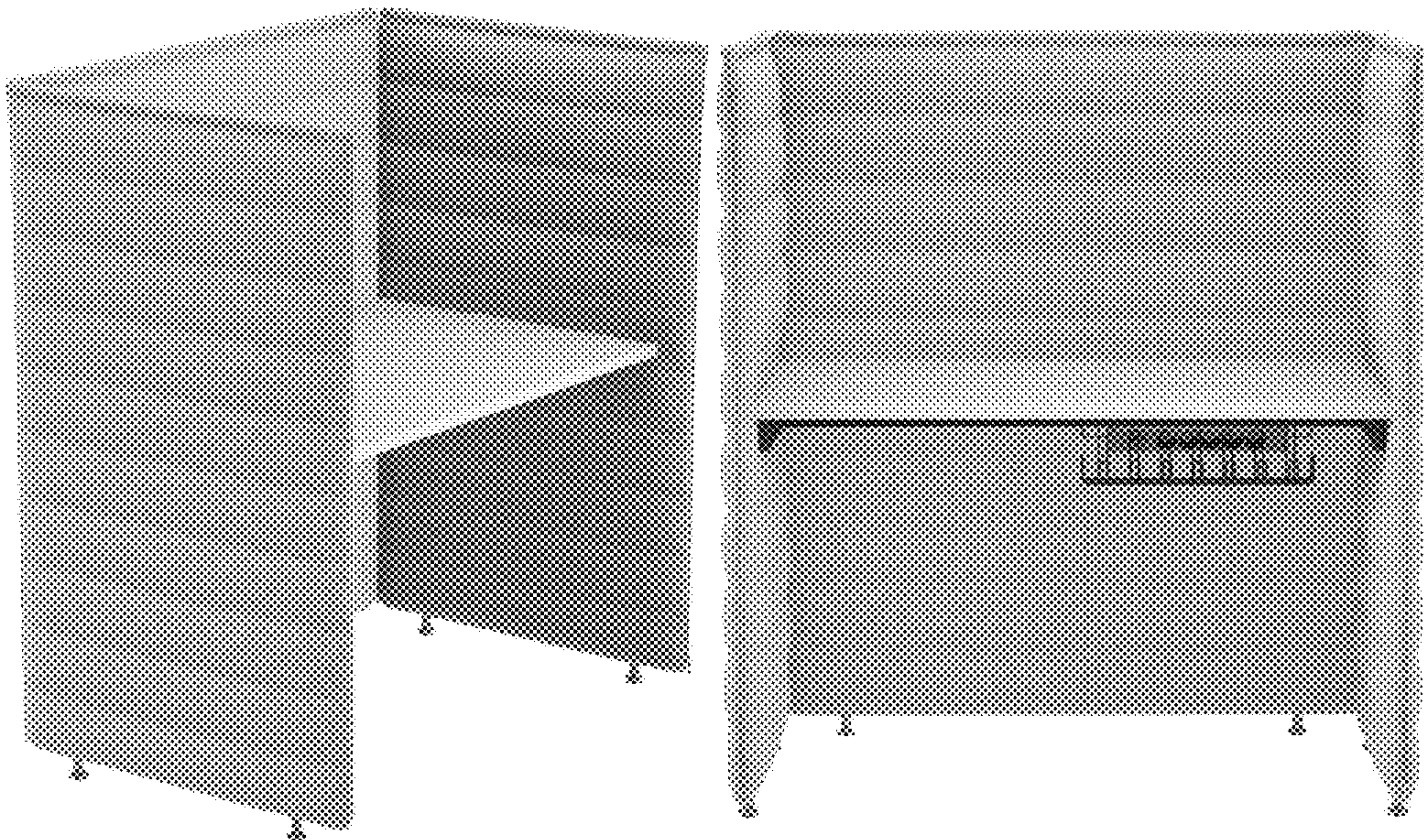
is a top view thereof; and,

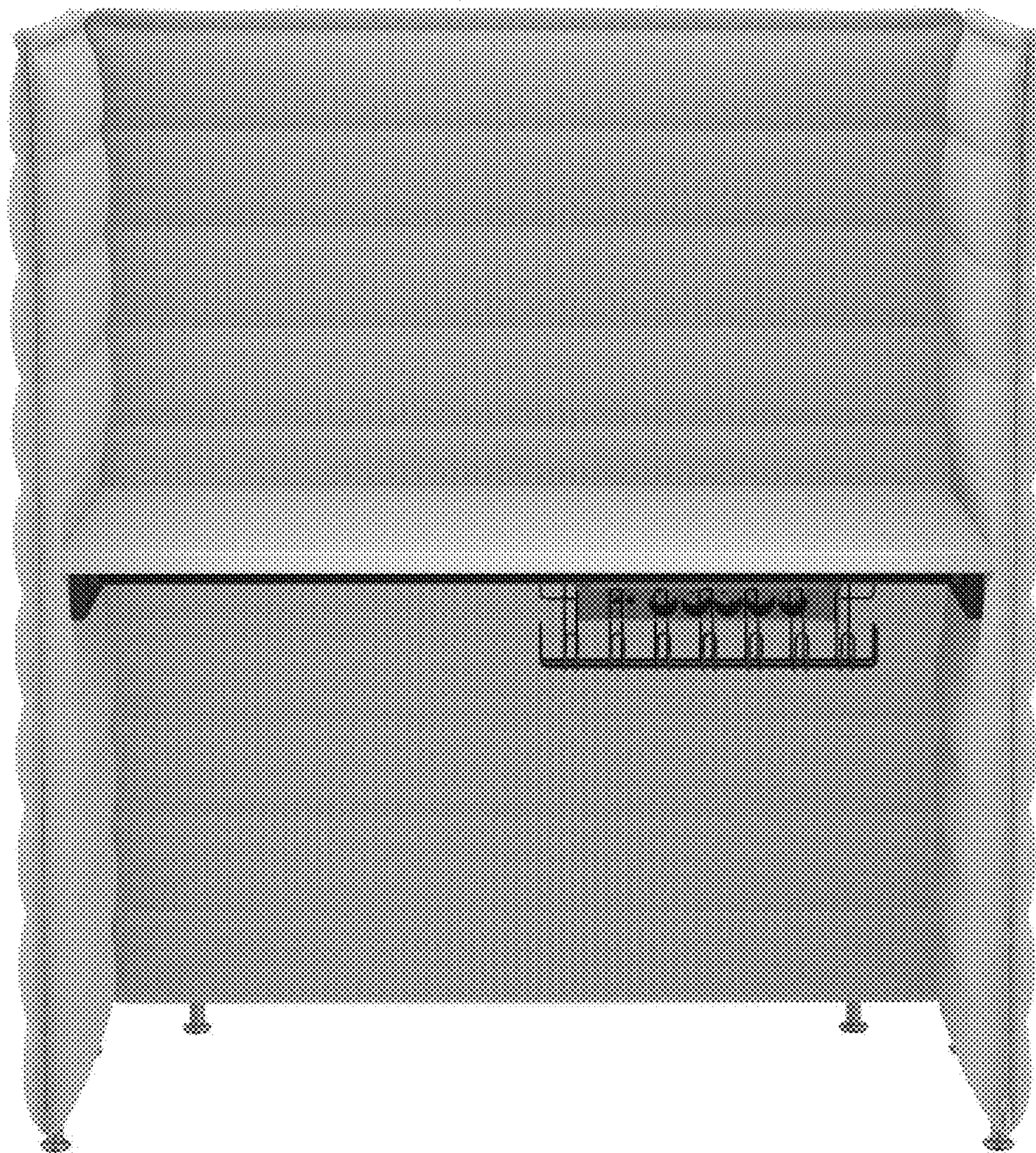

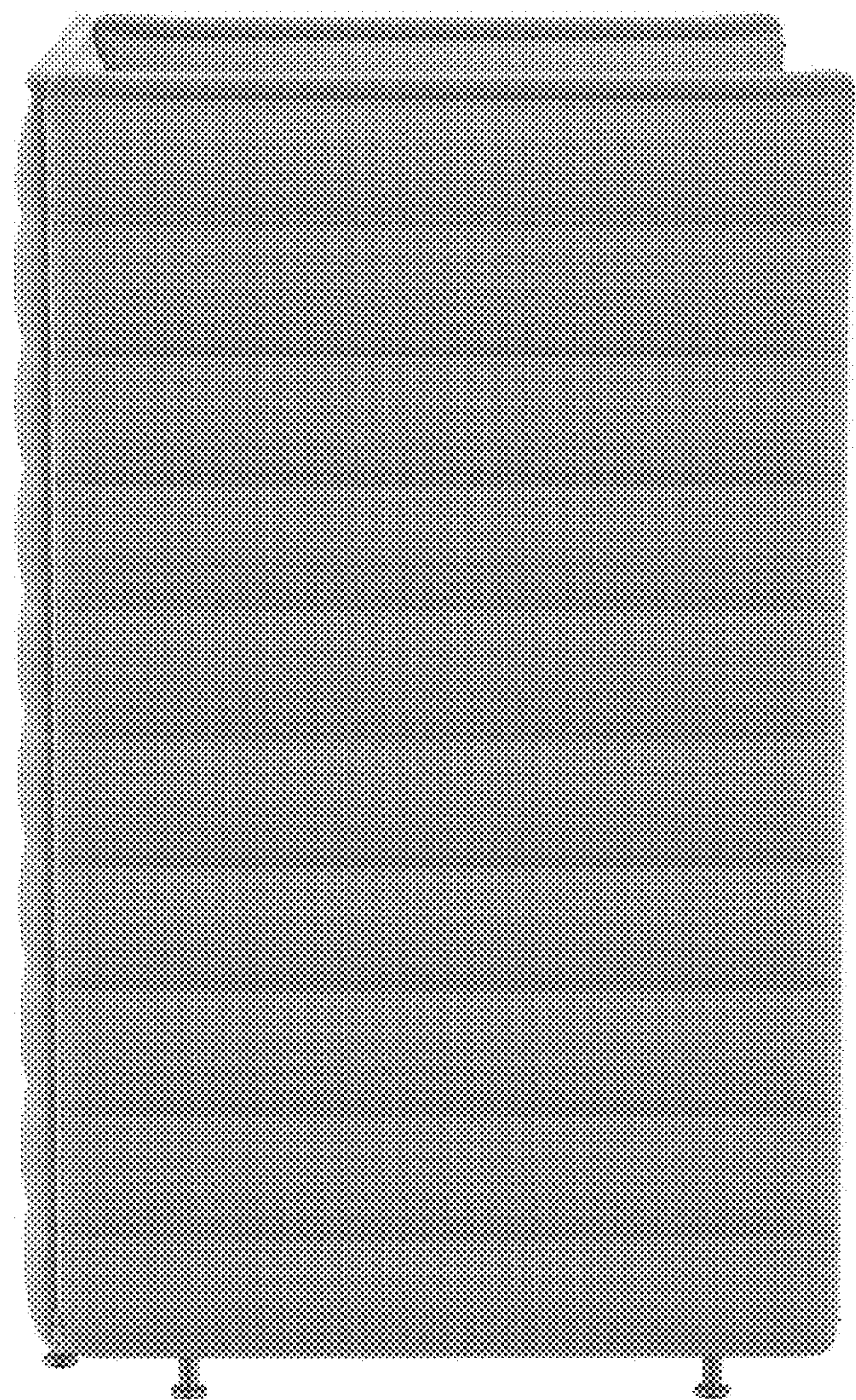

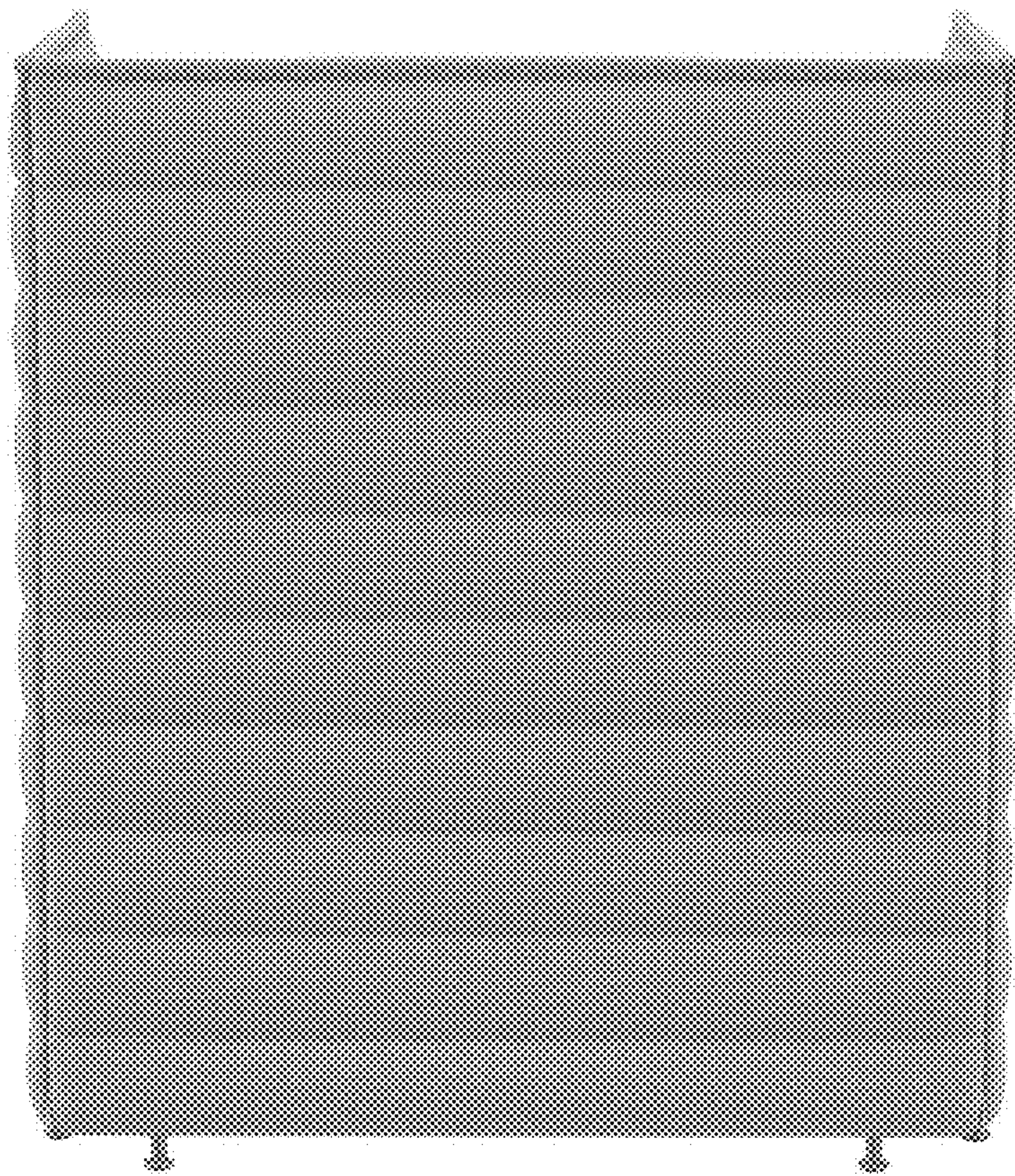

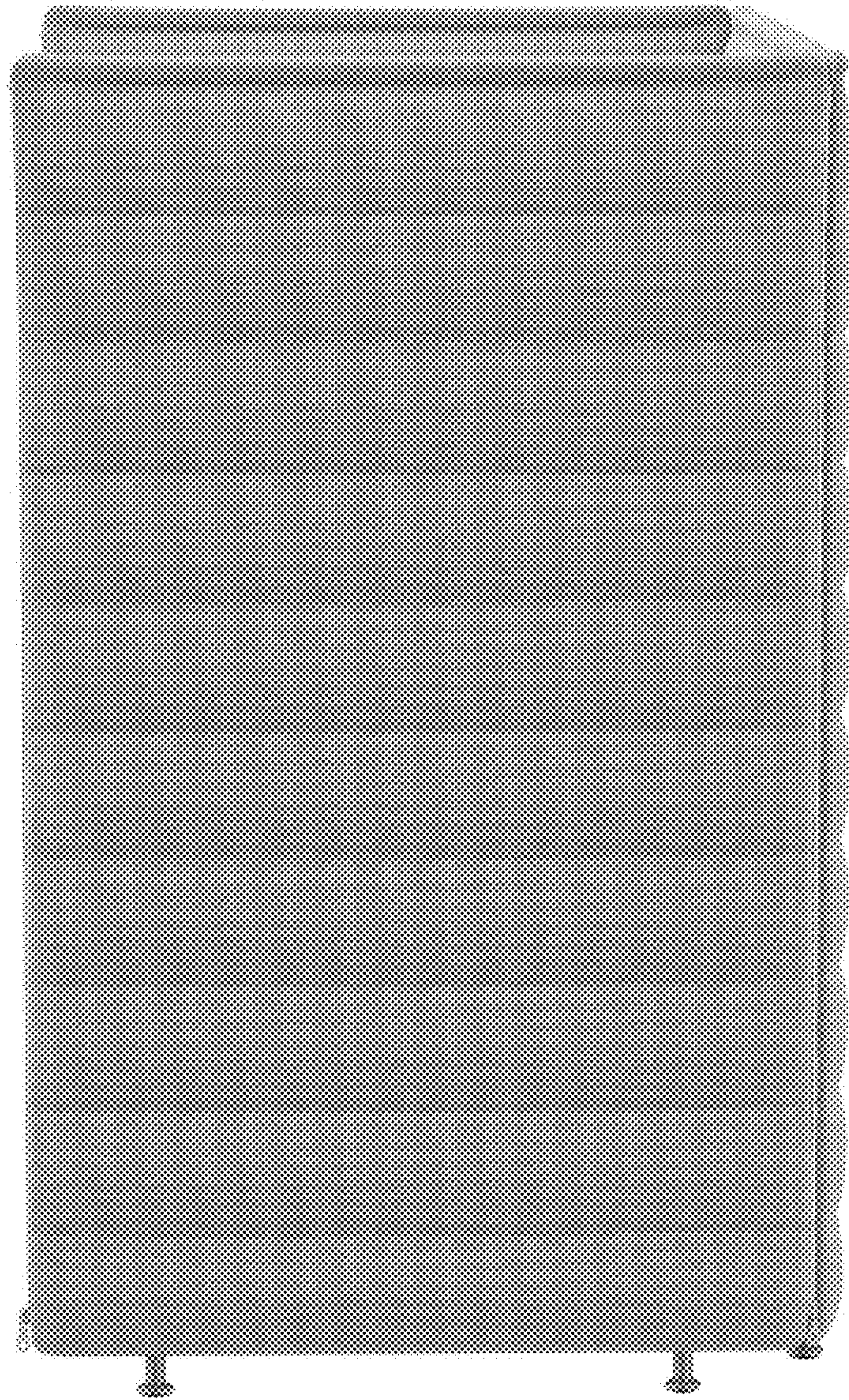

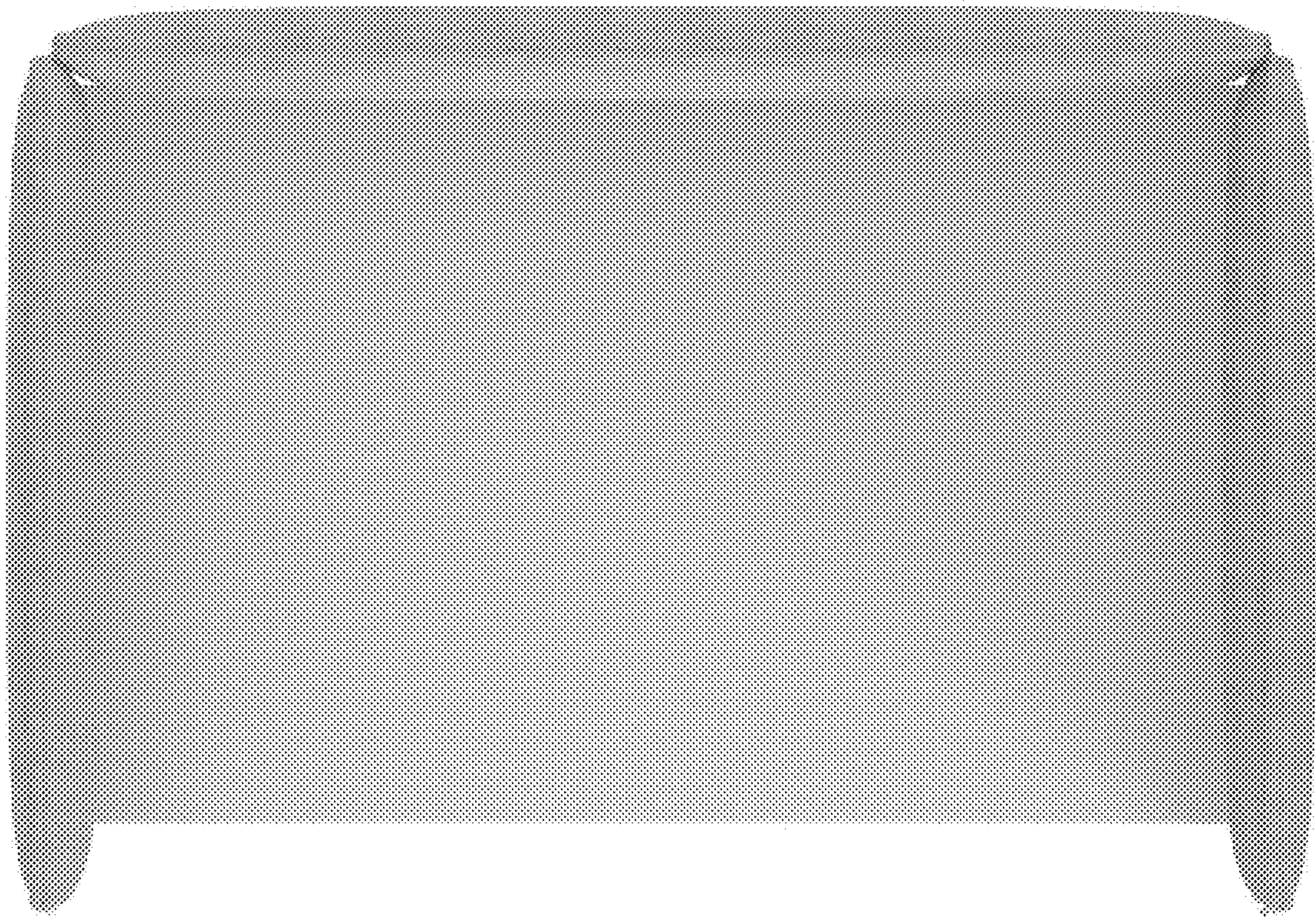

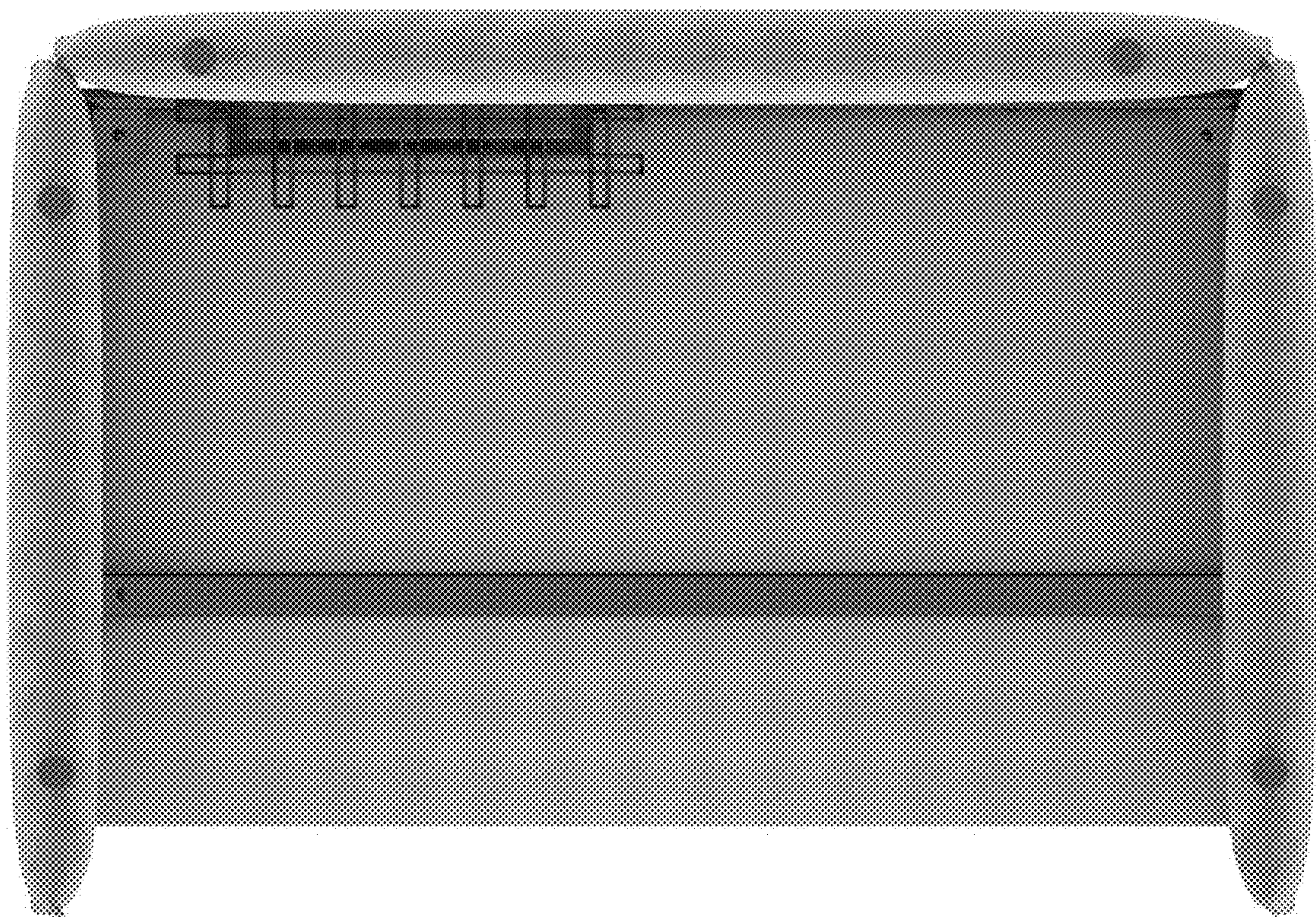
