claimed design.

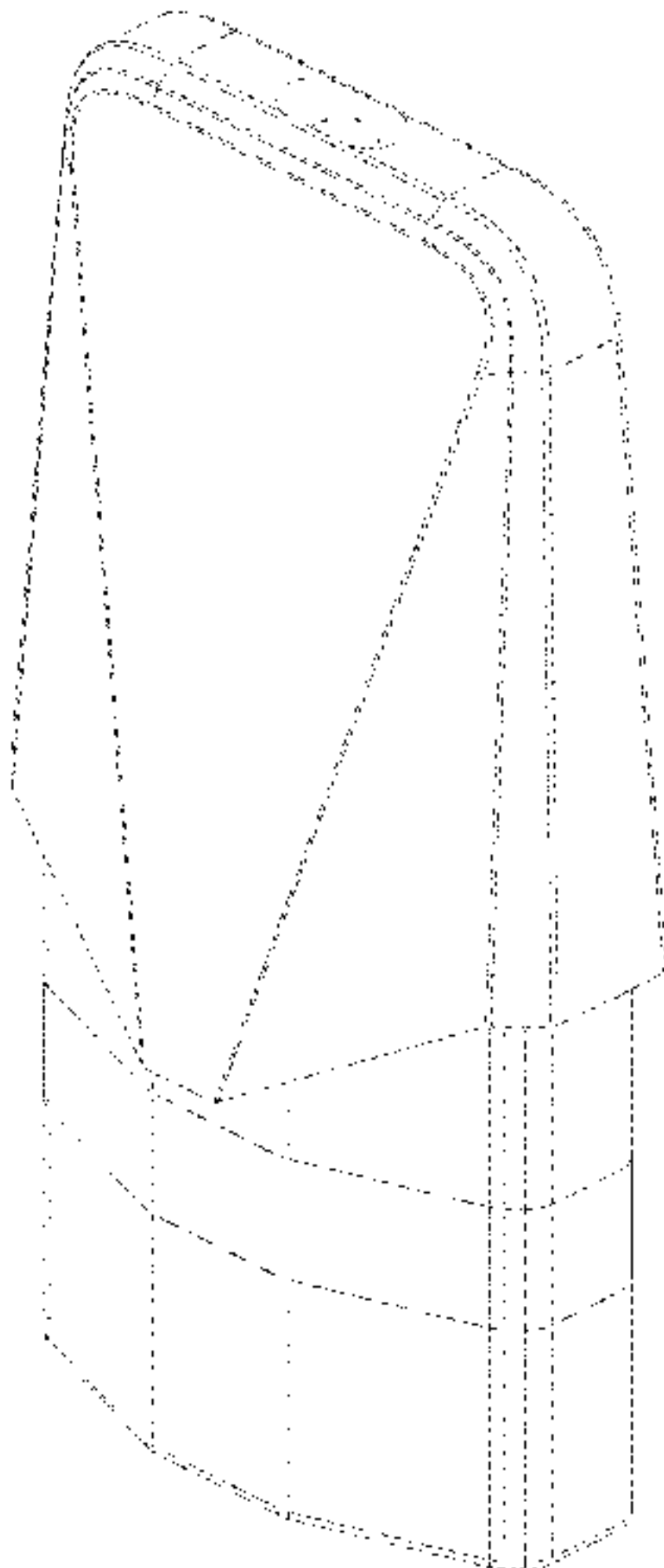

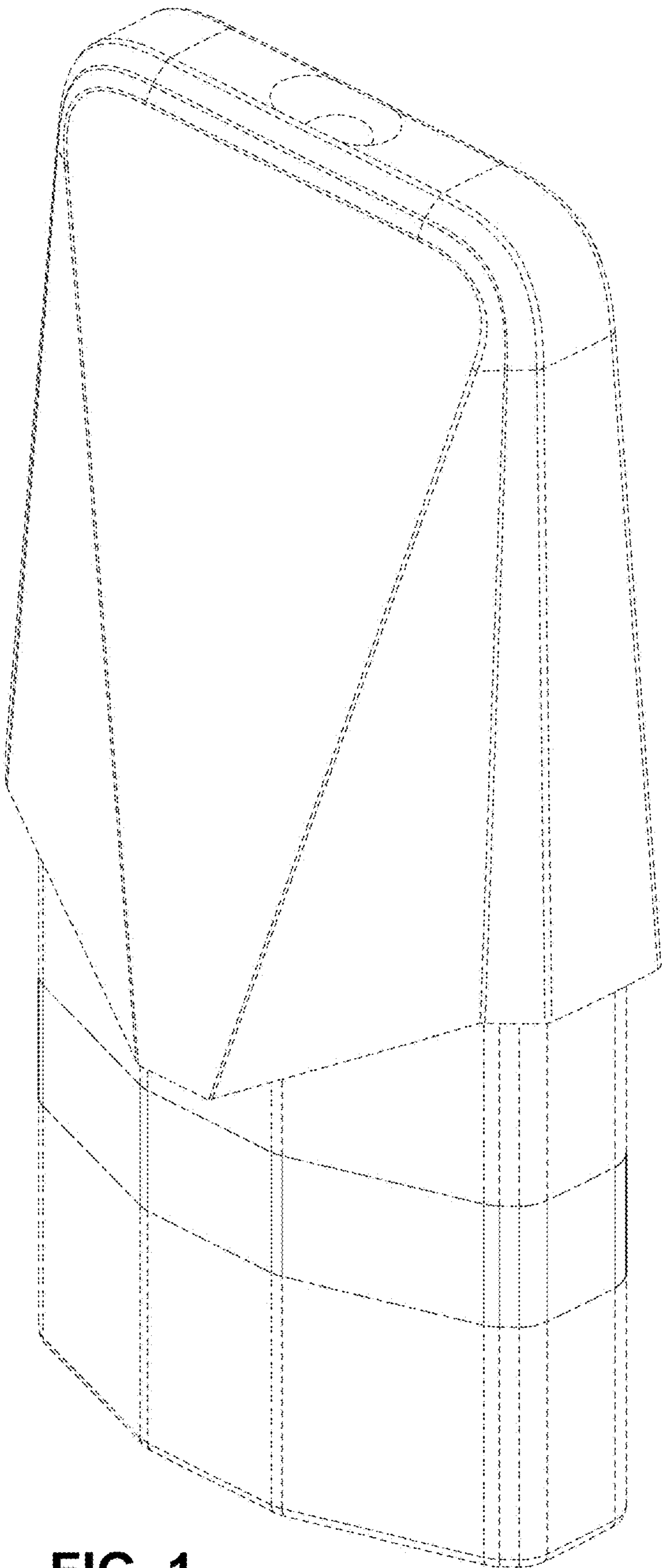

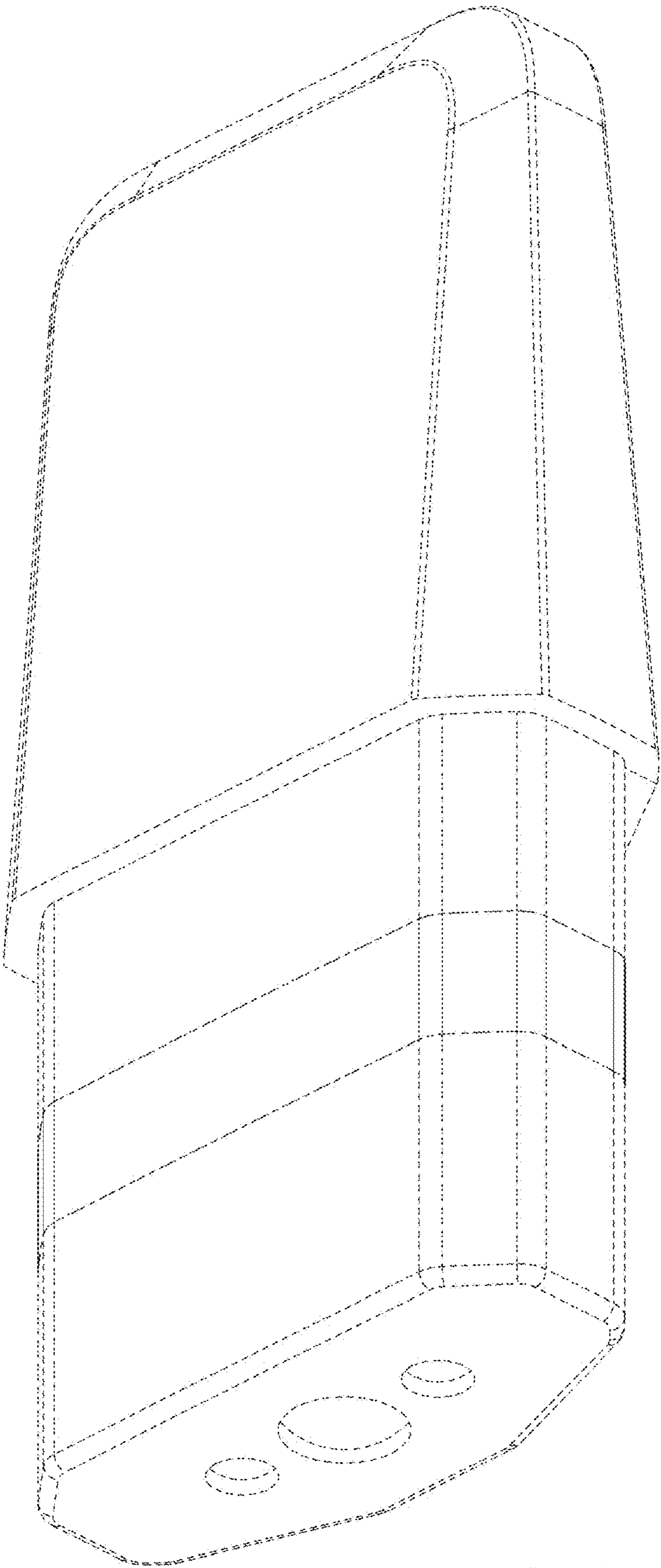

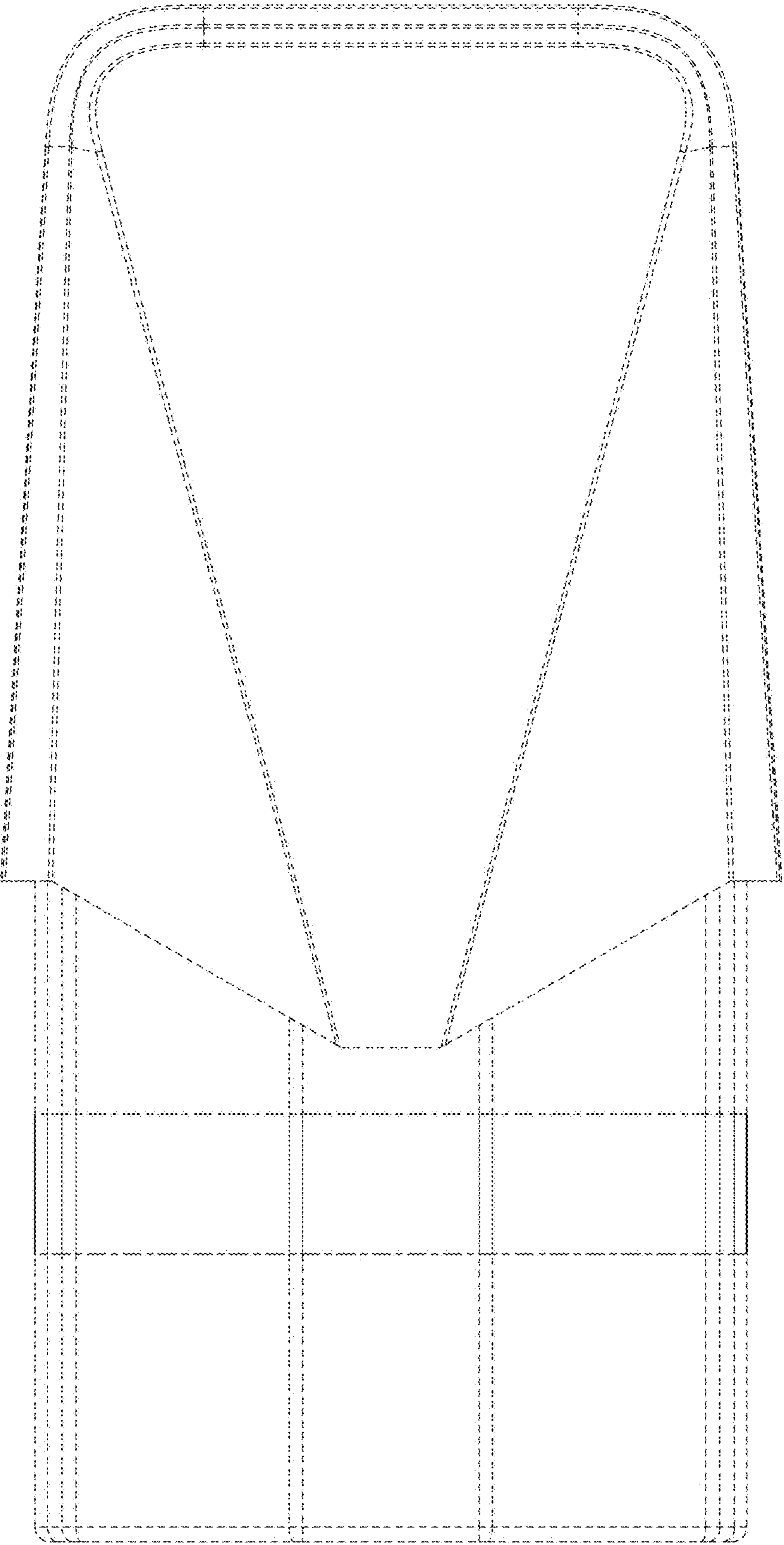

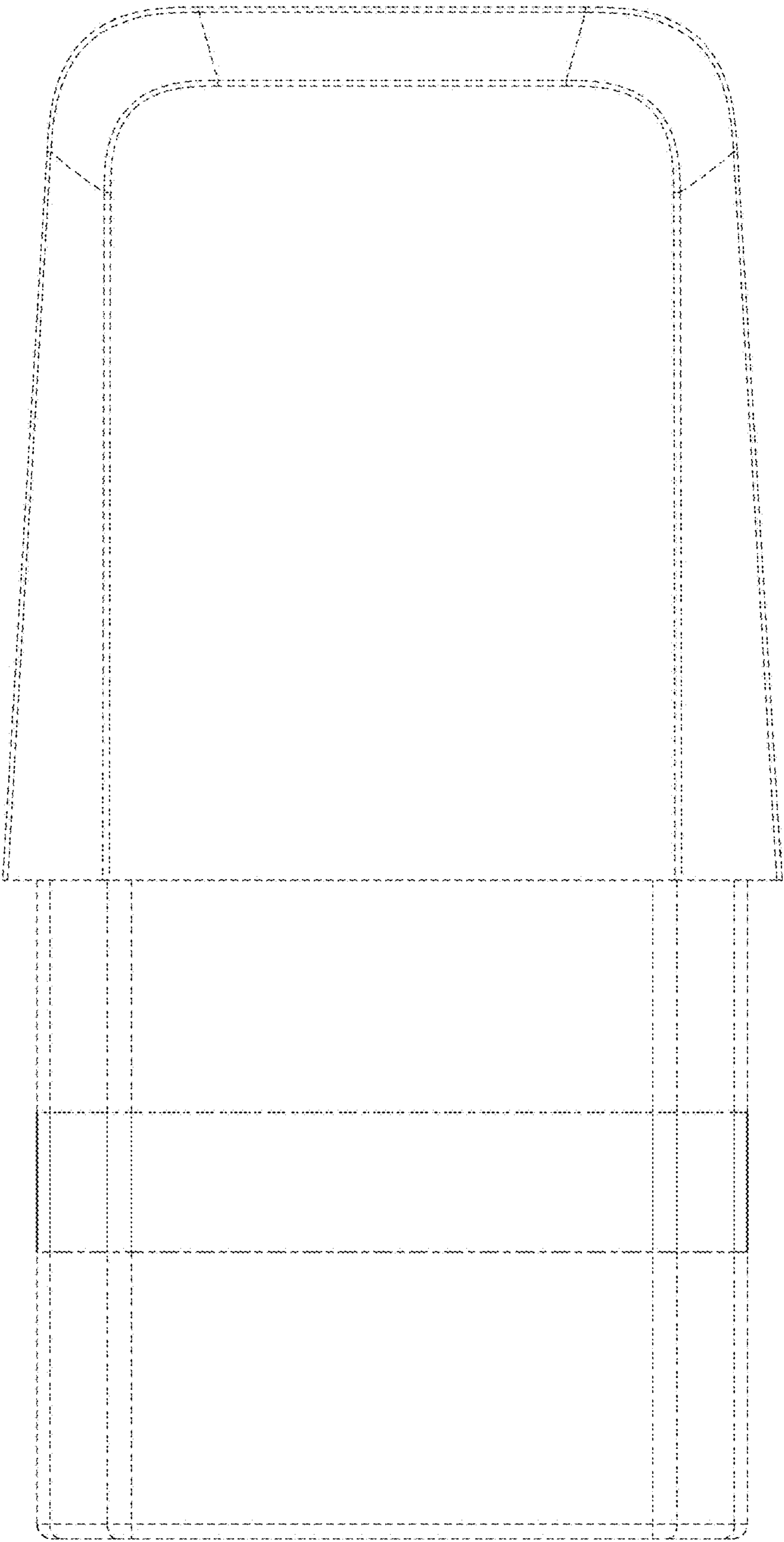

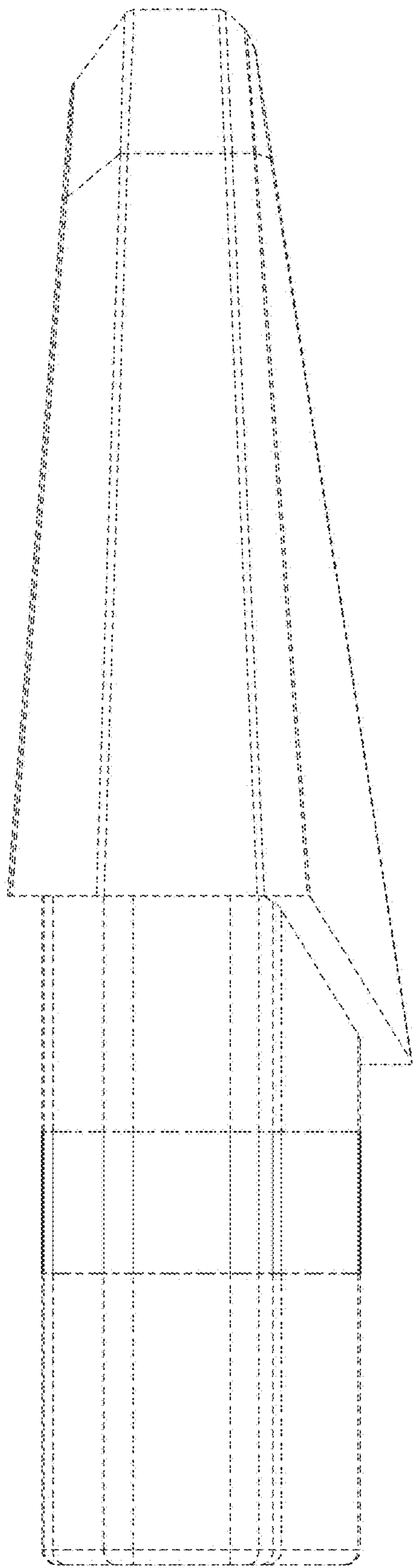

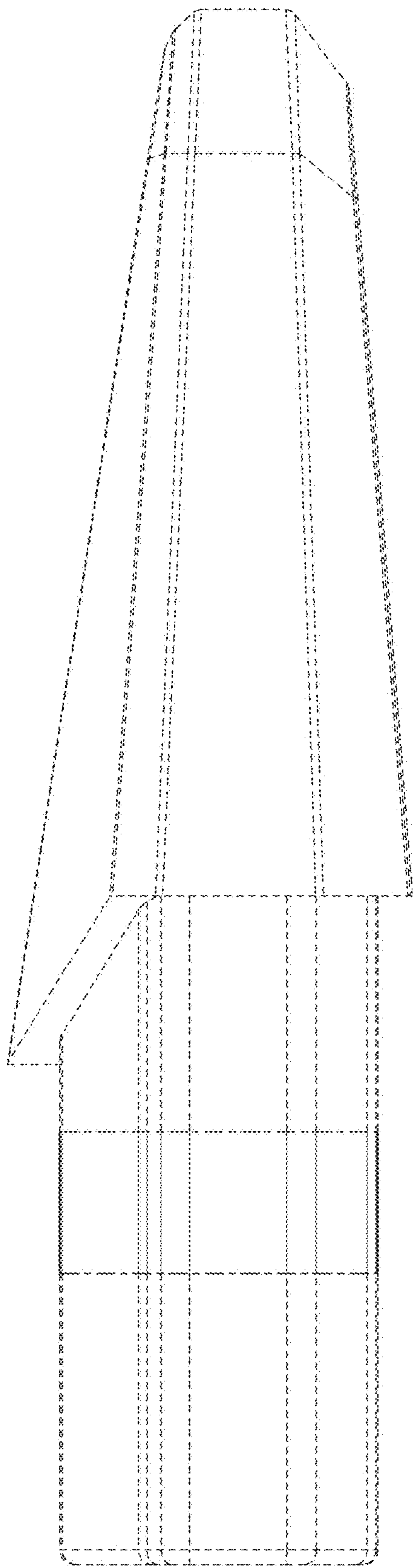

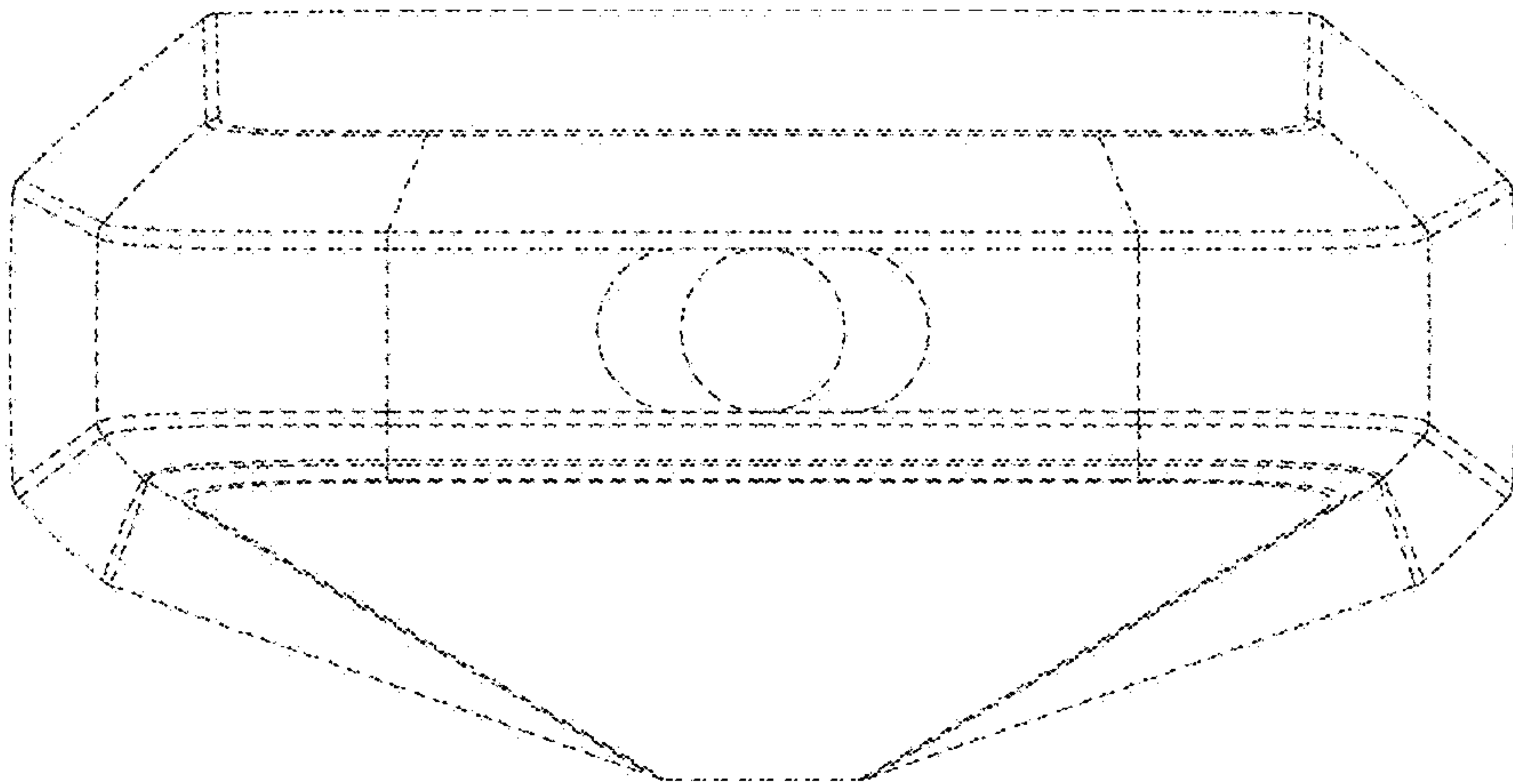

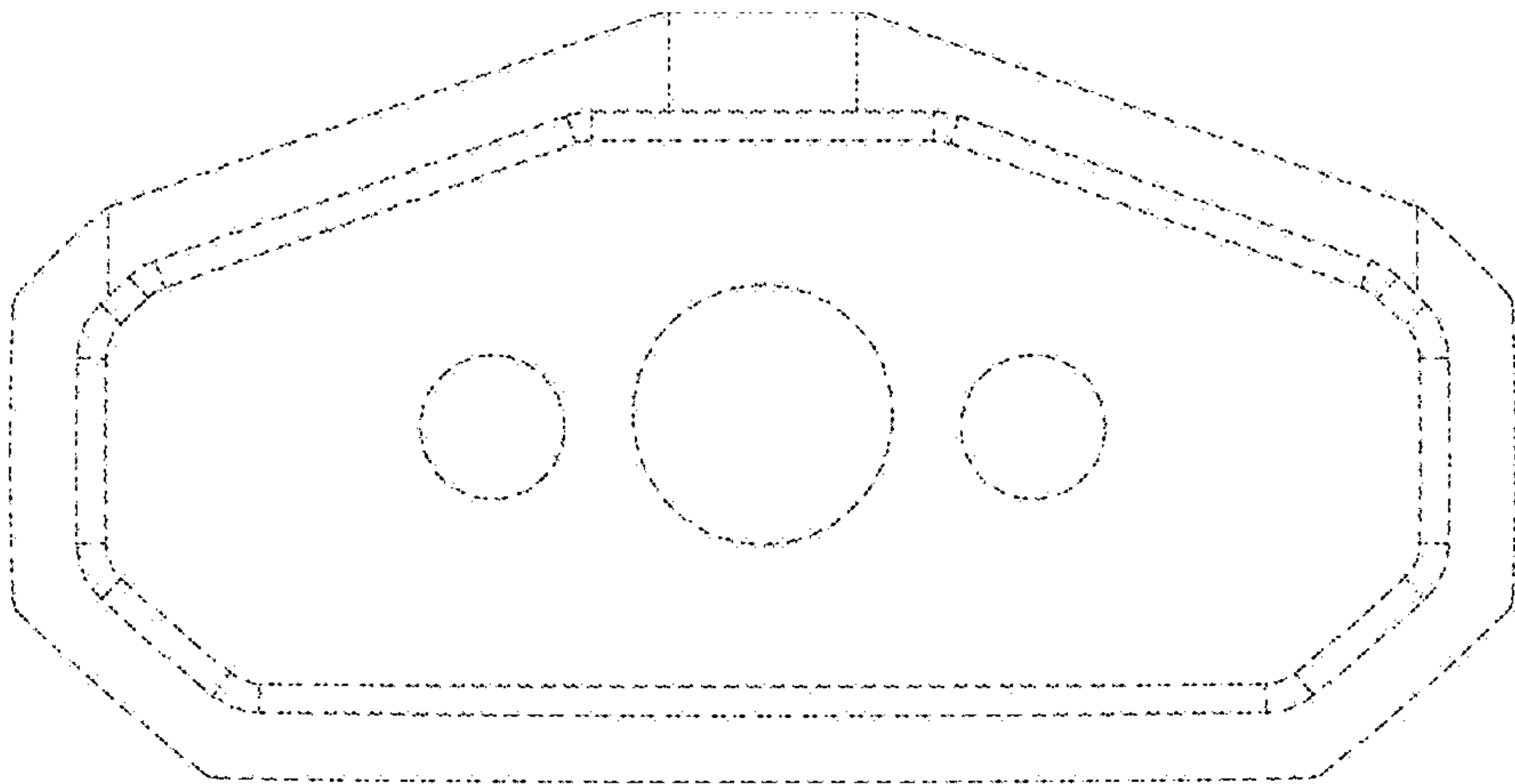
