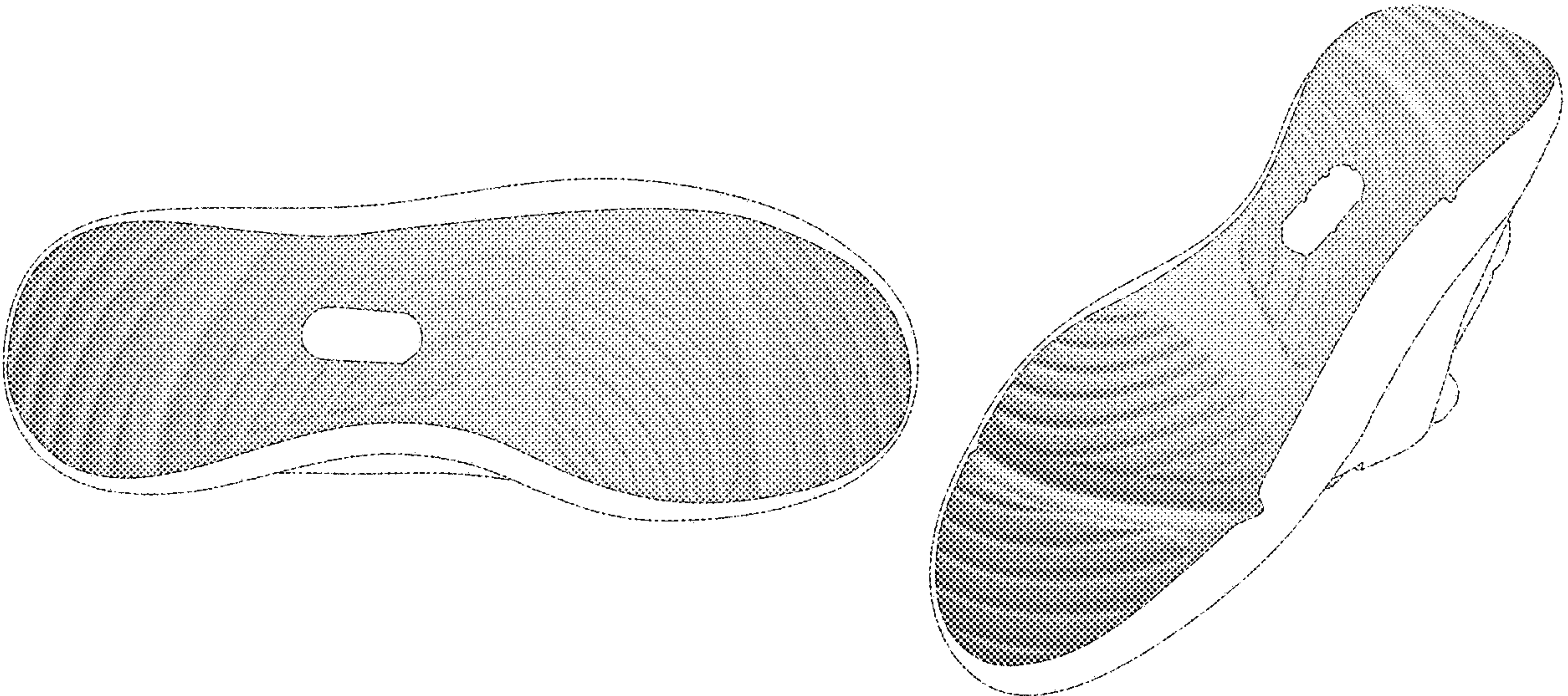
(57) CLAIM

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a shoe showing my new design; FIG. 2 is a bottom front perspective view thereof; FIG. 3 is a bottom opposite side front perspective view thereof; FIG. 4 is a bottom opposite side rear perspective view thereof; and, FIG. 5 is a bottom rear perspective view thereof. The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

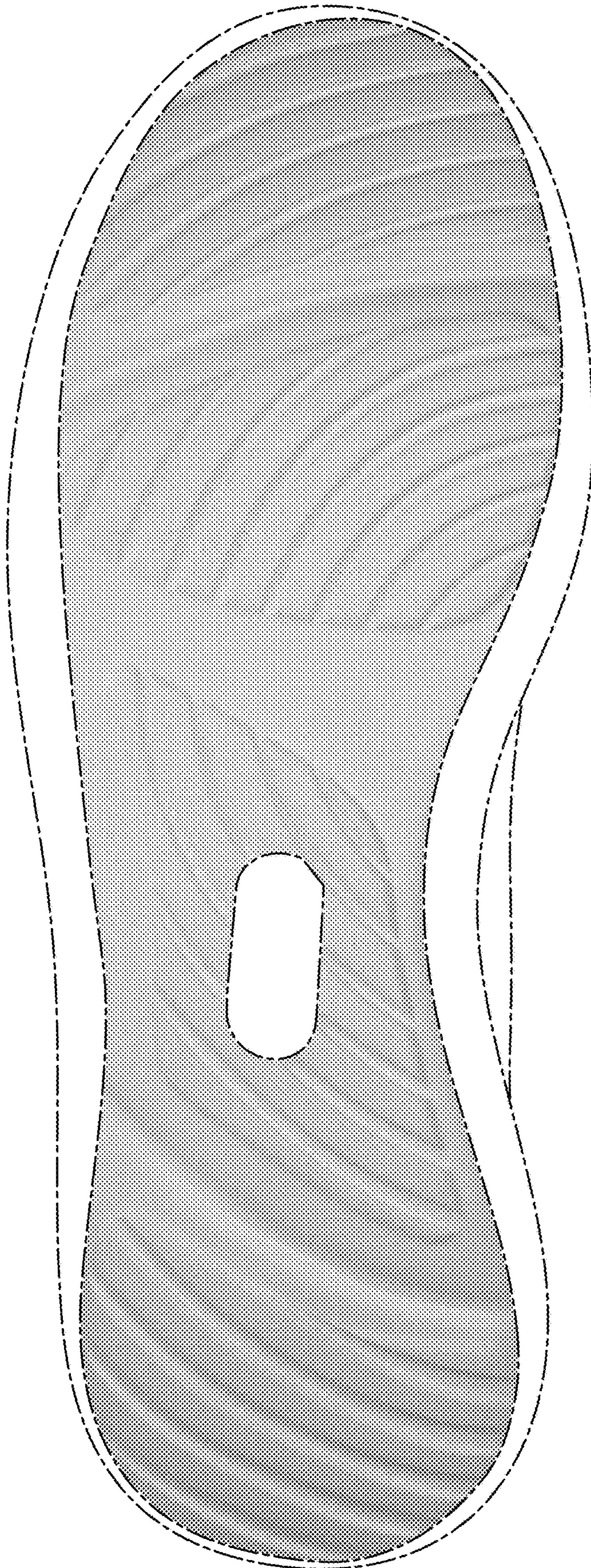

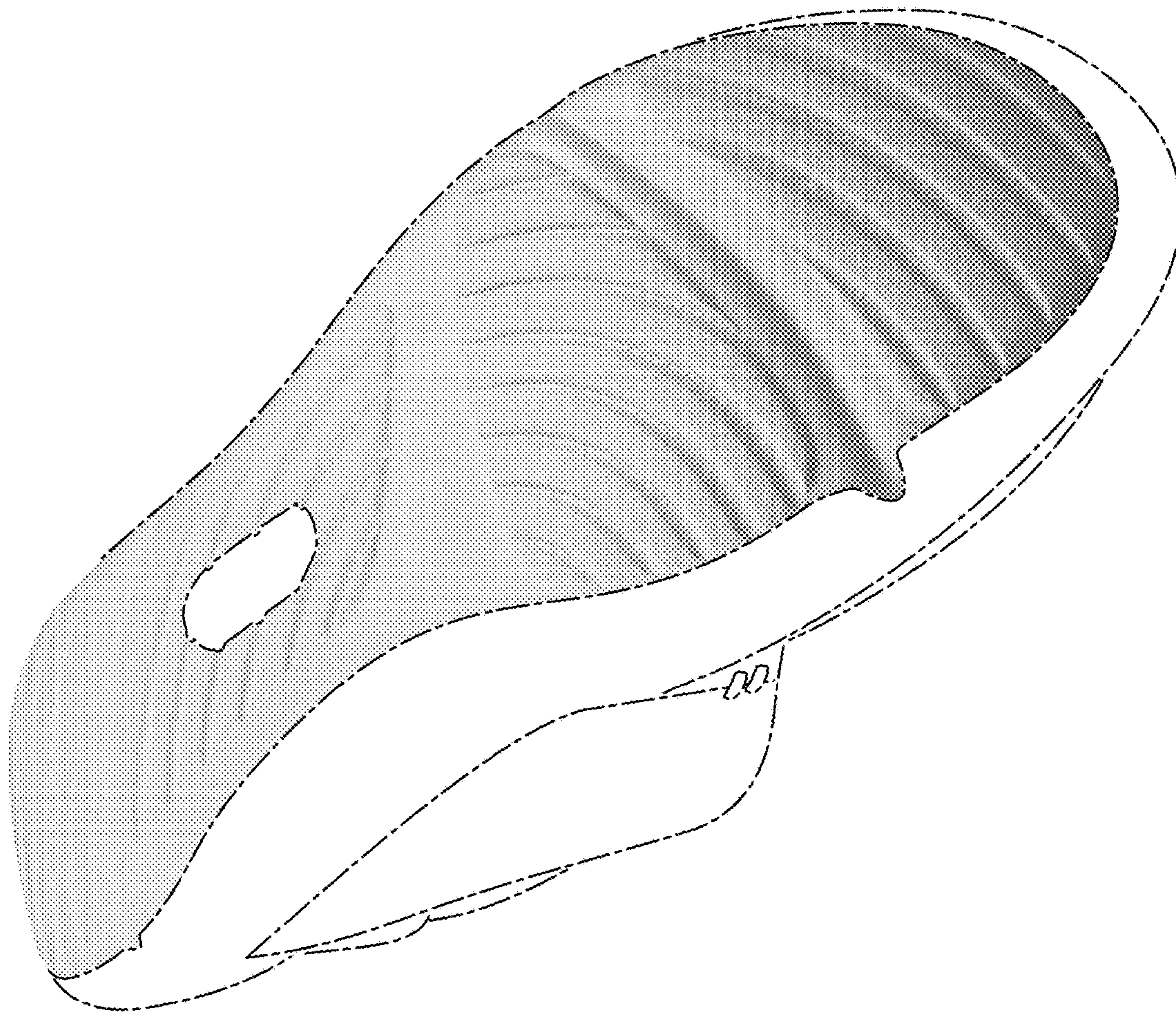

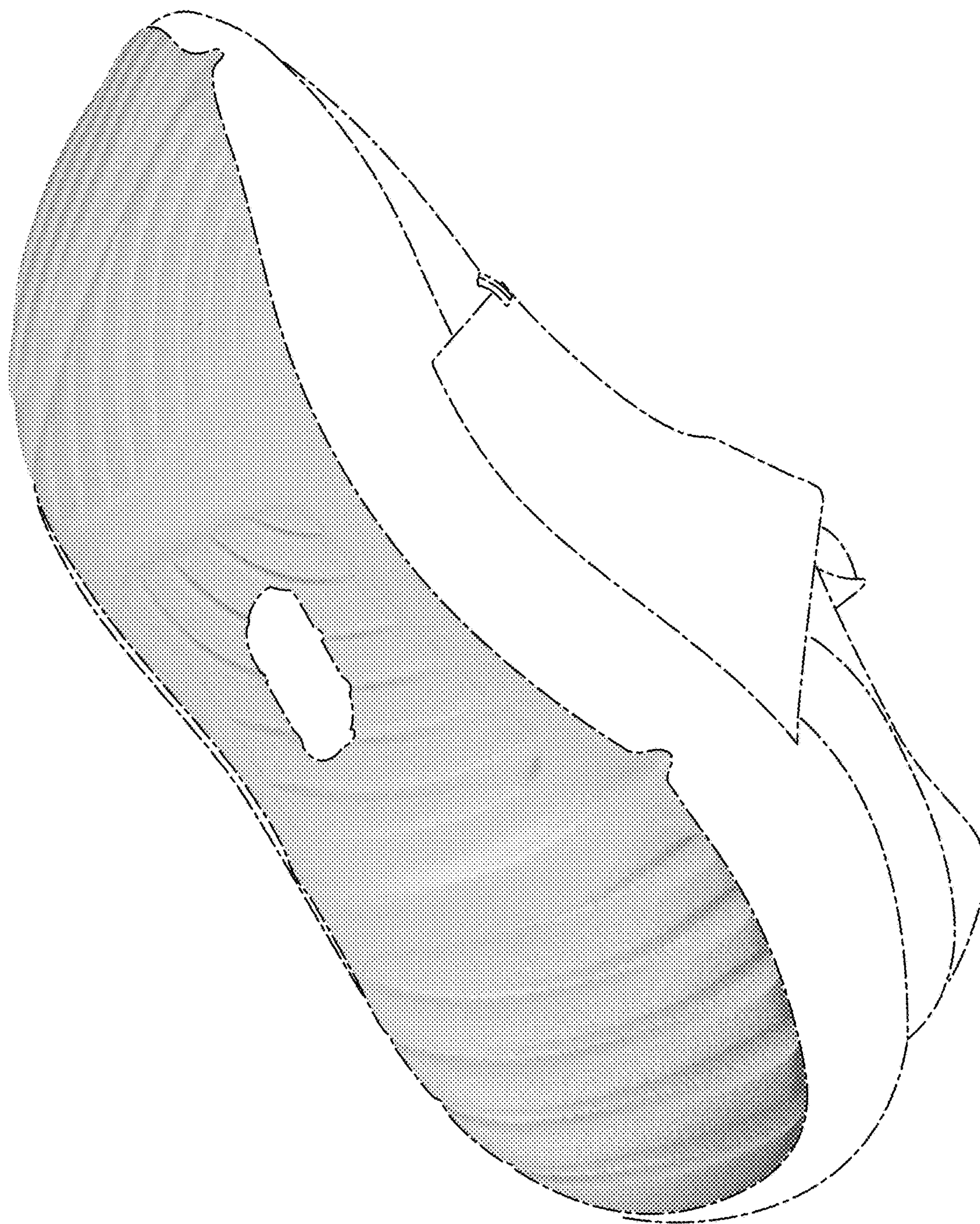

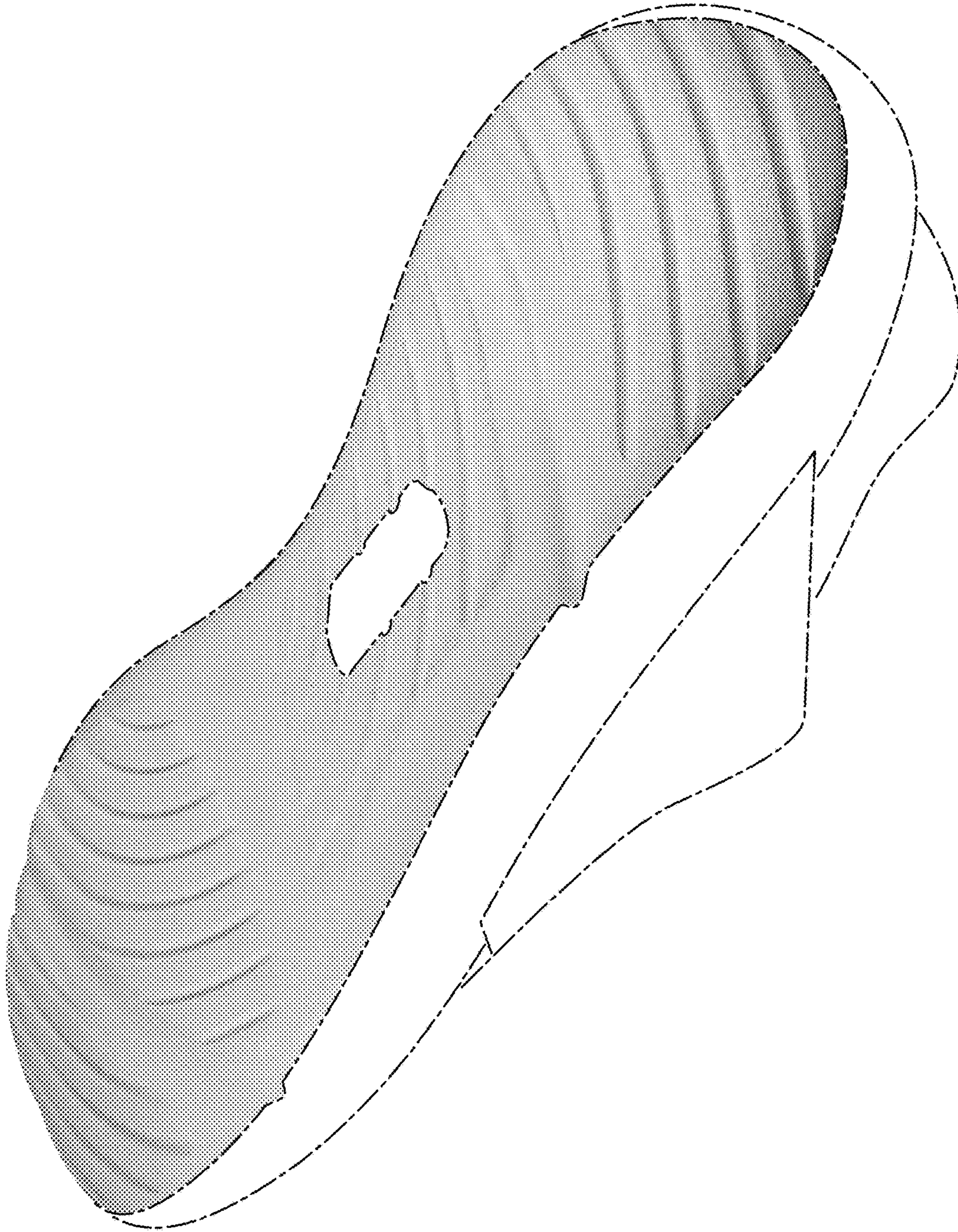
