(57) **CLAIM**

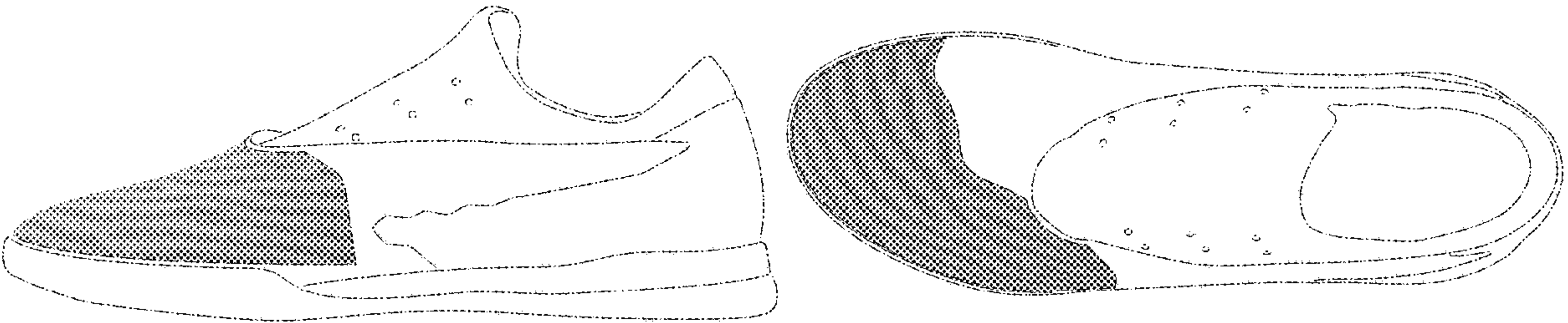
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is an opposite side view thereof; and, FIG. 5 is a top view thereof.

The broken line immediately adjacent to and surrounding the photographic area defines the peripheral bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

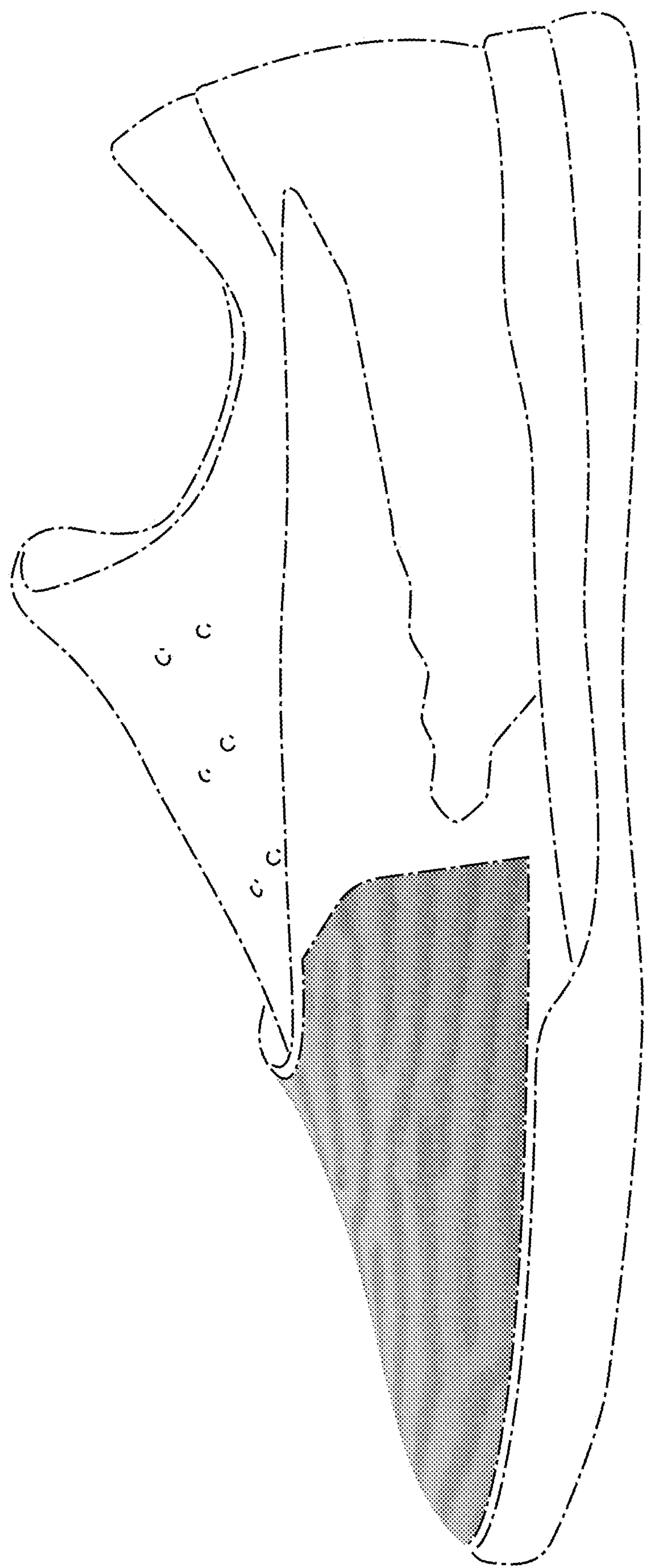

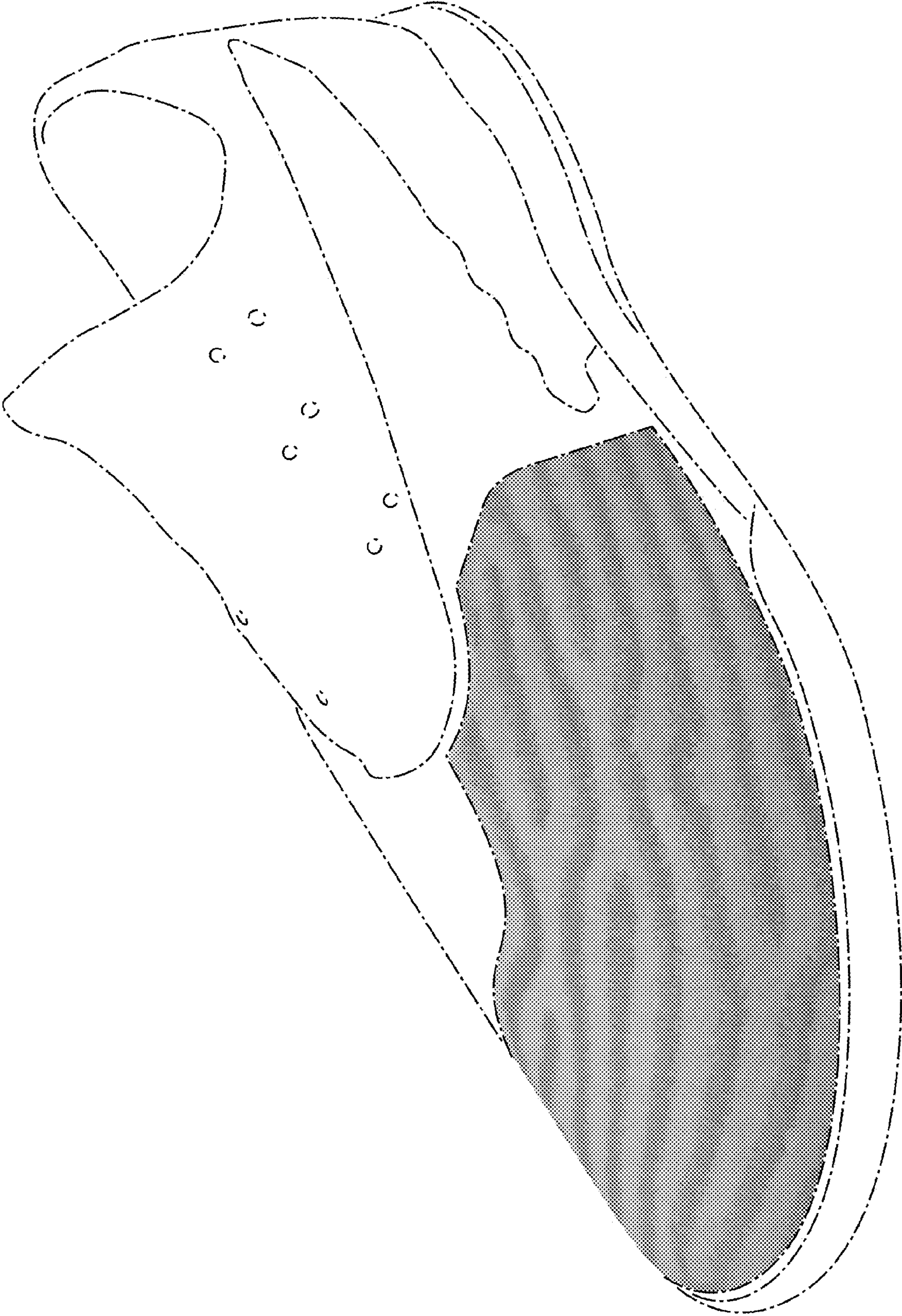

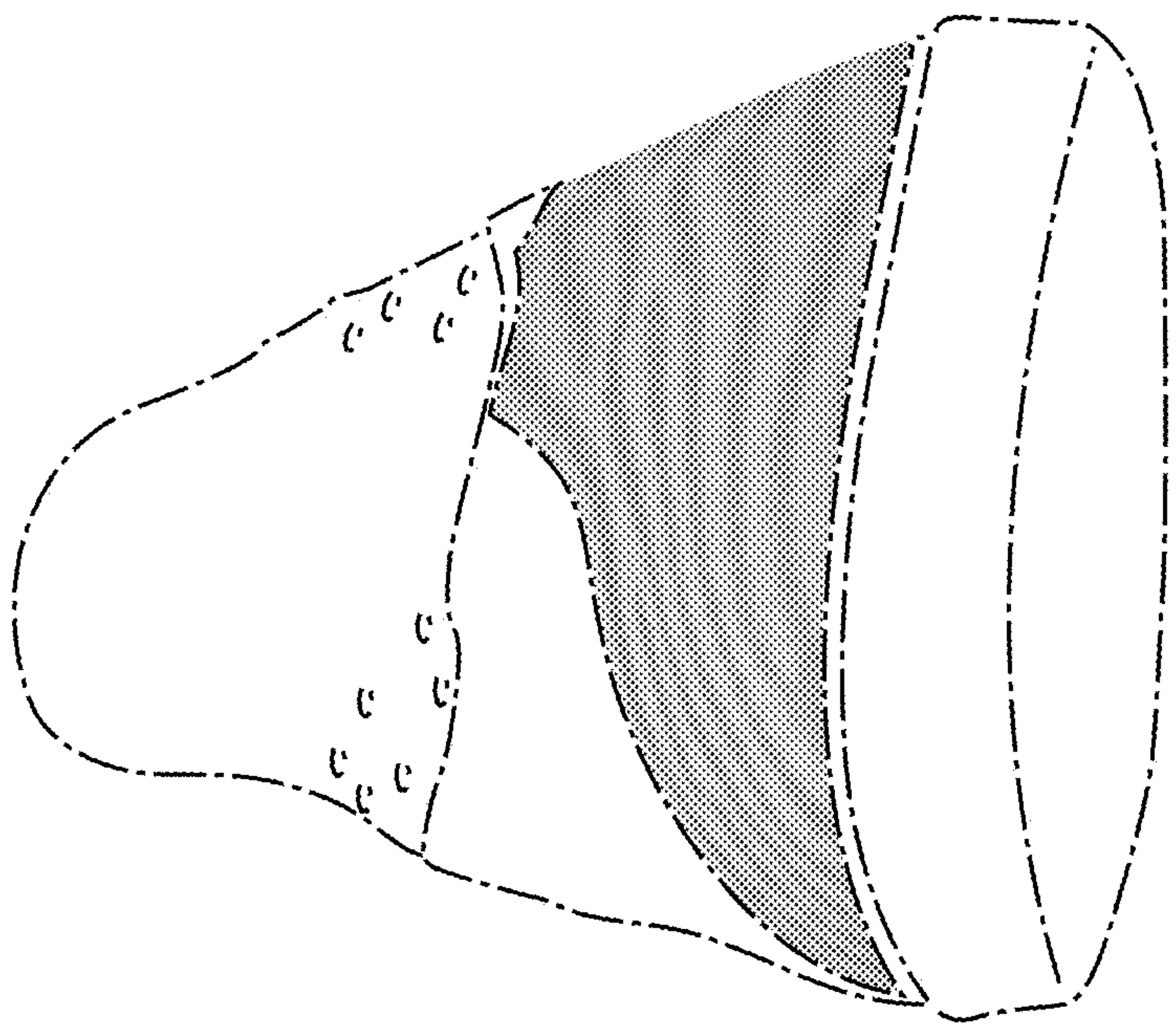

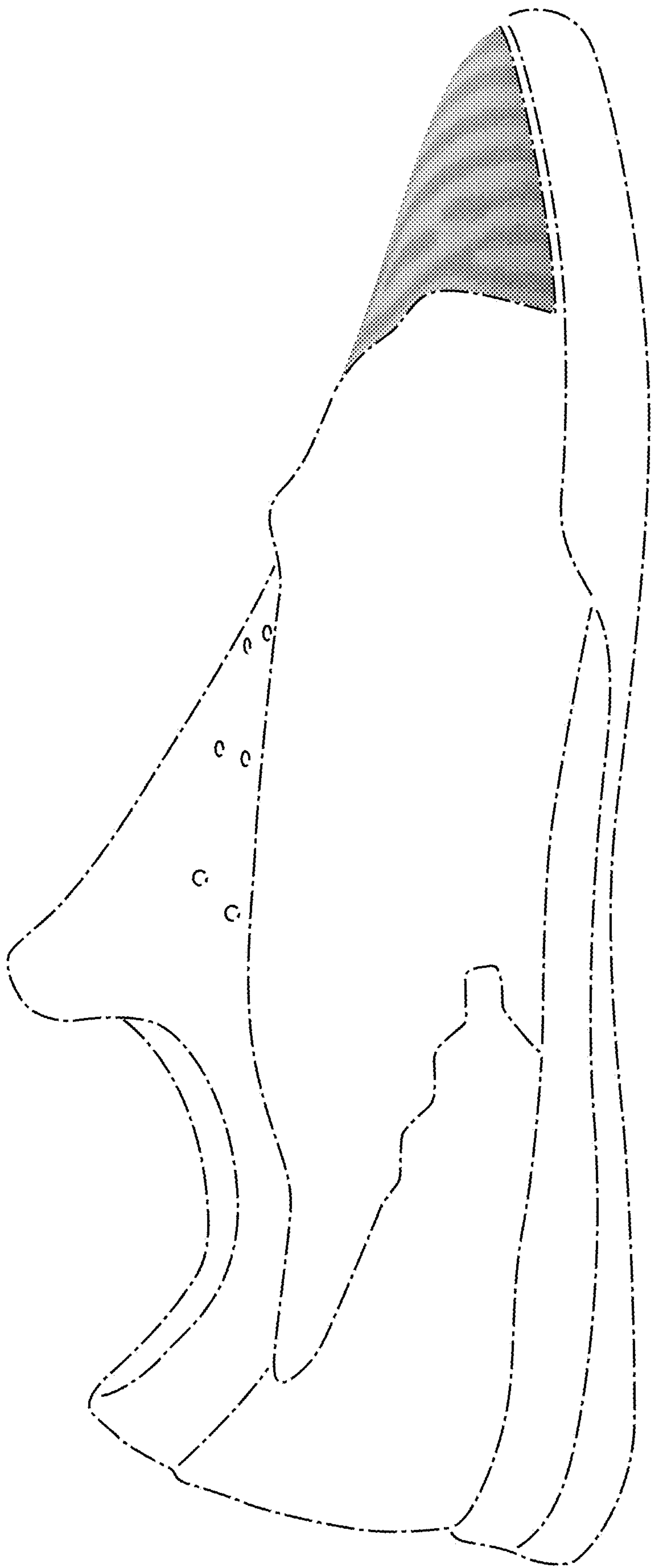

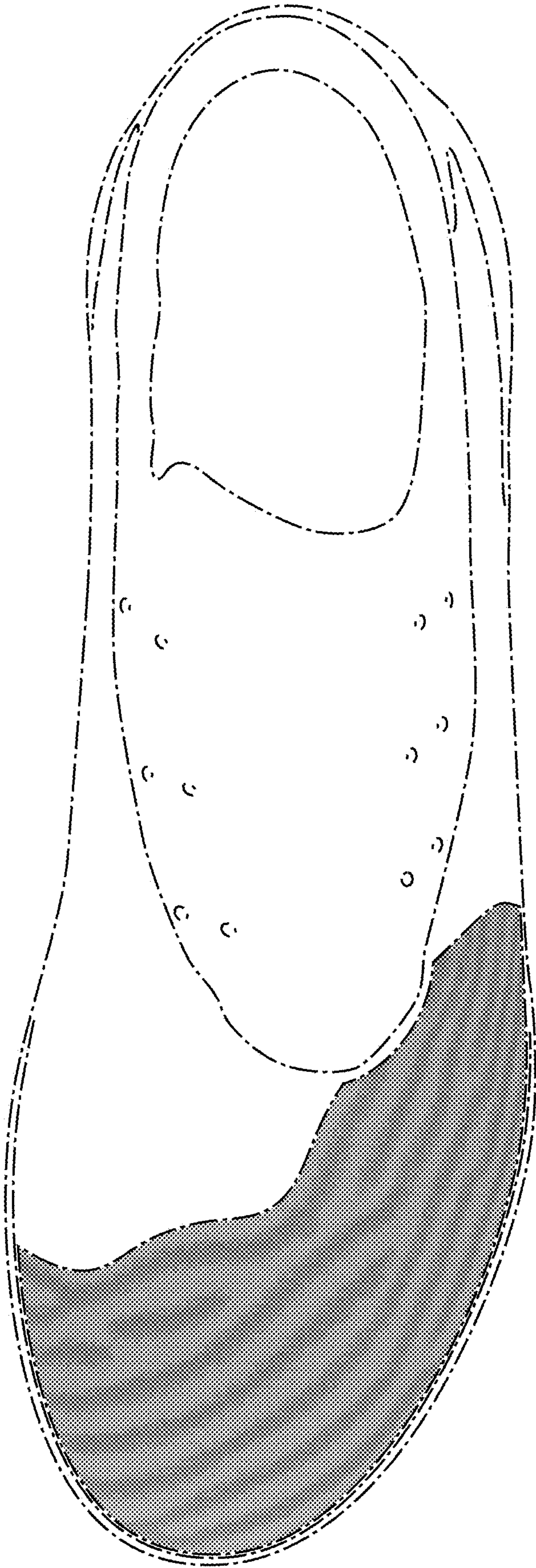
