(57) **CLAIM**

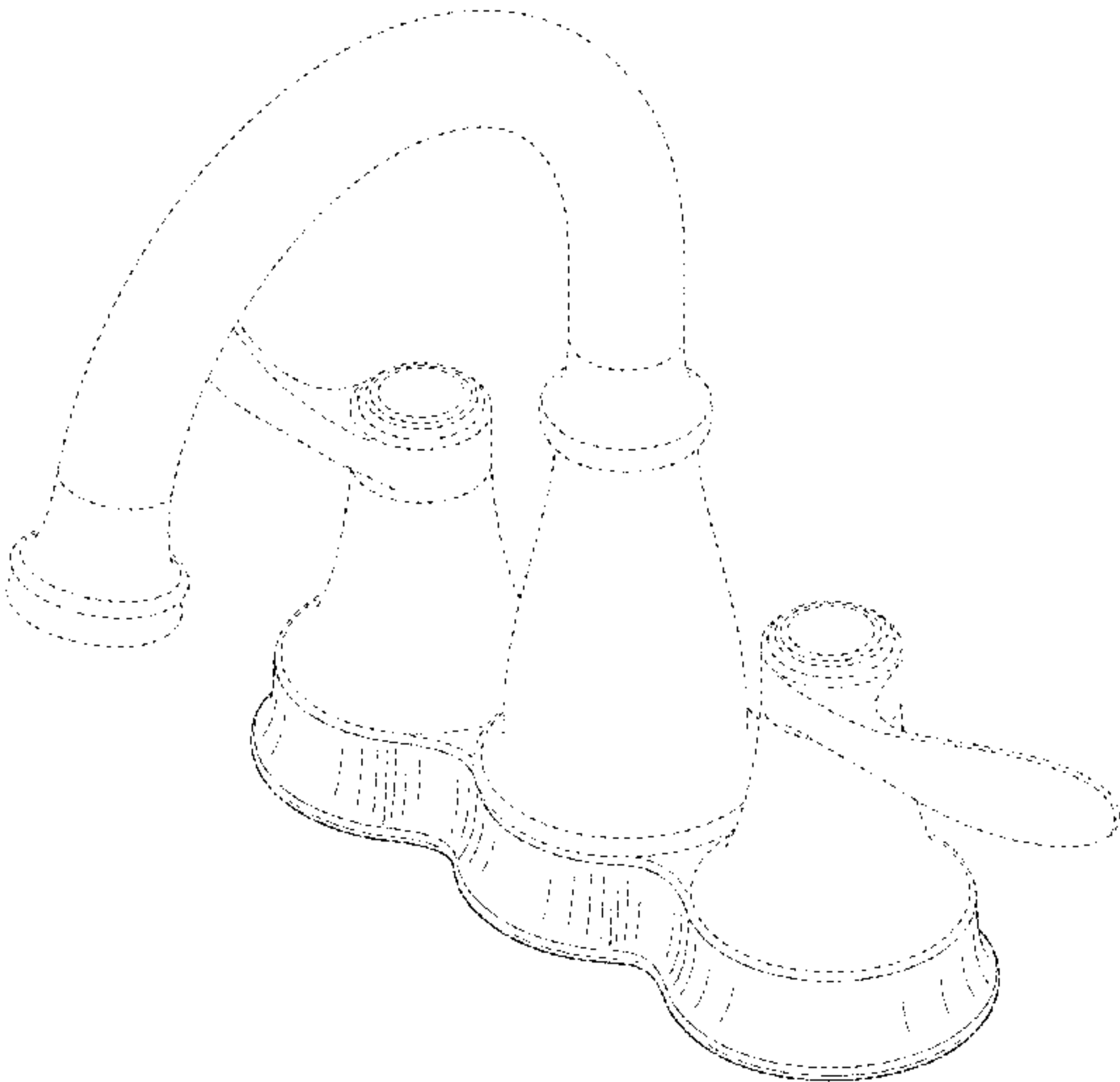
We claim the ornamental design for a faucet base, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the claimed design;

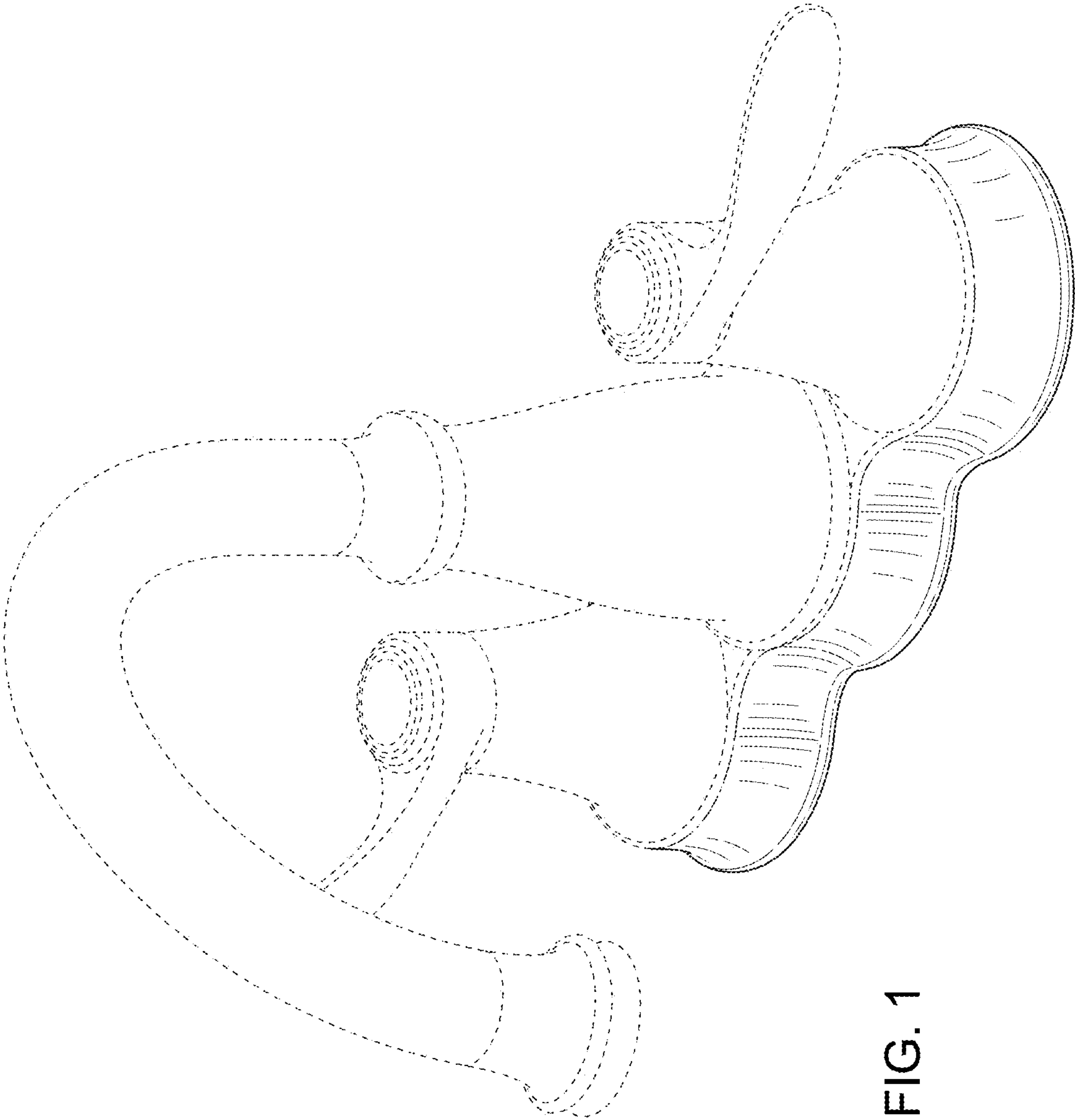

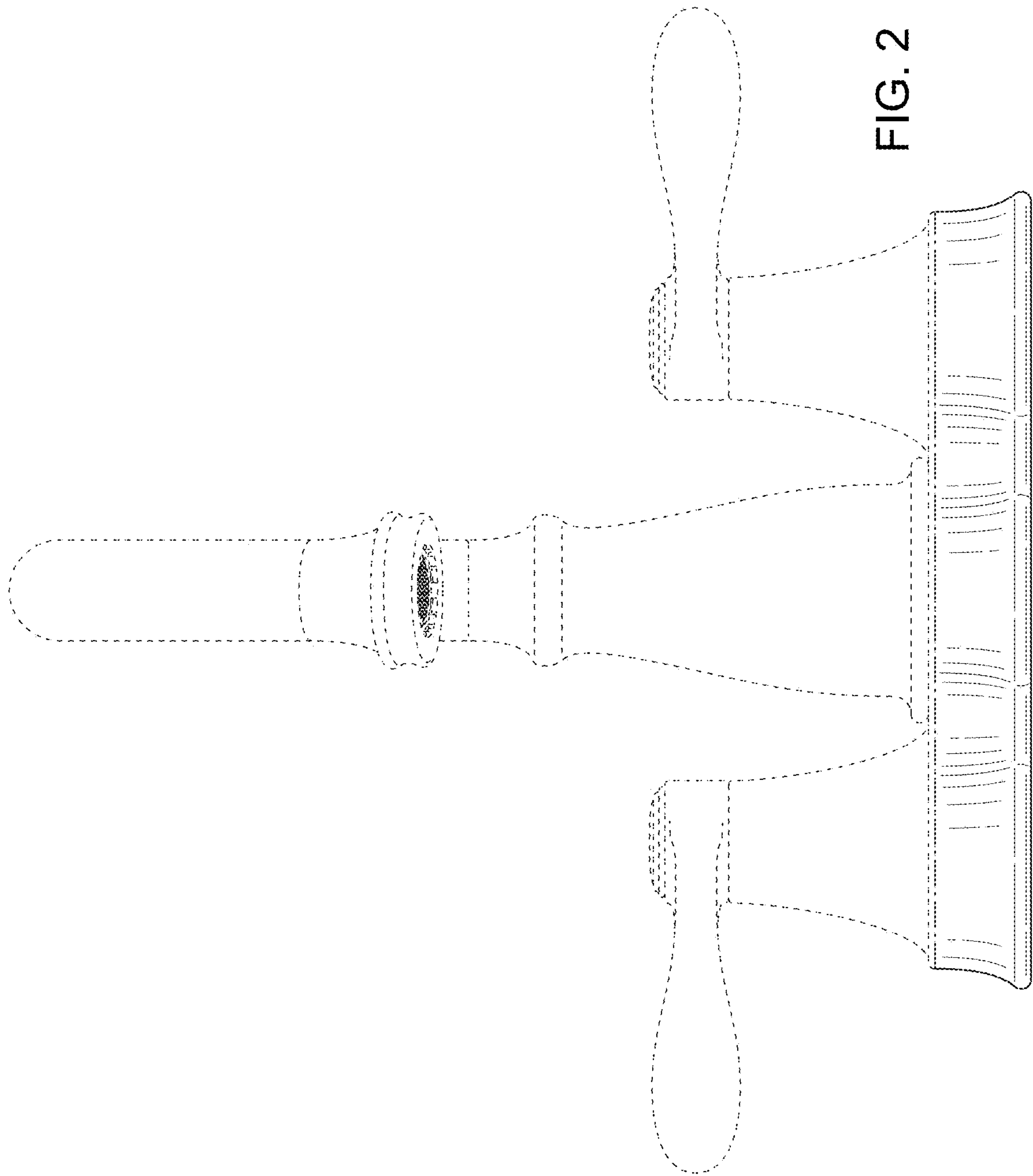

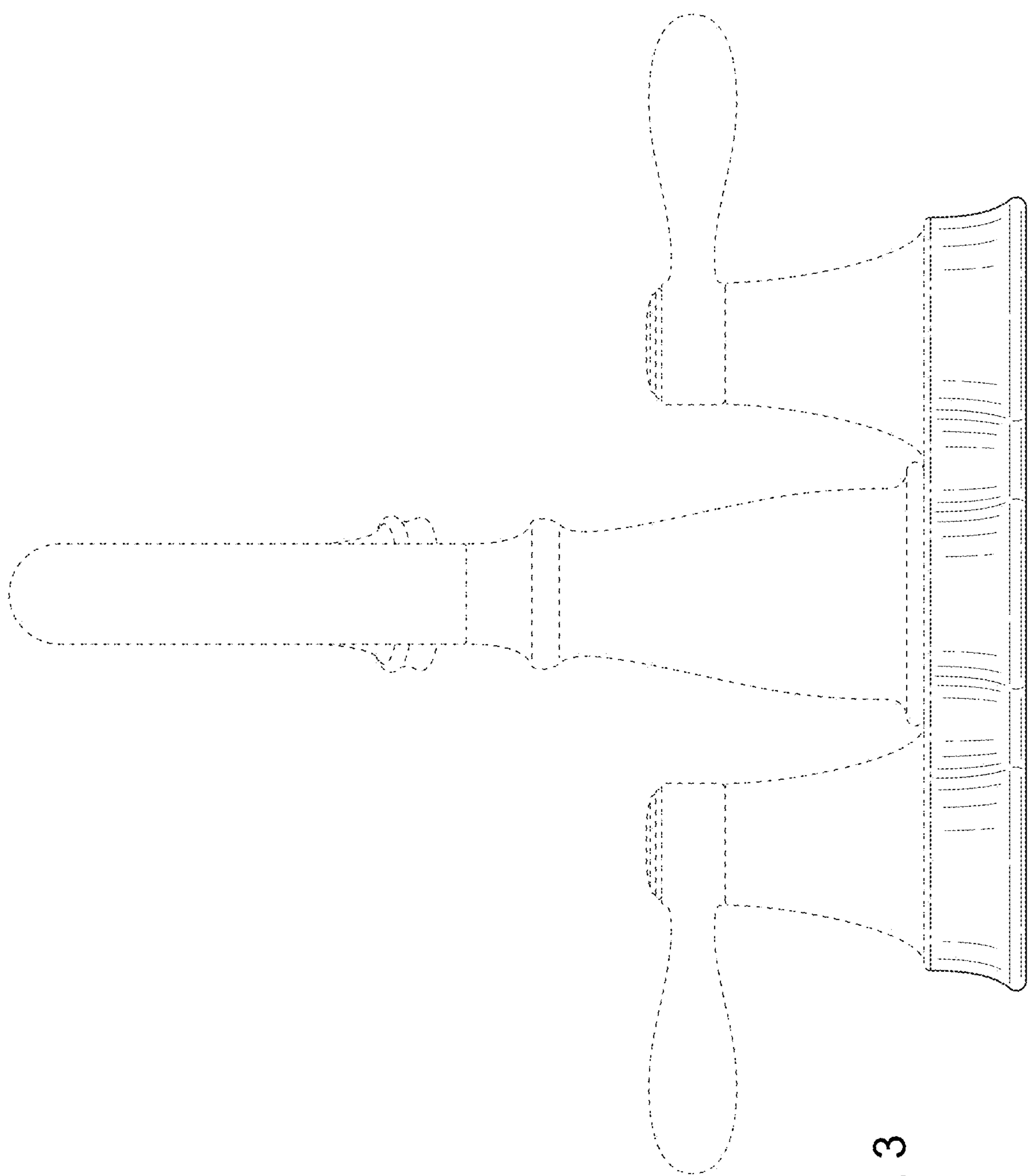

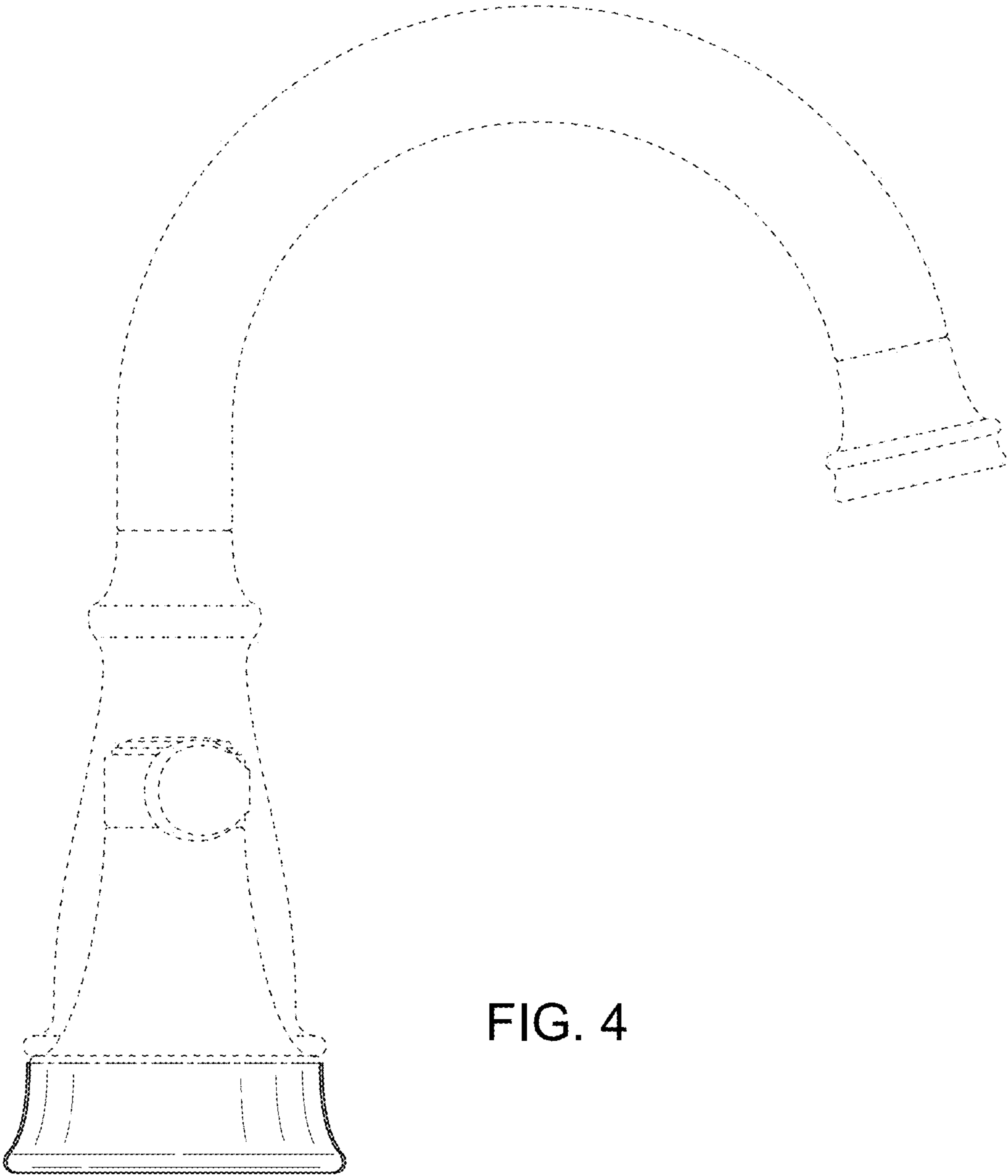

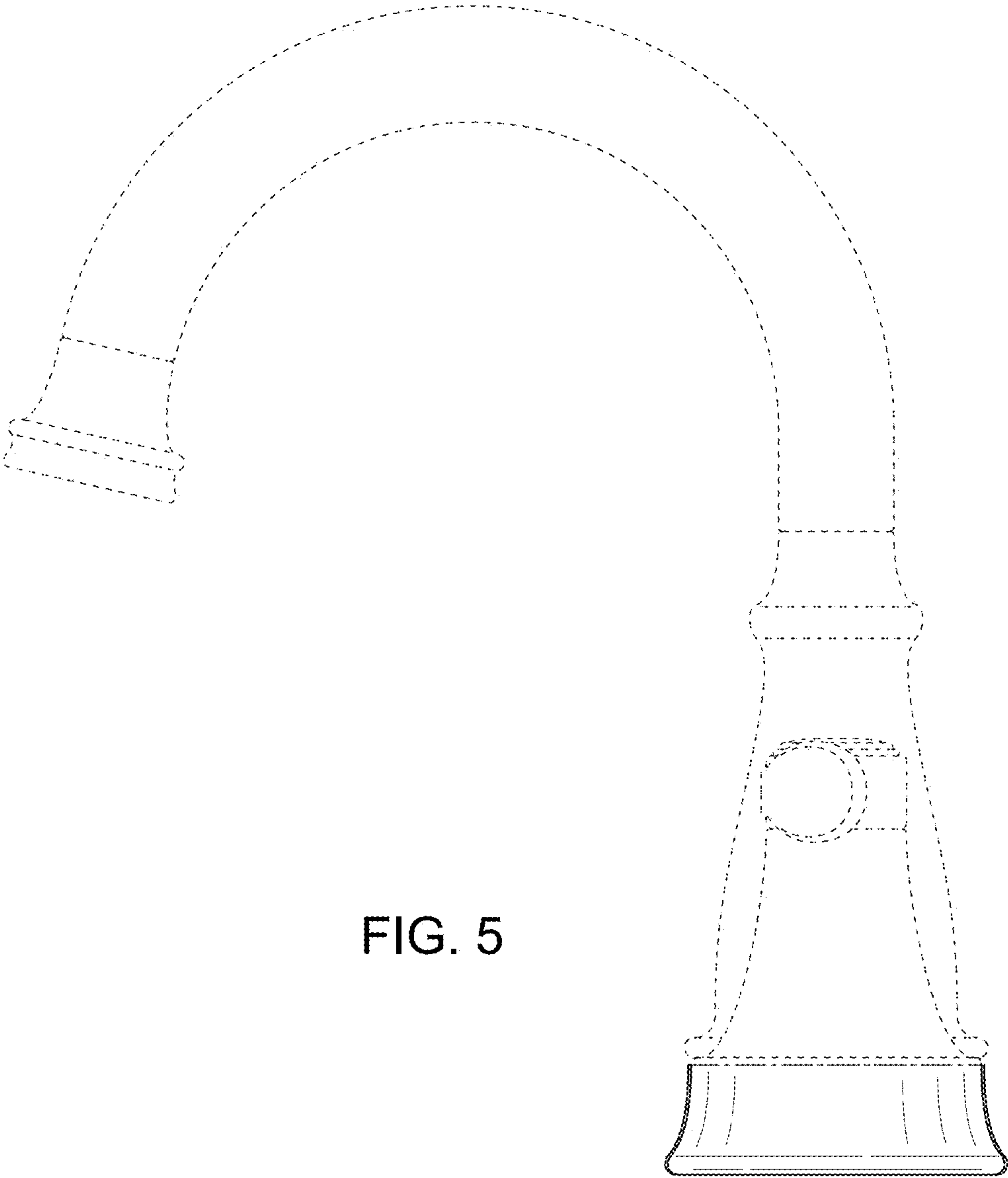

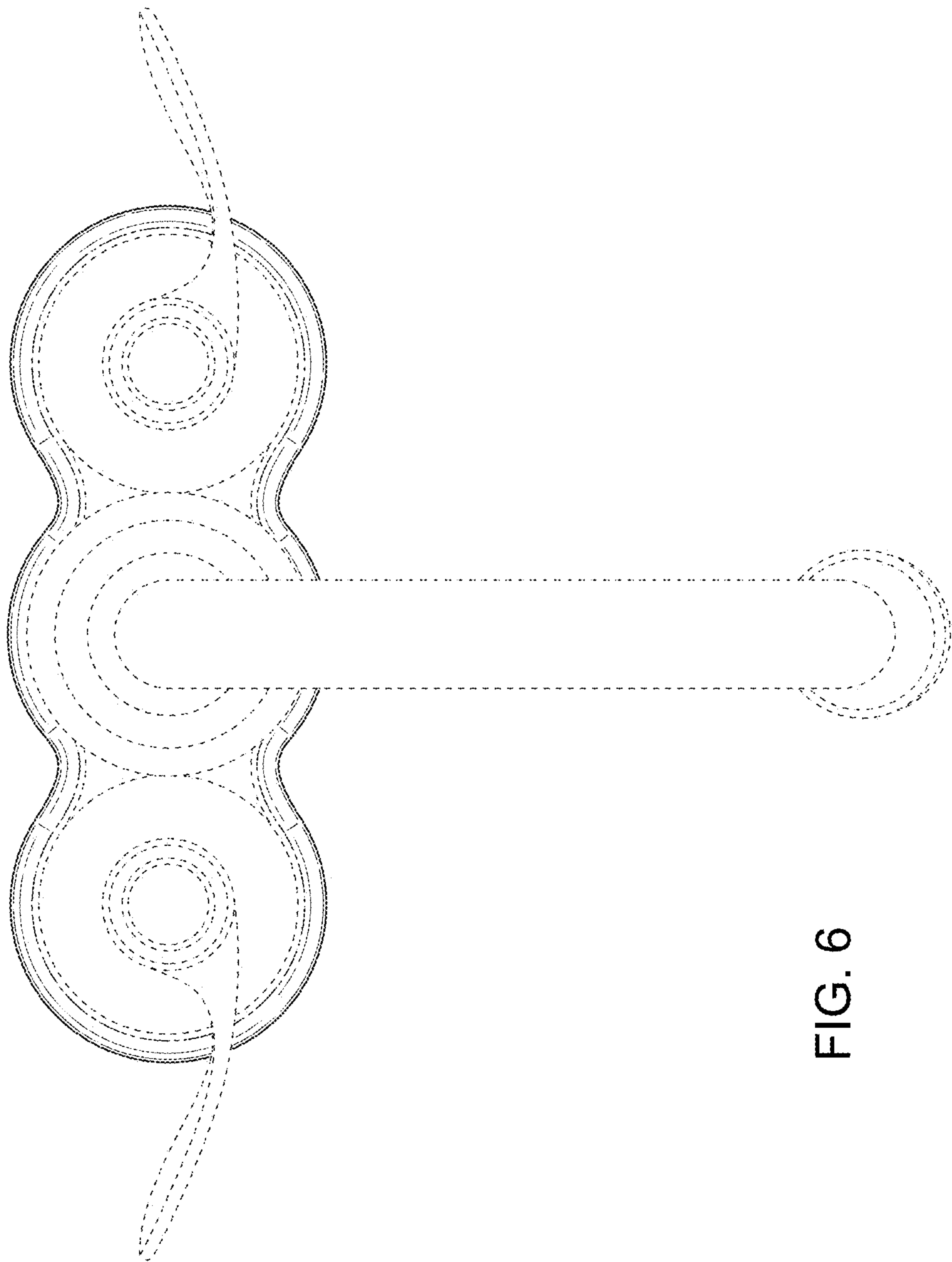

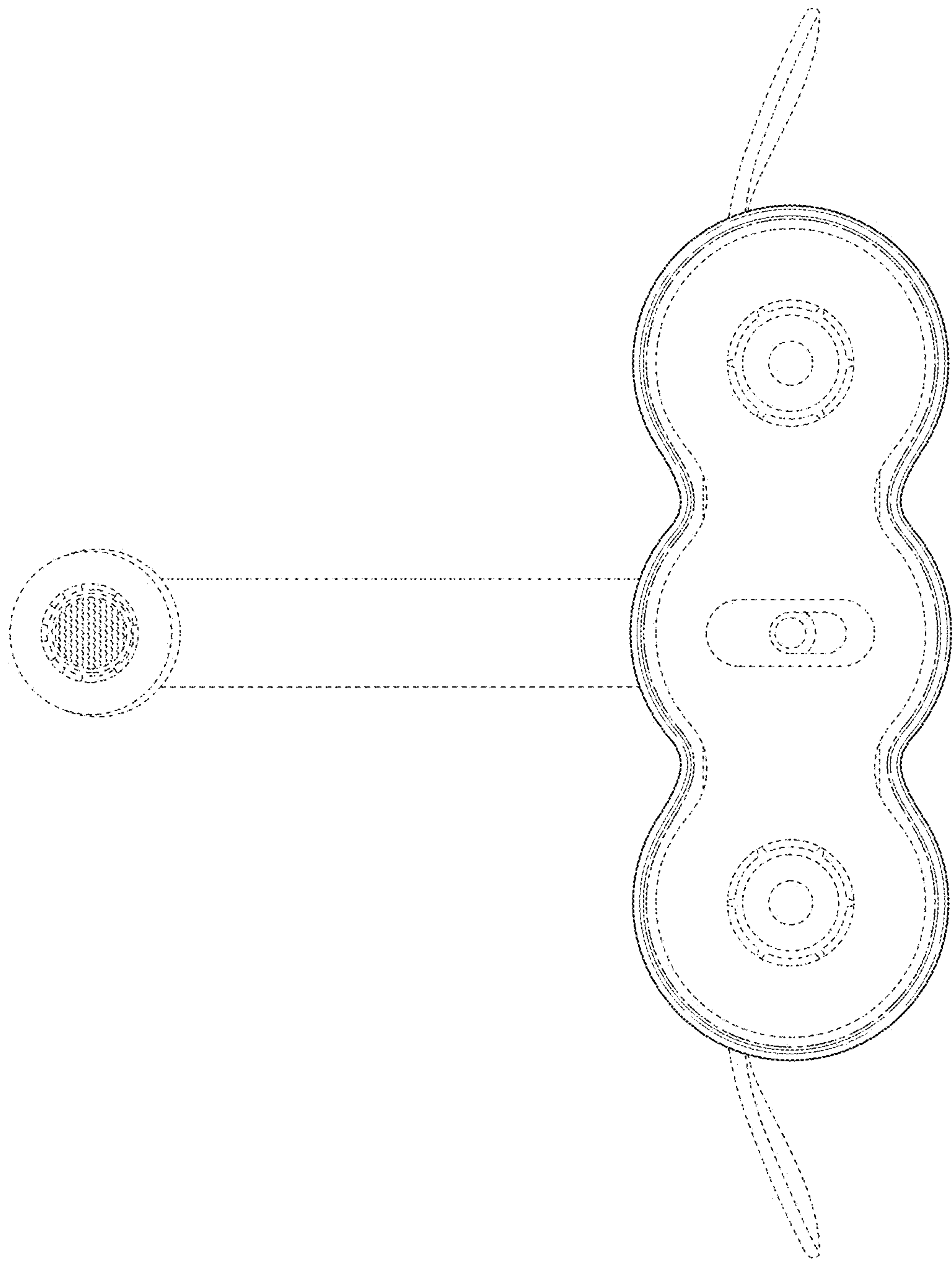
