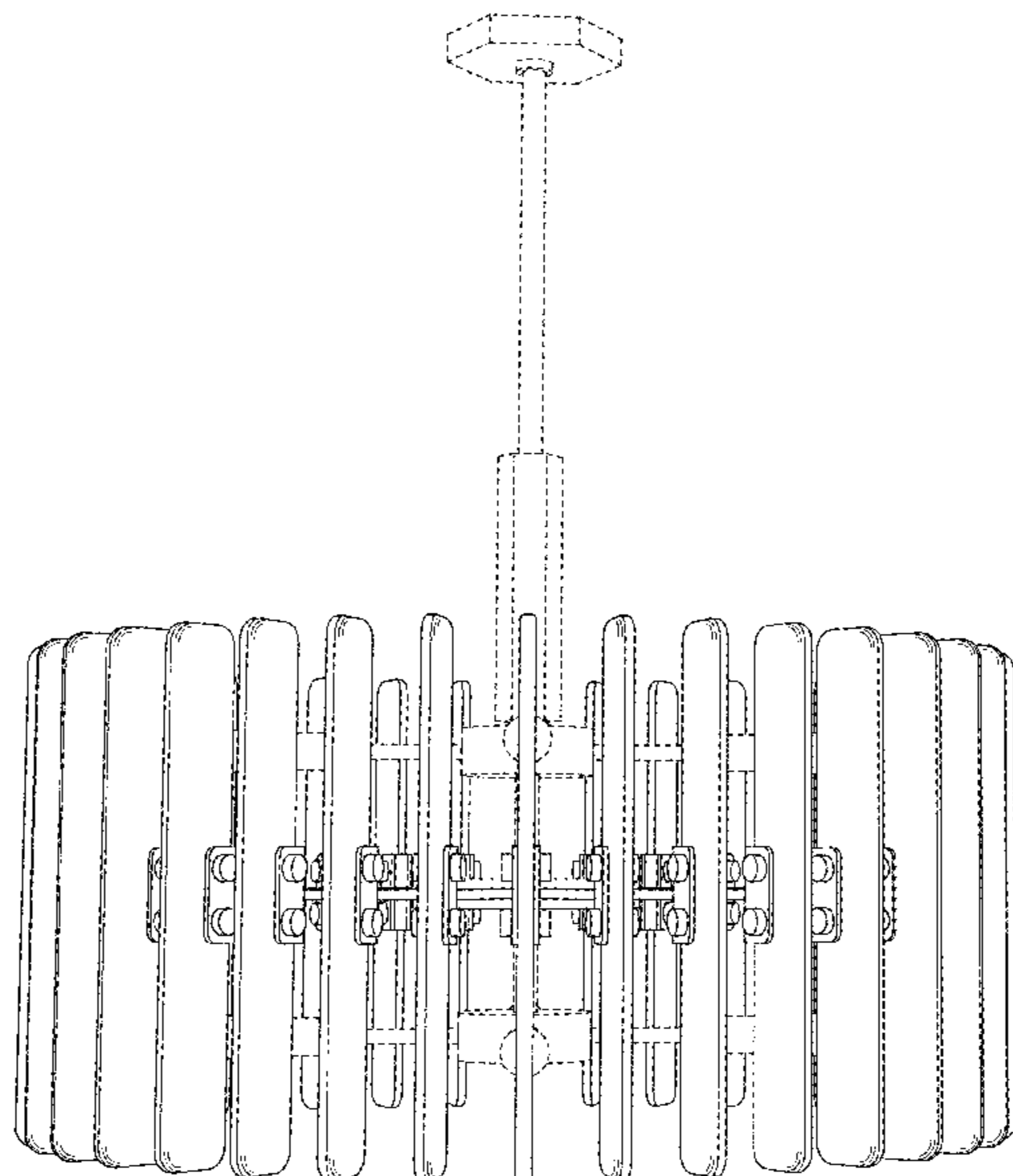
(57) **CLAIM**

I claim the ornamental design for a chandelier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chandelier according to this invention;  
FIG. 2 is a front view of the chandelier shown in FIG. 1;  
FIG. 3 is a rear view of the chandelier shown in FIG. 1;  
FIG. 4 is a top view of the chandelier shown in FIG. 1;  
FIG. 5 is a bottom view of the chandelier shown in FIG. 1;  
FIG. 6 is a left side view of an element of the chandelier shown in FIG. 1, the right side view being a mirror image thereof; and,  
FIG. 7 is a top view of the element shown in FIG. 6, the bottom view being a mirror image thereof.  
The broken lines illustrate portions of the chandelier that form no part of the claimed design. The jagged break lines in FIG. 6 and FIG. 7 illustrate boundaries of the enlargements and form no part of the claimed design.

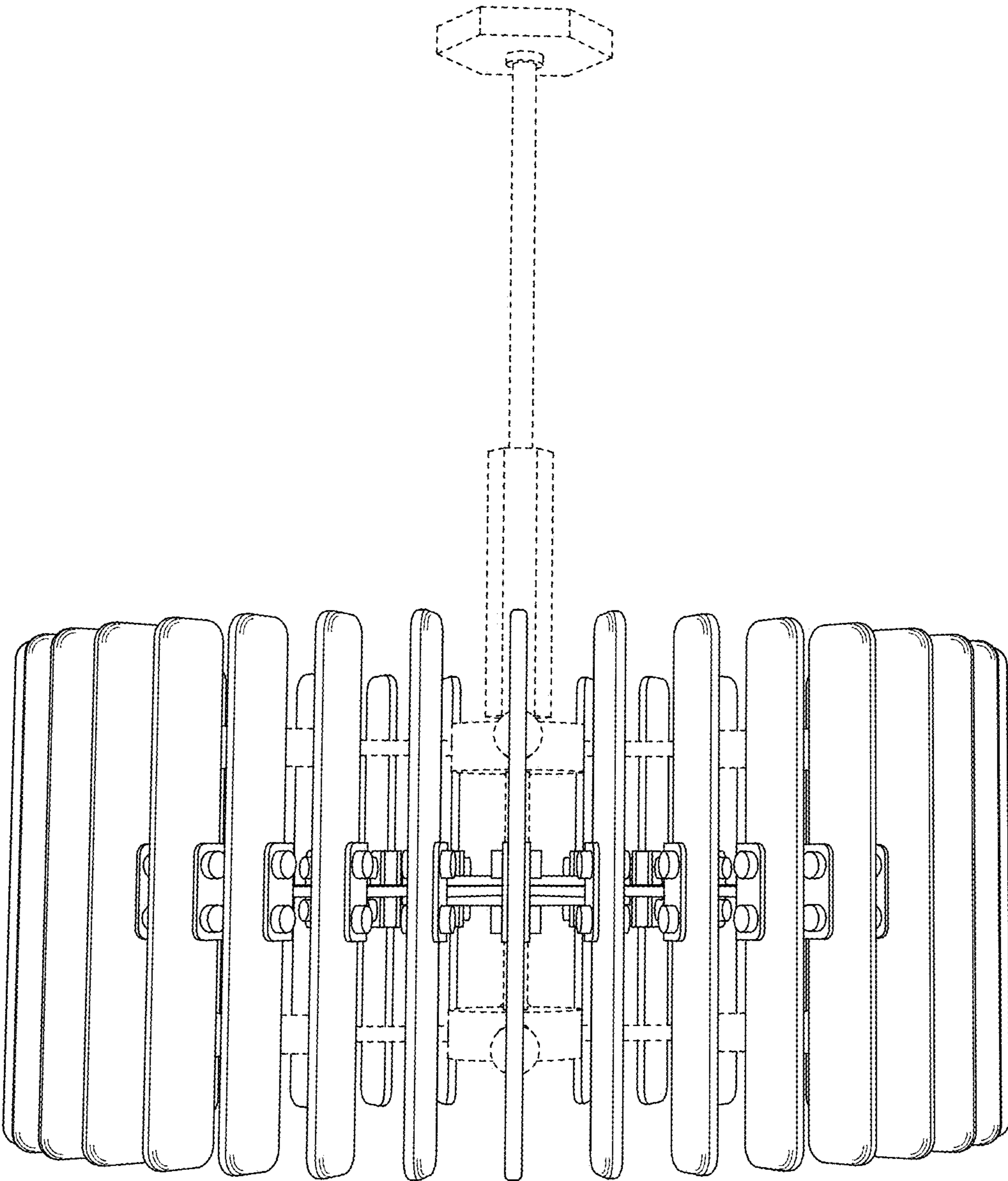

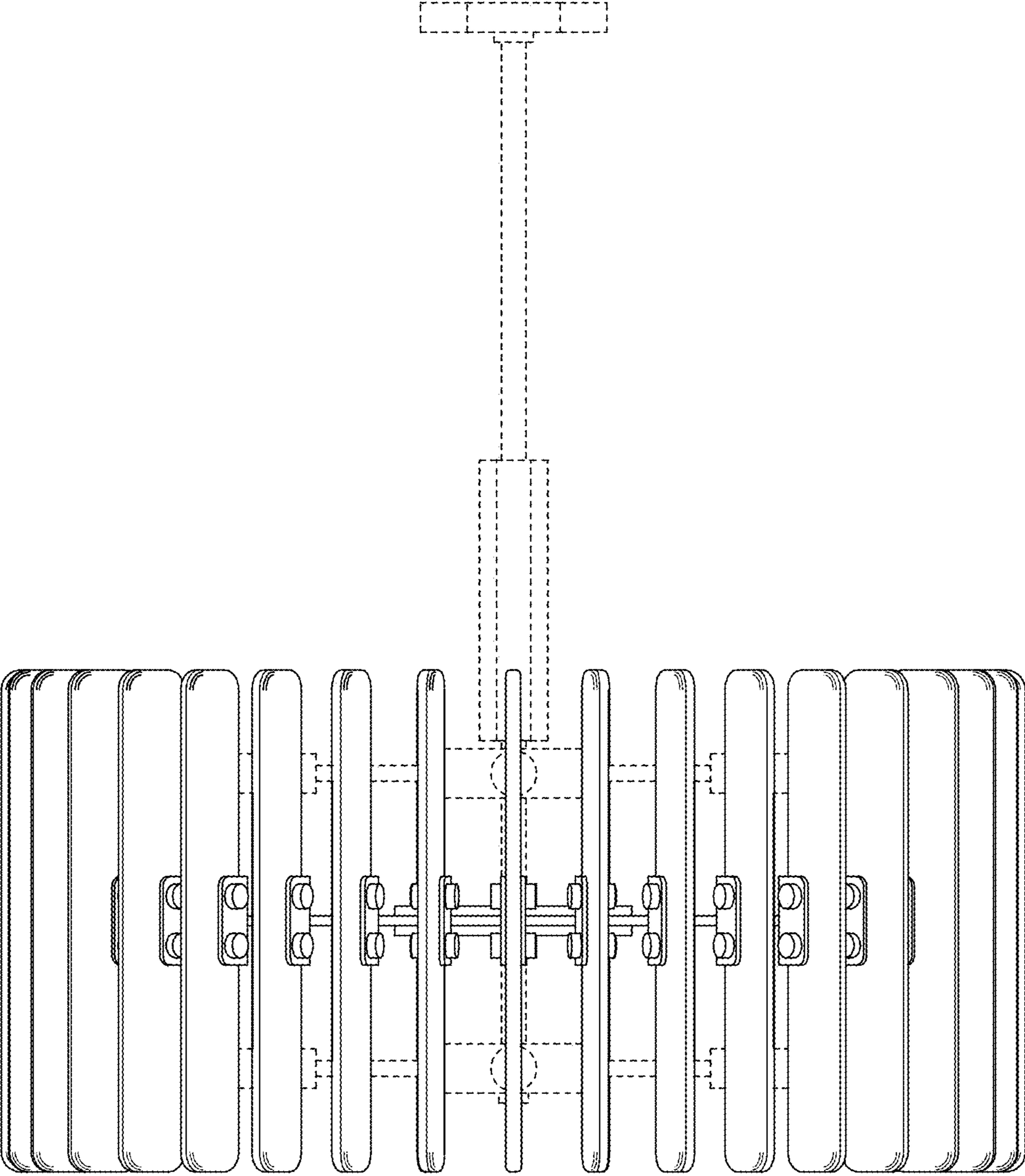

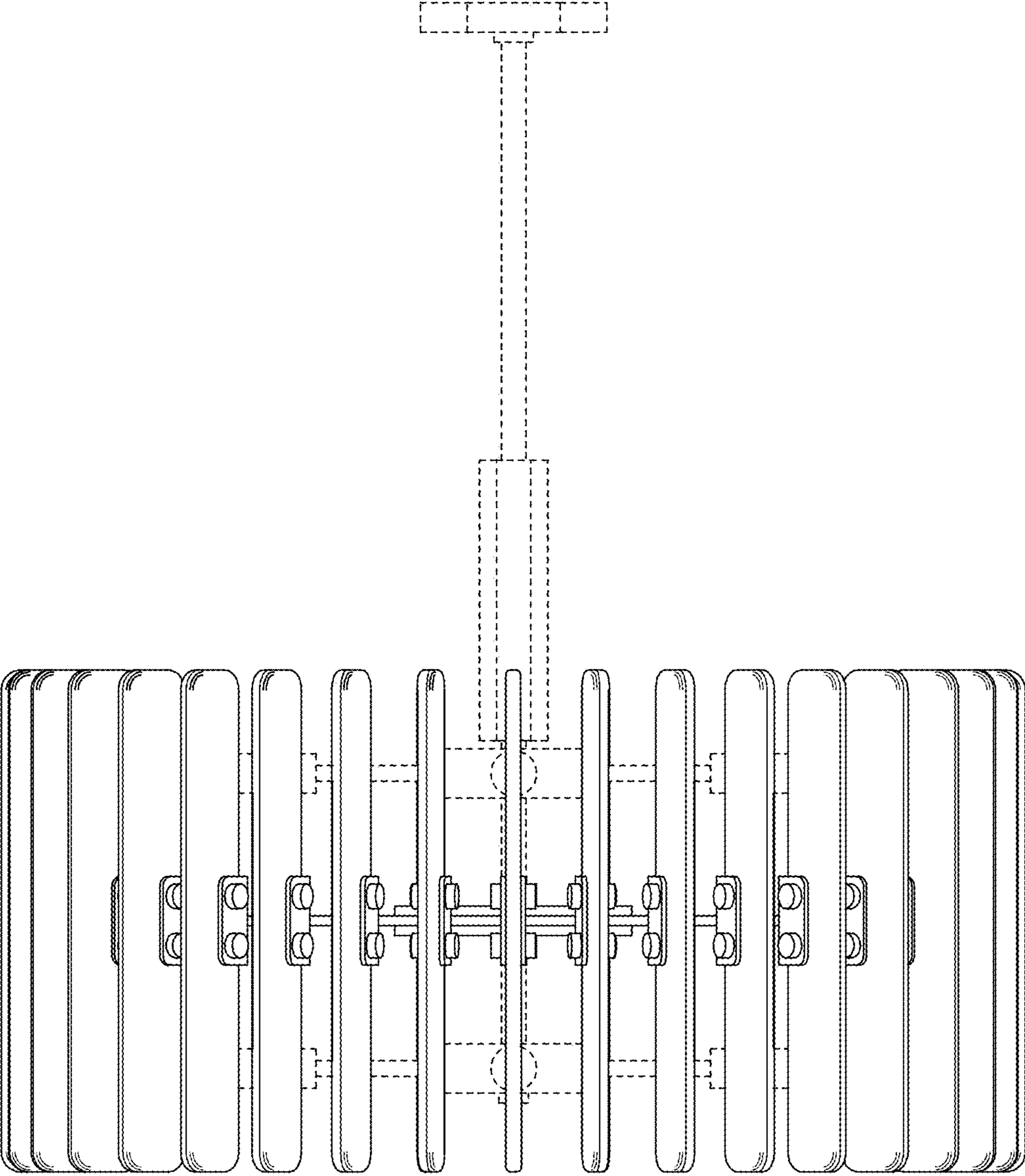

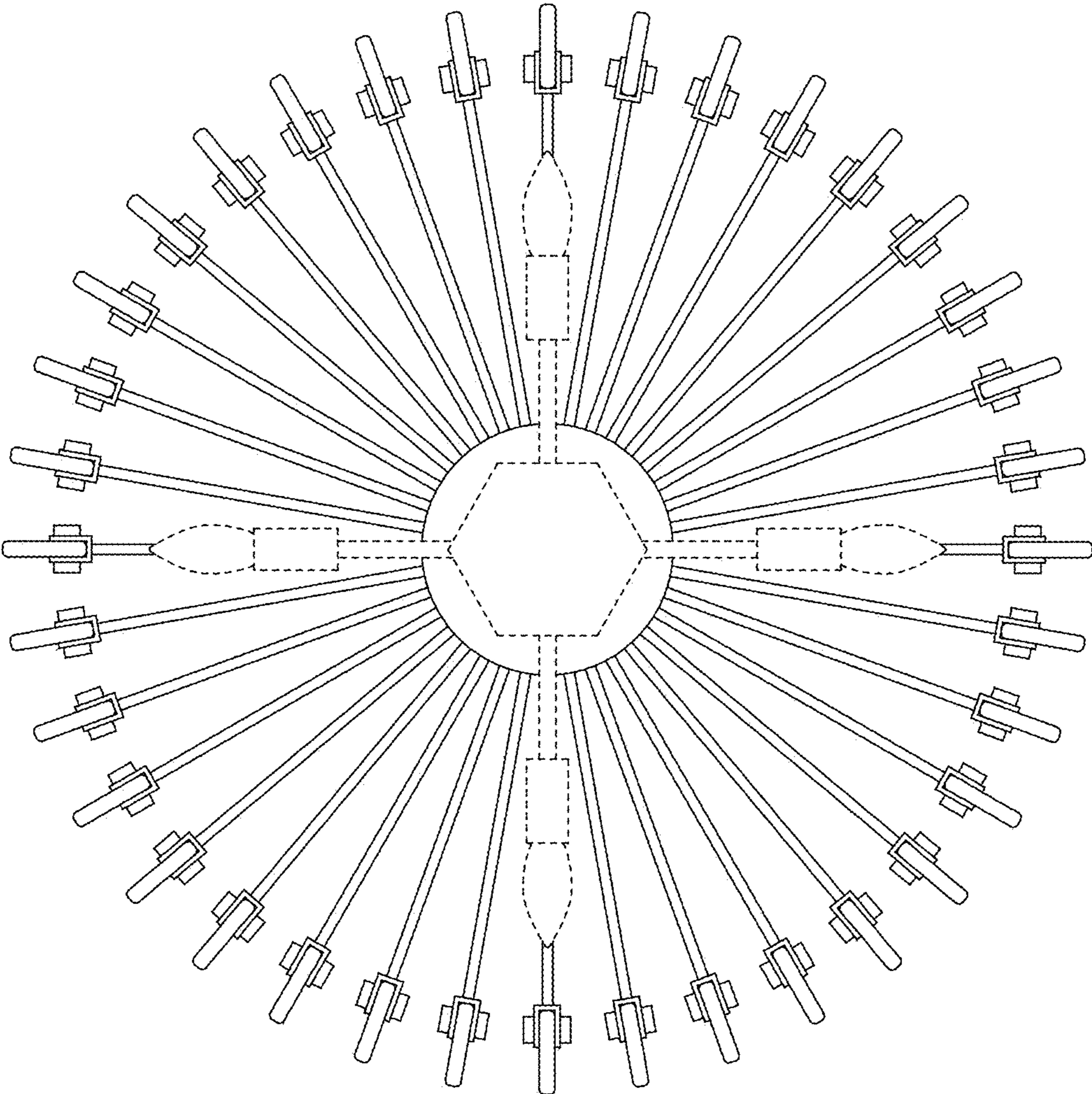

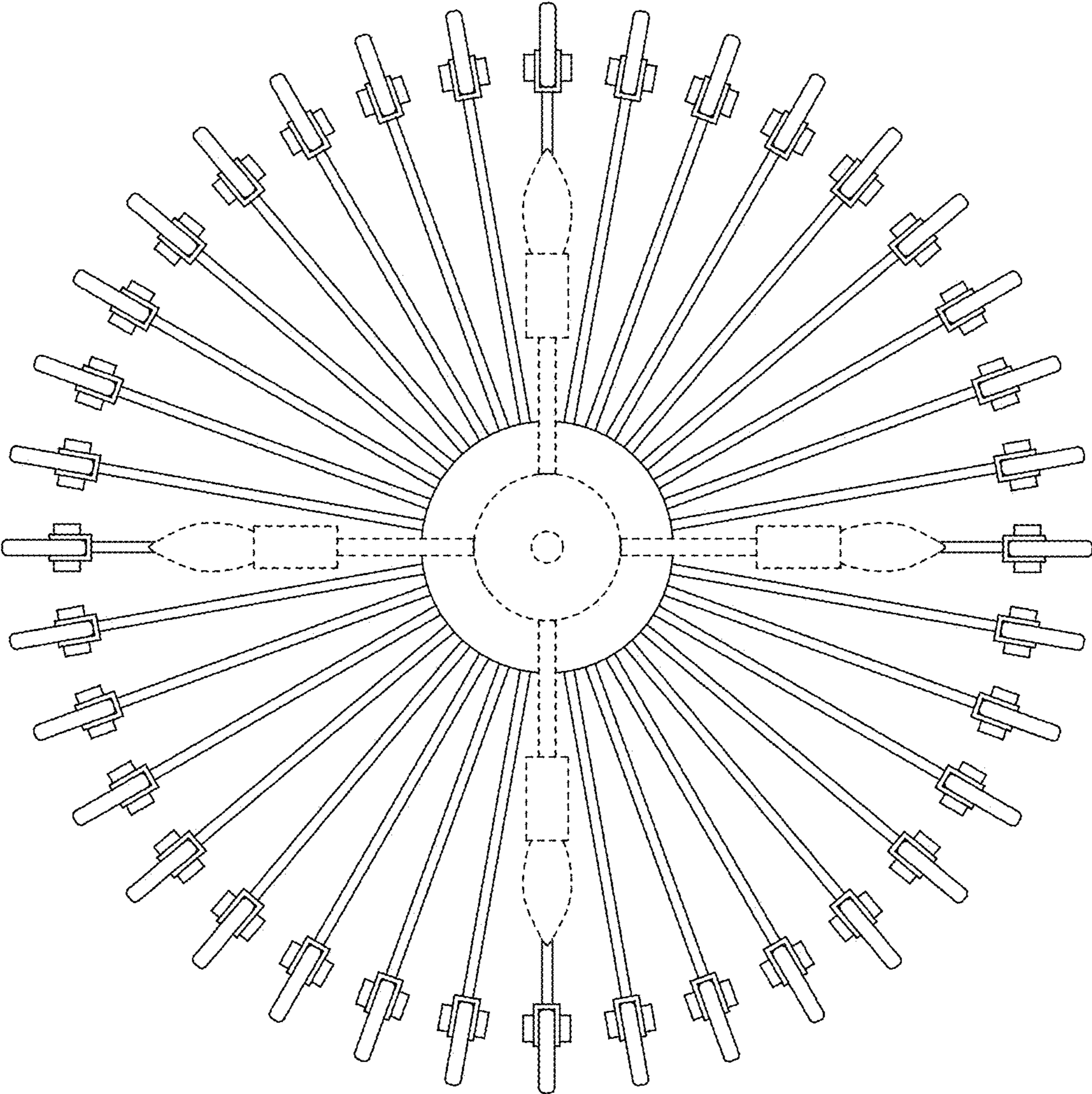

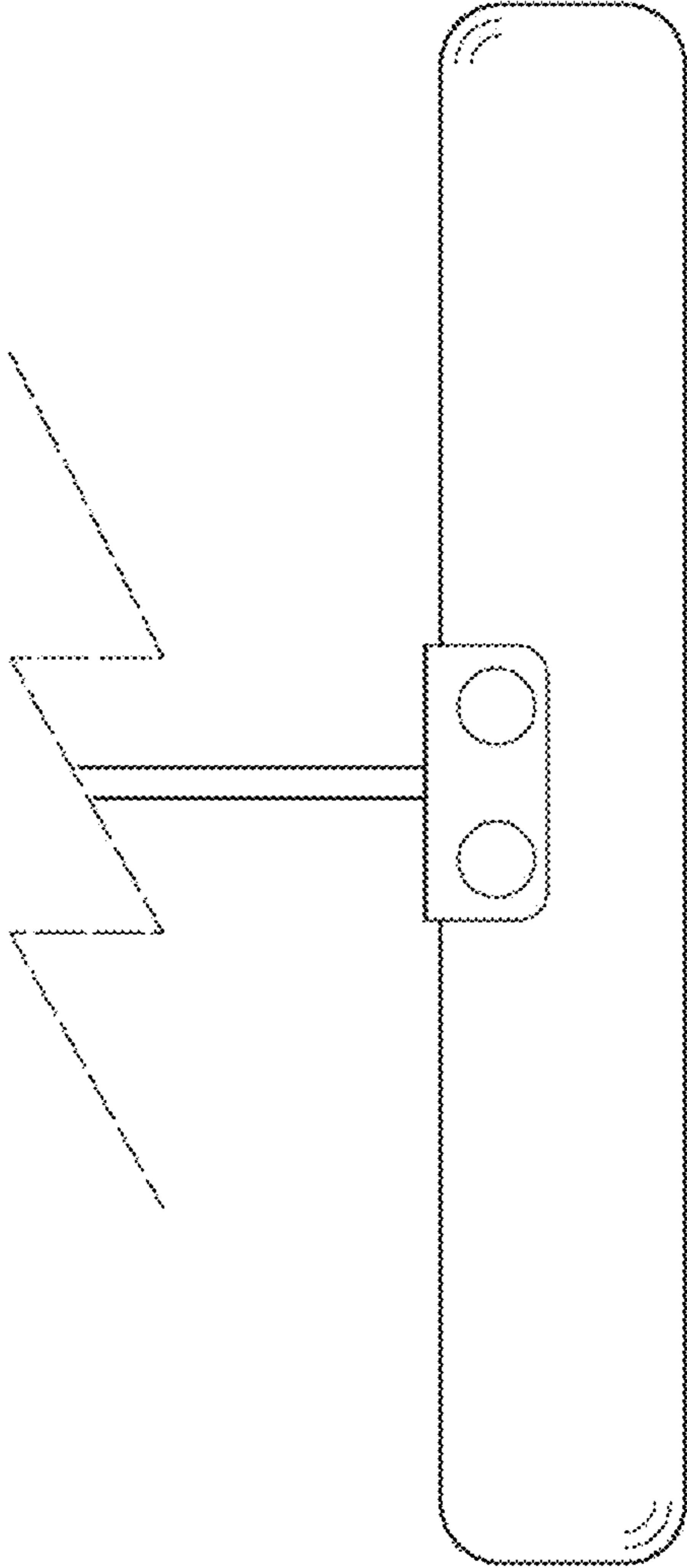

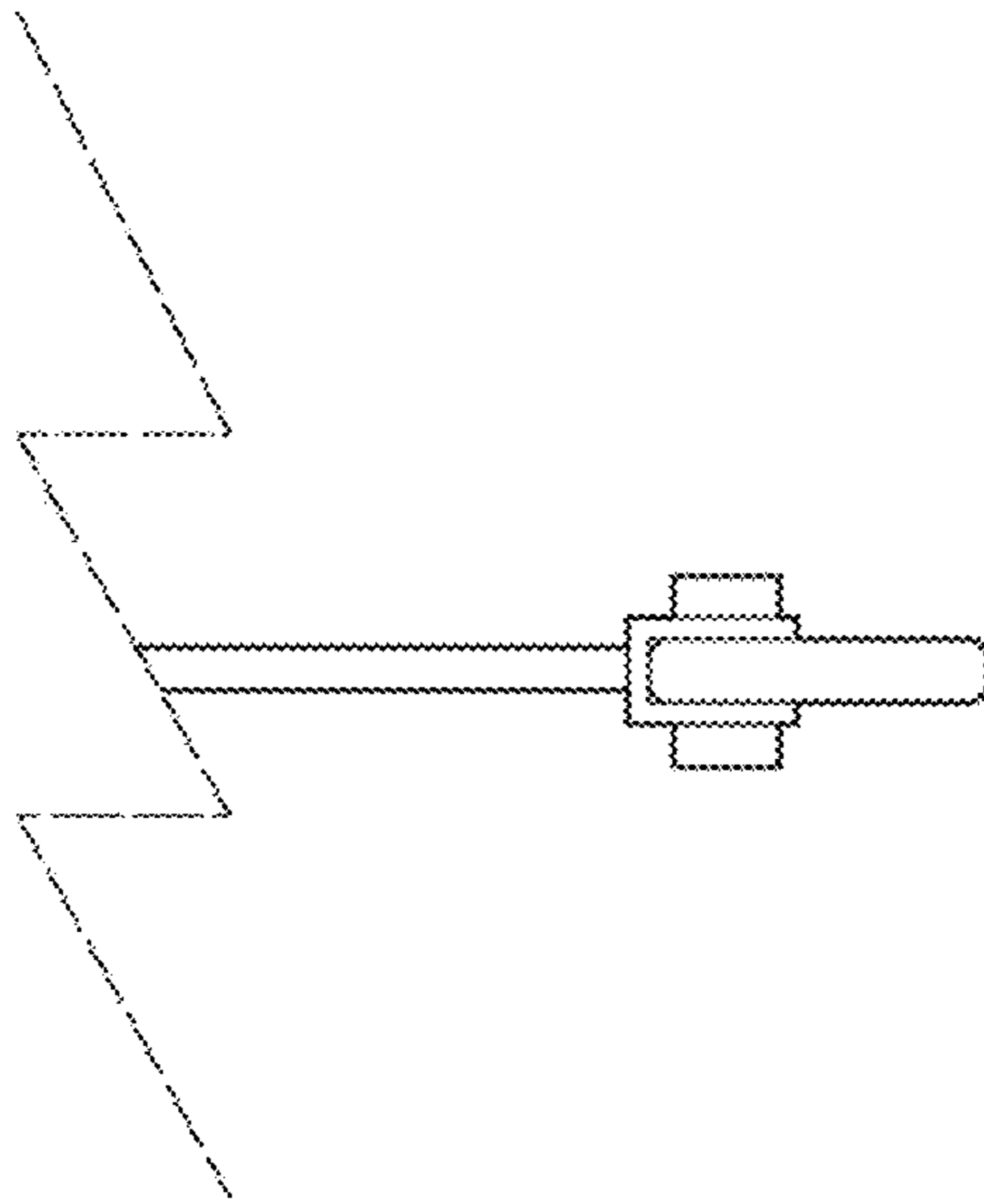
