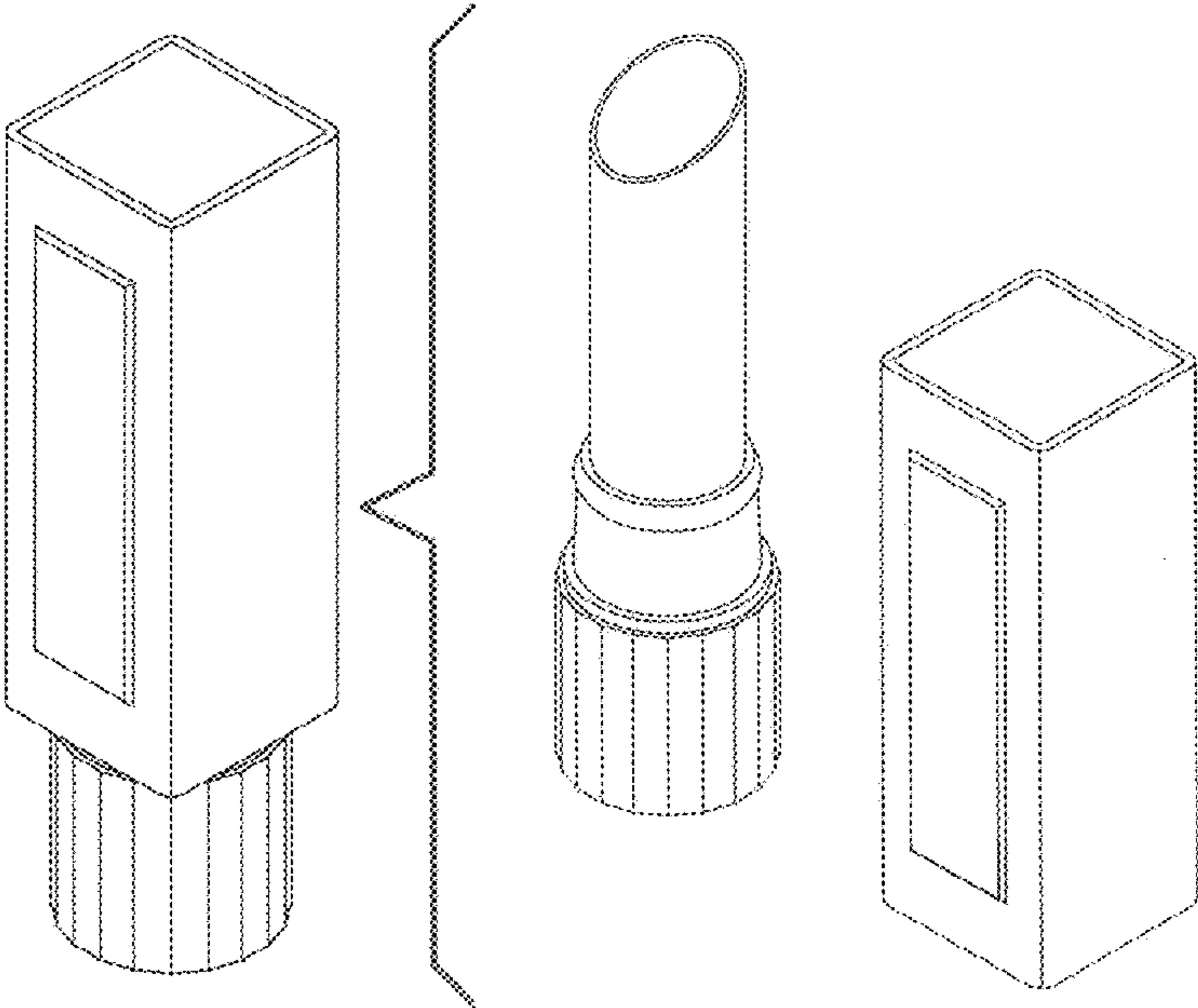
(57) CLAIM

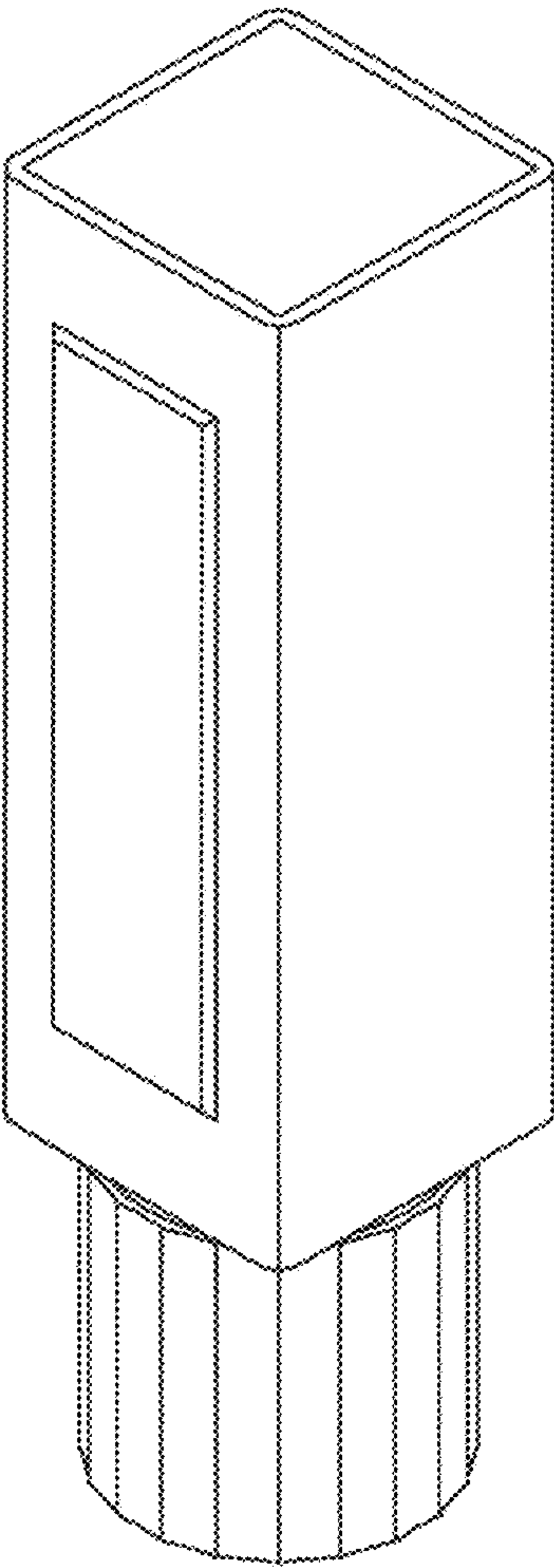

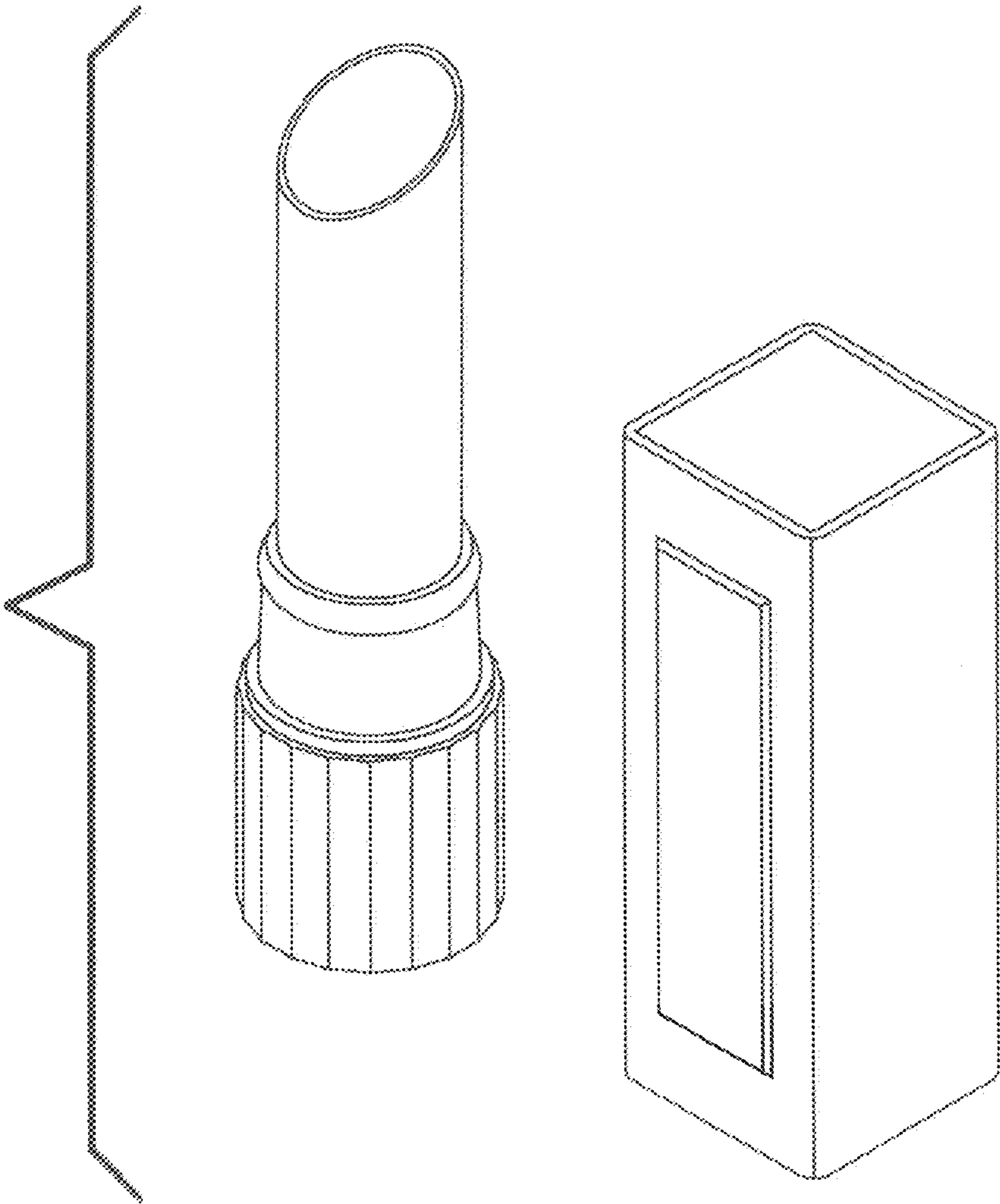

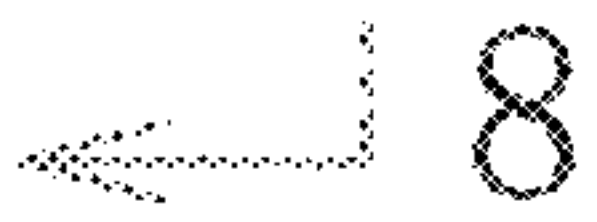
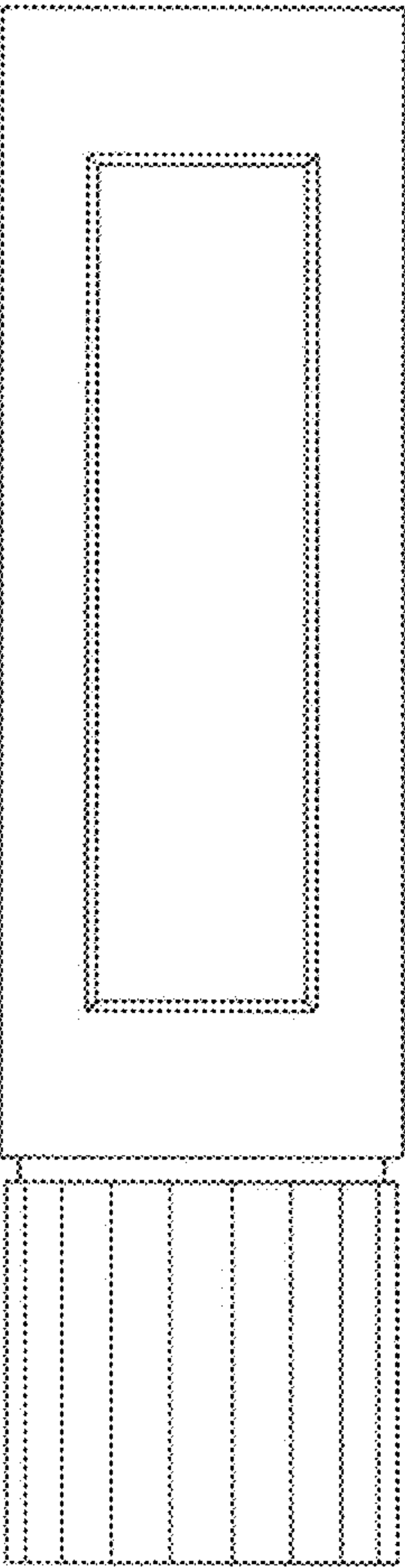

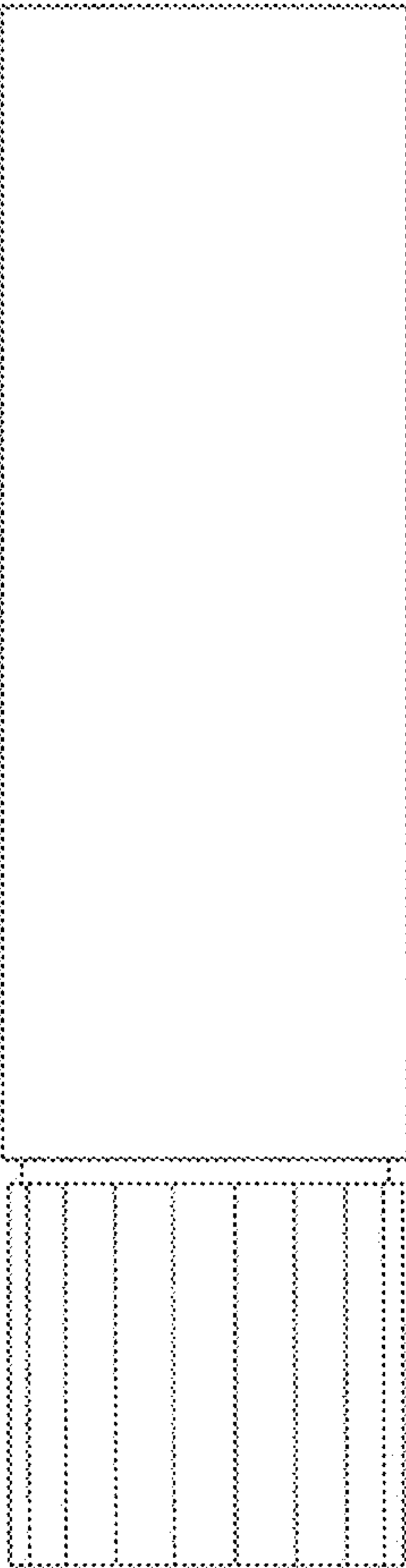

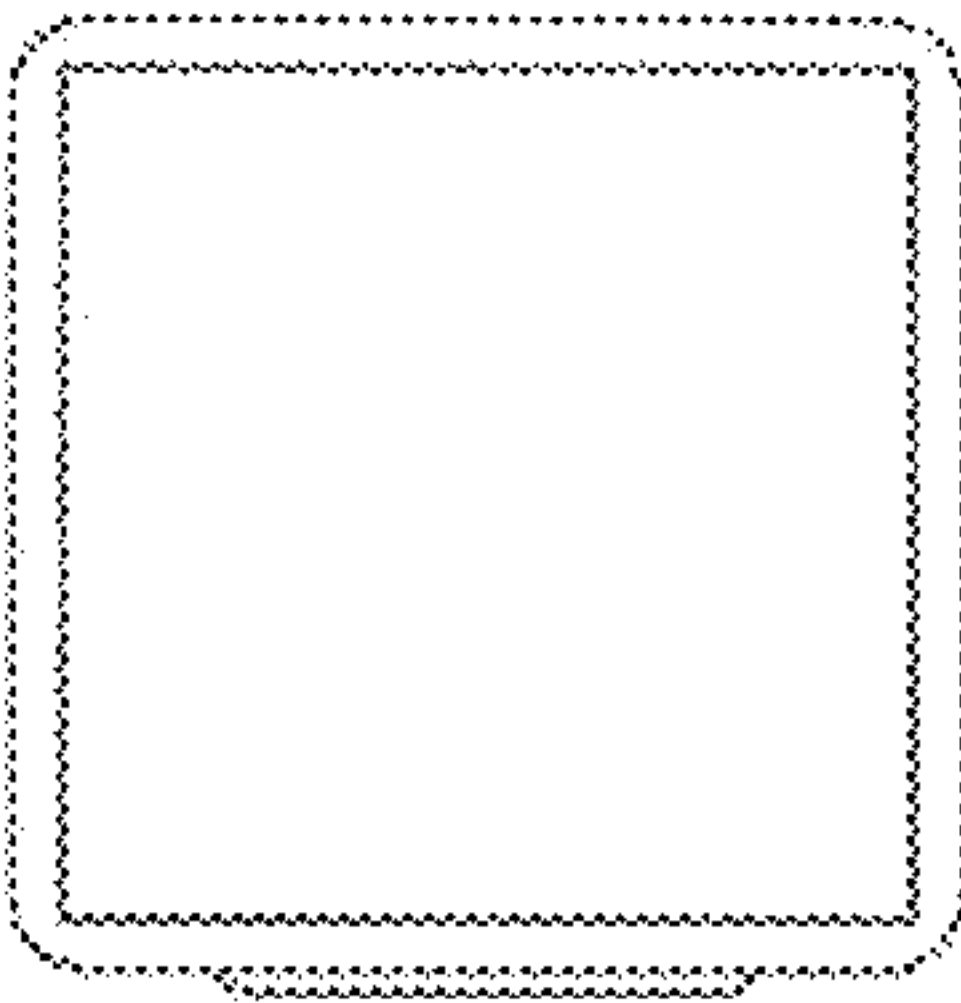

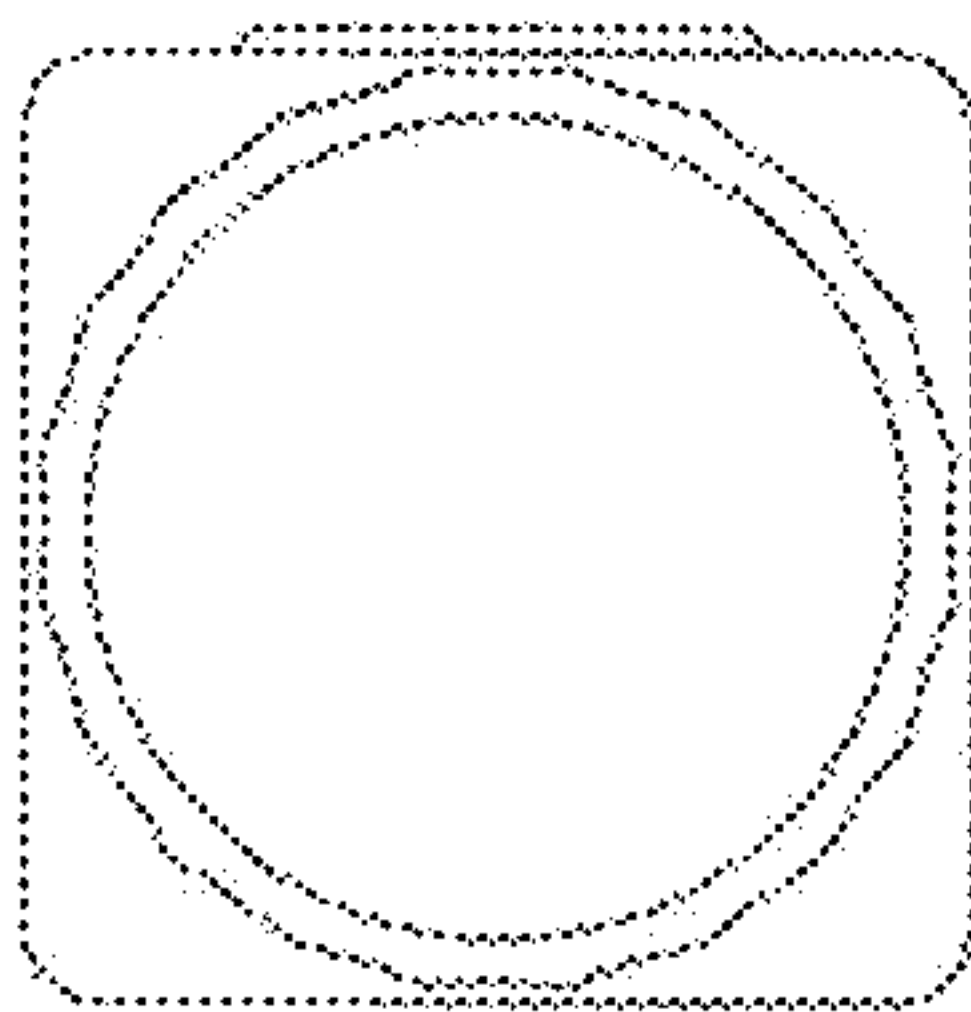

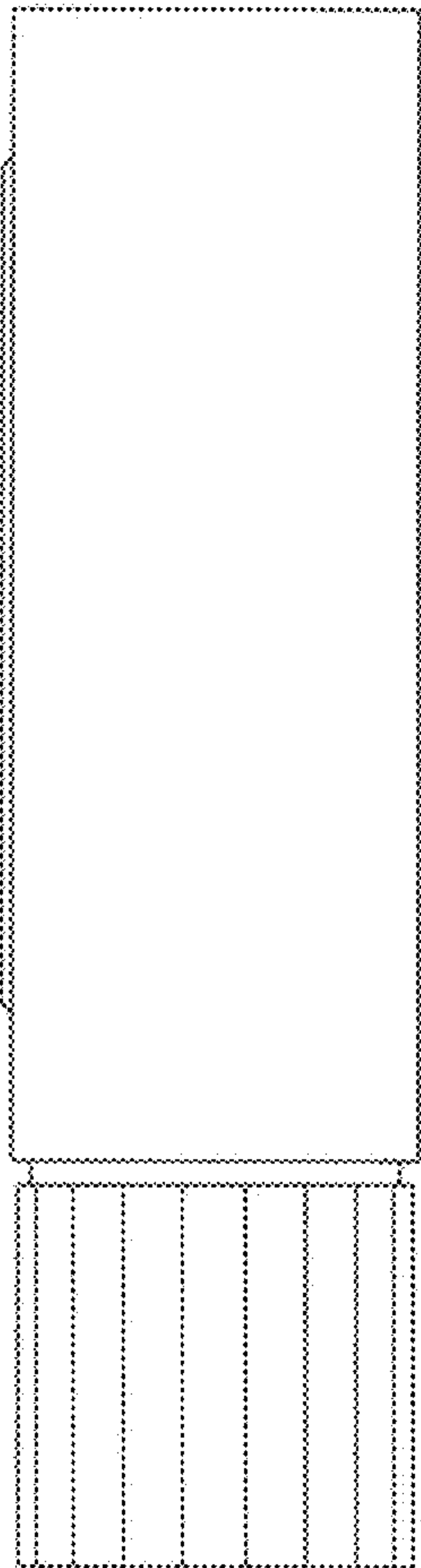
