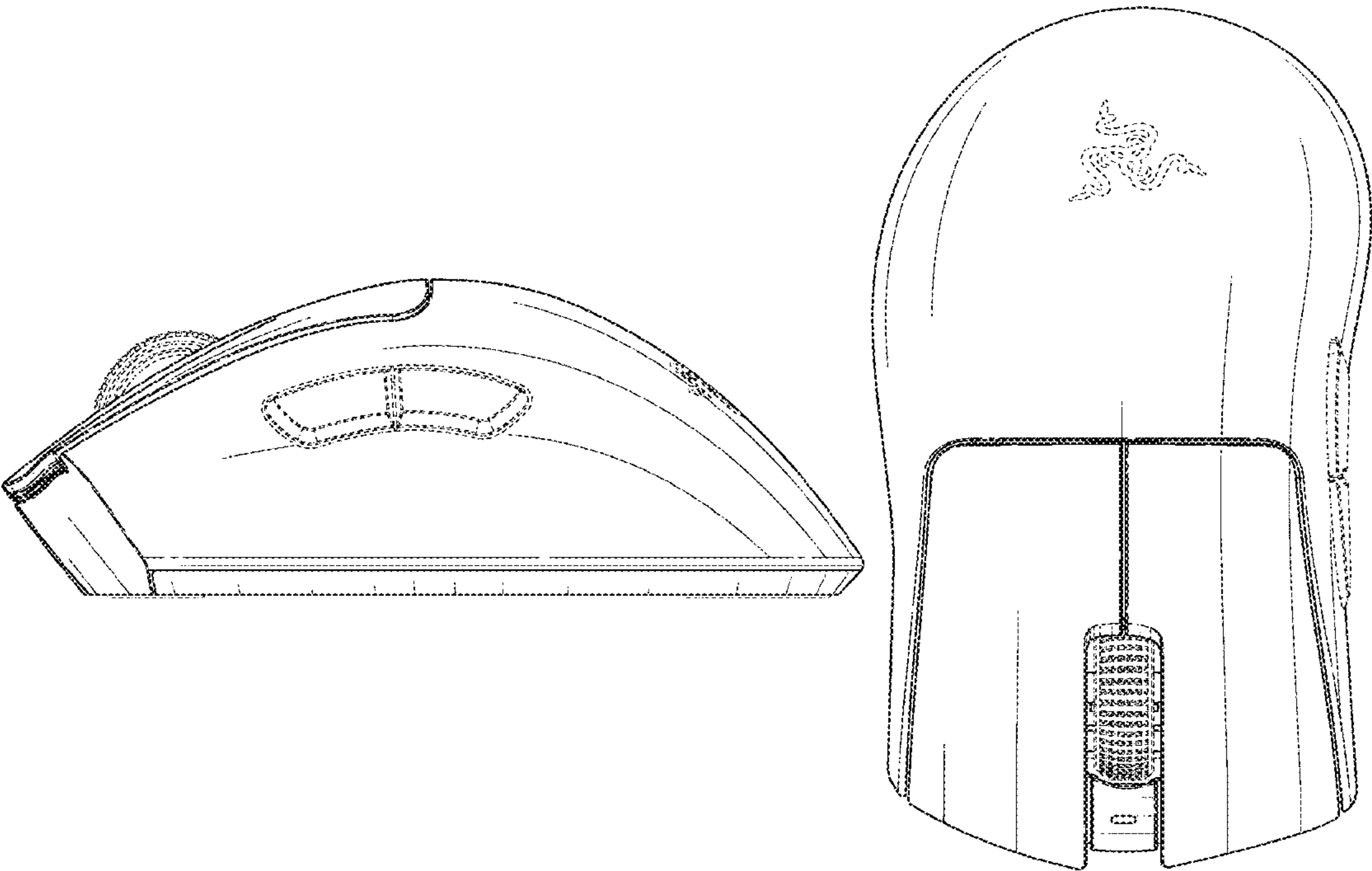
(57) CLAIM

The ornamental design for a mouse, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mouse, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines shown in the Figures are environment only and show portions of the mouse that form no part of the claimed design. The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.
The shade lines in the Figures show contour and do not claim surface ornamentation or treatment.

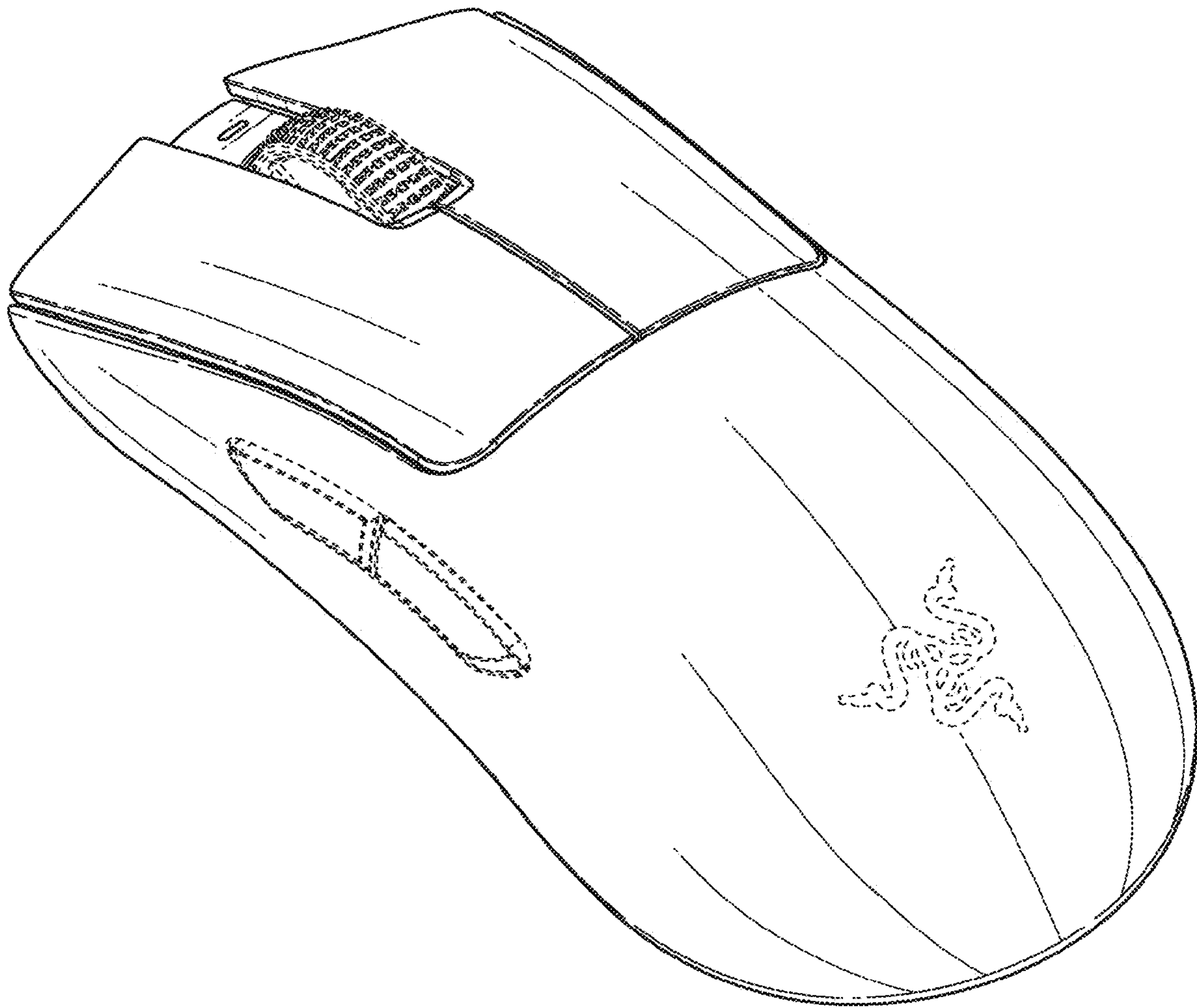

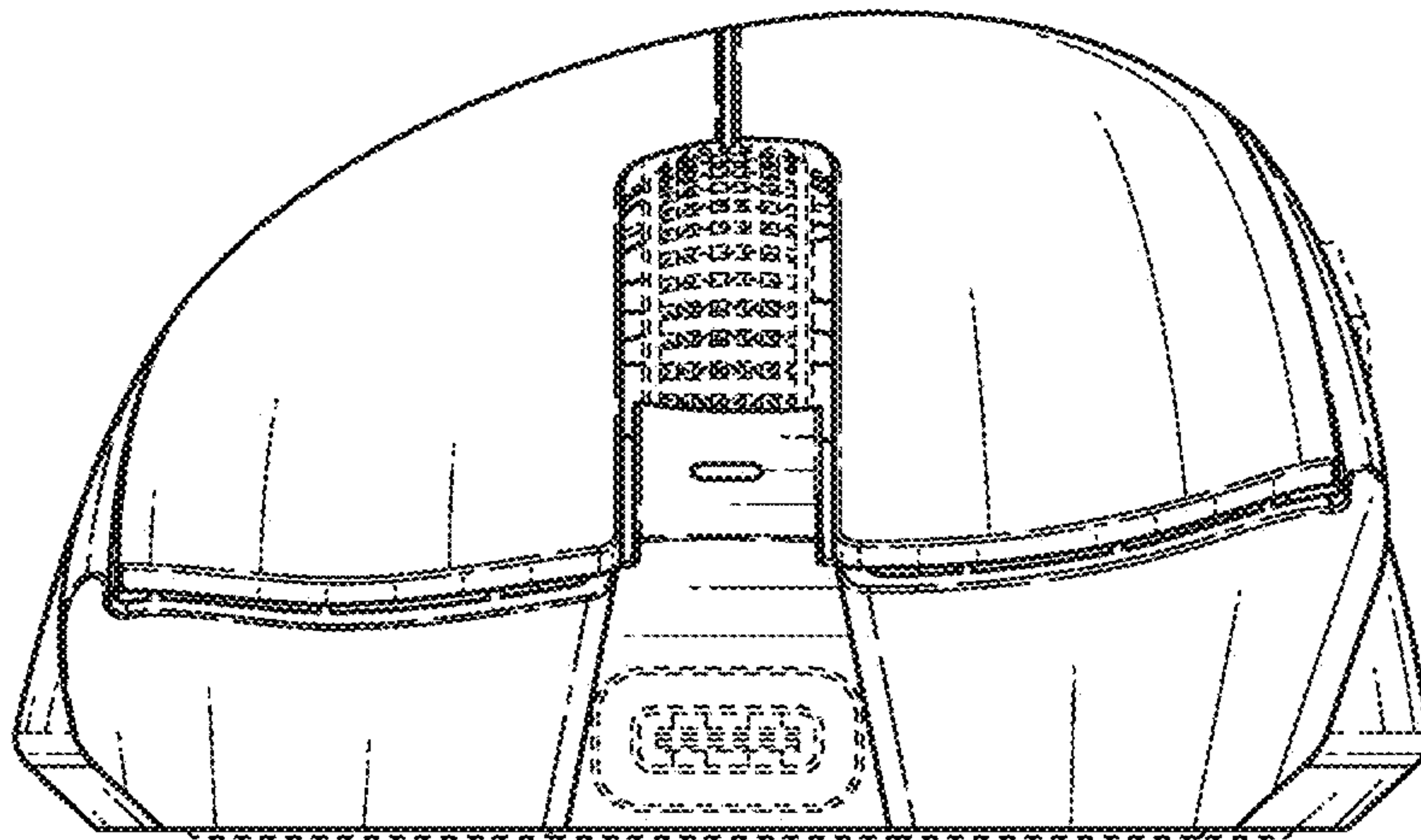

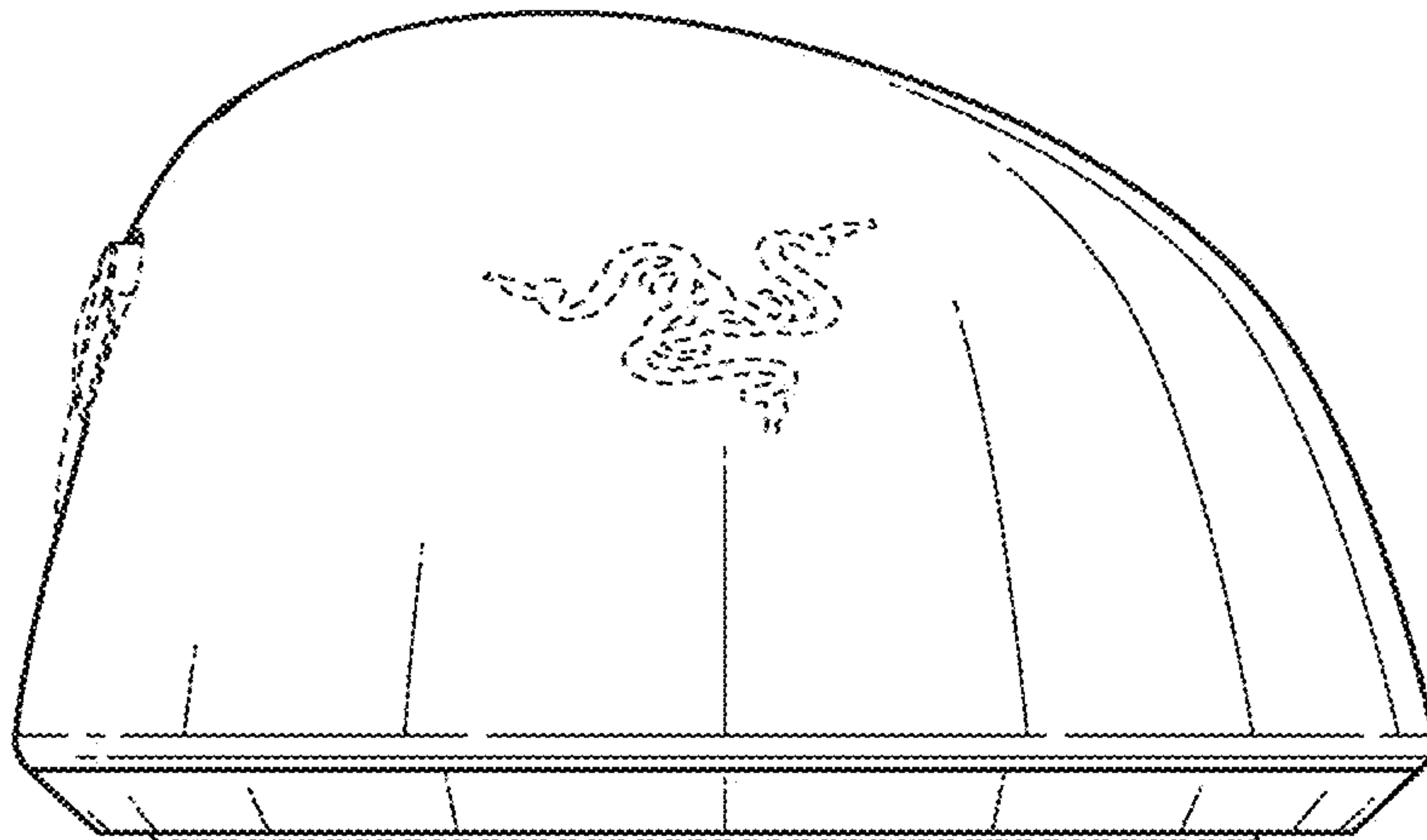

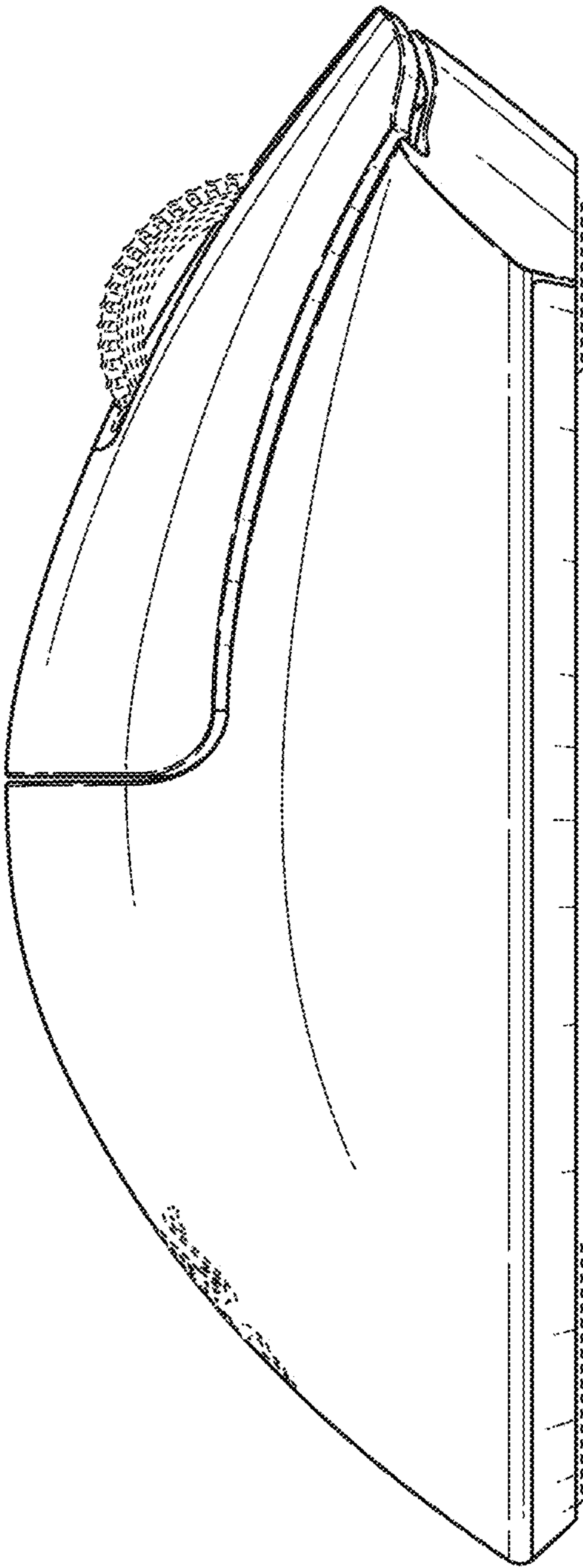

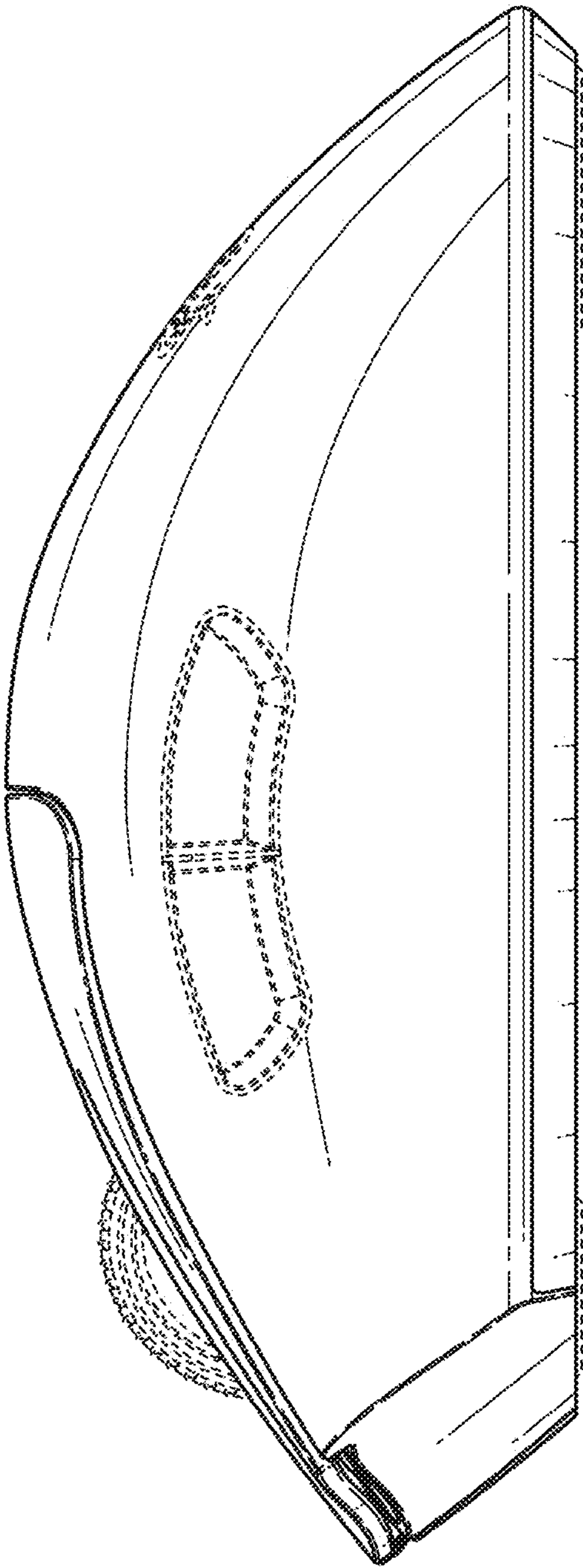

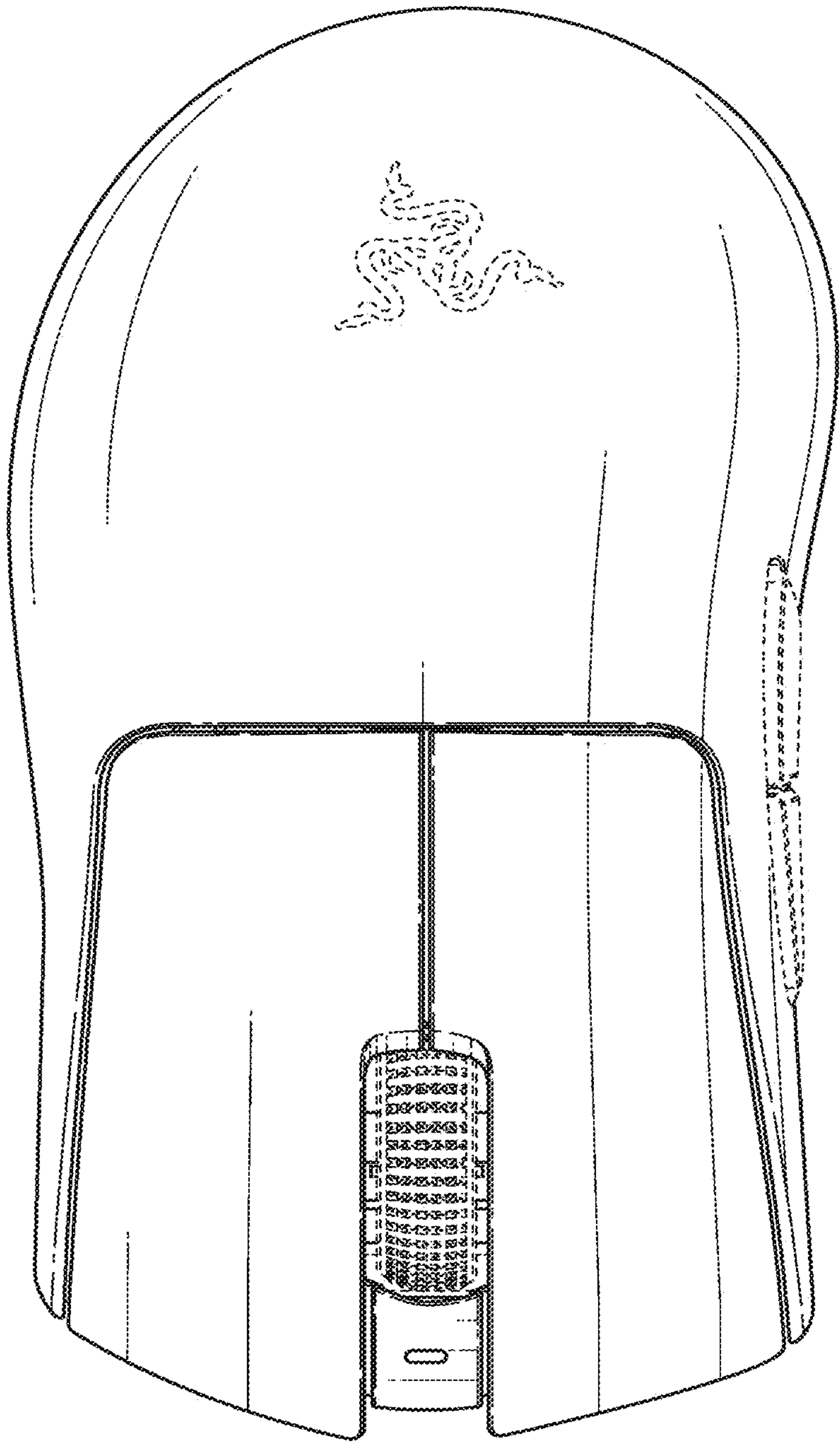

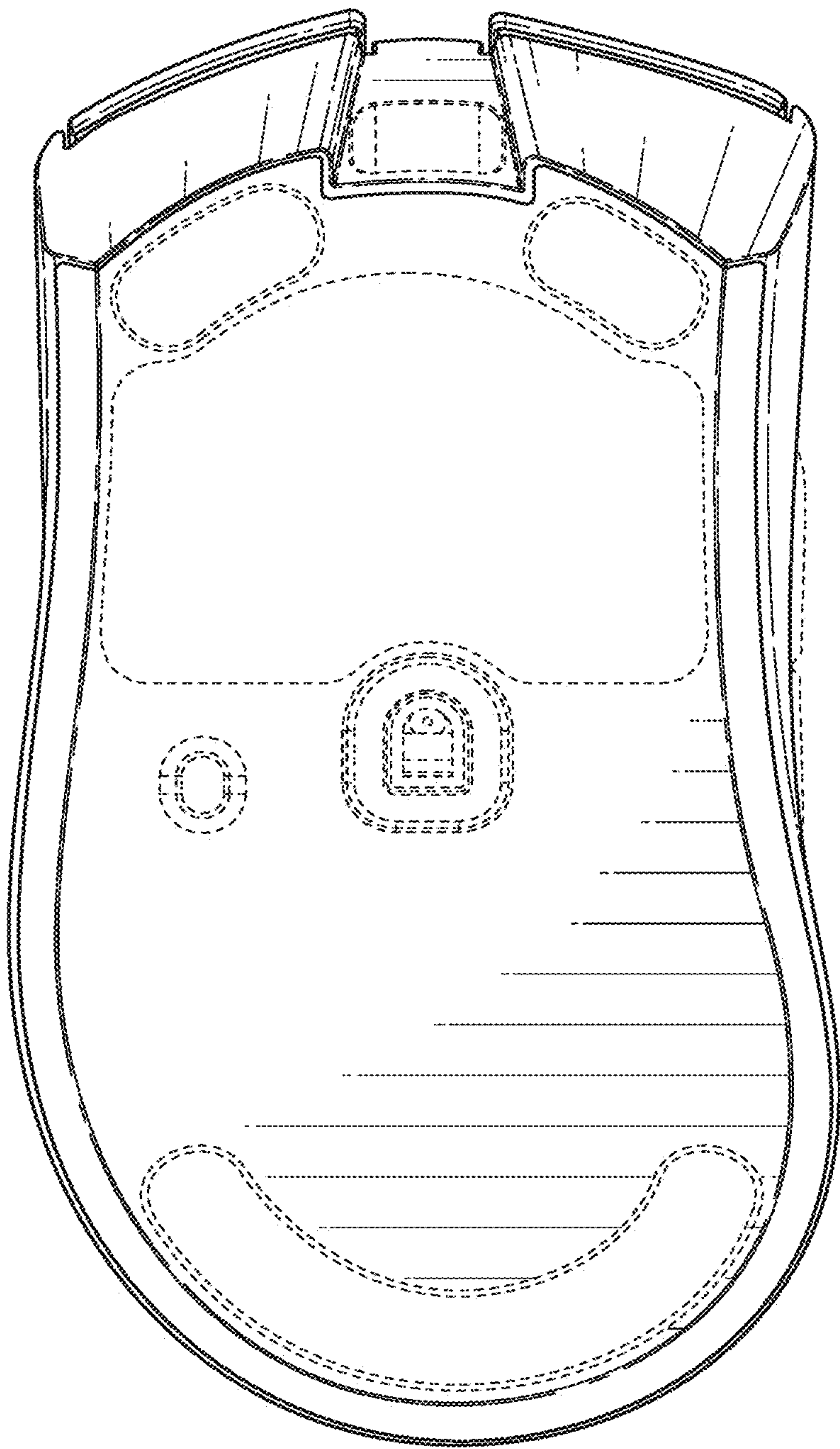
