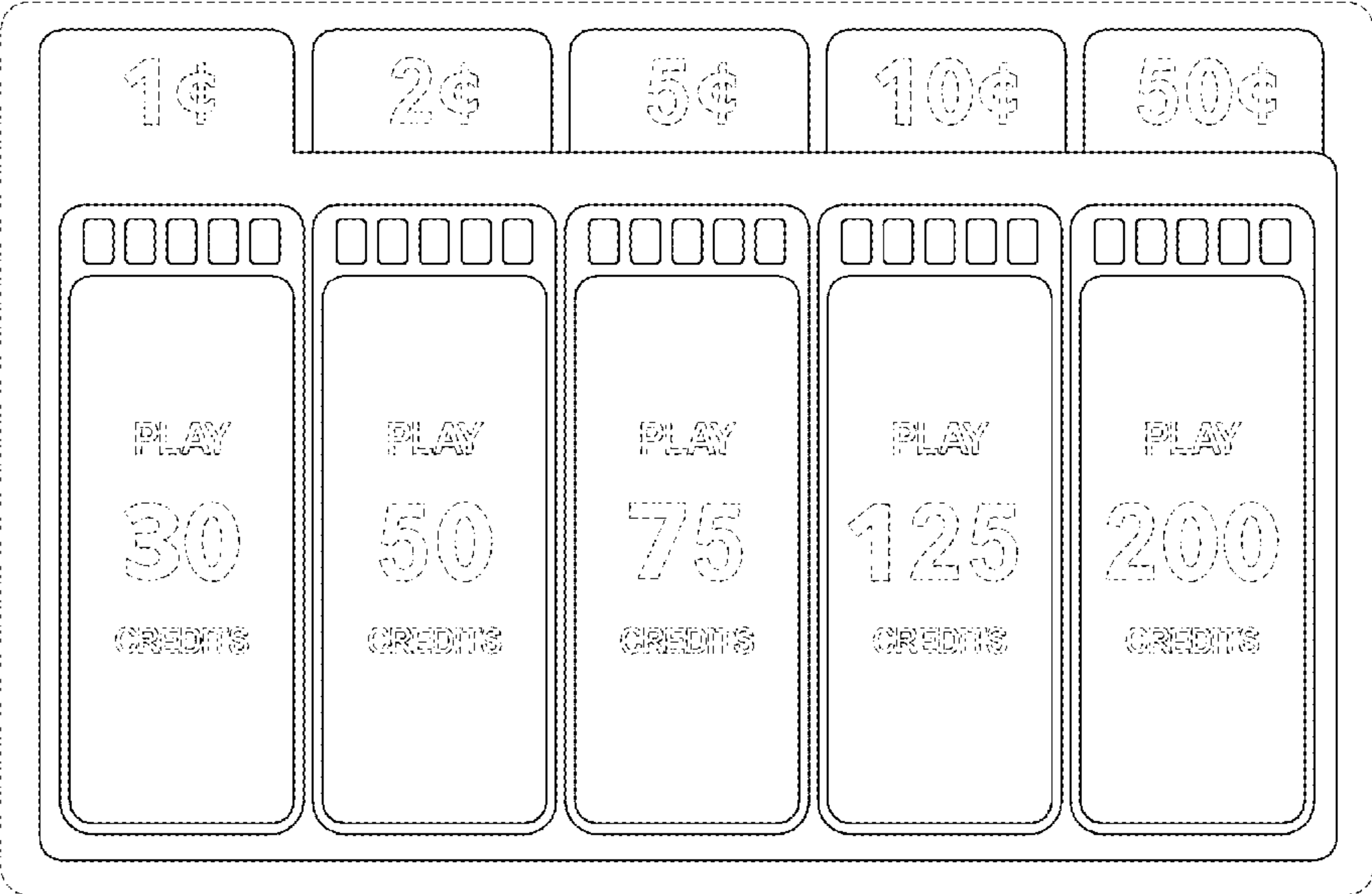
The ornamental design for a gaming machine computer betting display screen with graphical user interface, as shown and described.
