(57) CLAIM

We claim the ornamental design for an air ventilation system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an air ventilation system showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

FIG. 5 is a right-side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a perspective view thereof, showing the door opened.

The broken lines shown in FIGS. 1-8 depict portions of the air ventilation system and form no part of the claimed design.

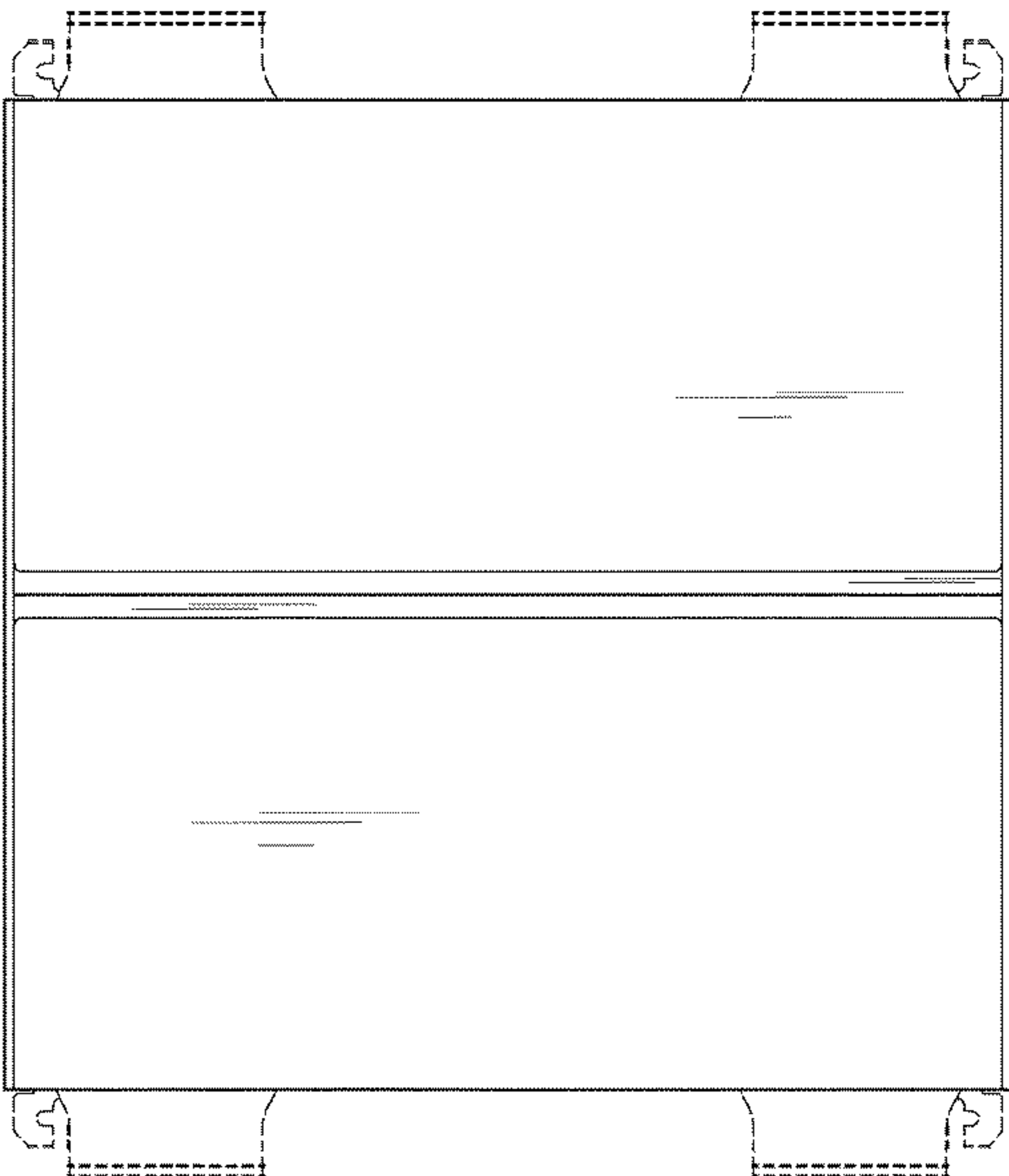
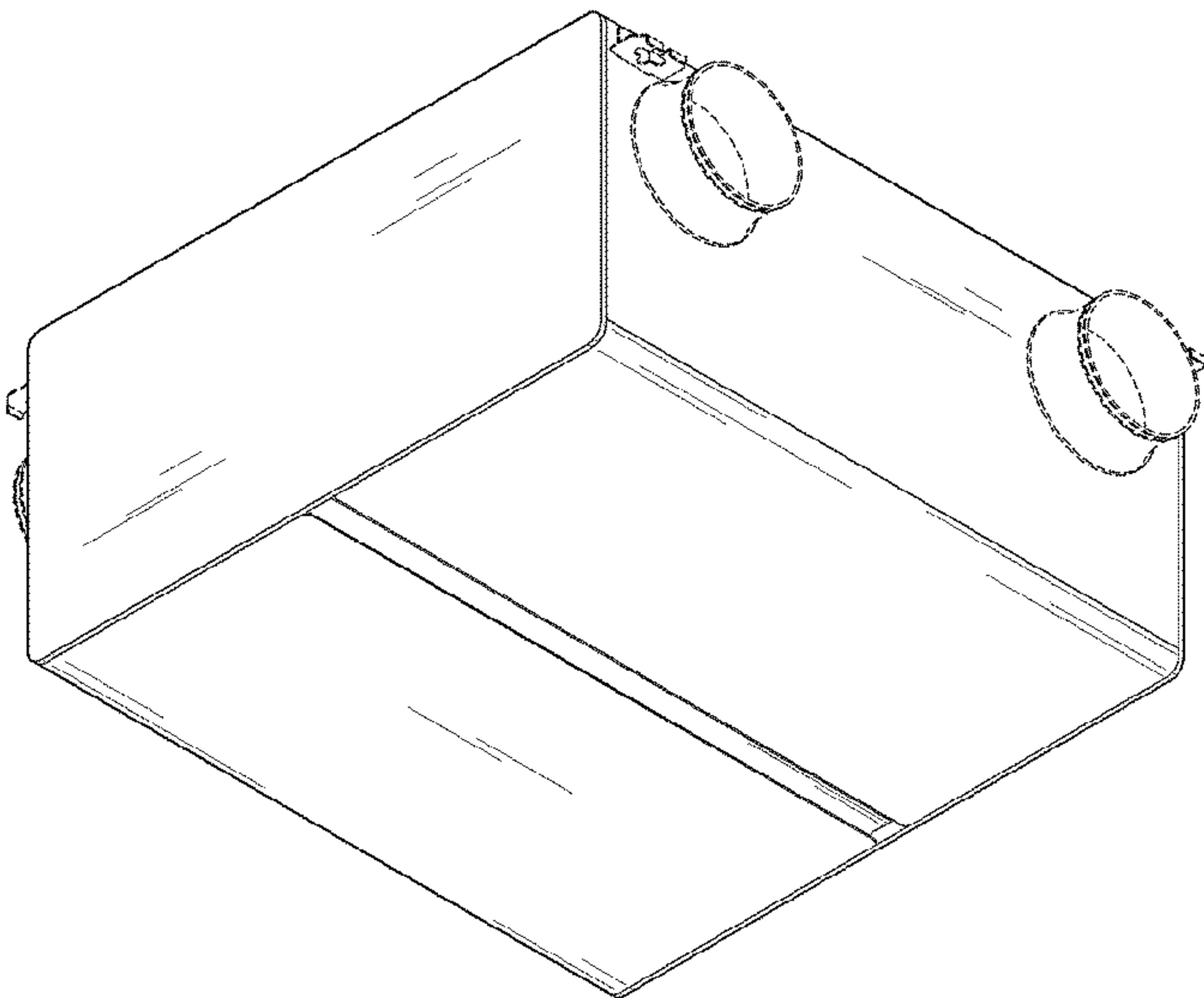

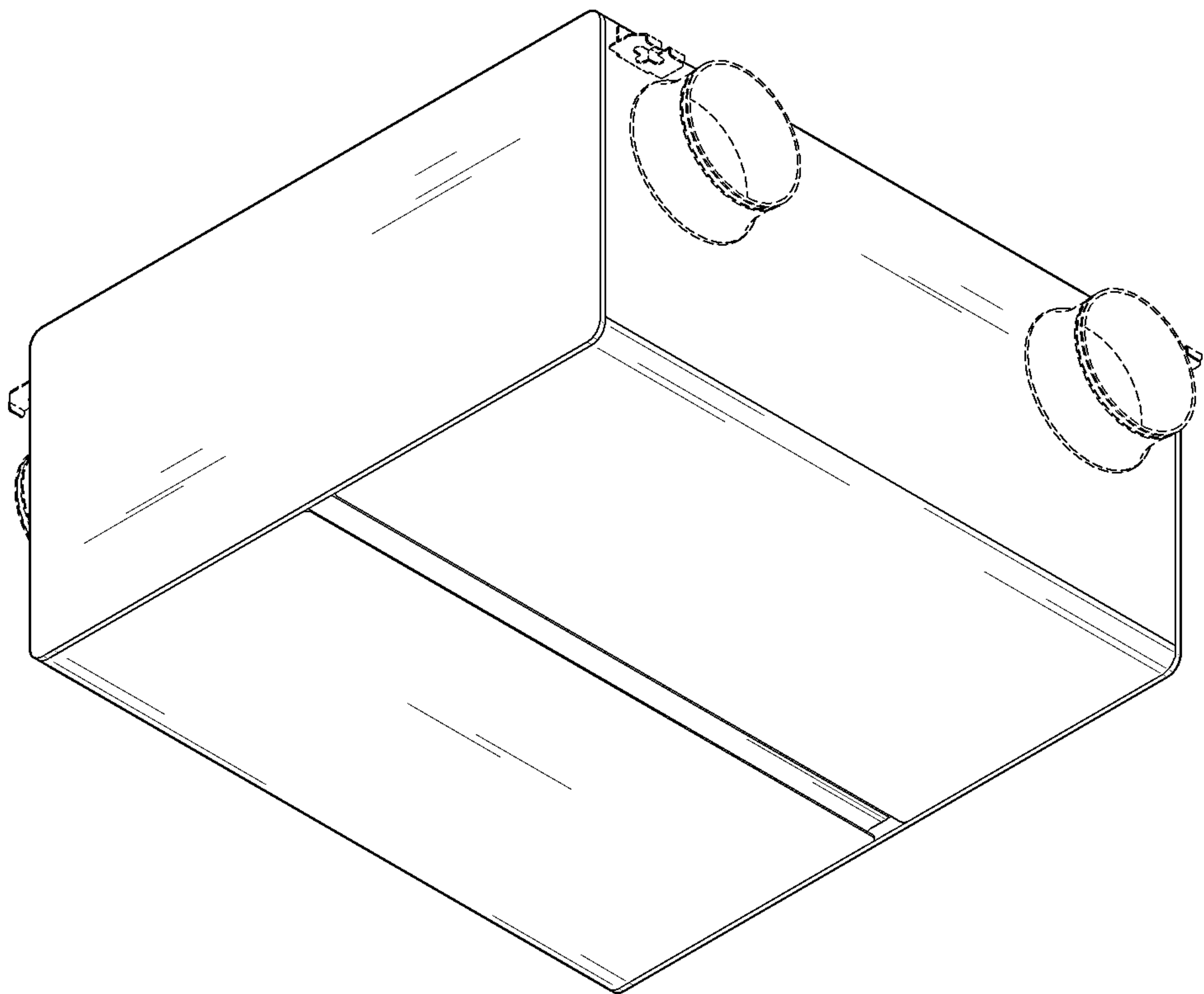

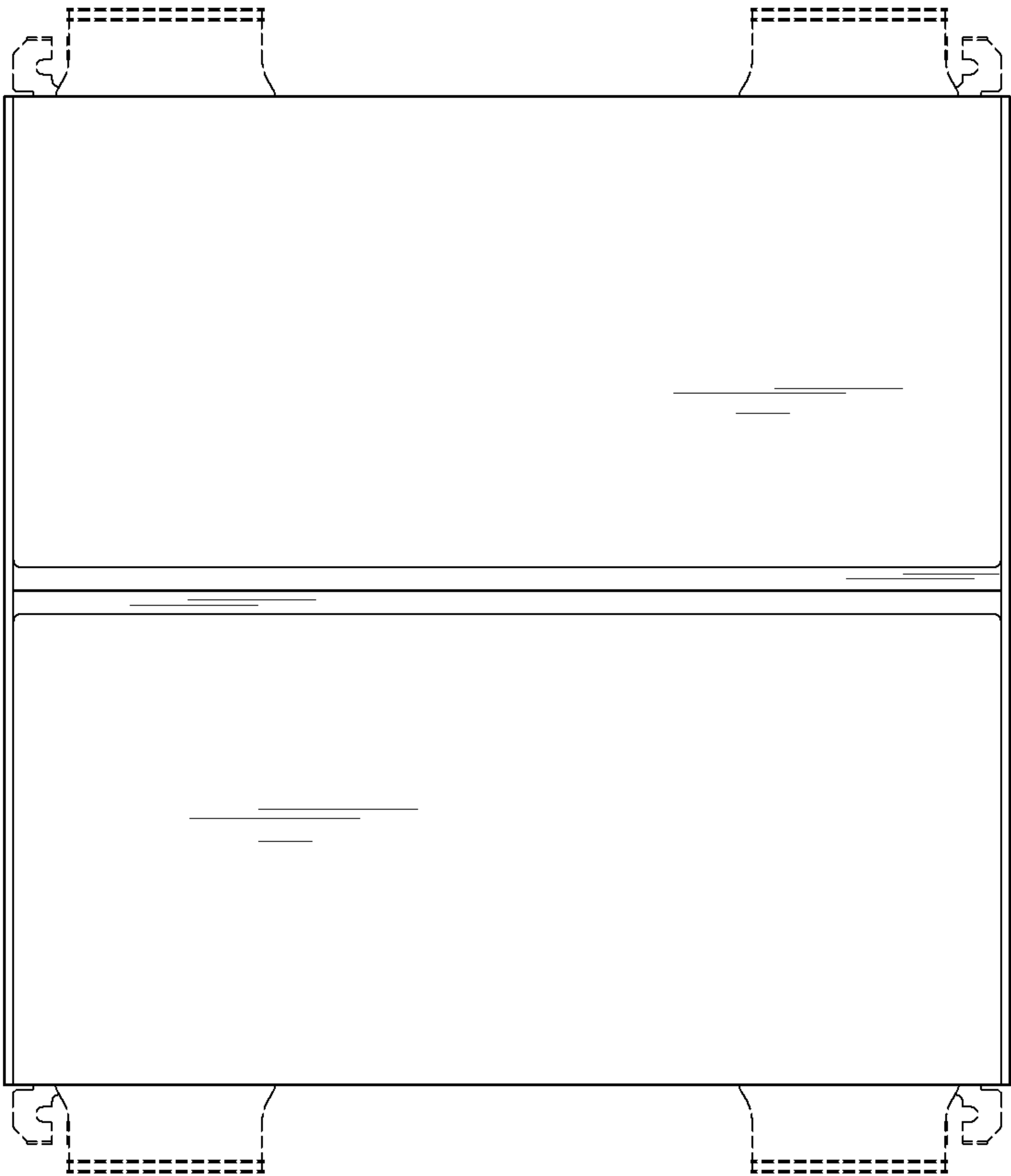

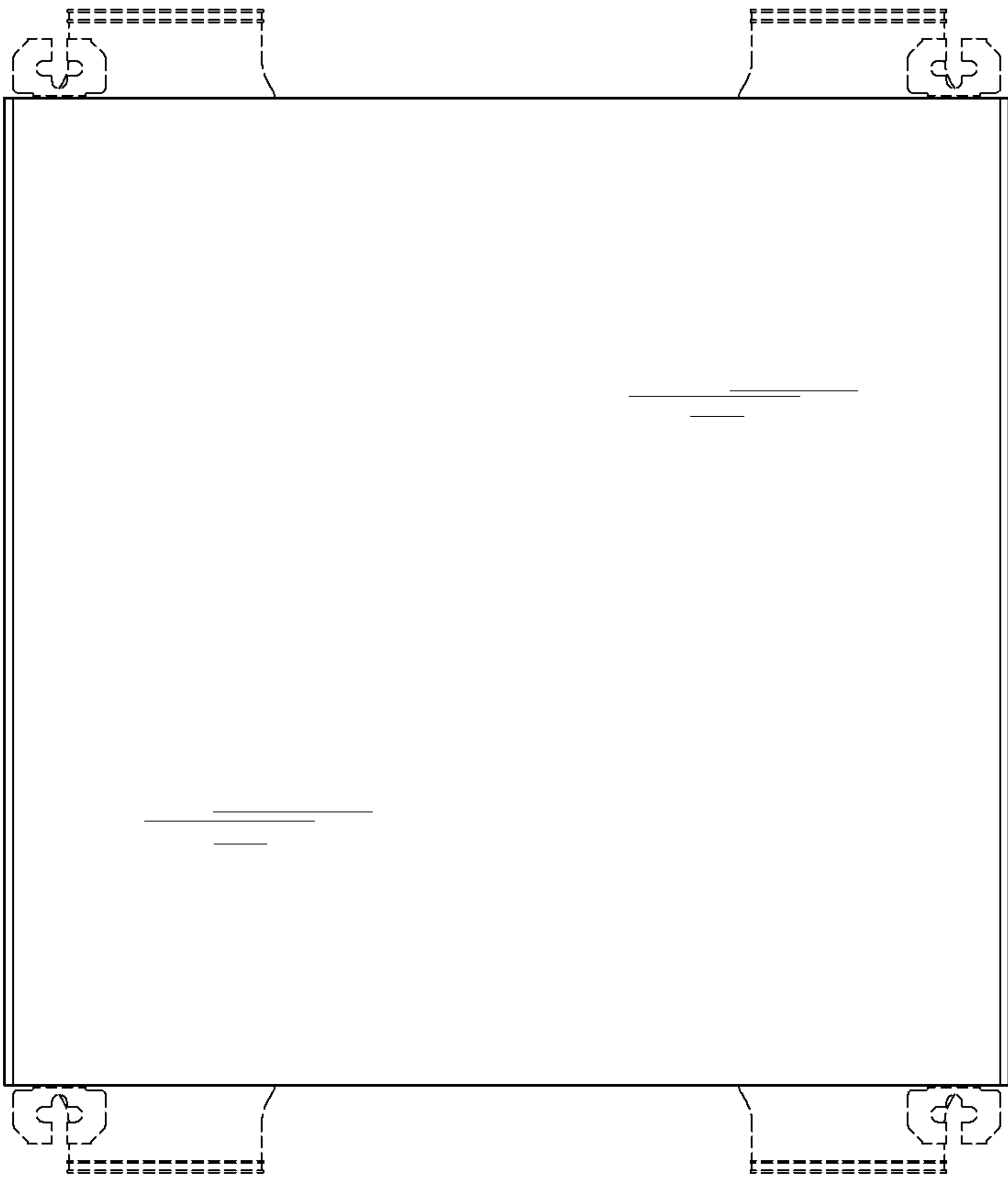

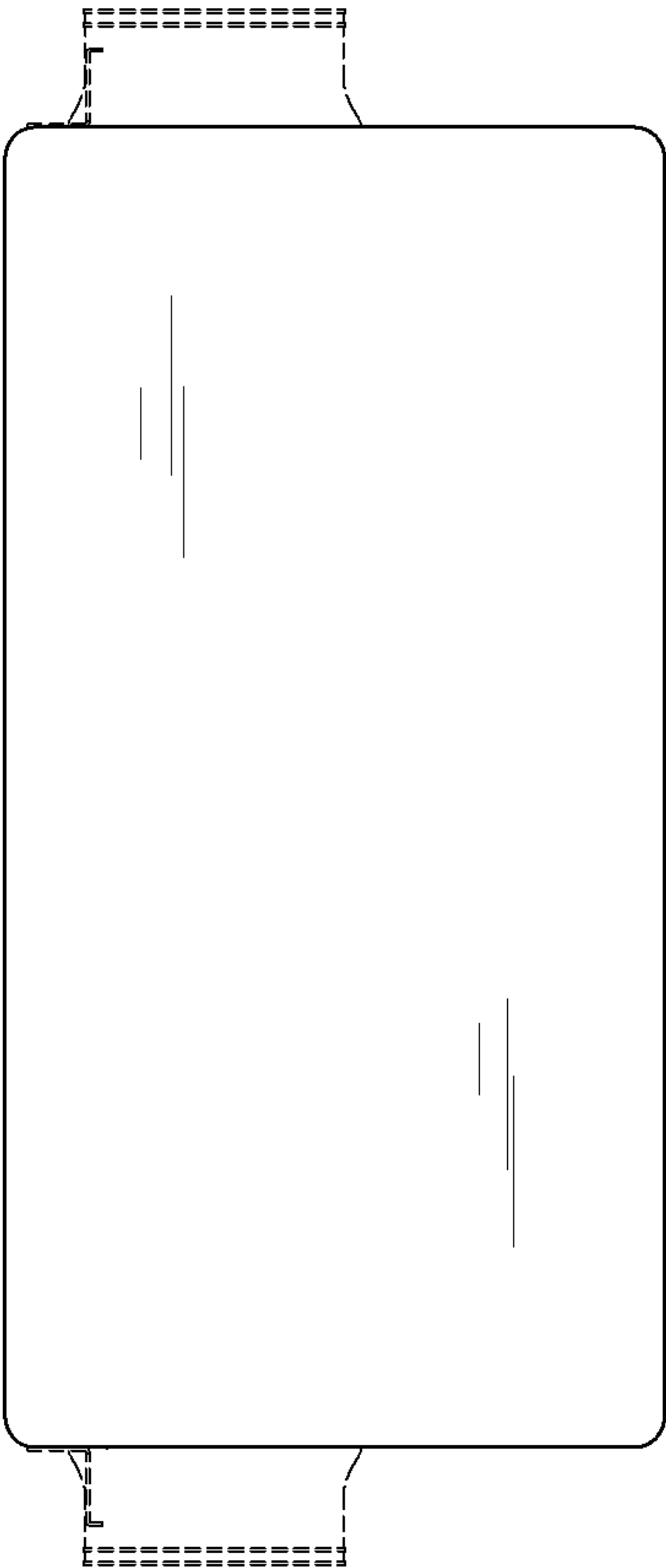

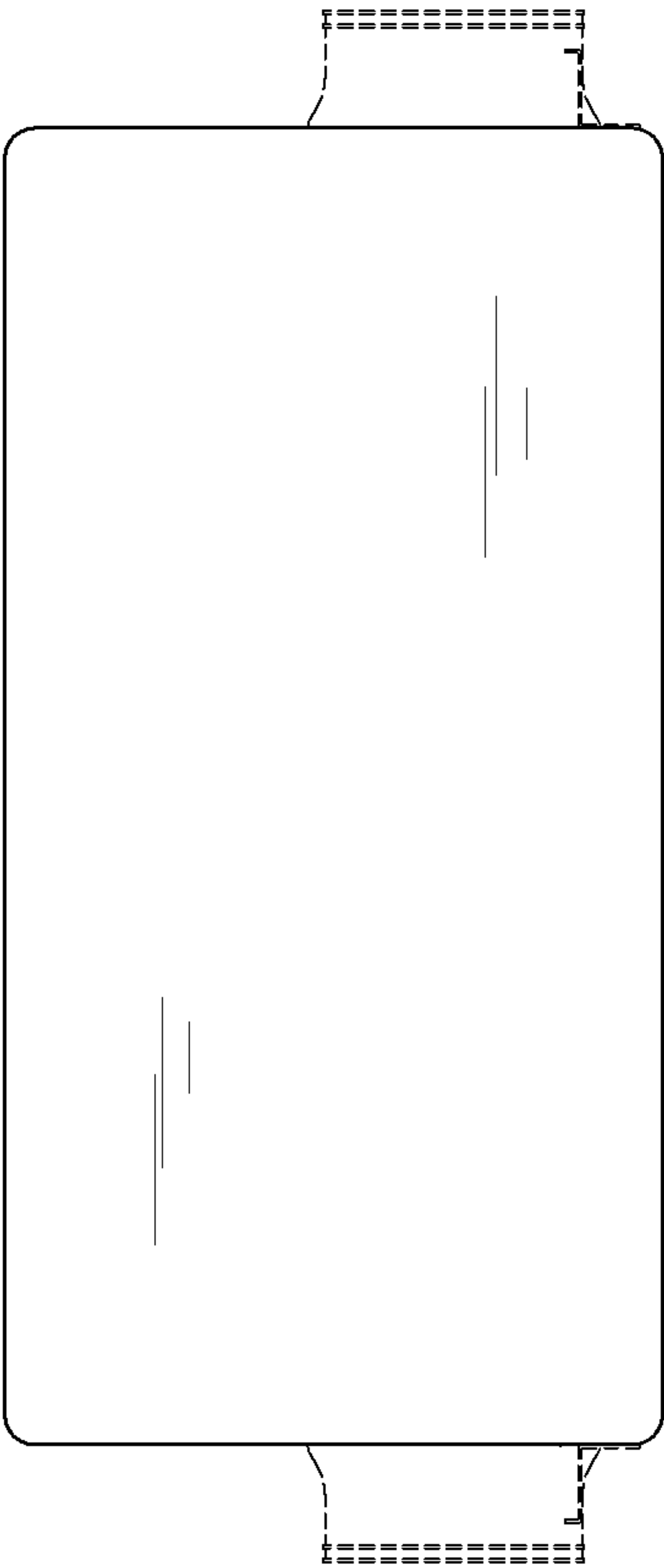

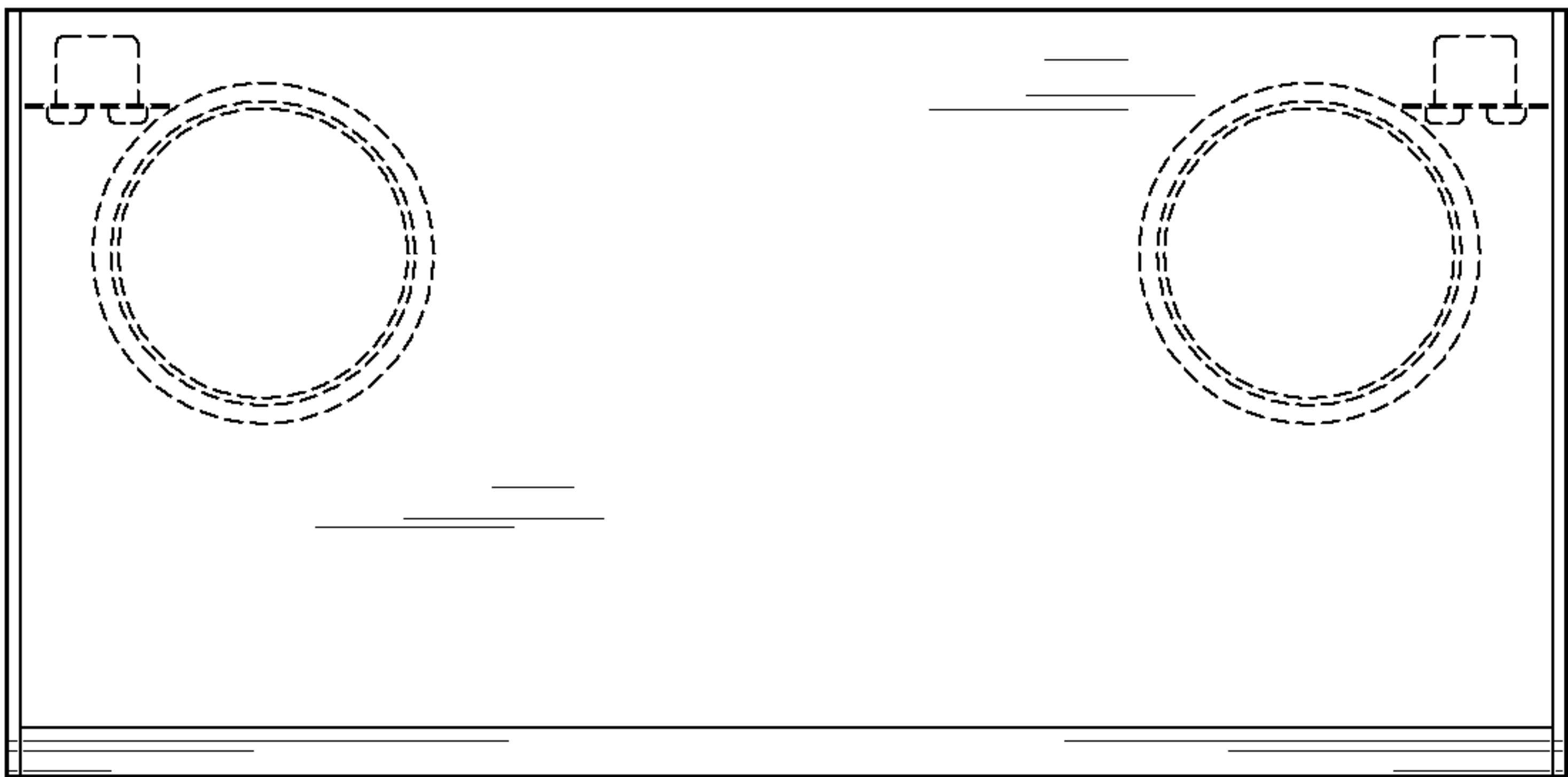

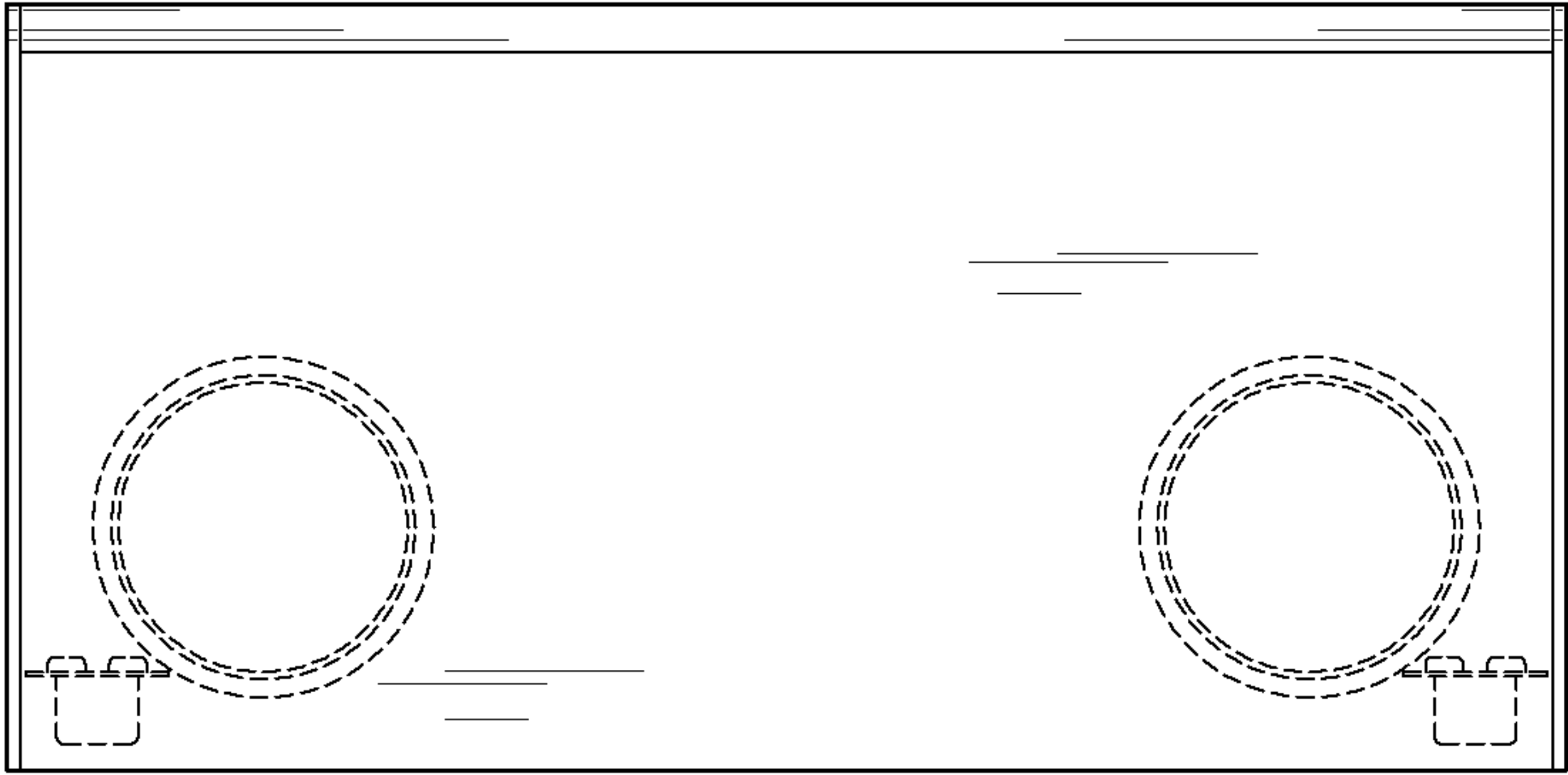
