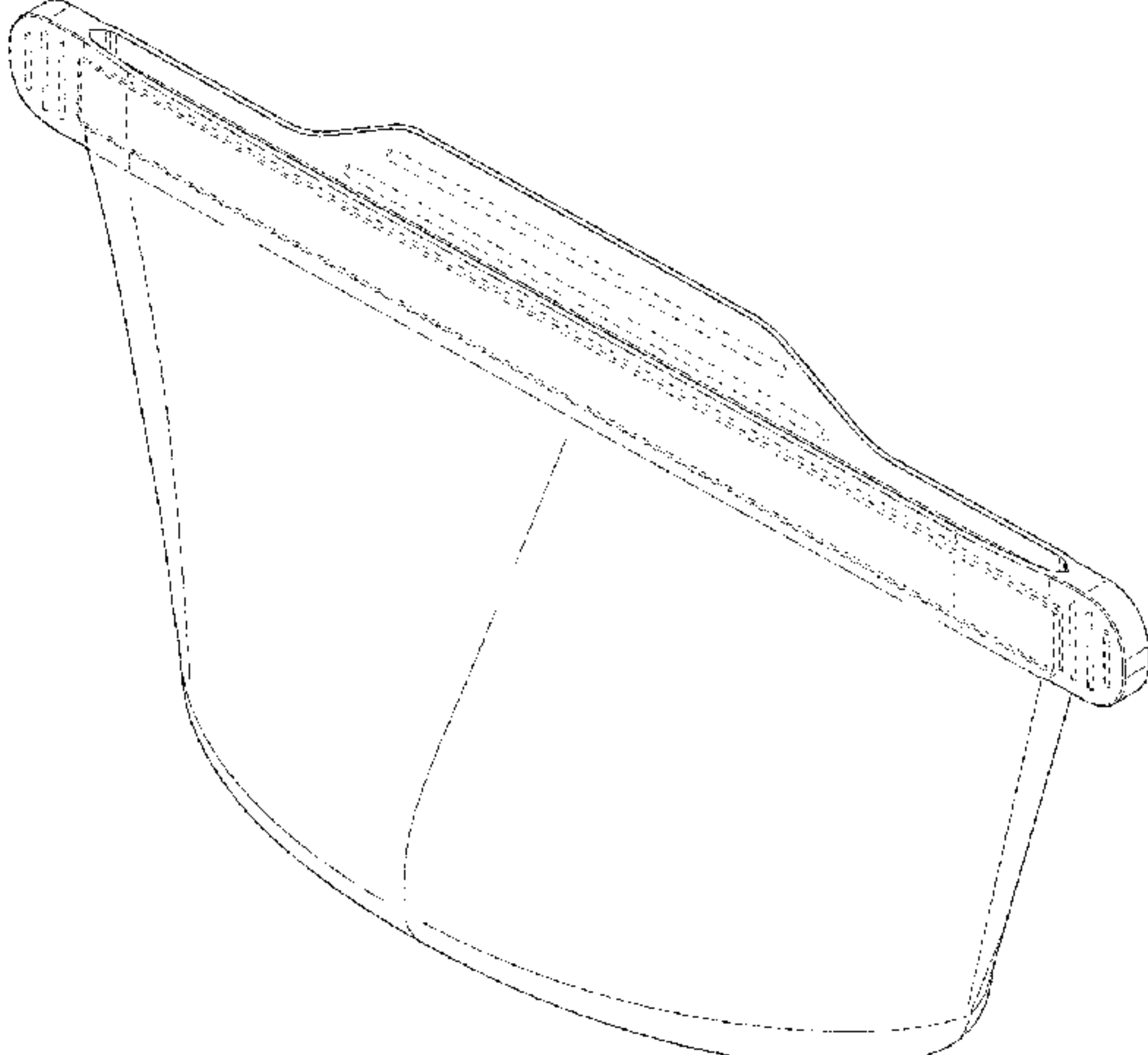
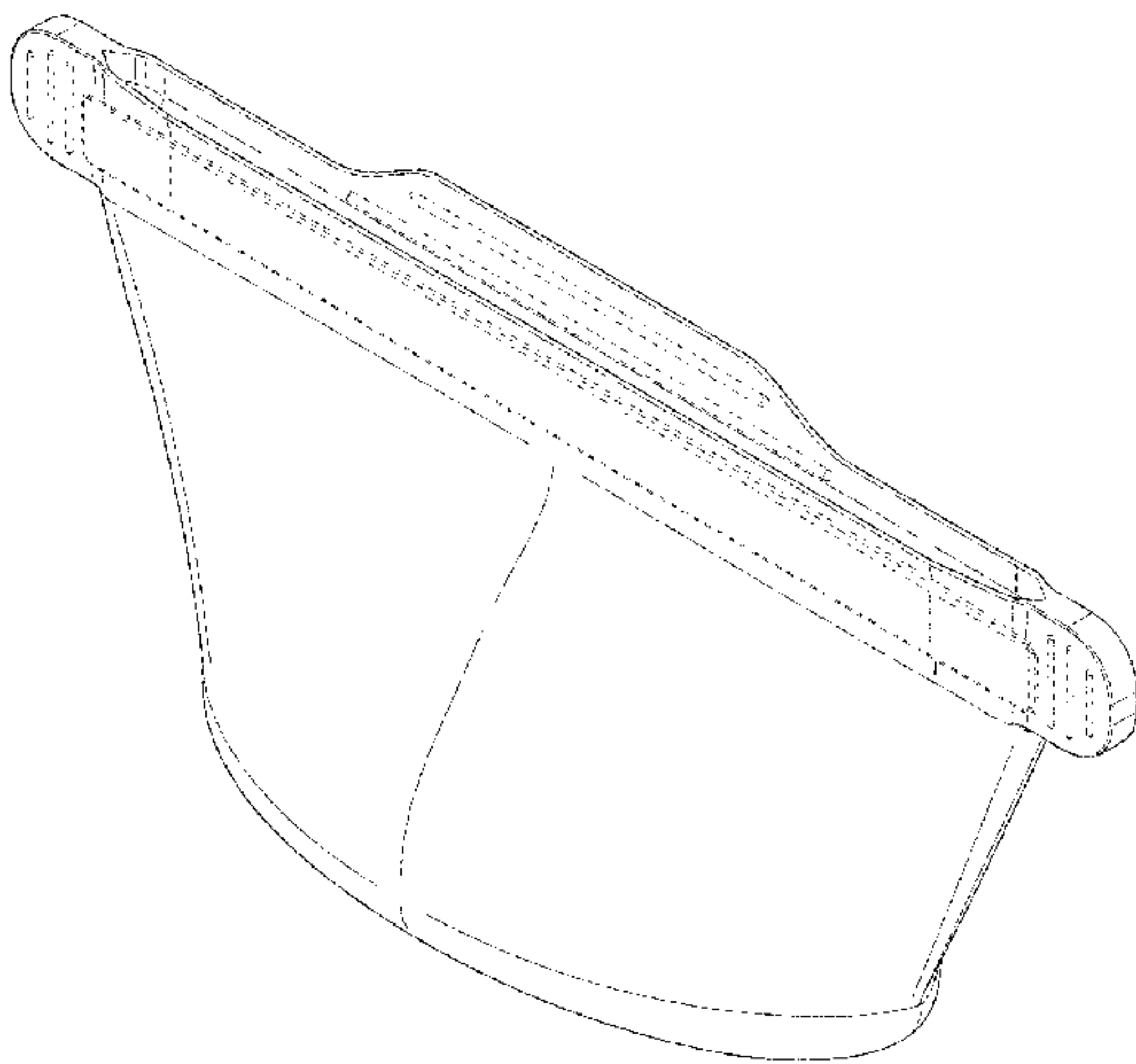
(57) CLAIM

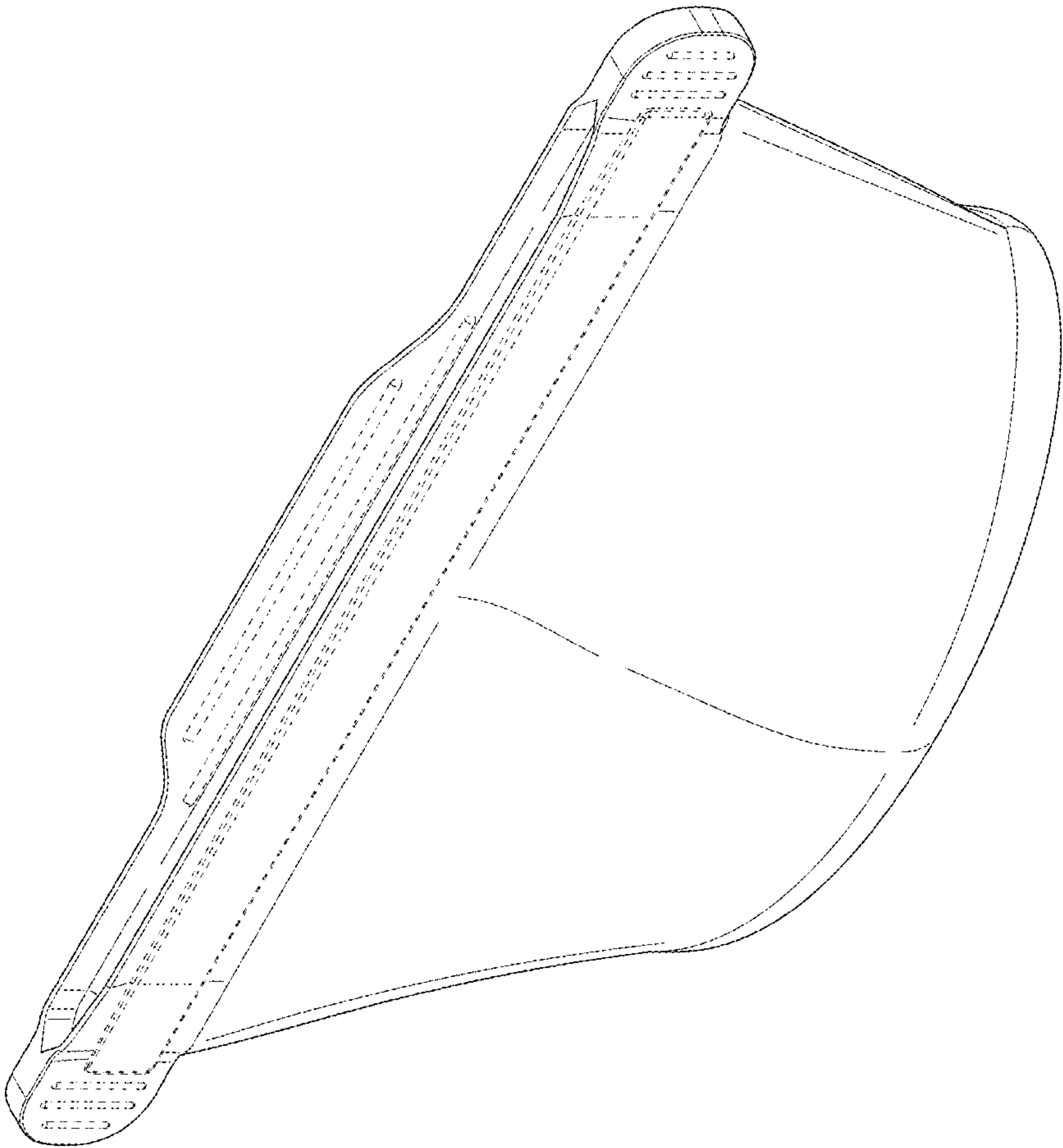

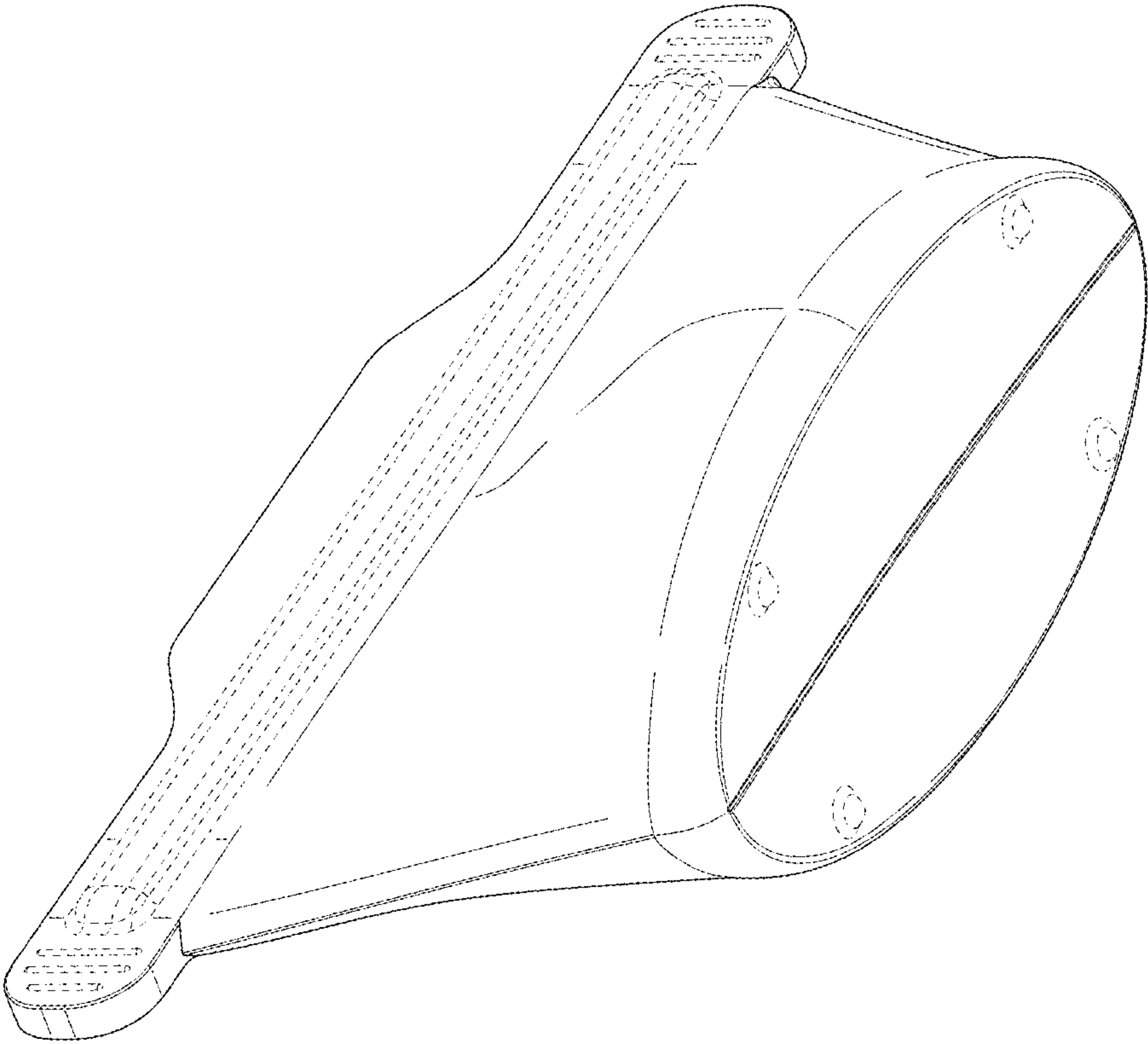

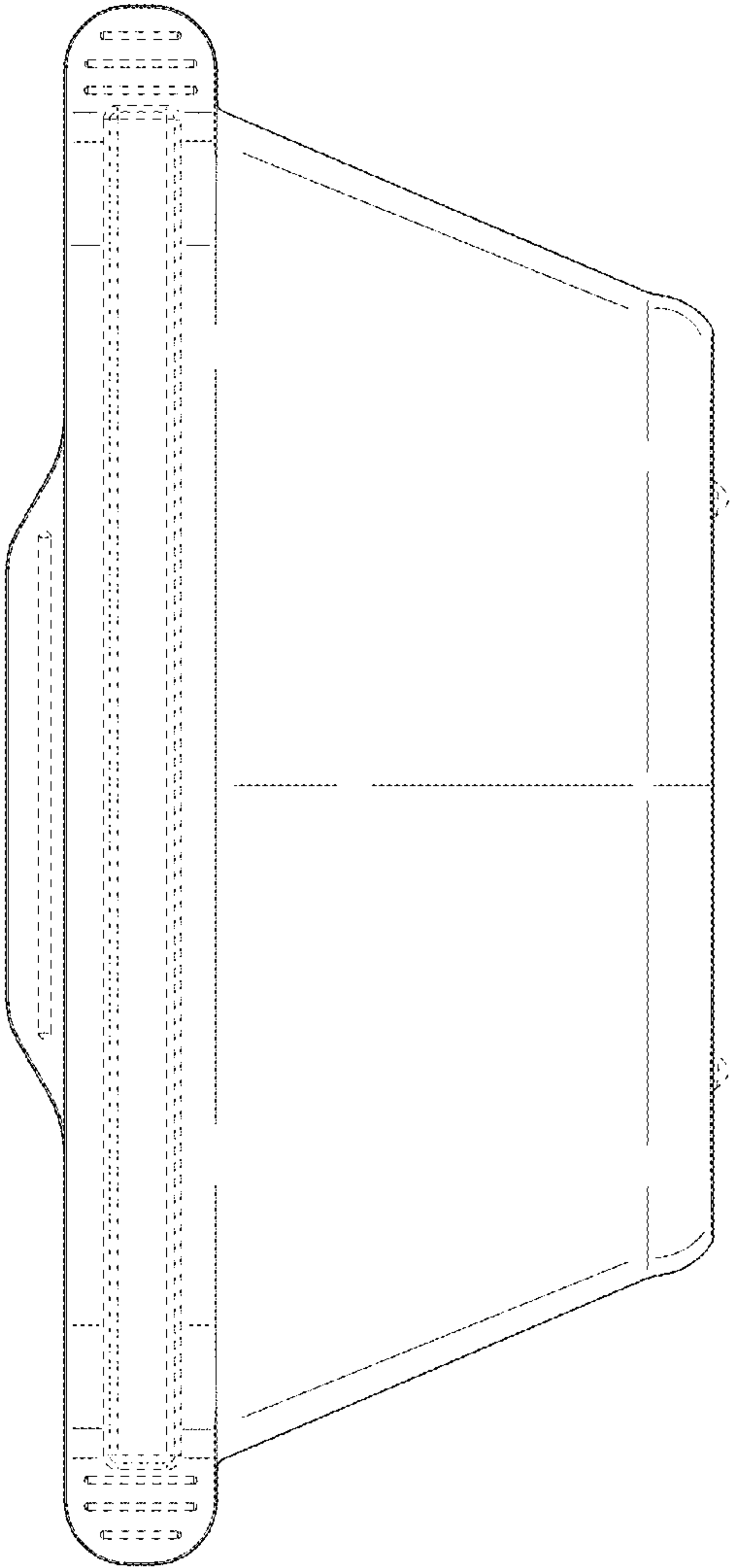

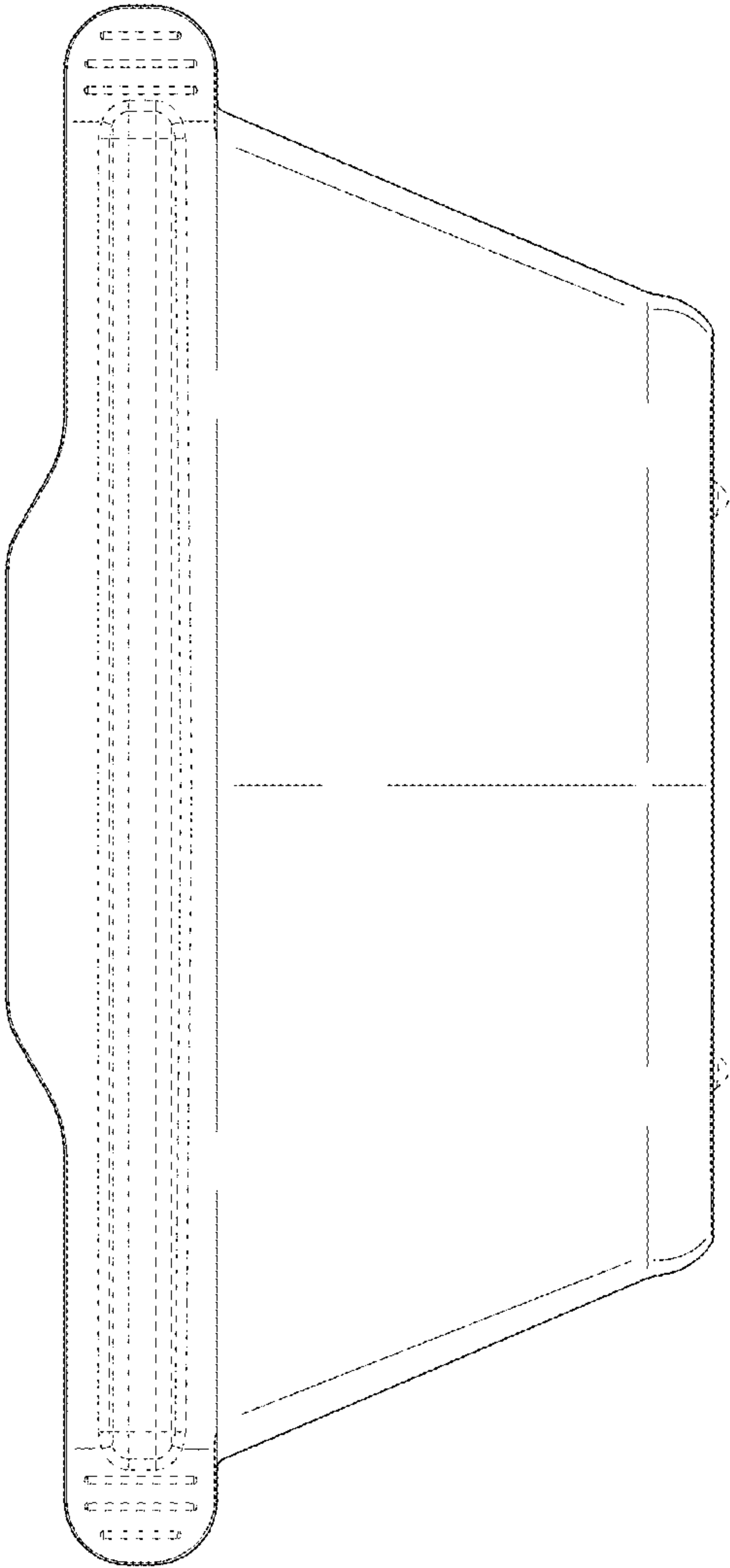

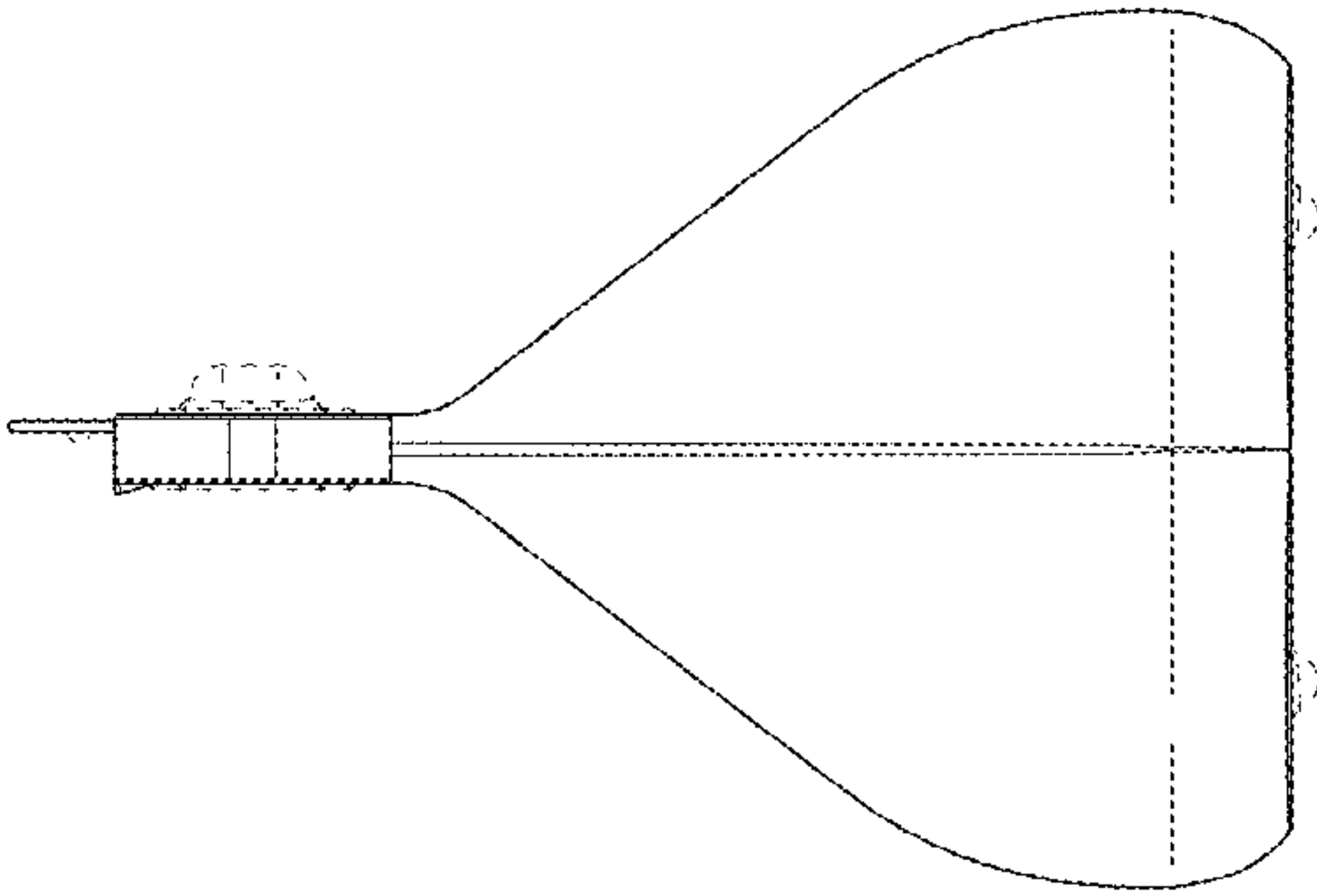

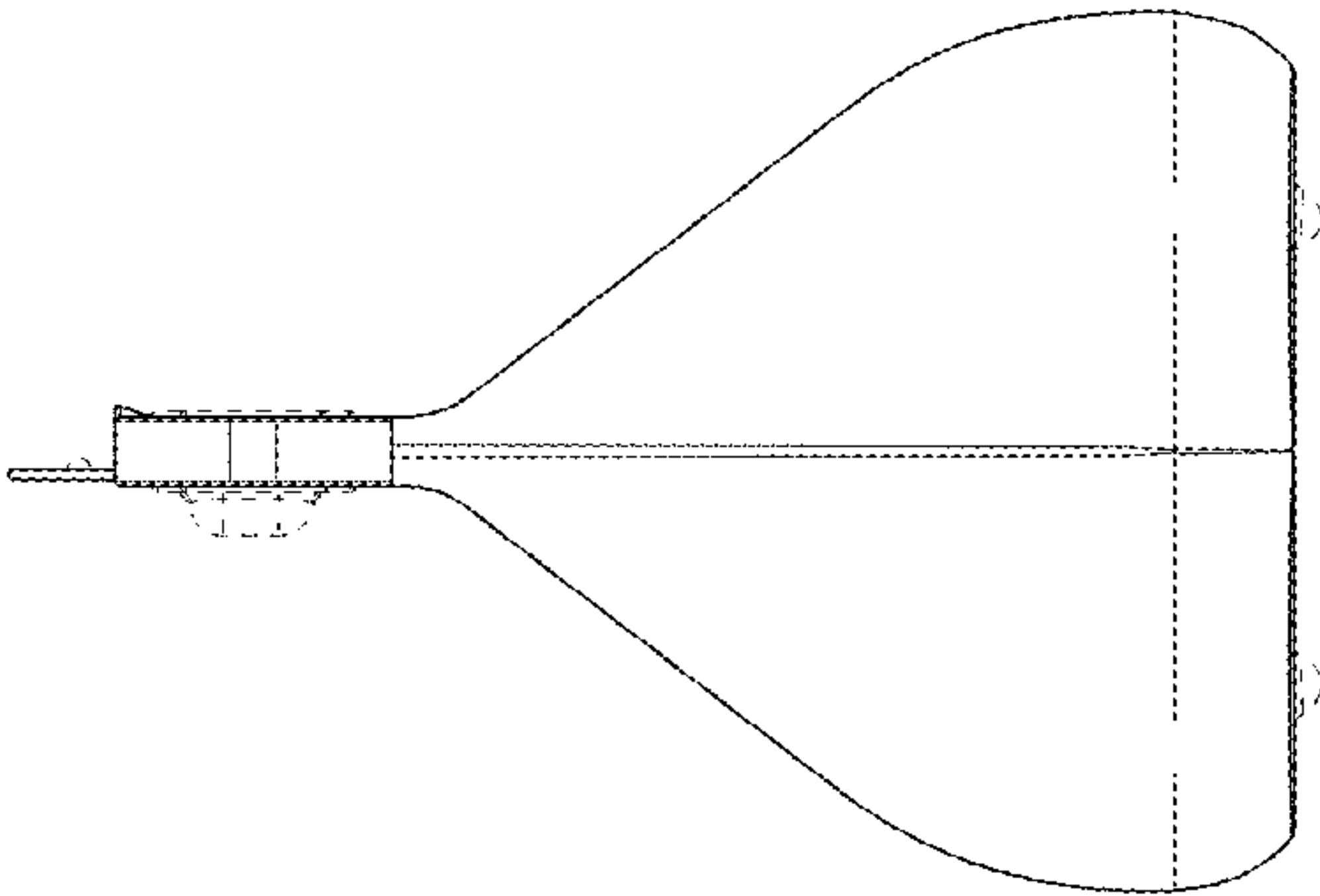

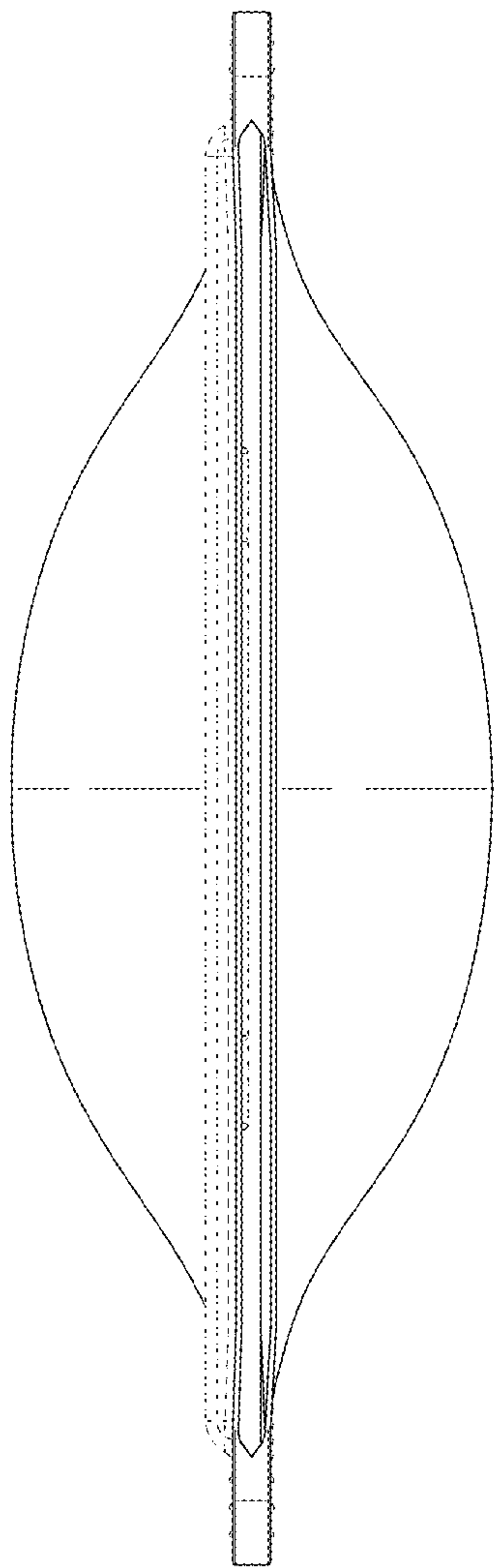

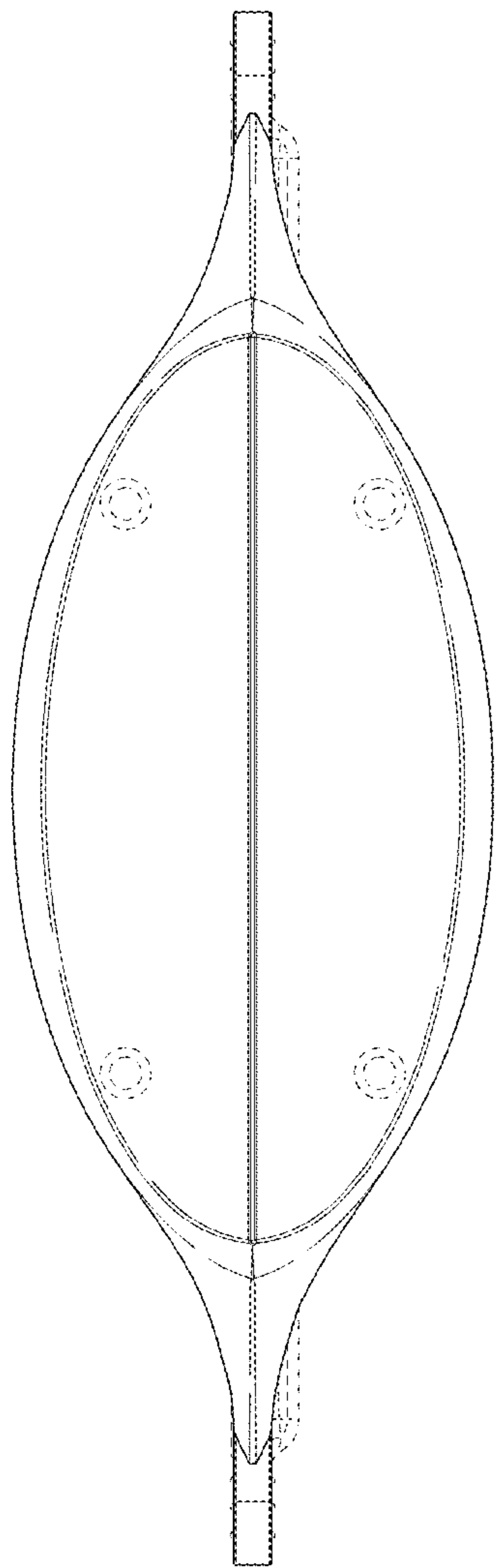

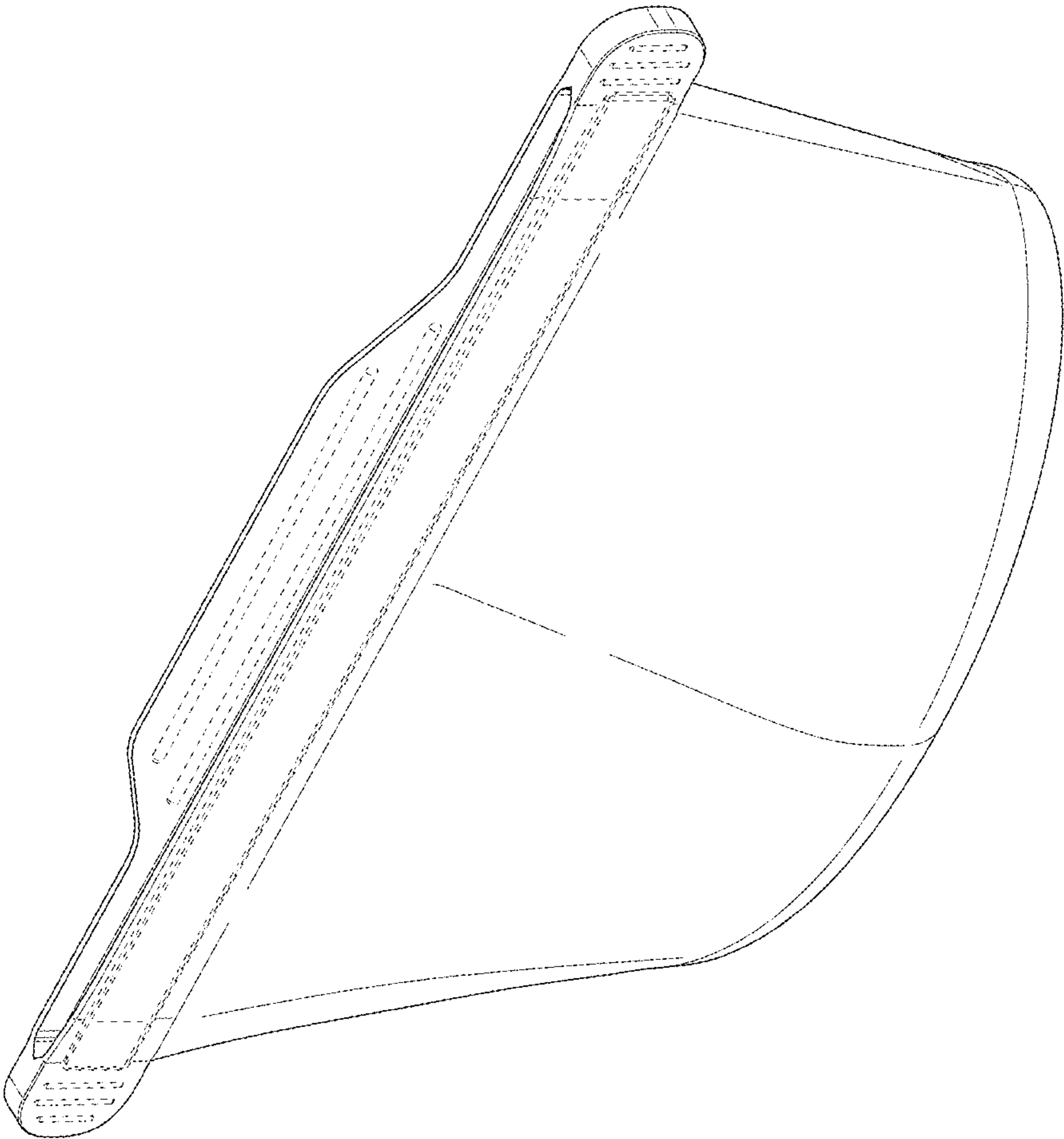

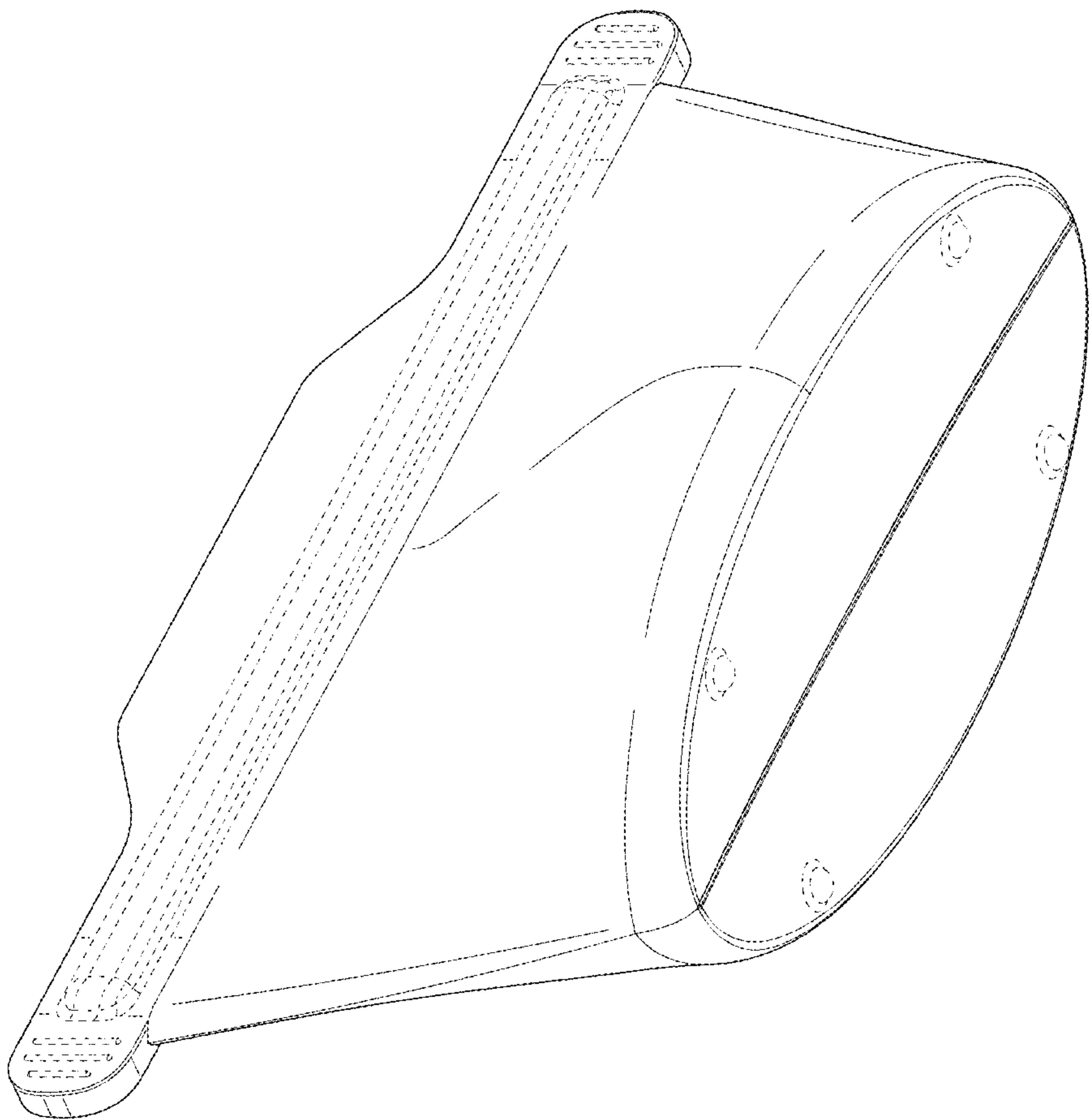

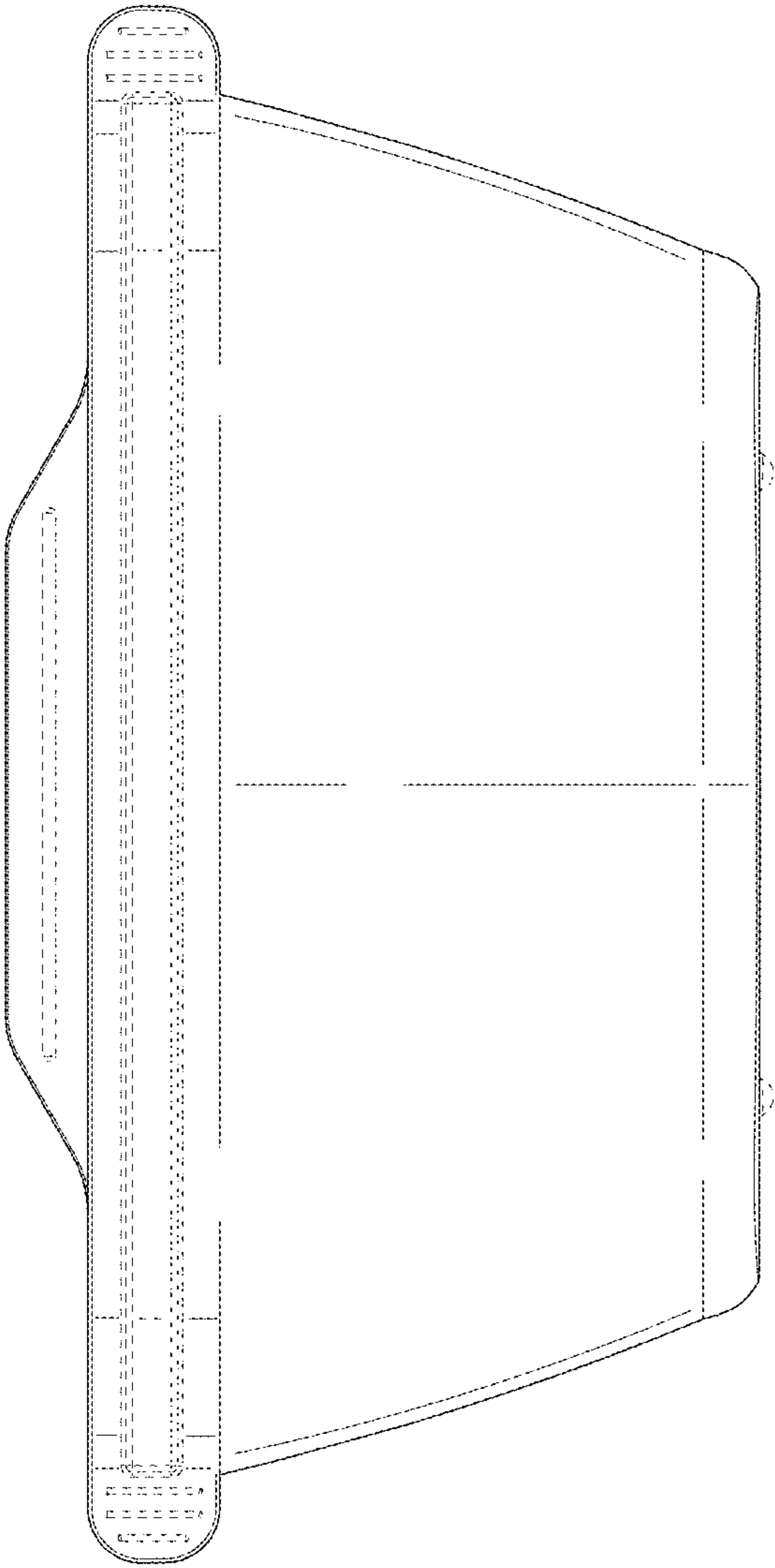

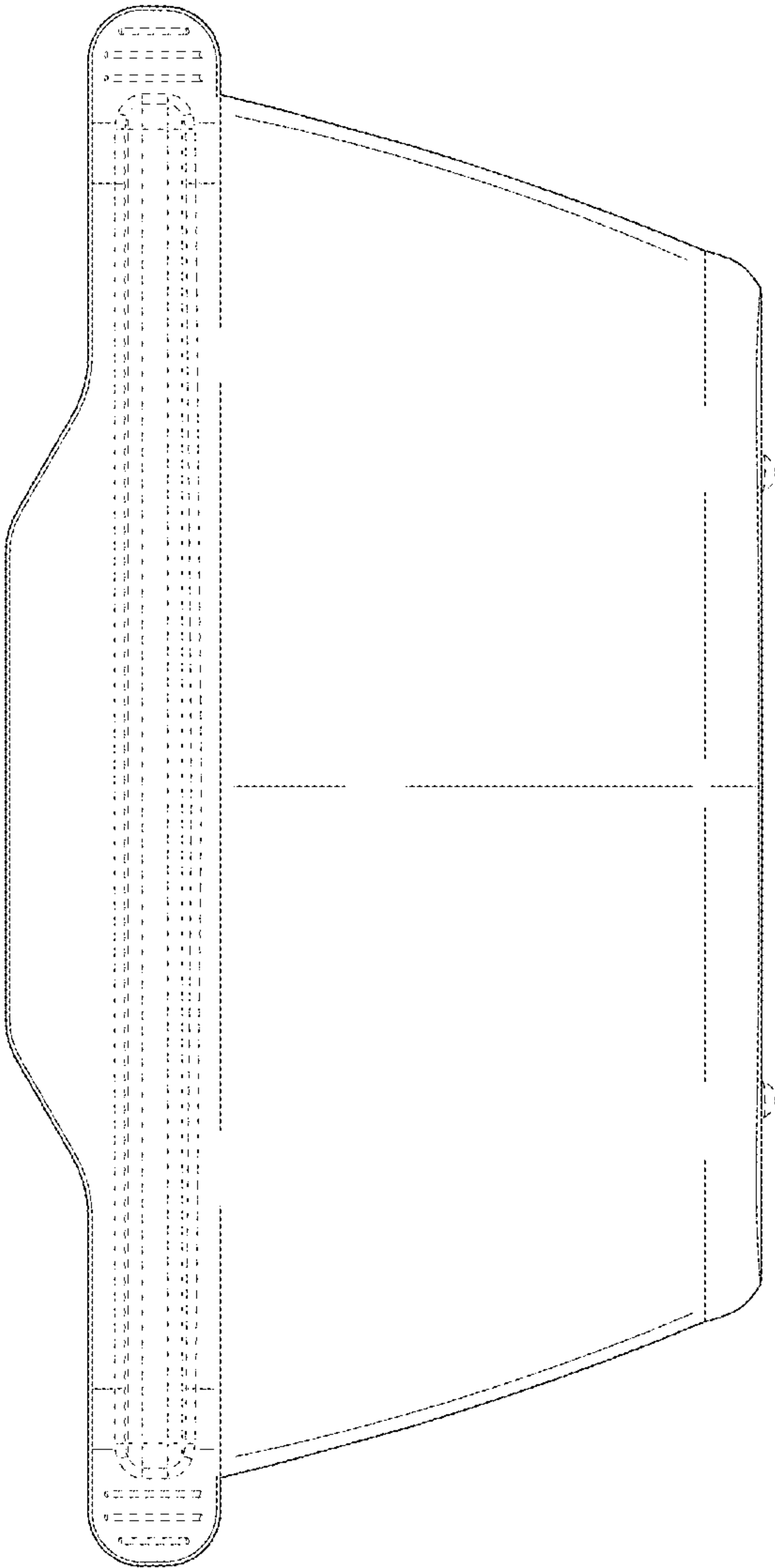

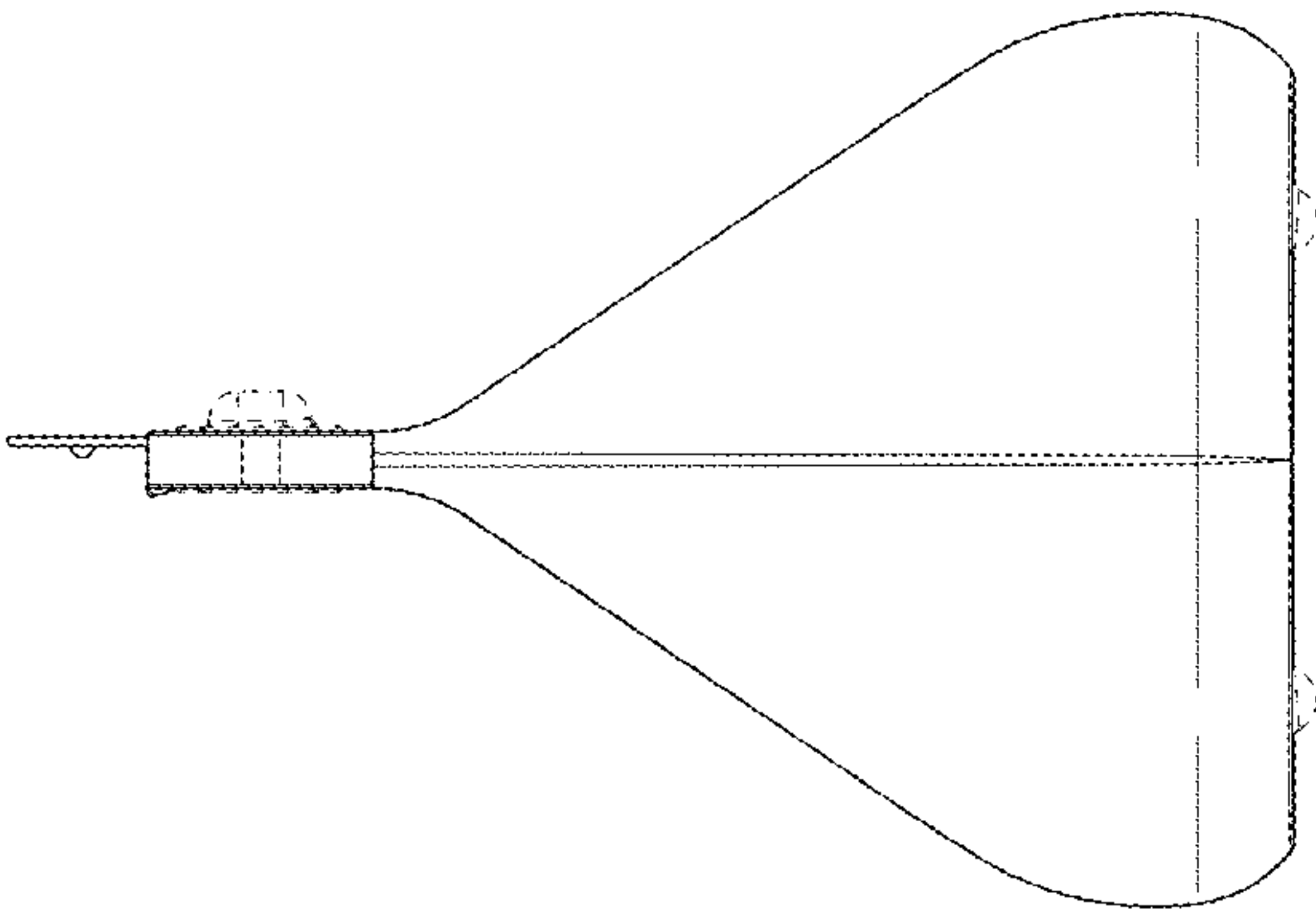

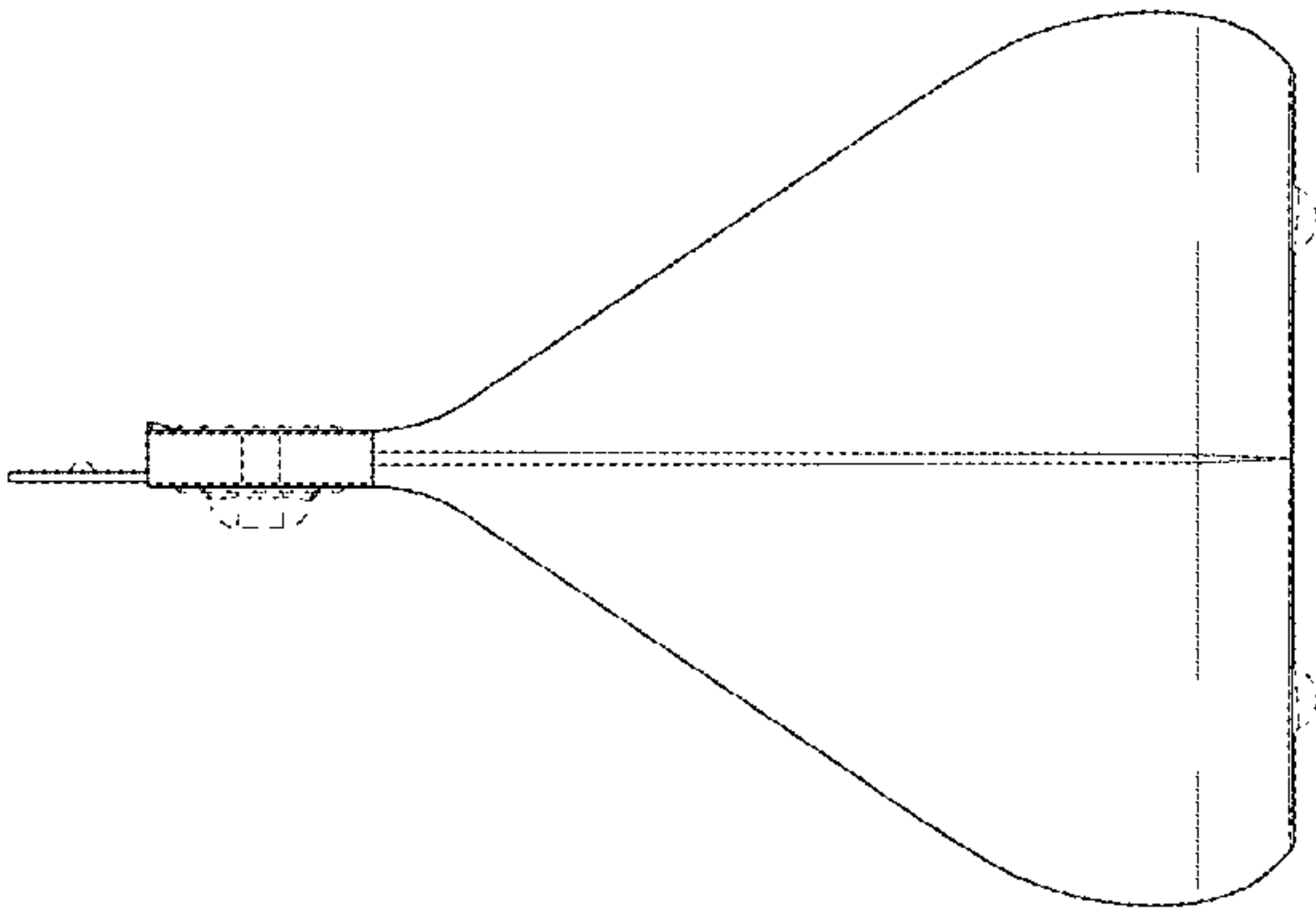

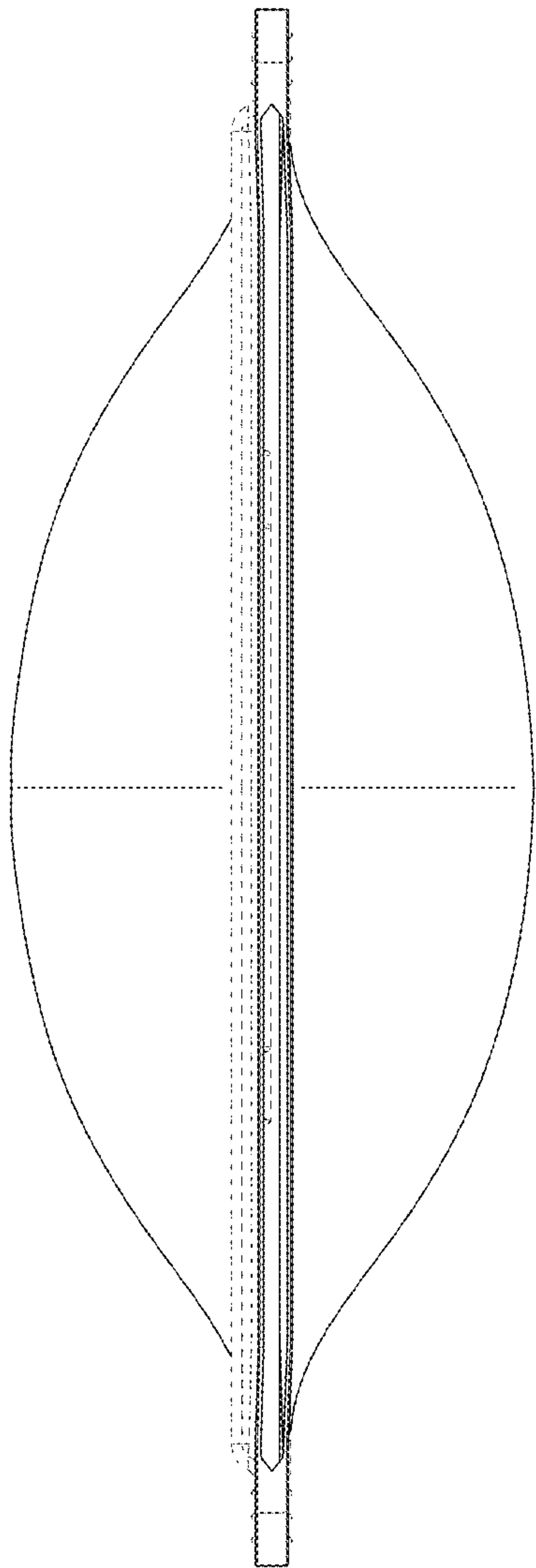

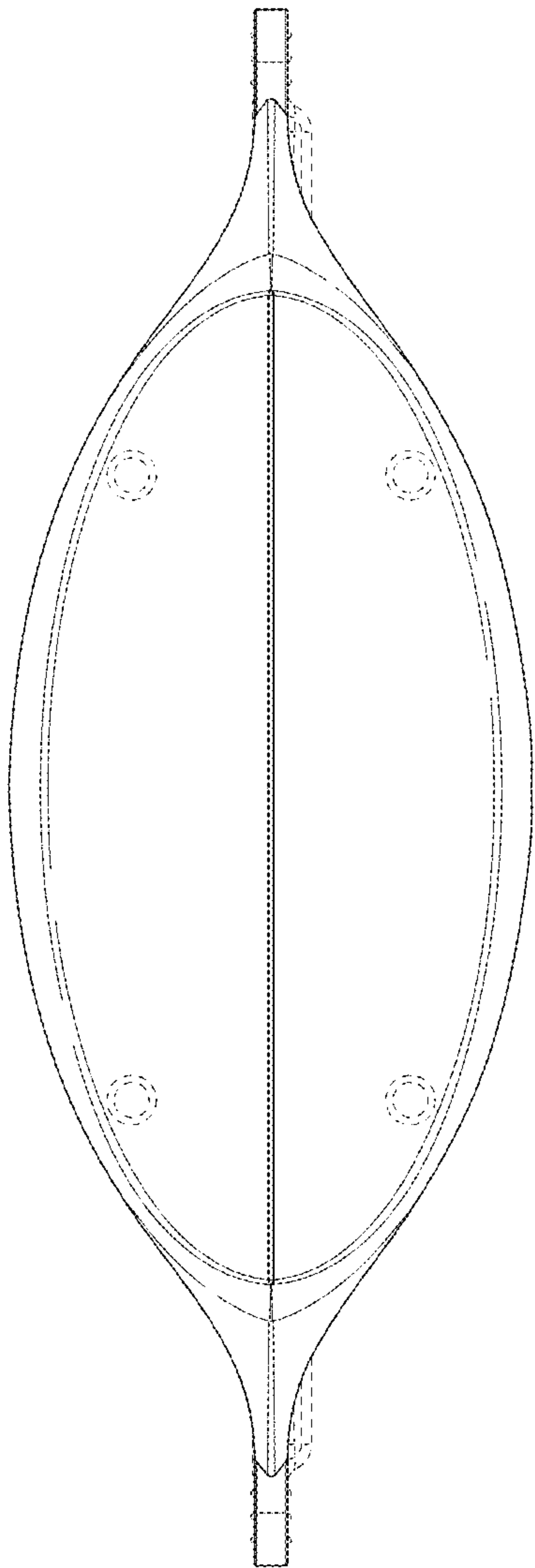
