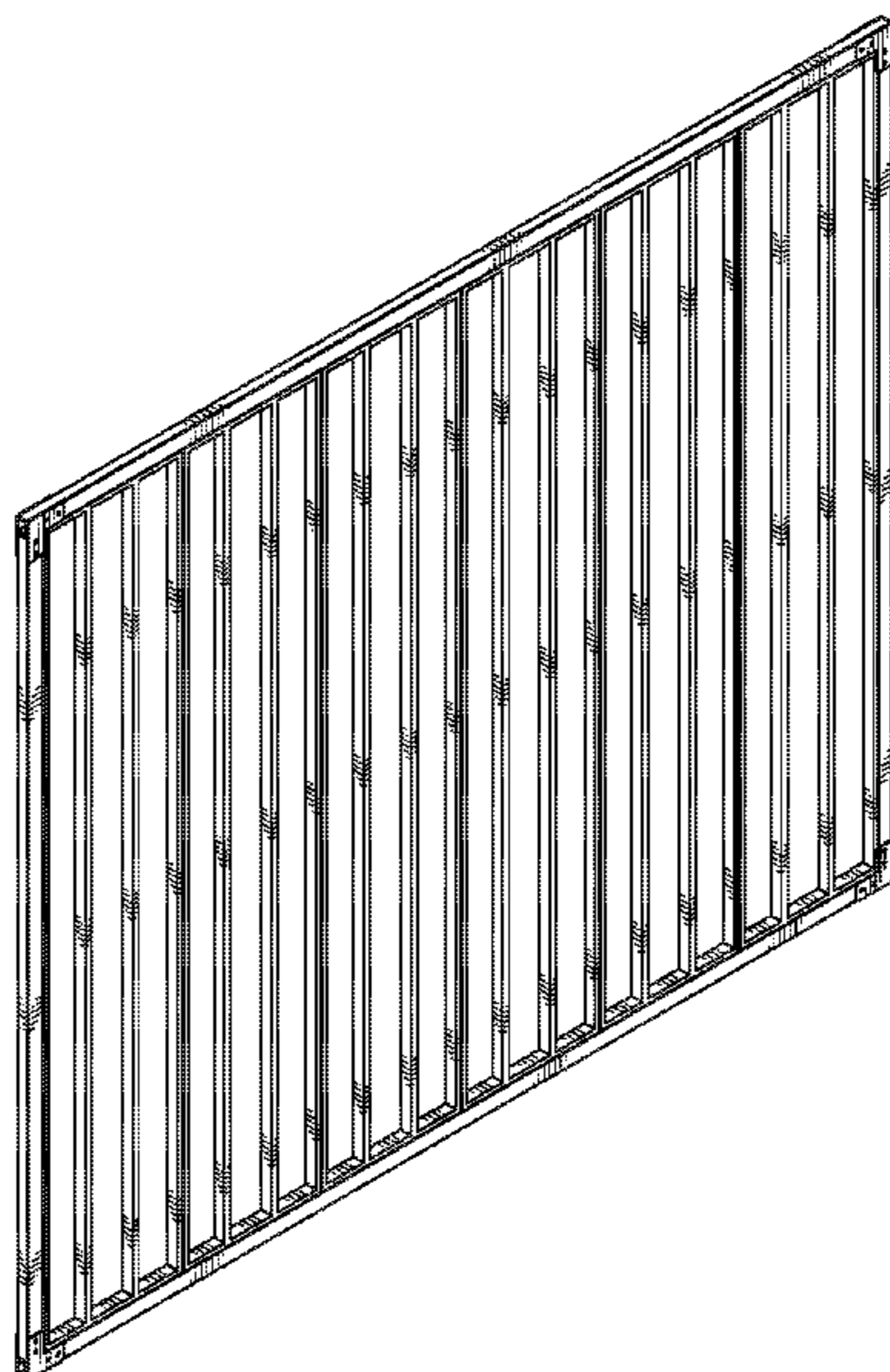
(57) **CLAIM**

The ornamental design for a prefabricated gate, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a prefabricated gate showing my new design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a left elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is another top front perspective view thereof shown in a broken line environment of use forming no part of the claimed design; and,
FIG. 10 is another bottom rear perspective view thereof shown in a broken line environment of use forming no part of the claimed design.
The broken lines depict portions of the prefabricated gate that form no part of the claimed design.

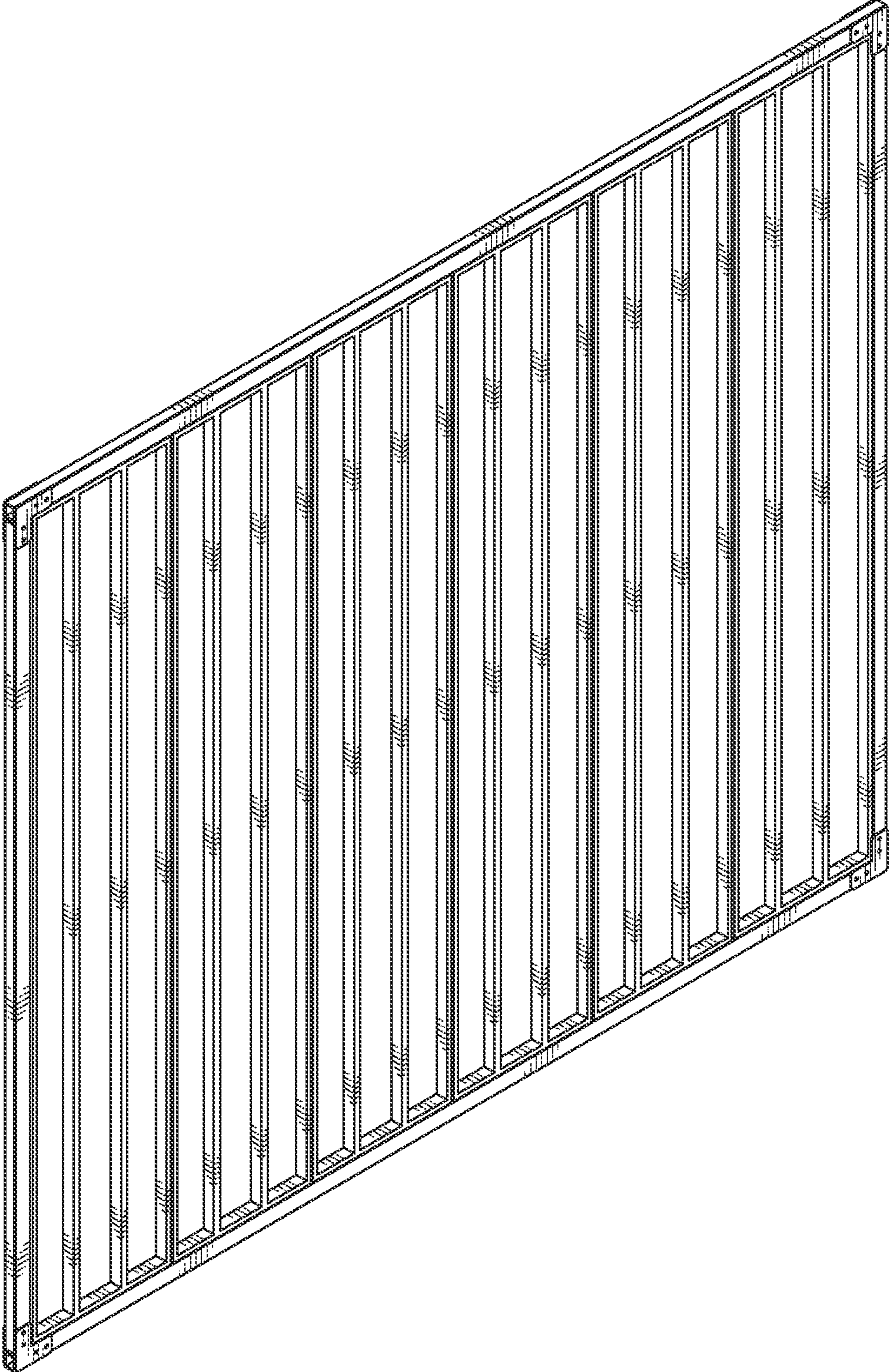

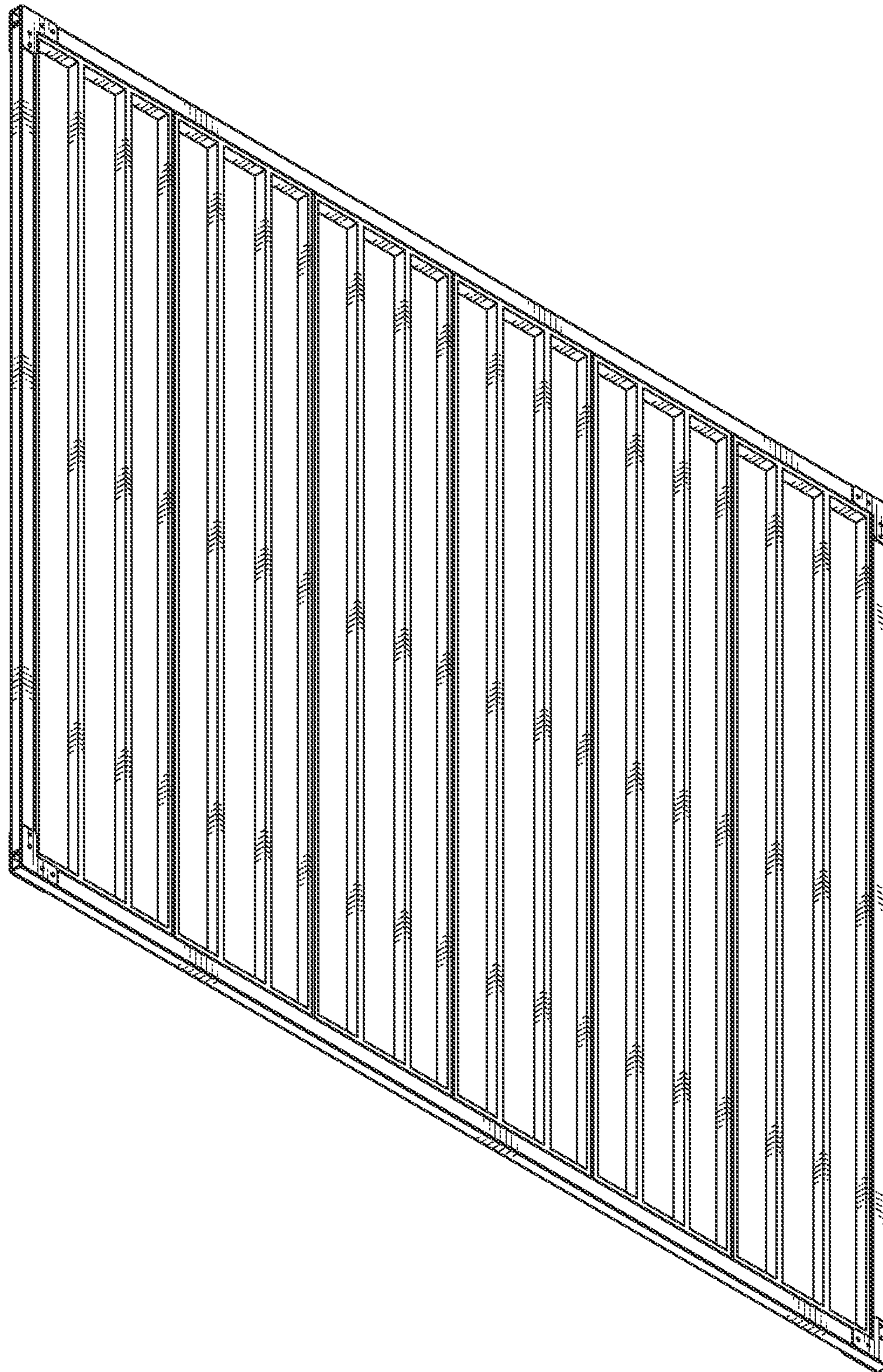

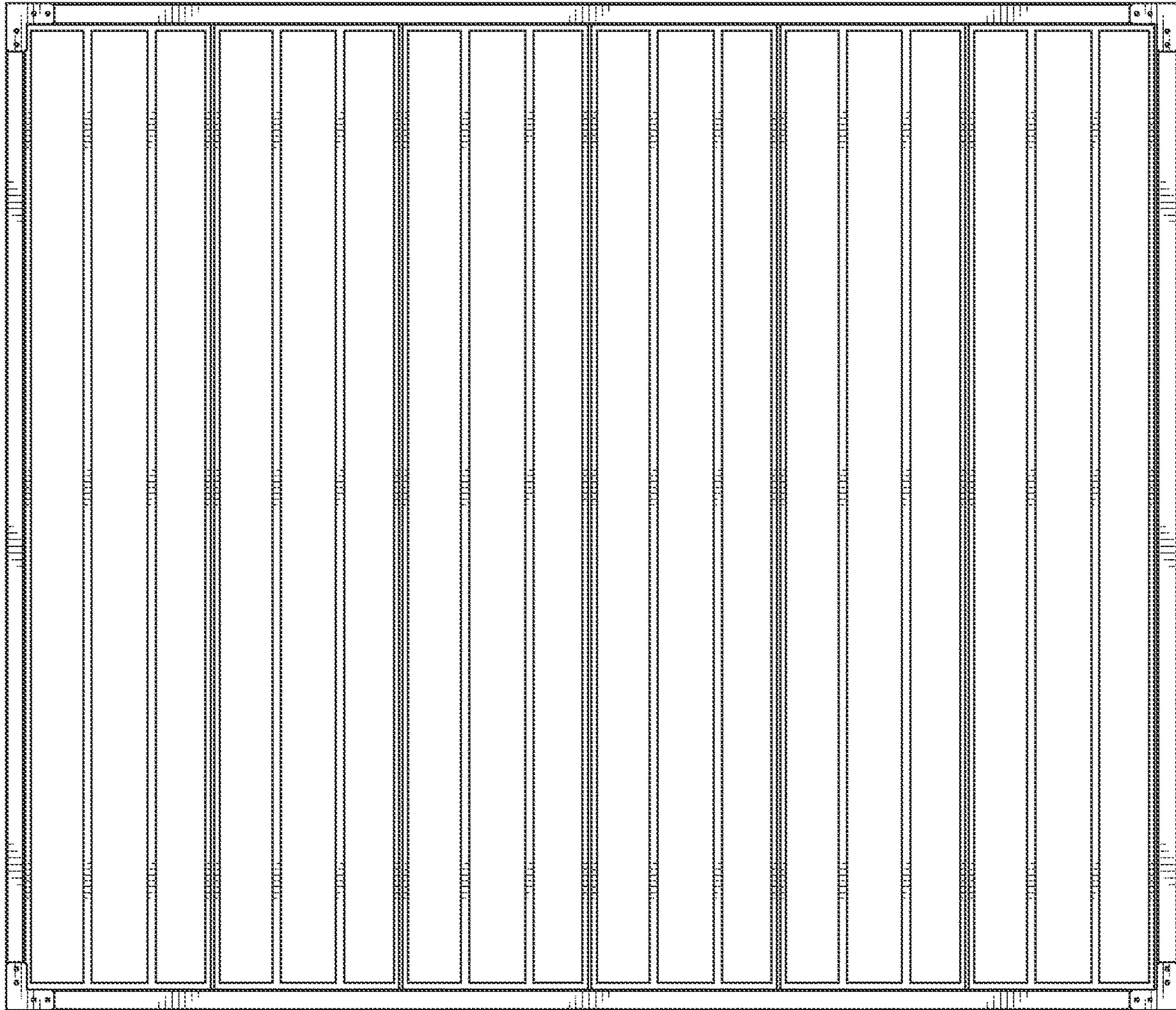

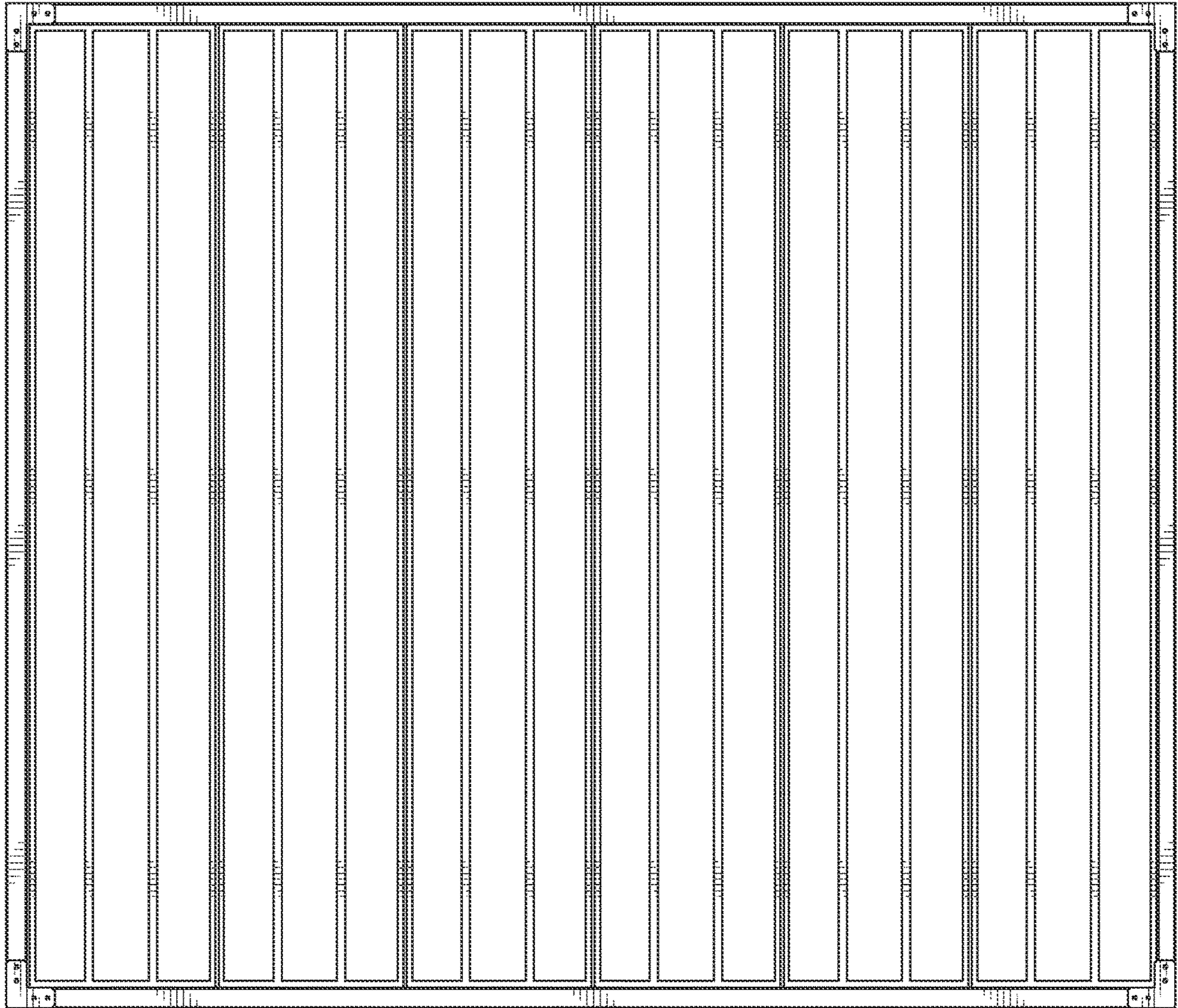

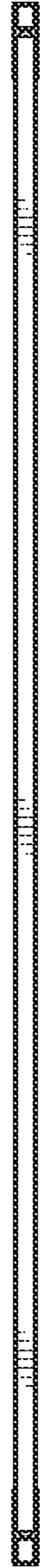

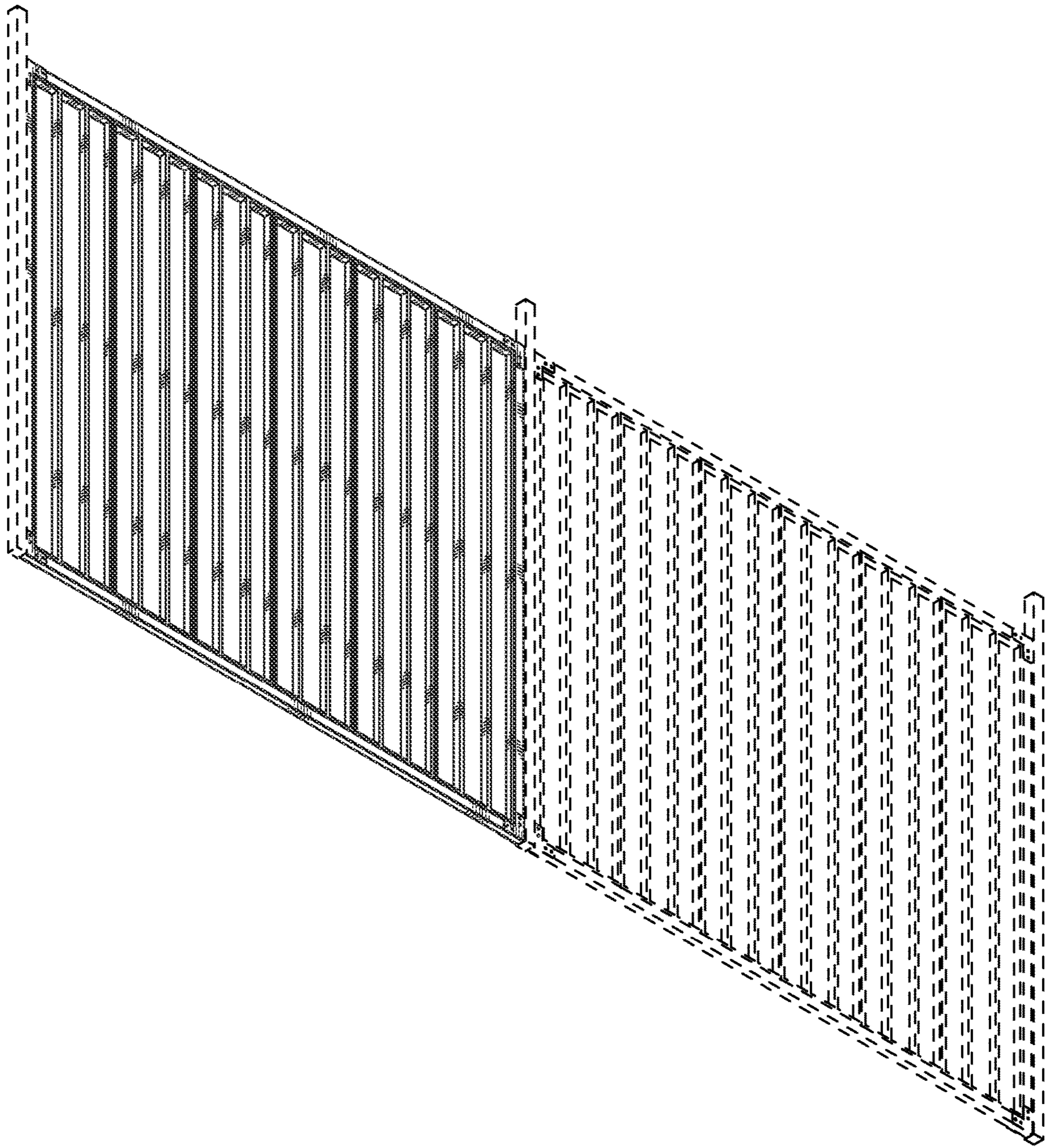
