**DESCRIPTION**

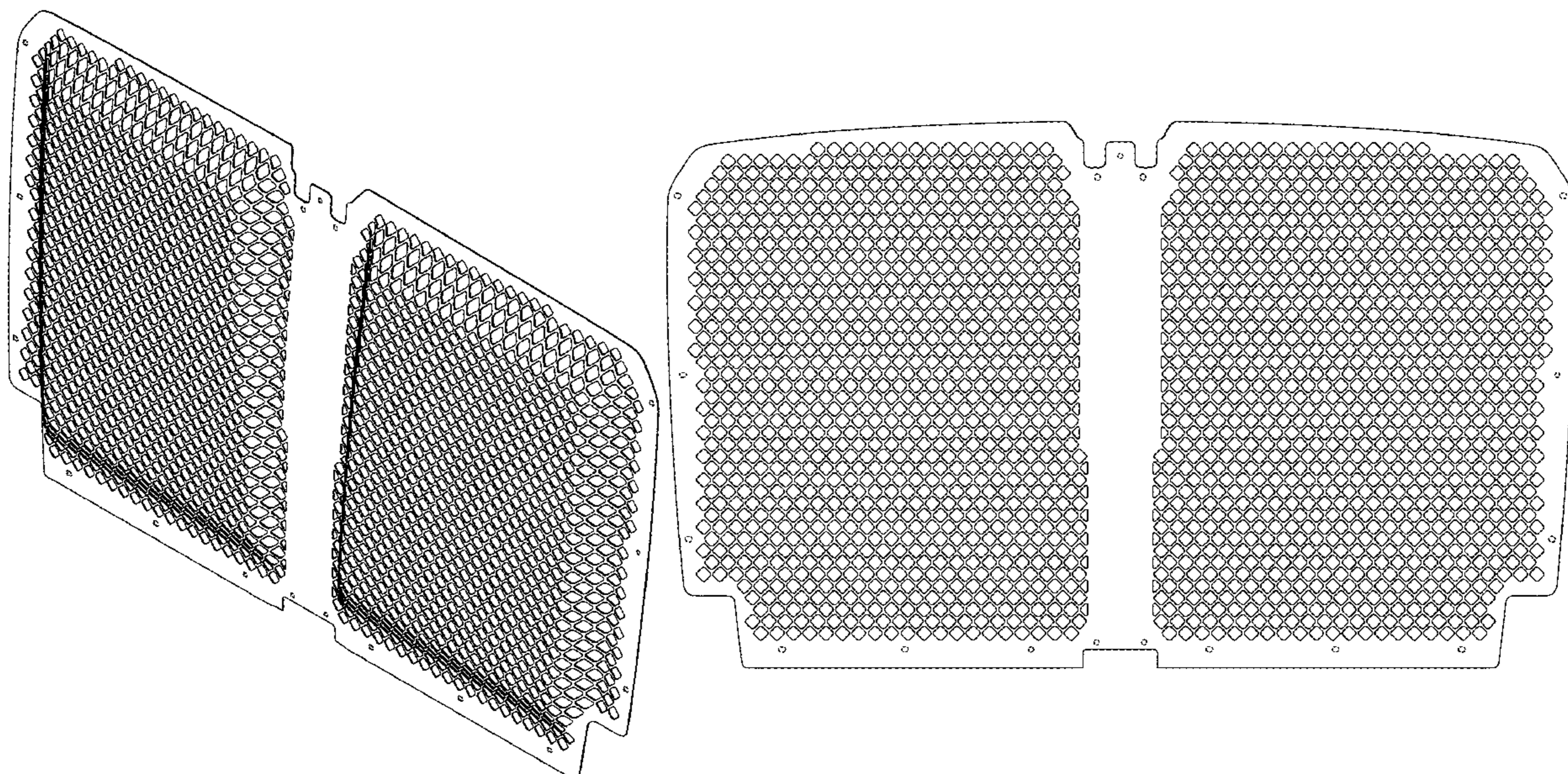
FIG. 1 is a perspective view of a vehicle grille, showing our new design.

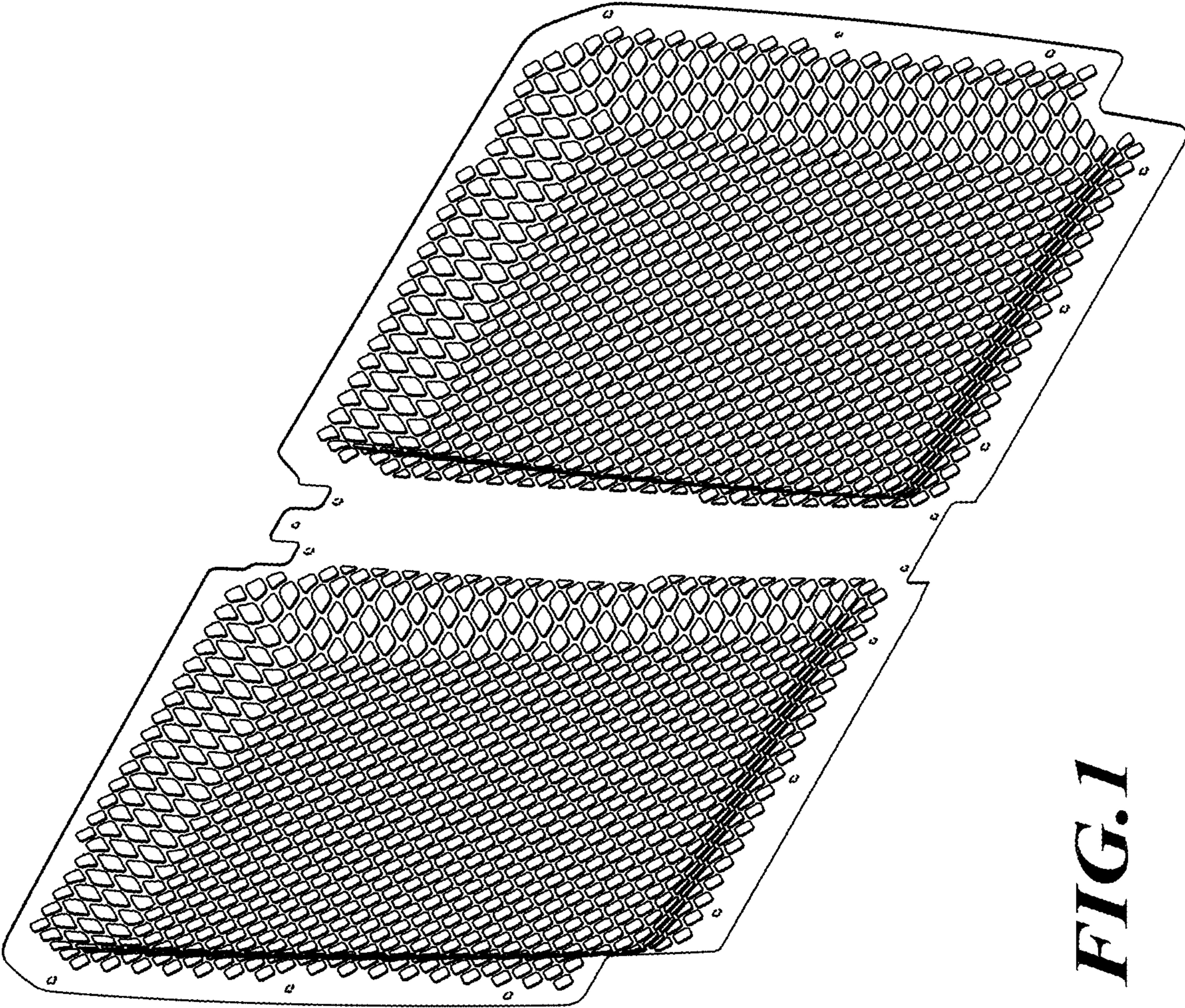
FIG. 2 is a front elevational view thereof; and,

FIG. 3 is a rear elevational view thereof.

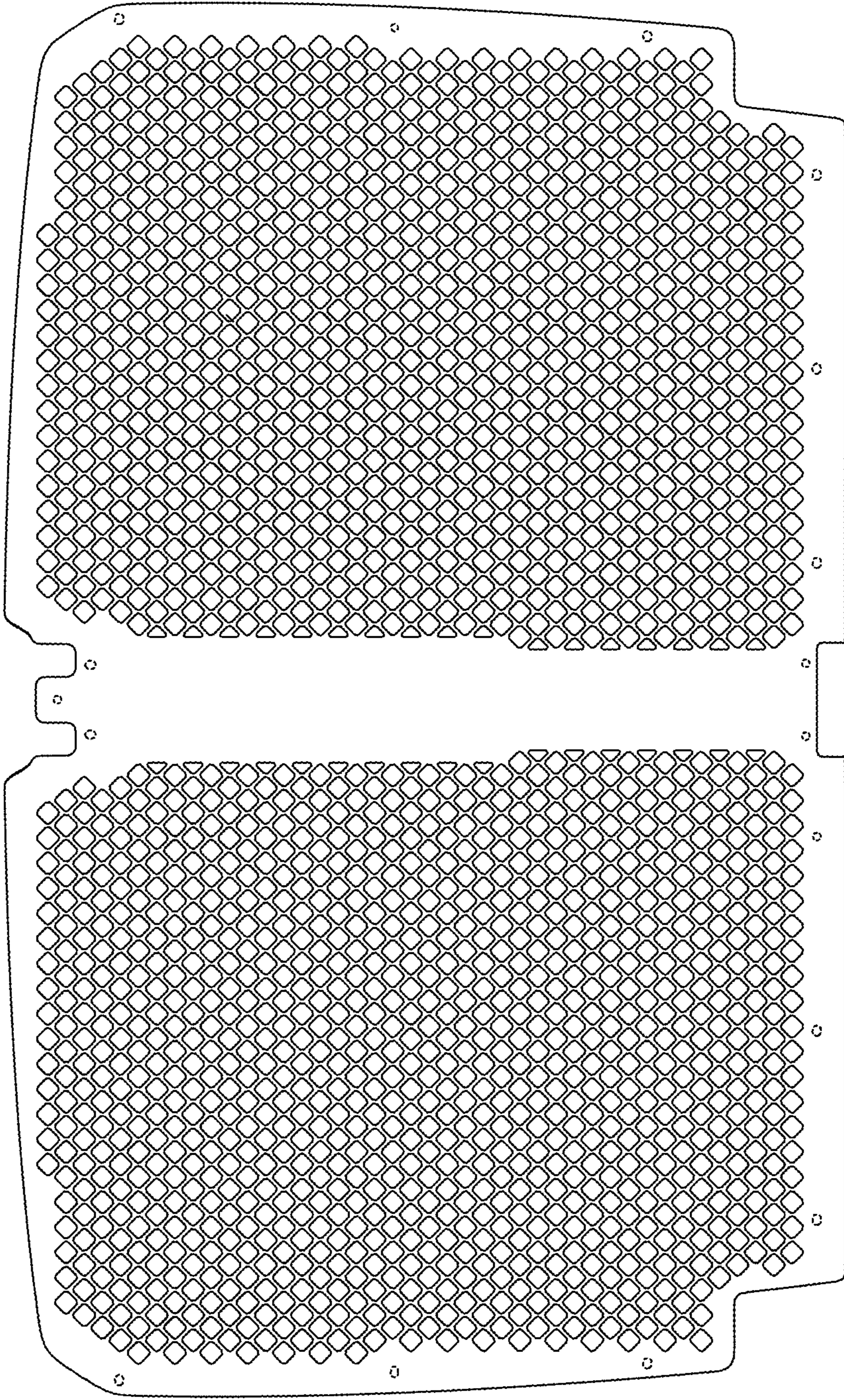
The broken lines shown in the drawings depict portions of the vehicle grille that form no part of the claimed design.

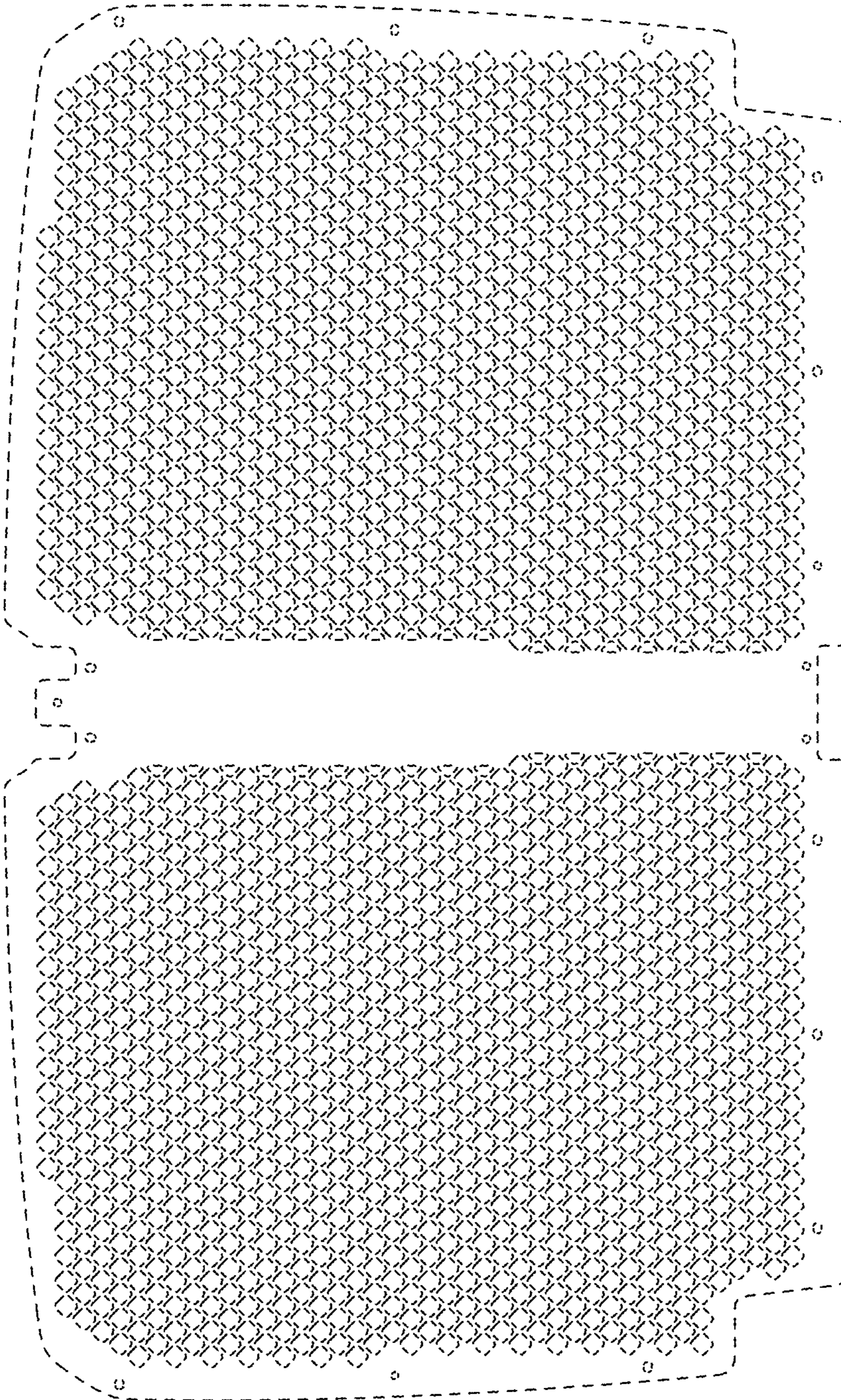
