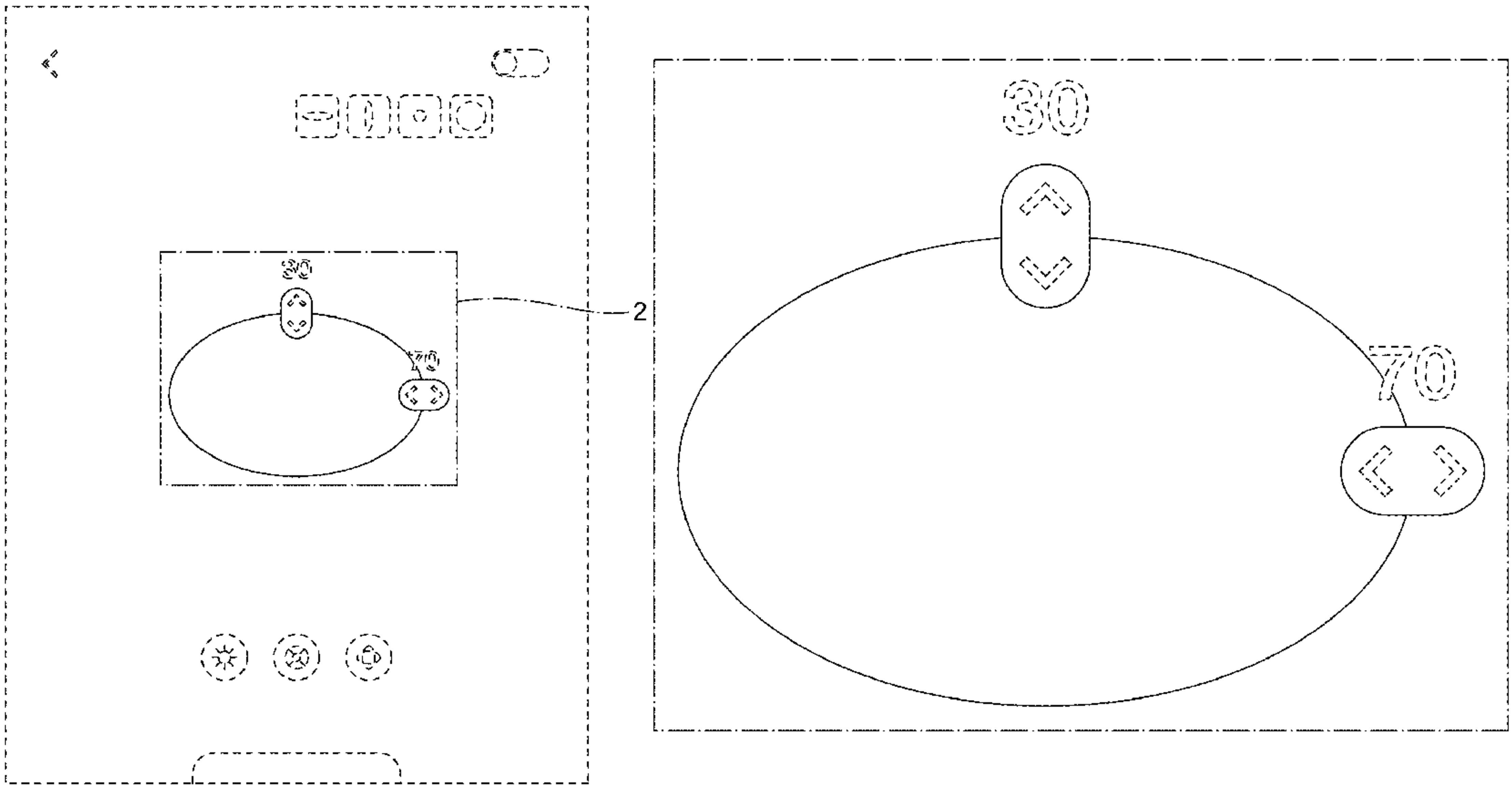
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing my new design; and, FIG. 2 is an enlarged view of the area 2 indicated by the single dot-dash broken lines in FIG. 1. The evenly-spaced broken lines depict portions of the display screen with graphical user interface that form no part of the claimed design. The areas indicated by the single dot-dash broken lines shown in FIG. 1 illustrate the boundary of enlarged area of the design. The “2” indicia and splined curve indicated by the single dot-dash broken lines in FIG. 1 identify the enlarged area. The single dot-dash broken lines form no part of the claimed design.

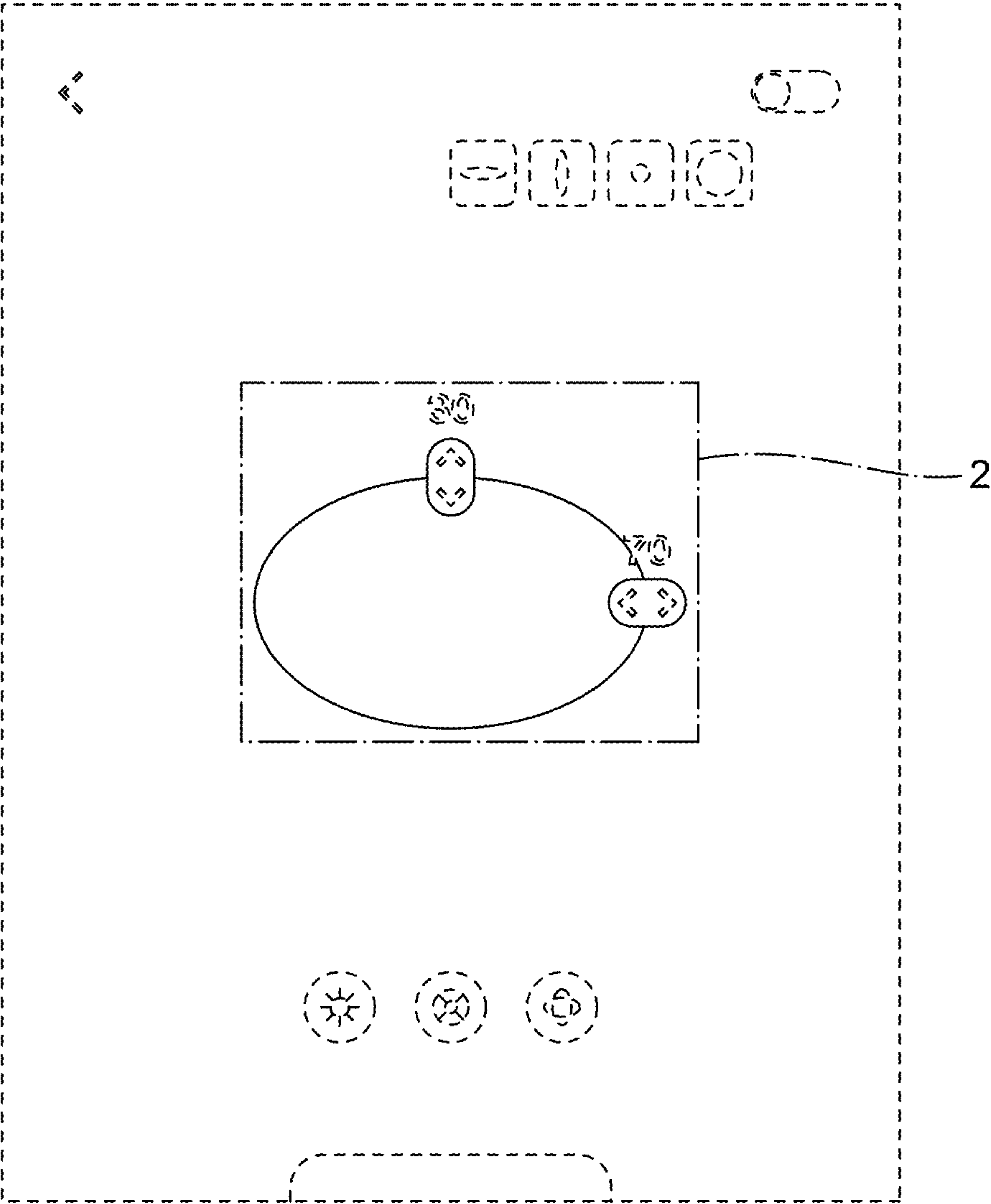
