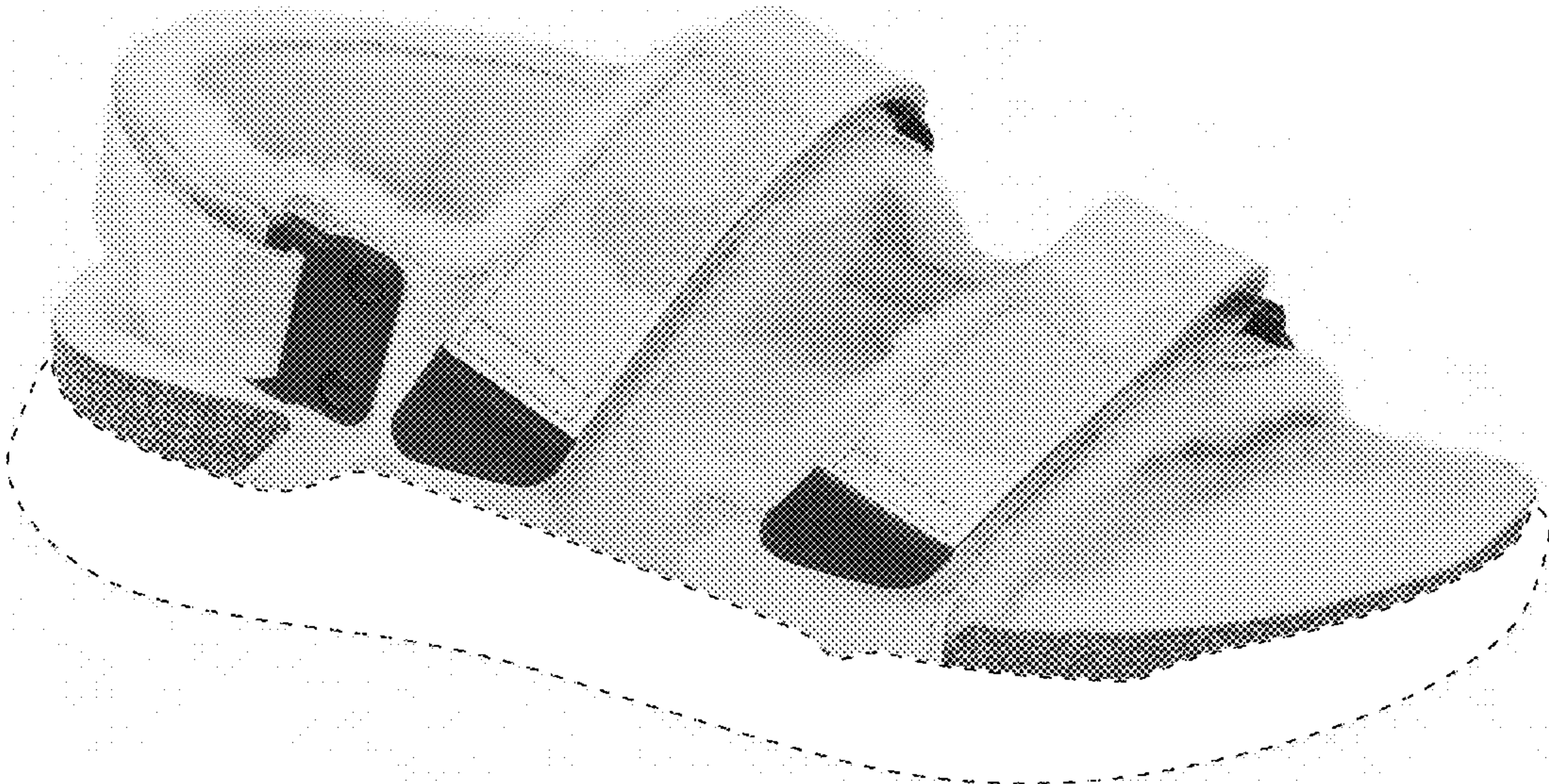
CLAIM

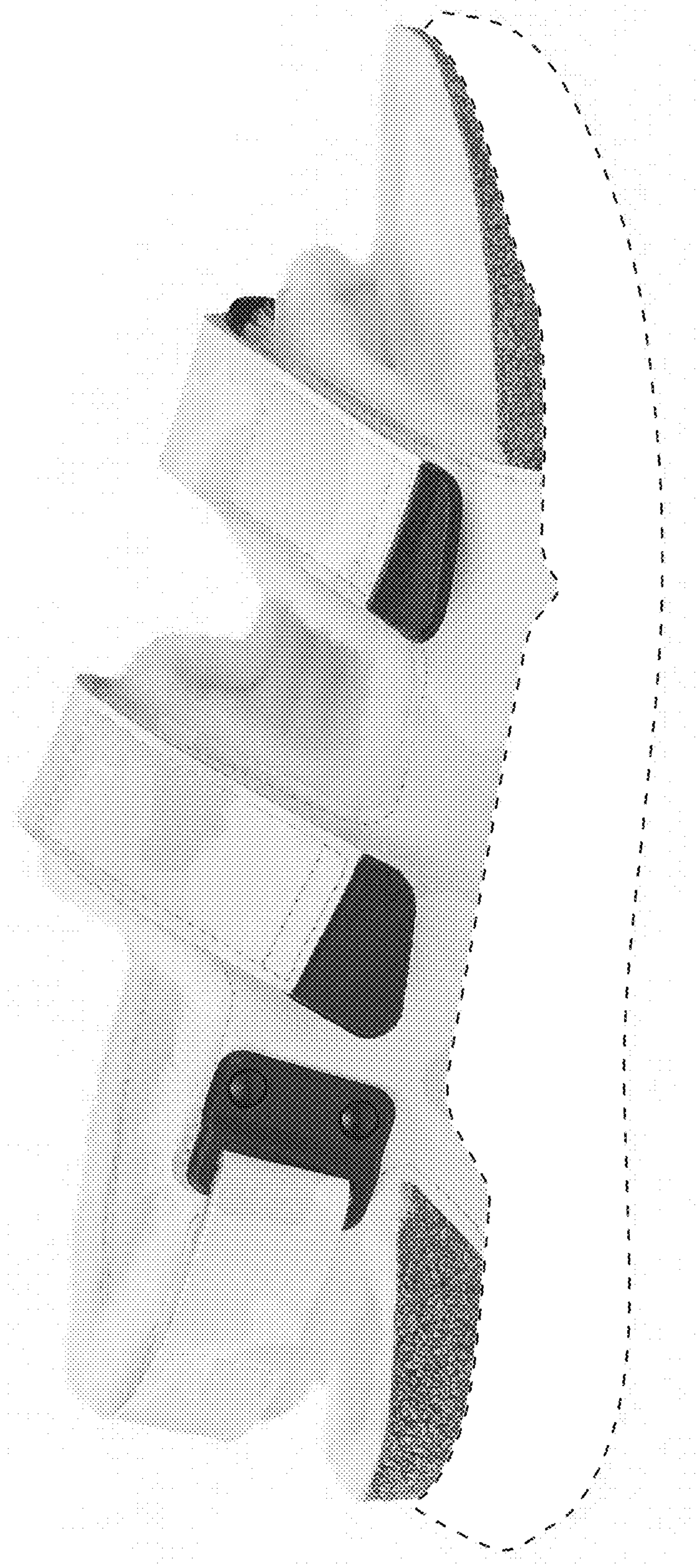

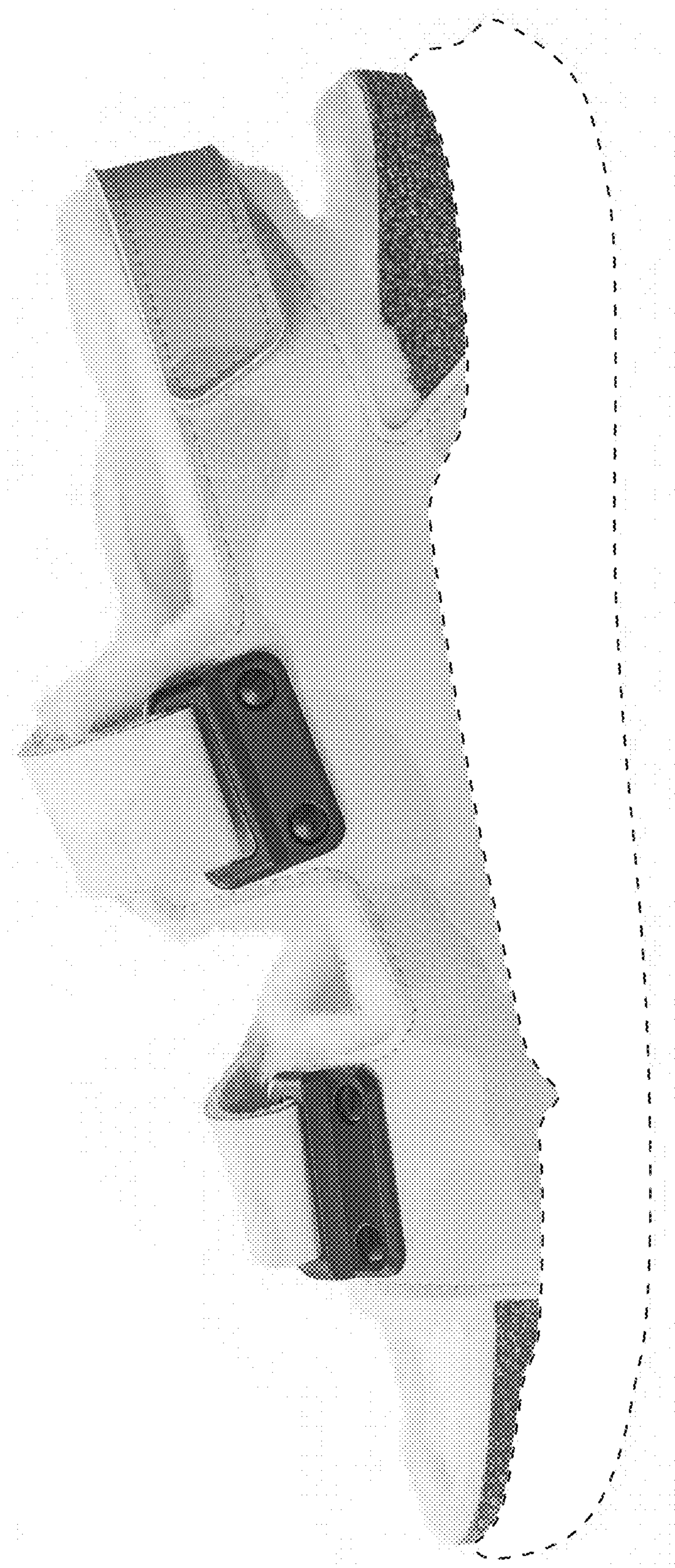

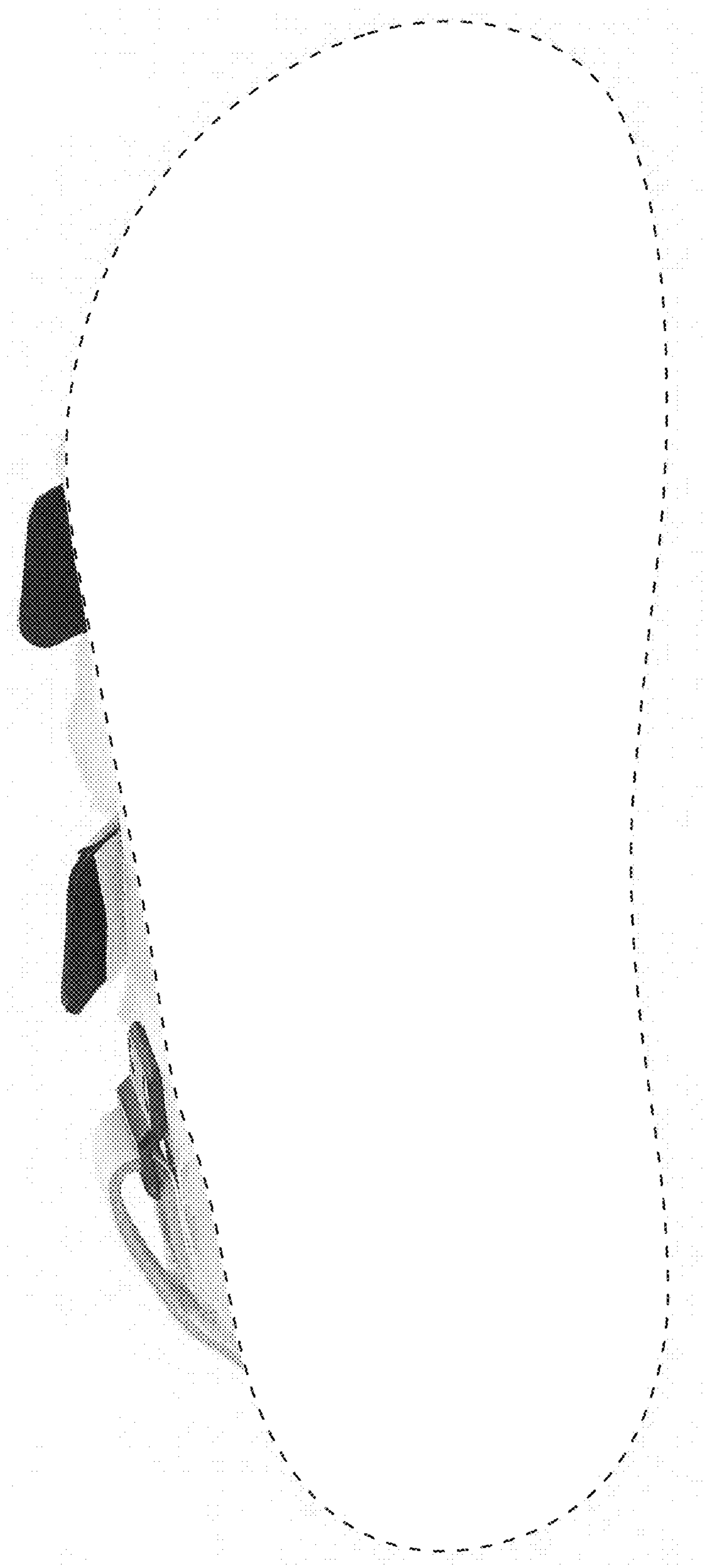
