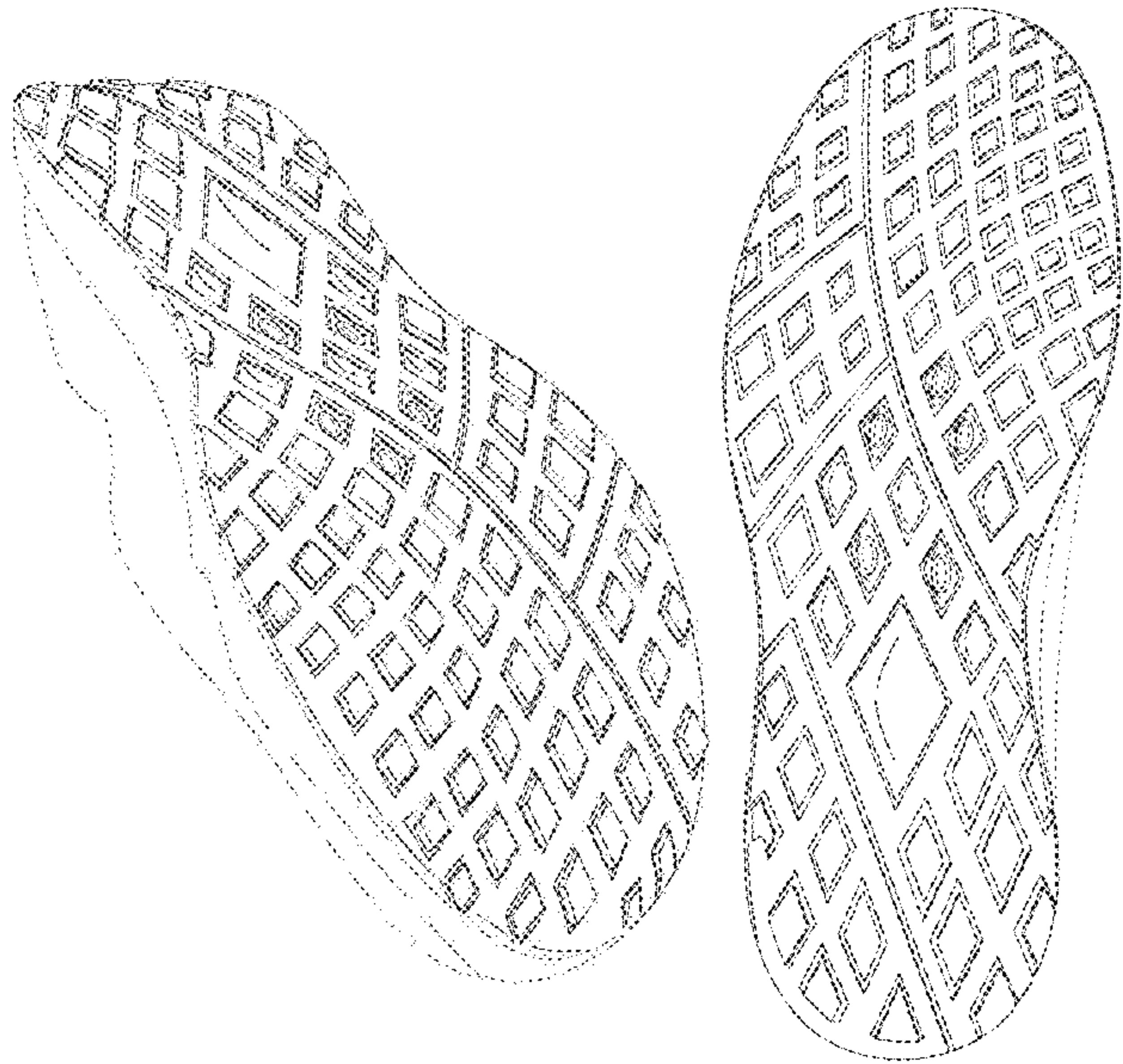
(57) CLAIM

DESCRIPTION

FIG. 1 is a perspective view of the footwear sole embodying the new design;
FIG. 2 is a bottom view thereof;

FIG. 5 is a front view thereof; and,
FIG. 6 is a rear view thereof.

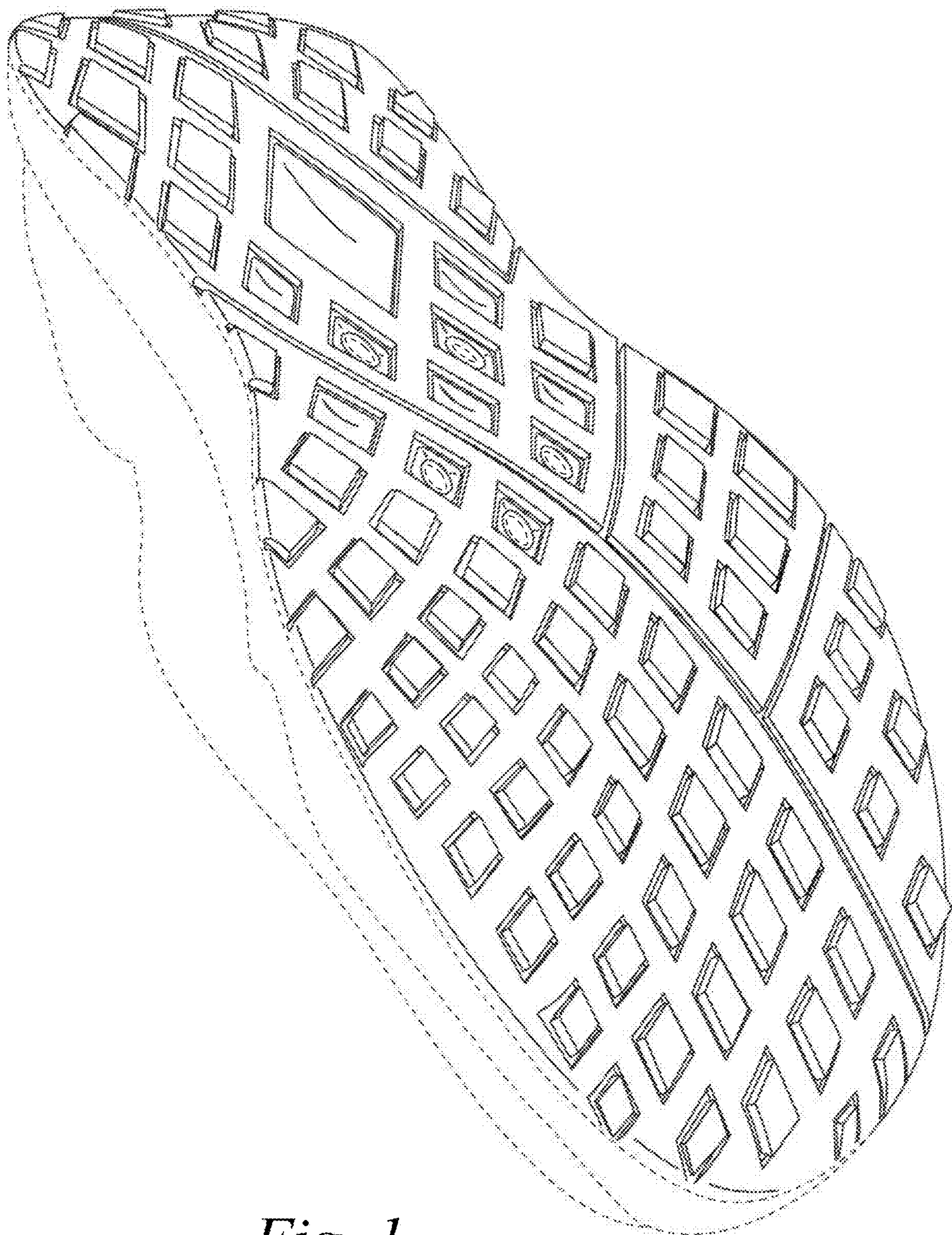

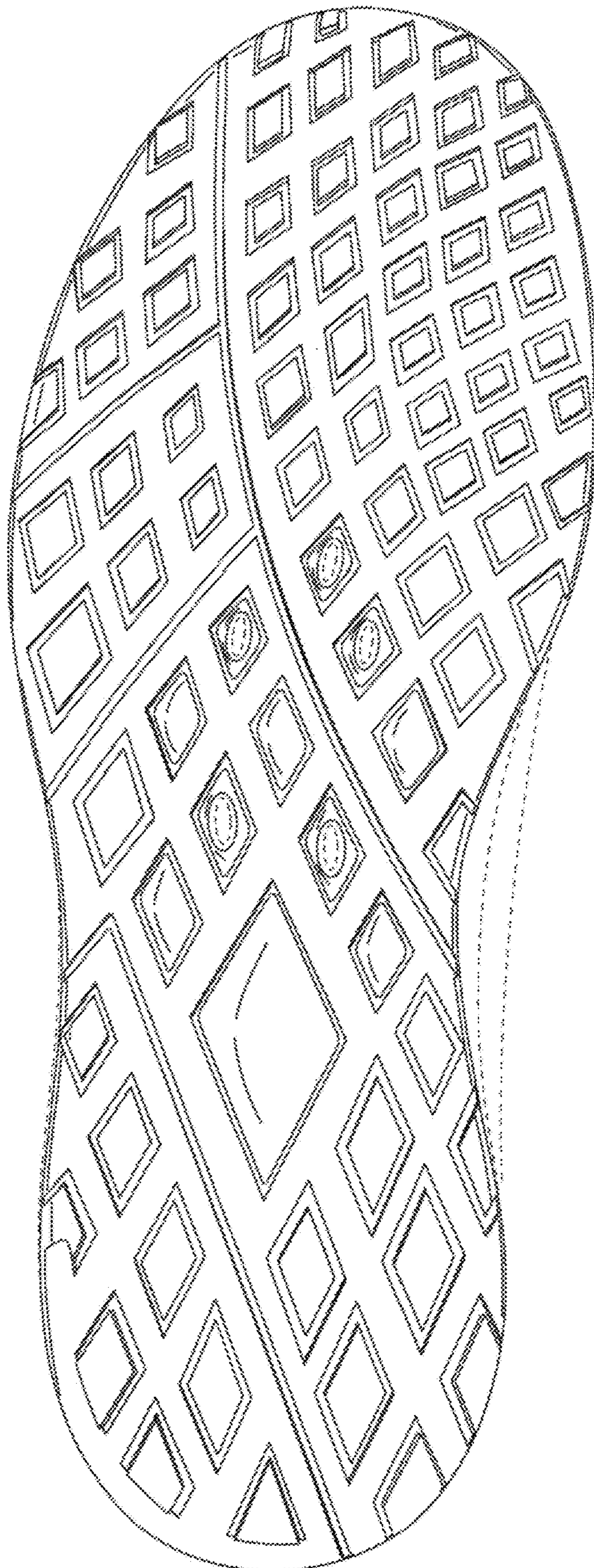

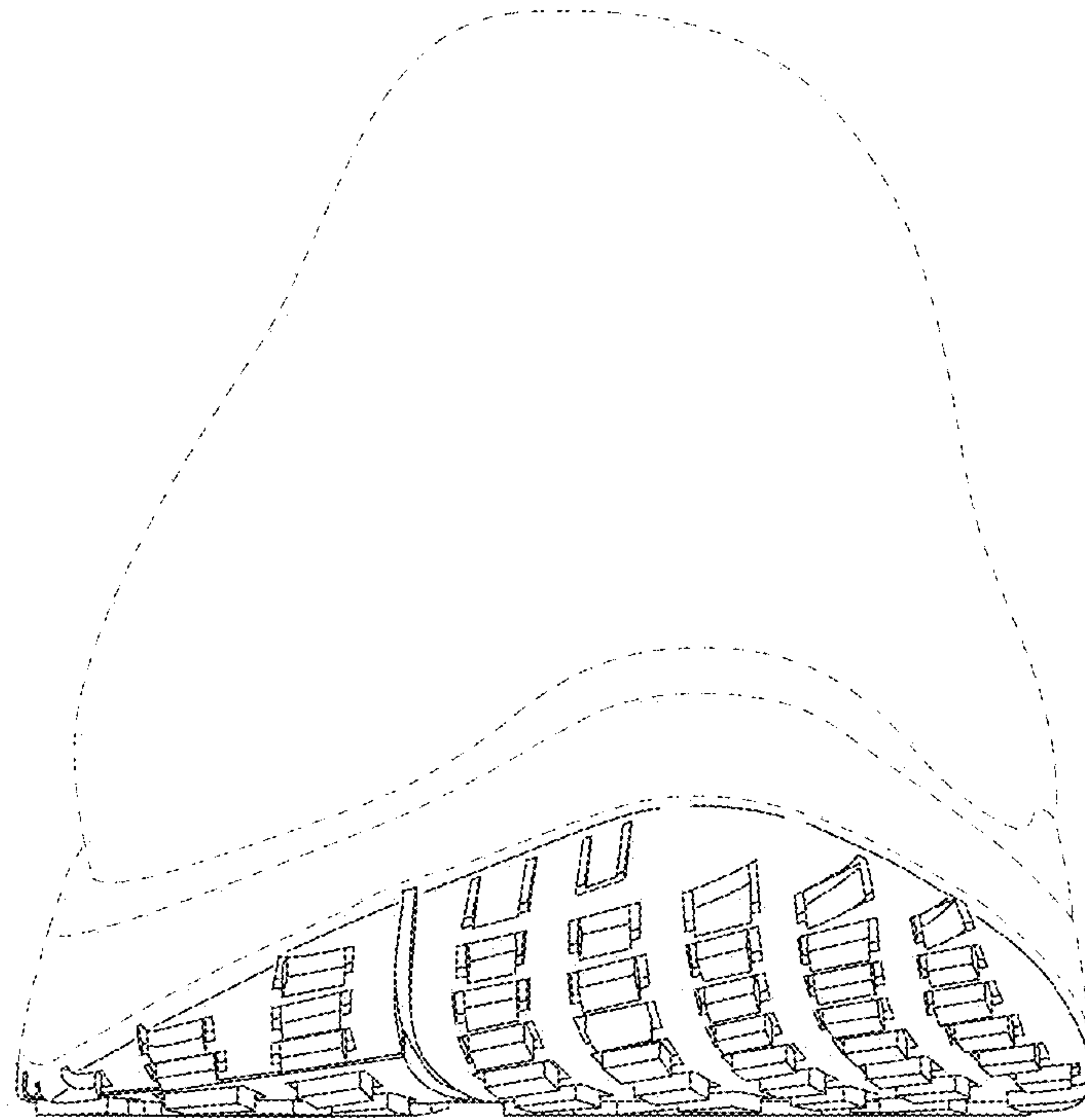

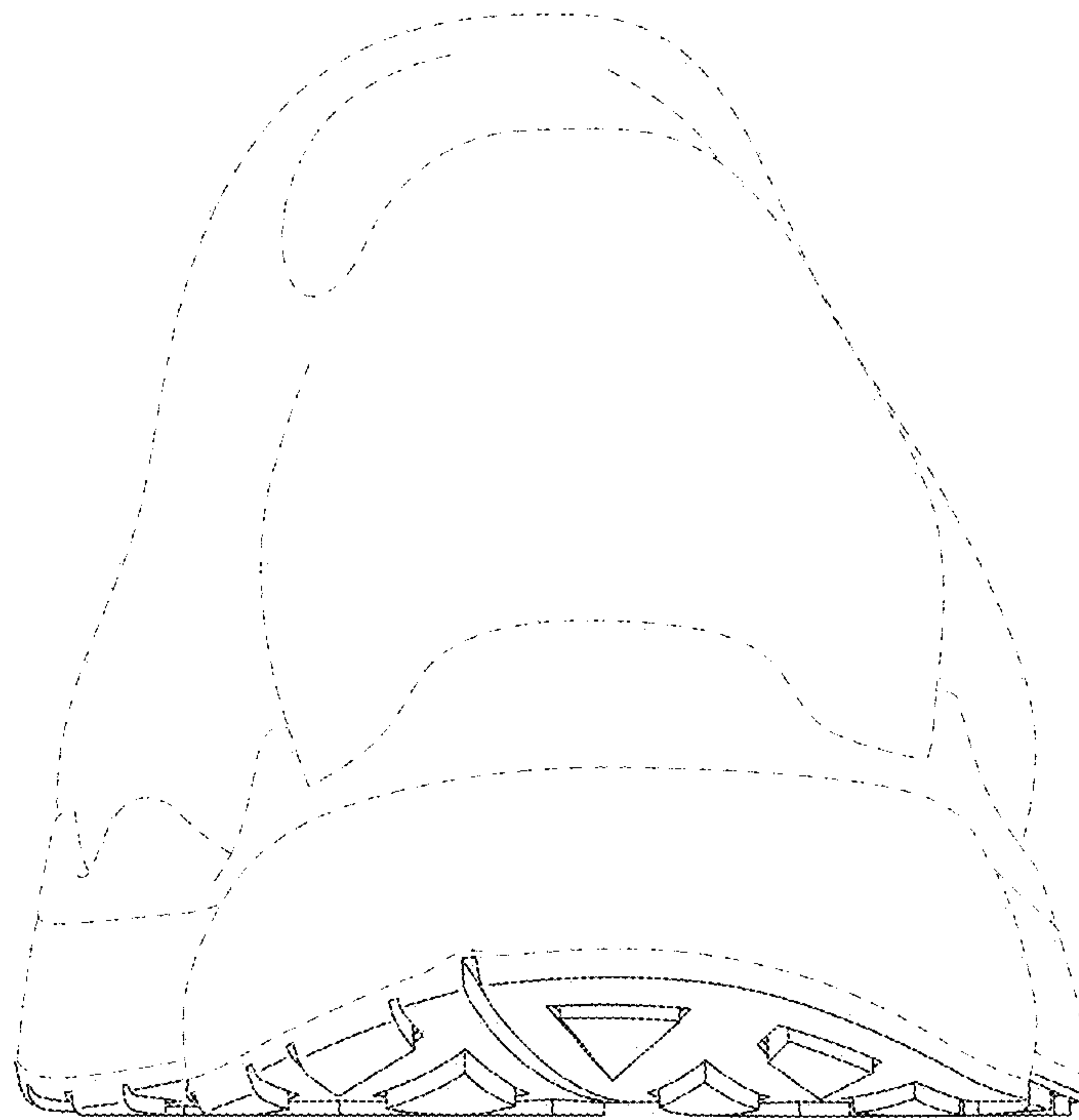
