We claim the ornamental design for a combined television, rollable display, and speaker drawer, as shown and described.

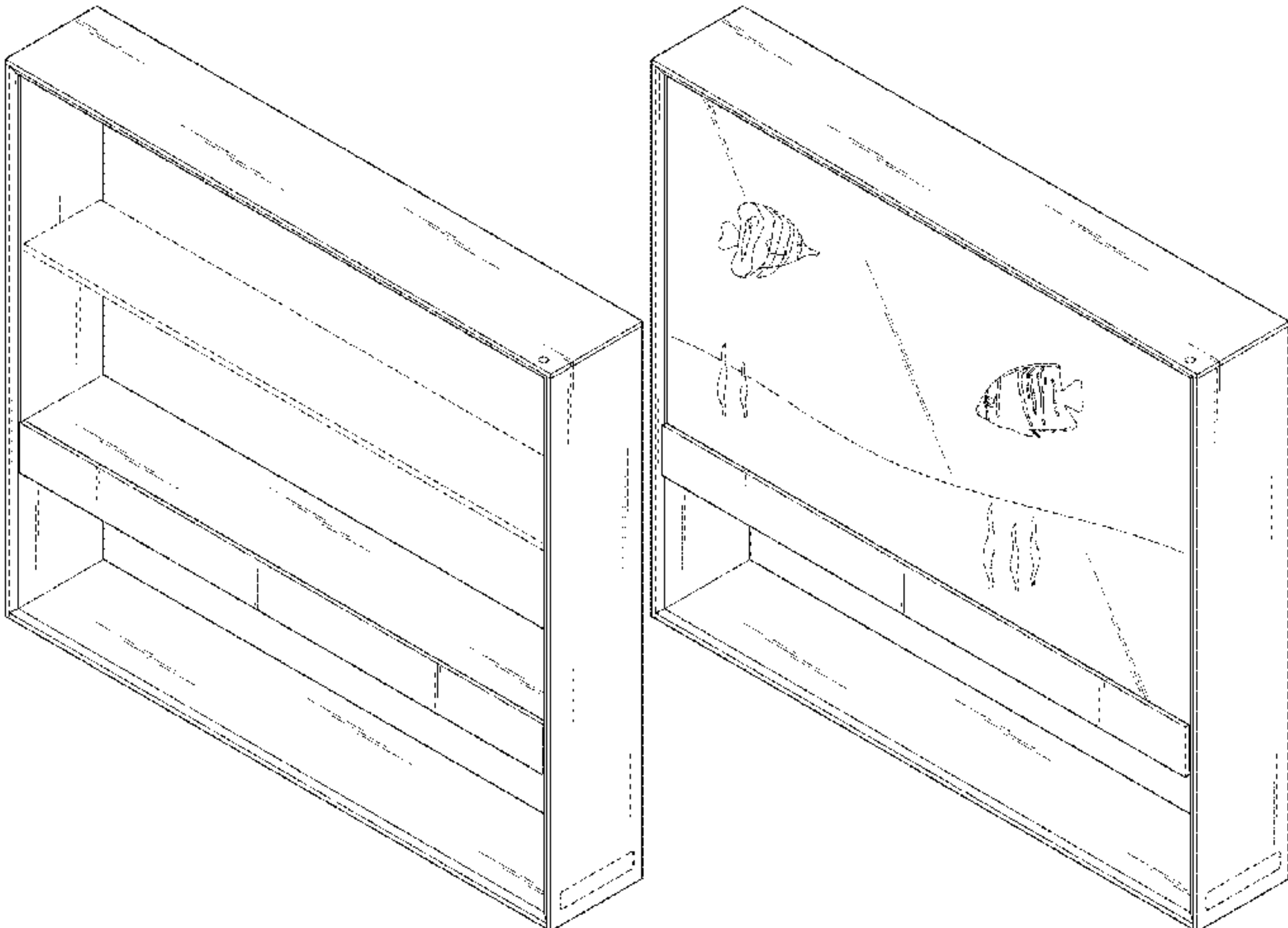


FIG. 2 is a rear perspective view thereof;

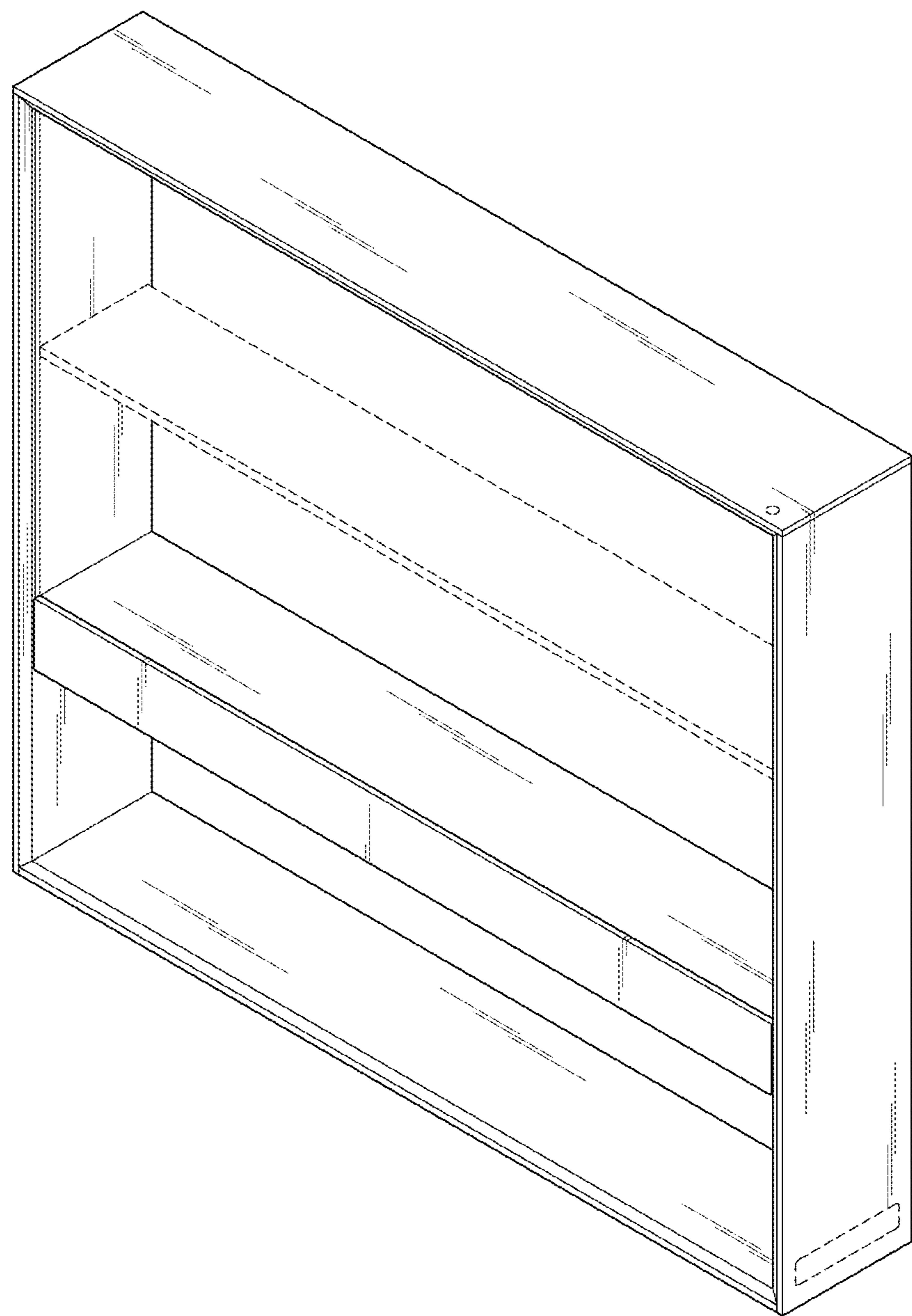

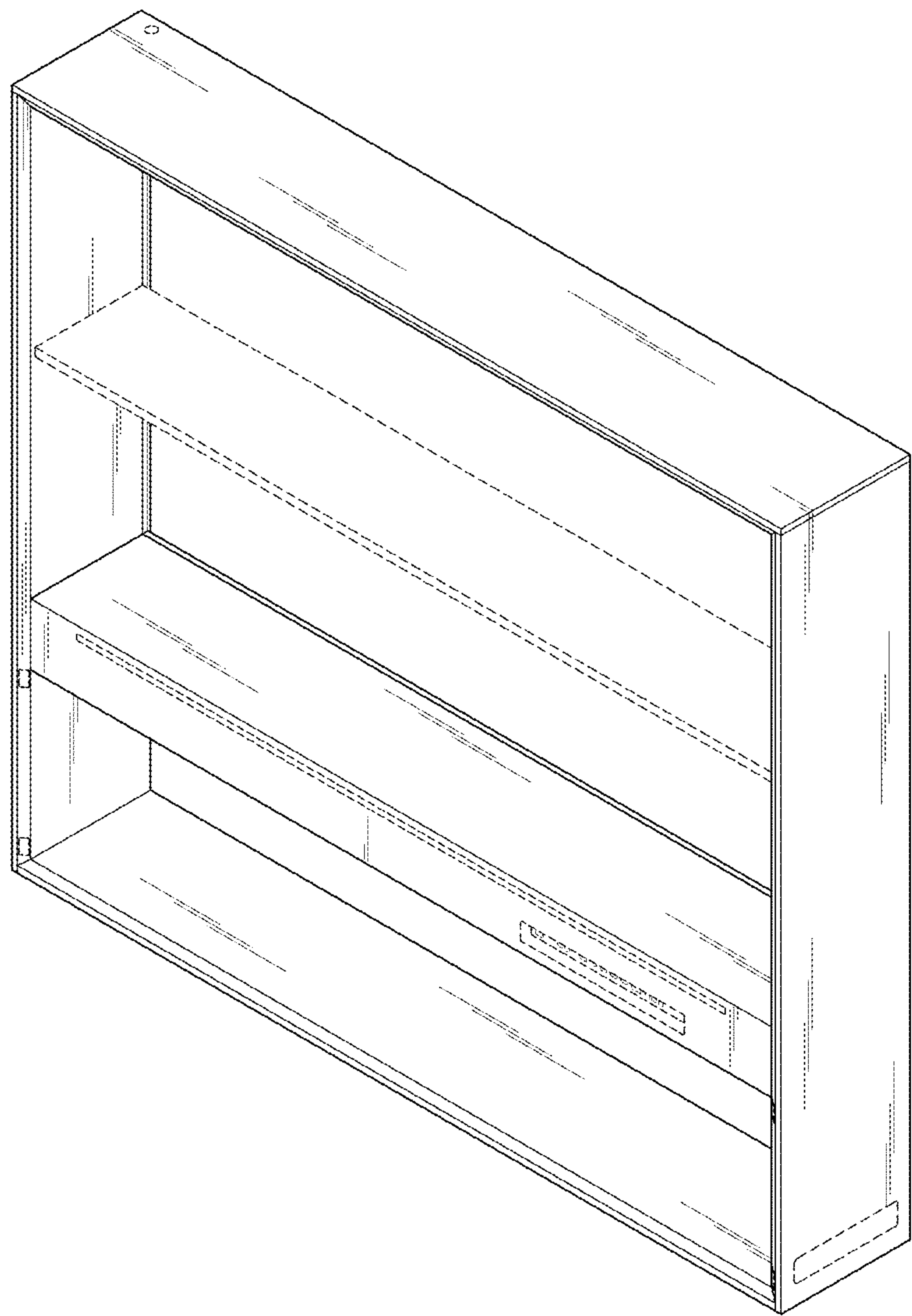

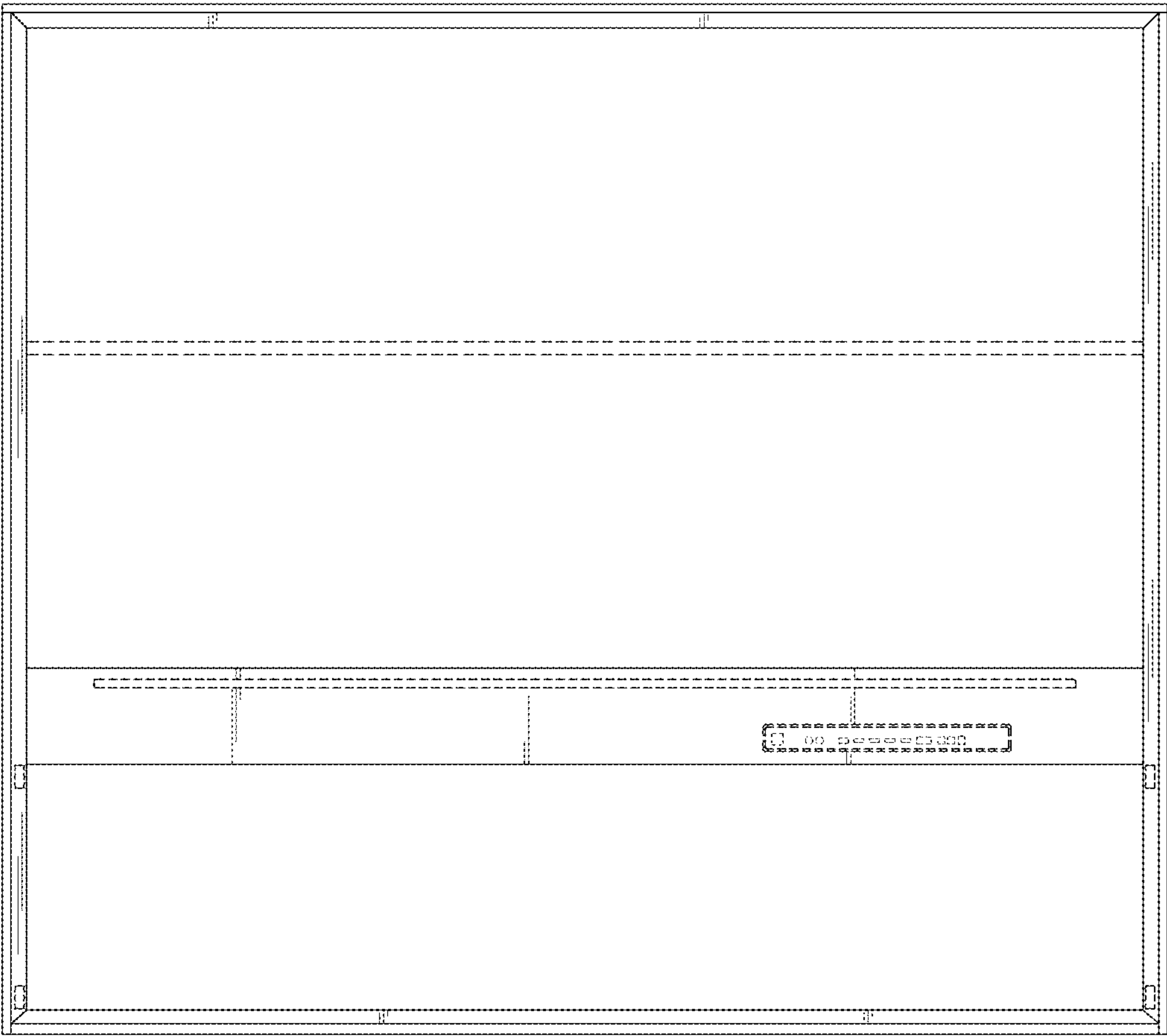

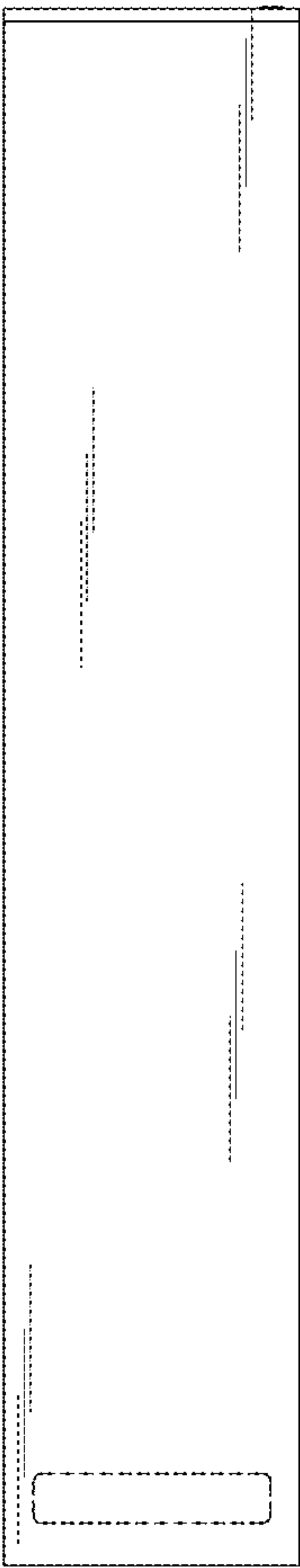

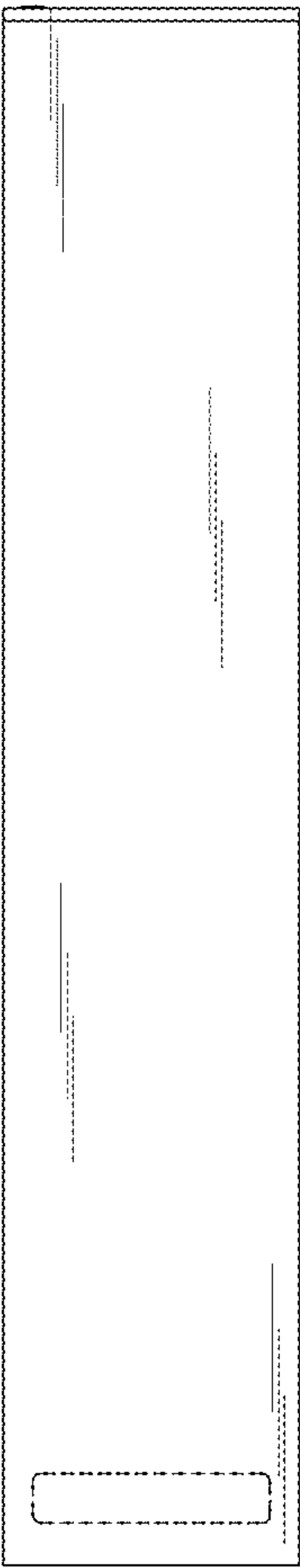

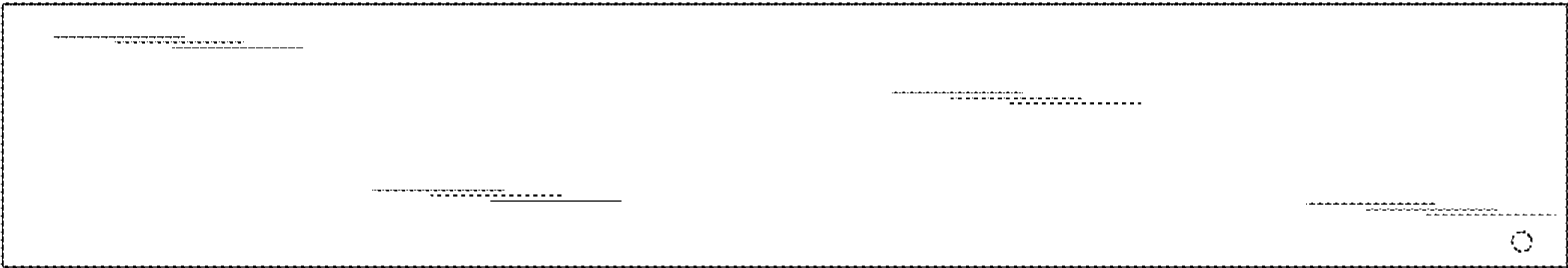

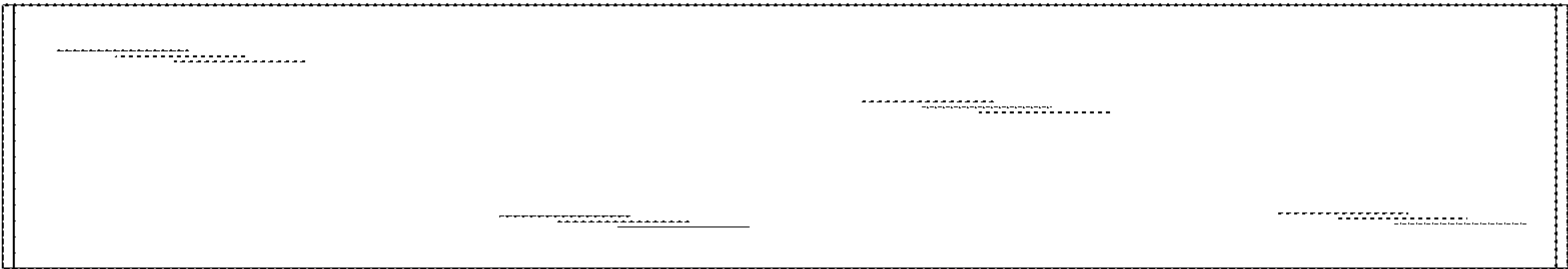

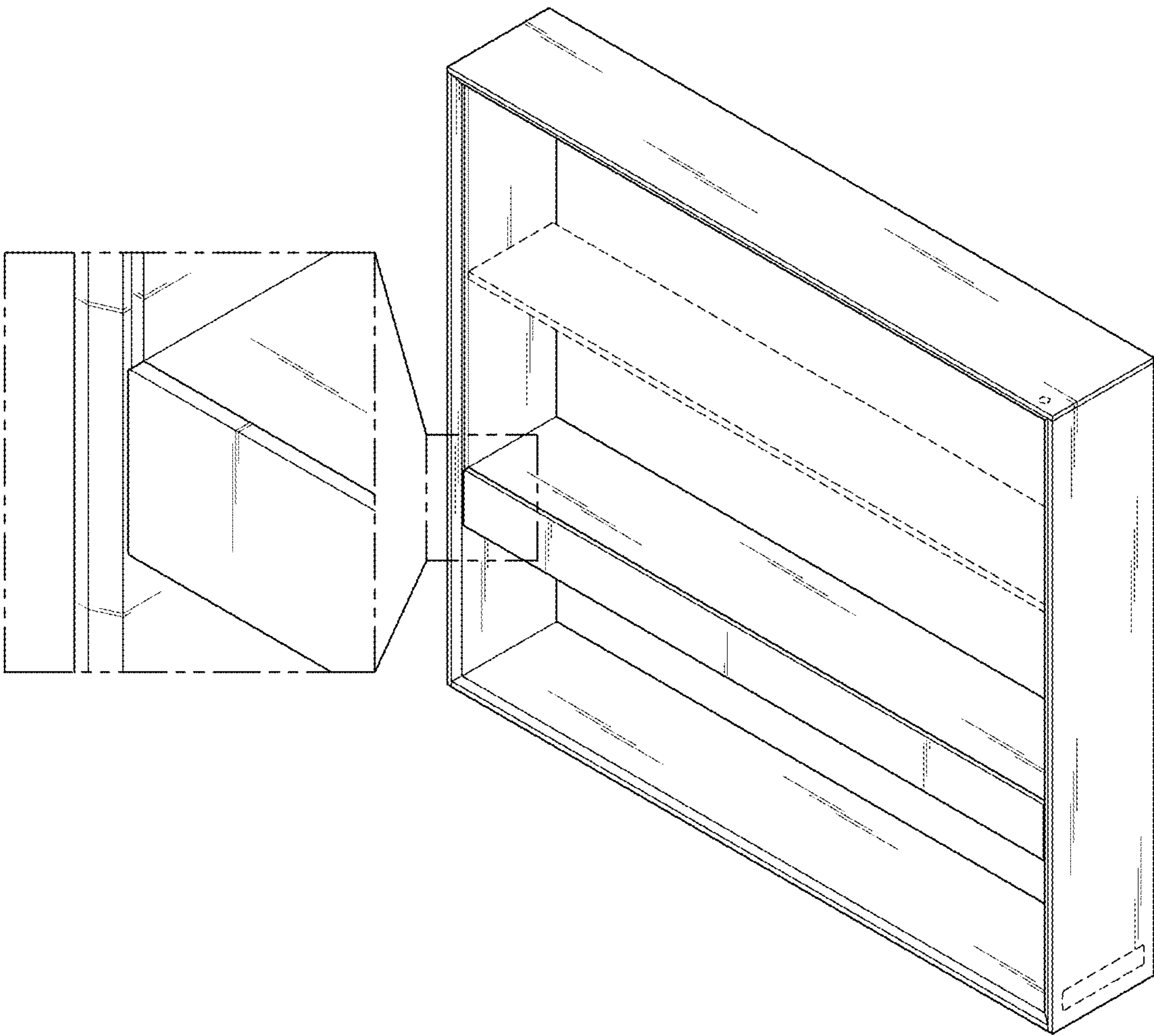

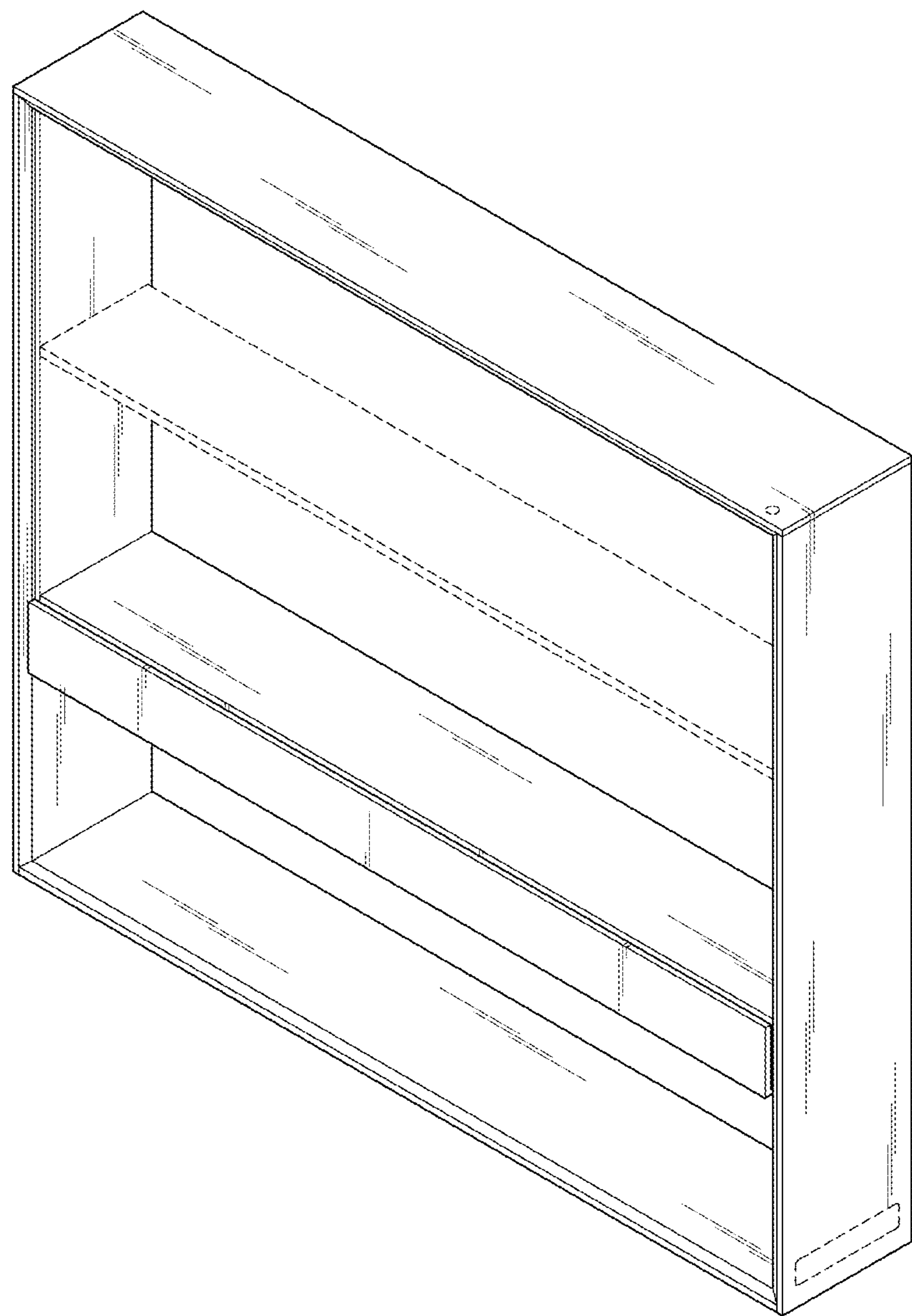

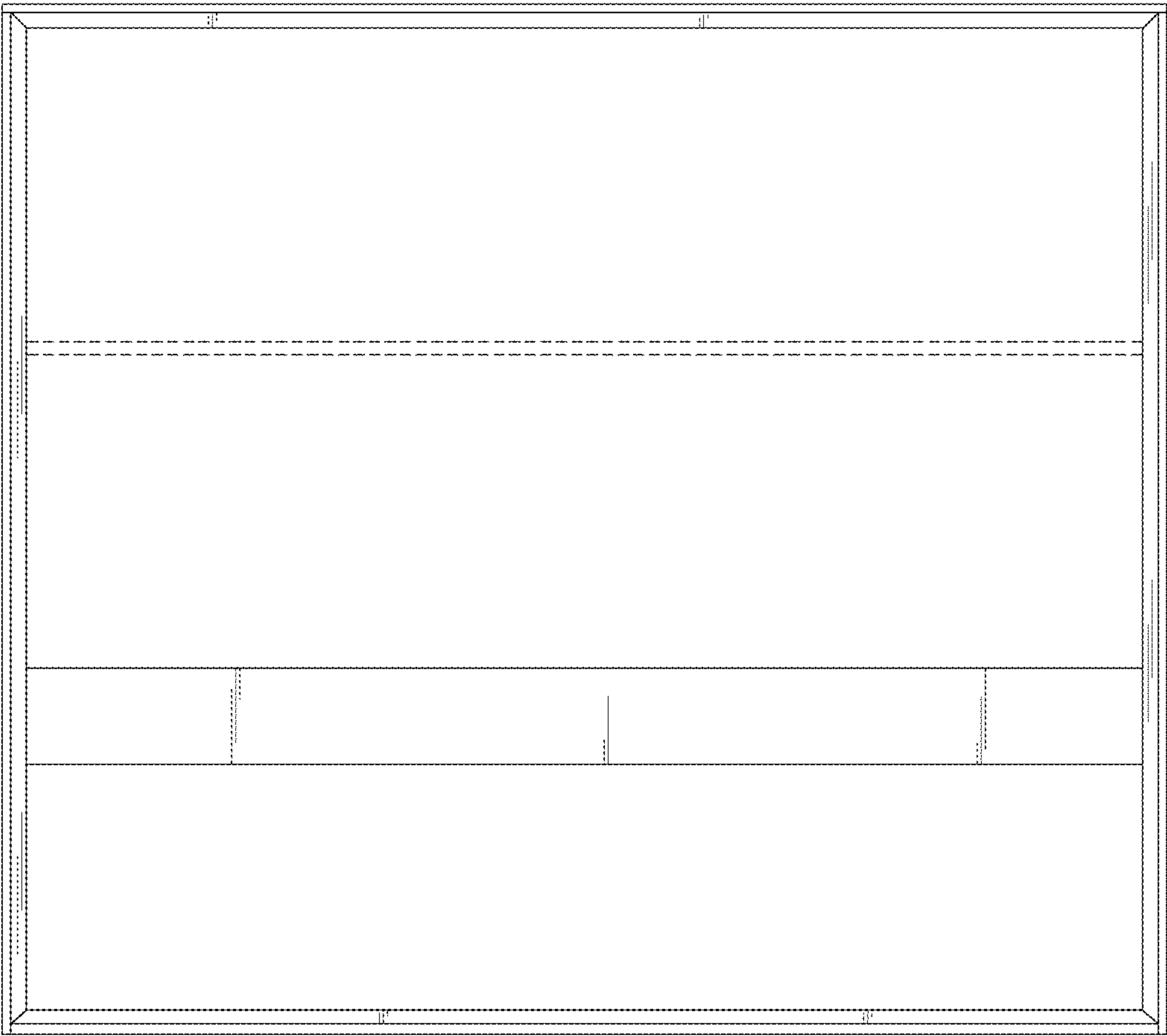

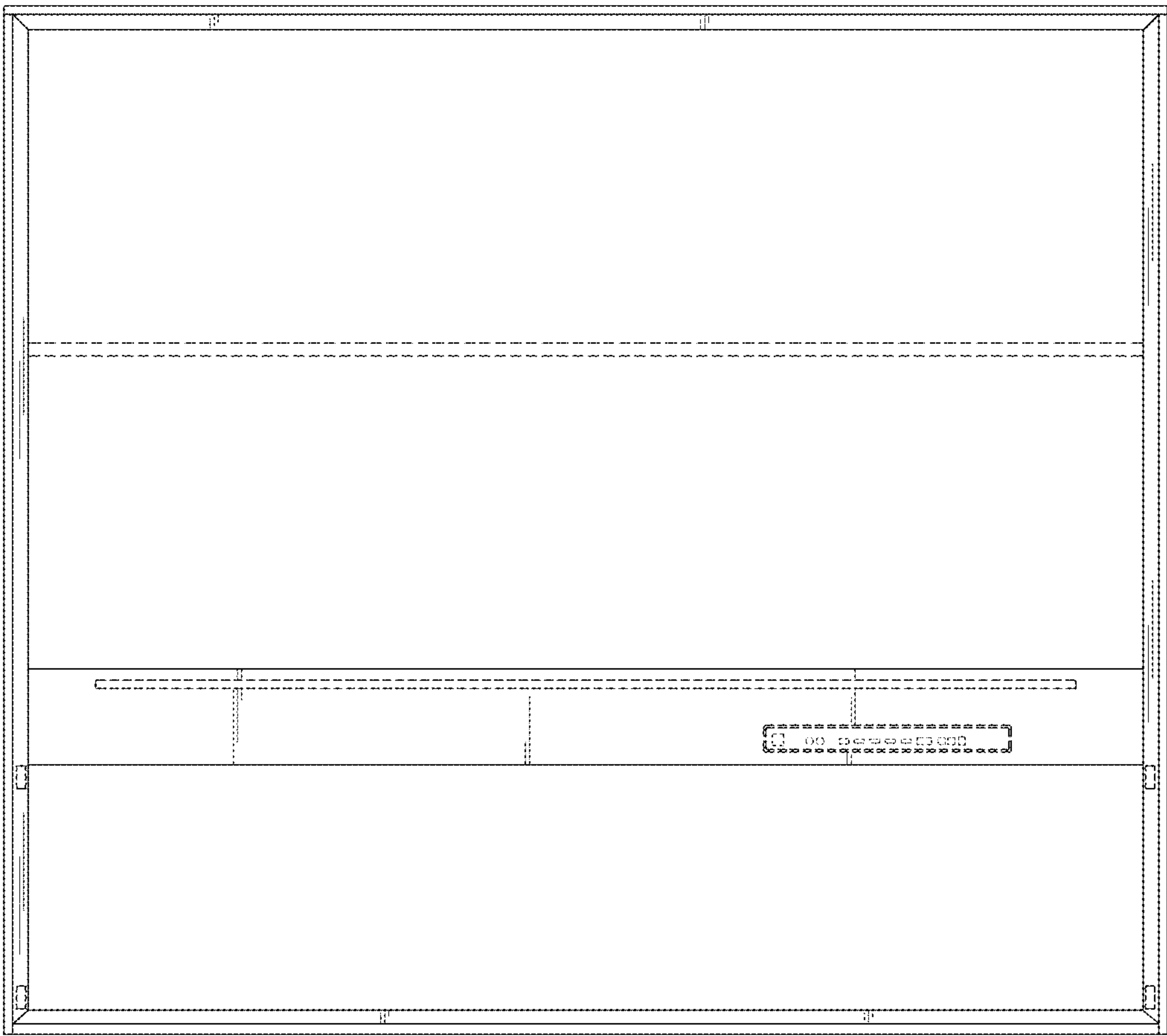

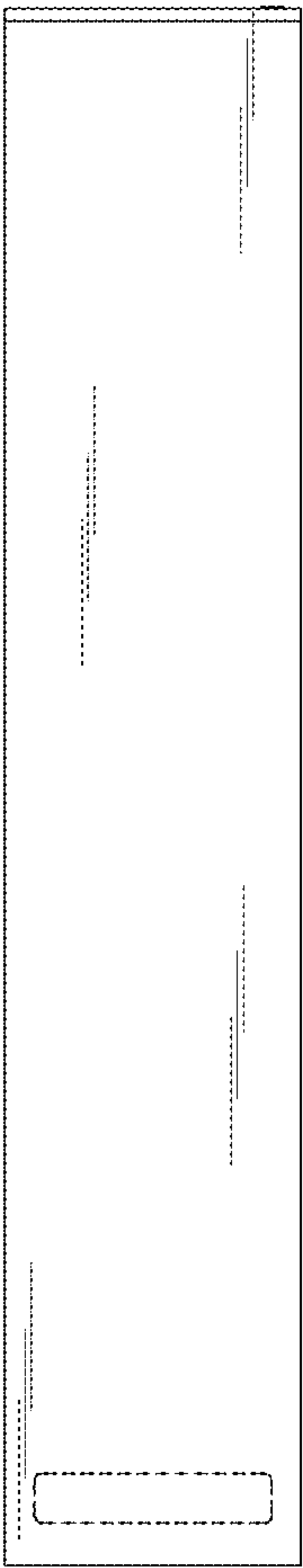

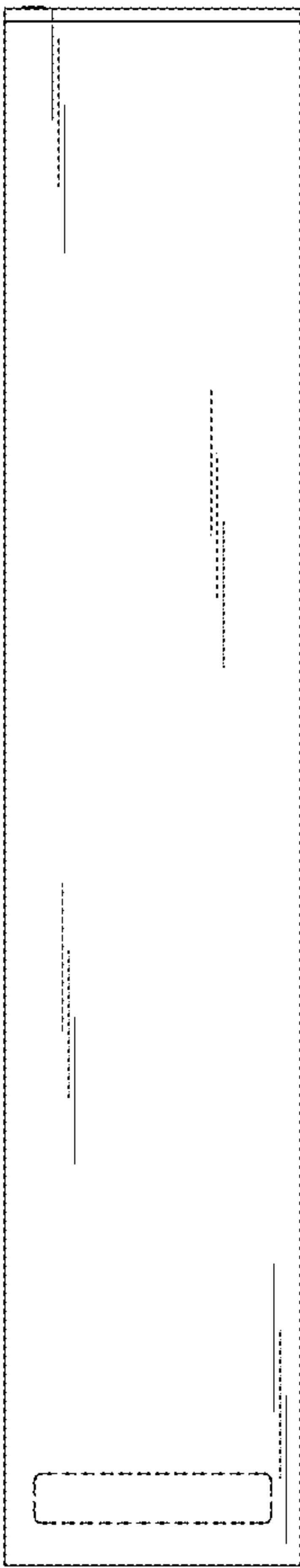

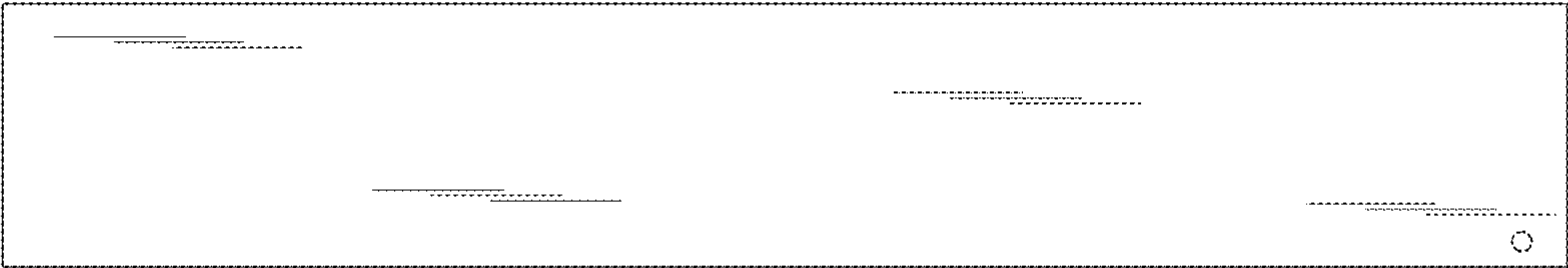

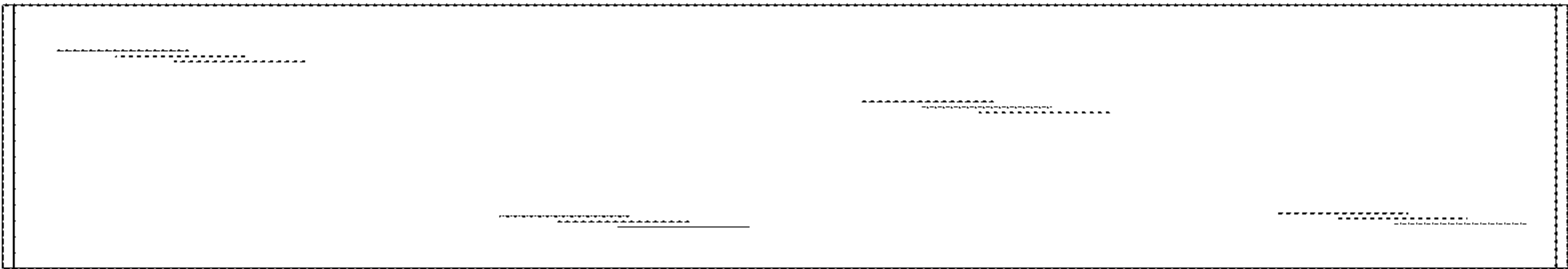

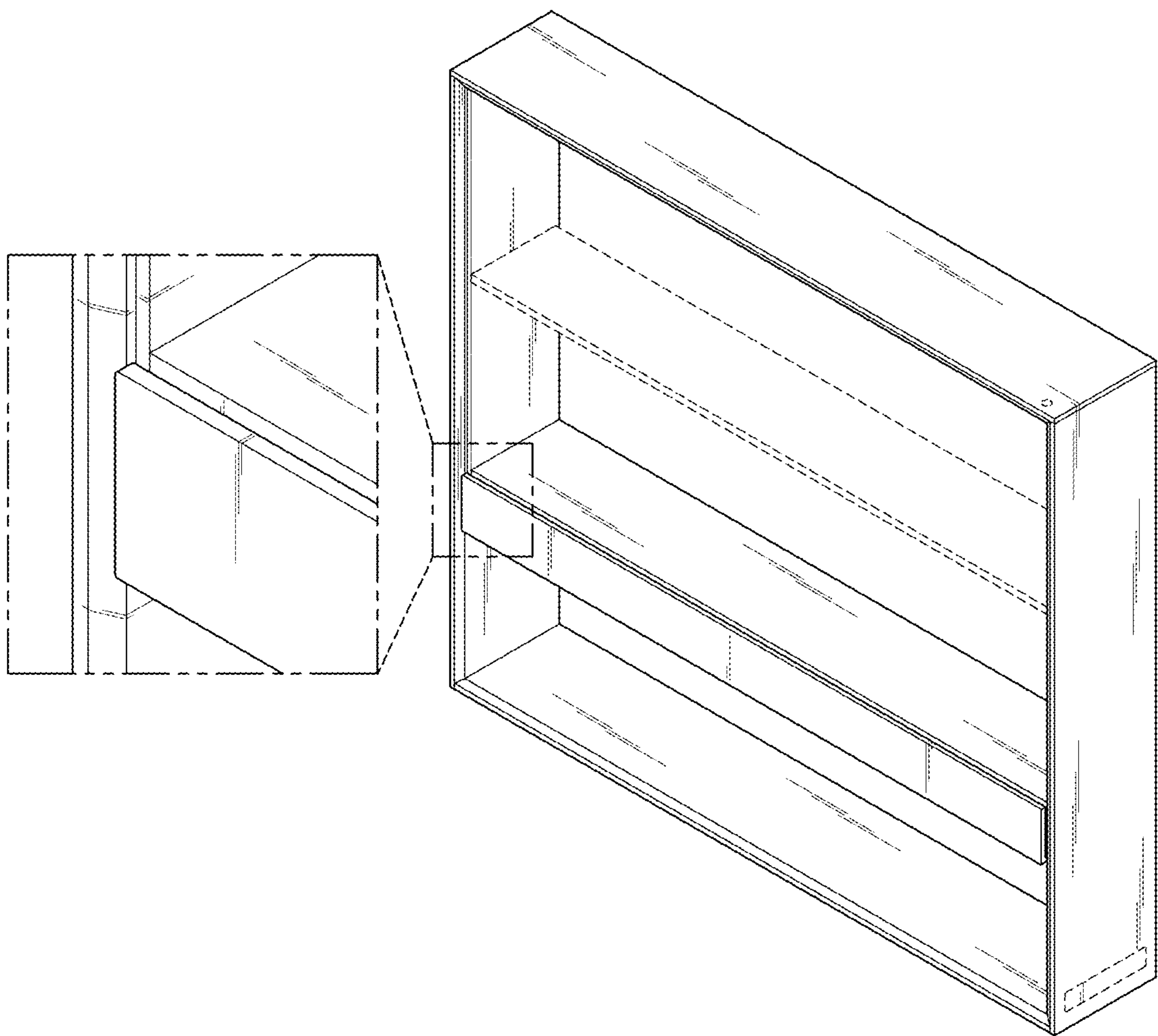

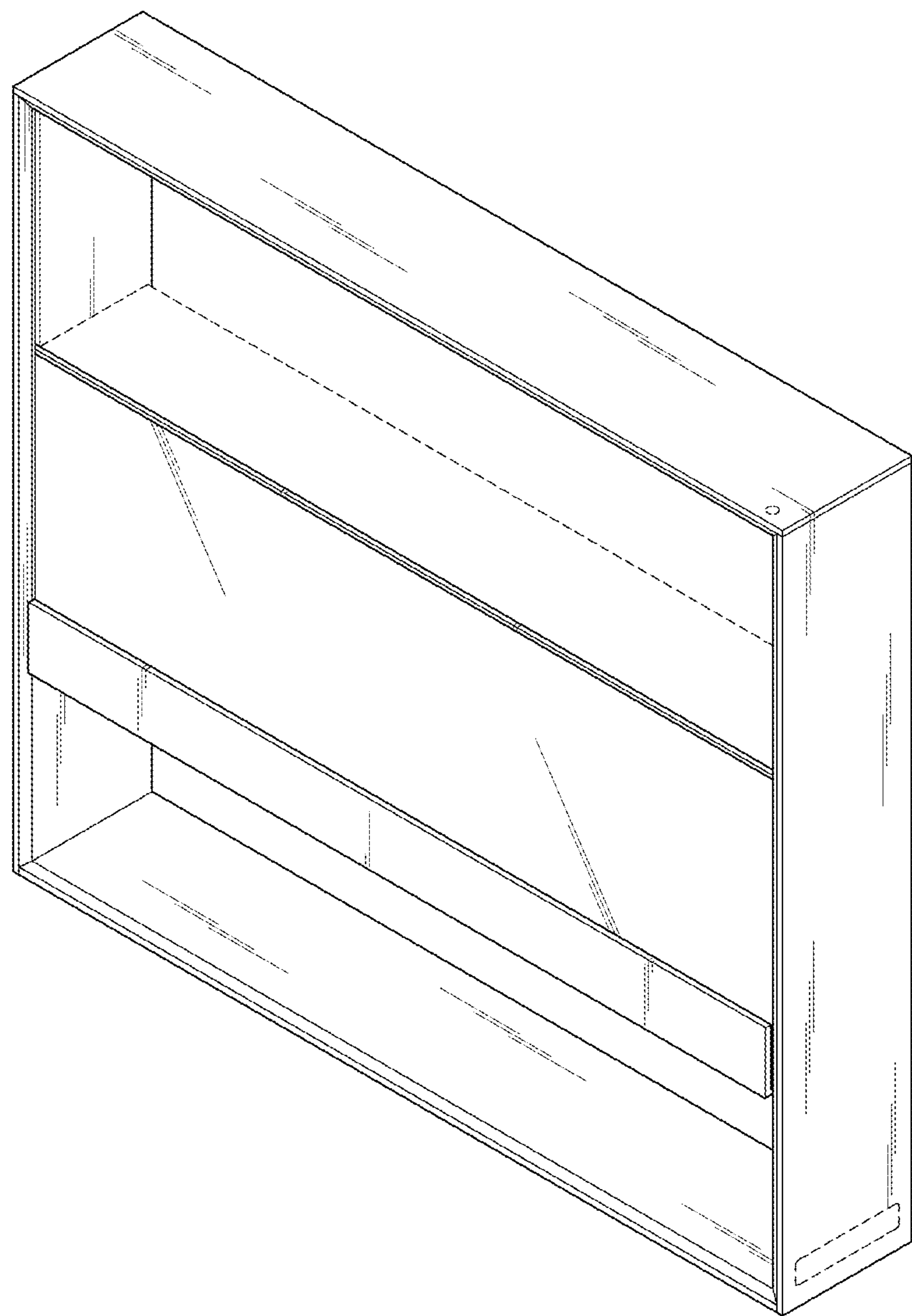

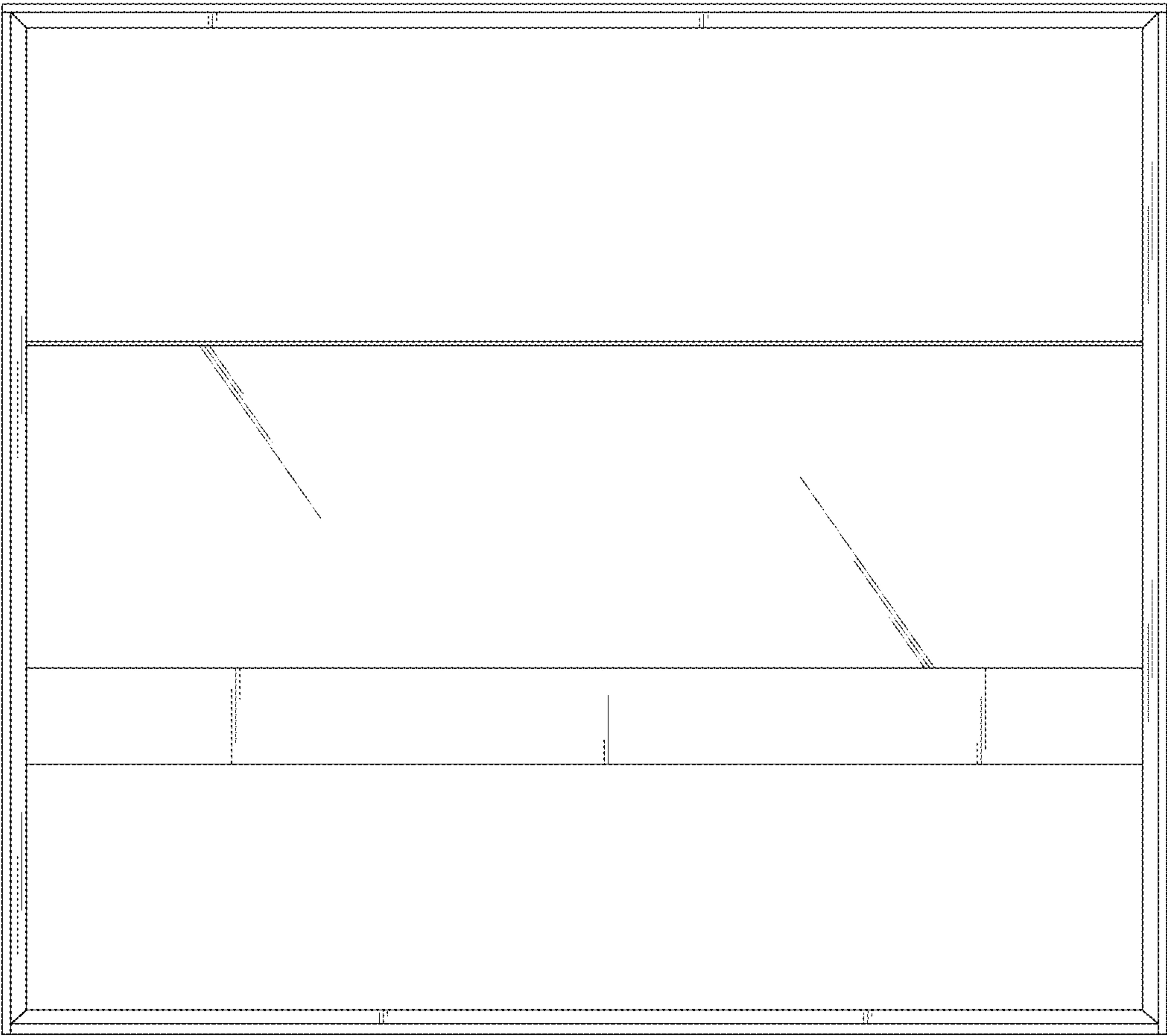

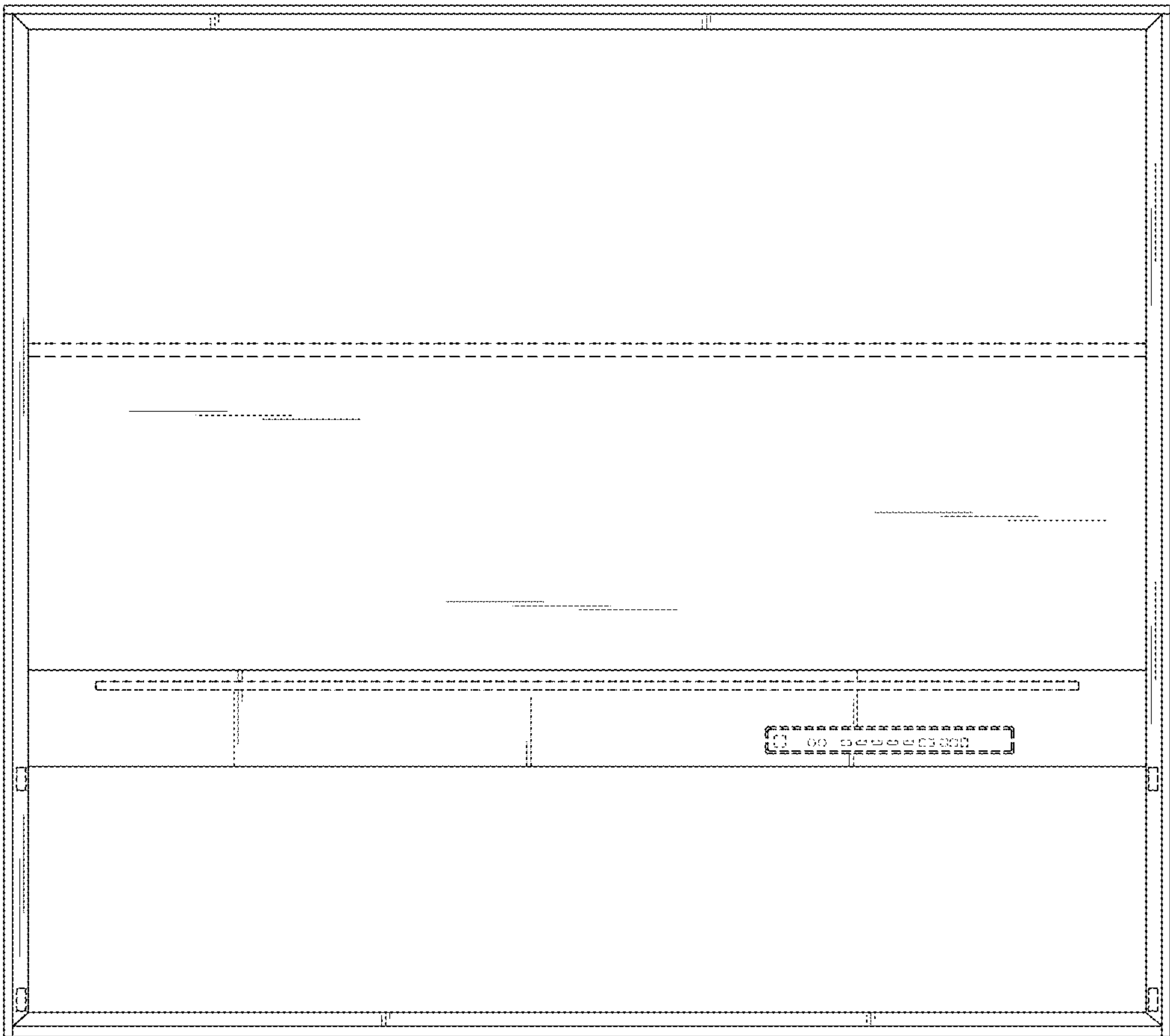

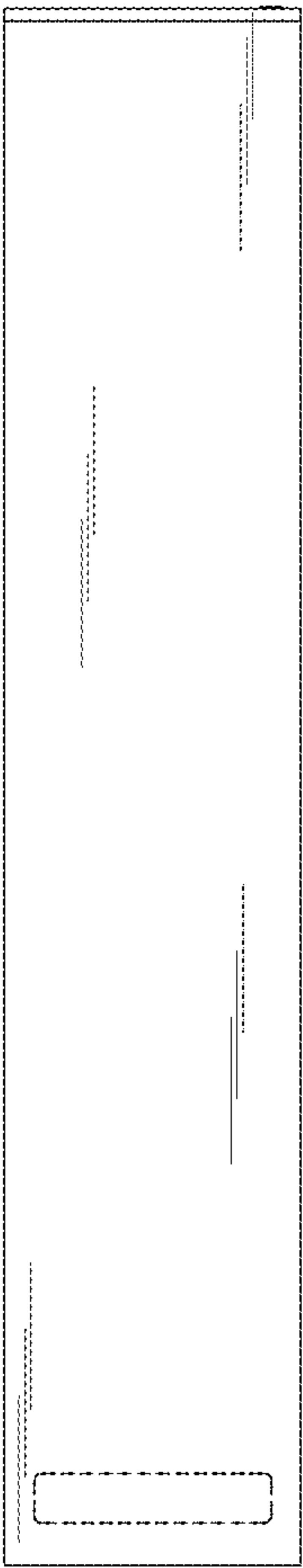

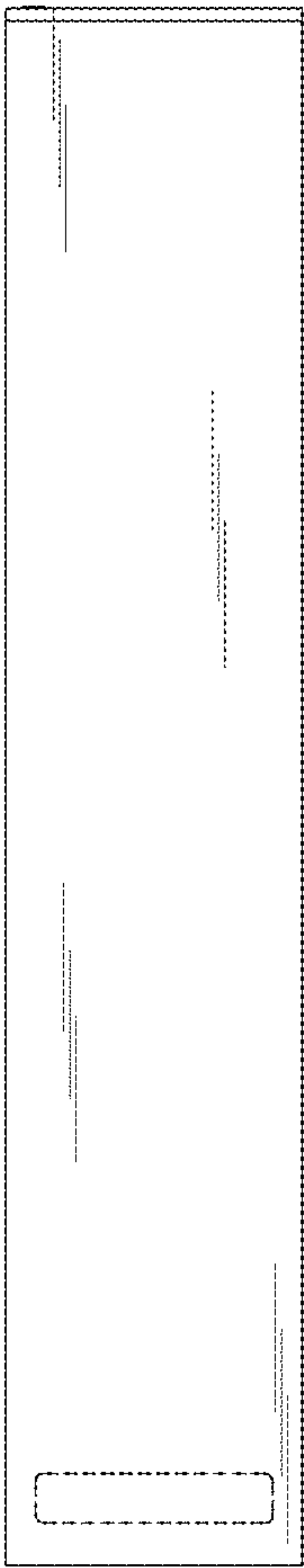

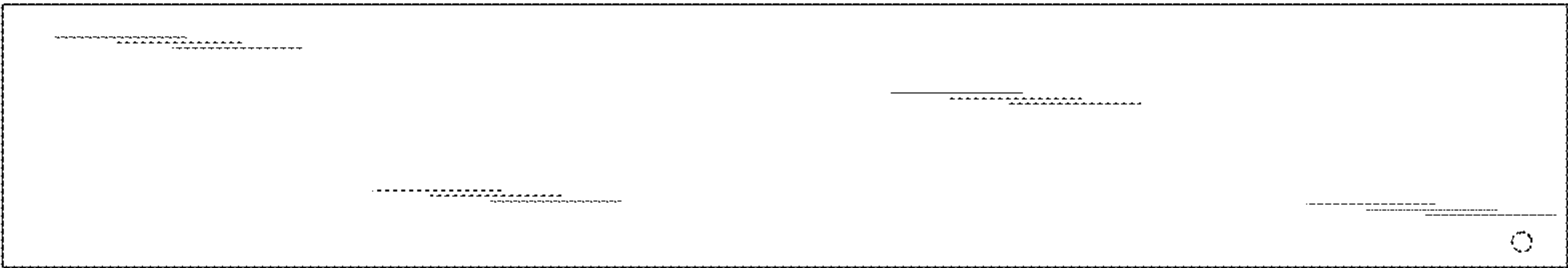

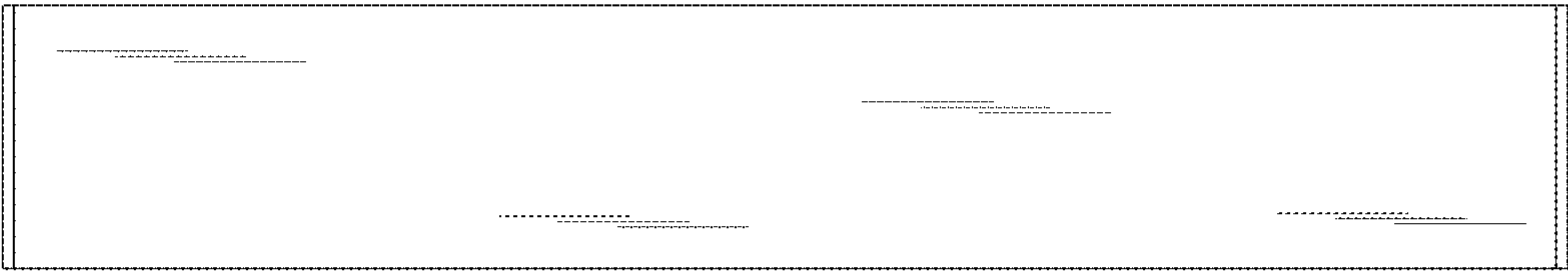

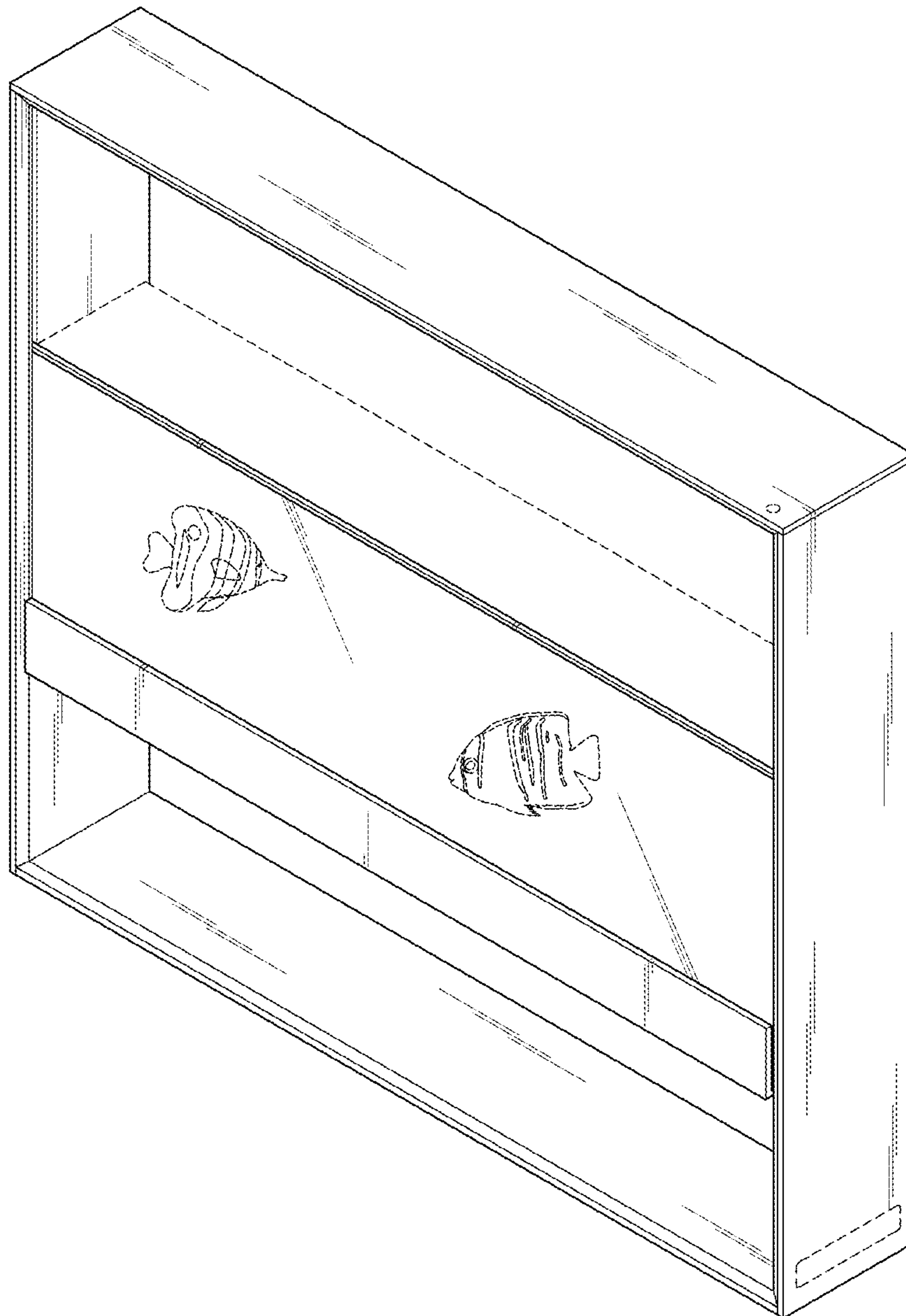

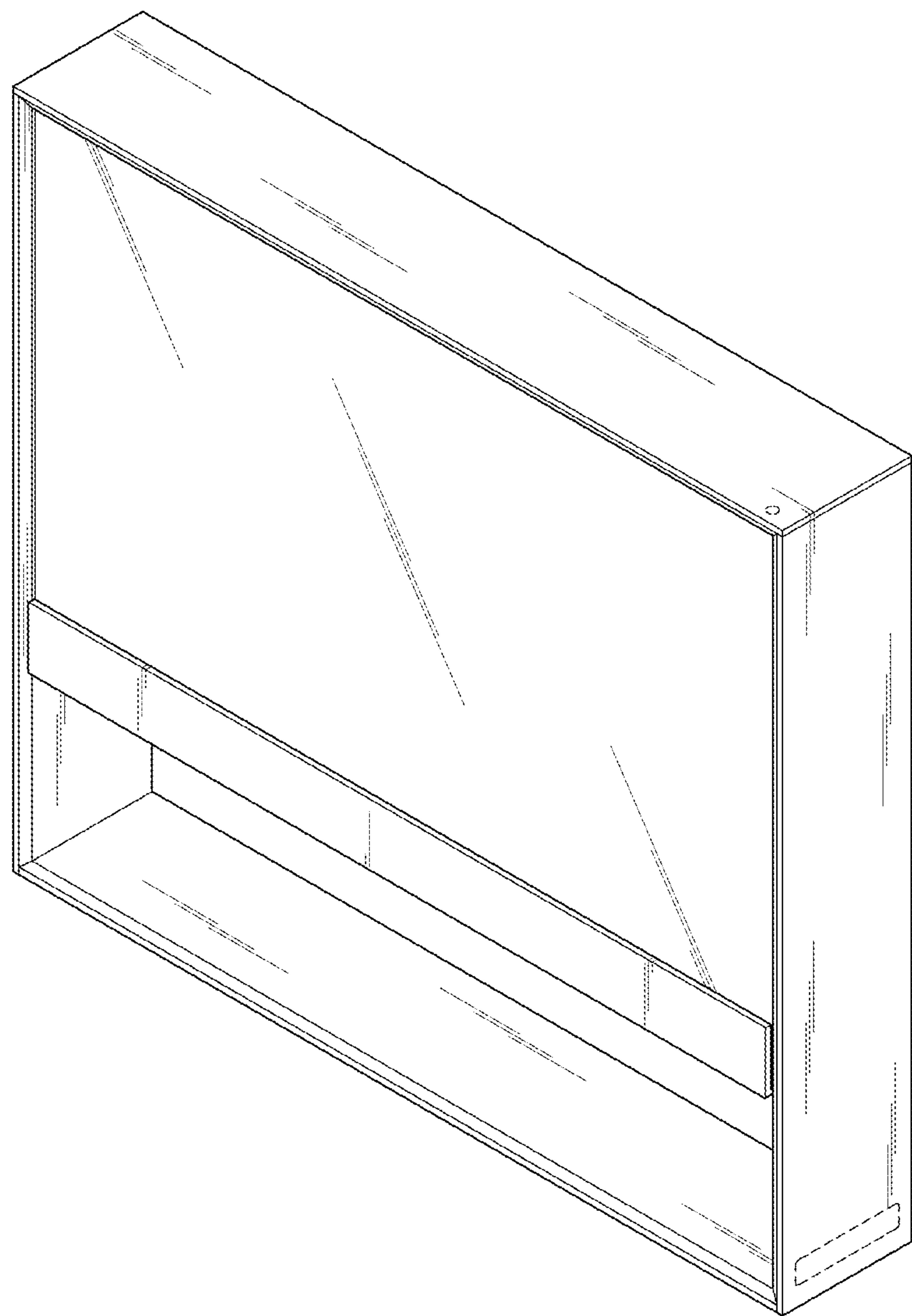

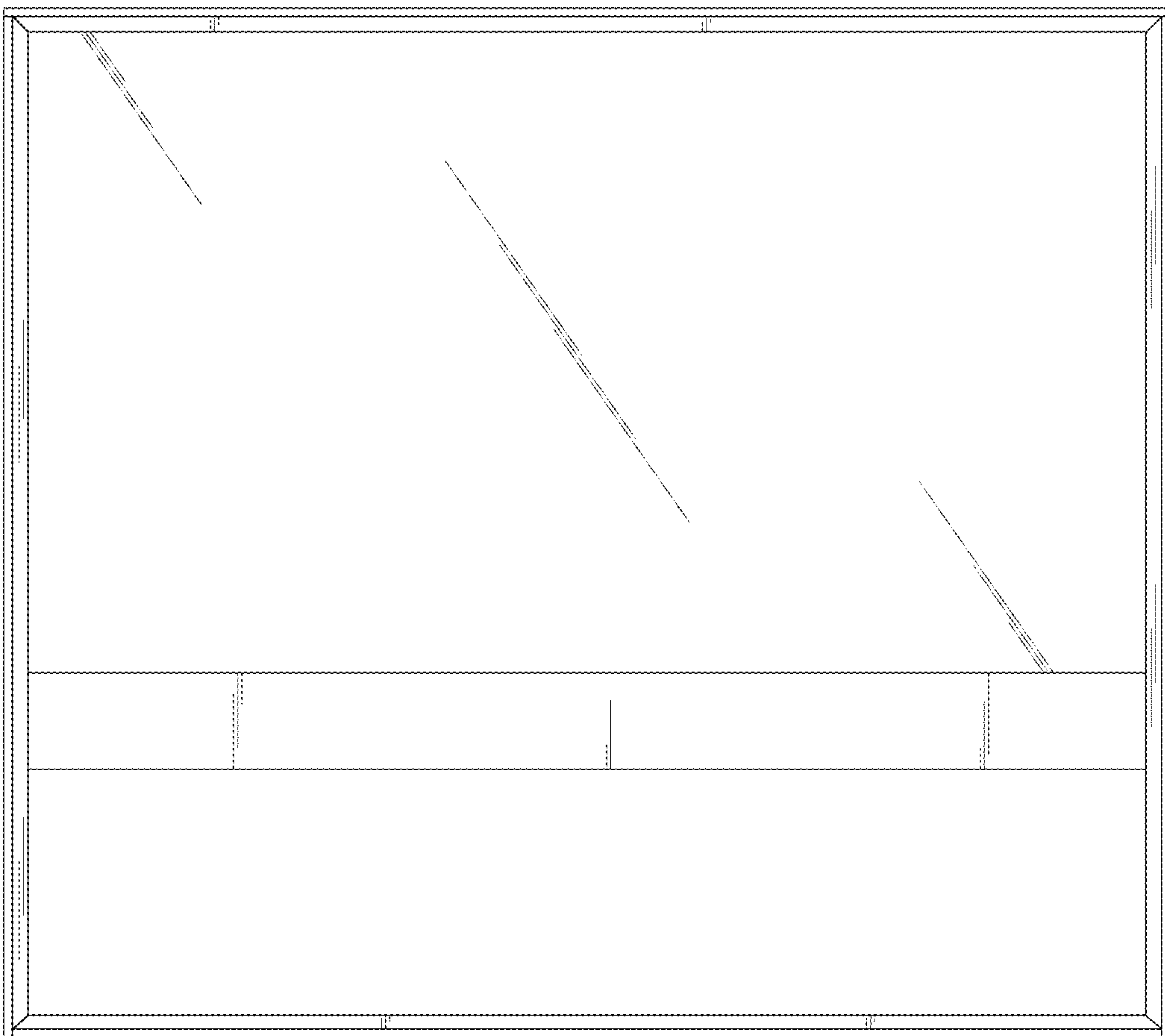

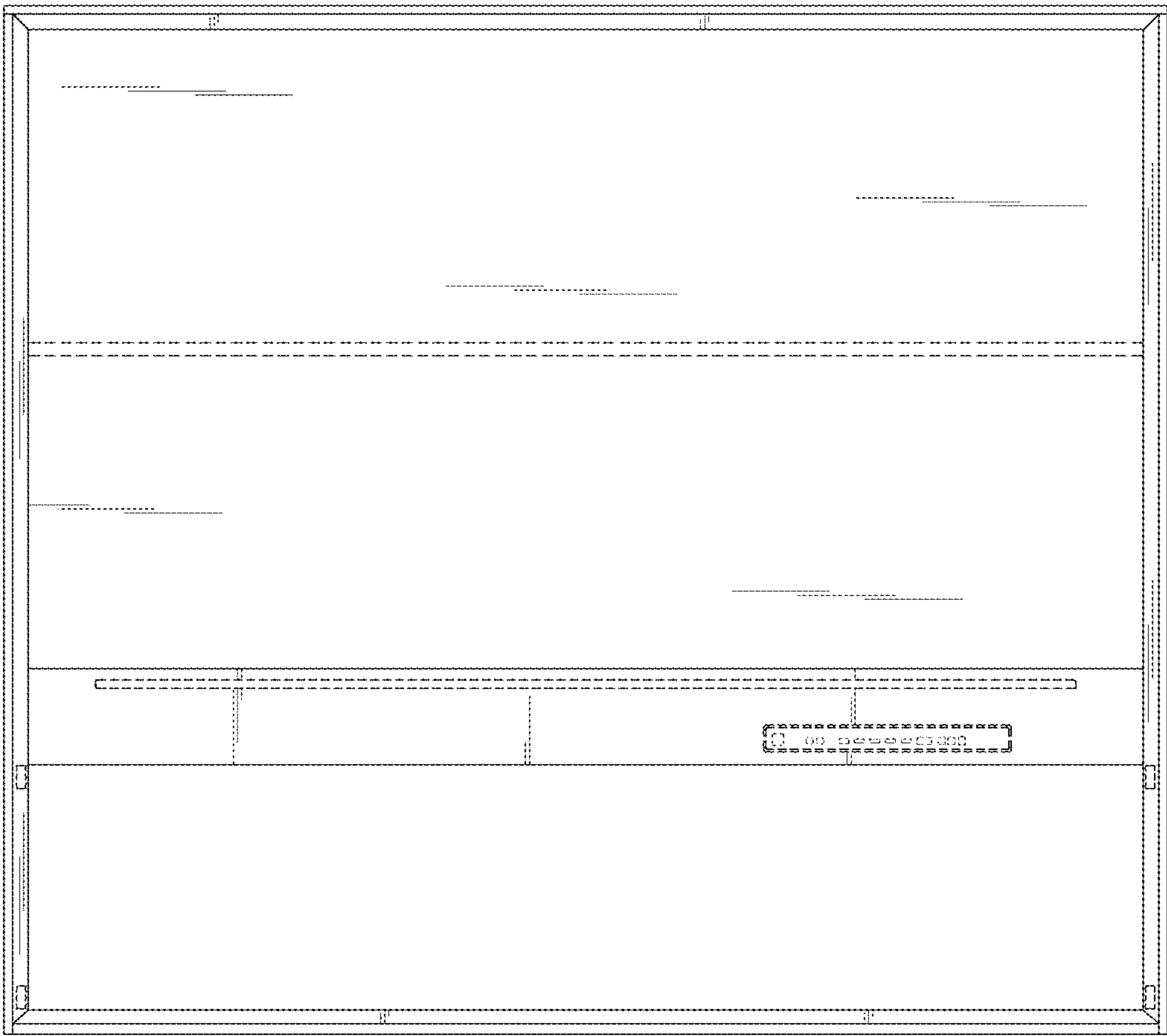

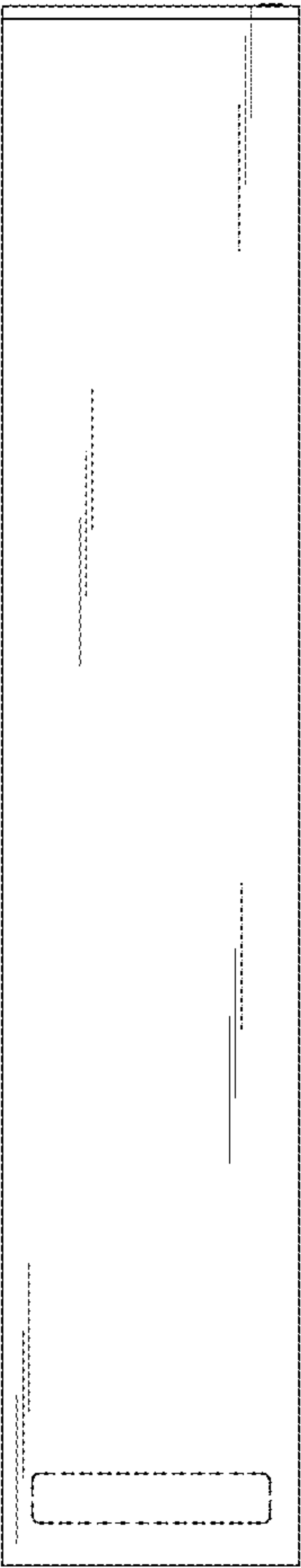

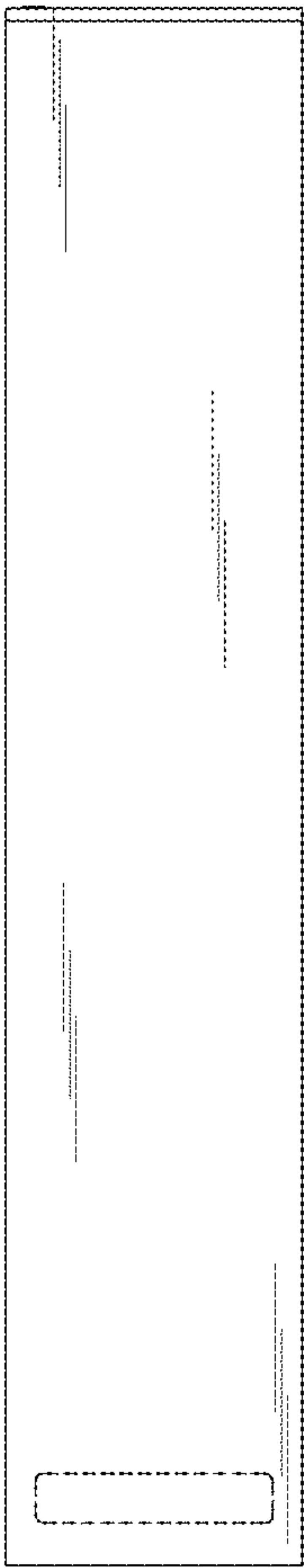

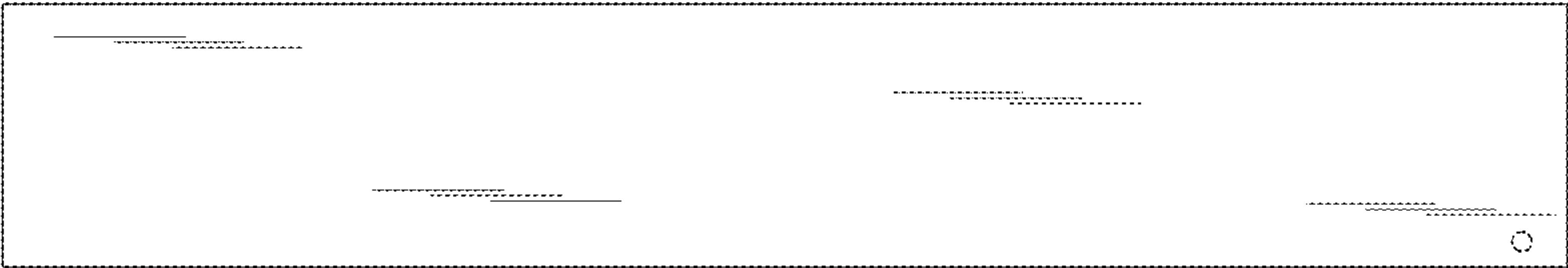

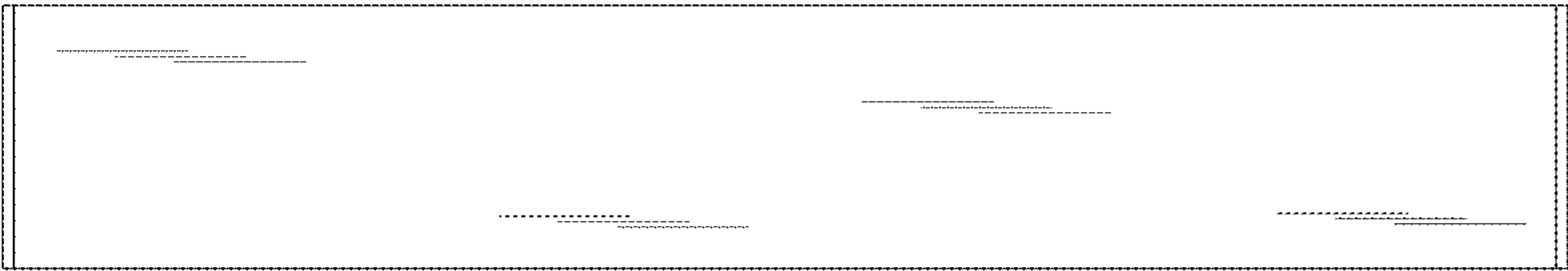
