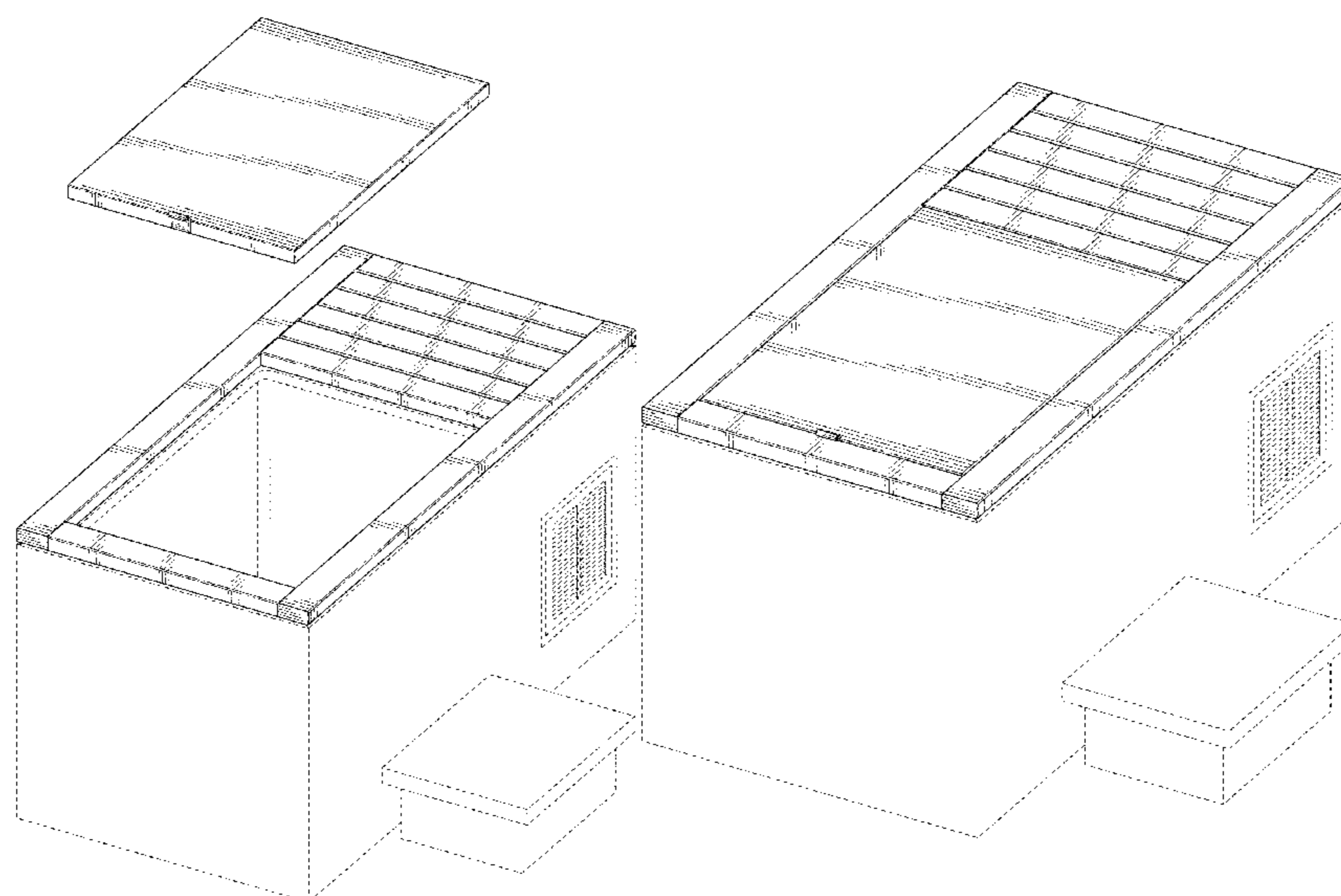

DESCRIPTION

FIG. 1 is a front, right-side perspective view of a tank showing an embodiment of my design with a lid removed; FIG. 2 is a rear, left-side perspective view thereof with the lid removed; FIG. 3 is a front, right-side perspective view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right-side elevation view thereof; FIG. 7 is a left-side elevation view thereof; FIG. 8 is a front elevation view thereof; and, FIG. 9 is a rear elevation view thereof. The broken lines shown in the drawings represent portions of the tank that form no part of the claimed design.

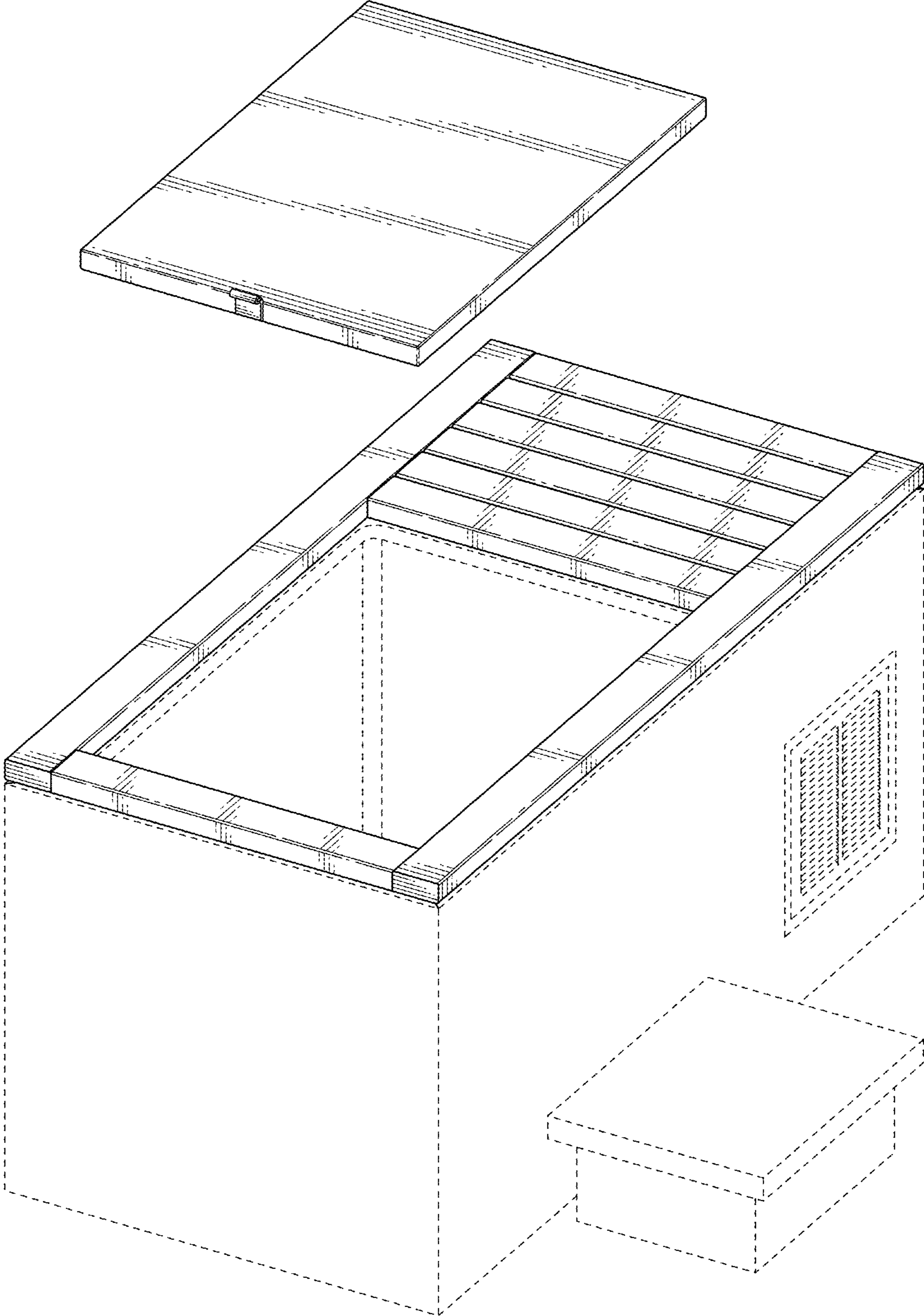

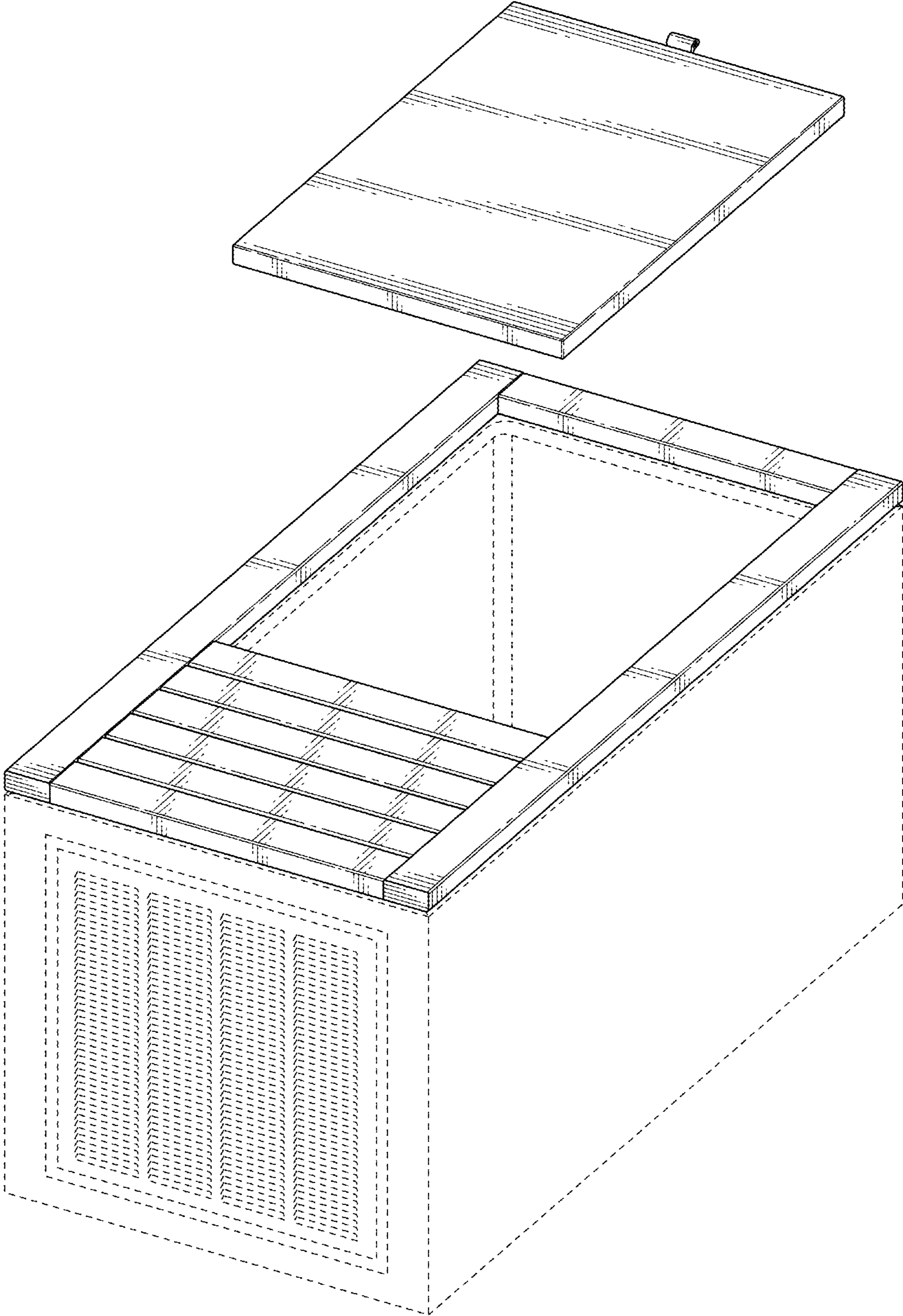

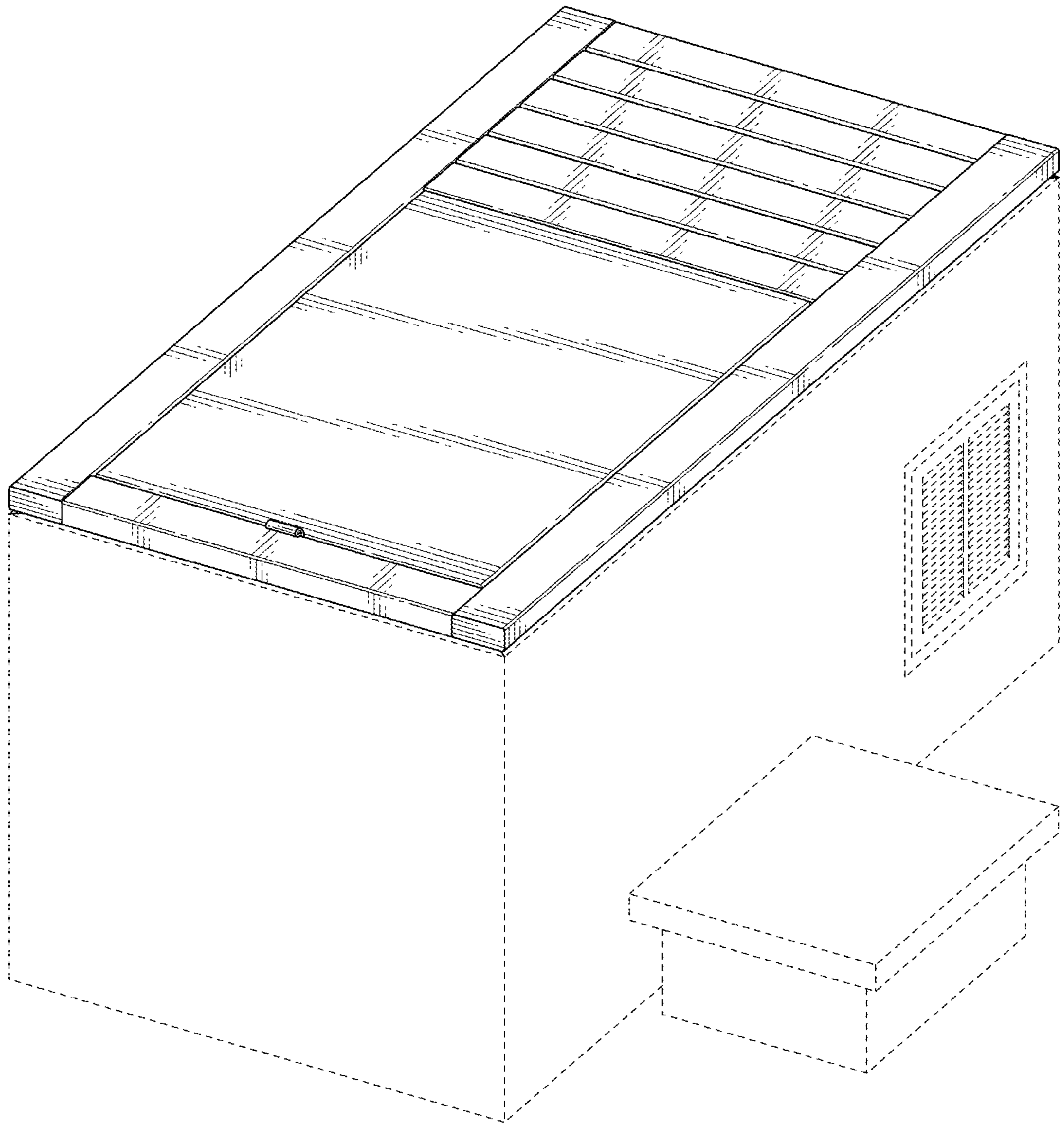

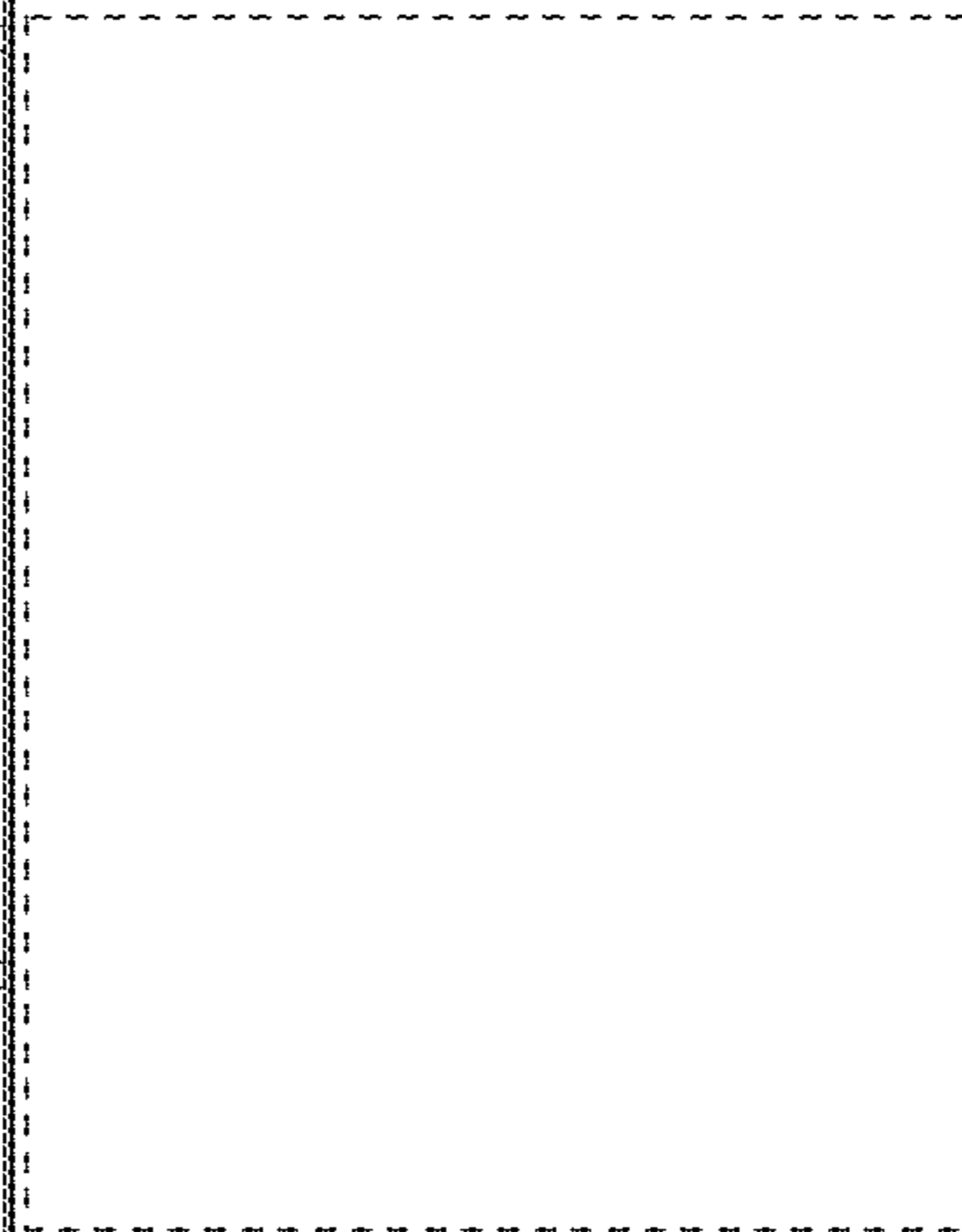
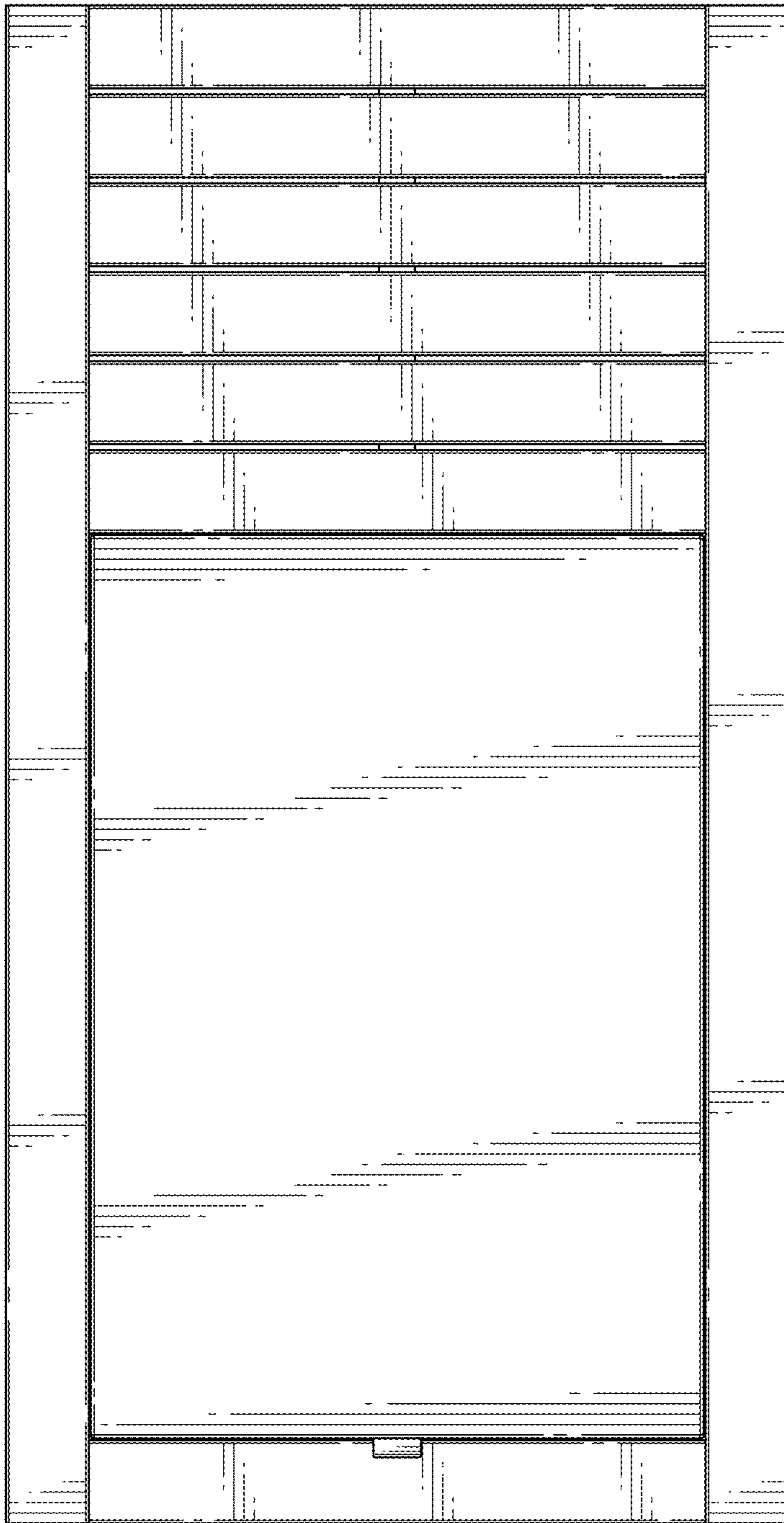

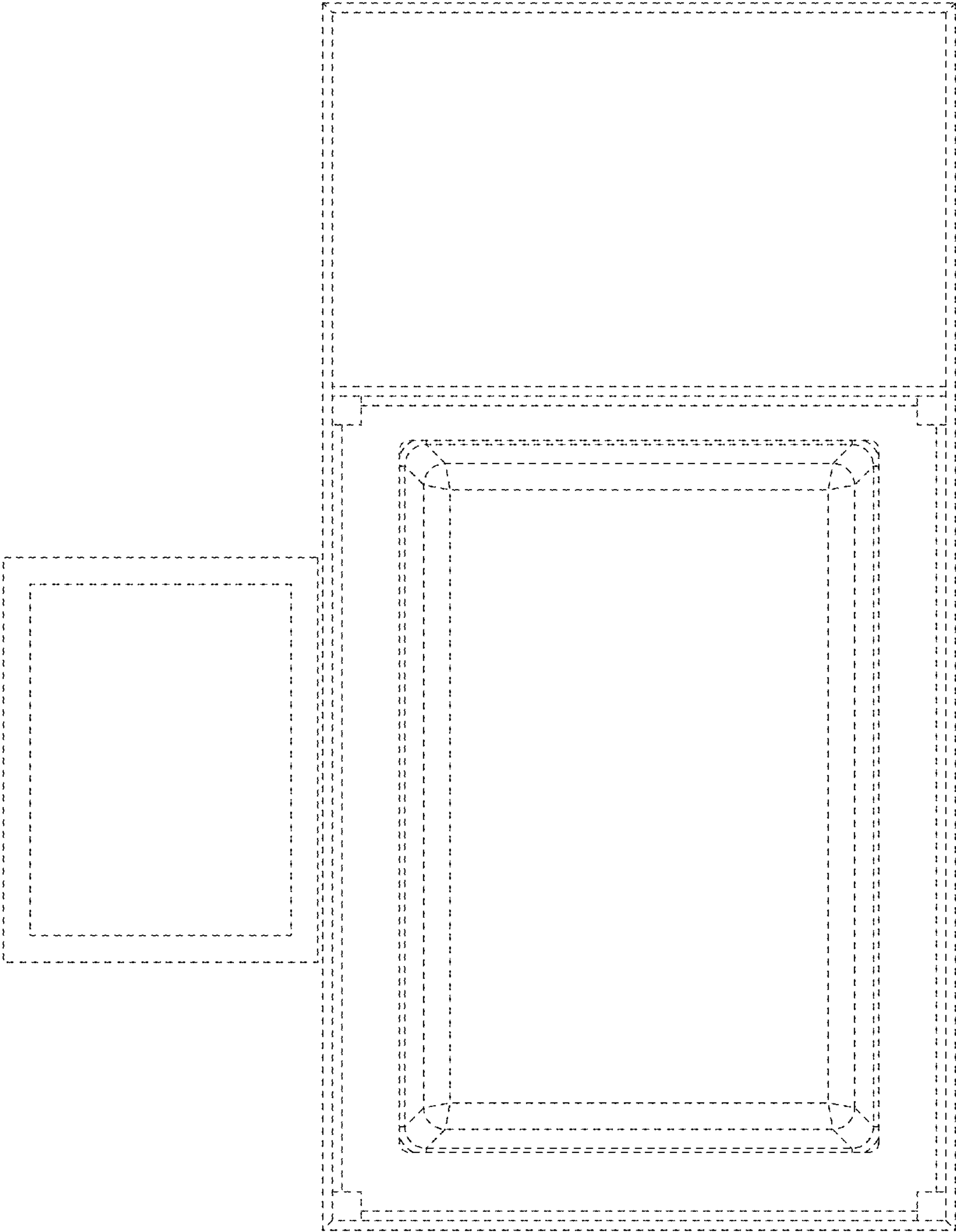

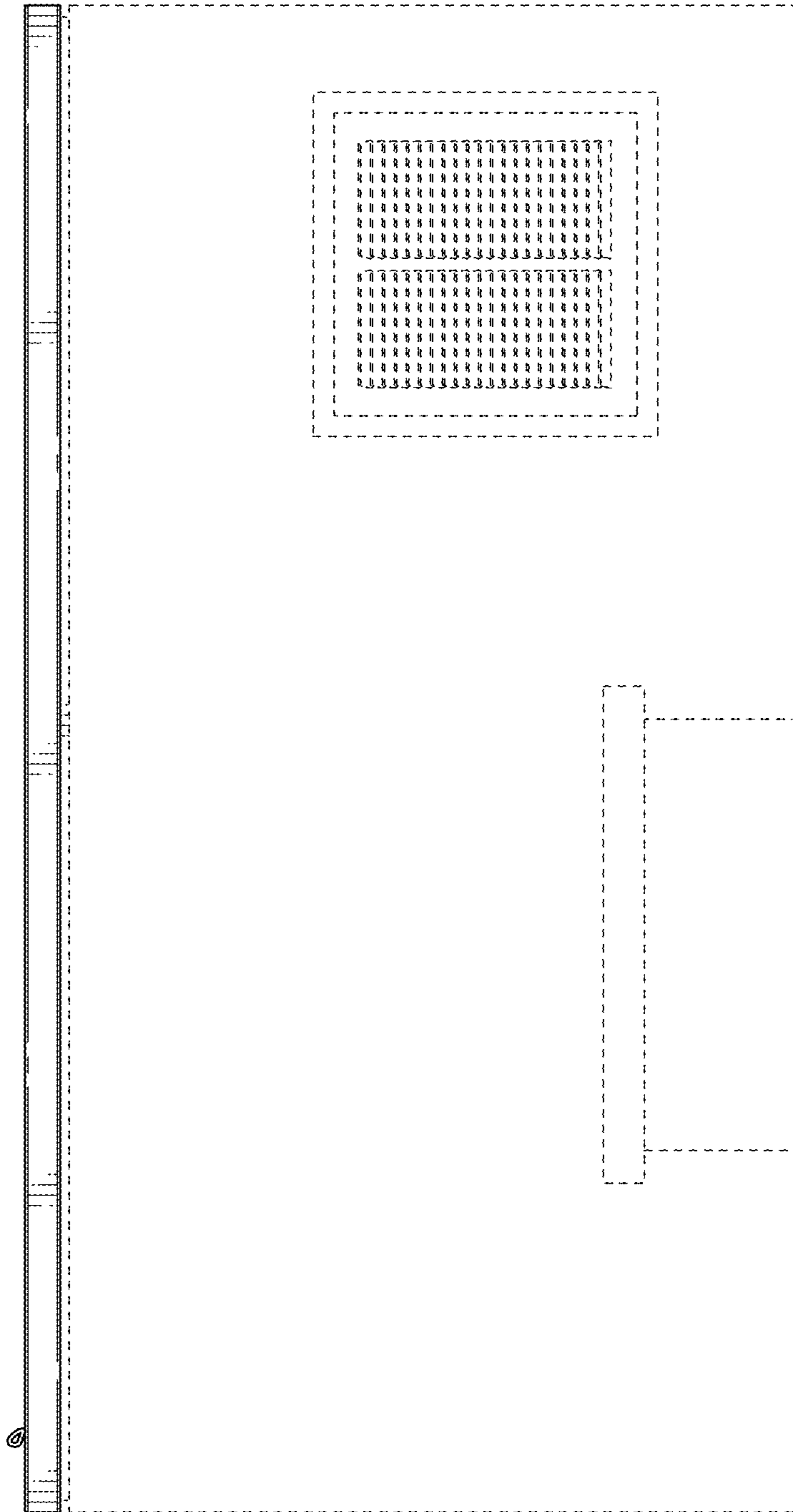

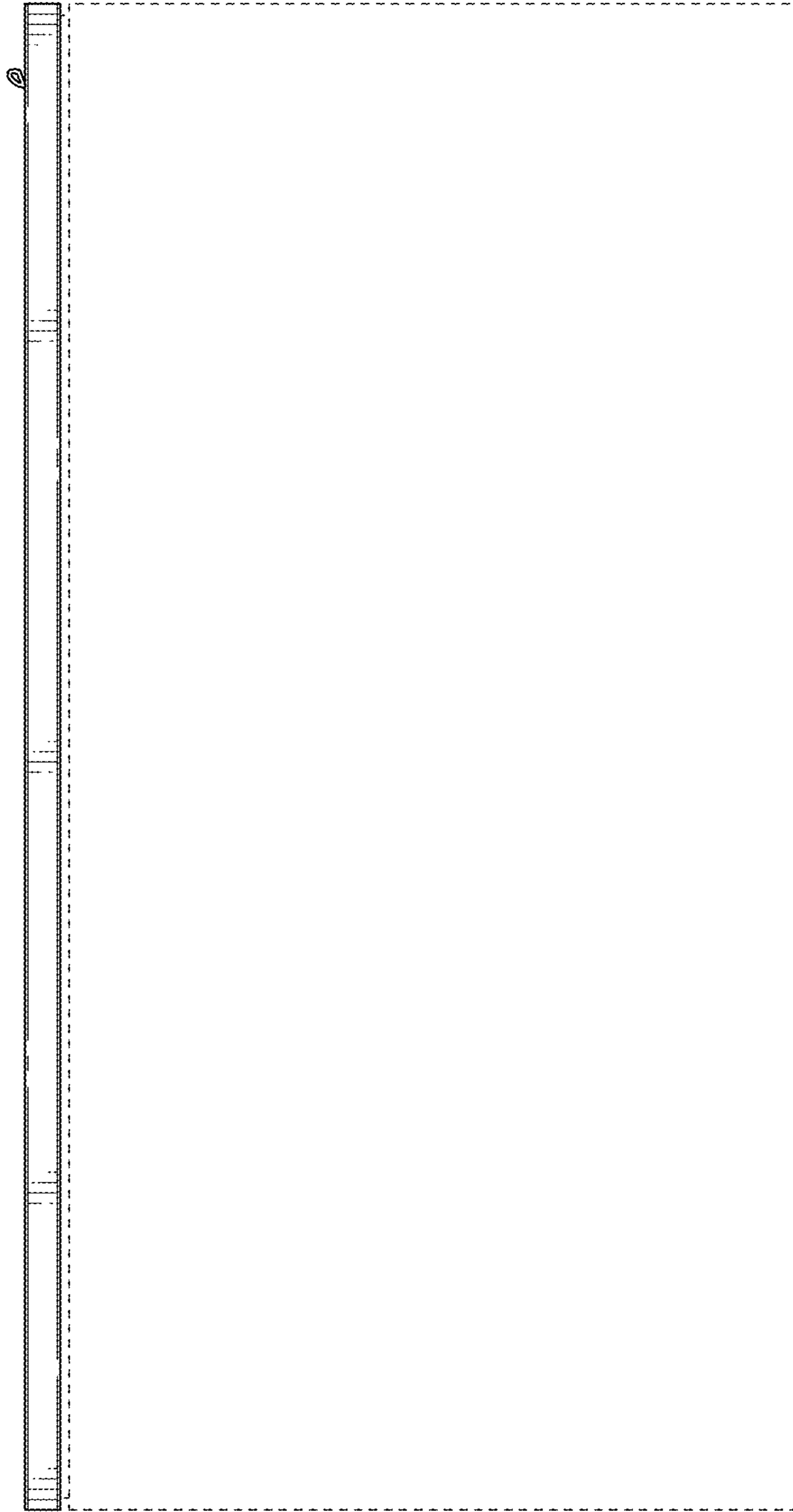

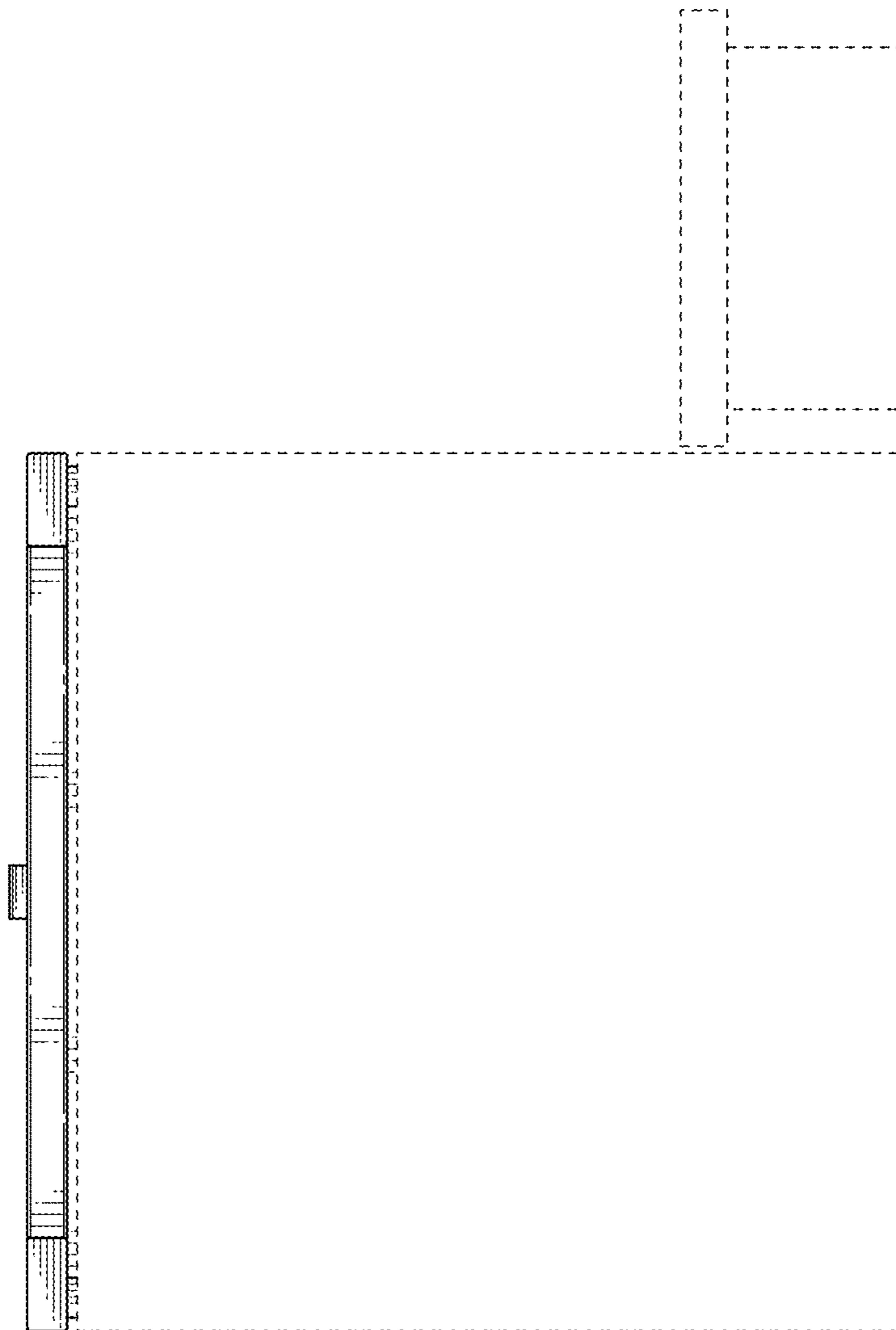

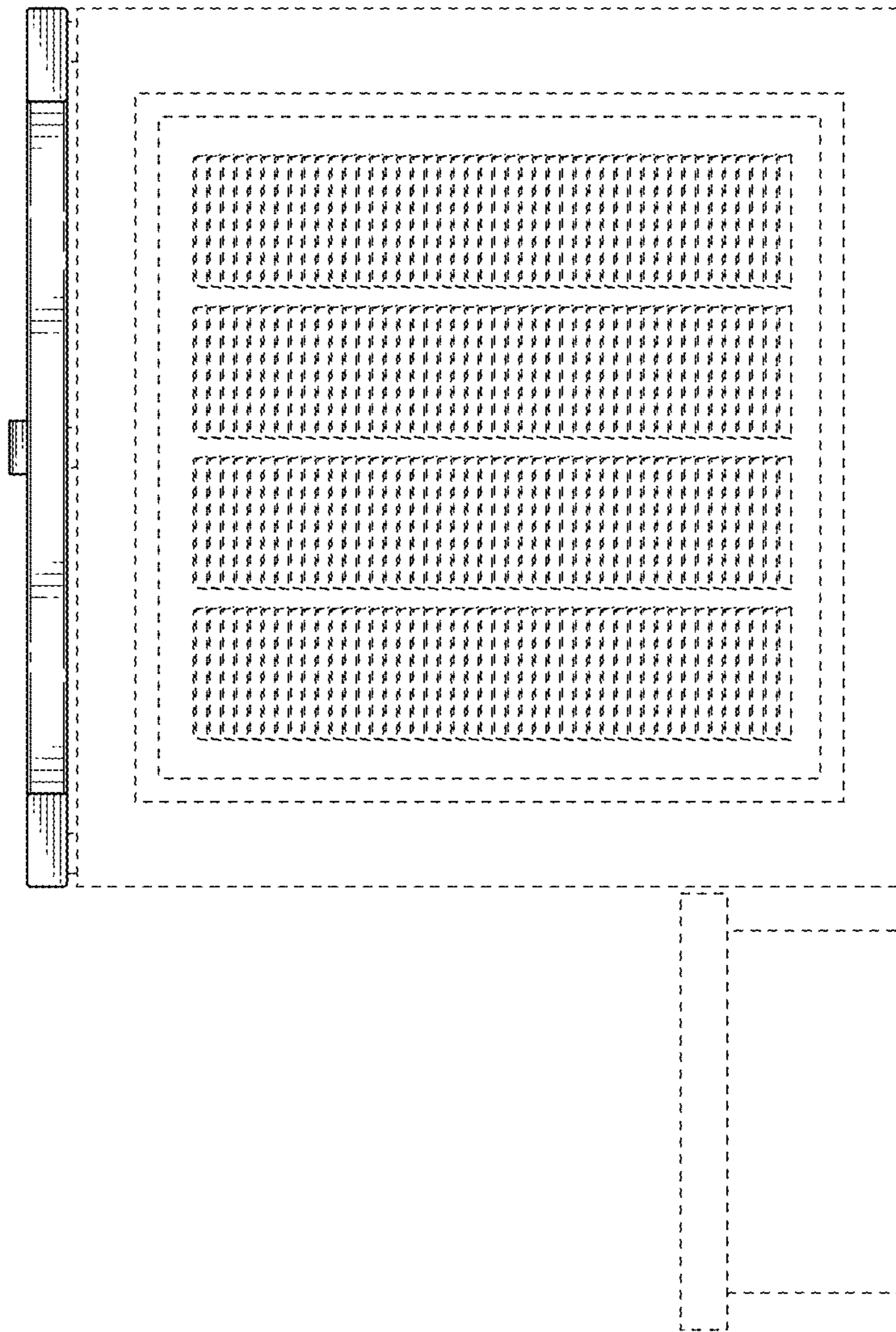
