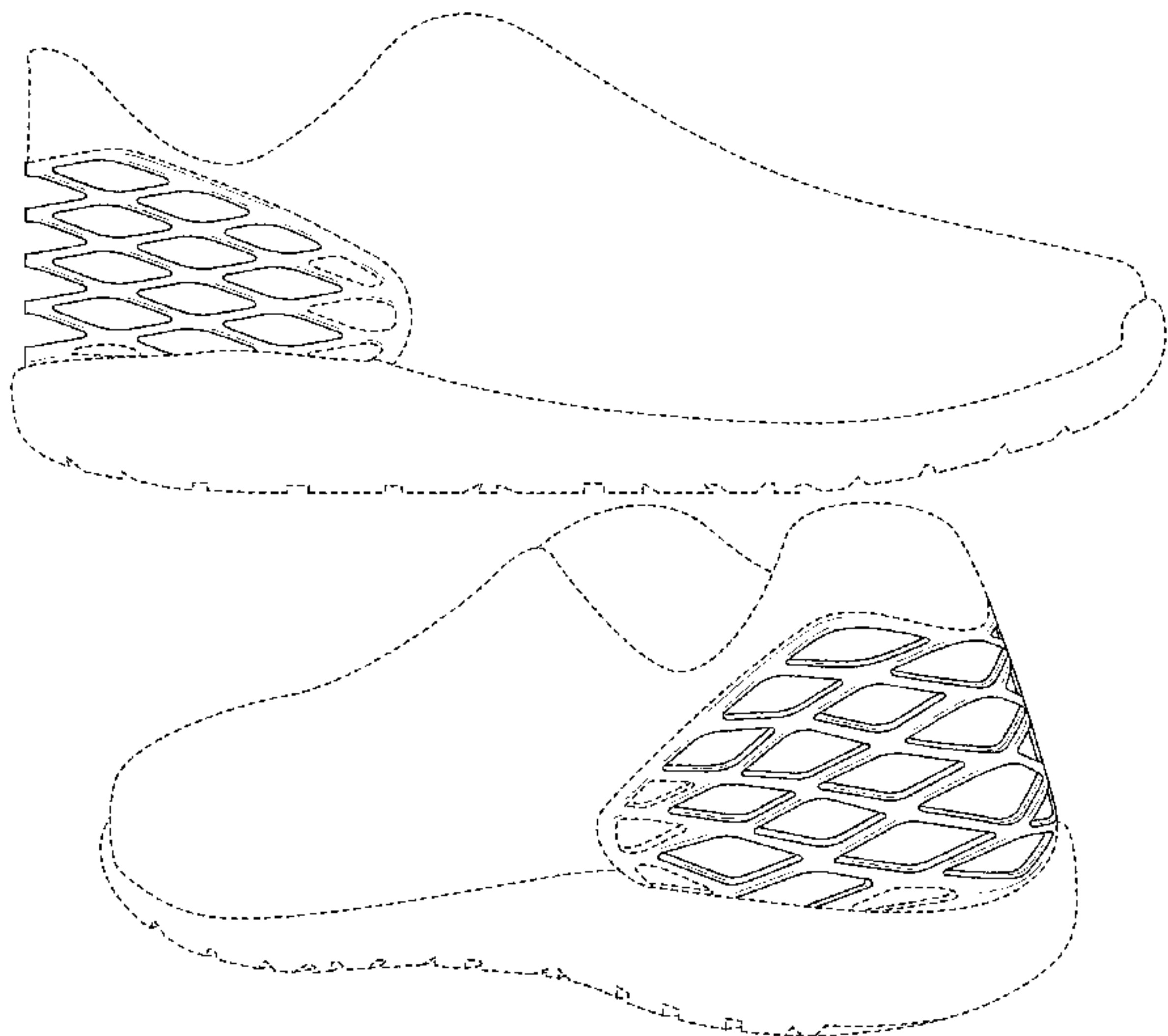
(57) CLAIM

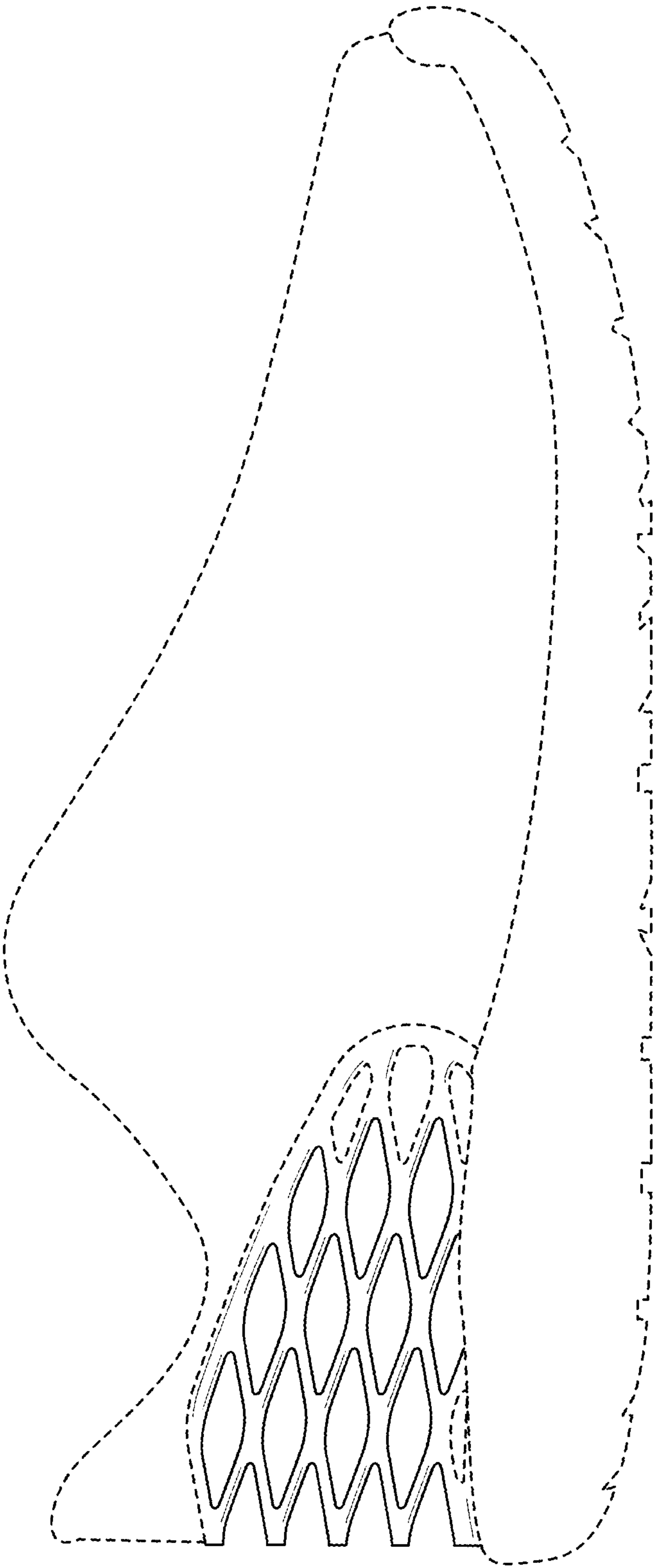

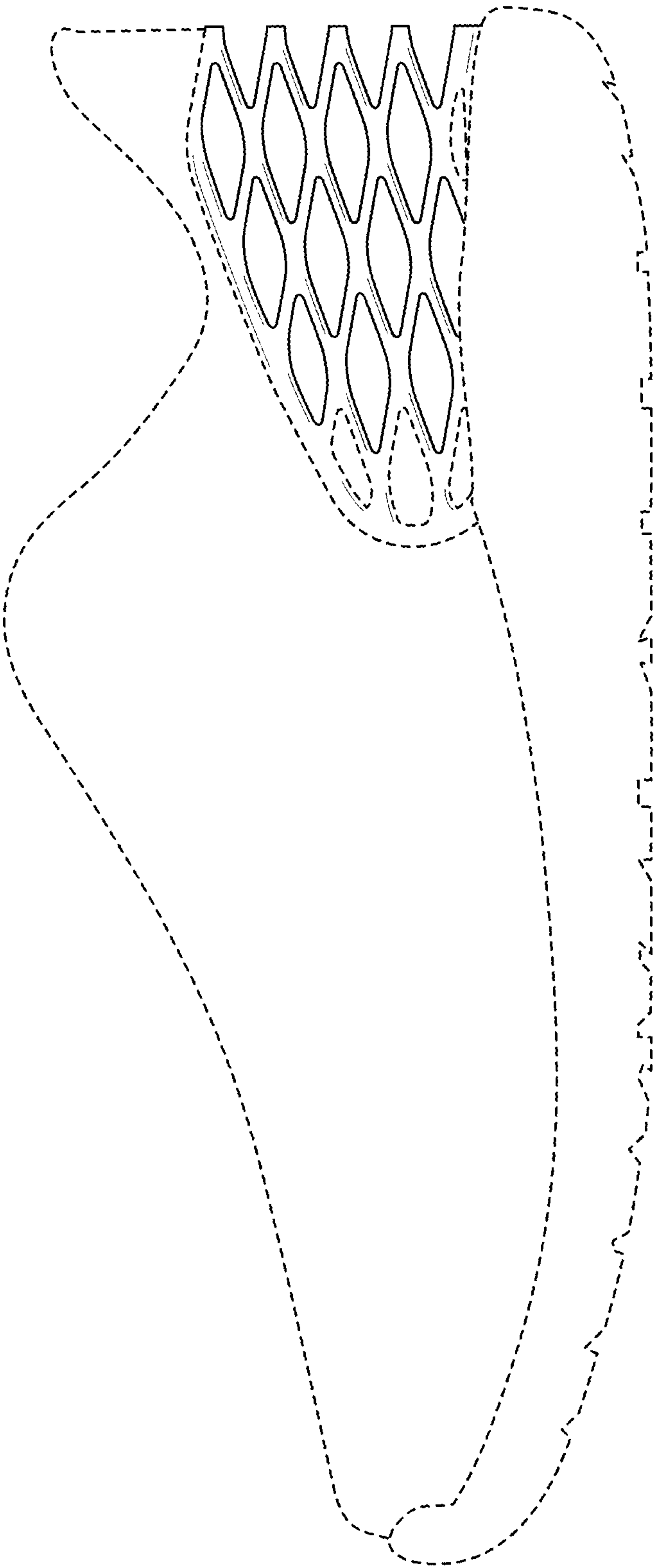

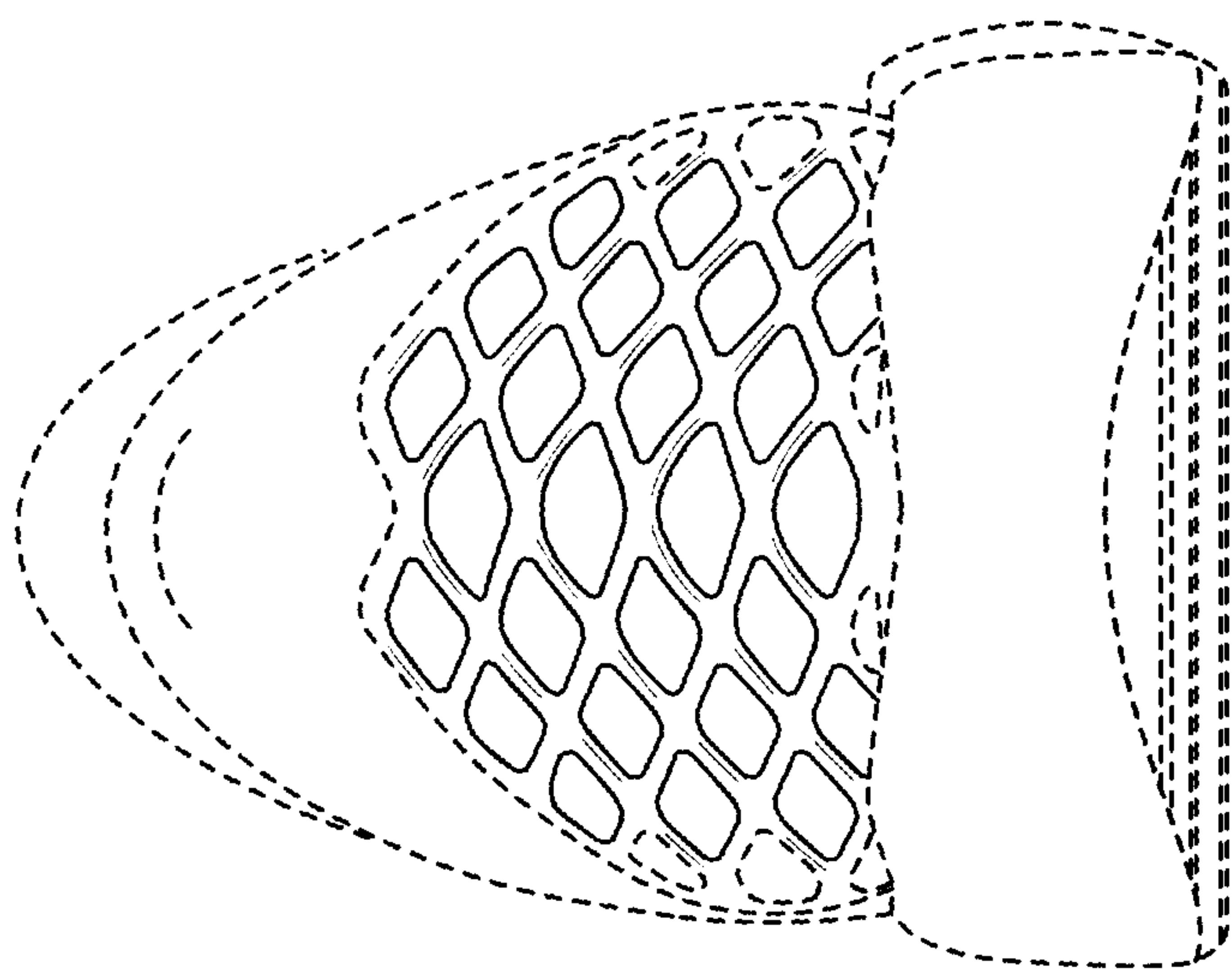

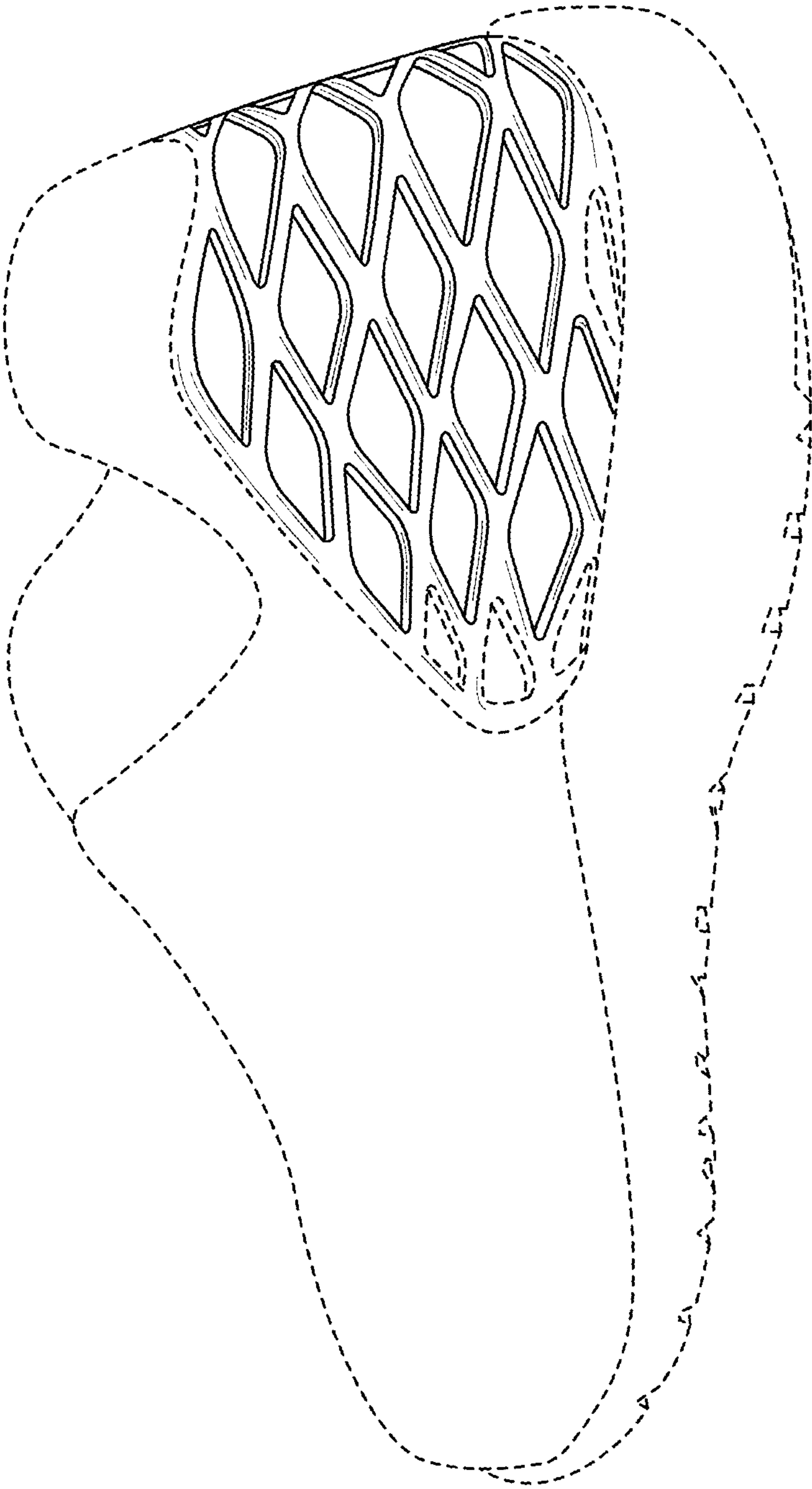
