(57) CLAIM

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;


FIG. 2 is a side view thereof;

FIG. 3 is a rear perspective view thereof; and,

FIG. 4 is a rear view thereof.

The two circular broken lines within the shaded area represent eyelets that form no part of the claimed design. The two half-pill shaped broken lines within the shaded area form no part of the claimed design. The broken lines immediately adjacent to the rear of the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.






