CLAIM

The ornamental design for a hot pot, as shown and described.

DESCRIPTION

FIG. 1 is a front, left and top perspective view of a hot pot, showing our design.

FIG. 2 is a rear, left and bottom perspective view thereof.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a left side elevation view thereof.

FIG. 6 is a right side elevation view thereof.

FIG. 7 is a top plan view thereof.

FIG. 8 is a bottom plan view thereof.

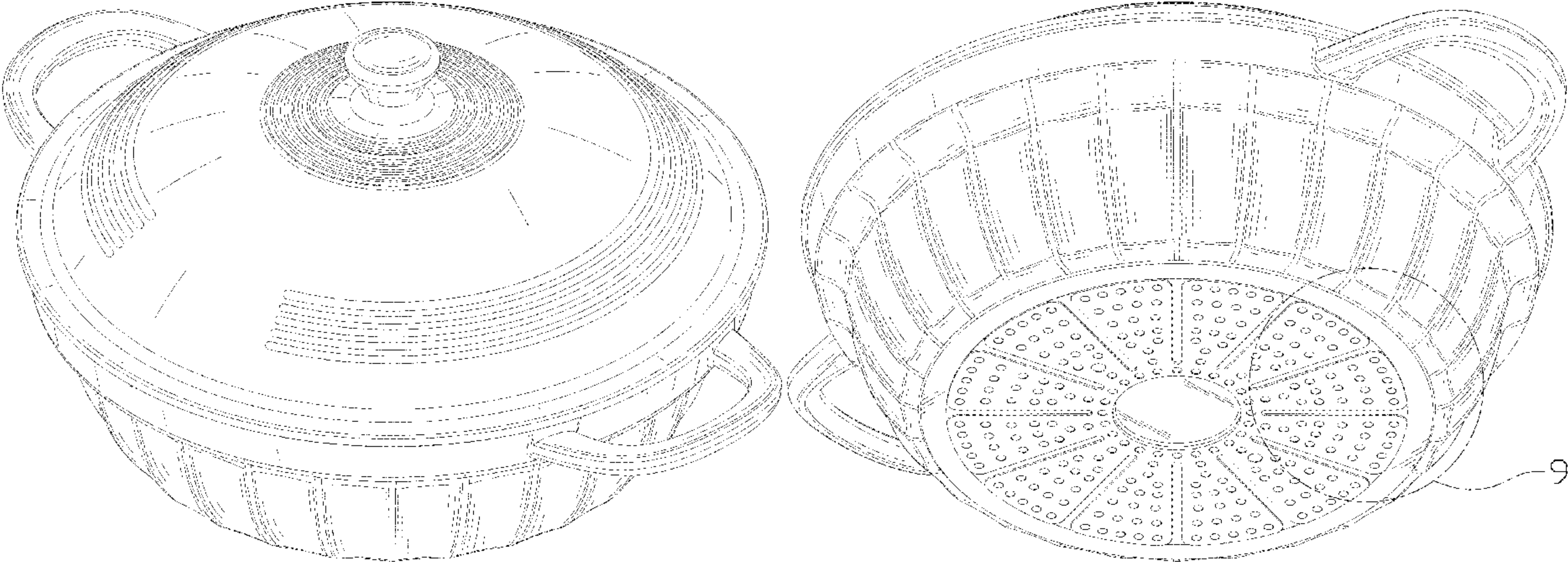
FIG. 9 is an enlarged view of detail 9 in FIG. 2; and,

FIG. 10 is a cross-sectional view of the hot pot of FIG. 1, taken along section line 10-10 as depicted in FIG. 7.

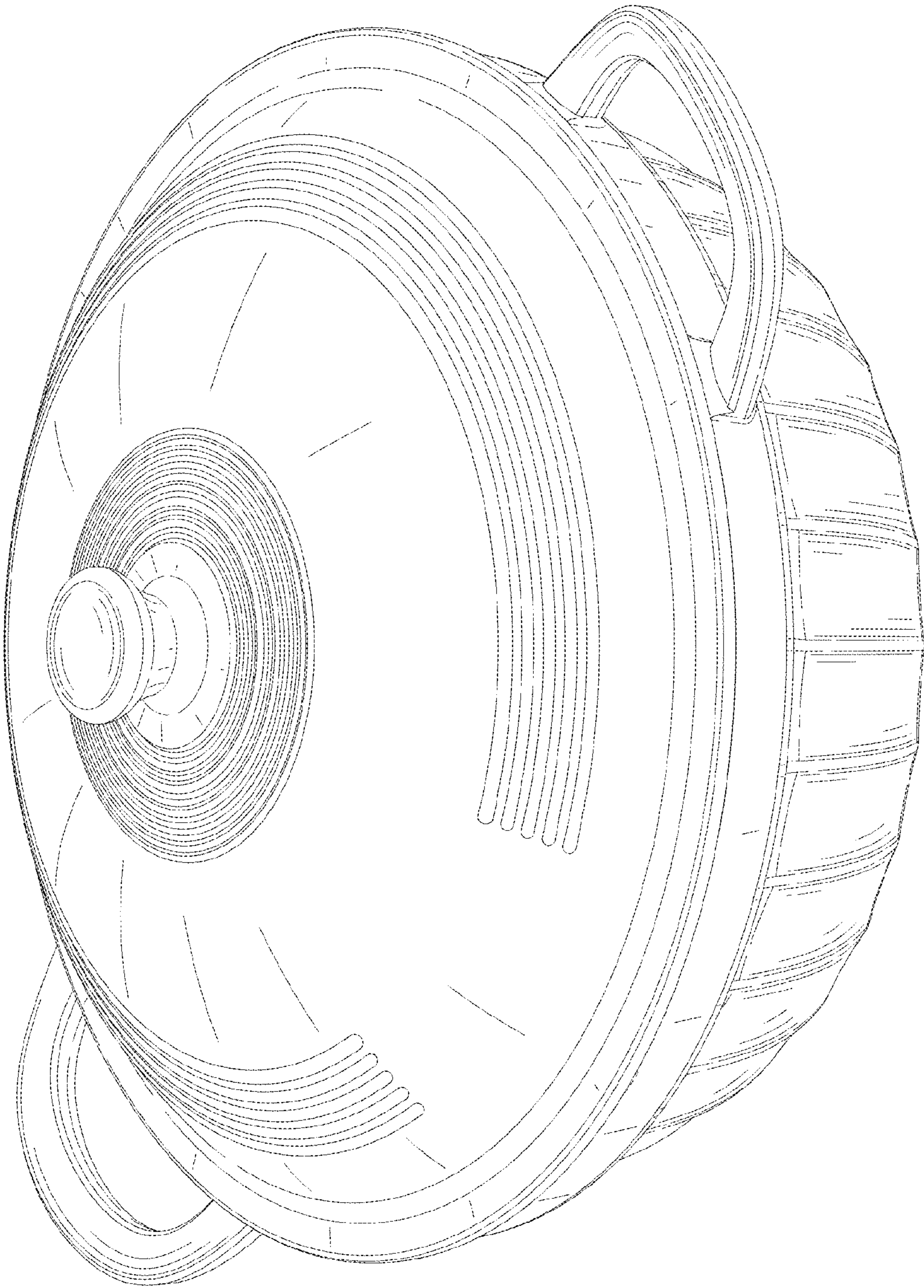

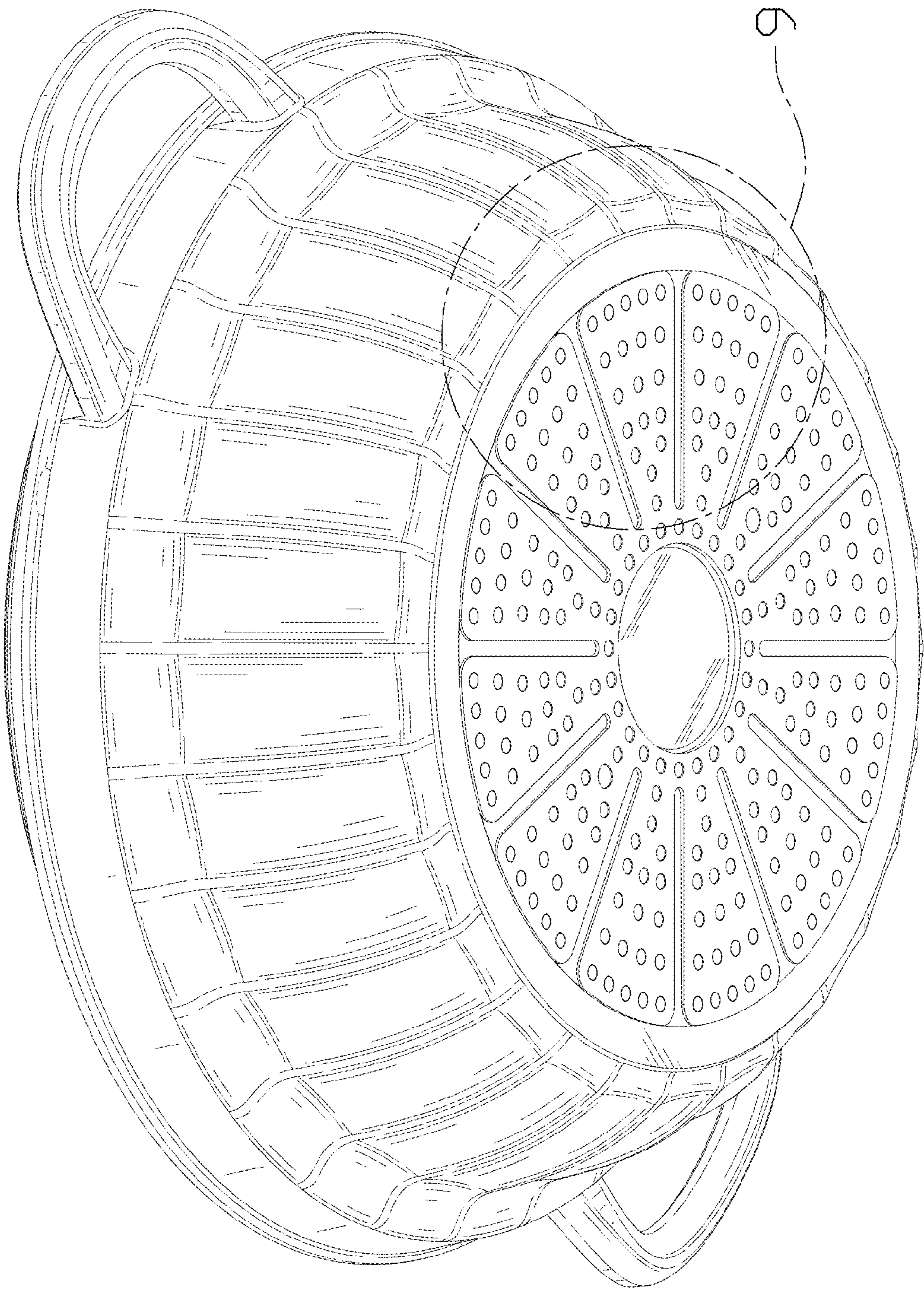

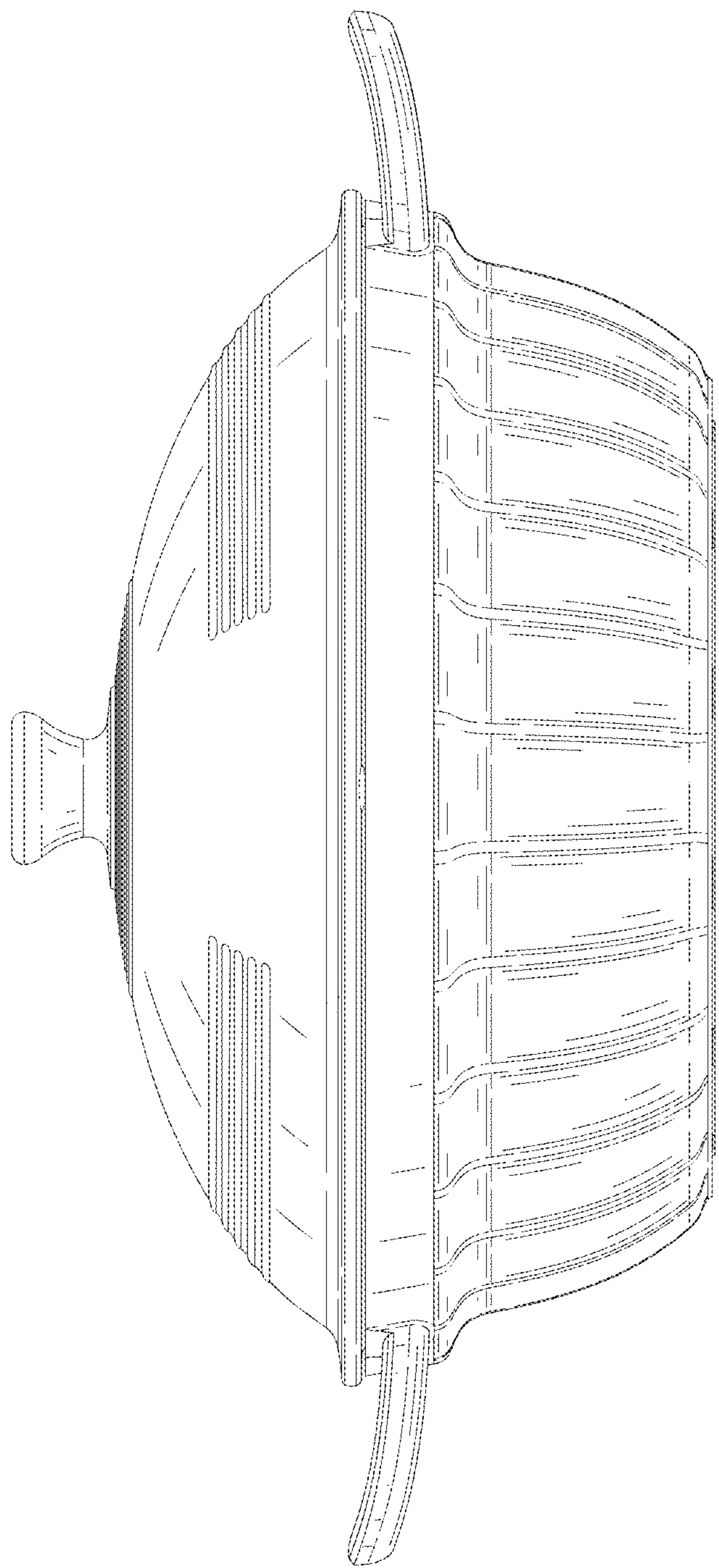

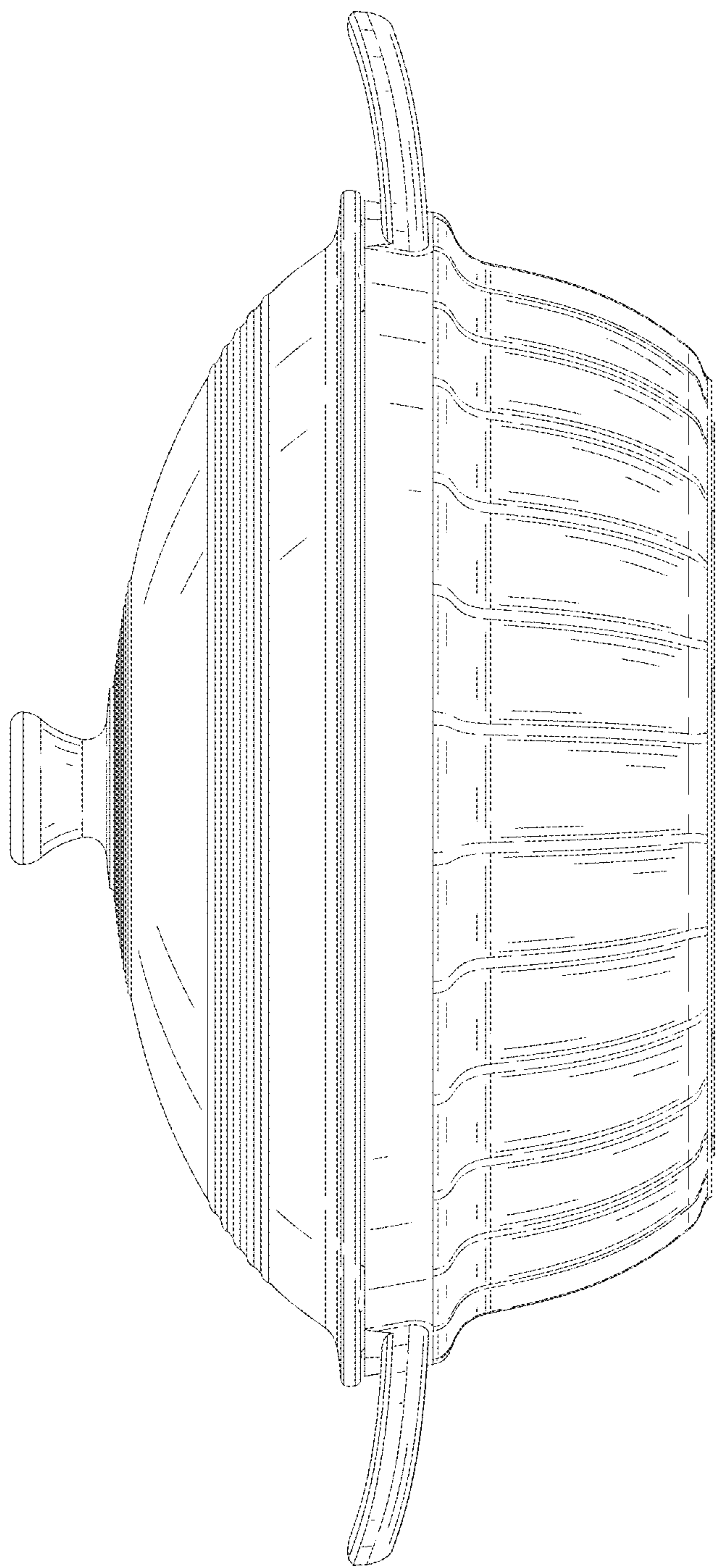

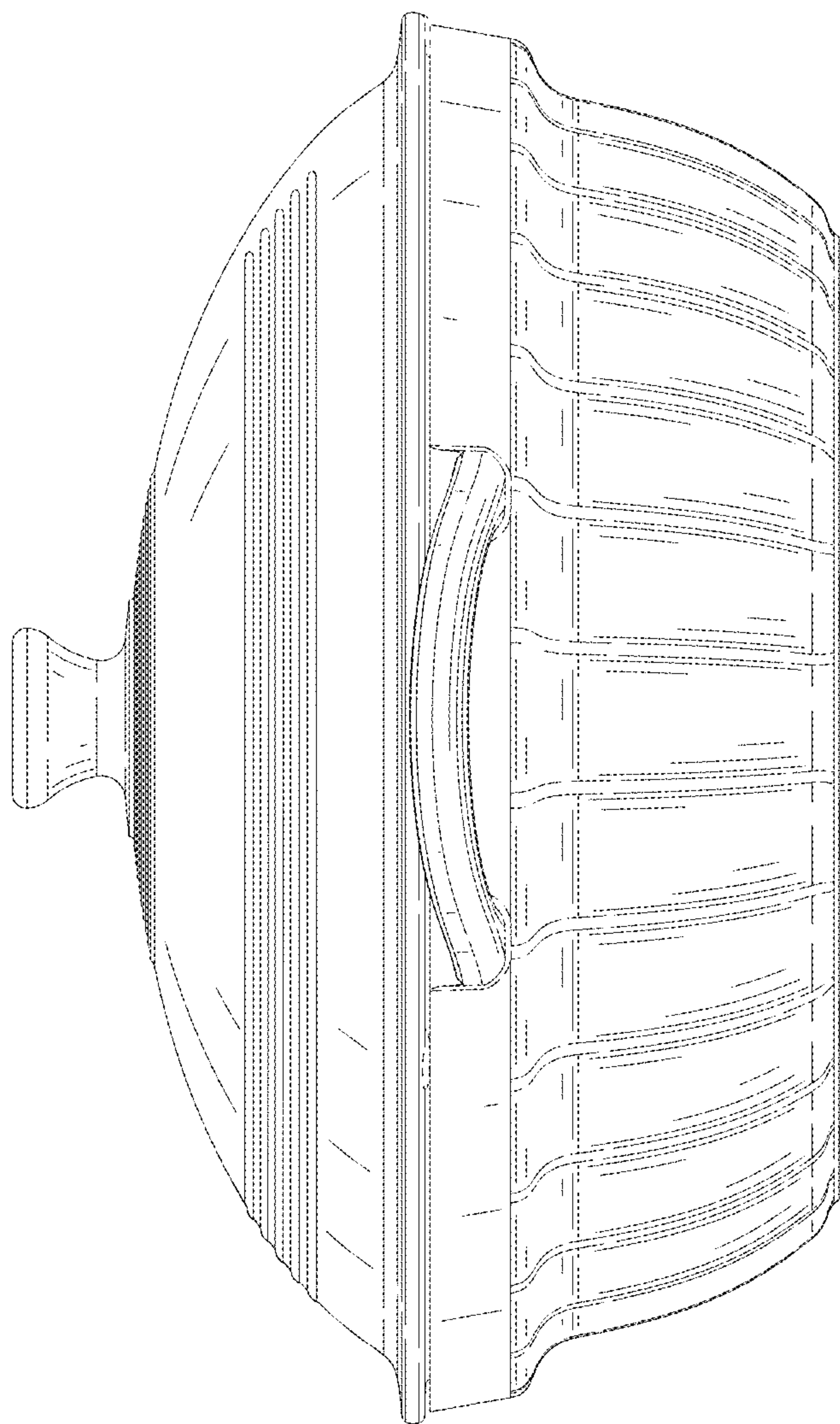

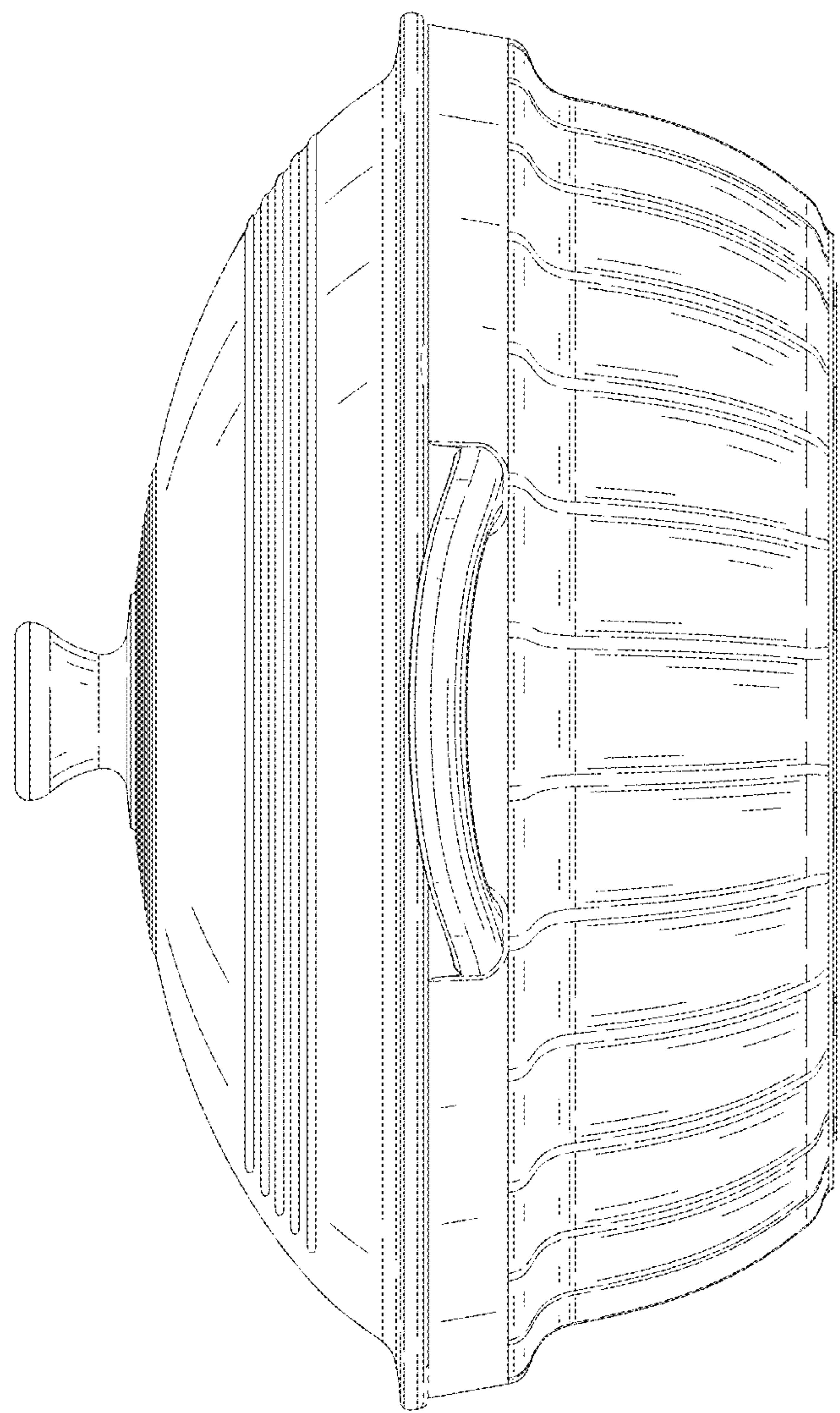

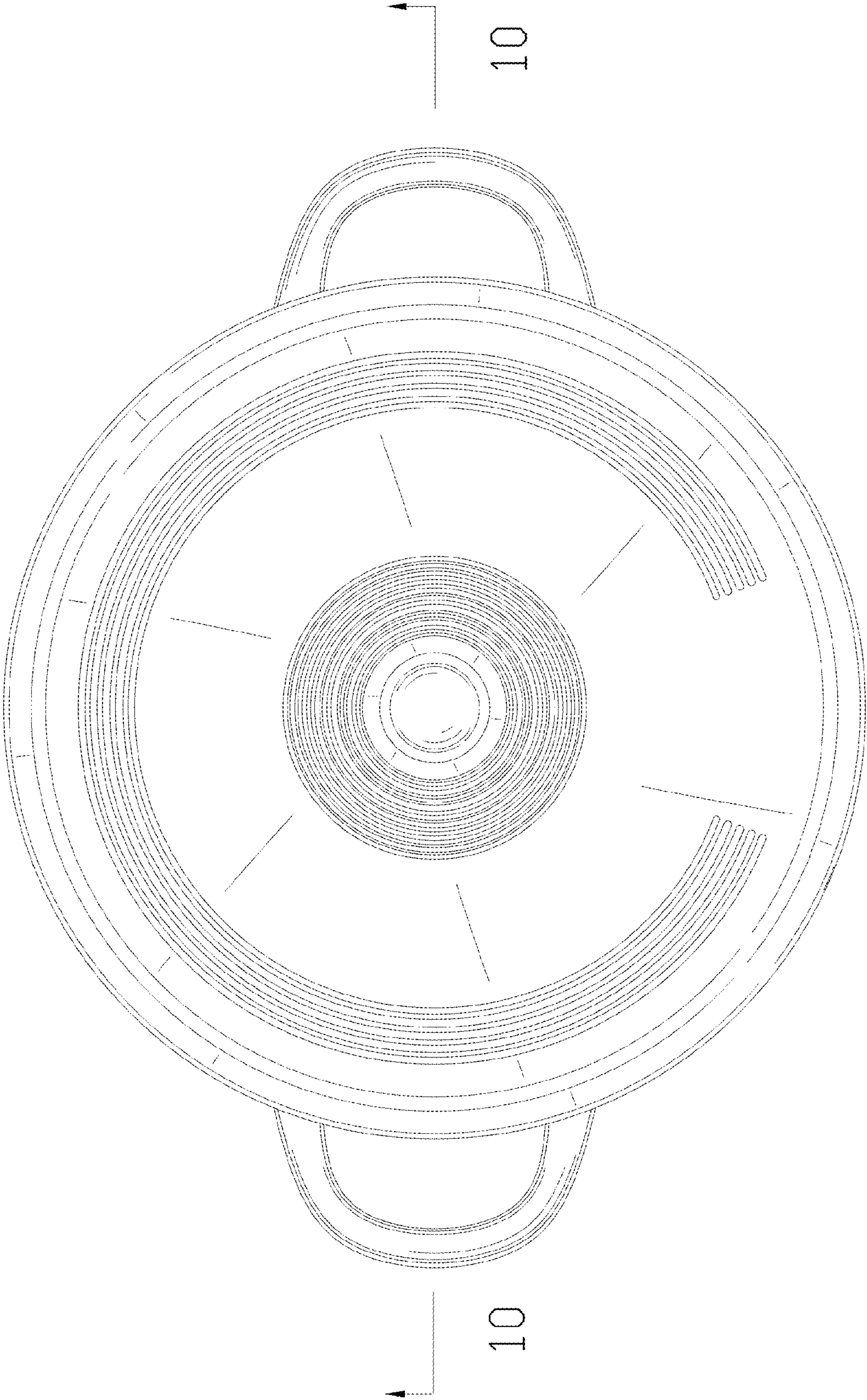

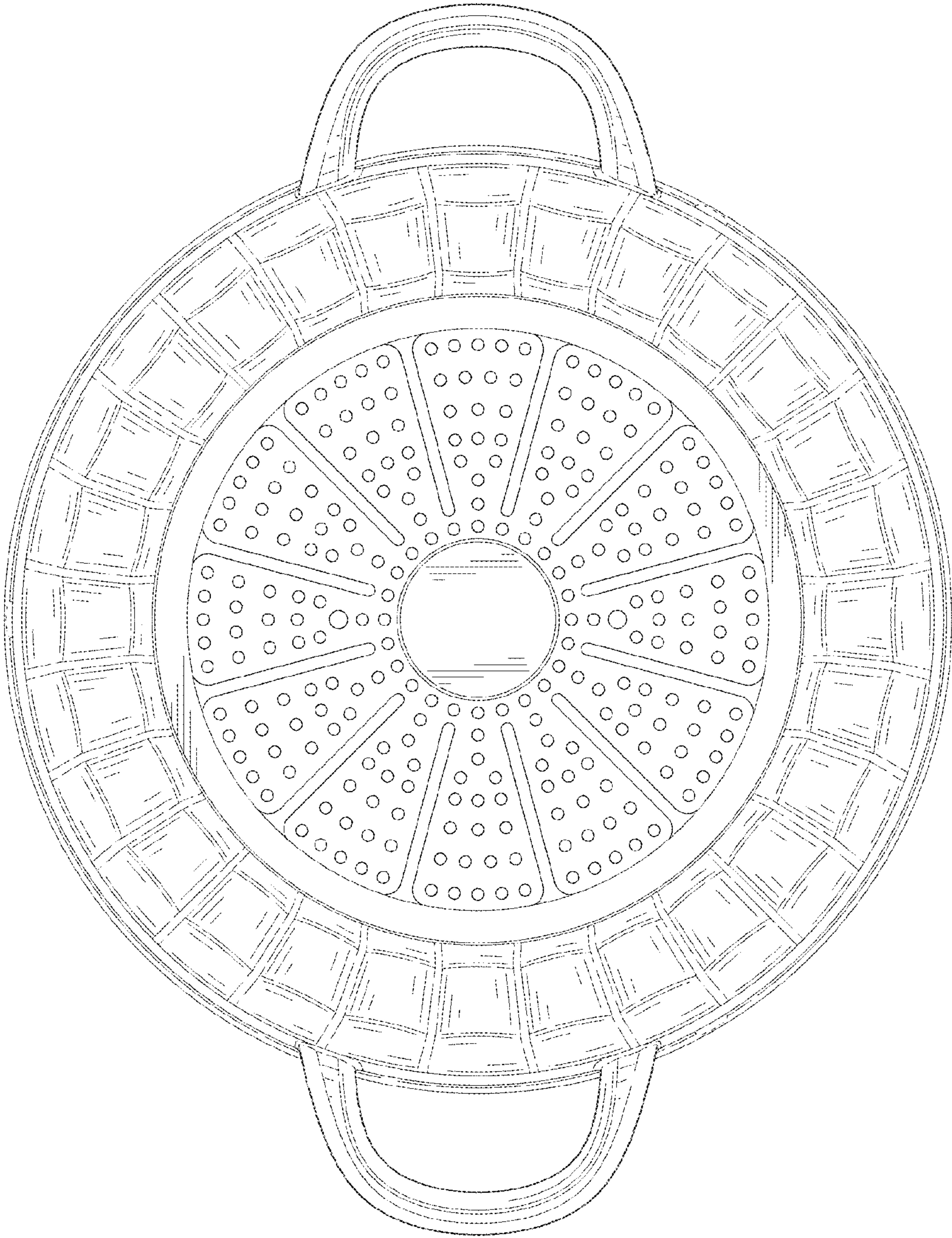

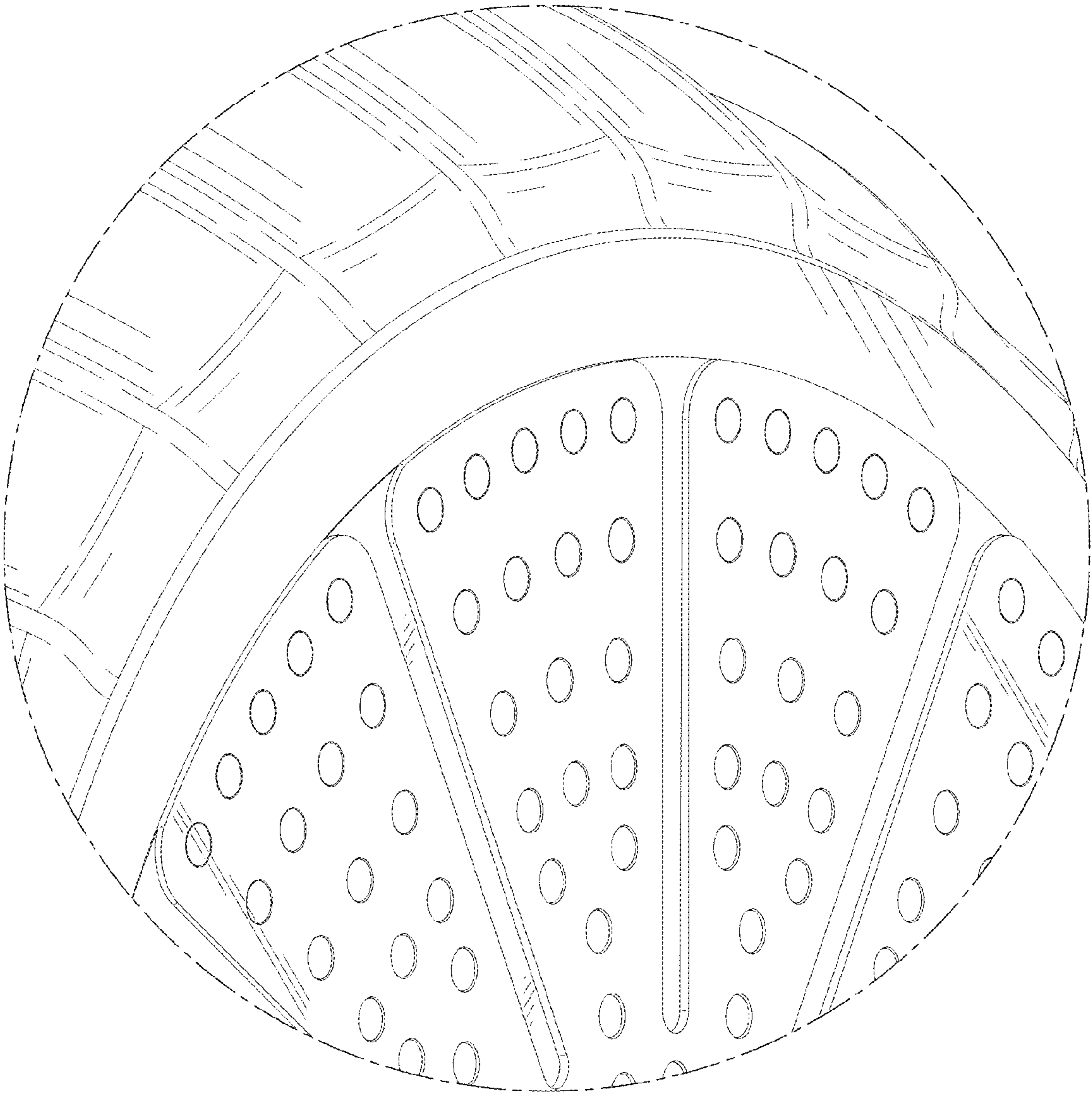

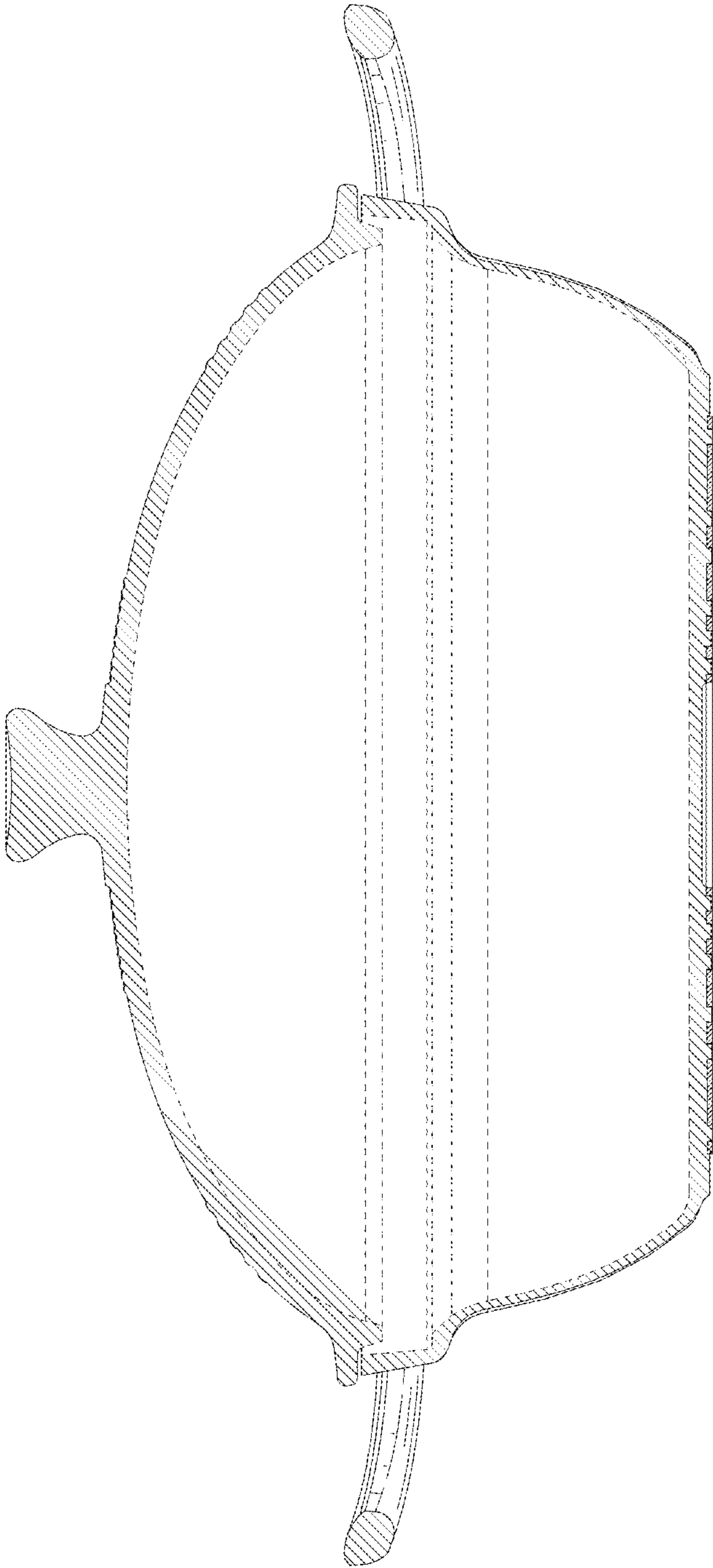
