The ornamental design for a recreational slide, as shown and described.

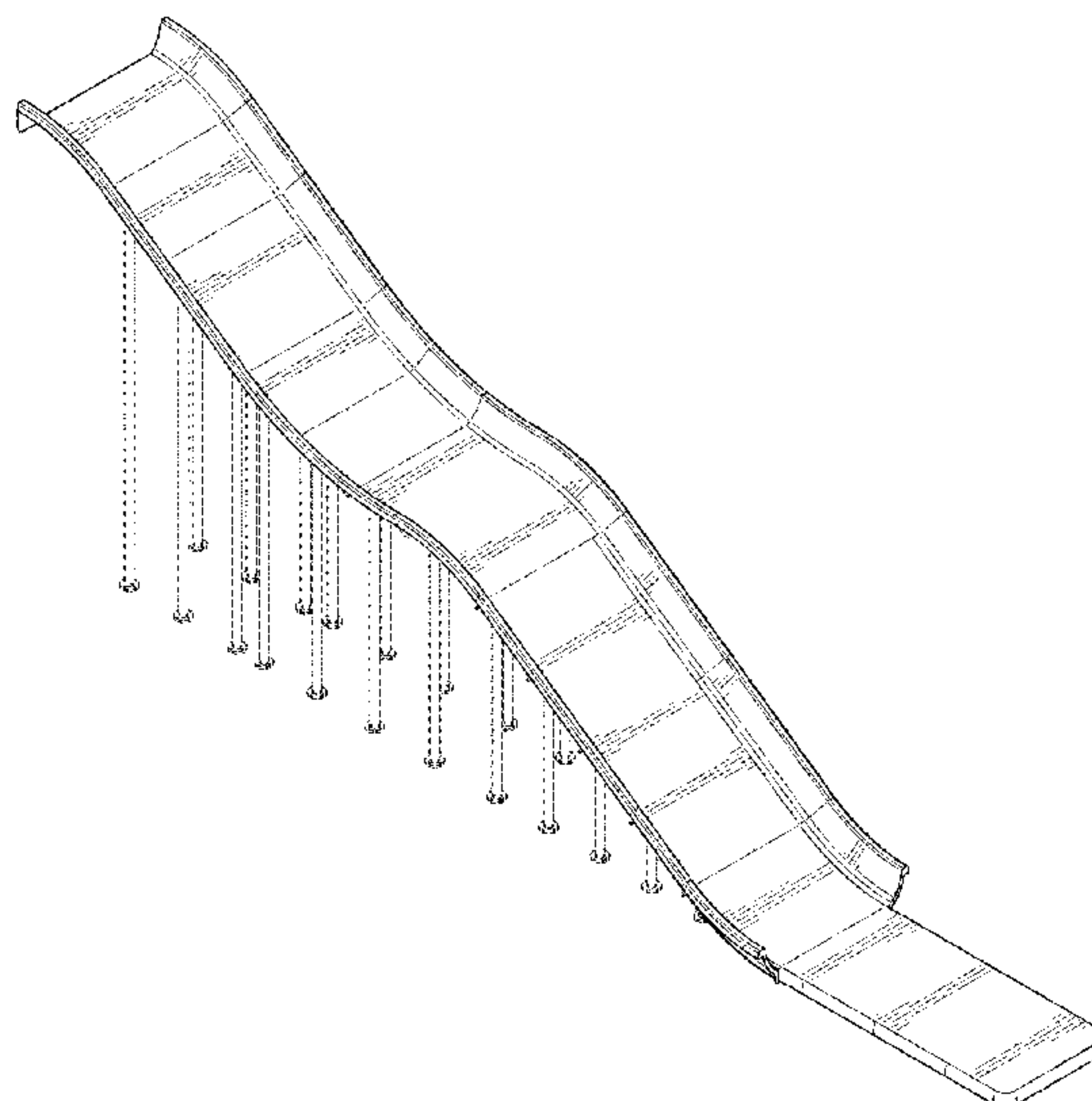
**DESCRIPTION**

FIG. 1 is a front left perspective view of a recreational slide showing my new design;  
FIG. 2 is a left side view of the recreational slide of FIG. 1, the right side view being a mirror image thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a longitudinal cross-sectional view taken along line 7-7 of FIG. 3;  
FIG. 8 is a front left perspective view of a second embodiment of the recreational slide showing my new design;  
FIG. 9 is a left side view of the recreational slide of FIG. 8, the right side being a mirror image thereof;  
FIG. 10 is a front view of FIG. 8;  
FIG. 11 is a rear view of FIG. 8;  
FIG. 12 is a top view of FIG. 8;  
FIG. 13 is a bottom view of FIG. 8; and,  
FIG. 14 is a longitudinal cross-sectional view taken along line 14-14 of FIG. 10.

The evenly spaced broken lines shown on the drawings form no part of the claimed design. The dash-dot broken lines are included as boundary lines and form no part of the claimed design.

Portions of the claimed design are shown separated and bound by a bracket to indicate indeterminate length or width.

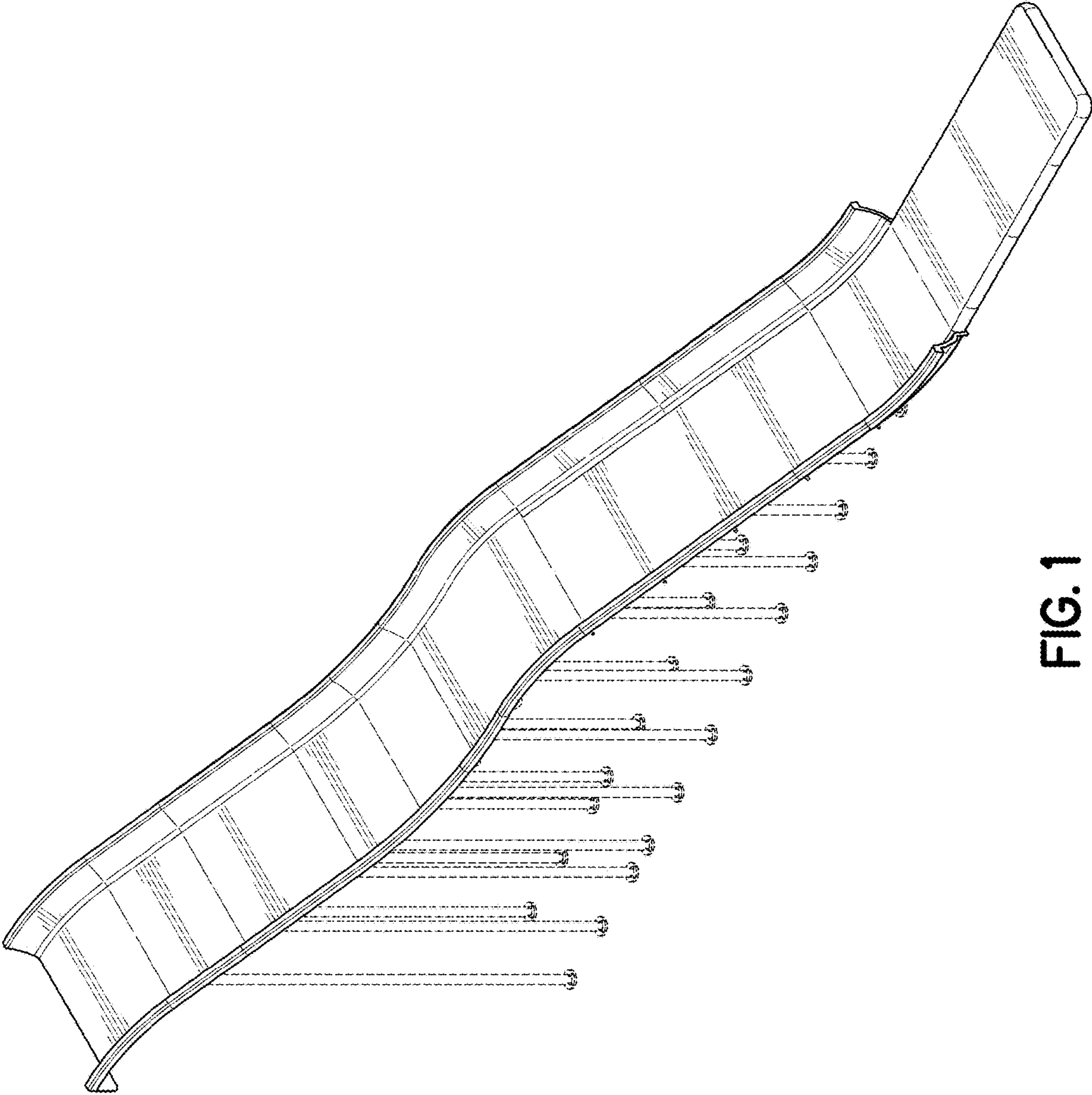

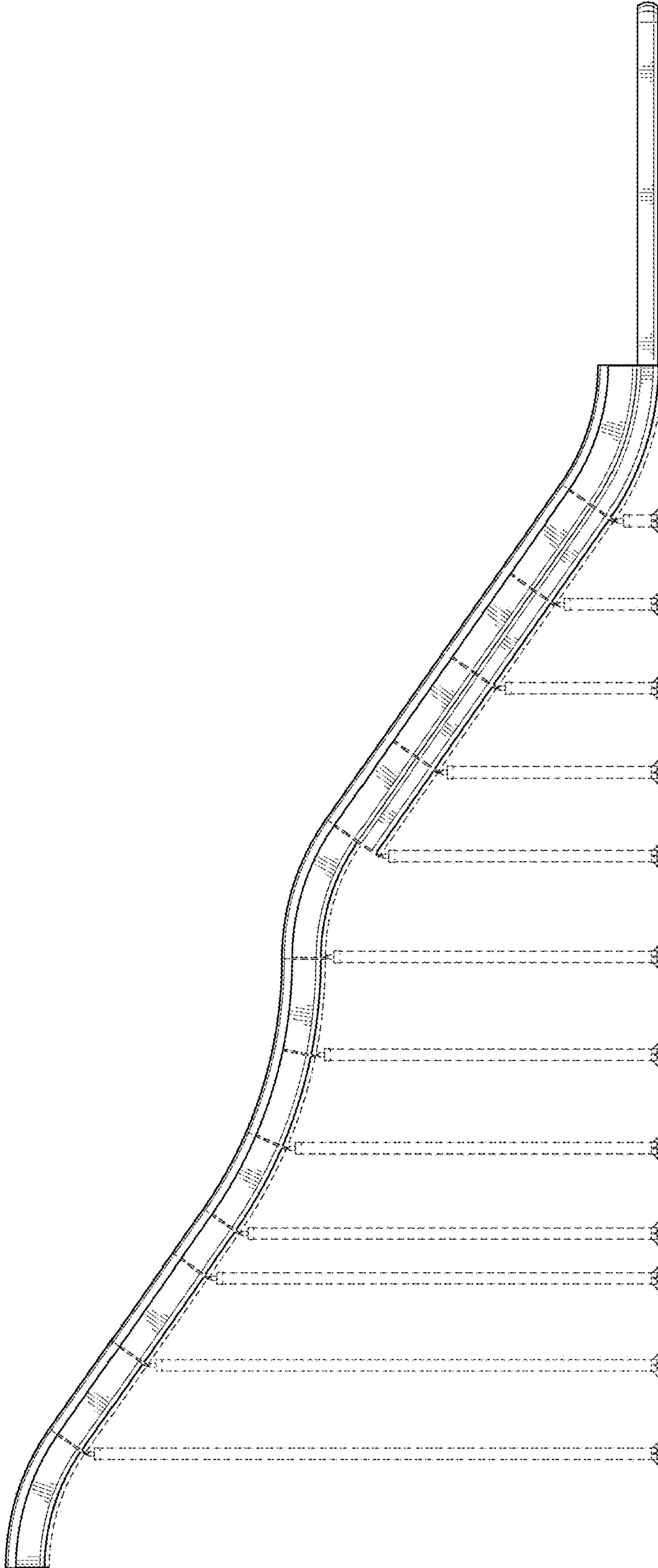

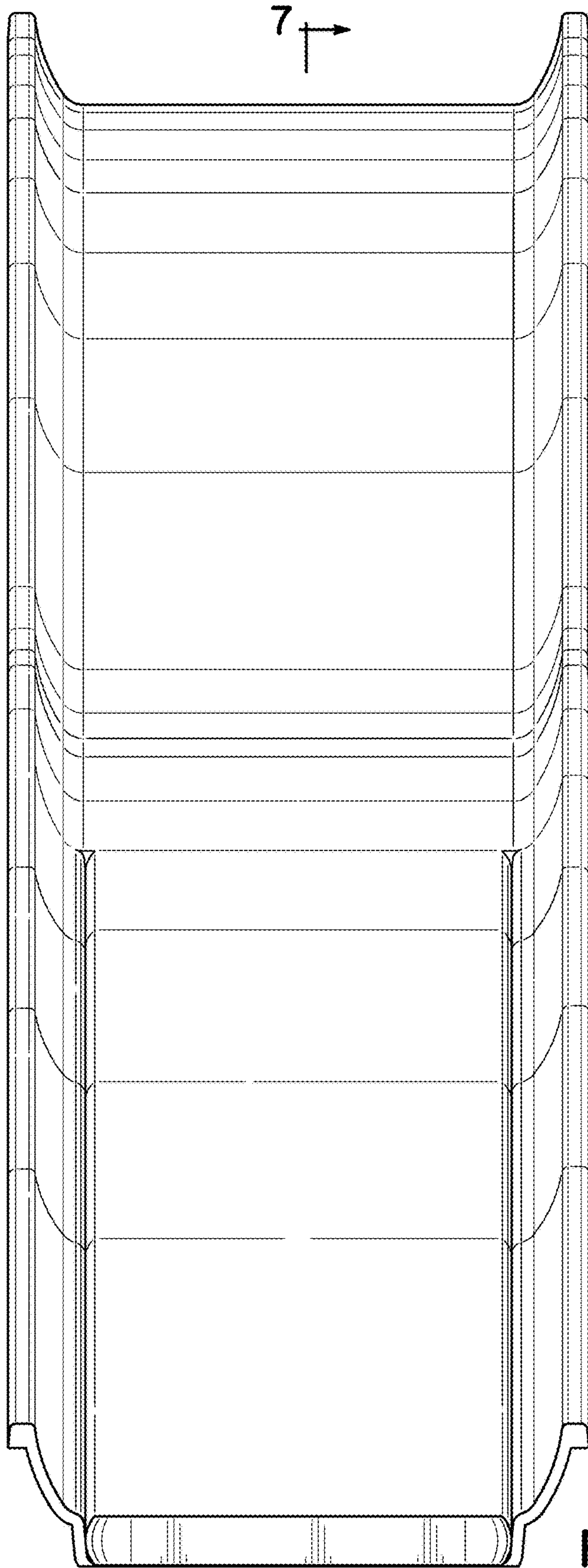

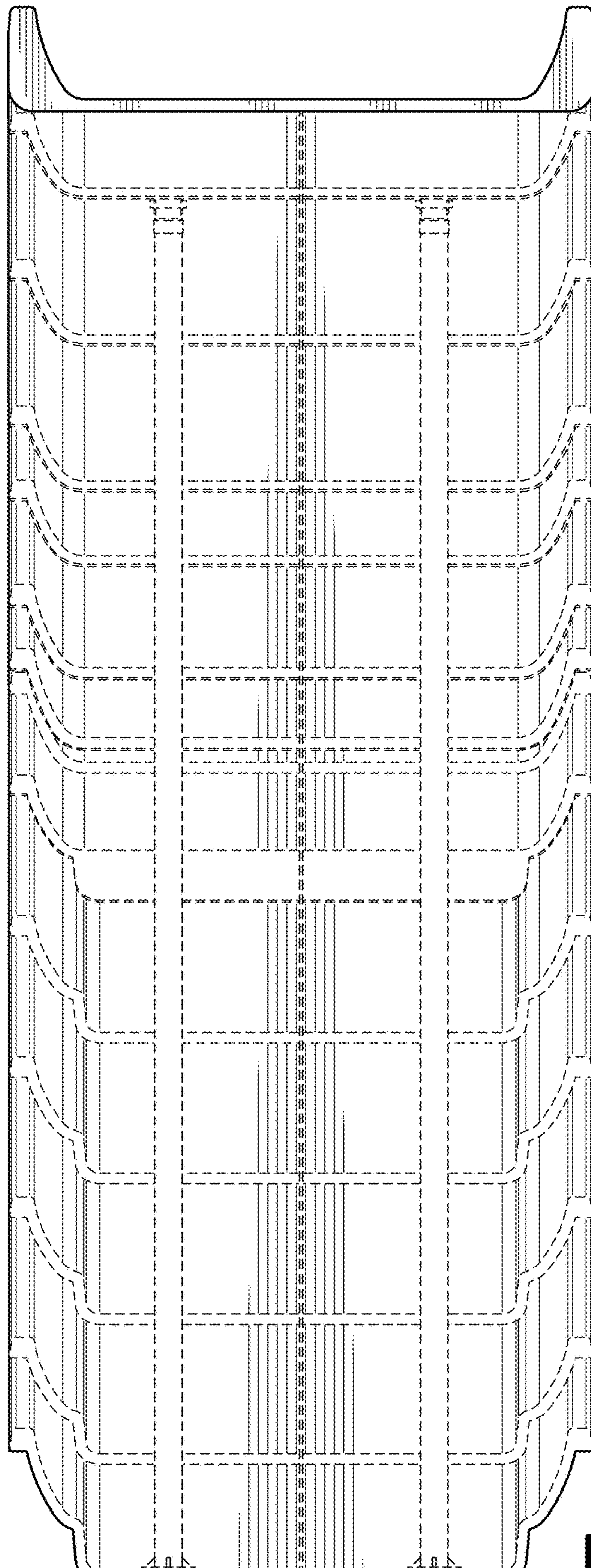

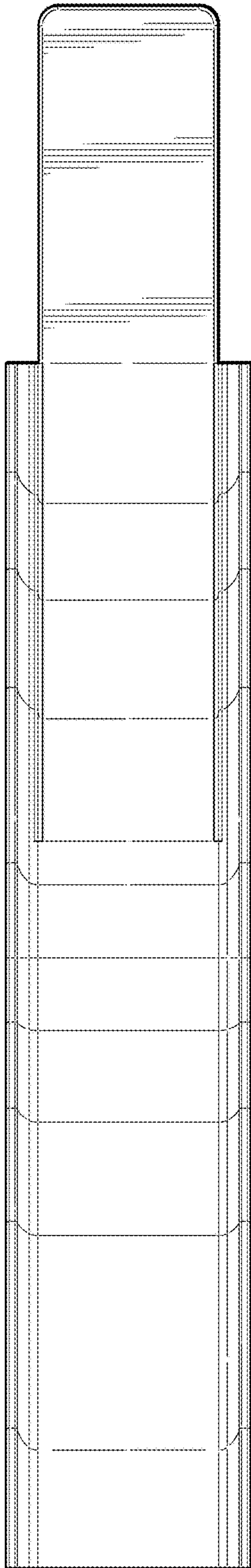

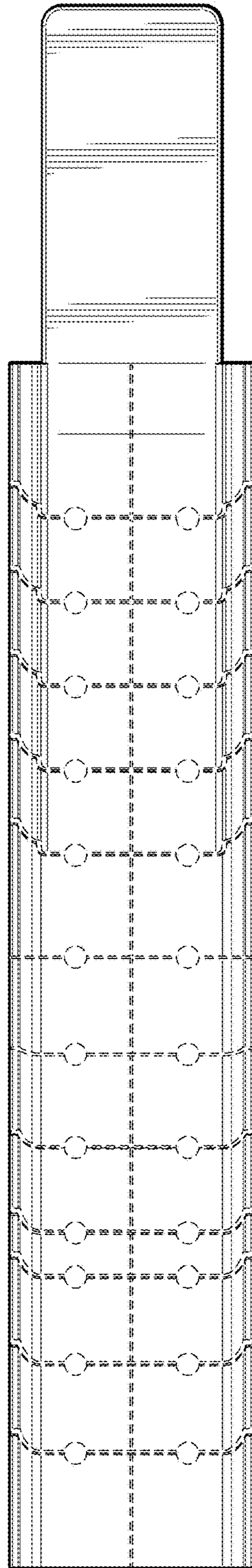

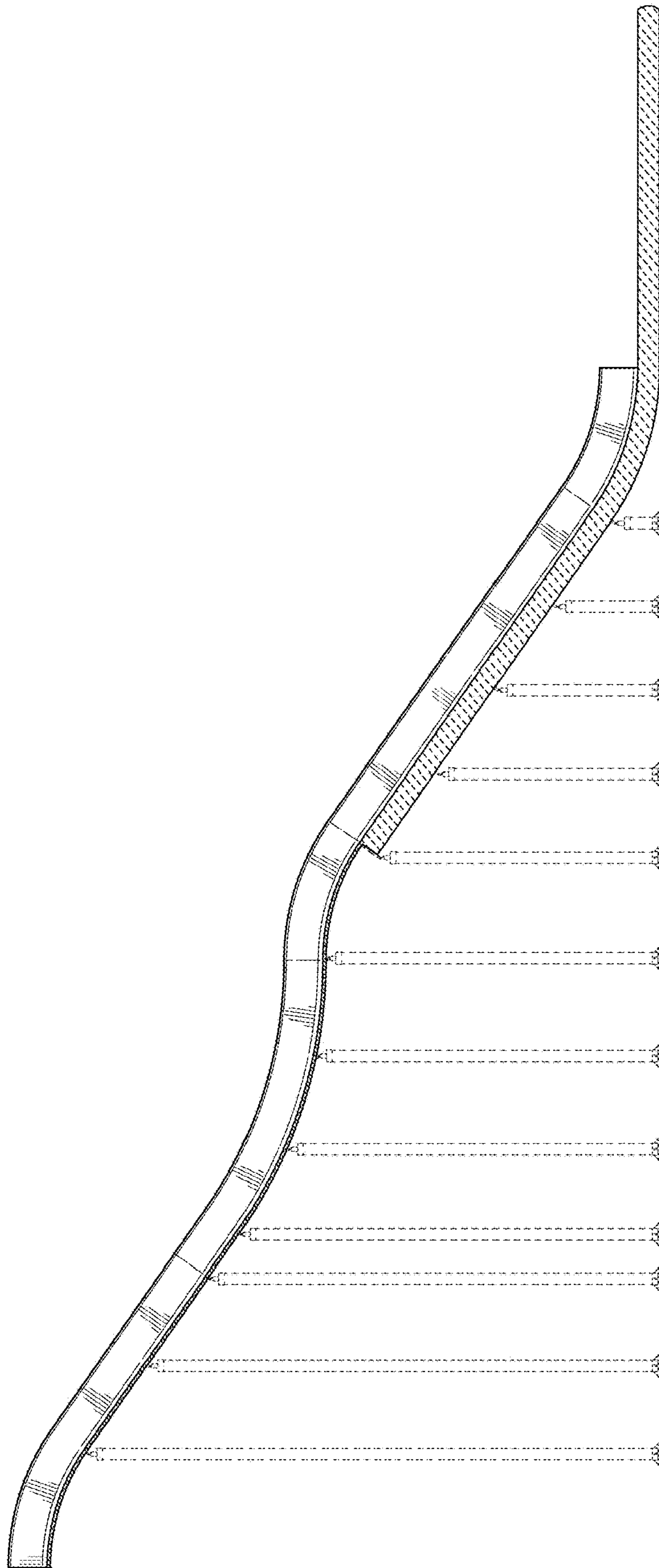

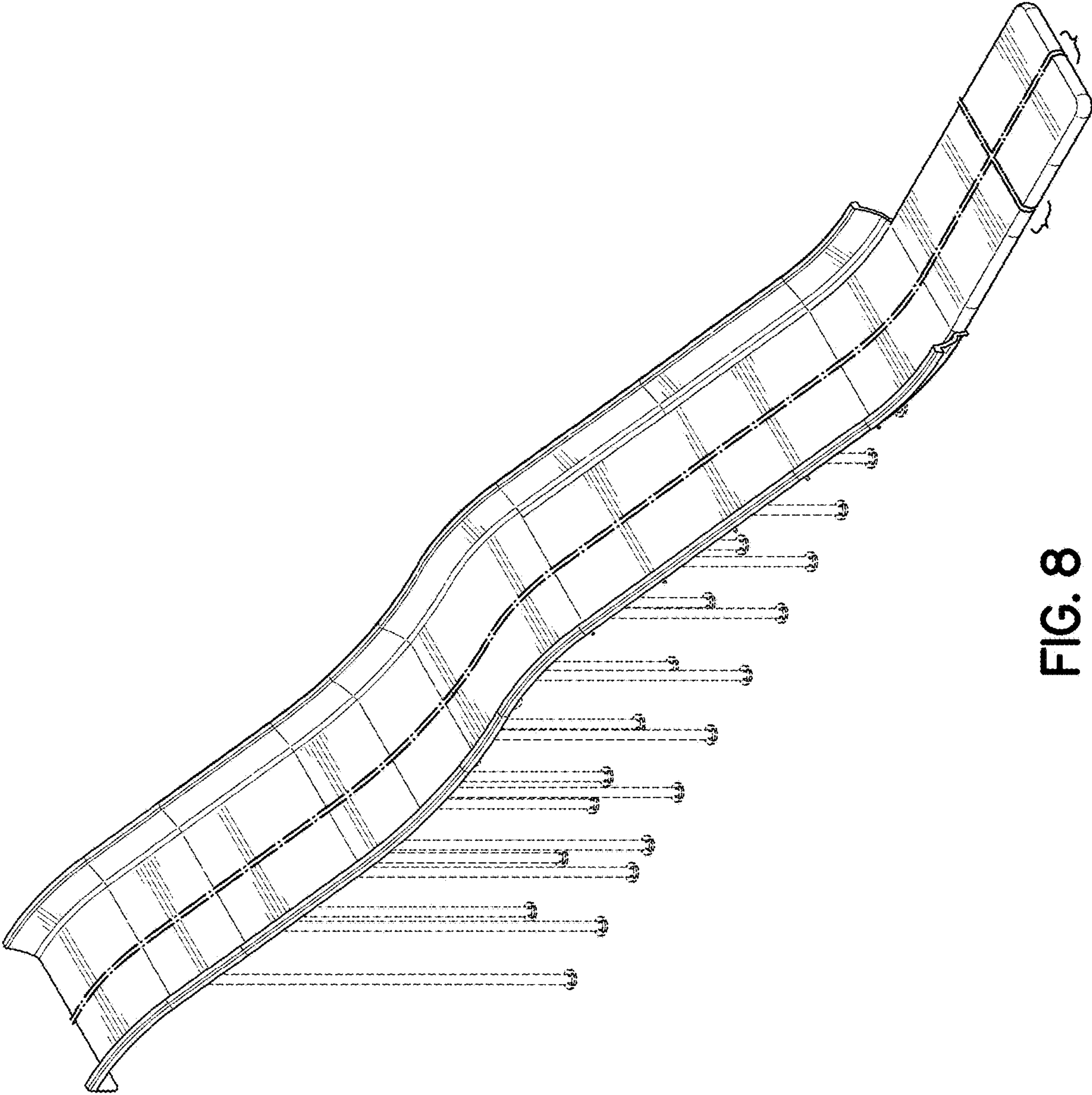

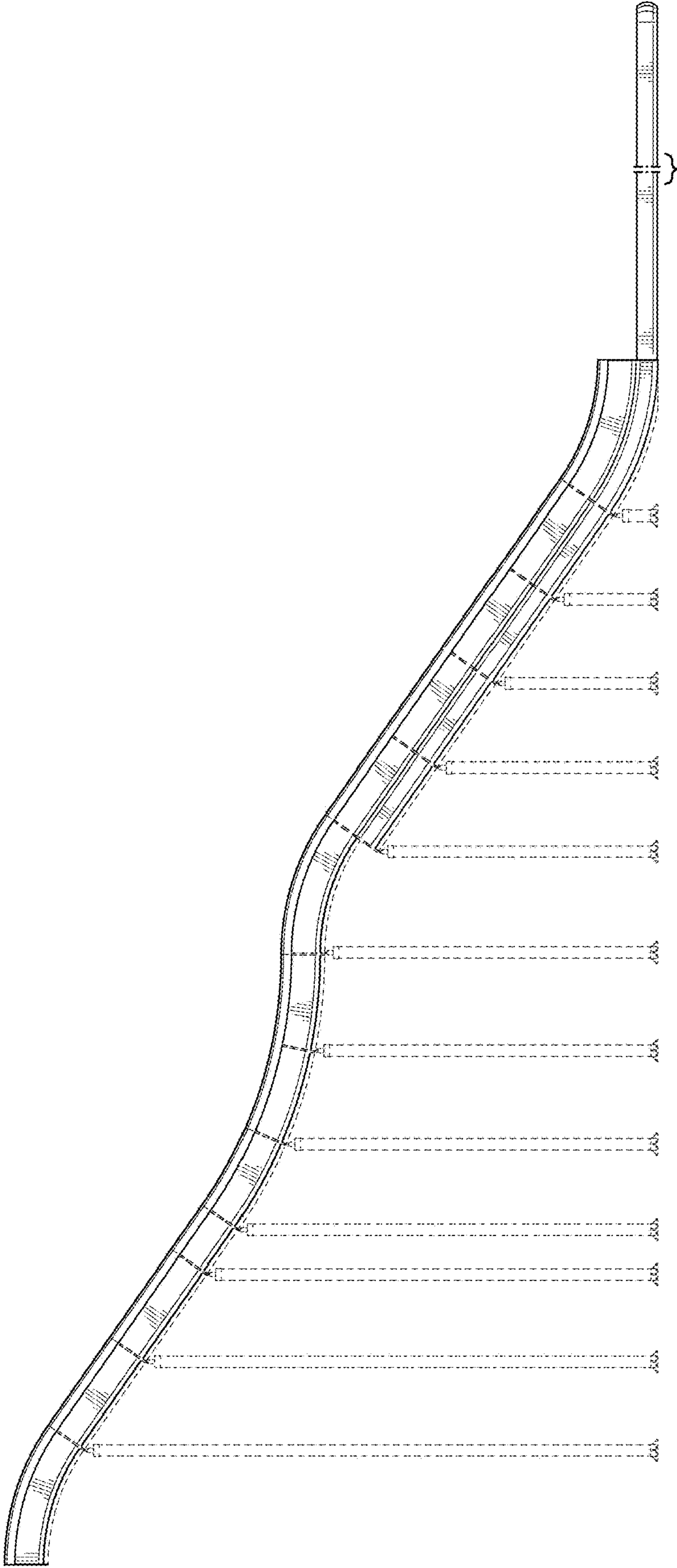

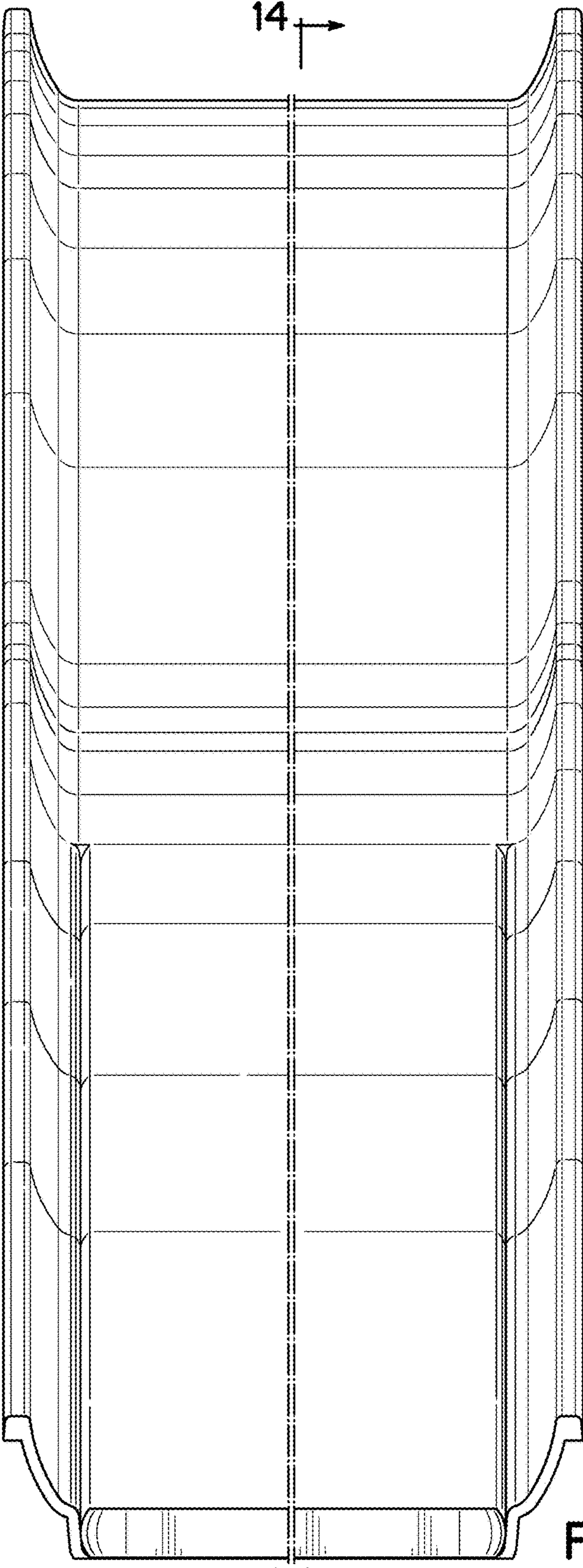

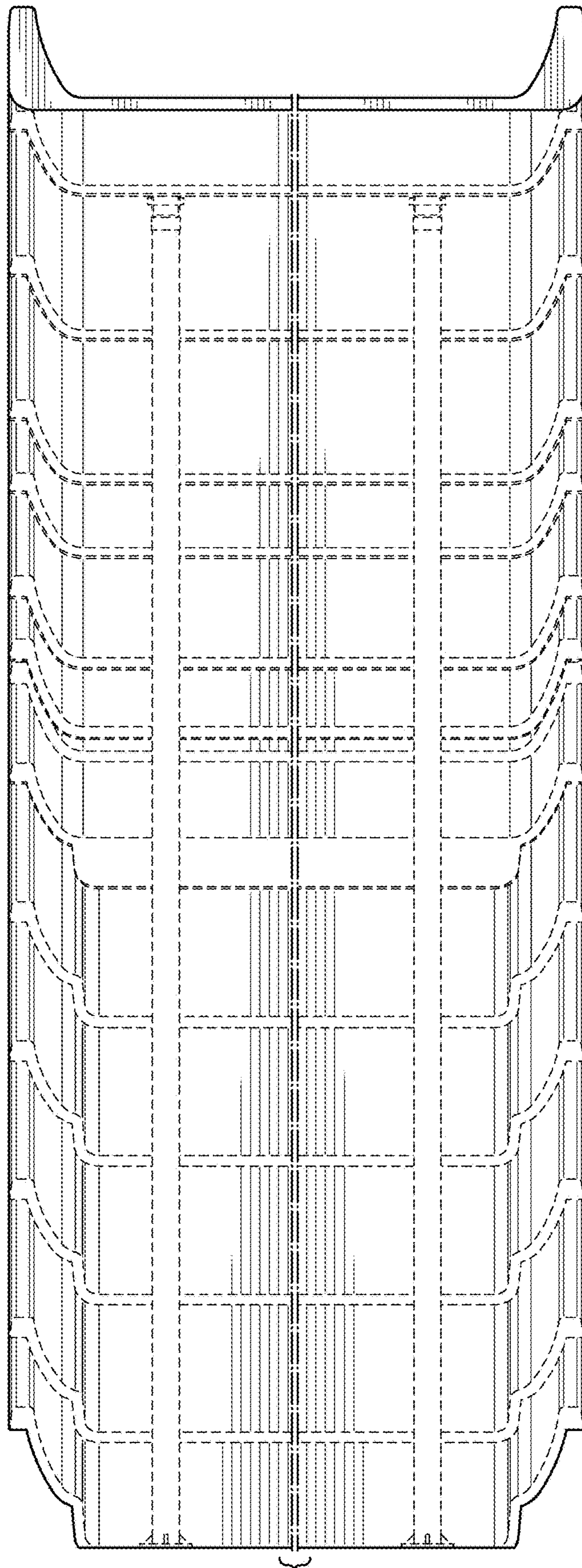

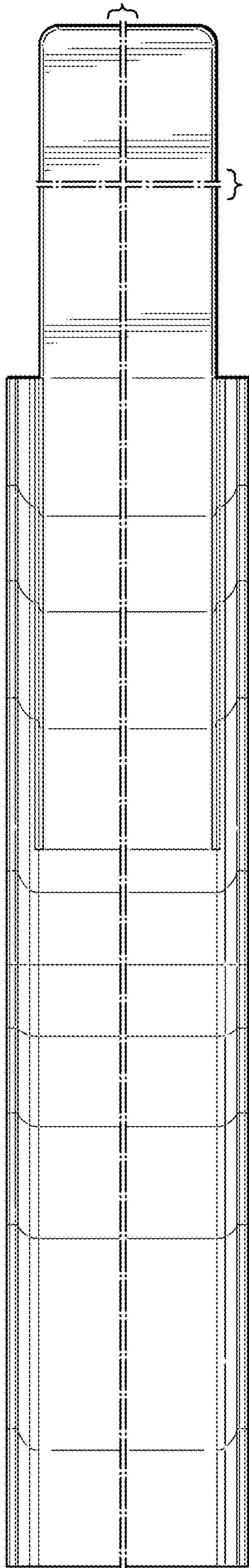

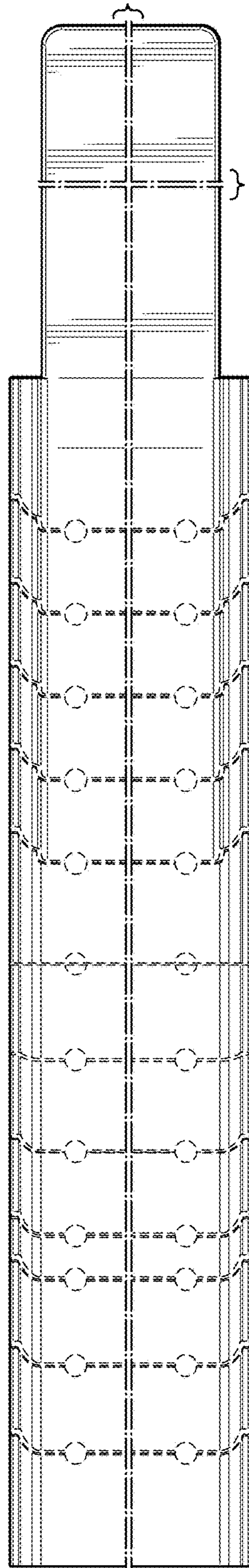

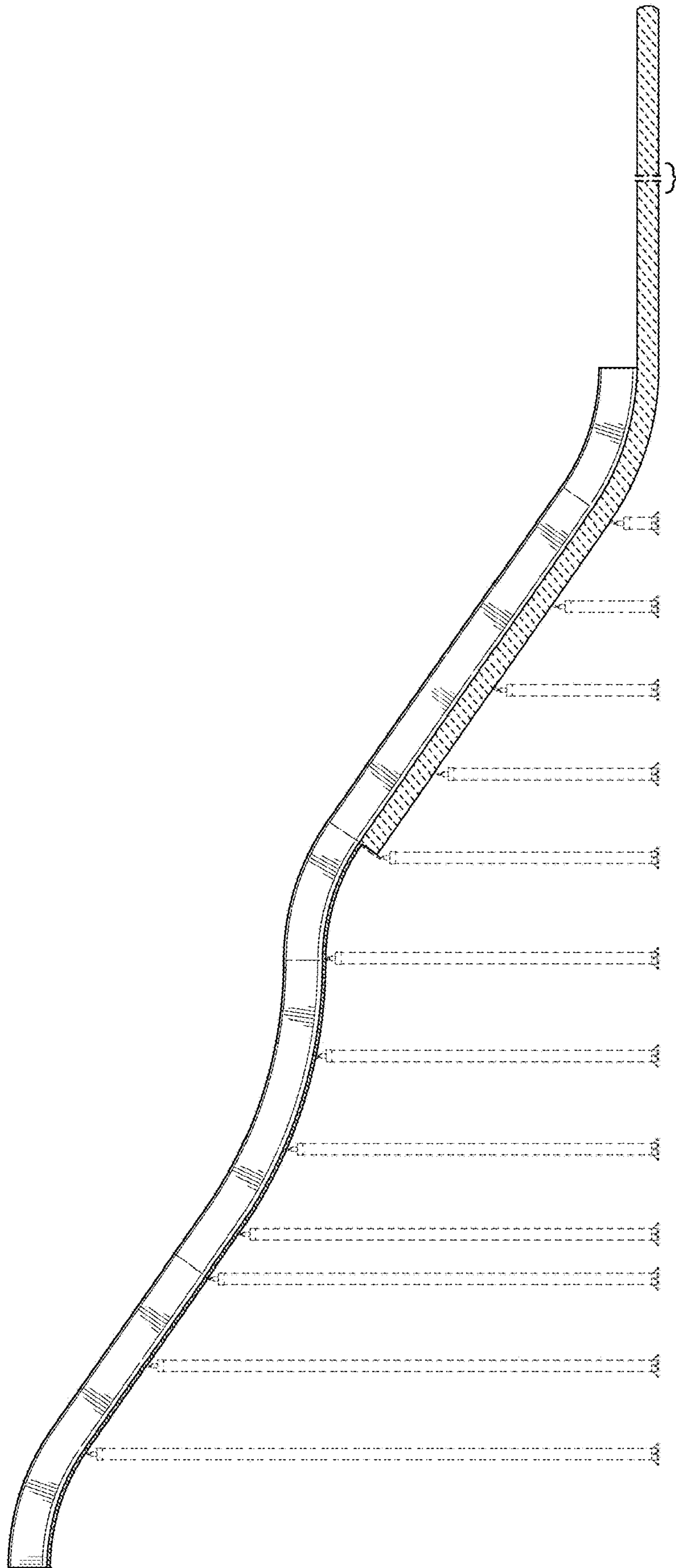
