The ornamental design for a decorative lamp, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a decorative lamp showing my new design;

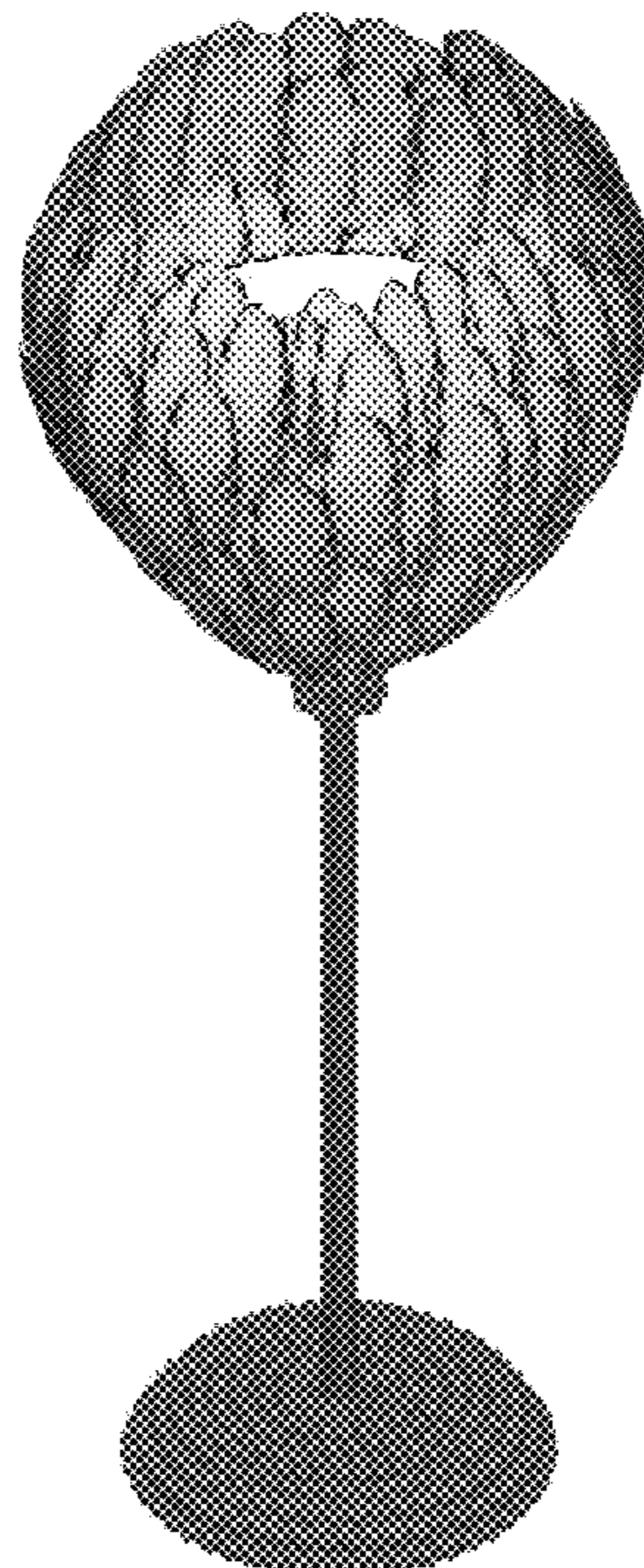

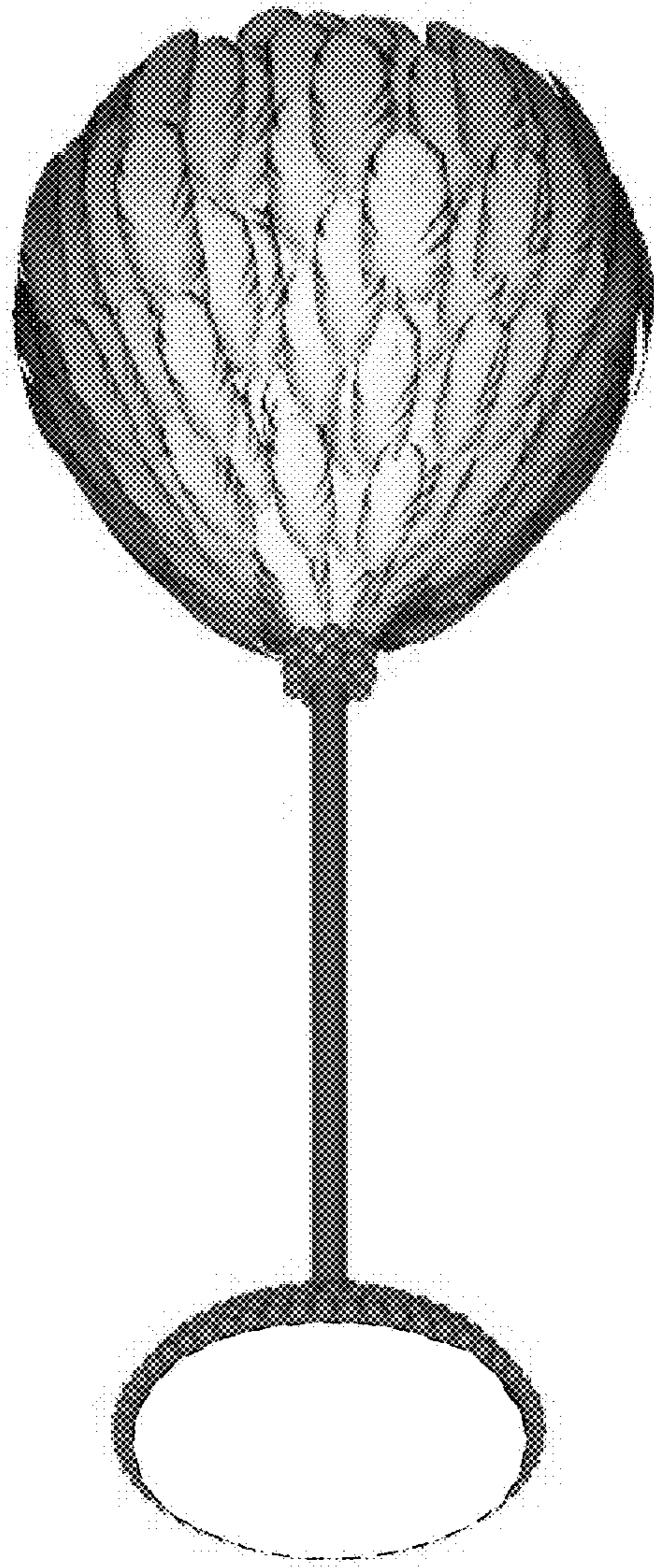

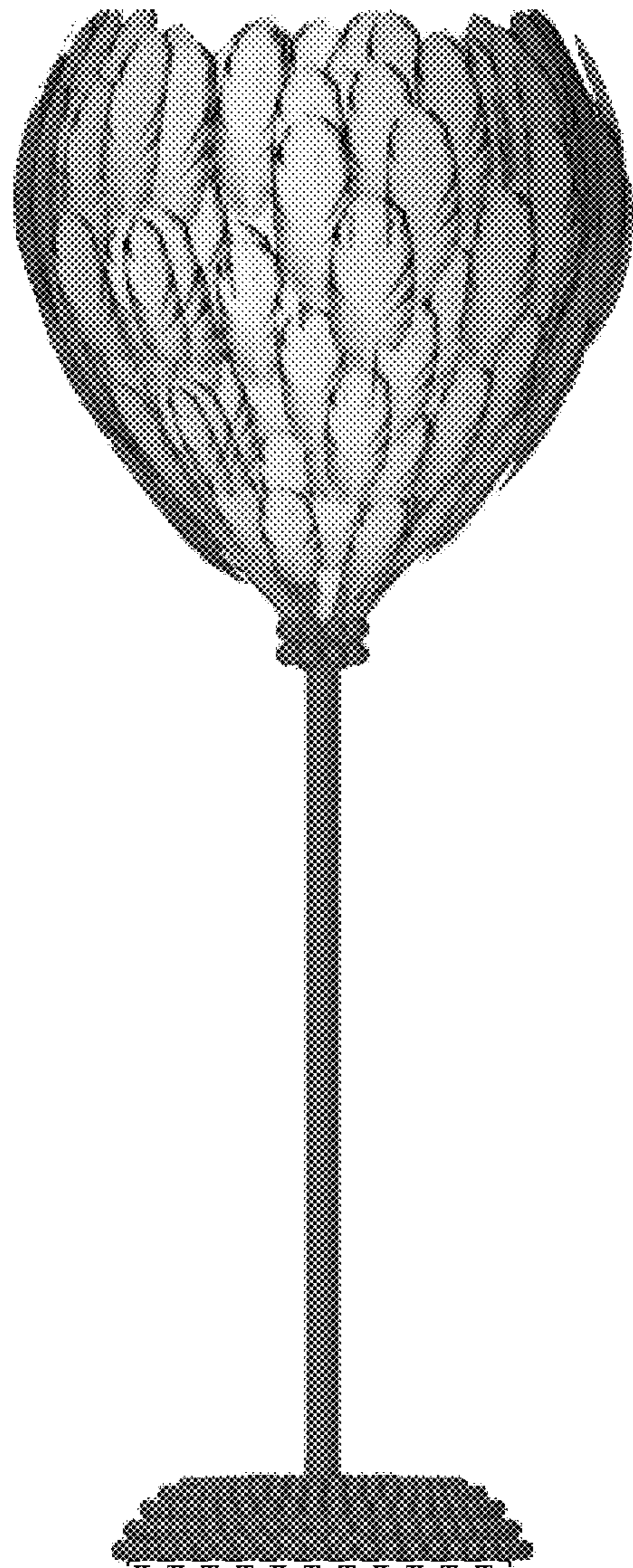

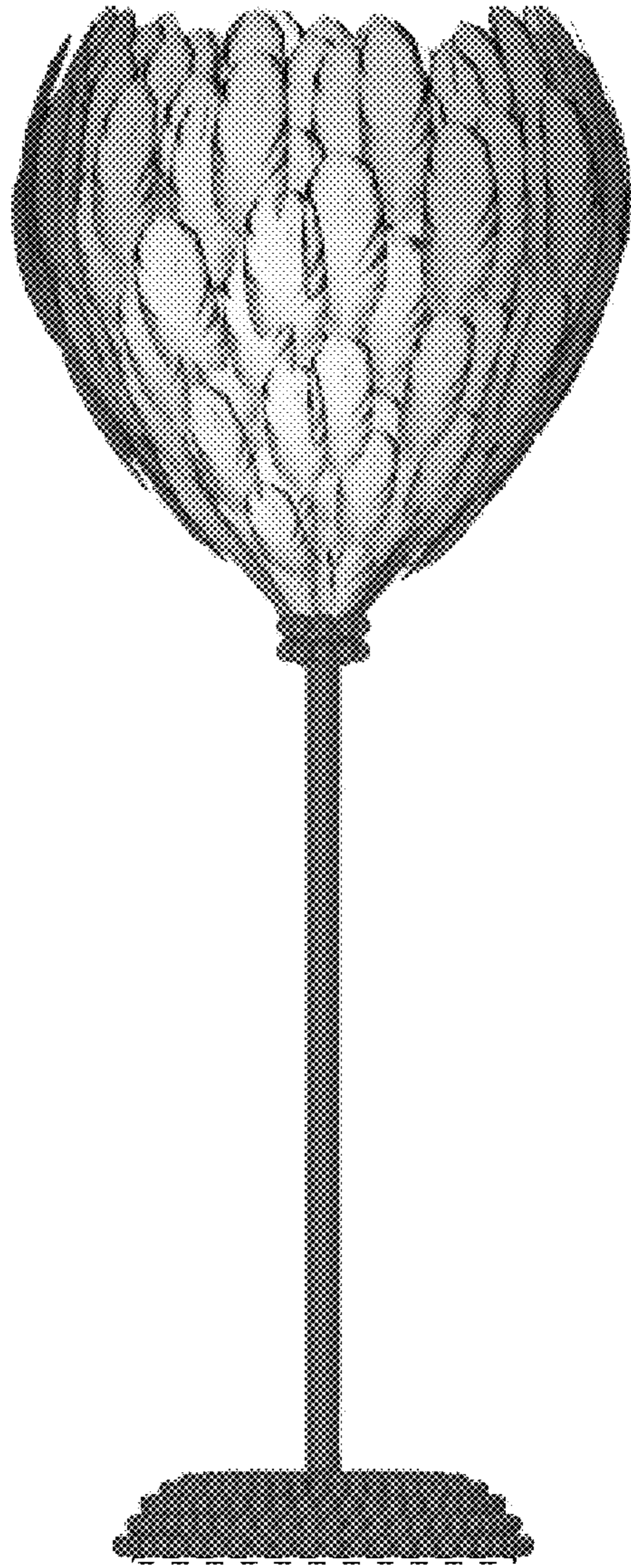

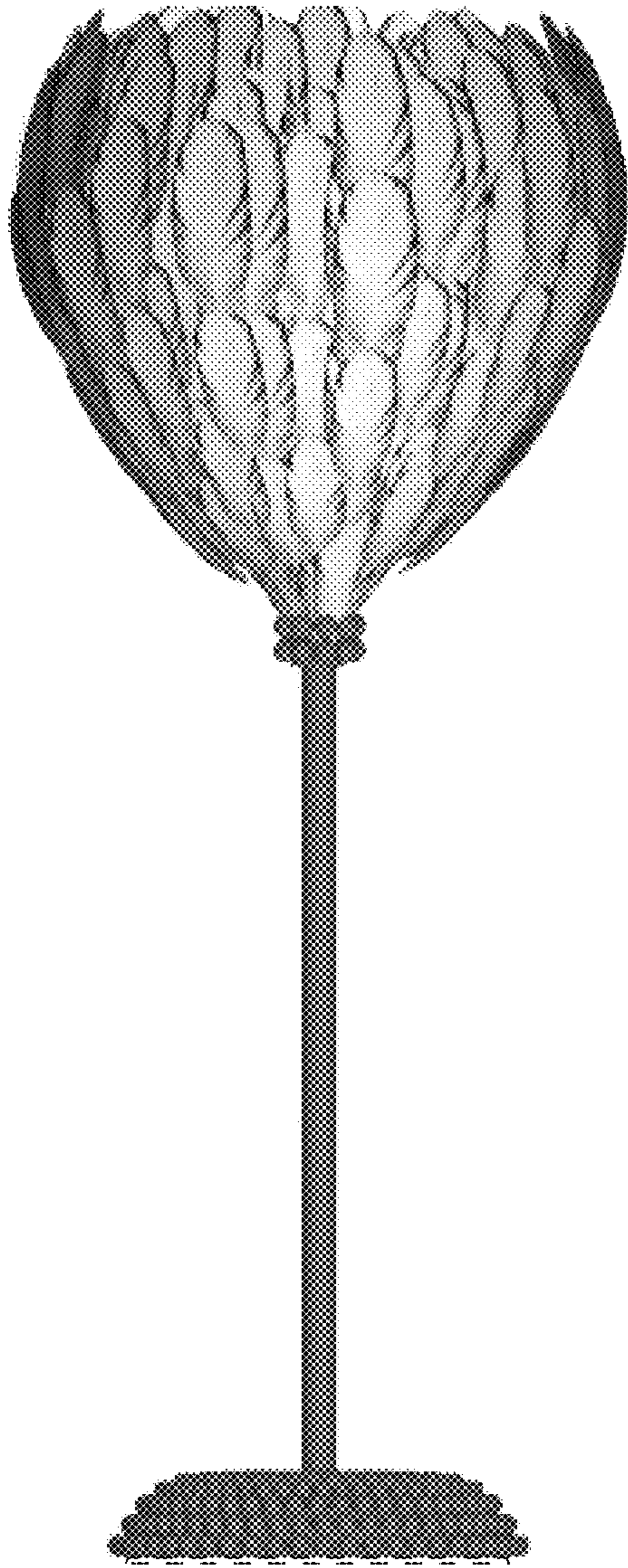

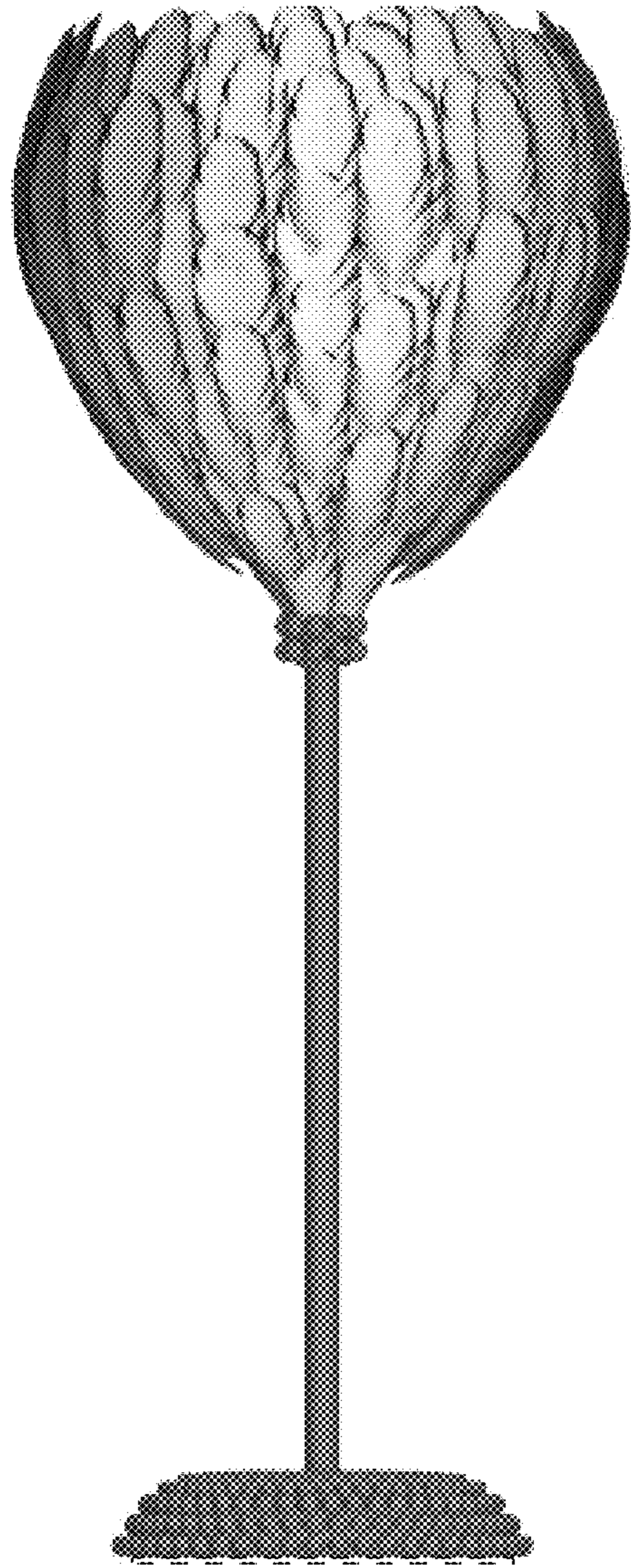

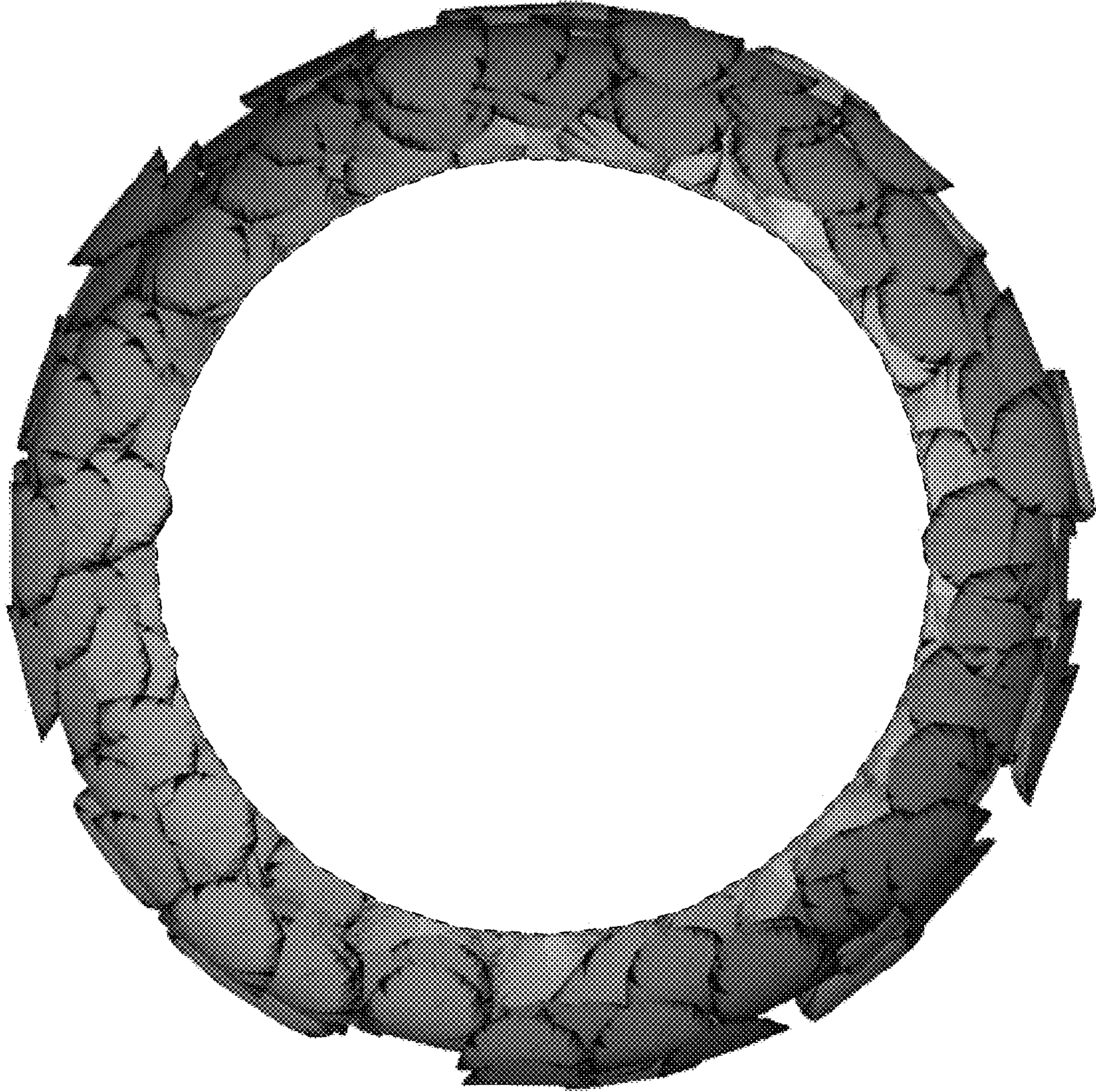

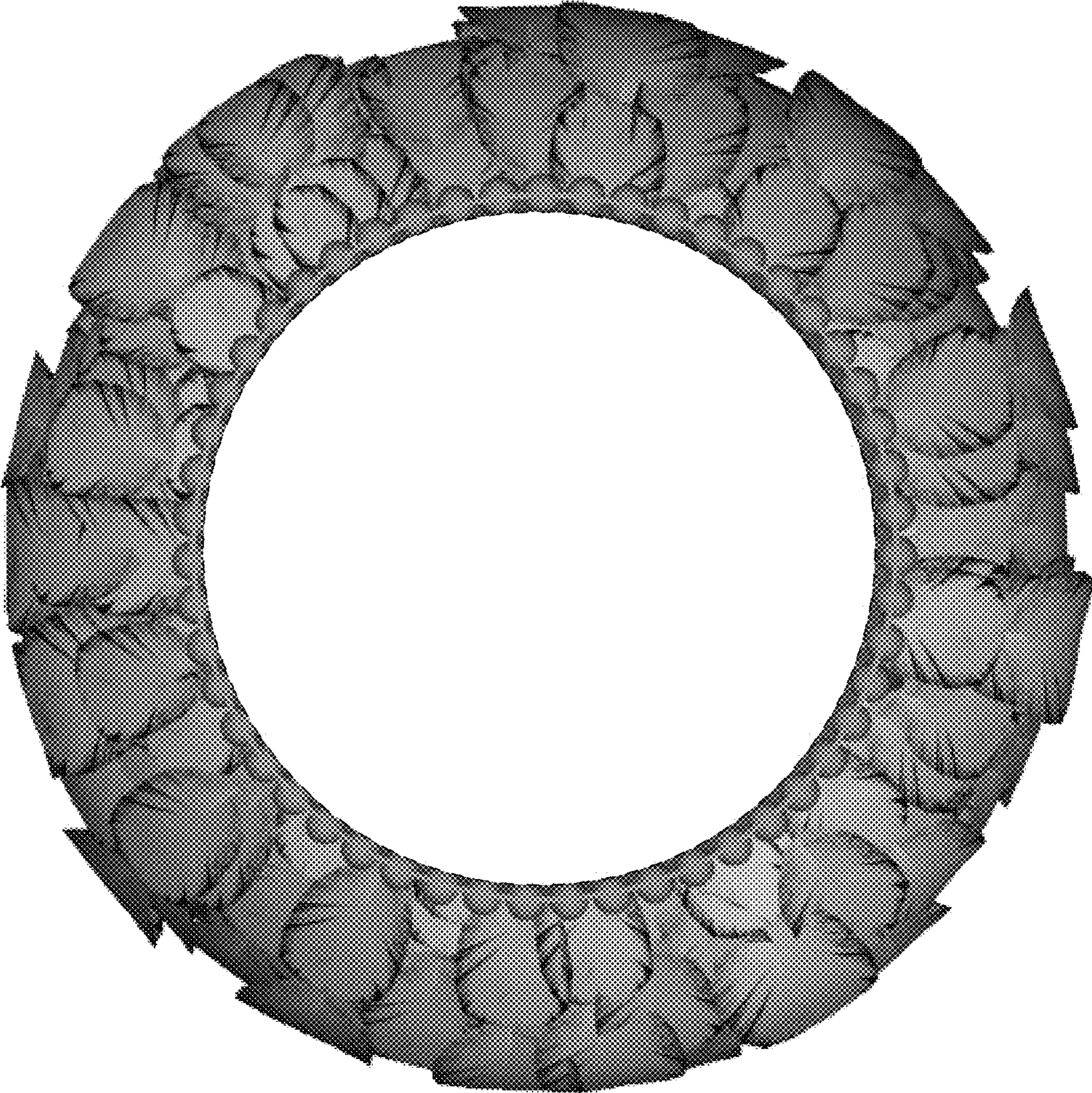

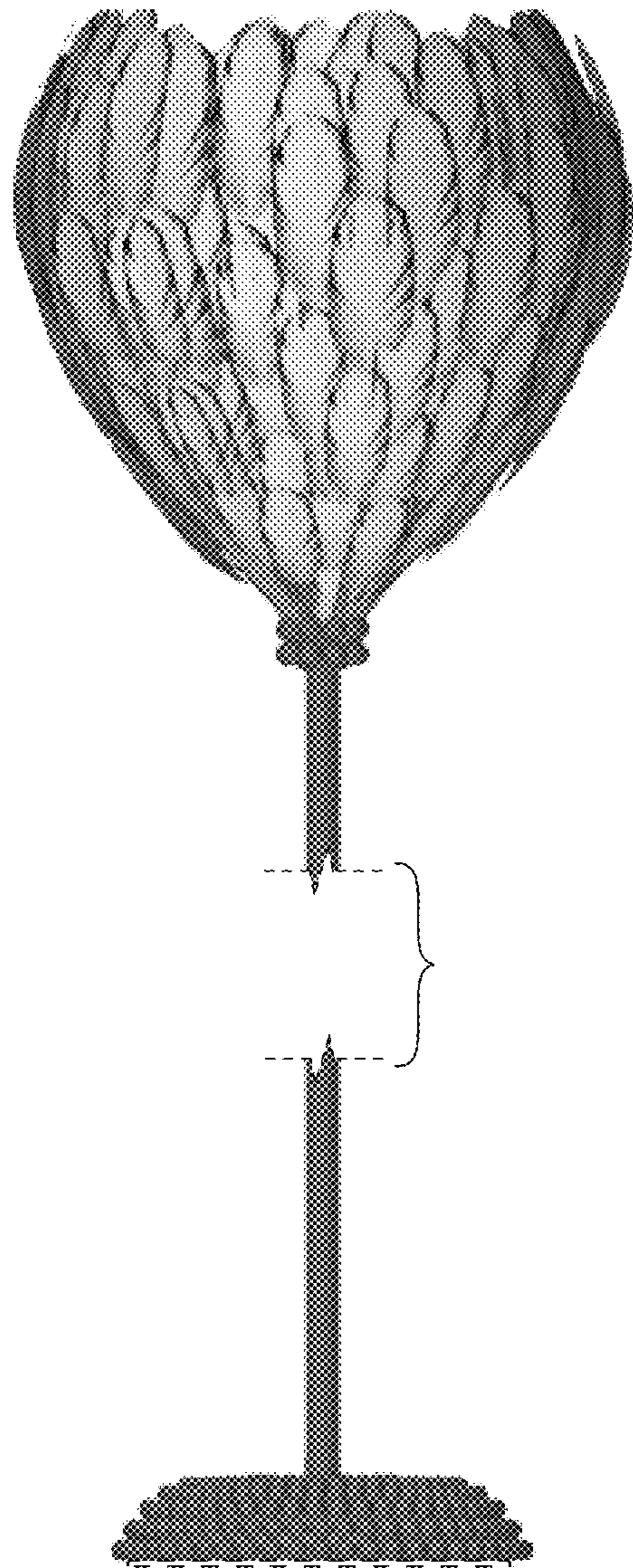
