FIG. 6 is a bottom view of the bicycle sprocket assembly shown in FIG. 1; and,

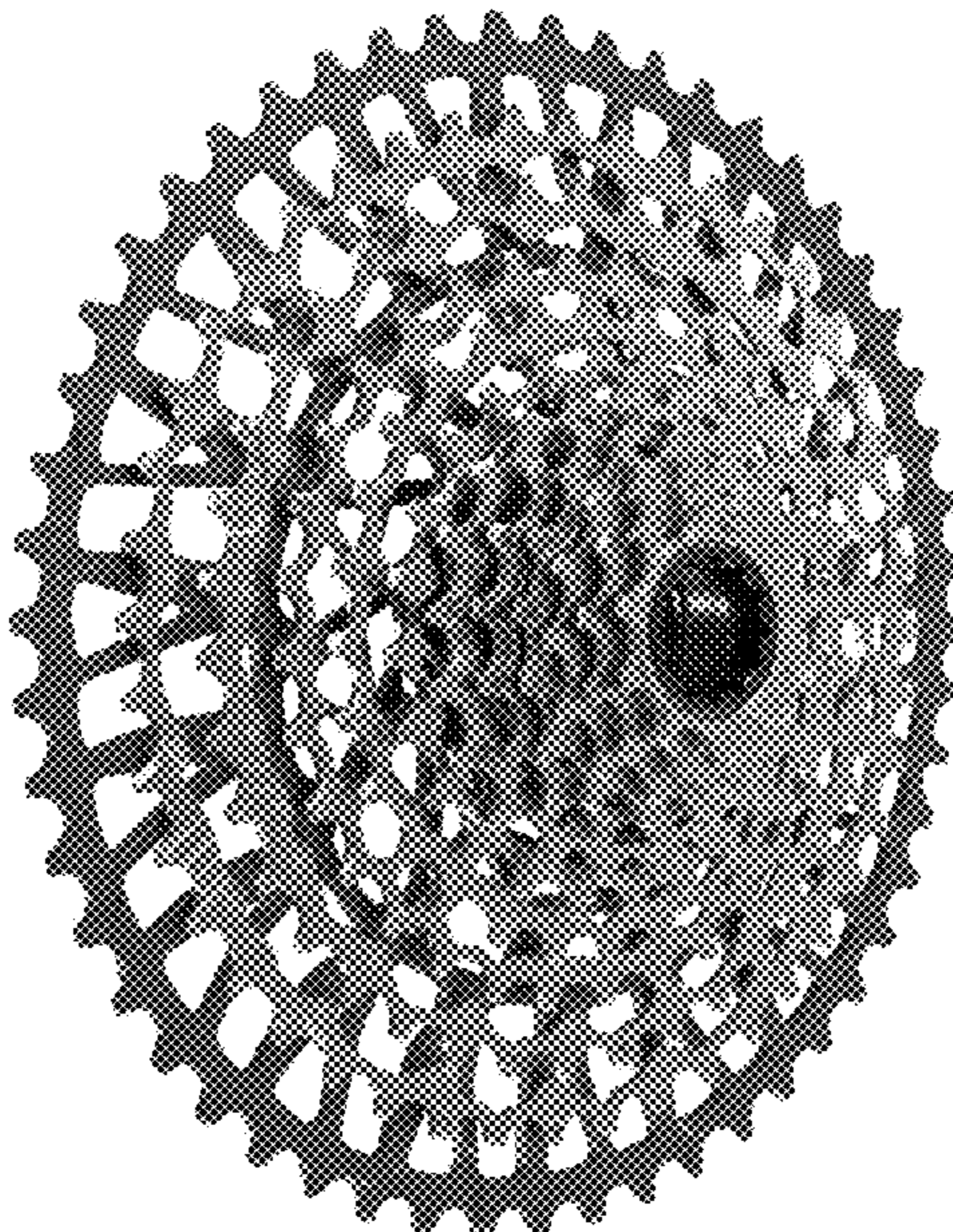
FIG. 7 is a right side view of the bicycle sprocket assembly shown in FIG. 1.

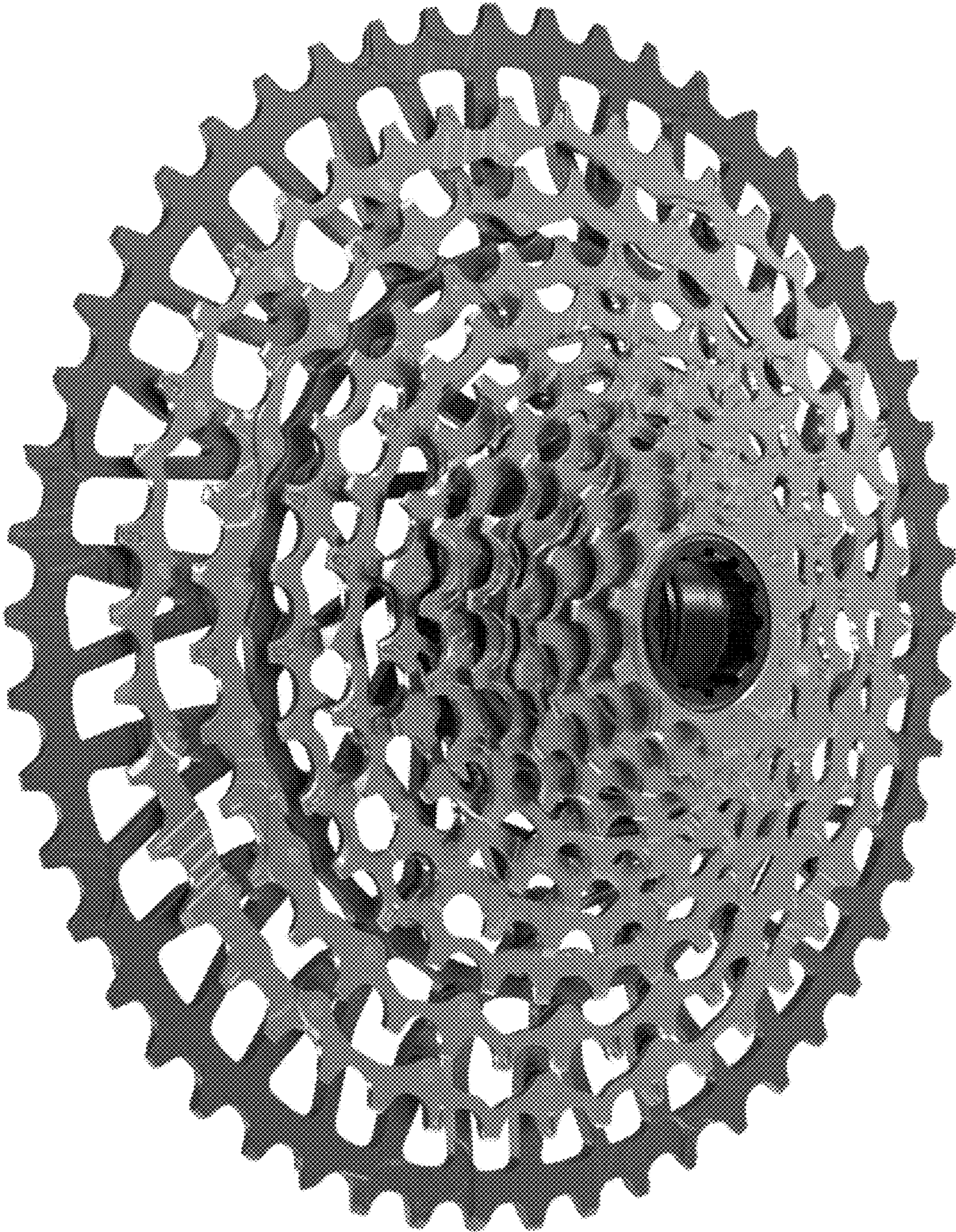

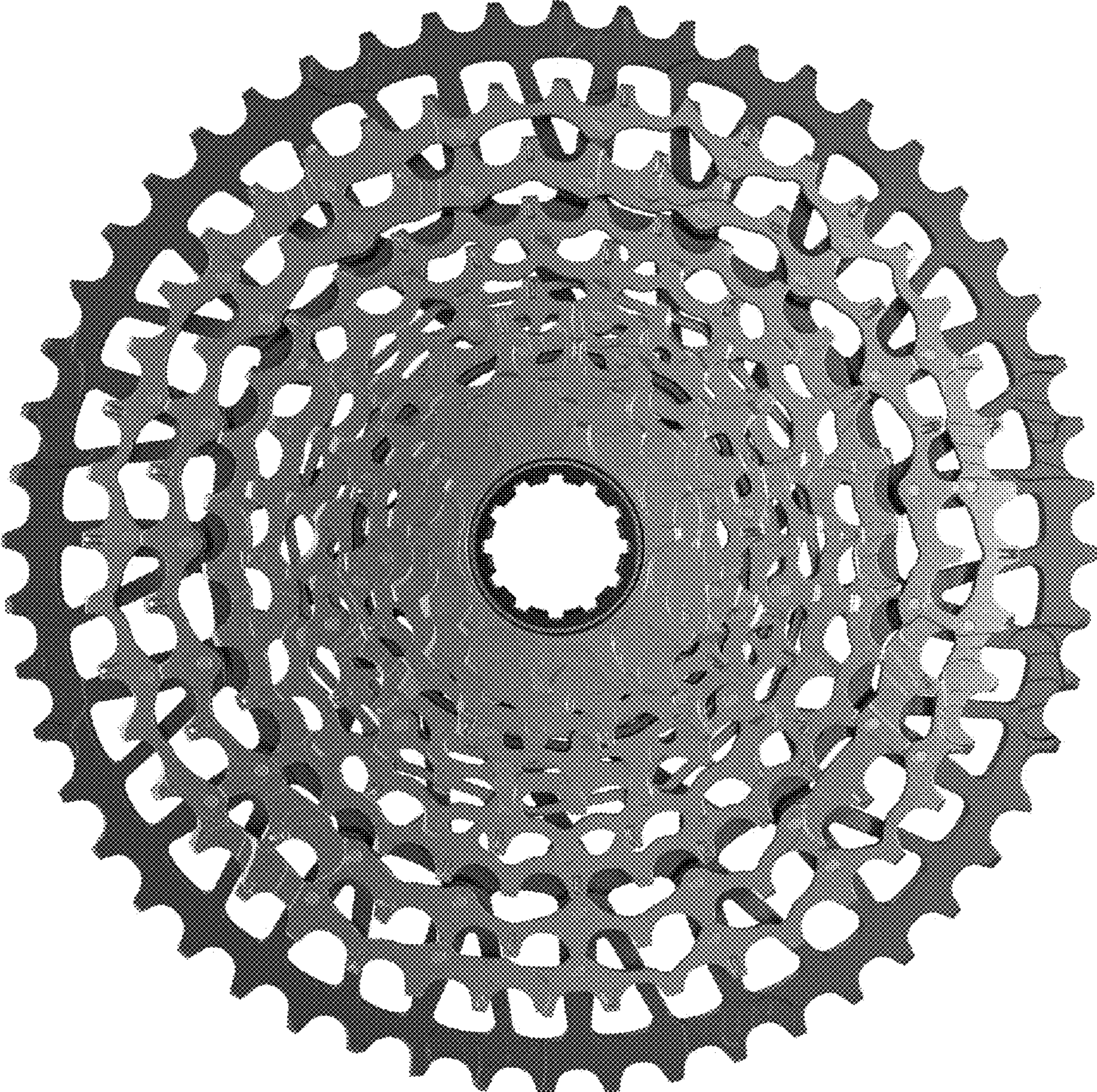

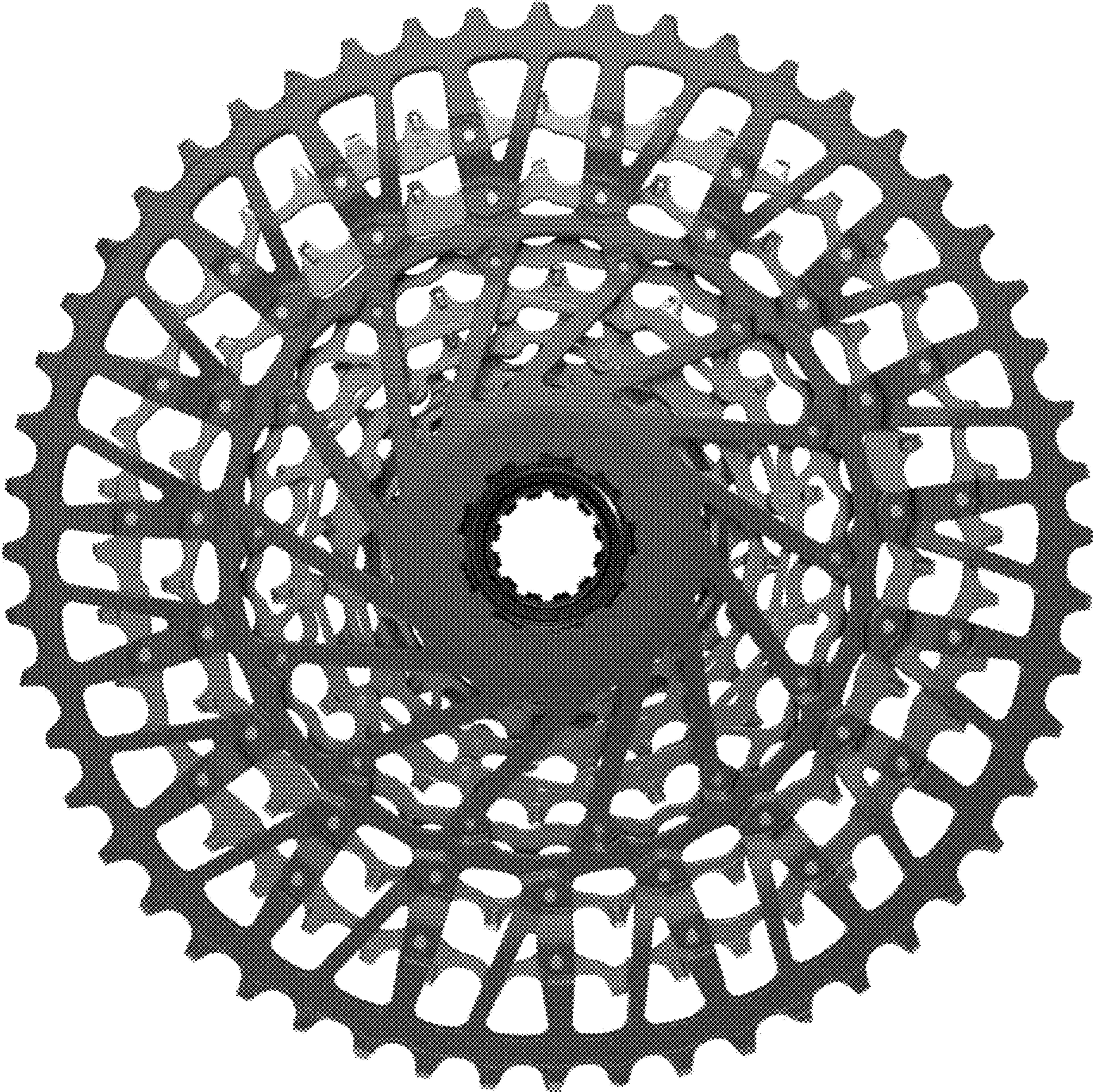

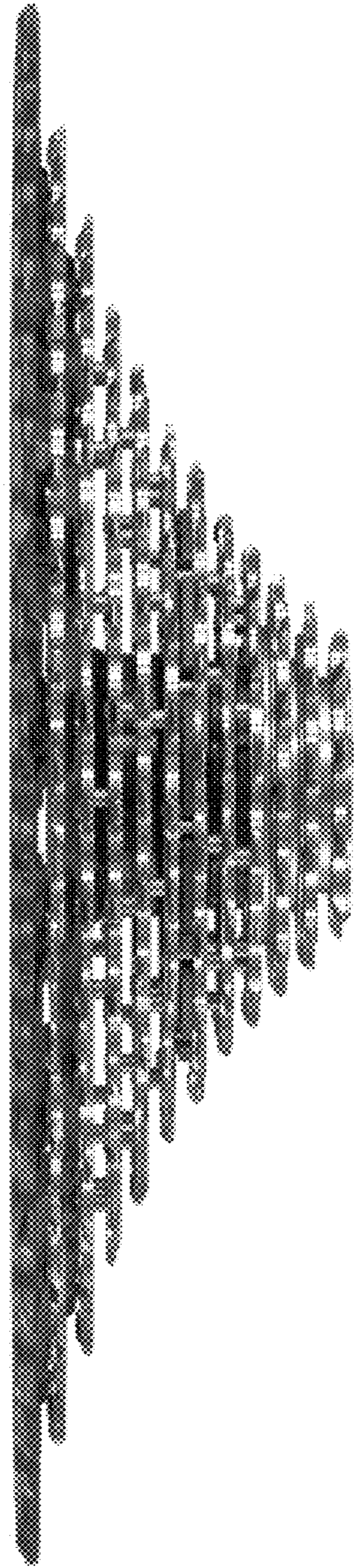

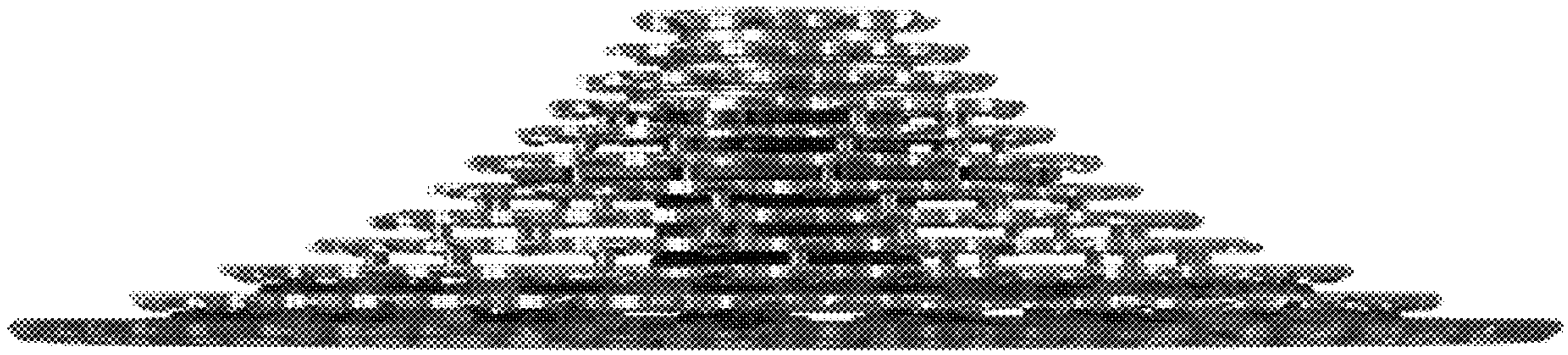

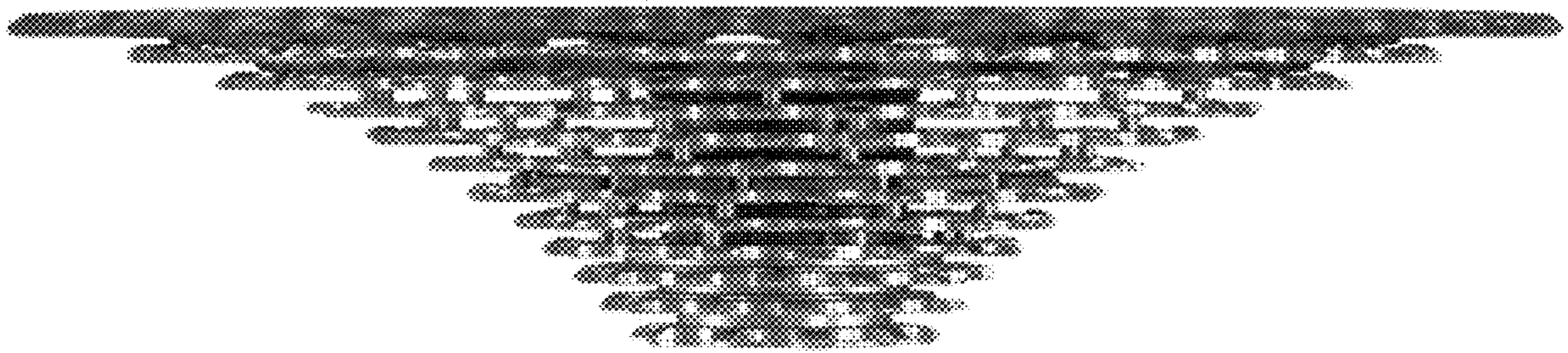

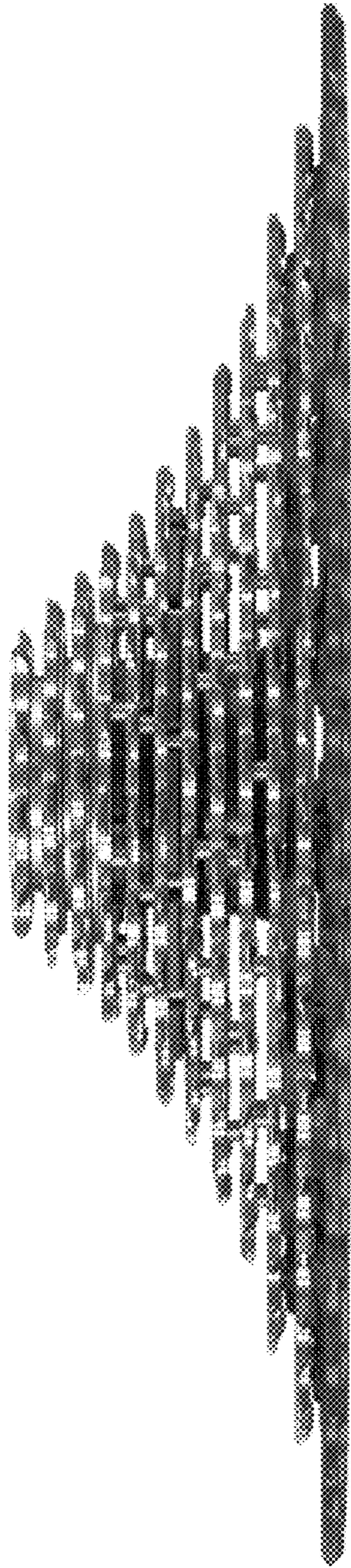
