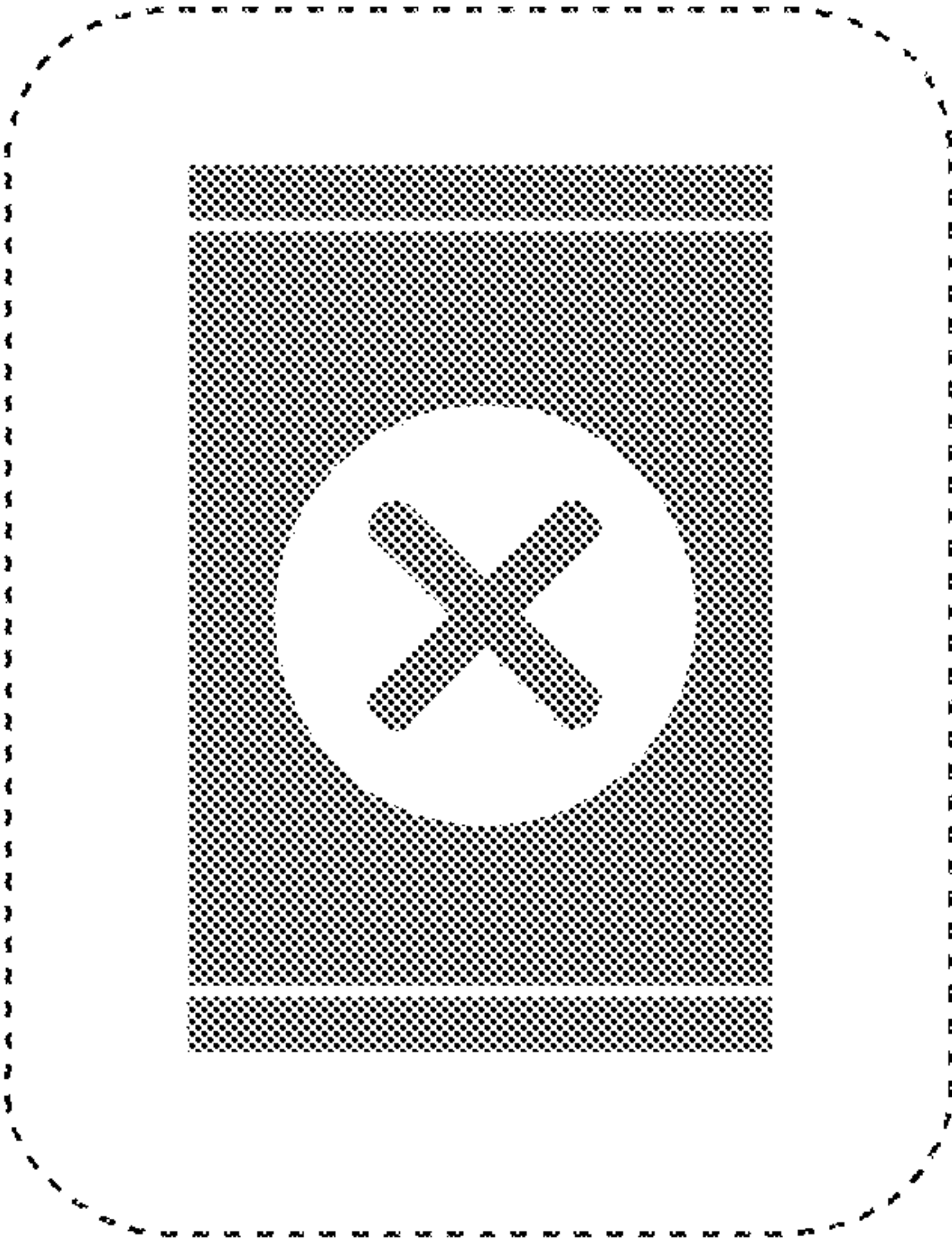
The ornamental design for a display screen having a graphical user interface, as shown and described.
